A New Court Kicks Off

CARMICHAEL, CA (MPG) - A reconfigured court allows Carmichael kids to play soccer, basketball and hockey at the same Carmichael Park facility.

Built with funding from Carmichael Recreation and Park District and a \$5000 contribution from Sacramento Republic Football Club, the \$70,000 Over Under project opened last week.

Supervisor Rich Desmond joined VIPS whose well-directed kicks obliterated the ceremonial ribbon. Desmond welcomed the opportunity to re-purpose under-utilized

recreation spaces. "We can be proud Carmichael Park has the first of these courts in Northern California, and only the second in our

whole State," he enthused. The facility came about through the efforts of famed American Soccer pro Kyle Martino. In

2021, the star launched an Over Under Initiative (non-profit) to benefit urban kids through sport. Over coffee at Carmichael's Bella Bru Café, Connecticut-based Martino scored cooperation from County Supervisor Rich Desmond.

"Meeting Kyle was refreshing," says Desmond. "He's passionate about helping kids. He really believes access to sport should be a right, not a privilege. He explained his Initiative to me and said he was looking for a Sacramento location. I immediately thought of the old basketball court in Carmichael Park. It

Sacramento County Led Workshop on Homelessness

SACRAMENTO COUNTY, CA (MPG) - On May 23, 2023, the Sacramento County Department of Homeless Services and Housing (DHS) led a workshop on homelessness at the Board of Supervisors meeting to educate and inform the Board, stakeholders, advocates and any interested residents of Sacramento County about the County's response to homelessness. The workshop included presentations by DHS, Regional Parks, Sheriff Homeless Outreach Team and the City of Sacramento, as well as input from critical agency partners Sacramento Steps Forward (SSF) and Sacramento Housing and Re-development Agency (SHRA).

DHS presented some vital information about the diversity of the homeless population, both in race and ethnicity, as well as age, gender, familial make-up, resources and chronic issues. The County also shared examples of various populations in a series of human-centric vignettes, designed to bring personal, humanizing stories that combat generalizations and harmful stereotypes. DHS also shared outcomes of County-funded programs from Fiscal Year 22/23, including encampment outreach, sheltering and rehousing services and programs.

DHS also acknowledged that while the road to homelessness is rarely a single issue, it often is a symptom of compounding issues such as unstable family life, lack of income, chronic health conditions, behavioral health challenges, involvement in the justice system, and many more. However, the only universal characteristic of people experiencing homelessness is that they lack a permanent home; therefore, to truly address the homelessness crisis, we need to increase access to and availability of safe and affordable housing wrapped with appropriate, client-centered supportive services.

While the Board has been increasing investments in diverse programs since 2017, the increase in homeless rates and the complexity of the challenges faced by the homeless population and the community necessitated the need for a singularly focused staff to work on this issue and to be publicly accountable and accessible.

In late 2022, the Board created DHS, which

Parking and admission for the event are free.

"We're very excited about our new location, which will be especially cool inside with plenty of space for our participating artists," she said.

The Sacramento Suburban Kiwanis Club, chartered in 1958, is a community service organization, dedicated to serving the Arden-Arcade community in Sacramento. Its annual Art Fiesta is the longest-running annual art show of its type located west of the Mississippi River. It's also a juried art show, which ensures that all artistic work presented is authentic, with genuine products and original creations.

"The Art Fiesta provides a wonderful opportunity to expose the whole family to local art while supporting these local artists and helping the Sac Suburban Kiwanis fund its many community and youth-assistance programs," Lagomarsino said.

setting at the Scottish Rite Masonic Center. Local food trucks and beverage vendors are slated for the event including Top Notch Food Spot, a hot dog cart, Zintzuni, offering Mexican cuisine; "Party at Pops", offering Southern-style cuisine and sellers of shaved ice and herbal-infused lemonade.

"We're tying the Kiwanis' mission into our event this year in a new way, by offering the non-profit partners with whom we work the opportunity to display information about their organizations and the many shared projects on which we jointly work," Lagomarsino said.

One of the Sacramento Suburban Kiwanis Club's newest non-profit partnerships is with the group Wide Open Walls, which promotes diversity through artistic expression. Participating mural artists have painted large scale

"We think art should be part of our daily life and want art to reach a much wider audience," Lagomarsino said.

Three local community leaders have been honored for their community service by the members of the Daughters of the American Revolution (DAR) General John A. wasn't getting much use. Reconfigured for multiple sports, I thought it would be a great community asset."

With Carmichael's growing immigrant population – and with soccer internationally beloved – the opportunity for the scaled-down variant known as Futsal seemed a win-win. "I knew

CRPD would jump at the chance," said Desmond.

Fourteen months later, new basketball hoops, retractable soccer posts, fresh asphalt, and lighting completed the project.

Much kicking and tossing of balls followed VIP speeches. First hoops were shot, and Sacramento Republic coaches gave informal soccer clinics. Seeing kids' immediate

and enthusiastic use of the court last week reinforced its value. "We'll do more of these courts in District 3," predicted Desmond. "I'm already talking to other park districts about similar projects. It's a great way to get kids outside and playing sport."

The CRPD basketball/football court is located near District headquarters at 5750 Grant Avenue. ★

Renowned Funk Icon Dawn Silva Releases Autobiography

SACRAMENTO, CA (MPG) - New Rising Publishing is pleased to announce the release of the publication "The Funk Queen Dawn Silva: An Autobiography." The deluxe coffee-table book spans the wide-screen life and career of funk icon Dawn Silva who was the founder and lead vocalist for the George Clinton-created Brides of Funkenstein, while also having enjoyed stints as a vocalist in some of funk music's greatest groups including Sly & The Family Stone, Parliament Funkadelic and the Gap Band.

As a memoir, the publication serves as a reference work that touches on Silva's participation in many key historical events and developments within the funk music genre while also serving as a cautionary tale as Silva navigated through a myriad number of inequities, challenges, and obstacles as a woman artist in the male-dominated music industry of the 1970s and 1980s.

"My mother once said that there is nothing in the music industry that prepares you for that lifestyle," said Silva. "She was right, and it was all the motivation I needed to complete my autobiography. I felt very strongly about putting my story in print in hopes of it inspiring and empowering those who read it."

Epic in scope, the publication chronicles Silva's rich cultural heritage, growing up during the Jim Crow era of the 1950s & 60s as well as her stint in the Black Panther Party of the 1970s. Her musical journeys are spotlighted through her tenures with Sly & The Family Stone, George Clinton / Parliament-Funkadelic (aka P-Funk), Brides of Funkenstein

(lead vocalist), as well as her background songstress days for the Gap Band and her later forays into rock/new wave with Was Not Was as well as her going solo and defying many of the norms for women in funk music.

The book takes a kaleidoscopic look at her musical experiences and how they galvanized her reputation as the "Funk Queen," as

Silva directly challenged the long-established status quo and institutional misogyny of the music industry.

"This is the story of a rebellious American female recording artist who escaped an era of subjugated institutions, misogyny, and physical and mental abuse, beating the odds and recapturing a worldwide underground cult following," said New Rising Publishing

Executive Director Henry Mayers. "This true story is no longer funk's best kept secret. It is the story of survival and persistence, a tale of a courageous woman who stood against the male-dominated music industry and never backed down; no matter how often she was knocked down, each time, she would rise stronger and better than before."

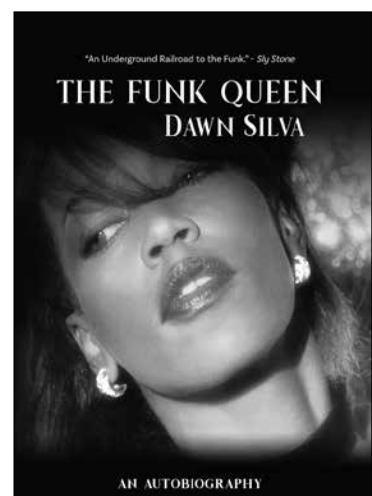
The release has garnered

How Will California Deal With Budget Deficits That Seem Here To Stay?

A little more than two weeks remain before the June 15 constitutional deadline for enacting a 2023-24 state budget.

It's as certain as anything in politics can be that the Legislature will pass something it calls a budget. If lawmakers missed the deadline, they could lose their paychecks.

It's equally certain that whatever they enact will not be the final plan for the 2023-24 fiscal year that begins July 1. Due to declines in revenue, the state faces not only a multi-billion-dollar deficit in the forthcoming year but the likelihood of continuing gaps for several years thereafter.

There is, moreover, neither consensus on the scope of the deficit nor agreement on how the governor and legislators respond. Meanwhile, those in the Capitol are besieged by pleas by those with stakes in the budget to protect their projects and programs and demands for even greater allocations.

When Gov. Gavin Newsom introduced his first version of the budget in January, he said the state had a \$22.5 billion deficit, and then increased the shortfall by another \$9 billion in the revised budget

proposal this month.

Immediately, however, the Legislature's budget analyst, Gabe Petek, told his bosses that it's really \$34.5 billion and, more ominously, declared that the state faces continuing deficits averaging \$18 billion for several more years.

It is, in the parlance of fiscal mavens, a "structural deficit," meaning it's baked into the state's finances regardless of underlying economic conditions. All of the competing versions of the state's fiscal situation also assume that California does not experience a recession in the near future.

Were a recession to strike, the deficits could grow by tens of billions of dollars because California's revenue system is dangerously dependent on taxing the incomes of the state's wealthiest residents, as Newsom's budget acknowledges.

"California's progressive tax system, where nearly half of all personal income tax in the state is paid by the top 1% of earners, has contributed to extreme budget volatility over the years," the May revision says. "Maintaining budget stability requires long-term planning in the face of these revenue fluctuations."

In light of that statement and Petek's rather gloomy long-term projections, will Newsom and the Legislature respond responsibly? Or will they take the easy way out, paper over the current deficit with creative bookkeeping and backdoor borrowing, and ignore the structural deficit until it becomes a crisis?

Newsom's budget is

essentially a short-term response, dipping the usual bag of fiscal tricks to produce a budget that would be balanced on paper – assuming his deficit estimate of \$31.5 billion is accurate.

Both Senate and the Assembly leaderships have adopted budget frameworks that purport to protect vital services but differ in approach. The Assembly's version would reshuffle appropriations while the Senate's would cover the gap by raising corporate income taxes, arguing that a tax hike would merely recapture money large corporations gained from the Trump-era federal tax overhaul.

Although Newsom immediately rejected a corporate tax increase, if the deficit is as wide and chronic as Petek projects, budget stakeholders will intensify their demands for tax increases of some kind.

In recent elections, California voters have rejected proposed increases in property taxes and personal income taxes on the wealthy. Newsom opposed the income tax increase, is now opposing the Senate's proposed corporate tax, and also has rejected periodic bills to impose a wealth tax.

"A wealth tax is not part of the conversation," Newsom said of this year's version. "Wealth taxes are going nowhere in California."

This year's budget dance will kick off a political tussle over spending and taxes that will likely continue for the remainder of Newsom's governorship.

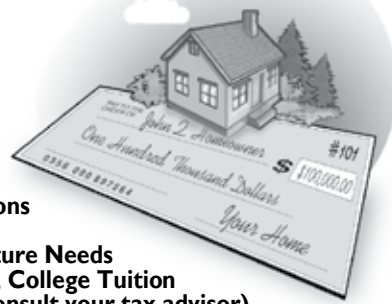

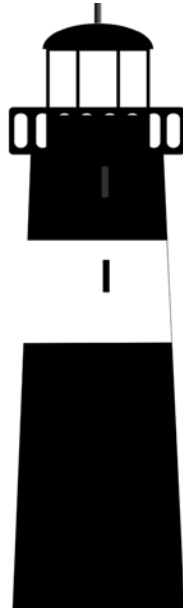

SACRAMENTO COUNTY, CA (MPG) - We've got some exciting news! The Sacramento County Department of Regional Parks has initiated its multi-pronged plan to reduce fire risk, defend wildlife habitats and protect our natural resources and the neighborhoods adjacent to the parks.

For its 2023 Fire Fuel Reduction Action Plan, the Department of Regional Parks has lined up sheep and goat grazing contracts, is utilizing maintenance crews to maintain fire breaks, and is issuing fuel break maintenance permits to properties bordering Park properties.

"We're seeing more vegetation than we have in past years thanks to the strong winter storms that passed through," said Liz Bellas, Director of Regional Parks. "Our fire fuel reduction work is going to be particularly critical this year as this vegetation dries out in the late spring."

To decrease the number and size potential of wildfires in our parks system, the techniques used will be applicable for each area and will include:

Firebreaks - A combination of mowing, soil discing and targeted herbicides will be used where appropriate to create perimeters around open fields, along fence lines and behind neighborhoods. This work is scheduled to be completed by the end of June.

Ladder Fuel Hand-Crews - In limited, hard-to-reach areas, hand-crews will remove vegetation that allows the potential for a fire to climb up or move into urban areas.

Grazing - There are hundreds of acres of undeveloped or protected land in our Regional Parks. Goats and sheep are ideal for vegetation management and are great at eating down weeds, bushes and grass that manned crews cannot get to. Grazing is expected to occur through the end of June.

Annual Encroachment Permits - Residents who live adjacent to Regional Parks' properties are able to apply for free annual encroachment permits to maintain a fire break behind their property line. These allow residents to string-trim grass and weeds for up to 50 feet beyond their private property line. To request a permit, provide your name, address and contact information to Regional Parks at park-sinfo@SacCounty.gov.

Additionally, the Ranger Division will continue its increased education and enforcement efforts related to illegal fires and cooking along the parkway in an effort to reduce the number of new fire outbreaks.

Visitors to Sacramento County Regional Parks should be aware of the following regulations:

Open flame fires are NOT allowed, and barbecuing is only permitted in designated picnic areas.

Smoking is only allowed in developed picnic areas, asphalt surfaces, golf courses and levee tops along the American River Parkway.

Sac County's Budget Released, Hearings Set

Sacramento County News Release

SACRAMENTO COUNTY, CA - The Sacramento County Recommended Budget for Fiscal Year (FY) 2023-24 has been released. The Board of Supervisors will begin hearings on the Recommended Budget at 9:30 a.m., Wednesday, June 7, in Board Chambers at the Sacramento County Administration building, located at 700 H Street in Sacramento.

The public is invited to attend the hearings and be heard on any items in the budget, either publicly, over the phone or through written comments. Budget hearings will also be telecast live on Metro Cable 14 and on the County's website.

The hearings will continue beginning at 9:30 a.m. through June 8 and 9, if necessary.

This year's \$8.4 billion spending plan is a 6.4% increase compared to the FY 2022-23 Adopted Budget. Of the total \$8.4 billion budgeted:

\$3.2 billion is in Enterprise and Special Revenue Fund appropriations (utility rates, fees and other dedicated revenue); \$3.9 billion is in General Fund appropriations (funded with \$979 million in discretionary resources, \$1.3 billion in reimbursements from restricted funds, and the

remaining \$1.7 billion in Federal, State and fee revenue dedicated to specific purposes); \$1.3 billion in Restricted Funds

The Board's budget priorities, based on the budget priority survey results of adult residents in Sacramento County, for the uses of General Fund discretionary resources are:

Complying with the County's legal, financial, regulatory and policy obligations; Maintaining existing service levels budgeted for County programs, improving effectiveness and efficiency where possible and limiting the extent to which reductions in categorical revenue are backfilled with discretionary resources; Funding new or enhanced programs that focus on the most critical and urgent needs, with the priority focus areas being 1) addressing homelessness and its impacts and 2) improving the condition of streets and roads in the unincorporated County

The Recommended Budget's most significant new or enhanced programs include:

Mays Consent Decree Jail Population Reduction - The Recommended Budget includes \$34 million in appropriations, with \$7 million in Net County Cost and \$1 million in AB 109 semi-discretionary revenue funding to fund new or

enhanced programs aligned with the County's jail population reduction plans to comply with the Mays consent decree.

Mays Consent Decree Remedial Plan - \$10 million in Net County Cost included in the Recommended Budget in the Sheriff and Correctional Health budget units to fund continued efforts to meet the County's obligations under the Mays consent decree remedial plan, including additional staffing and services.

Addressing Homelessness - \$10 million (\$2 million Net County Cost) to fund new programs and services addressing homelessness in the County, including establishing a new Community Outreach Recovery Empowerment (CORE) site in downtown Sacramento, adding outreach teams at existing CORE sites, adding behavioral health staff and vehicles for Homeless Engagement and Response Teams (HEART), adding outreach capacity for Encampment Services Teams (EST), and funding for equipment and office space for the new Homeless Services and Housing Department.

Additionally, the Recommended Budget includes Growth associated with mitigating the community impacts of homelessness, including enhanced funding for abandoned or inoperative vehicle towing and

shopping cart enforcement.

Health Services - Overall, the Health Services budget includes \$84 million of Growth funded almost entirely by State, Federal and Mental Health Services Act (MHSA) revenue.

In addition to the Growth identified in the Mays Consent Decree Jail Population Reduction and Addressing Homelessness sections above, recommended Growth includes \$14 million for Cal-AIM performance-based incentive programs, \$14 million to construct a new Children's Mental Health Psychiatric Health Facility and Crisis Stabilization Unit, \$10 million to construct a new Mental Health Rehabilitation Center, \$5 million to increase the Children's Mental Health Flexible Integrated Treatment contract pool, and \$2 million to increase existing Full Service Partnership contracts.

Child, Family and Adult Services - \$17 million (\$3 million Net County Cost) to support Child Family and Adult Services' programs, including one-time State funding of \$7 million to implement the Families First Prevention Services block grant program and \$2 million in Net County Cost to provide additional funding for Child Protective Services welcome and assessment center contracted services.

Scheduled presentations, public comment and deliberations will occur in the following order:

In-Home Supportive Services (IHSS) Public Authority Budget; Public Comment on IHSS Public Authority Budget; Board Deliberation/Approval of IHSS Public Authority Budget; Introduction by County Executive of Recommended Budget and Capital Improvement Plan (CIP); Sheriff; District Attorney; Mays Consent Decree; Health Services; Homeless Services and Housing; Public Comment on Recommended Budget and CIP; Board Deliberation/Approval of Recommended Budget and CIP

The budget letter and a complete set of budget documents may be found online and at the County Executive's Office, 700 H Street, Room 7650.

The Recommended Budget is a preliminary spending plan; the Revised Recommended Budget will be presented to the Board in September for deliberation and adoption.

Homeless Student Count Grows

As the number of unhoused students in California’s public schools continues to rise to pre-pandemic levels, experts and educators fear that today’s economy paired with the state’s unrelenting housing crisis will lead to unprecedented rates of homeless youth.

According to updated data released today by the California Department of Education, there are about 5.9 million students enrolled in public schools this school year, close to 40,000 fewer students than last year or a .7% drop. But the number of students experiencing homelessness increased by 9%, about 16,000, to a total of approximately 187,000 kids.

The overarching cause of homelessness among all Californians is the perennial shortage of affordable housing in the state, according to Angela James, a researcher at UCLA’s Center for the Transformation of Schools.

“It’s alarming to me, quite frankly,” James said. “Housing instability may be deepening in California as a result of the pandemic.”

The new data signals a return to pre-pandemic numbers. Last school year, about 2.9% of students qualified as homeless. The percentage is up to 3.2% this year, about the same as it was in 2019-20.

“As a state we have not made the housing and well-being of our population a priority,” James said. “Sadly, social policies have not been responsive to the needs of young people and

their families.”

Experts struggle to explain why homeless numbers dropped during the pandemic. They said students and their families may have been moving around during the early months of quarantine, so they may not have been counted. Or unhoused students may have just been falling through the cracks.

“In some cases, districts could be getting better at identifying students,” said Dion Burns, a senior researcher at the Learning

Policy Institute.

Student homelessness rose this year for the first time since 2020. The count includes students living in motels, trailer parks, campgrounds or public spaces.

While statewide numbers indicate a return to pre-pandemic levels, 13 of the 20 largest districts in the state have more students experiencing homelessness now than they did in the 2019-20 school year.

Since 2015, rates of

homelessness were rising gradually up until 2020, when they started dropping steadily. Student homelessness rose this year for the first time since 2020.

The California Department of Education uses a federal definition of homelessness that includes students living in motels, trailer parks, campgrounds or public spaces.

School districts and county offices of education employ liaisons who keep tabs on

students and families experiencing homelessness. James said they’re often shorthanded, so collecting data may have been a challenge, especially during the chaos of 2020 and 2021.

Many unhoused students and their families have been evicted from their homes, James said. She recalled her own personal trauma of having her family’s furniture moved out to their front lawn when they were evicted. With no home, students and their families might go from one temporary shelter to another with no sense of how long they can stay in one place.

“The degree to which that impacts a child cannot be underestimated,” James said.

She added that teachers are fortunately better prepared to work with these students than they were in past decades. When a student acts out or even gets violent, a teacher might try to calm the student instead of resorting to disciplinary actions like detentions or suspensions.

According to the state’s new data, the numbers of foster youth, students with disabilities and students from low-income households have all increased by between 2% and 3%.

The rate of decline for overall enrollment shows signs of stabilizing after plummeting in the first years of the pandemic. Kindergarten enrollment took the biggest hit, but is starting to climb back up. Enrollment went from about 71,000 in 2020-21 to about 130,000 this year, but state officials said it’s partly due to the state’s expansion of transitional kindergarten. ★

CHP Shifts into Overdrive to Halt Reckless Driving

SACRAMENTO, CA (MPG) - The California Highway Patrol (CHP) is accelerating its efforts to halt illegal street racing and sideshows plaguing the state’s roadways and destroying the lives of innocent victims. To increase awareness about the devastation and destruction caused by this illegal and dangerous driving behavior, the CHP unveiled a new multi-media campaign while standing amid a three-dimensional installation featuring an actual crashed vehicle along Melrose Avenue in Los Angeles.

The billboard, a striking visual

reminder, is just one of the more than 50 displays being erected throughout the state reminding drivers about illegal street racing and sideshows, “Thrills That Kill.” The public can expect to see the billboard campaign through the summer months in areas of California that have seen a high number of illegal street racing and side show activity. Among the locations: Los Angeles, the Bay Area, and the Central San Joaquin Valley.

Illegal sideshows have been occurring at an alarming rate in California, and they continue to get bigger and more dangerous. In 2021, the CHP responded to more than 7,300 incidents

statewide with nearly 123,000 participants. While the number of incidents decreased by approximately 50 percent last year, there is still a significant amount of work to be done to keep California’s communities, and those who use our roads, safe.

“Illegal street racing and sideshows put lives at risk, upset the quality of our neighborhoods, cause damage to private and public property, and in some cases, have resulted in the death of innocent people,” CHP Deputy Commissioner Troy Lukkes said. “Through our ongoing efforts we want to send the message

throughout California that this dangerous and illegal activity will not be tolerated.”

Over a 5-year period, illegal street racing and sideshow activities have resulted in 264 crashes. Of those incidents attributed to this reckless behavior, 30 crashes were fatal, and 124 others resulted in injuries.

To combat this trend, the CHP has been working with its public safety partners and community-based organizations throughout the state. Together, we are engaging in a strong education and enforcement campaign with the goal of keeping all who use California’s roadways safe by encouraging others

to make good choices behind the wheel.

Funding to support the CHP’s efforts were made possible by the Governor’s approval of a one-time state budget allocation of \$5.5 million at the request of California Assemblymember Vince Fong and a former Assemblymember, Sacramento County Sheriff Jim Cooper. The funds are being used to support state and local task forces to end dangerous sideshow activities that have become a major problem in communities throughout the state.

The mission of the CHP is to provide the highest level of Safety, Service, and Security. ★

became official in January of 2023 and will assume most of the budget and programs from existing departments on July 1, 2023. Part of DSHS's mission is to increase the diversity and accountability of its programs and outcomes.

The goals for year one are to increase communication from the County both internally to County employees and externally to those living unhoused, advocates, stakeholders, residents and business owners.

This includes increasing engagement in the community, both with those being served and those wanting more information about the department, the County and the overall work being done to address homelessness in the region.

DHS is committed to sharing outcomes. Reporting out data on the number of people that have engaged with our programs and services, the number of people currently being served and results of those that have exited programs and services.

The County is also making a concerted effort to be better storytellers, both in sharing the successes of our clients and programs, but also in our own journalistic

reporting. While the County has historically relied on trusted reporting from its local media partners, the need for accuracy and consistency has never been greater. To this end, the County will use its own communication channels to their fullest extent and work to position County staff and trusted partners as the source of information, not the media. The County will also endeavor to not just share the wins and successes, but also the process and the lessons learned from shortfalls.

In conjunction with the workshop, the County and staff from the City of Sacramento also reported on the six-month status update of the City/County Partnership Agreement.

Homelessness is a Countywide issue that impacts everyone. Meaningfully addressing the various aspects of each person's homelessness requires creative collaboration and sustainable solutions. On June 7, staff will provide a more in-depth look at the funding surrounding homelessness Countywide. The County is investing more than ever in creating and managing diverse programs, dynamic partnerships and impactful solutions that will work towards the mission of ensuring homelessness is rare overall and brief when it occurs. ★
