Birds and Breakfast

CARMICHAEL, CA (MPG) - Coffee and cormorants; hawks and hash browns; bagels and bushtits. Effie Yeaw Nature Center's Bird and Breakfast fundraiser proves that - for nature lovers - breakfast comes a close second to bird watching.

On March 18 and 26, experts will lead safaris to view birds in their most industrious season. Hot brunches follow. Because the events sell out, reservations are required.

Participants will see at least 40 species incubating, courting, feeding and nest-building. The wildlife experience follows trails in the 99-acre preserve and continues to river-side reaches, where ducks

abundant and elegant waders include egrets, herons and sandpipers.

Audubon scouts work beforehand to locate spots where visitors can observe nurseries under construction. Hawks nest in branch crooks; higher still, hummingbirds camouflage walnut-sized cradles. Nest-watching is enhanced by viewing scopes.

The \$55 safari on Saturday, March 18 is followed by a catered gourmet buffet. On Sunday, March 26, Carmichael Kiwanis volunteers will offer a pancake spread. The second program suits families with children aged six and up (under 11-year-olds are \$5 each).

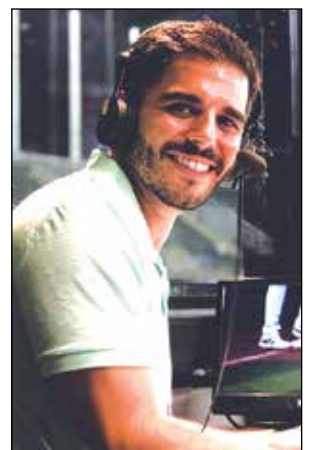
Animal ambassadors will be on hand for close encounters. These

include a Swainson's hawk; a Peregrine falcon, an American Kestrel and a great-horned owl. Silent auctions of bird-related goodies accompany breakfast.

As trail expeditions take an hour or more, neither of the programs is recommended for kids under six. Participants should wear stout shoes and bring binoculars. Both Bird and Breakfast programs begin at 8 am. All proceeds assist the Nature Center's educational outreach.

WEST SACRAMENTO, CA (MPG) - After receiving interest from across the country, the Sacramento River Cats, proud Triple-A affiliate of the San Francisco Giants, are thrilled to announce Zack Bayrouty as the new voice of the franchise.

Bayrouty replaces long-time River Cats announcer Johnny Doskow, who accepted a position with the Oakland Athletics in January. The Worcester, Massachusetts native Bayrouty becomes the fourth voice of the River Cats, following Jeff Walker (2000), Doskow (2001-2022), and Spanish-broadcaster Jose Reynoso (2000-2008).

"We received an overwhelming amount of interest in the position and Zack quickly separated himself from the pack with his mixture of on-air talent and multimedia experience," said Chip Maxson, President and COO of the River Cats. "Johnny Doskow was synonymous with Sacramento sports for over two decades and we feel Zack is the perfect heir to usher the franchise and fans into a new era."

Although from the east coast, Bayrouty is familiar with Northern California, calling games for the Oakland-affiliated Single-A Stockton Ports for 14 seasons, as well as serving as the play-by-play of University of the Pacific (Stockton) men's basketball since 2010 (13 seasons). He has spent the last three seasons broadcasting for the PCL-rival Reno Aces (Triple-A affiliate of the Arizona Diamondbacks), which included a 2022 PCL Championship.

"I'm beyond grateful for the opportunity to join the River Cats family and be part of an amazing team," said Bayrouty. "To have the microphone passed to me from Johnny Doskow is one of the great honors of my life. I know what his voice meant to the fans and what his presence meant to the community, and it's my privilege to continue to build on that legacy in Sacramento."

County Earns State Prohousing Designation

SACRAMENTO COUNTY, CA (MPG) - The California Department of Housing and Community Development (HCD) announced on Friday, February 3, 2023, that Sacramento County has earned the state's Prohousing Designation. Sacramento County, along with Placer County and the City of El Cerrito, joins seven other jurisdictions recognized for a commitment to policies that increase housing supply such as accelerating production, promoting equitable and sustainable zoning and land use, reducing development costs and providing financial subsidies. Sacramento County is also now eligible for the Prohousing Incentive Pilot (PIP) Program that rewards Prohousing communities for such commitments.

To earn the Prohousing Designation, cities and counties must demonstrate they are promoting climate-smart housing in a variety of ways, including but not limited to streamlining multifamily housing development, up-zoning in places near jobs and transit to reduce emissions, and creating more affordable homes in places that historically or currently exclude households earning lower

incomes and households of color.

Sacramento County's application highlights include the modification of development standards and other applicable zoning provisions to promote greater development intensity. In addition, the county provides impact fee reductions for residential development and permits "missing middle" housing in typically lower-density, single-family

residential zones. Lastly, the county uses holistic planning strategies in an effort to reduce vehicle miles traveled and greenhouse gas emissions.

"The Planning and Environmental Review Division has been hard at work updating its Zoning Code to allow for streamlined residential development," said Troy Givans, Sacramento County

Rio Americano HS Celebrates the Opening of its Renovated CTE Building

CARMICHAEL, CA (MPG) - Rio Americano High School celebrated the opening of its renovated Career Technical Education (CTE) building with a ribbon-cutting ceremony on Feb. 7. More than 100 students, staff and community members gathered for the event.

The renovated building houses the school's medical sciences and manufacturing pathways. Students from each pathway showcased their work during the event, with students from the medical sciences pathways demonstrating their skills by greeting patients at their reception desk, checking vitals and prepping injections.

"The medical pathway students now have a space that resembles a hospital, giving students the opportunity to learn essential skills in a real-world setting," shared Cliff Kelly, principal at Rio Americano High School.

The Medical Assistant pathway is for students who are interested in fields such as medical assistants, EMT, nursing, physician assistants, physicians, x-ray tech, athletic training, physical therapist assistant, physical therapy, kinesiology, nutrition, and other medical related fields. Students will have hands-on-training, such as taking blood pressure, rooming patients, assisting with minor surgery, and/or front office duties. In their senior year, students will be placed in the medical field for on-the-job experience.

Students from the manufacturing pathway showcased a robot they constructed earlier in the year by having it greet and distribute scissors to the ribbon cutters prior to the ceremony. The manufacturing pathway now has a renovated and reconfigured space that previously housed a woodshop and metal shop. An innovation lab has also been added.

displayed the teaching process in the manufacturing of robots at the CTE Robotics shop.

Students in the highest course of the pathway can elect to be members of the Rio Robotics team, where they get to compete in high-stakes competitions both regionally and nationally.

The renovation project was made possible by voter-approved bond funds. The construction and design team consisted of

CORE Construction, Innovation Construction Services and JK Architecture Engineering.

High schools throughout San Juan Unified offer Career Technical Education (CTE) programs to students. These courses provide hands-on, unpaid training that is designed to prepare them for life after graduation with entry-level, marketable skills.

There are former CTE

students in our community who are teachers, nurses, dental assistants, lawyers, doctors, accountants, bakers, chefs, entrepreneurs, engineers, computer techs, mechanics, law enforcement officers, vet techs, etc.

Every year, the graduates are surveyed so that CTE is updated on their employment and educational status. To date, nearly all persons responding to a

telephone survey have indicated they felt their training in the various CTE programs was good to excellent. Almost nine out of ten people also stated that their CTE training served as an influencing factor in their present work or educational pursuits.

The unemployment rate of CTE graduates has consistently been less than half of the rate of the general population for the same age group. ★

Community Development Director. "These updates have allowed for an expedited permitting process, which we believe will accelerate housing development in the unincorporated County."

"The County offers a one-stop shop for fee deferral/waivers for County of Sacramento, Sacramento Area Sewer District, Sacramento Regional County Sanitation District, and Sacramento County Water Agency impact fees on regulated affordable residential projects to allow for streamlined fee deferral/waiver process. In addition, the County's participation in Statewide Community Infrastructure Program (SCIP) provides additional financing tools to ease development impact fees for public infrastructure needed for residential projects."

The State of California budget for

the fiscal year 2019-20 established the Prohousing Designation Program as part of a spectrum of support, incentive and accountability measures to help meet California's housing goals. Increasing the availability of housing statewide is critical to bettering the quality of life of all Californians and to ending homelessness. Communities that earn the Prohousing Designation receive incentives in the form of additional points and/or other preferences in the scoring of competitive housing, community development and infrastructure funding programs administered by HCD.

Prohousing jurisdictions are also eligible for community development resources through the new PIP Program. The competitive program has \$25.7 million in additional flexible funding available to help accelerate housing production and expand the preservation of affordable housing ★

Where's Everybody Going?

In 2021, it was big news — the "California exodus." Now, it just looks like the new trend: California's population is still shrinking.

According to the latest population estimates from the U.S. Census Bureau, California's total population declined by more than 500,000 between April 2020 and July 2022.

Put another way, 1 out of 100 people living in California at the beginning of the COVID-19 pandemic had, two years later, left the state — either by U-Haul or by hearse.

Where'd they all go? Some died, though there were far more births; Some left the country, though on net, more immigrants arrived; The major driving factor: Californians departing for other states.

Just counting out-of-staters coming in and Californians leaving, the state's population saw a 871,127 net decline. If you're wondering why the state lost a congressional seat at the beginning of this decade, this is why.

This isn't a national problem. It's a California, New York, Illinois and Louisiana problem. California is one of only 18 states that saw its numbers decline and had the fourth biggest drop as a share of its population.

Topping the list of rapid growers are other Western states that aren't on the pricey coast: Idaho, Montana and Utah.

That may be why Utah Gov. Spencer Cox recently pleaded with Californians to stay put rather than come as "refugees to Utah." UCLA economist Paul Ong was quoted: "While salaries in other regions and states are lower, the cost of housing is even lower."

But not all of California is shrinking at the same rate. And no surprise, housing seems to be the key explanation why. A San Francisco Chronicle analysis of local population changes between 2010 and 2020 found that the fastest growing city in California was the East Bay bedroom community of Dublin, which permitted four-times as many new housing units per person as nearby San Francisco.

But as California lawmakers grapple

with the housing and homelessness crisis, a familiar clash is emerging between state and local lawmakers.

Despite a no-nonsense warning from Attorney General Rob Bonta, elected officials in Huntington Beach are vowing to fight state mandates to permit more than 13,000 new units over the next decade. They also pledged to push forward a local ordinance to exempt the city from the "builder's remedy" — an untested state law that punishes cities that haven't met their state housing goals by allowing developers to build as many units as they like, so long as at least 20% are set aside for low-income residents.

In the well-to-do 'burbs of Silicon Valley, builder's remedy applications are beginning to pour in. But some cities are refusing applications outright, while others are charging five-figure processing fees.

A nonprofit financed by the California Association of Realtors has been on a state-spanning lawsuit spree, asking courts to invalidate multiple cities' housing plans, paving the way for builder's remedy applications.

With hundreds of cities still deemed "out of compliance" with state housing requirements, the Department of Housing and Community Development set up a new web portal inviting Californians to "report potential violations of state housing law."

Remember when San Francisco Sen. Scott Wiener introduced a bill earlier this week that would require any developer who wants to make use of a particular housing law to pay their workers union-level wages — but stopped short of forcing developers to hire union members?

In an ideological divide between the state building trades union and the carpenters, that put Wiener squarely with the carpenters.

The trades responded. They aren't impressed. Trades President Andrew Meredith, in a statement: "Proponents' attempts to paint this as an affordable housing play are disingenuous. This is clearly all about putting more money in developer pockets."

And in many places in California, high housing costs are a driver of the gap between rich and poor. ★

Is Ending Homelessness Just a Matter of Money?

Being what it is, California has a mélange of complex public policy issues – some of them fully blown crises – that defy resolution year after year, decade after decade.

Rather than recognize and deal with their complexities, the state's politicians tend to condense responses into money.

K-12 education exemplifies the syndrome. The state's nearly 6 million public school students perennially fail to make the cut in national tests of academic achievement, often trailing states that spend far less per-pupil on their schools.

It indicates that money is only one factor, and perhaps not the most important one, in educating children. Nevertheless, the political debate over the state's educational deficiencies begins and ends with how much money is being spent, thereby providing a convenient excuse for failure.

California's newest crisis, the nation's highest level of homelessness in both absolute and relative terms, is following a similar arc.

Why upwards of 200,000 Californians, and probably more, are homeless involves factors that, much like educational aptitude, are as individual as fingerprints. While theories on causes and

potential cures abound, once again the politics of the issue is focused on money – how much to spend, who spends it and who, if anyone, is held accountable for outcomes.

The politics of homelessness – or rather of spending on homelessness – appear to be entering a very contentious phase.

Early in his governorship, Gavin Newsom appointed himself as the state's homelessness czar and during the first three years of his governorship (2018-21) the state spent nearly \$10 billion on battling the social malady, according to a new state report. The money paid for 35 different programs administered by nine different state agencies.

That total does not count billions more in homelessness spending by federal and local governments or the additional billions in more recent years. The 2022-23 budget allocated another \$10.2 billion while Newsom, facing deficits, proposes an additional \$3.4 billion for 2023-24.

Despite the spending, homelessness numbers have continued to rise and legislators know that the voting public is losing patience.

"It's very frustrating for the general public when they hear that in the state, we're spending billions – and that's billions with a B – of dollars on homelessness and housing. And yet they don't feel that they're seeing enough of an impact in their communities," Assemblywoman Laura Friedman, a Burbank Democrat, said.

In recent months, Newsom has blamed local governments for a lack of aggressiveness, saying he would be "hard-pressed to make a case to the

Legislature to provide them \$1 more" if local officials don't accelerate homelessness responses.

Newsom has not yet told the Legislature how he would compel stronger local action. Local officials say they need clear lines of accountability and a dependable stream of money to finance ongoing programs rather than yearly allocations that can vary widely.

"When you look at child welfare, transportation, criminal justice, health care, education, it's clear who's supposed to do what and how it's funded," says Graham Knaus, CEO of the California State Association of Counties. "Not with homelessness."

So, one might wonder, if successfully battling homelessness is a matter of money, how much would it take?

Fourteen months ago, the Corporation for Supportive Housing (CSH) and the California Housing Partnership released a report projecting that California could end homelessness by 2035 were it to spend \$8.1 billion a year until then – the vast majority of it for housing.

That totals more than \$100 billion, a big number that does not include ancillary services such as food, medical care and treatment for mental illness, drug addiction and alcoholism. However, it might be a bargain if, in fact, it worked.

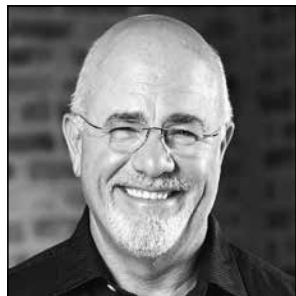

Dave Ramsey Says

Are You Willing To Do What It Takes?

Dear Dave,

I'm an anesthesiologist, and I make between \$260,000 and \$270,000 a year. My wife is a stay-at-home mom who takes care of our preschool-age kids. We have about \$50,000 in a retirement fund, \$50,000 in consumer debt, \$220,000 in student loan debt, and we owe \$280,000 on our house, which is worth around \$500,000. We're thinking about using our retirement fund to pay off credit cards and such, then selling the house and using the money to pay off the student loans. After that, we'd live in an apartment for a while, save up 20% or more for a down payment on the next home, and do things right financially moving forward. What do you think about this game plan?

— Jake

Dear Jake,

Wow, I really appreciate your motivation, man. You're willing to do whatever it takes, and that's pretty cool. Not many people have the determination to do the kinds of things you're talking about.

I almost never tell people to sell their homes. If you actually can't afford it, that's one thing—and in that case, we'd sell the house. If it's the only way to avoid bankruptcy, we'd get rid of it in a heartbeat. But in your case, things are a little different. You're in a pretty deep hole, but your income as an anesthesiologist gives you a really big shovel you can use to carve out some steps, get up out of that hole, and fill it in so you never fall in again.

Now, this is going to mean some real lifestyle changes for a few years. I'm talking about beans and rice, and no vacations. There's no more living like a rich doctor, because you're not a rich doctor—you're a broke doctor. We're going to temporarily stop adding to your

retirement fund, not cash it out, and we're going to start living on a written, monthly budget where every single dollar is given a name and a purpose.

Cleaning up \$270,000 of debt sounds scary. But with a \$260,000 income and the other changes we talked about, you could put \$90,000 a year toward all this and have it completely cleaned up in just three years. That's what I'd do if I woke up in your shoes. It will set you free for the rest of your lives to invest and save.

Get on it, doc. You can do this!

PG&E Urges Customers to See if They Qualify for Federal Program

OAKLAND, CA (MPG) - As Low Income Home Energy Assistance Program (LIHEAP) Action Day in Washington, D.C. occurred on February 16, 2023, Pacific Gas and Electric Company (PG&E) urges customers who are struggling to pay energy bills to learn more about the program and see if they qualify.

National Energy and Utility Assistance Coalition (NEUAC) hosted the LIHEAP Action Day. Hundreds of community advocates from throughout the country will travel to Capitol Hill to urge continued, substantive funding for the program, including PG&E and local LIHEAP service providers.

The federally funded program helps low-income households with their energy bills, including those at risk of having service interrupted for non-payment. LIHEAP is overseen by the California Department of Community Services and Development (CSD) and administered by nonprofit agencies that can help financially impacted residents in providing assistance toward their energy bill. Eligibility for the program is determined by income, household size, place of residence, and other factors.

Last year marked the highest amount of bill credits received by PG&E customers – in total, more than \$75.4 million. This January, PG&E customers received a total of \$8.6 million, with the average bill credit

totaling nearly \$1,000. Available funds will vary based on customer circumstances and funding availability.

PG&E is not responsible for administering the LIHEAP program. To find the local LIHEAP agency in your area to apply, visit csd.ca.gov/energybills or call (866) 675-6623 for more information.

To take advantage of additional programs, tools and savings opportunities, PG&E recommends customers become more familiar with the following:

Separate from CARE, income-qualified households with three or more persons can apply for the Family Electric Rate Assistance (FERA) Program at pge.com/FERA for an 18% discount on their electric bill;

Relief for Energy Assistance through Community Help (REACH) provides income qualified customers with financial assistance during times of hardship;

Customers on the Medical Baseline program who have special energy needs due to certain qualifying medical conditions can receive a lower rate on monthly energy bills;

Budget Billing averages customers' monthly energy costs to help monthly payment amounts remain more consistent, even if energy use changes significantly from season to season.

Arrest Made in Shooting at Smoke Shop

SACRAMENTO COUNTY, CA (MPG) - Just before 6:00 P.M. on Saturday, January 28, 2023, the Sacramento County Sheriff's Office Communications Center received a call regarding shots fired near a business on Arden Way. Moments later, the Sacramento Police Department was also notified of a shooting in the area. At approximately 6:04 P.M., an officer from the Sacramento Police Department was waved down by the victim at a nearby gas station. Deputies arrived on scene and learned the shooting actually took place at a smoke shop on Arden Way, approximately a half mile away.

The victim, an 18-year-old male, was transported to a local hospital by ambulance for his injuries; he fortunately survived.

Sacramento County Sheriff's Office detectives and Crime Scene Investigators responded to the crime scene, interviewed witnesses, and gathered evidence. Detectives were able to identify two suspects responsible for the shooting: a 17-year-old male juvenile and 20-year-old James Freeman.

On January 29, 2023, detectives located the two suspects at a motel on Alhambra Boulevard within the incorporated city of Sacramento. With the assistance of the Sacramento Police Department SWAT Team, the two suspects were taken into custody without incident. The juvenile suspect was taken to juvenile hall, while Freeman was booked into the Sacramento County Main Jail for attempted murder (PC 664/187). He is currently ineligible for bail and is scheduled to appear in court on January 31, 2023, at 3:00 P.M. ★

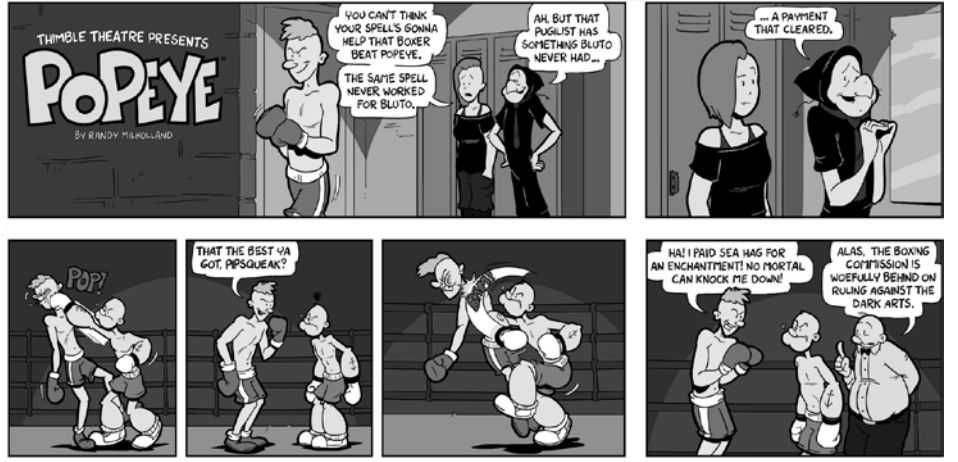

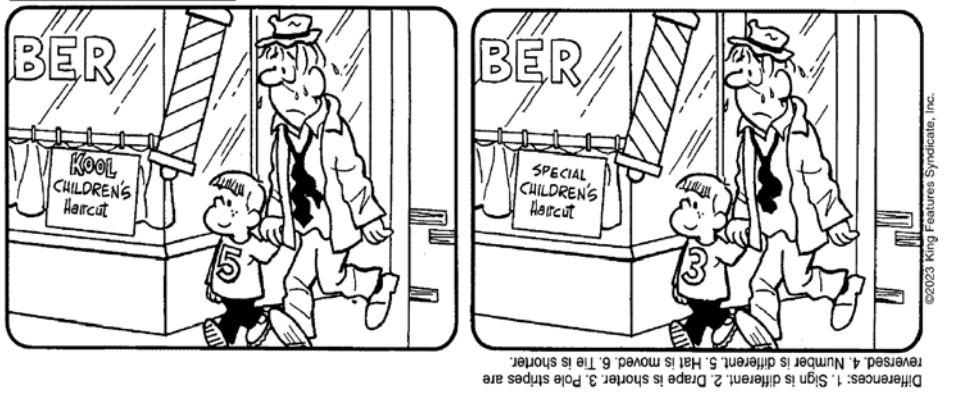

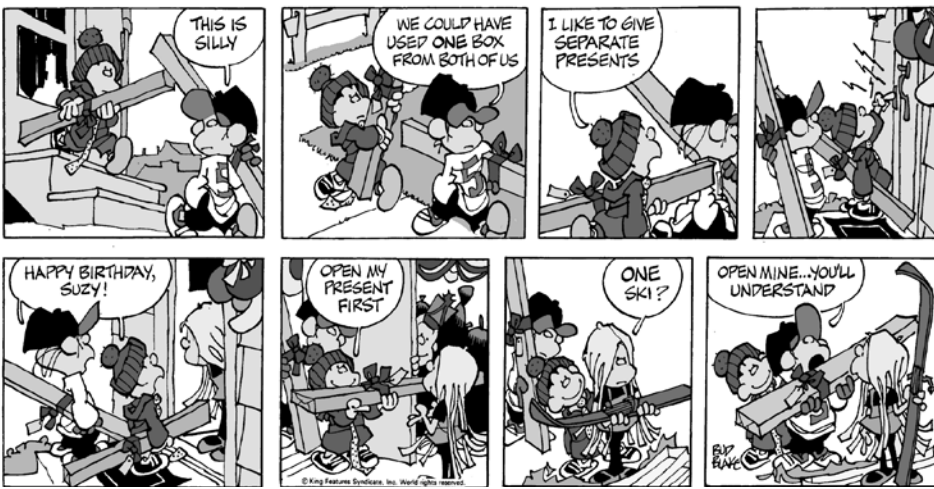

Bera Reintroduces Bicameral Bill for Americans to Sign Up for Health Care

WASHINGTON, DC (MPG) - On February 17, 2023, Representative Ami Bera, M.D. (D-CA) introduced the *Easy Enrollment in Health Care Act*, bicameral legislation to simplify health care enrollment for Americans by allowing them to enroll in coverage when they file their federal tax returns.

“As a doctor who has cared for our nation’s patients, I have seen first-hand how stressful and overwhelming it can be to sign up for health care coverage,” said Representative Ami Bera, M.D., who previously served as Chief Medical Officer for Sacramento County. “That’s why I’m introducing the Easy Enrollment in Health Care Act with Senator Van Hollen to help millions of uninsured Americans automatically enroll in affordable health insurance at the same time they file their federal tax returns. It’s critical that we cut burdensome red tape to make it easier for Americans to get insured.”

Senator Chris Van Hollen (D-MD) introduced companion legislation in the U.S. Senate earlier in the week.

“More Americans than ever can access free or low-cost health insurance through the Affordable Care Act, yet millions are still uninsured because of barriers they face in enrollment. Getting covered doesn’t need to be this complicated – and that’s why I’m introducing this bill to help Americans more easily find the health plans that work best for them by simply checking a box on their federal tax returns. Easy Enrollment is a simple, yet powerful approach that has already been proven in Maryland to boost participation in affordable health care plans, and it’s time we make it available nationwide,” said Senator Van Hollen.

BACKGROUND

Nearly 2 in 3 uninsured Americans are eligible for programs like Medicaid, CHIP, and Advanced Premium Tax Credits but still aren’t covered, totaling in over 18 million people – including 13 million who are eligible for free insurance at this very moment. This “enrollment gap” disproportionately harms families of color. In 2019, adults of color were 41% more likely than

whites to qualify for health programs but not be enrolled, and nearly 2 in 3 uninsured children who qualify for Medicaid or CHIP are African-American, Latino, Indigenous, or other children of color. However, 4 in 5 uninsured citizens and lawfully present immigrants filed federal income tax returns, including 64% of those with incomes below 150% of the FPL.

Under this bill, Americans would be able to check a box on their federal income tax returns that would connect them with available health care programs in their state. By checking the box, the IRS would be authorized to share the data they already have on file with the individual’s state health care marketplace exchange. A menu of options would then be sent back to the individual in a formal letter – at which point that person could either chose to opt-in to a specific program or remain uninsured if they choose. Individuals would have a 60 day special enrollment window to make your choice, and those who are eligible for a zero-premium plan who neither select a program nor opt out would be paired automatically with the program that provides the highest coverage with no premiums.

This type of tax filing system could reach the millions of uninsured Americans who know little about health programs or their eligibility to receive free health care. In 2017, after ample public education and 4 open enrollment periods, 40% of uninsured Americans were still unaware of health insurance marketplaces. By checking the box, these same families could see whether they qualify for free or low-cost health care and then enroll. This legislation brings health care information directly to people who need it most – and makes it easier than ever to sign up for a plan with zero premiums.

The bill is supported by a large and diverse group of organizations, including: Families USA, Protect Our Care, Third Way, Blue Cross Blue Shield Association, First Focus, Alliance of Community Health Plans, American Academy of Pediatrics, American Cancer Society Action Network, American Heart Association, and Centene. ★

SACRAMENTO COUNTY, CA (MPG) - The County Board of Supervisors intends to continue providing \$1 million through the Transient Occupancy Tax (TOT) Grant Program to support non-profit organizations located in Sacramento County in Fiscal Year 2023-24. For the last 7 years, the Board of Supervisors has awarded funds to organizations that carry out community-based programs and/or services in the areas of economic and workforce development, arts and culture, community development, and health and human services. The County began setting aside funding for this purpose in 2017.

Grants will be allocated through a competitive process and applicants must meet eligibility and funding requirements. Applications will

be accepted online beginning February 10, 2023, through the County's Office of Budget and Debt Management with a deadline of March 13, 2023.

Funding for the TOT Grant Program will come from County Transient Occupancy Tax (TOT) revenues. Transient Occupancy Taxes are levied on guests who occupy rooms in hotels, motels and other temporary lodging accommodations in the unincorporated area of the County.

Grantee Award Approval June 2023

Grant Program Hearing Notification: Applicants will receive a second electronic notification of the schedule for the Board of Supervisors Hearing where recommended award selections will be made.

The Board of Supervisors will make the final determination and approval for all TOT Grant Program recipients.

County Budget & Dept Management Division staff will notify applicants of funding selections within 5 business days of Board Hearing approval. All notifications will be made electronically.

County Budget & Dept Management Division staff will draft and administer agreements between the County and grantees.
