

## SLEEPING CABIN FOR HOMELESS

**CARMICHAEL, CA (MPG)** - On July 18, Post office Mail Carrier Willie Shannon serviced his Foothill Farms route.

"By afternoon, it was around 100 degrees," he recalled. "I'm used to the heat. I'm also used to dogs and aggressive turkeys. I never expected to be a firefighter."

Circumstance makes heroes. For his actions on that day, Shannon (60) last week received a US Postmaster General Hero Award nomination. Air Force veteran and 21-year US Post Office employee Shannon scrambled from his truck and began hammering at apartment doors. No one answered. "I was blowing my horn to get attention," he said. "A lady from another unit came out to see what was going on. She pointed at a garden hose. I grabbed it and aimed upwards, trying to put out the fire out. Then I thought: holy smoke, I'd better call 911. I've got a hose spraying in one hand and a phone in explosion might have engulfed the entire 36-condo complex.

Fire fighters believe the mailman's actions averted disaster. "We don't encourage civilians to get involved in firefighting," noted Sac Metro Captain Kurt Katsuyoshi. "But Willie Shannon's actions were validated."

With the fire contained, the carrier called his supervisor to report a delay. He then calmly finished his deliveries. The afternoon's adventure went unnoted until an apartment resident - who witnessed the drama sang Shannon's praises in a letter to the Post Office. His award nomination quickly followed. "He's been our carrier for eight years," the neighbor said. "He's helpful, polite and respectful. 
## SCOE News Release

Delivering to an apartment complex at Connecticut Drive (Carmichael), he glanced at a second-floor balcony and saw billowing smoke. "I thought they were barbecuing up there," he recalled. "Then I saw big flames and thought, that's no barbecue." the other. I'm telling the emergency operator to get out here."

A garden hose alone would not have sufficed. Fire was imbedded in a wooden support beam that firefighters eventually hacked away. But Shannon's actions might have saved the apartment's sleeping tenant. Flames also came close to cars garaged downstairs. A gas tank

## **Ordinances to Prohibit Camping Approved**

### Sacramento County News Release

SACRAMENTO COUNTY, CA (MPG) - The Board of Supervisors on August 11, approved two ordinances addressing camping and encampments near critical infrastructure such as levees and government buildings, wildfire and flood risk areas during severe weather, near shelters for persons experiencing homelessness, youth-serving facilities and a separate ordinance prohibiting camping on the entire stretch of the American River and Dry Creek Parkways. The Board will formally adopt the two approved ordinances on August 23, and they will go into effect 30 days later.

As was mentioned several times by staff, county counsel and supervisors, these ordinances going into effect will not result in the wide-scale clearing of encampments. The County has both a legal and moral obligation to identify the highest priority camps, identify the needs of the campers and offer services and shelter as appropriate. The County is committed to applying a thoughtful approach in order to balance the needs of both the campers and the impacted community surrounding encampments.

"These ordinances provide another tool for County staff and our outreach partners to engage with folks experiencing homelessness camping illegally, assess their needs and determine the best course of action to move them away from critical infrastructure," said Board Chair Don Nottoli. "The time has come to balance the needs of our unsheltered population with the impacts that our communities and environment have been facing for years."

The ordinances provide law enforcement officials with the authority to specifically address the activities in these particular locations because of public health, safety and welfare concerns.

The critical infrastructure ordinance adds Chapter 9.120 to the Sacramento County Code to prohibit camping and encampments in the following priority areas: In, on or within 25 feet

of critical infrastructure or the entrance/exit of critical infrastructure; Up to 1,000 feet of a location providing year-round overnight shelter to people experiencing homelessness and the entrance/exit to such locations; Inside of, or within 30 feet of wildfire and flood risk areas during severe weather; And, within 25 feet of a youth-serving facility, defined as public or private primary or secondary schools and public libraries.

Violations would first be subject to verbal and written warnings and any person who violates the ordinance would be guilty of a misdemeanor. This also authorizes the County Executive or designee to promulgate rules, protocols and procedures for the implementation of the ordinance.

To read the full definitions of each identified priority area, read the full ordinance at the county website.

The Board also approved a separate ordinance that

addresses the Dry Creek and American River Parkway specifically.

"The American River Parkway is our region's most treasured recreational and ecological asset," said First District Supervisor Phil Serna. "As the stewards responsible for its protection, we are obligated to see that it is a clean and safe place for everyone to enjoy while ensuring those who feel their only option is to reside on the Parkway, have housing opportunities and access to services elsewhere in the county."

The following are key provisions of the ordinance:

Prohibition on camping or constructing, maintaining or inhabiting any structure or camping facility in the American River Parkway or Dry Creek Parkway, except with written permission from the Director;

Prohibition on modifying the parklands (e.g. dirt, landscaping) or accumulating furniture, household goods, or other items in order to create a structure; *Continued on page 12*

### About blood donation

To donate blood, individuals need to bring a blood donor card or driver's license or two other forms of identification that are required at check-in. Individuals who are 17 vears of age in most states (16 with parental consent where allowed by state law), weigh at least 110 pounds and are in generally good health may be eligible to donate blood. High school students and other donors 18 years of age and younger also must meet certain height and weight requirements.

Donors can also save up to 15 minutes at the blood drive by completing a RapidPass<sup>®</sup>. With RapidPass®, donors complete the pre-donation reading and health history questionnaire online, on the day of donation, from a mobile device or computer. Willie took the time to ring our doorbells and tell us to get out. Then he grabbed that hose. If not for him, our whole building might have gone up."

Shannon figures military and Post Office training kicked in on-cue. "The Air Force teaches you courage," he considered. "Letter carriers learn to be aware of their surroundings; to be the eyes and ears

of where they serve. Maybe it seems I was heroic, but I just did the right thing. I care about my customers; I'd do anything to help them.

"I'm thankful God's presence made me look up that day."

Willie Shannon's award nomination is being reviewed at Post Office Headquarters Washington DC; it will be presented later this year.



SACRAMENTO, CA (MPG) -The Sacramento Regional Transit District (SacRT) is reminding students and families that with the RydeFreeRT program, students in transitional kindergarten through 12th grade can ride the entire SacRT transit network for free. The program includes SacRT buses, light rail and SmaRT Ride on demand microtransit services.

The RydeFreeRT program is available for any youth that live or go to school within SacRT's service area, which includes the cities of Sacramento, Elk Grove, Folsom, Citrus Heights, Rancho Cordova and parts of Sacramento County. Approximately 220,000 students in grades TK – 12th, home-schooled students, and foster and homeless youth are all eligible.

SacRT launched the RydeFreeRT program in October 2019, at that time, SacRT experienced a 127% increase in student ridership (pre-COVID-19). Over the last year, SacRT provided over 2.4 million

free rides to youth across the region.

New RydeFreeRT cards for the 2022-2023 school year are distributed by schools and have a valid date from June 1, 2022, through June 30, 2023. For students that still need a RydeFreeRT card, visit SacRT's Customer Service and Sales Center located at 1225 R Street (adjacent to the 13th Street Light Rail Station) or Sacramento Public Libraries.

"Thanks to continued funding from the cities of Sacramento, Citrus Heights, Elk Grove, Folsom and Rancho Cordova as well as additional funding from the County of Sacramento, we are able to keep the RydeFreeRT program going into a fourth year," said SacRT General Manager/CEO Henry Li. "The fare-free program helps our region's youth by removing the transportation barrier to education, jobs, and healthcare."

"SacRT's award winning RydeFreeRT program for TK-12th grade students has benefited our community immensely and I could not be happier it is continuing for a fourth year," said SacRT Chair and Citrus Heights Council Member Steve Miller. "With this program, we are increasing mobility options and school attendance, reducing congestion and greenhouse gases and creating new rider habits."

"RydeFreeRT has become a model that many transit agencies across the nation are trying to replicate," said SacRT Board Member and Sacramento City Councilman Jay Schenirer. "This is an investment in our future connecting youth to school, work, internships and other education and career opportunities. It's great to see so many young riders on public transit!"

"At Sac City Unified our focus is on providing equitable access to high quality education. The costs and challenges associated with transportation can often create a significant barrier to that access," said SCUSD Chief Communications Officer Brian Heap. "The SacRT free transit program is a tremendous support tool for the district and our families. We have some middle and high schools where as many as onethird of students rely on SacRT to safely get them to and from school each day. Chronic absenteeism is a serious problem for schools, and we appreciate that our partnership with SacRT helps get more students to class every day."

## **Bearded Band** of Brothers Rock Park

CARMICHAEL, CA (MPG) - Beards, tattoos and solid American songs recently brought the multitudes - including scores of Harley Davidson riders - to Carmichael Park. The 2022 concert season revved to full throttle as veteran biker band, the Fryed Brothers, earned a warm reception on a hot night.

The Sacramento musicians have been in movies and made records with superstars. Of founding brothers Harry and Tommy Fryed, only fiddler Harry (62) remains with the group. Younger brother Tommy died of heart failure at 49 years old. Youngest of a Carmichael family of seven siblings, the brothers grew up on Carter Road and attended Rio Americano High School.

"From childhood, they loved music and they loved bikes," says their sister/manager Barbara Fryed. Harry and Tommy formed their band in memory of an older brother, Mark, who died when a car hit his motorcycle on the Fair Oaks Boulevard side of Carmichael Park in 1980.

Together, Harry and Tommy wrote more than 40 songs and, over 36 years of pro-gigging, the Fryeds have shared stages with Waylon Jennings, Charlie Daniels, the Doobies, Jefferson Starship, Tower of Power, Eddie Money, Blood, Sweat & Tears and Billy Idol.

"They have fans all over the world," says their manager. "My brother was joking that it only took 36 years to get on a Carmichael stage. But he was more than happy to play there." The Fryeds' mom still lives in Carmichael and at 90, she remains their biggest fan. By tradition, Harry dedicated "Amarillo by Morning" to his mom at the weekend concert.

The band's park arrival was orchestrated by the roar of dozens of motorcycles; their ensuing performance was as much a concert as a Harley Davidson convention. In the bikers' midst, Carmichaelites enjoyed all-American blues/rock and many unaccustomed sights. Facial hair, bare flesh and tattoos were the order of the day.

By Carmichael standards, it was a diverse group. But appreciation of the music was universal.

**SACRAMENTO COUNTY** - Sleeping cabin construction at Sacramento County's new concept "Safe Stay Community" to shelter persons experiencing homelessness has officially begun. The new project, located at 8144 Florin Road, on the corner of Power Inn and Florin at the former site of a now razed grocery store will have 100 sleeping cabins constructed on the site. Construction of the Pallet cabins is expected to take 10 days.

Once cabin construction is complete, infrastructure work such as running power and sewer lines will take several months to complete. In addition to the cabins, the site will have a sanitation trailer for restrooms and showers, staff quarters for the 24/7 on-site operator, a security booth to manage all persons on-site, a communal eating area, storage units for possessions guests bring that do not fit in their cabin and a pet relief area. The site is expected to begin welcoming guests late this fall. It will ultimately be able to shelter 125 people at any point in time.

"Seeing the Safe Stay sleeping cabins go up is very exciting," said District 2 Supervisor Patrick Kennedy. "It is it an important step forward in welcoming guests into this new sheltering model, and the community can begin to see how this will benefit the neighborhood and local businesses."

Pallet has built nearly 100 communities in 50 cities across the U.S., with 76 currently operating in 45 cities including multiple locations in Northern and Southern California. The unique design and capabilities of the cabins such as a door that can be locked for privacy and safety, heating and cooling to protect guests from extreme weather events and the individualized areas that further provide a sense of space that allows people to shelter and receive services with dignity and respect.

In addition to the hard working Pallet staff, the Pallet structures are being put together by members of the Sacramento Regional Conservation Corps (SRCC) – a non-profit, workforce development and education agency. They provide an opportunity for 18-26 year-old young adults to acquire paid work experience and job skills on conservation projects in a four county region. Young adults, from diverse backgrounds, receive technical skills training and educational achievement. Their area of focus is recycling and conservation projects that enhance and protect our environment.

## County Proclaims MonkeyPox Public Health and Local Emergency

**SACRAMENTO COUNTY, CA** (**MPG**) - On Tuesday, August 9, Sacramento County proclaimed a public health emergency and a local emergency in order to ensure appropriate resources and funding are available to the County in its response to monkeypox.

The proclamations of a public health emergency and local emergency do not signify an increased risk to the residents of Sacramento County. A proclamation of emergency allows the County to provide or receive mutual aid from other jurisdictions and assists in opening up available resources, mutual aid and staffing.

The proclamations follow the State of California's proclamation of emergency on Aug. 1, regarding monkeypox and the funding that would be made available. Proclaiming a local emergency is a prerequisite for requesting and receiving available federal or state funding.

"Proclaiming a state of emergency in response to Monkeypox helps the County to ensure uninterrupted access to resources necessary to lessen disease transmission," said Don Nottoli, Chairman of the County Board of Supervisors. "The proclamations should not be a reason for elevated concern; but rather, considered as mechanisms to assist in our mission to better respond to and contain the virus."

The County continues to work closely with the Centers for Disease Control and the California Department of Public Health on coordinated testing, investigations, and providing guidance and assistance to health providers in monitoring for monkeypox symptoms and gathering information to detect new cases for laboratory testing and confirming infection.

Transmission of monkeypox virus occurs when a person comes into contact with the virus from an animal, human or materials contaminated with the virus. The virus enters the body through broken skin (even if not visible), respiratory tract or the mucous membranes (eyes, nose, or mouth).

Symptoms of monkeypox include; fever, headache, muscle aches, backache, swollen lymph nodes, chills and exhaustion. Within 1 to 3 days (sometimes longer) after the appearance of fever, the patient develops a rash, often beginning on the face then spreading to other parts of the body. The incubation period (time from infection to symptoms) for monkeypox is usually 7-14 days but can range from 5-21 days. The illness typically lasts for 2-4 weeks.







### Office of Congressman Ami Bera, M.D

WASHINGTON, DC (MPG) - Representative Ami Bera, M.D. (CA-07) announced on July 26, that he secured \$750,000 in the House Fiscal Year 2023 Appropriations package to support Meals on Wheels in the Sacramento region.

Funding for the project was included in the FY23 House Transportation, Housing and Urban Development (THUD) Appropriations bill, which passed the House of Representatives last week. The THUD bill now head to the Senate for consideration.

"I am proud to announce that I secured \$750,000 in federal funding that will support the Meals on Wheels Kitchen Project to deliver more nutritious meals to seniors living throughout Sacramento County. "With the Community Project Funding, Meals on Wheels by ACC (MoW) will be able to move meal production from Mississippi to California. Moving production to California means we can

source meal ingredients from local farms, make immediate changes to our menus, offer culturally diverse meals, and serve more seniors," said Kevin McAllister, Executive Director of Meals on Wheels Sacramento.

The funding would be used to purchase food service equipment for a commercial kitchen in the Sacramento area that would allow them to produce locally sourced, freshly prepared meals to Sacramento seniors and expand their program capacity. This project is a good use of taxpayer dollars because it will allow them to meet the growing demand for nutritious meals by a growing senior population in Sacramento and expand the number of meals they serve through collaborations with local farmers and producers. Eliminating the use of a vendor who produces meals out of state will save taxpayer dollars and support local farmers.

Representative Bera has been a longtime support of the Meals on Wheels program. Amid a government sequester in 2013, Representative Bera donated a portion of his monthly pay to Meals on Wheels.

In total, Representative Bera secured more than \$32 million to support 15 community funding projects for the Sacramento-region in the FY 2023 House appropriations bills.  $\star$







Bans the use or maintenance of a container with flammable or combustible liquid or a generator, except when issued a permit by the Regional Parks Director.

The intent of the proposed ordinance is to provide the County with an additional enforcement tool to address camping and the proliferation of unpermitted structures used as makeshift shelters in the Parkways and reduce public safety concerns relating to the use of flammable or combustible liquids and generators in parks. However, the ability to enforce the proposed ordinance, like the existing Code provisions, is dependent on law enforcement capacity and prioritization as well as availability of shelter, as outlined in the proposed Park Rangers' Action Plan. In addition, the Action Plan describes the County's commitment to conduct outreach efforts to offer alternative shelter and other services to individuals camping in the Parkways.

James (not his real name; he prefers not to be known for his work off the field) is a college football coach. He knows that in football, you are judged by winning and losing. But in life, character endures. So, James focuses on teaching players about their past so they can improve the future.

Football brings kids from all different backgrounds together and requires them to sacrifice for each other, be selfless and do the job they are asked to do. Creating a team from players with disparate racial, socioeconomic, religious and geographical backgrounds and different styles of upbringing can be quite challenging.

James has found that most kids coming out of high school don't know much about their history, the history of the country they live in, the history of their teammates. So, one night a week, he leads a class that focuses on Black history, Hispanic history, Polynesian history, American history, world history and religious history – and how those lessons inform the decisions we all make today.

What emerges is not a discussion on diversity but rather on unity. Turns out that every one of us is different in some way, and our shared experience grows out of our ability to take those differences and turn them into advantages. Respect grows with understanding.

This past year, James' team had its best year ever in the program's history. The team is one of the most diverse in the nation. Yet the two words most often heard uttered by the players describing the program are "love" and "family." One alumnus returning to the team, now as a coach, said: "It's like coming home. This is where I learned to change who I was, to become a man. I want to help other kids do the same."

Each of us has a history, good or bad, that can teach us something about ourselves. But most importantly, when we learn the history of others, we discover a world that makes room for all.  $\bigstar$
