## Best of the Best Honored

**CARMICHAEL, CA (MPG)** - More than 7000 voters have decided the top businesses and services in Carmichael. After weeks of voting, winners were announced at the Best of Carmichael awards dinner last weekend.

An occasion for business people to let down hair, the gala adopted tropical theme. Guests were treated to ukulele music, exotic cocktails and desserts by auction. A chocolate and raspberry confection whipped up by Heidi Green raised a final bid of \$300. A nine-layer chocolate cake from Claim Jumper Restaurant claimed \$250. The hammer also fell on pies, cookies and a vegan recipe cake.

Almost 150 candidates and supporters packed the Mission Oaks Community Center. Winning envelopes were torn open Oscar-style.

While nobody got face-smacked, back-slapping and cheering were victors' dues.

Some organizations won twice: Effie Yeaw Nature Center netted Best Non-Profit and for Best Place to Visit; Katie Pexa's business took dual awards: Best Insurance Agency and Best Residential Service.

Auto shops were revved up contenders: American Eagle Body Shop and Wrench Rat Automotive tied for Best Body Repair. A single-vote difference won the Buck Family's Best Auto Repair award.

Among 30 categories, restaurants attracted most competition. Best Pizza was delivered to Mark and Monica's; Hagen's Orange Freeze squeezed Best Fast-Food honors. Skip's Kitchen won Best Restaurant and River City Brewery was voted Best Bar and Pub - the brewery also scored most overall support with 601 voters in its favor.

Incapacitated by a car accident, I Love Pie Bakeshop owner Diana Shockey was cheered in absentia as Best Dessert Shop winner. A bespoke apple pie from Shockey's oven sold for a \$200 bid. Top silent auction earner was a Wine Country getaway, closing at \$800.

For the fifth time, Carmichael Presbyterian collected Best Church laurels. Another perennial winner, Bel Air Market, has snagged best Grocery Store every year since 2017.

Nearly 400 local businesses were nominated this year and 387 people cast a total of 7125 votes. This figure reflects almost doubled participation over the 2021 competition, whose results were announced virtually due to COVID restrictions. Votes were tallied by Ryan Griffith of Voter Fly.

Awards dinner sponsors include Assemblyman Ken Cooley, SMUD and Dignity Health.

## Plastic Tax Initiative Will Devastate Working Families

**SACRAMENTO, CA (MPG)** - According to a new cost impact study released by the Center for Jobs and the Economy, the average family of four could pay more than \$900 extra per year in higher costs under the Tax on Plastic Initiative (Initiative #19-0028A1) that has qualified for the November 2022 ballot.

The analysis estimates the ballot measure's tax on plastic products and complex regulatory requirements will generate nearly \$9 billion per year in higher direct and indirect consumer costs - more than double the \$5.6 billion currently paid for recycling programs.

"This massive tax increase could not come at a worse time for working families. Record-high inflation and skyrocketing food costs are already causing serious financial hardship for nearly half of California's households making less than \$40,000 per year, according to a recent poll from the Public Policy Institute of California," said Robert Gutierrez, president of the California Taxpayers Association. "Hardworking Californians can't afford to add another \$900 per year to their expenses."

The cost impact study looks at the job, consumer costs, and business impacts of the Plastics Tax Initiative, which proposes a one-cent tax on single-use plastic packaging and food containers while adding a myriad of new regulatory requirements on plastic products. Despite the measure's significant cost increase, its flawed provisions make it unlikely to achieve the state's current recycling goals.

Some of the report's key findings include: Adds \$901 per year in higher costs for consumer goods for the average family of four; Creates nearly \$9 billion more per year in total direct and indirect costs, including \$4.3 billion in higher taxes - one of the largest state tax increases in recent history on working families; Doubles the \$5.6 billion that Californians currently pay for recycling while likely failing to achieve California's recycling diversion goal; Impacts more than 40,000 in-state good-paying, middle-class jobs in the packaging industry that are disproportionately held by Latinos and workers with a high school degree; Dedicates only about 30% of its tax proceeds toward increasing recycling and reducing plastic waste; and Opens

# Carmichael Native Battles Cyber Threats for U.S. Navy

**FORT MEADE, MD (MPG)** - Petty Officer 3rd Class Raymond Halvorsen, a native of Carmichael, California, protects America from cyber threats as a member of U.S. Fleet Cyber Command.

Information technology advances at a staggering pace. Practically all major systems on ships, aircraft, submarines, and unmanned vehicles are networked to some degree. This includes most combat, communications, engineering, and navigation systems. While connectivity provides the military with speed, agility, and precision, it also opens numerous attack opportunities for adept cyber adversaries.

Halvorsen attended Rio Americano High School and graduated in 2018. Today, Halvorsen uses skills and values similar to those learned in Carmichael.

"Growing up, I learned to have a strong will and mind to keep going even when things were rough," said Halvorsen. "I learned

to persevere. It's ok to be weak, but it is not ok to remain weak."

Today, Halvorsen plays a crucial role in defending against cyber threats in support of the command's mission to collect, analyze and report on communication signals using computers, specialized computer-assisted equipment, and video display terminals.

According to Navy officials, networks are under continuous threats of attack by a broad array of state actors, terrorist organizations, 'hacktivist' groups, organized crime, and individual hackers. Motivations include personal gain, information theft, discrediting the United States, sabotage, political gain, denial or degradation of the Navy's access to cyberspace.

"As leaders and experts in Information Warfare, our sailors and civilians are at the forefront of disrupting the ability of bad actors to execute their plans, which often degrade U.S. interests," said Vice Admiral Ross Myers, commander, U.S. Fleet Cyber Command and U.S. 10th Fleet. "Because of our workforce and their world class skills and dedication to service, today's Navy has the agility, tactical skills, advanced technologies and innovative mindset to succeed. Alongside our sister services, Fleet Cyber Command is on the frontlines to thwart malicious efforts in cyberspace - we are engaged against adversaries, around the globe and around the clock - 24/7/365." ★

That's why the work being done by Halvorsen is so important.

Serving in the Navy means Halvorsen is part of a team that is taking on new importance in America's focus on rebuilding military readiness, strengthening alliances and reforming business practices in support of the National Defense Strategy.

"The Navy keeps the peace and maintains stability on the seas," said Halvorsen. "We also protect global trade."

With more than 90 percent of all trade traveling by sea, and 95 percent of the world's international phone and internet traffic carried through fiber optic cables lying on the ocean floor, Navy officials continue to emphasize that the prosperity and security of the United States is directly linked to a strong and ready Navy.

Halvorsen and the sailors they serve with have many opportunities to achieve accomplishments during their military service.

"I've been named the Bluejacket of the Quarter twice by my command," said Halvorsen. "I'm proud of that because it is a strong start to my Navy career."

As Halvorsen and other sailors continue to train and perform the missions they are tasked with, they take pride in serving their country in the United States Navy.

"It means being part of something bigger than myself," added Halvorsen. "I'm serving the country, and I really enjoy the camaraderie and relationships I'm making in the process." ★

**SACRAMENTO COUNTY, CA (MPG)** - With Independence Day coming up, please remember to know the risks of fireworks, only use legal fireworks and stay safe when using. If you see or suspect illegal firework usage, please report it! See reporting contact information below.

The County has teamed up with our cities, fire and law enforcement jurisdictions to educate our community members on how to celebrate safely, how to spot a safe and sane firework and how to report illegal fireworks usage. In addition, many jurisdictions are enforcing stricter penalties this year for illegal fireworks usage.

Sacramento County Board of Supervisors adopted a social host ordinance that levies fines, starting at \$1,000, against property owners that either use or allow use of illegal fireworks on their property, in addition to fines for use in places like the American River Parkway. Read more about the Social Host Ordinance.

Calls for service throughout the County increase dramatically on July 4, and emergency response resources are stretched extremely thin. During the holiday weekend, please use 9-1-1 for emergencies only - like an active fire or injury or immediate threat to persons or property. Each jurisdiction has provided an alternative method to report illegal fireworks sale and usage.

Together, we can ensure that

Independence Day celebrations are fun, safe and do not cause undue injury or fire in our communities.

### Know the Risks

The unsafe use of fireworks can cause severe burns, amputations, blinding and even death; Damaging fires may occur when children use fireworks unsupervised by adults; Parents are responsible for any property damage or injuries caused by all fireworks.

### Keep it Legal

All legal fireworks in California are called Safe and Sane Fireworks and must bear the State Fire Marshal's seal; Safe and Sane Fireworks may only be used and sold from noon June 28th through midnight on July 4th; Any firework that goes up in the air or explodes is illegal and dangerous.

### Keep It Safe

Always have a bucket of water to dispose of fireworks and leave in the water overnight before disposing; Always have a hose connected to water available in case of fire; Do not use fireworks near dry grass or other flammable materials; Do not use fireworks while under a canopy, covered balcony, covered patio or under a tree or bushes.

Desmond is Grand Marshal. According to Elks Secretary Jim Warrick, the VIP personifies this year's We the People theme. "Desmond has built his life on caring about people," Warrick explains. "He was a CHP officer who ran for office to serve his community."

Carmichael-raised, Desmond has watched the parade since childhood. "On July 4, dad hitched a trailer to our tractor. We kids all piled on board

to watch the parade," recalls Desmond. "Heading down Palm Drive was so exciting. Being Grand Marshal might well be the crowning achievement of my political career."

Far from a tractor, the supervisor's 2022 transport is a red vintage Mustang convertible. Grand Marshal and first parade units roll at 10:30 am. A Sons of the American Revolution color guard marches in advance; almost 600 patriots join the fray.

Go-Karts, Boy Scouts, belly

dancers, classic cars, floats, bicycles, Keystone Kops, politicians and clowns follow the siren whoop of fire trucks. Carmichael Chamber of Commerce parades its honorary mayor. Carmichael Improvement District directors will hand out fans. Denim-clad Ophir Prison Marching Band inmates are set to oomph-pa-pa the entire concourse.

Bringing up the rear, Del Campo High School student body will field a mighty vanguard of athletes and ROTC flag-bearers.

Fair Oaks Boulevard closes from 10 am till noon for the cavalcade and thousands of spectators traditionally applaud. Biggest crowds accumulate near Carmichael Park corner. At the park clubhouse, Carmichael Kiwanis fortify celebrations with \$5 pancake breakfasts.

The parade leads many observers to the Elks Lodge, where dancing, barbecue lunches and swimming are offered. The lodge is located at 5631 Cypress Avenue. La Sierra Center is at 5325 Engle

Road. Carmichael Park Clubhouse is at 5750 Grant Avenue.

# California's Sham Budget and Unintended Consequences

The “law of unintended consequences” is a tenet of classic economics – essentially a warning that an action meant to have a positive effect can often bring a negative outcome.

The political version is an oft-voiced admonition: “What goes around comes around.”

The California Legislature’s frantic effort this week to approve a 2022-23 budget – or at least its unfinished version of the budget – exemplifies the principle.

For many decades, the state constitution has required the Legislature to pass a budget by June 15 but for many decades the requirement was routinely violated – sometimes for months.

During those decades, the budget required a two-thirds vote in the Legislature, which meant the minority party – usually Republicans – could hold up passage until its demands were met. The syndrome reached a climactic point in 2009 when one Republican state senator, Abel Maldonado, refused to vote for the budget until Democratic leaders agreed to place a measure on the ballot to change California’s primary election process to what’s called a “top-two” system.

Leaders of both parties despised the proposed new system, but Maldonado, with backing from then-Gov. Arnold Schwarzenegger, held out until they agreed to his demand. The top-two proposal, in which all candidates appear on one ballot and the two top finishers face each other in the general election regardless of party, was approved by voters in 2010. Last week’s election was its latest employment.

Maldonado’s holdout had a consequence that neither he nor Schwarzenegger intended – motivating Democrats to make sure it never happened again. Their labor union allies spent millions of dollars to qualify and pass another measure in 2010, lowering the budget vote to a simple majority.

To make the measure more attractive to voters, its sponsors included a passage that said legislators would lose their pay if a budget was not enacted by June 15.

That proviso, however, had another unintended consequence a year later when Republican Schwarzenegger’s successor, Democrat Jerry Brown, and his fellow Democrats in the Legislature deadlocked over details of the state budget.

Brown vetoed the placeholder budget that the Democrats passed by the June 15 deadline, saying it was not balanced, and Controller John Chiang declared that since that left the state without a balanced budget, legislators would have their pay – about \$400 a day – suspended until there was one.

Chiang said the

Democratic budget was, by his reckoning, \$1.85 billion out of balance. “The numbers simply did not add up,” said Chiang, drawing the ire of his fellow Democrats, who sued, contending he had overstepped his authority.

Fundamentally, the courts later said, the Legislature is the sole judge of whether it has met the June 15 deadline. Consequently, the penalty for noncompliance that was ballyhooed to voters in 2010 is a fiction.

In subsequent years, the Legislature has always passed a budget by the June 15 deadline, sometimes a real one in agreement with the governor but often merely a placeholder.

The 1,000-page budget being passed this week is another sham, drafted largely in secret with minimal public exposure and many blanks to be filled in later. Democratic leaders and Gov. Gavin Newsom are still at odds on multi-billion-dollar issues, including the size and form of payments to Californians to offset inflation.

There’s also a big gap over how much of the state’s projected surplus to spend on permanent commitments, with Newsom’s Department of Finance warning that overspending could create problems in the future if, as many economists suspect, a recession is on the horizon.

That could be a truly important consequence of budgetary gamesmanship. Dan Walters has been a journalist for nearly 60 years, spending all but a few of those years working for California newspapers. ★

# Defendant Convicted of Kidnapping, Three Sexual Assaults

## Sac County DA News Release

**SACRAMENTO COUNTY, CA (MPG)** - Manuel Sicario was convicted by a jury of kidnap for the purpose of rape, assault with the intent to commit rape, sexual battery, attempted sexual battery, annoying or molesting a child and indecent exposure.

The jury also found true allegations that Sicario kidnapped the victim; the victim was particularly vulnerable; Sicario's crimes were carried out with planning, sophistication, and professionalism; and Sicario engaged in a violent conduct that indicates a serious danger to society.

On August 10, 2019, the 15-year-old victim was at Sutter's Landing when Sicario walked up next to her and began to masturbate. As Sicario masturbated, he pulled the victim towards him. The victim was able to pull away from him and flee. She did not call the police. On August 18, 2019, the second victim was at Sutter's Landing when Sicario came near her and began to strip down to his underwear. The victim was so uncomfortable with Sicario's behavior that she took a video of him. When the victim turned her back on Sicario, he immediately jumped on her.

Sicario straddled the victim and tried to grope her. The victim was able to throw Sicario off of her, run away and call 911. The third victim was jogging on the bike path at Sutter's Landing when she encountered Sicario standing on the bike path. When she tried to pass him, Sicario grabbed her, dragged her down the bike path and took her under the I-80 overpass. Sicario threw the victim to the ground exposed himself. He then held one of the victim's hands down as he pulled her clothes to expose her body. The victim tried to fight off Sicario during the entire attack. When Sicario covered the victim's mouth to prevent her from screaming, the victim bit his hand so hard that he let her go for a minute. The victim ran away screaming for help. Law enforcement took the second victim's video of Sicario and released it to the public, resulting in numerous tips. The tips included the first victim reporting that she was assaulted by the suspect as well. Sicario was located in Tulare County and arrested on August 28, 2019.

Sicario faces a maximum sentence of 32 years to life in prison. Sentencing is set for July 6, 2022, at 1:30 p.m. in Department 10 before the Honorable Ernest Sawtelle. ★

# Defendant Convicted of Charges Stemming from Domestic Violence Assault

**SACRAMENTO COUNTY, CA (MPG)** - Michael Dwyer was convicted by a jury of kidnapping, kidnapping for carjacking, domestic violence, evading an officer with willful disregard, and making terrorist threats.

Dwyer and the victim were estranged. On July 15, 2016, the victim opened her garage door and Dwyer immediately rushed into the garage. Dwyer punched the victim in the head, took her phone, duct taped her mouth shut, and tied her hands with zip ties. He forced her back into her house and threatened to kill her, her children, and her parents. Dwyer then threw the victim in the trunk of her car and drove her to his residence. While tied up in the trunk, the victim pressed random buttons on her iWatch until she got a hold of someone who called 911. Officers were not able to find the victim since Dwyer had taken her to his residence. At the house, Dwyer forced the victim into his bathtub, tied her legs with zip ties, and water boarded her because he wanted her to

admit she was having an affair. He also showed her a curling iron and told her he would stick it inside of her and burn her. After begging Dwyer to loosen the ties on her hands, he cut the ties on her hands, but tied her to a chair. He then swallowed a cupful of pills. When Dwyer passed out, the victim was able to cut the zip ties off and get her phone before running out of the house. Officers saw the victim running down the street with no shoes and duct tape still around her neck. Before officers could get all the information from the victim, Dwyer pulled out of his garage in the victim's car and fled. Officers chased Dwyer who was speeding in excess of 100mph while running red lights and stop signs. The pursuit ended when Dwyer lost control of the victim's car. The Sacramento Police Department, Elk Grove Police Department and CHP all worked together to investigate this case.

Dwyer faces a maximum sentence of 18 years and 8 months to life in prison. Sentencing is set for July 6, 2022, at 1:30 p.m. in Department 20 before the Honorable Michael Sweet. ★

# CHP Arrests Teen for Attempted Murder

**SACRAMENTO, CA (MPG)** - The California Highway Patrol (CHP) arrested a Sacramento teen on multiple felony charges stemming from the April 2022 shooting in a south Sacramento parking lot, which left a local man with serious injuries.

Since the April 22 incident,

CHP investigators worked to identify the suspected shooter and his accomplice. On Tuesday, June 7, officers from the CHP's South Sacramento Area office conducted an operation in which the alleged shooter, 16-year-old Joesuff Cochrun, was located and taken into custody without incident. He was booked into the Sacramento Youth Detention

Facility on multiple felony charges, including attempted murder, conspiracy to commit armed robbery, and robbery.

An arrest warrant has been issued for a second suspect wanted in the shooting that occurred in the parking lot of the Employment Development Department at 2901 50th St. in Sacramento. 16-year-old

Larry Bernard Scott Jr., of Sacramento, is wanted on similar felony charges as the suspect in custody.

The involved vehicle, a gold 2000 Chevrolet Malibu, was located at a third residence in Sacramento and taken as evidence to be searched pursuant to a search warrant.

The incident remains under

# New Fire Station 68 Responds to Firefighter Well-being

## SACRAMENTO COUNTY, CA (MPG)

- On May 27, the Sacramento Metropolitan Fire District (Metro Fire) opened with a “hose uncoupling” the newly constructed Fire Station 68 in east Rancho Cordova. The now inaugurated facility, located near Douglas Road and Sunrise Boulevard, incorporates state-of-the-art improvements which show the way of the future in firefighting facilities.

Susan Wood, wife of Sac Metro Board Director Ted Wood – Division 4, shared with the crowd that during the economic slowdown, the older Fire Station 68 had been temporarily closed, which left a sizeable “geographic service area hole” in the surroundings.

The new Fire Station 68 located at 12065 Cobble Brook Drive will replace the station that was formerly located at 4381 Anatolia Drive, which Rancho Cordova Mayor Donald Terry described as “more like a shed with a house in the back.”

Sac Metro staff said the facility will keep “three firefighters, staffing one fire engine with room to expand staffing as the area continues to build and grow.” And there certainly has been a lot of growth recently.

Fire Chief Todd Harms commented on the first stages of the project: “When I first came out here, and we looked at the site, there was nothing that was out here—literally a few roads. There was a little bit of expectation of the growth that was about to happen. But just in the time that we have built this location, the growth has just been incredible.”

The fire station, which features state of the art crew quarters, health and wellness facilities, safety equipment, and fast-access sideways opening bay doors (rather than garage-style doors), was designed by Tylor Babcock of MFDB Architects and built

by Trent McCuen of McCuen Construction Inc., and the construction management team led by Sean Strongman.

Speakers highlighted that what makes the new fire station building so innovative are the health and safety features incorporated into its design.

Chief Harms explained that “because someone will live in this fire station 24 hours a day and 365 days a year for the next 60-70 years,” they will be exposed to toxic diesel exhaust fumes and soot which cause cancer.

Station 68 features a descending exhaust ducting system that hooks up to tailpipes to expel spent gases, together with divided living and garaged areas which are pressurized at different

levels (somewhat analogous to a space station) so as not to allow contaminants flowing into living spaces when opening doors and other access breaches.

Metro Fire Board of Directors President Cinthia Saylor expressed gratitude that this station prioritizes the long-term health and safety of its members.

turnouts inside our rigs... We did not know that just the soot on our turnouts was cancerous.”

Newly representing the redrawn Supervisor District 3, which covers Station 68, Supervisor Rich Desmond attended the grand opening and congratulated the fire district and residents.

Desmond said that the new station was not only going to “improve response times... in the local community... but also that it was going to boost Sac Metro’s response to all hazards in the county.” He was referring to the pre-positioning of wildland response rigs and other special operations which will be based at Station 68.

# Second Fire at Improvement District Leads to Speculation

**CARMICHAEL, CA (MPG)** - For the second time in a handful of months, the Carmichael Improvement District (CID) was targeted by arsonists.

The CID is a Property-Business Improvement District (PBID) that was started in 2016 by Carmichael businesspeople. The CID has an office located at 6825 Fair Oaks Blvd. that has now been set on fire twice in several months.

The Sacramento Metropolitan Fire District was called to the scene of the crime early on Friday, June 17, as the first call came in around 6:34 a.m. The Metro Fire crew responded to the scene and spent about two hours in total putting out the flames and performing the necessary checks.

Local Carmichael businessman Gary Hursh believes the two fires are not a coincidence.

“It appears that someone has targeted the Carmichael Improvement District,” Hursh told the Carmichael Times.

Months ago, the first fire occurred at the office building. If you are facing the property from Fair Oaks Blvd., the first incident occurred on the right side of the second floor of the building. Repairs have been made to the structure, but the replacement wood has yet to be painted to match the building and old material that was burned remains on the ground below

where the first fire took place.

“The office of the Carmichael Improvement District is just being rehabbed now to remove the burned part of the structure and the smoke smell,” Hursh said. “Now they have a second part of that building that was caught on fire this morning.”

The second fire that occurred on Friday, appears to be much smaller and contained quicker. Facing the building from the street, the most recent fire burnt and charred the strip on the left side of the building. However, the fire did not spread and was contained before spreading to the remainder of the building.

Hursh speculates that some homeless individuals in Carmichael could be the culprits.

“The Carmichael Improvement District is addressing the homeless issue and that has offended some homeless people,” Hursh said. “There are cameras that were able to show two persons in the area of the fire before the fire was noticed.”
