CARMICHAEL, CA (MPG) - Carmichael's Vietnam Memorial was last weekend central to community Veterans Day commemorations. In the first open service since the pandemic began, flags, music and memories were shared by almost 100 masked visitors. The ceremony was also livestreamed The first-known California monument to the Vietnam War, the memorial is in the Koobs Nature Area on Engle Road. ### **Distracted Driving: Is It** Worth It?

**CHP** Release

SACRAMENTO REGION, CA (MPG) - Every year, thousands of people are seriously injured or killed statewide in vehicle crashes caused by distracted drivers. To combat this issue, the California Highway Patrol (CHP) received the Adult Distracted Drivers (ADD) XII grant to keep California roads safe through education and enforcement.

"Distracted driving is a serious issue that is 100 percent preventable," said CHP Commissioner Amanda Ray. "We are encouraging drivers to make a conscious choice to not drive distracted. This simple decision can have a tremendous positive impact on the safety of California's roadways."

Drivers who choose to drive distracted exponentially increase the odds of being involved in a vehicle crash. According to data from the CHP's Statewide Integrated Traffic Records System, in 2019 there were nearly 19,000 crashes where driver inattention played a role. Of the 9,371 drivers involved in a fatal or injury distracted driving crash that year, nearly 10 percent cited cell phone use as the source of inattention. Though there are numerous distractions for a driver, cell phones are the most prevalent. Handheld cell phone use while driving is not only illegal in California, it is an unsafe activity behind the wheel. In California, drivers under the age of 18 are prohibited from using a cell phone while driving for any reason, including hands-free devices. "Driving safely requires complete attention, so it is best to stay focused on the road. Distraction behind the wheel jeopardizes your safety, your passengers' safety, and the well-being of those around you,' Commissioner Ray added. Funds from the ADD grant will help support the CHP's completion of at least 400 traffic safety presentations statewide and a minimum of 80 distracted driving enforcement operations between October 1, 2021, and September 30, 2022. Funding for this program is provided by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration. The mission of the CHP is to provide the highest level of Safety, Service, and Security.

WEST SACRAMENTO, CA (MPG) -Sacramento River Cats outfielder Drew Robinson's final professional baseball game, and the moving standing ovation from fans, teammates, and opponents at Sutter Health Park, was a moment much larger than baseball, and won the MiLBY Award for Best Feel-Good Moment of 2021.

With his family watching from the stands, players from both dugouts stepped out to applaud an emotional Robinson before his first at bat against the Round Rock Express on July 20.

Robinson returned to baseball, making the River Cats' roster out of Spring Training.

He started for Sacramento on Opening Day against his hometown Las Vegas Aviators. In his fourth game of the season, Robinson launched a towering home run and pointed to his family in the crowd as he touched home plate on May 11.

Robinson also earned the No. 1 spot on SportsCenter's Top-10 Plays with a diving double-catch against Round Rock on July 19.

The inspirational Robinson has since transitioned into a role as a mentalhealth advocate with the San Francisco Giants.

### SCDA Lauds House Passage The Teacher Shortage of Infrastructure Bill

SACRAMENTO COUNTY, CA (MPG) - The US House of Representatives passed the \$1.2 trillion Infrastructure Investments and Jobs Act bill package. Very preliminary estimates show that the formulaic components of the bill could provide the Sacramento County Department of Airports (SCDA) as much as \$14 million per year for five years.

Additionally, there is anticipated to be \$5 billion for airport terminal programs that will be awarded on a discretionary basis over five years. SCDA staff is working to identify eligible projects that would meet the timeframe for infrastructure funds being made available.

Once signed into law by President Biden, this oncein-a-generation investment will help to create quality jobs for Californians, support the modernization of key state infrastructure, improve our transportation systems and help fund the expansion of zero-emission vehicle infrastructure.

The Infrastructure Investment and Jobs Act SCDA's construcwill provide \$20 billion tion activities, visit in crucial funding that airports can use to upgrade aging infrastructure and build needed capacity to serve recovering passenger levels. The bill also enhances low-interest financing options for airports through the Transportation and Infrastructure Finance and Innovation Act (TIFIA).

assistance for qualified projects of regional and

national significance. Many large-scale, surface transportation projects - highway, transit, railroad, intermodal freight, and port access - are eligible for assistance. Eligible applicants include state and local governments, transit agencies, railroad companies, special authorities, special districts, and private entities. The bill also provides \$5 billion to FAA for modification of existing air traffic control tower and towers.

"SCDA is thrilled with the passage of the Infrastructure Investment and Jobs Act," said Cindy Nichol, Director of Airports for Sacramento County. "As SCDA looks to adapt to the future of air travel, the financial tools provided by the infrastructure bill will be important components of our efforts to put the people at the center of every trip, every experience, every day.

"SCDA would like to thank Congressman John Garamendi for his support of TIFIA for airports, as well as the members of the greater Sacramento delegation who supported this legislation," said Nichol.

The decline in substitute teachers challenges school districts

California's teacher shortage means most quality substitute teachers are being hired on full-time. At the same time, there has been a steep decline in applications for substitute teaching credentials since last January.

In short, we're creating a substitute teacher shortage as we try to ensure great teachers are leading our classrooms.

Substitute teachers play a vital role in the success of students and teachers. Students spend, on average, approximately more than 10 days with substitute teachers during a given school year. Not having adequate support during these days has shown a negative impact on students' achievement. Substitute teachers maintain healthy and successful learning environments for students and provide teachers the time and energy they need to build their professional skills to best support students.

Full-time teachers could take advantage of professional learning, networking and collaboration opportunities. Most importantly, teachers felt secure and confident knowing students continued receiving a high-quality education without skipping a beat.

California is investing in teachers this year but there needs to be more focus on substitutes as part of the solution.

To expand the pool of potential substitute teachers, state policymakers need to collaborate and reexamine CalSTRS existing policies that prevent retired teachers, under state and federal law, from doing substitute teaching within their first six months of retirement. Retired teachers have experience leading students through their educational journeys and are familiar with the communities they served.

Having opportunities for retired teachers to temporarily work to continue helping local schools while solving a statewide shortage of teachers is a shortterm solution, but one that is needed this school year.

Having the support of policymakers is only part of the solution. The support and involvement of all our communities is also important to make a difference; this is how you can help; Research requirements to be a substitute teacher and see if this is a good fit for you or someone you might know. This can be your way of giving back to your community and helping our next generation of young scholars; Call your local district and neighborhood schools and find out how you can provide additional support on campuses. If not as a substitute, it's likely volunteers are needed; Attend career job fairs to learn more about what it takes to be an educator in today's world and how you can support districts who might need higher levels of support.

Recruiting and retaining enough substitute teachers to help solve the shortage won't be an easy task. This is a statewide problem that will be solved locally with the help of many people, people like you. Even if you've never worked in education, take a moment to learn more. What could be an occasional day of work for you could be what provides the consistency students in your town need to learn, grow and succeed.

### **Legislation Honors SMUD** as National Climate Leader

SACRAMENTO, CA (MPG) - California is the capital of innovation and a global leader in the fight against the climate crisis. Over the past five years, Californians have witnessed two of the hottest years on record and experienced devastating wildfires that affect the health, economy, and overall well-being of our communities. As state legislators, we set policy aimed to protect our great state, and it is imperative that we collaborate with and recognize community partners that take action to move the needle toward real, identifiable, and positive change. For these reasons, we proudly authored Senate Concurrent Resolution 51 - which passed with bipartisan support - recognizing SMUD for being the first large utility in the country to adopt a Zero Carbon Plan that will completely eliminate carbon from its electricity generation by 2030.

The Sacramento area is consistently ranked as one of the dirtiest air basins in the country, as shown by the recently released American Lung Association State of the Air Report. Our children are 22 percent more likely to develop asthma than those in the rest of the country. Consequently, these challenges impact our most vulnerable populations disproportionately. Our current reality is unacceptable, and the only way to safeguard our future for generations to come is to create carbon free solutions that foster healthy outcomes and create green jobs for the benefit of us all.

Right here in our own backyard, our community-owned, not-for-profit electric utility, SMUD, recently adopted a Zero Carbon Plan to eliminate all carbon emissions from electricity generation in our region by 2030. While that timeline sounds ambitious, SMUD's track record of delivering on sustainable solutions and championing innovative action plans is exactly what is needed to create clean powered communities.

The SMUD Board of Directors has consistently championed green initiatives that support innovative solutions to renewable energy. Their leadership has achieved tangible results. For example, SMUD was the first utility to reduce its greenhouse gas emissions by nearly 50 percent from 1990 levels - the equivalent of removing 377,000 vehicles from the road. They've championed clean cars and partnered to plant more than 600,000 shade trees. They helped usher in the solar industry and now with their Zero Carbon Plan, they are ushering a new era of innovation. Today, SMUD already delivers power that is 50 percent carbon free. With its Greenergy and SolarShares programs, SMUD provides many state owned and privately owned buildings with 100% clean, carbon-free electricity. In keeping with this tradition, their new Zero Carbon plan doubles down on these efforts and would power the Sacramento region with 100% renewable sources.

SMUD's Zero Carbon Plan includes retiring carbon emitting natural gas plants and relies heavily on the electrification of the building and transportation sectors since these are two of the largest carbon emitting sectors in the State. For example, efforts include providing support for all-electric homes through customer incentives for rooftop solar and battery storage, electric vehicles, and by providing rebates to builders and homeowners for the installation of clean water heaters, HVAC systems, and cooktops.

In addition, SMUD has spearheaded and funded the California Mobility Center to bring emerging clean transportation options to the market. This innovation hub has brought federal funding to the Sacramento area and has successfully attracted startup companies in the field of clean mobility. The Center is providing the guidance, education and partnerships needed to bring these ideas to fruition, while simultaneously providing 8,500 new clean technology jobs.

SMUD's comprehensive plan to reach zero carbon emissions by 2030 is one that relies on all the tools in our toolkit. It's the most ambitious of any large utility in the nation and their commitment to our community and equity for all is one to be commended and recognized.

For these reasons, it was an honor and pleasure to come together in a bi-partisan and bi-cameral effort to recognize SMUD for leading the nation by example as it takes tangible steps to reduce the devastating effects of climate change and trailblazing the path forward for a more prosperous future.

### California's Messier, but Fairer, Redistricting Process

For many decades, the decennial chore of redrawing California's congressional and legislative districts was relatively simple.

Every 10 years, following the census, legislative and congressional leaders would hire some knowledgeable number-crunchers and privately divvy up the districts for purely political purposes.

If one party controlled both the Legislature and the governorship, it would maximize its ability to remain in power. The maps that the dominant Democrats drew up after the 1980 census was the last time California saw a blatantly partisan gerrymander.

Republicans howled and persuaded voters to overturn the plan via a referendum, but the state Supreme Court ordered that the rejected maps be used anyway for the 1982 elections, in which Democrats retained their control of the Legislature and the congressional delegation.

Assembly Speaker Willie Brown publicly thanked "Sister Rose and the Supremes" for helping his party overcome the referendum, referring to Chief Justice Rose Bird. It fueled a successful drive to oust Bird and two other justices when they stood for re-election four years later.

After the 1982 election, Democrats enacted a slightly altered version of the gerrymander and then-Gov. Jerry Brown signed it just before leaving office. The congressional map was particularly slanted toward Democrats and its primary creator, San Francisco Congressman Phil Burton, laconically called it "my contribution to modern art.'

Control of redistricting was the primary, if unspoken, issue of the 1990 campaign for governor and after Republican Pete Wilson won he vetoed a new set of maps drawn by Democrats, throwing the issue into the state Supreme Court. The court generated maps of its own that allowed the Republicans to make some gains in the 1992 and 1994 elections.

Democrats once again controlled the Legislature and the governorship after the 2000 census, but a partisan gerrymander was blunted by other factors, including an implicit threat of intervention by the U.S. Department of Justice under President George W. Bush.

The upshot was a bipartisan gerrymander aimed at protecting all incumbents and preserving the partisan status quo in both the Legislature and Congress, while ignoring dramatic demographic shifts, including a big surge in Latino population.

Overt gerrymandering ended a decade later, after voters approved two initiatives - hated by leaders of both parties – to shift the decennial mapmaking to an independent commission that would ignore partisan considerations,

California with a weekly draw districts to follow, where possible, city and county boundaries and preserve "communities of interest."

> On the whole, the commission was faithful to its mission, but nevertheless, Democrats made big gains in congressional and legislative seats – eventually winning three-fourths of both as GOP voter strengthen plummeted.

With data from a new census - much delayed due to the COVID-19 pandemic - a new commission is working on new maps under a very tight deadline and it's been a rather messy process – a "hot mess" in the recent words of one commission member. Drafts of the new maps were released last week and it's apparent that they are likely to change quite a bit before the Dec. 27 deadline.

That said, it's obvious that Democrats will retain their overwhelming legislative and congressional supermajorities and could gain a few more seats simply because demographic trends continue to run their way.

Most of the uncertainty is in the 52 congressional districts - one fewer than before due to California's slow population growth. Democrats are struggling to retain their paper-thin control of Congress and a handful of toss-up seats in California could be the difference.

However, until the final maps are filed, no one can truly predict who will survive and whose careers will end. The process is messier than before, but also fairer.

### **Fatal Hit-And-Run Collison** on Marconi Avenue

CARMICHAEL, CA (MPG) - On November 9, 2021, at approximately 9:54 PM, North Sacramento CHP Area units were dispatched to a call of a traffic collision that occurred on Marconi Avenue at Becerra Way. Upon arrival, units discovered a pedestrian had been struck by an unknown vehicle which had been traveling in the #2 eastbound lane of Marconi Avenue at a high rate of speed. Upon further investigation, officers discovered painted vehicle parts left at the scene. The 59-yearold male pedestrian from Sacramento was immediately pronounced deceased at the scene of the collision.

Shortly after officers arrived, Alcier Francis Albert, a 27-year-old male from Carmichael, called the CHP Sacramento Communications Center to report his vehicle stolen. After a cursory search of the area for the vehicle, officers were able to locate it near the area of El Camino Avenue at Bridle Path Lane (approximately 1.4 miles from the scene of the collision). Officers then responded to Albert's

residence in order to inquire about the stolen vehicle report and investigate the hit-and-run crash. Upon arrival at the residence, officers located evidence indicating Albert was the driver at the time of the collision and subsequently placed him under arrest. Alcier Francis Albert was booked at the Sacramento County Main Jail for the following charges:

20001(b)(2) VC - Hit-and-run causing bodily injury or death to a person other than himself or herself; 191.5(C)(1) PC - Gross vehicular manslaughter; 148A PC -Delaying or obstructing any peace officer in the commission of their duties; 148.5B PC -Submitting a false report to any peace officer; 31 VC – Knowingly giving false information (verbally or written) to any peace officer

# Home and Community-based Care Supports Us All

#### Commentary by Angela F. Williams

Every day, millions of workers enter people's homes to provide care to those with disabilities and the elderly. These "direct-care" workers assist individuals with bathing and dressing, cooking and eating, taking medication, and getting exercise. For the people they help, they are lifelines to health, independent living, and economic stability.

Yet our system for providing this care is in desperate need of repair. Medicaid serves approximately 4.8 million Americans with home- and community-based services, but there are still nearly 850,000 people on waiting lists. They often wait years for crucial support.

At the same time, directcare workers have been underpaid for decades, causing instability in their own lives. This situation was untenable even before pandemic-induced social distancing kept these workers from fulfilling their jobs.

President Biden proposed a fix for the industry in his infrastructure plan, which would have added \$400 billion in federal spending for Medicaid's home and community-based services program. This would have provided a sorely needed boost to the caregiving economy.

Yet the president and a group of bipartisan senators dropped this aid from the "compromise" they reached and passed on infrastructure. That's deeply disappointing. Lawmakers must do everything they can to work this aid back in as a separate bill. Funding home- and community-based care for the most vulnerable Americans shouldn't be a partisan issue. just 3% owed mortgage debt in 1989, compared to 27% by 2019.

The voting public recognizes this. An April poll from Morning Consult and Politico found that 76 percent of Americans support new funding to improve caregiving for people with disabilities and the elderly. And yet, some of our political leaders don't seem to see the need.

stand that care workers enable people to continue living in their own homes – or how important this is. Aid recipients prefer to be cared for in their own homes and communities, and the law obliges public agencies to do so whenever possible.

Care workers themselves also need help. Though entrusted with their clients' wellbeing, direct-care workers make \$11 an hour on average. Approximately 15% live in poverty. It's no wonder that there is 50%

turnover every year among direct-care workers.

The low wages also exacerbate gender and racial inequality, as women of color dominate the ranks of direct-care workers. And when we fail to support direct care, the burden of looking after family members typically falls to women, taking them out of the workforce.

Home- and community-based care makes it possible for millions of families to thrive. But without new expenditures, both

the workers who provide these services, and the individuals and families who rely on them, will not. Our lawmakers need to make this investment now, assuring a sustainable system of services and support for our most vulnerable citizens, their families, and the professionals who care for them.

Appeals court reaffirms stay on Biden workplace vaccine mandate, cites 'severe' risks - The Fifth Circuit granted a temporary stay on enforcement of the federal mandate on Nov. 6, one day after the rule was announced | 12 Nov 2021 | A federal appeals court reaffirmed its decision Friday to enact a stay on Joe Biden's workplace vaccination mandate following a legal challenge from Texas and several other states. The Fifth Circuit Court of Appeals ordered the U.S. Labor Department's Occupational Safety and Health Administration to "take no steps to implement or enforce the Mandate until further court order." The decision was the latest development in what is expected to be a lengthy legal battle over the mandate's legality. Texas Attorney General Ken Paxton, a vocal critic of the workplace vaccine mandate, lauded the court's decision on Twitter. "Citing Texas's 'compelling argument[s],' 5th Circuit has stayed OSHA's unconstitutional & illegal private-business vaccine mandate. WE WON! Litigation will continue, but this is a massive victory for Texas & FREEDOM from Biden's tyranny & lawlessness," Paxton wrote.

Ten States Sue Biden Over COVID-19 Vaccine Mandate for Health Care Workers | 11 Nov 2021 | A coalition of ten states led by Missouri's attorney general on Nov. 10 sued Joe Biden over his administration's COVID-19 vaccine mandate for health care workers. A federal court has blocked, for now, the regime's private employer vaccine mandate, although a stricter one focused on health care workers remains in place. The health care worker mandate, which covers more than 17 million nurses and others, doesn't include a testing opt-out. The coalition says the mandate is unlawful under federal law in part because the federal government is trying to wrest away compulsory vaccination power that has "always been the province of--and still properly belongs to--the states."

Calaveras Unified School District board votes to not 'support, enforce or comply' with vaccine mandate The vote was 5-0. | 12 Nov 2021 | (Sacramento, CA) The Calaveras Unified School District announced Wednesday it will not be adhering to the COVID-19 vaccine mandate. In a 5-0 vote, the CUSD Board of Trustees decided to "not 'support, enforce or comply with" the mandate. The decision came during a Tuesday meeting and applies to both students and staff. According to CUSD, they will discuss and possibly make a decision on mask mandates and testing protocols at a later meeting on Nov. 23.

Two million COVID-19 at-home test kits recalled over false positive results | 11 Nov 2021 | A recall of at-home COVID-19 test kits that have the potential to produce false-positive results has been expanded to include 2 million kits. The Ellume brand of test kits were manufactured between Feb. 24 and Aug. 11 and distributed from April 13 to Aug. 26. The U.S. Food and Drug Administration said 2,212,335 kits were distributed in the United States. Ellume initiated the original recall in early October saying the problem was tied to a manufacturing issue.

'I will send them to Delaware' on buses: DeSantis hits back over Biden secretly flying migrants into Florida | 11 Nov 2021 | Republican Gov. Ron DeSantis threatened this week to bus illegal immigrants to President Joe Biden's home state of Delaware should the administration continue to pay for "clandestine" flights carrying migrants into the Sunshine State. "If they're going to come here, you know, we'll provide buses and...I will send them to Delaware," DeSantis warned during a press conference on Wednesday. The governor's tough remarks came amid a lengthy polemic against the president over his handling of the ongoing immigration crisis at the U.S southern border, during which he described the secretive process that the Biden administration has reportedly used to send some 70 flights carrying illegal aliens into his state and elsewhere around the country.

### Don't Neglect Long-Haul **Covid in the Panic Over Delta**

#### Commentary by Dr. Jeffrey Gold

Long Covid" is one of many scary phrases that have barged into our vocabulary since the pandemic upended global life.

Those who have it are afflicted with a Covid that seems never to go away. With the present panic over the Delta variant, there's a danger that we will not accord this slow-burn condition the attention it deserves.

With symptoms ranging from severe fatigue and lightheadedness to anxiety and, in some extreme cases, psychosis, these long-haul patients are begging for help. Studies indicate that as many as three out of 10 people infected with Covid-19 may experience long Covid. Yet, doctors struggle to find an explanation.

Another problem is that almost all studies of long Covid focus on the unvaccinated. Little research has been done on "breakthrough infections" -- the contracting of Covid-19 after vaccination. Preliminary research suggests that symptoms can endure for up to six weeks in breakthrough cases.

What makes long Covid so puzzling is the variety of possible symptoms, of which there are potentially hundreds. Patients report shortness of breath, fever, difficulty concentrating, and skin conditions. Some patients experience hearing loss. Still others report fatigue so severe that they struggle to get out of bed. There's no diagnostic test for long Covid, and brain MRI scans and other tests fail to yield results.

But this list of symptoms also gives researchers multiple vantage points from which to study the condition.

Some scientists theorize that fighting Covid-19 leaves behind viral particles that trigger a generalized cycle of inflammation long after the body has defeated the pathogen itself. Others think the virus may burrow in human tissues, allowing it to surface sometime later when immunity weakens

symptoms with a rare condition known as postural orthostatic tachycardia syndrome (POTS). The condition often appears suddenly following a viral infection.

Any theory or link to a known condition offers hope for patients. In guidelines released mid-June, the Centers for Disease Control and Prevention recommended doctors focus their approach on patients' specific symptoms.

Thus, in the fight against long Covid, doctors should target the symptoms patients are experiencing with treatments already proven to address those indications.

For patients experiencing high blood pressure, for instance, doctors can prescribe beta-blockers to slow their heart rate. Those patients who feel extreme fatigue can benefit from medicines used to treat chronic fatigue syndrome. Some patients with a POTS diagnosis see positive results from a drug called ivabradine.

A number of drugs, FDA-approved for other ailments, are finding welcome additional use in the treatment of Covid. Empagliflozin, commonly used for Type-2 diabetes, promises to protect against Covid-related organ failure. Baracitinib, an anti-inflammatory drug developed for rheumatoid arthritis, has shown notable effectiveness in reducing Covid-related mortality.

Patients experiencing respiratory problems may benefit from a new drug known as Tavalisse, which has FDA approval for use in patients suffering from a rare condition known as thrombocytopenia. Meanwhile, a recent study found that low-dose naltrexone -- a therapy for chronic fatigue or chronic pain -- shows potential to safely and effectively disrupt Covid-19's ability to attack the body.

Curing long Covid requires dedicated research and investment. Even repurposing existing drugs requires expensive clinical trials. With tens of thousands of Americans getting infected with Covid-19 every day, the scientific community must double down on finding cures for this condition.

SACRAMENTO, C A (MPG) - From John Kabateck, California state director for the National Federation of Independent Business on today's release of NFIB's monthly Small Business Economic Trends (SBET) report, America's bellwether measurement of the Main Street economy.

I am glad the U.S. Labor Department is finding workers returning to the job, Main Street is still waiting. What stood out for me in this month's SBET is that small business owners expecting better business conditions over the next six months fell four points to a net negative 37%. This indicator has declined 17 points over the past three months to its lowest level since November 2012. Unfilled job openings, supply chain disruptions, inflation, a Congress threatening more taxes add up to a bleak outlook for the nation's and California's leading job-creators.

Small business owners are attempting to take advantage of current economic growth but remain pessimistic about business conditions in the near future. One of the biggest problems for small businesses is the lack of workers for unfilled positions and inventory shortages, which will continue to be a problem during the holiday season.

Adding to the muddle, Washington is having trouble putting its economic policies into place. Spending and tax policies are still up in the air, while debt ceiling problems loom larger each day. The Federal Reserve is also scrambling to reset policies to deal with growth and inflation numbers it had not expected.

#### About the Small **Business Economic** Trends (SBET) Report

The NFIB Research Center has collected Small Business Economic Trends data with quarterly surveys since the 4th quarter of 1973 and monthly surveys since 1986. The SBET is one of the few archival data sets on small business, particularly when research questions address business operations rather than opinions. Today, it's the largest, longest-running data set on small business economic conditions available.



### **California Farm Bureau Hails Investments in Infrastructure**

#### California Farm Bureau News Release

SACRAMENTO, CA (MPG) - California Farm Bureau President Jamie Johansson today applauded members of Congress for passing the Infrastructure Investment and Jobs Act, hailing its crucial benefits for California's agricultural communities.

"We applaud Congress for passing this critical bill," Johansson said. "This represents a once-in-a-generation opportunity to make the kind of investment we need to bring our rural infrastructure into the 21st century.'

The legislation - H.R. 3684 - provides \$550 billion in new spending on physical infrastructure over the next five years. That includes investing \$110 billion in U.S. roads and bridges, \$65 billion for broadband, \$17.3 billion for ports and inland waterways and more than \$8 billion to repair and invest in water storage and conveyance projects for the droughtimpacted West.

The U.S. Chamber of Commerce estimates that California would receive more than \$45 billion in long-term funding.

"This will benefit California's farmers and ranchers, who are counting on improvements to millions of miles of roadways and waterways to get food to America's dinner tables and upgraded ports to ship products to international markets," Johansson said. "Our rural communities can thrive with expanded broadband and feel protected due to investments in forests that reduce wildfire dangers.

"And amid our searing drought, farmers can now look forward to long-needed improvements in water storage and conveyance systems. But we need to make sure those investments result in real infrastructure and are not bogged down in regulatory processes."

The California Farm Bureau works to protect family farms and ranches on behalf of nearly 32,000 members statewide and as part of a nationwide network of nearly 5.6 million Farm Bureau members.







### Is it Possible?

This column's primary mission deals with citizen ownership and responsibility for our governments. However, at times I am asked if that just sounds good? Or, is it really possible? Are we "tilting at City Hall?

Today, I want to assure everyone that citizen ownership is absolutely possible, and I have real-world results to prove it. It takes effort and organization, but it is possible. Let me share a few illustrations to encourage us all!

2020 was a busy year for the Sacramento Taxpayers Association. SacTax was involved in a multitude of state and local issues, including Split Roll Property Tax and several local policy and tax matters (COVID fines on businesses, changing the election cycle of the county sheriff, and the Sacramento strong mayor initiative, etc.). unnecessary tax dollars were saved!

Of particular significance, in the spring of 2020, we met head-on the Sacramento Transportation Authority's proposal to increase the county-wide sales tax by a half percent for forty years. On July 15, 2020, after months of working on this tax increase in the middle of a pandemic, the Authority

reluctantly withdrew its November 2020 ballot measure. Most notable to me was literally the very last comment in the report: "(S)hould any organized

opposition materialize, the measure will not be viable (on the November ballot)." Dear co-owners of our

government, we were the "organized opposition!" And, we had a resounding success.

Then in August 2020 (after pleading with the Citrus Heights City Council to reconsider placing Measure M on the November ballot to raise their sales tax by one percent with no sunset date) we faced another new battle. windmills?" Can you fight The Council was intransigent – arrogantly confident that voters would easily approve their tax increase as the Council's consultants assured them that polling showed the measure being adopted by well over 70 percent.

The City Council scoffed at us - confident in their ability to call in over \$50,000 of "pay-to-play" vendor money to push Measure M across the winning line, as well as spend thousands of public city dollars in multiple citywide mailings to every household - all proclaiming the merits of Measure M in so called "educational mailings."

... but SacTax rolled up its The result was that billions of collective sleeves and organized a "No on M" task group. With a total of about \$7,000 (from small donors) plus hundreds of coordinated hours of volunteer time and help from community leaders, in two months the citizens sent this "ugly pig" of a tax measure to its rightful grave by approximately 2,000 votes (or 52.45%).

> Again, friends, we were "the organized opposition,"

with another resounding success!


In fact, if you look at all of the local tax increase and bond measures placed before Sacramento region voters in November 2020, they all passed – except for the ones SacTax actively opposed.

There is an important lesson here, we did not have to burn down buildings or destroy businesses. We did not have to deface or tear down any monuments. All we had to do was be well organized; upfront; use sound logical arguments; make our concerns known; and educate citizens. All we had to do was put leadership into practice and encourage our citizens in exercising ownership over their governments.

We had to shed light on important topics; allow government officials to realize that we must all be good stewards of public dollars; and realize that "business as usual" was not acceptable.

Lesson learned - our democratic, republican form of government works when we collectively take responsibility for it! Together, we make a difference!
