Float Master's Final Super Float

RANCHO CORDOVA, CA (MPG) - A double-float, the Million Dreams Express with caboose will be the swan song for Float Master Wayne Harmer and family at the Rancho Cordova 4th of July parade.

After creating 13 floats since 2004 including "Train the Stars" in 2017, and "Charlie Brown and Friends" in 2022, Harmer has announced there will be no other large multi-functional floats. His Million Dreams Express honoring the 20th anniversary of Rancho Cordova is 60 feet long, 12 feet high, and 10 feet wide. When fully animated as it travels slowly down

Coloma Avenue viewers will see and hear the usual signature bells and whistles, see a water feature and lots of things turning and

moving above the dozen wheels. The Express was the bell of the ball in the Folsom parade June 24 and will make its second and final appearance at the Rancho Cordova parade.

Harmer says one goal has always been to create "the next big thing" in parade floats each year, more elaborate than the last, leaving viewers of all ages wondering, "How did they do that," with little or no evidence of how it was done. There have been no wires: all working elements, even ladders, are

CAL FIRE Encourages Safety this Fourth of July Holiday

SACRAMENTO REGION, CA (MPG) - With the Fourth of July holiday around the corner, state fire officials are stressing the dangers and consequences of using illegal fireworks. This Fourth of July, remember to celebrate responsibly. Protect your community by preventing fires and injuries caused by fireworks. Before you think about buying fireworks for your celebration, make sure they are permitted where you live. Fireworks purchased out-of-state are illegal in California without a license. Why not let the experts handle the fireworks show? You can easily grab a blanket, head to local fireworks show, and find the perfect patch of lawn to kick back and enjoy.

"With fireworks causing over \$25 million dollars in property loss in 2022, preventing fires and injuries caused by fireworks begins with you" said Chief Daniel Berlant, Acting California State Fire Marshal. "Don't be the reason your Fourth of July holiday goes up in smoke".

If Safe and Sane fireworks are legal in your area and you choose to use them, it's important that you follow these safety tips:

Never use illegal fireworks; Make sure the firework has the State Fire Marshal "Safe and Sane" seal on it; Make sure the "Safe and Sane" firework is purchased from a licensed fireworks booth; Never allow young children to use or handle fireworks; Never use fireworks while impaired by drugs or alcohol; Never hold a lit firework in your hands; Never light fireworks indoors; Only use them away from people, houses, and flammable materials; Never point or throw fireworks at another person or animal; Do not try to re-light or handle malfunctioning fireworks; Soak both spent and unused fireworks in water for an extended time before discarding; Keep a bucket of water nearby to fully extinguish fireworks that don't go off or in case of fire.

hidden with every moving part controlled by remote control.

Harmer's second goal has been the simple fun and joy of bringing his entire family together to work on one project at the same time.

That joy was enhanced in 2014, the first year that brought three generations of Harmers together to create the 12-foot-high Eagle Mountain float. The float featured an 8-foot running waterfall, smoke, an 'active' volcano, complete with (safe) smoke and a five-ton winch/pulley built to move a mother eagle performer up the mountain to her eaglets' nest to feed her young (three young performers). A confetti (biodegradable) air cannon was shot off towards the judge's station, another signature feature of Harmer's floats.

Harmer has faced dozens of obstacles throughout his parade, float-building career. Besides the satisfaction of working beside his family, another of his motivations for creating new and innovative floats has been hearing, "you can't do that", when planning his next creation. The wrong thing to say to an inventor.

Harmer's mantra has always been, "Never say, I can't do that." There's always a way to overcome an obstacle, even in life. "We may not be able to do it one way, that doesn't mean it can't be done, you just don't know the way yet. Thirteen floats and 19 years later, Harmer has proven his point.

Harmer emphasizes how he could not have produced any of his creations without Nickey, his wife of 46 years. They have two sons and two daughters. Nickey is his inspiration. When he is stumped by an element of a project, a brief discussion with Nickey always gives him clarity. She says, "his brain is always going."

Following completion of his float Harmer spends the next week at Hagen Park helping put on the two-day celebration the 3rd and 4th. New this year will be a drone show at 9:30 on both nights.

For Harmer, this year marks 20 years working throughout the year with the Cordova Community Council on many events. Not ready to hang up his volunteer hat, he will continue this position for at least another five years, completing 25 years of service to the city he loves. ★

- On June 14, 2023, the Sacramento Regional Transit District (SacRT) along with GiddyUp EV Charging, Inc. and the Sacramento Municipal Utility District (SMUD) officially unveiled a new high-speed electric vehicle public charging hub at the Power Inn light rail station.

This public-private partnership offers a state-of-the-art charging solution for Sacramento's emerging electric vehicle market, aimed to meet the region and state's sustainability goals, and provide a revenue sharing model for SacRT.

The Charging Hub is a large-scale network of Level 3 charging stations that provides the ability to charge both passenger and commercial vehicles simultaneously, and dramatically faster than the Level 2 chargers found in the majority of public charging stations. The new Charging Hub occupies 20 underutilized parking spots in the Power Inn light rail station. The

Charging Hub will serve everyday drivers and commercial fleets alike, with several spots designed to accommodate large fleet vehicles such as buses and semi-trucks.

SMUD estimates that there will be nearly one million electric vehicles in the region by 2040.

"California continues to lead the nation in setting big, bold climate goals and building the clean energy infrastructure required to make the transition from fossil fuels," said California State Treasurer, Fiona Ma. "Projects in local communities, like the Power Inn station charging hub, make electric vehicle adoption more attractive and charging more convenient for existing owners. It's projects like this that help California solidify its position as the country's leader in zero emissions vehicle integration into our way of life. Congratulations to SacRT, SMUD, and GiddyUp EV Charging on a successful public-private partnership!"

As a member of the State Assembly in 2011,

Ma authored AB 631 which placed into law a California Public Utilities Commission decision not to regulate EV charging stations as utilities.

"This public private partnership is delivering state of the art charging solutions to help us meet the region and state's sustainability goals, while providing revenue sharing for SacRT. Offering a mobility hub for multiple transportation modes at our light rail stations is an excellent way to connect riders and enhance our stations," said SacRT General Manager/CEO Henry Li.

"It's projects and partnerships like this that will increase EV deployment and help us expedite the transition to a carbon free economy," said SMUD General Manager and CEO Paul Lau. "Locating a fast-charging hub along a major thoroughfare helps increase access to varied forms of clean transportation. At SMUD we are partnering with our customers and community to bring electrification to under resourced communities, and this hub provides a bridge to get there."

GiddyUp EV Charging, Inc. is financing the purchase and installation of some of the fastest DCFC/Level 3 chargers in the industry, which will have the ability to recharge light and medium vehicles simultaneously in minutes compared to Level 2 chargers that may take hours. The Charging Hub is brightly lit and offers customers a high-tech security system using high-definition video cameras and real-time monitoring.

Flights of Independence

SACRAMENTO REGION, CA (MPG) - Gales, hail storms, a surprise late hatch and dramatic tumbles were among pre-flight adventures for the 2023 American River bald eagle family.

By now, all three of Mama and Papa's eaglets have fledged. Storm, Providence and latecomer Fortune are winging to independence (note: these names are unofficial and coined by this eight-year observer. Scientific records identify the eaglets as eaglets 14, 15 and 16.)

Run ragged by months of incubation and providing, their parents will soon restore their battered eyrie and anticipate a 2024 breeding season. Such is their existence. Like most wild animals, our beautiful national bird lives only to enjoy freedom and sustain its species.

Built in 2016, their eyrie was considered the closest to Sacramento in recorded history. The phenomenon of their breeding in unaccustomed territory underscored a comeback for a species that hovered near extinction in the 1970s. The American River nest has since been sanctuary to 17 babies.

The parents courted and coupled in January and February. Alpha eaglet Storm hatched during tempests in early March. The second arrived providentially in peaceful days that followed.

Then an eagle-cam installed by Friends of Folsom and Lake Natoma revealed a third fluff-head. I called this surprise baby Fortune.

Eaglets fly at around 12 weeks after hatching. To achieve adult size in less than three months, they must be fed non-stop. Their parents worked in relays to deliver prey and at first, the hatchlings were delicately beak-fed. As they grew, they learned to tear at flesh unaided. Fish and waterfowl were on the menu most days.

Alpha Storm was first to scramble outside the nursery and begin the process of branching. Flapping and building flight muscle, she navigated the tall pine. Early in this process, an

incoming adult caused near-disaster by knocking the baby off her limb.

Hanging by a talon, she clung to the nest upside down – for

10 minutes. Eaglet resilience triumphed as she scrambled uphill, regained the basket and lunged, squealing, at dinner with her siblings. No peril, it seemed, dulls eaglet appetite.

One June morning, second sister Providence missed her footing and plummeted. Unready for flight, she nevertheless broke her fall with a few flaps and landed in brush a hundred feet below the nest. For a day, she flapped and flailed among flimsy buck-eye branches.

When she eventually hit ground level, the refugee hop/flitted across a shallow ravine to ascend an oak for her second night on the lam. She awoke hungry and managed a first deliberate flight to bluff-top trees.

Later, still unfed, she ascended a pine snag and screamed to the heavens. Arriving in Papa's talons, a squirrel was served picnic-style. When a second squirrel came hours later, survival seemed sure. Strengthened by unshared provisions and continuous wing exercise, she flew home four days after her fall. A fat trout was the incentive. You can only eat so much squirrel.

Alpha Storm's fledge – a fast lateral loop and flawless re-landing – went almost unnoticed during the middle-sibling's drama. Baby Fortune flew the coop about 13 days after the eldest eaglet's on-time flight. Their future includes gradual weaning from parental provisions and finding new territory. In time, I predict, there will be eagles up and down all Sacramento river systems.

The comeback of our national bird from near-extinction in the 1970s cannot be better illustrated than by this American River family. During seven seasons – in territory where their species was previously unknown – one couple has hatched and dispatched 15 eaglets to continue their resilient line.

Like the nation whom their image represents, these babies are bred to be resourceful, independent and above all, free.

God Bless nature. And God Bless America.

Footnote: in the interests of safety for these protected birds, the nest location is not revealed. ★

Fun Bang Day

HAPPY (BANG BANG) 4TH OF JULY!!! It's here and time to celebrate the birth of our nation, or Independence Day, when the Continental Congress voted in favor of independence. It actually happened on July 2, 1776 when the Declaration of Independence was adopted. But what's a couple of days anyway. And it's been a federal holiday since 1941. So it is that the United States and Great Britain parted ways. Here are a few fun facts connected with that fateful day.

Only John Hancock signed the Declaration of Independence on July 4, 1776. All the others signed later. The Declaration was signed by 56 men from 13 colonies. The average age of the signers was 45 from the youngest Thomas Lynch from South Carolina at 27 to the oldest Benjamin Franklin from Pennsylvania at 70. One out of eight signers was educated at Harvard...7 total. The only two signers who later became President of the United States were John Adams and Thomas Jefferson. The stars on the original American flag were in a circle so all colonies would appear equal. President John Adams, Thomas Jefferson and James Monroe all died on the fourth. Adams and Jefferson died on the same day within hours of each other in 1826. Benjamin Franklin proposed the turkey as the national bird, but was overruled by John Adams and Thomas Jefferson who recommended the Bald Eagle. In 1776, there were 2.5 million people living in the new nation. Today the population is over 330 million. Fireworks are part of the tradition of celebrating this national holiday.

But please only legal fireworks and be respectful of where you shoot them off. Always enjoy BBQ and hot dogs to chicken and ribs. Every 4th of July the Liberty Bell in Philadelphia is tapped (not actually rung) thirteen times in honor of the original thirteen colonies. Traditions place the origins of the song "Yankee Doodle" as a pre-revolutionary War song originally sung by British military officers to mock the disheveled, disorganized colonial "Yankees" with whom they served in the



French and Indian war. It's believed the tune comes from

the nursery rhyme Lucy Locket. The tune of the National Anthem was originally used by an English drinking song called "To Anacreon in Heaven." The words have nothing to do with consumption of alcohol but the melody was what Francis Key had in mind when he wrote the words we sing today. But it is kind of funny they originated as the melody for a song praise of wine.

We are better today than we have been for the last three and a half years with regard to the pandemic. But it's not all gone away and we should still be mindful there are viruses still hanging in the air. Did you know the Spanish Flu as it was called in 1918 is still with us? Let's say a prayer that we do not have to face another covid ever. Stay safe and celebrate to the MAX, but keep in mind it's the birthday of our nation!

UCSF Study Unpacks Root Causes of California's Homelessness Crisis

The timing could not have been better.

A massive UC San Francisco study of California's worst-in-the-nation homelessness crisis was released Tuesday as Gov. Gavin Newsom and legislative leaders were negotiating details of a new state budget, with homelessness spending as one of the knottiest issues.

The study bolsters previous research which concluded that California's chronic shortage of housing, which imposes crushing costs on low-income families, lies at the heart of the crisis.

About a third of California's 40 million people live in poverty or near-poverty, United Ways of California recently reported. Sudden illness, an accident, a layoff or an unexpected car repair bill can easily lead to unpaid rent, eviction and a lack of shelter.

Homelessness, the UCSF study found, often leads to – or exacerbates – alcohol or drug dependence, mental health problems and violence, indicating that its victims need more than just roofs over their heads.

"Something goes wrong, and then everything else falls apart," the study's lead researcher, Dr. Margot Kushel, the director of the Benioff Homelessness and

Housing Initiative at UCSF, told the New York Times. "Everything in their life gets worse when they lose their housing: their health, their mental health, their substance use.

"This is a problem of this toxic combination of deep poverty and high housing costs," Kushel added. "We're a state, like every state in this country, that has a lot of very poor people, and we just don't have the housing for them."

The study recommends a wide array of services and projects to help those experiencing chronic homelessness to get off the streets and protect others from the same fate.

It would seem to bolster the demands of city and county officials not only for additional billions of dollars to help homeless Californians escape their plight, but for a multi-year state commitment to provide continuity.

While Newsom has been willing to provide local governments with some funds, he's been highly critical of their homelessness efforts and so far unwilling to make long-term commitments.

That conflict was evident when the state seemingly had oodles of money, and has become even sharper now that Newsom and legislators must contend with deficits that could continue for the remainder of Newsom's governorship.

Interestingly, the Benioff study was requested by Dr. Mark Ghaly, Newsom's secretary of health and human services, who said, in a statement, "this study reinforces the importance of comprehensive and integrated supports," which is what

local officials advocate in their demands for additional state aid.

The state plays only a tangential role in providing housing and social, medical, addiction and mental health services to those in squalid encampments that have become unwanted California symbols and fodder for political and media critics.

City governments are the main overseers of housing construction and joust with the state incessantly over zoning, building permits and other hurdles for projects to house low-income families and individuals – the ones most in peril of becoming homeless.

Meanwhile, county officials provide welfare, medical and mental health services with local, state and federal funds and often squabble with their city counterparts over how those programs are sited and administered in urban centers.

The Benioff study tells us that contrary to popular belief, those lacking shelter are overwhelmingly Californians, not migrants from other states, who largely remained in their communities after falling on hard times.

California's crisis will not be resolved without the "comprehensive and integrated" approach Ghaly advocates and that means state, county and municipal officialdom must set aside fingerpointing and blame-shifting to work cooperatively. Otherwise, we'll just waste billions of more dollars and the crisis will continue to worsen.

Loaves and Fishes Mercy Clinic Offers Healthcare for the Unhoused

SACRAMENTO COUNTY, CA (MPG) - Sacramento County's homeless population faces numerous challenges, from lack of housing to limited access to essential healthcare services. Recognizing the need for medical assistance in this community, the Sacramento Loaves & Fishes Mercy Clinic offers primary care services. Operating under the Health Care for the Homeless program, this clinic has been a vital lifeline for those in need.

The clinic operates during the first part of the day Monday through Friday. Staff provide wound care, tuberculosis testing, and help people navigate health services. The dedicated team of doctors and Public Health Nurses ensure the medical needs of their clients are met.

The current form of the Sacramento Loaves & Fishes Mercy Clinic was established in 2020. However, workers with Sacramento County's Primary Care and Public Health Departments have been offering medical assistance to the unhoused for decades.

Located within Loaves & Fishes, the clinic serves as a beacon of hope for those who have fallen through society's cracks. The location allows unhoused individuals to easily access care where they are. The clinic also serves as a reminder of Sacramento County's long-standing commitment to helping the homeless community. The clinic's experienced professionals understand the unique challenges faced by this population, and they strive to ensure everyone gets the care they deserve.

"I truly believe that healthcare is a basic human right and that everyone, regardless of their housing status, deserves access to care," says Dr. Kirti Malhotra.

Dr. Malhotra has been working with the unhoused population for more than a decade. And she is not the only friendly face clients are welcomed with when they go to the clinic. The entire team at Sacramento Loaves & Fishes Mercy Clinic echoes Dr. Malhotra's sentiment. Leading the team is Dr.

Susmita Mishra, an experienced physician dedicated to serving the homeless population. Her leadership and expertise help drive the clinic's mission of providing compassionate care. The team also puts a heavy emphasis on building trusting relationships. Many patients have experienced a lack of trust in the system due to past negative experiences.

"So many of our patients come to us and they've had so many things happen to them, so they don't trust the system," says Dr. Malhotra. "We want them to know that we will work with them and that we care about them. We are there to support them and not judge them."

Part of that support goes beyond offering medical services. The clinic collaborates with community resources and shelters to help unhoused individuals seek comprehensive care. Transportation vouchers are provided to facilitate visits to labs and radiology services. Medications are available at the clinic based on insurance coverage. The staff considers not only the immediate needs but also the long-term well-being of its clients. The team looks at the patient's ongoing health requirements. Unmanaged chronic diseases and mental health conditions are common among the unhoused population.

"We often have to be very resourceful in the way we manage patients because they may not have access to the same things as other people. They might not have access to a fridge for their medication," explains Dr. Malhotra.

Because of the wide range of individual needs, the team creates individualized care plans that address each patient's needs. It's not a one-size-fits-all approach but rather tailored care that respects the limitations of unhoused individuals.

"We build rapport and trust. You have to listen to them. So often, they are

being rushed to one place after another. Incorporating that into our care goes a long way. Patients come back," says Dr. Malhotra.

Even though the clinic has been operating for years, the doctors and nurses still want to get the word out so they can assist more people in need. All unhoused patients are welcome at the clinic. Patients simply sign their names at the front of the clinic and are seen on a first-come, first-served basis. Once they are signed in, a nurse will introduce themselves, take vitals, and accompany the patient to a doctor.

In cases where clients are seriously ill or have serious injuries, physicians quickly assess the situation. Depending on the severity, they either arrange for an ambulance or taxi to pick up the patient so they can get more extensive medical treatment.

The doctors and nurses at Sacramento Loaves & Fishes Mercy Clinic understand that access to proper medical and mental health care is essential for the homeless population to find and sustain housing. When homeless individuals are healthy, they are more likely to be in a better mindset to seek and engage with housing services, helping break the cycle of homelessness.

"Just knowing that there is a place for them to go if they need support or care makes a significant difference," says Dr. Malhotra.

By addressing the healthcare needs of the homeless and breaking down barriers, the Sacramento Loaves & Fishes Mercy Clinic offers hope, healing, and a path toward a brighter future for all it serves. The clinic's unwavering dedication to the community sets an inspiring example for compassionate healthcare provision, and it underscores the importance of extending support and care to those who need it most. ★

Korean National Sentenced for "Bust Out" Bank Fraud Scheme

SACRAMENTO, CA (MPG) - Hee Soun Oh, 47, a Korean national residing in Southern California, was sentenced on June 1, 2023, to two years and nine months in prison for bank fraud and bank fraud conspiracy, U.S. Attorney Phillip A. Talbert announced.

According to court documents, between January 2017 and September 2017, Oh participated in a nationwide check kiting "bust out" scheme in order to obtain cash from banks. The scheme's participants obtained a real Republic of Korea passport that was altered to bear a new photograph and name, which they used to open bank accounts with a small amount of cash. The accounts were dormant until a time the participants believed the bank would allow the account holder to deposit a check and make withdrawals before the check actually cleared. At that time, the participants wrote checks from a different bank account with non-sufficient funds, deposited those checks into the dormant account, and then withdrew cash from

the dormant account before the checks cleared. The participants would access funds by purchasing a money order and then depositing the money order into yet another bank account associated with the scheme.

The bust-out scheme resulted in an actual loss of \$273,800 to the banks, and a total intended loss of \$466,318 based on additional, unsuccessful bust-out attempts.

This case was the product of an investigation by the IRS Criminal Investigation and the Federal Bureau of Investigation. Assistant U.S. Attorney Audrey B. Hemesath prosecuted the case.

Korean nationals Jong Eun Lee, 48, and Kyung Min Kong, 55, were previously sentenced: Lee to 22 months in prison and Kong to seven years and nine months in prison. Charges are pending against Ki Jang and Bon Soke Hong, who were indicted on Oct. 21, 2021. The charges against them are only allegations; they are presumed innocent until and unless proven guilty beyond a reasonable doubt. ★

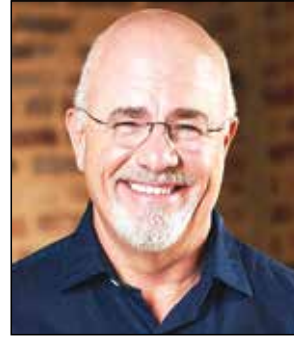

Family Business? Keep it Professional

Dear Dave,

My father isn't involved with our family-owned business anymore, but he's still a one-third owner and insists on taking a salary. This situation has begun to cause problems for other members of the family, and I was wondering what your take is.

– Tracy

Dear Tracy,

If I understand correctly, three owners form the board, and you three direct the management and leadership of the company. That means if your dad gets outvoted on something, he must accept it because he's a minority owner. As an owner who is no longer actively involved in the company, he should be getting a distribution of the profits—not a salary.

Dave Ramsey Says

Specifically, one-third when the profits are distributed.

Let me give you a visual. Draw three concentric circles so that they all overlap in the center. It should look a bit like the Olympic symbol—a Venn diagram. In each circle, write "owner," "management and leadership" and "family." This is a standard family-business diagram. Most problems in family businesses come when someone forgets which circle they're in. You could be a member of the family but not have any ownership or be in leadership. You could be in leadership but not be part of the family or be an owner. You could also be a member of the family and be an owner but not work at the company. That would be your father.

I think you guys need to reset things in your business. It's time for the working owners to sit down with your father and have an adult conversation. The discussion should be professional and gentle and go something like: "Dad, we all set this up in the beginning. But we've

made some mistakes. We shouldn't be paying a salary to people who don't work in the business. You've been repaid for your venture money, and from now on, you'll be getting a distribution of profits instead of a salary. We think this is fair and reasonable, but if you don't agree, we can discuss buying you out of your third of the company."

It sounds like things are already strained, but you've got to have a professional setup within the business. Do your best to be respectful and reasonable with your father. But you need to get this sorted out and agreed on before it causes any more hard feelings.

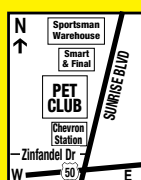
