RANCHO CORDOVA, CA (MPG) - The Cordova Recreation & Park District (CRPD) is honored to be the recipient of the California Parks and Recreation Society (CPRS) Marketing & Communications Award of Excellence for the Who We Are Campaign. The CRPD Board of Directors was presented with the award during the Regular Board Meeting in May.

CRPD's Marketing & Communications staff identified the need to help increase community understanding of CRPD's identity and to help educate the community in a fun and easily understandable way. Through discussing community needs with various staff members at multiple locations, community input and CRPD goals, staff identified the need to create a video series and developed

content necessary to meet those goals. One of CRPD's goals has been to help educate the community on their role as the park and recreation service provider in the community.

Through input received from community outreach, CRPD staff isolated key topics to develop the Who We Are campaign. CITRUS HEIGHTS, CA (MPG) - The Sunrise Mall will play host to a Comic Con event on June 24 and 25. Entitled 'The Weekend Blender,' the event is being organized by Diehardz and Son, a California-based event coordinator and collectibles shop owner.

The Weekend Blender, which was previously held in various locations in Northern California including Tracy, touts itself as "Not Your Typical Comic Con" and is making itself free to the community.

This is a breath of fresh air to budget-conscious anime lovers, as other larger local events like Sacramento Comic Con usually cost upwards of \$15.00 per person. For cosplaying families, some free admission can really make a difference and allow more financial freedom to spend on costuming and onsite vendors.

The Weekend Blender was founded in 2009 in Clovis, Calif., as a small vendor weekend for toy collectors, and began to evolve into a more Comic Con-inspired event around 2016. The latest incarnation at the Sunrise Mall will include interactive exhibits, vendors with various collectibles for sale, and a chance to meet some celebrities from the Comic Con world.

Special guest Nick Palma, who has worked as a stuntman in various films including Teenage Mutant Ninja Turtles films, will be in attendance on June 25 to speak about his career and interact with fans. Other notable guests include Sindiroom Cosplays, Jon Rego, and Hay's Hobbies. Several other notable cosplayers are also expected to be in attendance.

A cosplay contest has also been listed on the event's Facebook page, signaling that everyone is welcome by using the hashtag #cospositive. By holding body-positive cosplay events, all shapes, sizes, and ages feel comfortable in participating and joining in the fun.

Costumes should be family friendly, but do not have to be completely horror-free. When asked this exact question on social media, Diehardz and Son responded, "Horror is okay. We stay away from gore."

Events like The Weekend Blender are a welcome addition to the Sunrise Mall, which has struggled in recent years to retain business. The mall now contains stores on

Kings and Queens Rise Co-Ed Youth Sports and Mentoring League

SACRAMENTO REGION, CA (MPG) - The sixth season of Kings and Queens Rise Co-Ed Youth Sports and Mentoring League launches this week with a tip-off event, presented by G-Unity Foundation, at Golden 1 Center. The league, a partnership among The Center at Sierra Health Foundation's Black Child Legacy Campaign and My Brother's Keeper Sacramento programs and the Sacramento Kings, provides young people opportunities to engage in intercommunity activities during the summer months, helping to prevent and interrupt violence. The program is a caring and safe environment where mentors teach community building and sportsmanship.

"The Kings and Queens Rise program brings together trusted community organizations and leaders to provide a safe and supportive environment for youth to build relationships, develop teamwork skills and strengthen confidence," said Sacramento Kings Chief Operating Officer Matina Kolokotronis. "We are thrilled to host the tip-off event at Golden 1 Center and launch our sixth summer of youth basketball and mentorship opportunities."

"Investing in youth is essential to any thriving community and is an important part of our comprehensive approach

to community-led violence prevention in Sacramento," said Chet P. Hewitt, President and CEO of Sierra Health Foundation and The Center, which manages Kings and Queens Rise, the Black Child Legacy Campaign and My Brother's Keeper Sacramento. "The launch



of Kings and Queens Rise sixth season is a celebration of the partnerships that make this work possible, including the dedicated community organizations working to build trust and expertise in our neighborhoods throughout the year."

The tip-off event will be an opportunity for youth to pick up their uniforms, participate in activities and enjoy food and music. The day will include a short speaking program featuring G-Unity Foundation founder, Emmy and Grammy Award winning Multi-Hyphenate Curtis "50 Cent" Jackson, Kings guard Keon Ellis and Kings and Queens Rise Commissioner Kenneth Duncan. In addition, participants will receive mental health tips and resources courtesy of CalHOPE.

This eight-week basketball season will run

from June 24 and until August 5 and features 24 teams composed of more than 300 youth from 4th through 10th grade. Participants join teams from one of the following neighborhoods served by the Black Child Legacy Campaign and its partners: Arden Arcade, Del Paso Heights-North Sacramento, Foothill Farms-North Highlands, Fruitridge-Stockton, Marina Vista, Meadowview, Oak Park and Valley Hi. Games and practices take place throughout North and South Sacramento in community locations. The season will culminate with a tournament hosted by the Kings.

In addition, youth and their families will be invited to attend the California Classic Summer League games hosted at Golden 1 Center, July 3 and 5.

The Kings and Queens Rise program is part of the Sacramento Kings Jr. Kings program presented Kaiser Permanente. The curriculum is crafted by Kenneth Duncan of Ball Out Academy who serves as the league's commissioner. Black Child Legacy Campaign community partners in each of the seven focus neighborhoods provide safe spaces for training and season games and coaches are trained, trusted adults from these partner organizations.

Sac County Opens Welcoming Centers for Foster Youth

SACRAMENTO COUNTY, CA (MPG) - On June 16, 2023, Sacramento County's Department of Child, Family and Adult Services (DCFAS) will open three Welcoming Centers for foster youth to stay while the department searches for suitable homes and therapeutic programs to meet their needs. The centers are homes located in residential neighborhoods and staff will provide temporary shelter care for up to six children. The goal of the Welcoming Centers is to ensure a safe and supportive environment during the transition process.

DCFAS has submitted licensing applications to the California Department of Social Services Community Care Licensing (CCL) division for each of the houses. The centers will be operated by County staff temporarily while we increase capacity in home-based settings that have trained resource parents who are equipped to meet the needs of our youth. The centers are part of a larger effort by Sacramento County to facilitate timely placements, especially for teens and siblings who may take longer to find suitable home-based settings that fit their needs.

The County has been making significant efforts to transition youth out of the Warren E. Thornton Youth Center (WETYC) and into appropriate home-based placements. Placements are currently being identified or have been identified, for all youth at the facility. Unfortunately, a number of youths have chosen to exercise their right to refuse placements that have been located. These youth have experienced significant past traumas with their families and in home-based family settings that have been unable to meet their needs. Many have also been ejected from congregate care settings and may experience significant stress and difficulty when moving to new environments.

We acknowledge that children thrive in family environments, but we must respect their rights and provide them with the supports they need to increase their willingness to go to a placement. We work collaboratively with the child's counsel, community-based providers, advocates, and natural supports to accomplish this mutual goal. For the few youth that refuse identified placements, or for whom it takes

longer periods of time to find a placement, the Welcoming Centers will provide a safe community-based environment, while the department continues to work diligently to find placements and supports that can meet their needs.

Sacramento County is in the process of building a comprehensive system of care, supervision and supports for youth needing to be in short-term, safe, temporary care. Over the next six months, we will establish a number of emergency family homes that will be able to support individual children, sibling groups and youth with complex needs. We are grateful to our community-based partners who have stepped up to help us build this continuum so we can better support our youth.

"Sacramento County is not alone in facing difficulty finding safe, service-rich placements for youth with significant trauma and service needs that cross multiple systems," said Cathy Senderling-McDonald, Executive Director of the County Welfare Directors Association of California (CWDA). "This is a significant issue both statewide and across the nation." Find the full statement from CWDA regarding the need for service-rich placements for foster youth with complex needs here

In addition, DCFAS is developing prevention and early intervention strategies that will build on our long-term community-based investments in prevention services. The goal is to align with the statewide and national effort to establish a comprehensive framework that promotes child and family well-being by addressing social determinants of health, supporting families and addressing childhood trauma at an early age, while also connecting children and families to services and natural supports. Taking this approach can help prevent contact with the child welfare and juvenile justice systems.

We have been working closely with other child and family serving partners, including education, behavioral health, human assistance, juvenile justice, Alta Regional Services and many community-based providers to meet the immediate needs we are facing, while also developing the comprehensive system of prevention and early intervention. ★

CSLB Sting Uncovers Unlicensed Contractors in Rancho Cordova

RANCHO CORDOVA, CA (MPG) - The Contractors State License Board (CSLB) recently partnered with the Sacramento County District Attorney's Office to conduct a highly successful undercover operation aimed at targeting unlicensed contractors. This operation took place in Rancho Cordova on June 7 and 8, 2023, and resulted in the identification of multiple individuals engaged in illegal contracting practices.

During the operation, CSLB cited 10 individuals for allegedly conducting contracting activities without the required license. These offenders have been issued Notices to Appear in criminal court, where they could face legal consequences, including fines up to \$15,000 and/or jail time. Engaging in contracting work without a contractor's license is a misdemeanor offense in California.

The individuals targeted during this operation submitted bids ranging from \$1,500 for bathroom improvements to more than \$10,000 for concrete work. A California contractor's license is required to bid or contract for construction work exceeding \$500 in value, including materials and labor. CSLB remains steadfast in its mission to enforce contracting laws and protect consumers from unscrupulous individuals involved in unlicensed contracting activities.

Unlicensed contractors apprehended in this operation may also face additional charges for advertising their construction services without the necessary license. It is illegal under California law for anyone to advertise construction or home improvement work without a valid license in the advertised classification. If unlicensed individuals advertise contracting services,

they must explicitly disclose their lack of licensure and cannot bid or contract for work valued at more than \$500.

"CSLB is unwavering in our dedication to protect homeowners from the risks posed by unlicensed contractors," emphasized CSLB Registrar David Fogt. "Our commitment includes providing continuous consumer education on the critical significance of hiring licensed contractors. We urge homeowners to verify a contractor's license before embarking on any construction project in California."

During the operation, it was discovered that some individuals demanded excessive down payments before commencing work. California law strictly limits contractors to requesting no more than 10% of the project cost or \$1,000, whichever is less. Violating this provision constitutes a misdemeanor offense, punishable by substantial fines of up to \$5,000 or a potential one-year county jail sentence, or both.

CSLB, in collaboration with the Sacramento County District Attorney's Office and other agencies across the state, will continue to work to combat unlicensed contracting activities. Together, they will enforce the law, promote consumer protection, and uphold the integrity of the construction industry.

African Lion Kamau Passes Away at Sacramento Zoo

SACRAMENTO, CA (MPG) - The Sacramento Zoo is mourning the loss of one of our most charismatic and iconic animals, an African lion named Kamau. At nearly 17-years-old, Kamau was considered elderly. His longevity here at the Zoo is a testament to the care he received from his dedicated animal care professionals and veterinary team including specialists from UC Davis School of Veterinary Medicine.

Our staff did everything possible to make Kamau comfortable and gave him the best quality of life in his golden years. Over the last few weeks, Kamau had developed worsening gastrointestinal problems with decreased interest in food, and the difficult decision to proceed with humane euthanasia was made when medical treatment options failed

to provide sufficient relief from his condition.

Kamau came to Sacramento Zoo from the San Diego Zoo in 2008. For the 14 years that he called the Zoo home, visitors (and many Land Park neighbors) enjoyed his impressive roar. He would draw crowds from every corner of the Zoo. In 2014, Kamau sired a litter of cubs and in 2019, his habitat doubled in size and a glass viewing wall allowed our guests to get "nose-to-nose" with both Kamau and his mate, Cleo.

Cleo, our nearly 18-year-old lioness is doing well. Our carnivore care team will be monitoring Cleo closely to ensure her wellbeing. She enjoys her regular training sessions and one-on-one time with her care team.

Kamau was adored by many over the years, and we appreciate the love and support of our Zoo family. ★

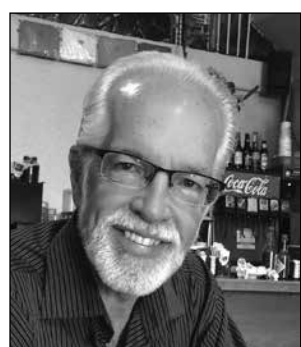

SacTax Challenges Pay Increase for Board of Supervisors

On June 8, 2023, the Sacramento Taxpayers Association (SacTax) Board of Directors formally rebuked the Sacramento County Board of Supervisors for their recent decision to grant themselves a substantial 36 percent pay raise. Compensation would increase from \$127,000 per year to \$173,000 per year or by \$46,000. This action has captured the attention of the public and two primary reasons were given for this rebuke. First, considering the economic challenges the county is currently facing, the timing of the pay raise could not have been more inopportune. Second, the process of using the “consent calendar” for the passage of the pay increase in order to avoid public scrutiny is highly inappropriate. SacTax is dedicated to the highest levels of government transparency and meaningful government oversight by members of the public and media.

It is worth noting that while the vote in favor of the salary increase was nearly unanimous, one supervisor, Sue Frost, stood against the decision. Supervisor Frost recognized the inappropriateness of the pay raise given the burden of the recent pandemic and current inflation on the economy. In contrast, the remaining board members chose to reward themselves, which can be seen as a selfish move by many. Even more troubling, median income in Sacramento is only \$36,152 — so a County

Supervisor will make nearly 500% more than their constituents. In fact, the pay raise they just voted for themselves is \$10,000 more than the ENTIRE ANNUAL INCOME of many of their hard-working constituents.

This vote is an issue that is bound to generate controversy and divide opinions. On one hand, the board members justified the pay raise by citing the County Executive’s advice to the Board that a substantial increase was necessary as some media outlets quoted that Supervisor pay had not increased since 1991. However, in examining the public record it is discovered that from just 2012 to 2022 (or 10 years) the Supervisors’ base pay went up by \$34,000 a year, not counting a car allowance, pension, and higher pay for serving on regional committees and commissions that they appoint themselves to. That is a far cry from the claim that “Supervisors’ pay hasn’t changed since 1991.”

Many Californians who have lost jobs during the pandemic will likely view the decision as tone-deaf at best and unjust at worst. The Board might argue that their work, which ensures Sacramento County is taken care of, should not go unrewarded, but the optics of their move in the present context could bring into question the decisions made by the supervisors. For example Alameda county was cited as compatible with Sacramento in population and was the basis for the 36% salary adjustment, yet housing prices which represent 40% of a household budget are double Sacramento County housing prices (\$1.1 million in Alameda vs \$550,000 for Sacramento County). The duplicity comes when the County Executive recommends raises for County staff using neighboring counties with lower costs of living than Alameda County to justify smaller staff wage increases. Also

shocking are the rumors of 25% wage increases for County Executives. This is outrageous.

According to SacTax President W. Bruce Lee, *“Being on the Board of Supervisors is a public service, not a way to pad one’s own pockets. We are not attracting candidates for public office because we offer a big salary. We are not trying to hire employees away from other companies as is done in the general marketplace. A reasonable wage is appropriate, but elected office is a service to the community and so many candidates run for public office for all of the wrong reasons – including money, ego, and fame. That’s how we get career politicians. Our electeds need to serve in office out of sense of duty – not out a sense of personal gain. I can guarantee you that if we pay \$173,000 for a county supervisor, we will not get a better supervisor than if we pay \$127,000. And, we can find highly qualified people to serve for \$110,000. Money is not the issue and should not be the motivation. Public duty and service should be the reward in itself. Remember, that US Senators and Congressional Representatives are paid \$174,000 per year.”*

The Sacramento Board of Supervisors’ decision to grant themselves such a huge pay raise is just inappropriate and wrong. Supervisor Frost, who vocalized her concerns and voted against the raise, deserves commendation, and the board needs to question County staff conclusions more and consider their constituents when making such decisions. SacTax hopes that during this budget season at the County the Board of Supervisors would revise downward their large spike in pay.

Sacramento County’s Recommended Budget Approved

SACRAMENTO COUNTY, CA (MPG) - The Sacramento County Board of Supervisors voted unanimously on June 7 to approve the \$8.4 billion recommended budget for Fiscal Year (FY) 2023-24.

“The approved budget stands as a testament to the County’s commitment to addressing the critical and urgent needs of our community,” said County Executive Ann Edwards. “The budget prioritizes funding programs that tackle pressing issues like homelessness, the improvement of road conditions in the unincorporated areas of our County, Health Services and Child, Family, and Adult Services. It is important to continue investments in these key areas to ensure the well-being of all residents.”

The \$8.4 billion budget consists of \$3.2 billion in Enterprise and Special Revenue Fund appropriations (utility rates, fees and other dedicated revenue), \$3.9 billion in General Fund appropriations (funded with \$979 million in discretionary resources, \$1.3 billion in reimbursements from restricted funds, and \$1.7 billion in Federal, State and fee revenue dedicated to specific purposes), and \$1.3 billion in Restricted Funds.

The recommended budget recognized new or enhanced areas of growth, including annual commitments of:

Mays Consent Decree Jail Population Reduction - The Recommended Budget includes \$34 million in appropriations, with \$7 million in Net County Cost to fund new or enhanced programs aligned with the County’s jail population reduction plans to comply with the Mays consent decree.

Mays Consent Decree Remedial Plan - \$10 million in Net County Cost included in the Recommended Budget in the Sheriff and Correctional Health budget units to fund continued efforts to meet the County’s obligations under the Mays consent decree remedial plan, including additional staffing and services.

Addressing Homelessness - \$2 million in Net County Cost to fund new programs and services addressing homelessness in the County.

Health Services - Overall, the Health Services budget includes \$84 million of Growth funded almost entirely by State, Federal and Mental Health Services Act (MHSA) revenue.

In addition to the Growth identified in the Mays Consent Decree Jail Population Reduction and Addressing Homelessness sections above, recommended Growth includes \$14 million for Cal-AIM performance-based incentive programs, \$14 million to construct a new Children’s Mental Health Psychiatric Health Facility and Crisis Stabilization Unit, \$10 million to construct a new Mental Health Rehabilitation Center, \$5 million to increase the Children’s Mental Health Flexible Integrated Treatment contract pool, and \$2 million to increase existing Full Service Partnership contracts.

Child, Family and Adult Services - \$3 million in Net County Costs to support Child Family and Adult Services’ programs to implement the Families First Prevention Services block grant program, and \$2 million in Net County Cost to provide additional funding for Child Protective Services welcome and assessment center contracted services.

During Board deliberations, the Board added additional items totaling \$7.6 million:

\$5 million to address road repairs/improvements in the unincorporated County; \$1.7 million to Regional Parks to fund ongoing contracted trash pickup and removal and for necessary equipment expenses; \$300,000 to Water Resources for staff time or contracted services to manage flood mitigation efforts in the south County; \$463,150 to the District Attorney for two additional attorneys; \$168,000 to Human Assistance for Cal-Fresh benefits at farmer’s markets.

For more details on the recommended budget, read the County Executive’s Budget Letter or view the budgets documents on the Office of Budget and Debt Management’s website.

The numbers on the Recommended Budget will change between now and September, when the County receives new information, including the impact of the State Budget and updated revenue totals. The Final Budget will come back to the Board of Supervisors in September for review and adoptions.

Defendant Convicted for Drive-By Shooting Murder

SACRAMENTO COUNTY, CA (MPG) - Devonte White was convicted by a jury of first-degree murder and felon in possession of a firearm. The jury also found true the special circumstance that in the commission of the murder, White intentionally and personally discharged a firearm from a motor vehicle causing death.

On January 25, 2022, Matthew Keen was

murdered on the front porch of his residence in a targeted drive-by shooting. He was shot at eight times and hit three times. Surveillance video showed a vehicle passing the victim, making a U-turn, passing the victim a second time before backing up and the driver shooting the victim at point blank. A stolen handgun was located at Devonte White’s apartment. The District Attorney’s Crime Lab matched the gun to expended shell casings on scene and in the car used in

the shooting. White’s DNA was also located on the firearm. Two weeks prior to the murder, White got into an argument with people the victim was with at a market near the victim’s residence. White left the scene and returned with a firearm that he brandished at the victim.

White faces a maximum sentence of life in prison without the possibility of parole. Sentencing is set for September 8, 2023, at 9:00 a.m. in Department 11 before the Honorable James McPetridge. ★

Workplace Angst Helping 'Job Killer' Bills Survive In California Legislature

In the 27 years of the California Chamber of Commerce's "job killer" project, it has followed a fairly predictable pattern.

The chamber would annually designate several dozen legislative bills that business and employer groups considered to be particularly onerous – usually the highest priority measures of labor unions, environmental groups, consumer advocates and personal injury attorneys.

One-by-one, most of the targeted bills would fall by the wayside and only a few, if any, would reach the governor's desk and be signed into law. Overall, the chamber and its allied business groups have achieved about a 90% kill ratio.

This pattern continued even after Gavin Newsom, arguably the most liberal governor in California history, took office in 2019. In the first four years of his governorship, the chamber tagged 94 bills as "job killers." Just eight of them landed on Newsom's desk and he signed six.

So far, 17 bills have made this year's list – an unusually small number – and more than half have already faltered, mostly failing to clear committees.

One has reached Newsom

and been signed, but it's a faint shadow of its original thrust. Newsom wanted to either tax or penalize oil companies for what he characterized as price-gouging, but settled for giving the California Energy Commission the power to investigate gas prices, set allowable profit margins and levy fines on those which exceed them.

There are two tax increases on the chamber list, one imposing a wealth tax and another increasing corporate income taxes. Both, however, are nonstarters.

The unusual aspect of this year's "job killer" battle is that the eight bills still viable, having cleared their first legislative houses, all relate to one topic – wages and workplace conditions – and are sponsored by unions or personal injury attorneys.

They are the political manifestation of what has become a very contentious labor relations atmosphere this year, not only in California but across the nation, due to high inflation and an overall shortage of workers.

In the main, the employment bills' sponsors contend they are needed to bring more equity to workers while the chamber and other opponents say they will raise costs and thus reduce the financial ability of employers to expand payrolls.

The eight, in brief:

- Assembly Bill 524, which would outlaw discrimination against a personal caregiver in employment, similar to the protection granted to persons on the basis of gender, age and other

personal characteristics;

- Assembly Bill 647, which would enhance the job protections of grocery industry workers who are displaced by mergers, sparked by the pending merger of the Kroger and Albertsons grocery chains;

- Senate Bill 365, which would make arbitration of employment disputes, which employers generally favor, less viable by allowing lawsuits to continue while employers seek judicial approval of arbitration proceedings;

- Senate Bill 399, which would prohibit employers from disciplining any worker who refuses to listen to employer presentations on political or religious issues;

- Senate Bill 525, which would increase minimum wages in the health care industry to \$21 an hour in 2024 and then \$25 in 2025, with cost-of-living increases thereafter;

- Senate Bill 616, which would increase the amount of paid sick leave employers must offer from a minimum of three days a year to seven days;

- Senate Bill 627, which would require retail and service chains, such as restaurants, to use seniority when deciding which workers to retain or transfer when closing outlets;

- Senate Bill 723, which would make permanent a temporary law passed during the COVID-19 pandemic to protect return rights of workers in the hospitality industry who are laid off.

SMUD to Hold Public Workshops on Proposed Rate Action

SACRAMENTO REGION, CA (MPG) - The SMUD Board of Directors is holding two public workshops and a public hearing to discuss proposed rate changes.

The Chief Executive Officer & General Manager's Report and Recommendation on Rates and Services, released by SMUD CEO & General Manager Paul Lau, outlines a proposed rate increase of 2.75 percent on January 1, 2024; May 1, 2024; January 1, 2025; and May 1, 2025. RESOLUTION OF THE BOARD OF DIRECTORS OF THE CORDOVA RECREATION AND PARK DISTRICT RESOLUTION OF THE INTENTION TO LEVY ASSESSMENTS FOR FISCAL YEAR 2023/24, PRELIMINARILY APPROVING ENGINEER'S REPORT, AND PROVIDING FOR NOTICE OF HEARING FOR THE PARK MAINTENANCE AND RECREATION IMPROVEMENT DISTRICT

WHEREAS, the Board of Directors of the Cordova Recreation and Park District (the "District"), acting as the legislative body of the Park Maintenance and Recreation Improvement District, has previously ordered through Resolution 06/07-1 the formation of an assessment district pursuant to the provisions of the Landscaping and Lighting Act of 1972, known as the Park Maintenance and Recreation Improvement District, for the purpose of financing certain park and recreational improvements, and for the purpose of funding maintenance operations of the District; and

WHEREAS, *Streets and Highways Code* sections 22622, 22623 and 22661 authorize the preparation of an Engineer's Report on an annual basis which shall describe any proposed new improvements or any substantial changes in existing improvements, set forth an estimate of the costs of any improvements and/or annual maintenance costs for the park and recreational improvements specified in the Engineer's Report, specify a diagram for the assessment district and specify the amount to be assessed upon various types of assessable lands within the assessment district; and

WHEREAS, an Engineer's Report for Fiscal Year 2023/24 as authorized by the Board of Directors has been presented to the Board of Directors for its consideration and approval, which Engineer's Report generally describes the general nature, location, and extent of the new improvements or any substantial changes in existing improvements, provides an estimate of the costs of any proposed new improvements or substantial changes in existing improvements and refurbishments, specifies the costs of maintenance of park and recreational improvements within the district, and sets forth a diagram for the assessment district; and

WHEREAS, the Board of Directors has adopted a Resolution approving and filing an Engineer's Report for Fiscal Year 2023/24 as required by *Streets and Highways Code* Section 22623, which Engineer's Report sets forth plans and specifications for the improvements or any substantial changes in existing improvements, an estimate of the costs of these improvements, an estimate of the cost of maintenance with respect to such improvements, a diagram of the assessment district, and a description of the net amount to be assessed upon assessable lands within the assessment district which Engineer's Report is incorporated herein by this reference.

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors hereby declares its intention to levy and collect assessments pursuant to *Streets and Highways Code* Section 22624 as follows:

a. The Board of Directors of the Cordova Recreation and Park District, acting as the Board of Directors of the Park Maintenance and Recreation Improvement District, hereby adopts the Preliminary Engineer's Report dated June 21, 2023, and files said Engineer's Report with the Clerk of this Board as approved pursuant to the requirements of *California Streets and Highways Code* section 22623.

b. Said assessments will be levied and collected within the boundaries of the Park Maintenance and Recreation Improvement District, the boundaries of which are specifically described in the Engineer's Report. A full and detailed description of the boundaries of the Assessment District and the parcels of land within the district is contained within the approved Engineer's Report.

c. The Board of Directors declares its intent to levy and collect assessments for the Fiscal Year 2023/24 within said district at an assessment rate of \$31.11 per year per single family residential unit, as set forth in the Engineer's Report. These assessments are based on the same formula as those levied in Fiscal Years 2006/07 through 2022/23. The total number of parcels projected to be assessed and an estimate of total annual assessment revenue are contained within the Engineer's Report.

d. Ongoing maintenance, improvements and/or refurbishments within said assessment district to be funded by said assessments are detailed within the Engineer's Report which is incorporated herein by this reference.

e. RESOLUTION OF THE BOARD OF DIRECTORS OF THE CORDOVA RECREATION AND PARK DISTRICT RESOLUTION OF THE INTENTION TO LEVY ASSESSMENTS FOR FISCAL YEAR 2023/24, PRELIMINARILY APPROVING ENGINEER'S REPORT, AND PROVIDING FOR NOTICE OF HEARING FOR THE INDEPENDENCE AT MATHER LANDSCAPING AND LIGHTING ASSESSMENT DISTRICT

WHEREAS, the Board of Directors of the Cordova Recreation and Park District (the "District"), acting as the legislative body of the Independence at Mather Landscaping and Lighting Assessment District, has previously ordered through Resolution 00-8 the formation of an assessment district pursuant to the provisions of the Landscaping and Lighting Act of 1972, known as the Independence at Mather Landscaping and Lighting Assessment District, for the purpose of financing certain park and recreational improvements, and for the purpose of funding maintenance operations of the District; and

WHEREAS, *Streets and Highways Code* sections 22622, 22623 and 22661 authorize the preparation of an Engineer's Report on an annual basis which shall describe any proposed new improvements or any substantial changes in existing improvements, set forth an estimate of the costs of any improvements and/or annual maintenance costs for the park and recreational improvements specified in the Engineer's Report, specify a diagram for the assessment district and specify the amount to be assessed upon various types of assessable lands within the assessment district; and

WHEREAS, an Engineer's Report for Fiscal Year 2023/24 as authorized by the Board of Directors has been presented to the Board of Directors for its consideration and approval, which Engineer's Report generally describes the general nature, location, and extent of the new improvements or any substantial changes in existing improvements, provides an estimate of the costs of any proposed new improvements or substantial changes in existing improvements and refurbishments, specifies the costs of maintenance of park and recreational improvements within the district, and sets forth a diagram for the assessment district; and

WHEREAS, the Board of Directors has adopted a Resolution approving and filing an Engineer's Report for Fiscal Year 2023/24 as required by *Streets and Highways Code* section 22623, which Engineer's Report sets forth plans and specifications for the improvements or any substantial changes in existing improvements, an estimate of the costs of these improvements, an estimate of the cost of maintenance with respect to such improvements, a diagram of the assessment district, and a description of the net amount to be assessed upon assessable lands within the assessment district which Engineer's Report is incorporated herein by this reference.

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors hereby declares its intention to levy and collect assessments pursuant to *Streets and Highways Code* section 22624 as follows:

a. The Board of Directors of the Cordova Recreation and Park District, acting as the Board of Directors of the Independence at Mather Landscaping and Lighting Assessment District, hereby adopts the Preliminary Engineer's Report dated June 21, 2023, and files said Engineer's Report with the Clerk of this Board as approved pursuant to the requirements of *California Streets and Highways Code* section 22623.

b. Said assessments will be levied and collected within the boundaries of the Independence at Mather Landscaping and Lighting Assessment District, the boundaries of which are specifically described in the Engineer's Report. A full and detailed description of the boundaries of the Assessment District and the parcels of land within the district is contained within the approved Engineer's Report.

c. The Board of Directors declares its intent to levy and collect assessments for the Fiscal Year 2023/24 within said district at an assessment rate of \$200.79 per year per single family residential parcel as set forth in the Engineer's Report. These assessments are based on the same formula as those levied in fiscal years 2000/01 through 2022/23. The total number of parcels projected to be assessed and an estimate of total annual assessment revenue are contained within the Engineer's Report.

d. Ongoing maintenance, improvements and/or refurbishments within said assessment district to be funded by said assessments are detailed within the Engineer's Report which is incorporated herein by this reference.

e. Reference is hereby made to the Engineer's Report which is on file with the Clerk of the Board for a complete description of the proposed improvements and maintenance to be undertaken in Fiscal Year 2023/24 and the cost thereof, and the proposed assessments upon assessable lots and parcels of land within the proposed assessment district.

f. The Board hereby declares that this Resolution of Intention constitutes a Notice of Hearing regarding its intent to levy and collect assessments within the Independence at Mather Landscaping and Lighting Assessment District for Fiscal Year 2023/24. This Public Hearing shall be held at a Regular meeting of the Board of Directors on July 19, 2023, at 6:30 p.m. at the Meeting Chambers of the Cordova Recreation and Park District, 2729 Prospect Park Drive, Rancho Cordova, California 95670. The Clerk is hereby directed to publish this notice as a Notice of Hearing in a newspaper of general circulation pursuant to the requirements of *Government Code* section 6061.

BE IT FURTHER RESOLVED that prior to the conclusion of the Public Hearing, any interested person may file a written protest with the Clerk of the Board, or, having previously filed a protest, may file a written withdrawal of that protest. A written protest shall state all grounds of objection. A protest by a property owner shall contain a description sufficient to identify the property owned by such owner. Such protest or withdrawal of protest should be mailed to the attention of the Clerk of the Board of the Cordova Recreation and Park District, 11070 White Rock Road, Suite 130, Rancho Cordova, California 95670 or may be hand delivered to the Clerk prior to the conclusion of the public hearing.

Officer Pleads No Contest to Submitting False Police Reports

SACRAMENTO COUNTY, CA (MPG) - On June 5, 2023, Alexa Palubicki pled no contest to two felony counts of submitting a false police report. The charges relate to an incident that occurred on July 11, 2020, while Palubicki was an officer with the Sacramento Police Department, which involved falsifying the probable cause for stopping a vehicle. Sentencing is set for June 5, 2024, at 9:00 a.m. in Department 25 before the Honorable Shauna Franklin. If Palubicki does not commit another criminal offense before the sentencing, the judge will reduce the felony counts

to misdemeanors and she would face a maximum sentence of 2 years in county jail.

The Sacramento District Attorney's Office objected to the plea bargain offered by the judge and argued that Palubicki should receive felony convictions for her conduct and the charges should not be reduced to misdemeanors at sentencing. With felony convictions, Palubicki would face a maximum sentence of 3 years and 8 months in state prison.

District Attorney Thien Ho stated, "Any time a police officer falsifies a police report, it is an affront to justice and taken very seriously. As prosecutors, we must proceed only on cases where the

evidence is trustworthy and legally obtained. We have the solemn duty to ensure that justice and fairness remain the touchstone of our criminal justice system."

Immediately upon being notified of Palubicki's conduct, the Sacramento District Attorney's Office conducted an internal case audit to identify cases we had filed in which she participated. Pending cases in which her participation was material and necessary for prosecution were dismissed. In other cases where Palubicki participated in some manner but was not a necessary witness for trial, we notified the defense of this investigation consistent with our ethical obligations. ★

Defendant Sentenced for DUI-Involved Murder of Bicyclist

SACRAMENTO COUNTY, CA (MPG) - The Honorable Allen Sumner sentenced Armando Moreno-Rodriguez to 16 years to life in prison. On March 20, 2023, a jury convicted Moreno-Rodriguez of the second-degree murder of Michael Dodson, gross vehicular manslaughter while intoxicated, hit and run, and driving on a suspended license.

Moreno-Rodriguez had three prior misdemeanor convictions for DUI and was given a Watson advisement, which is an advisement that driving

under the influence is extremely dangerous to human life and might lead to a charge of murder if someone is killed as a result. In June 2021, Moreno-Rodriguez drove through a main gate and onto the American River bike path. He drove at speeds of 35 mph for approximately 4 miles before colliding with a cyclist, who was a member of the Sacramento Wheelman. After the collision, Moreno-Rodriguez kept driving until his car shut down due to the damage. The victim suffered major injuries and eventually died one month later. Moreno-Rodriguez's blood alcohol level was .27. ★

Detectives Arrest Citrus Heights Man for Internet Crimes Against Children

CITRUS HEIGHTS, CA (MPG) - On June 7, 2023, Internet Crimes Against Children (ICAC) detectives from the Sacramento County Sheriff's Office arrested Ryan Coats (48), of Citrus Heights.

In April of 2023, Coats began communicating with an undercover (UC) detective who posed as a 13-year-old child. During the course of communication, COATS sent explicit pictures and videos of himself to the UC and expressed desire to teach UC about sex. Additionally, he offered to meet with UC, described his sexual experiences in graphic detail, encouraged UC to view pornography and to conceal their communication from the UC's mother.

Investigation revealed that Coats is a registered sex offender and has been

previously convicted in 2014 for sending harmful matter (pornography) to a minor. Coats has also been previously convicted, in 2016, for communicating with a minor to commit a sex offense and attempted lewd and lascivious acts with a child under 14.

ICAC detectives coordinated with the Citrus Heights PD Sex Offender Registration Unit and determined Coats had moved out of his residence, purchased a different vehicle, changed his telephone number, and was preparing to move to Oregon. ICAC detectives intercepted Coats just prior to him moving out of California.

If you have information regarding unreported crimes or if you believe a child may have had inappropriate communications or contact with Coats, please contact your local law enforcement agency. ★

Medical Director under Arrest for Sexual Assault in Facility

CARMICHAEL, CA (MPG) - On April 26, 2023, the Sacramento County Sheriff's Office received a call for service at the River Pointe Post-Acute Care Facility on Fair Oaks Boulevard regarding a report of a sexual assault. The victim, an employee at the facility, alleged that her boss, Dr. Rachandeep Singh, touched her sexually against her will.

Dr. Singh was removed from the facility by their administration. Singh was identified as the facility's medical director, and detectives learned he oversaw at least two other facilities as the medical director in the City of Stockton and the San Joaquin County areas. Based on the subsequent investigation results, the Sacramento County District Attorney's Office elected to file felony

sexual battery charges against Singh and issued a warrant for his arrest.

Singh was arrested on June 17, 2023, by the San Francisco Police Department at the San Francisco International Airport. He was booked into custody at the San Mateo County Jail but released on bail the same day. He is scheduled to appear in court in Sacramento on August 17, 2023, at 3:00 PM. Due to Dr. Singh's position in several areas throughout the region, Detectives are looking for other potential victims.

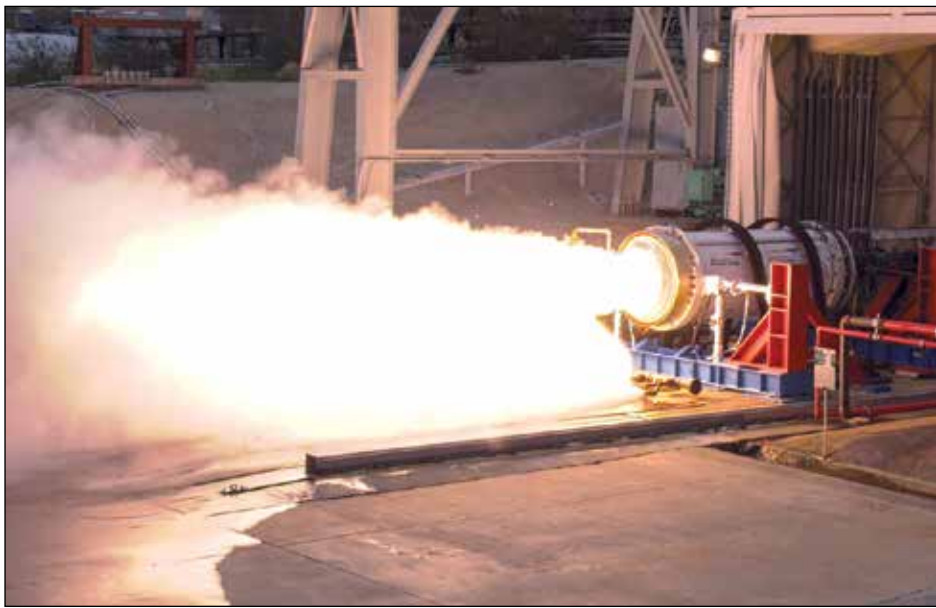

Aerojet Hot Fires Solid Rocket Motor for Next Generation MRBM Target

HUNTSVILLE, AL (MPG) - Aerojet Rocketdyne has successfully completed the qualification static fire test of the eSR-19, the advanced large solid rocket motor that will power the Missile Defense Agency's (MDA) next generation Medium Range Ballistic Missile (MRBM) target used to test our nation's missile defense systems.

"I applaud the dedicated efforts by teams across Aerojet Rocketdyne to meet this important milestone," said Eileen P. Drake, Aerojet Rocketdyne CEO and president. "Our steadfast workforce and advanced solid rocket motor propulsion remain crucial to helping protect our nation and our allies."

The successful qualification test, conducted by Air Force Research Laboratory (AFRL) and Aerojet Rocketdyne personnel at AFRL's test facility at Edwards Air Force Base, California, paves the way for delivery of flight test motors later this year.

The eSR-19 is a redesigned version of the SR-19 that currently serves as the second stage of the nation's Minuteman III strategic missiles. Featuring a lighter, filament-wound composite case and other performance-enhancing

improvements, the eSR-19 will provide the propulsion for both stages of MDA's air-launched, medium-range target vehicle, developed by Aerojet Rocketdyne subsidiary Coleman Aerospace.

The motor was designed and fabricated in Aerojet Rocketdyne facilities in Huntsville, Alabama, and cast and cured in Camden, Arkansas. The eSR-19 motors are later integrated into the target systems by the Coleman Aerospace team in Orlando, Florida.

This recent qualification test was the latest achievement in the evolution of Aerojet Rocketdyne's legacy Large Solid Rocket Motor (LSRM) capabilities, which have included investments in a talented workforce and new modern LSRM facilities.

2021 County Greenhouse Gas Inventory Released

SACRAMENTO COUNTY, CA (MPG) - Sacramento County has released its 2021 Greenhouse Gas (GHG) Inventory for public review and is proud to show reduced GHG emissions in government operations and throughout the unincorporated community as a whole.

The GHG Inventory presents both a Sacramento County government operations inventory and an unincorporated community-wide inventory. The Inventory shows that Sacramento County has reduced GHG emissions in its government operations by 32.5 percent compared to 2015 levels, the year of our last inventory. The Inventory also shows that the unincorporated community of Sacramento County has reduced GHG emissions by 3.2 percent since 2015.

"Our 2021 government operations

inventory shows a reduction of 39,979 metric tons of carbon dioxide equivalents from 2015 levels, which equates to 8,897 gasoline-powered passenger vehicles driven for one year or planting 661,056 tree seedlings grown for 10 years," said John Lundgren, Sacramento County Sustainability Manager. "While we still have a tremendous amount of work to do to reach carbon neutrality, we can celebrate a victory in seeing our internal government operations efforts pay off in documented GHG reductions."

The Inventory will be presented to the Climate Emergency Mobilization Task Force as an informational item on June 15. The public may submit comments on the GHG Inventory until July 31 by emailing John Lundgren at Lundgrenj@Saccounty.gov.
