## Paying Tribute to the Fallen

**RANCHO CORDOVA, CA (MPG)** - Rancho Cordovans paid tribute to American men and women who have given their lives in defense of the country during a moving Memorial Day Observance held at the Cordova High School Performing Arts Center on May 29, 2023.

A group of 13 veterans were honored with the dedication of memorial bricks, which will be installed at the Veterans Memorial Plaza, located in front of the medical center – an annual tradition. They will join more than 2,000 which have now been placed at

the plaza.

The 2023 Memorial Day event paid special homage to the veterans and fallen from the Vietnam War era.

March 29 marked the 50th anniversary of when the last troops left Vietnam and the final group of American prisoners of war were

freed and left Hanoi. The Vietnam conflict raged on the soil of Vietnam, Laos and Cambodia from 1955 to fall of Saigon, years which changed the lives of those who served, and the entire nation, as well.

“We are so fortunate to be living in the United States of America, the most wonderful country on earth,” said Master of Ceremonies and Navy veteran Rick Swinford. “We honor those who have protected our freedoms. All gave some. Some gave all. And remembering those is what Memorial Day is all about.”

Dr. Dan DeShong, a Vietnam veteran, shared moving remarks as keynote

## Blue Star Museums Offer Free Admission to Military and Families

**SACRAMENTO, CA (MPG)** - Six Sacramento area museums are participating in Blue Star Museums – a partnership between the National Endowment for the Arts and Blue Star Families, in collaboration with the Department of Defense and museums across America – to offer free admission to the nation’s active-duty military personnel and their families, including National Guard and Reserve, through Labor Day on September 4, 2023. The six local museums participating in the 2023 Blue Star Museums program include the following: Aerospace Museum of California, California Automobile Museum, California Museum, Crocker Art Museum, Fairytale Town, and the Sacramento History Museum.

The free admission program is available for those currently serving in the United States Military—Army, Navy, Air Force, Marine Corps, Coast Guard, including Reservists, National Guardsman (regardless of status), U.S. Public Health Commissioned Corps, NOAA Commissioned Corps, and up to five family members. Qualified members must show a Geneva Convention common access card (CAC), DD Form 1173 ID card (dependent ID), or a DD Form 1173-1 ID card for complimentary entrance into a participating Blue Star Museum.

Before planning a visit, guests are encouraged to contact the individual museums for hours of operation and note some are normally closed on Mondays and in observance of holidays such as Memorial Day and Labor Day. ## All Aboard the Anniversary Train!

*Sac-Valley Live Steamers Celebrates 50 Years*

**RANCHO CORDOVA, CA (MPG)** - On May 20, 1973, 25 members of the not-yet-formed Sacramento Valley Live Steamers Corporation held their 1st Spring Meet in Cordova Community Park (not yet Hagan Community Park). A ceremony was held celebrating the completion of the 1,700-foot oval aluminum track. Fast forward to May 20, 2023, and the 230 plus members of the Sac-Valley Live Steamers Railroad Museum (SVLSRM), a 501(c) 3 non-profit organization is holding another Spring Meet in the now Hagan Community Park.

About 200 people attended another ceremony commemorating 50 years of service. The ceremony took place on a beautiful Saturday afternoon at the same location of the first official golden spike celebration. The

event included the original engines involved in the inaugural golden spike: Ken Spicer’s Mikado and Milon Thorley’s American. Today, there is nearly 7,000 feet of track laid containing many switches and 230 plus members in

the SVLSRM organization. The program started with a warm welcome from Andy Berchielli, Board President of SVLSRM followed by historical remarks from Don Yungling and Dennis Gramith. Gramith served several years as president

of SVLSRM, is a life member and attended the original ceremony in 1973. He also helped with the expansion and acquiring the full-size caboose and boxcar that are part of the museum. Yungling is the son of Ed Yungling who is

**SACRAMENTO, CA (MPG)** - The Sacramento Regional Transit District (SacRT) is entering year four of the RydeFreeRT fare-free rides for youth program. Launched in 2019, RydeFreeRT was the first unrestricted youth fare-free ride program in the country. The program allows all 265,000 youth living in SacRT's service area, from transitional kindergarten to 12th grade, including home-schooled students, foster and unhoused youth to ride all buses and light rail trains for free, all day, any day of the year.

The RydeFreeRT program has helped boost student ridership, which now accounts for nearly 25% of all SacRT bus and light rail rides over the last year compared to 8% before the launch of the program in 2019. In fact, student ridership is on pace to carry nearly 3.5 million youth in FY 2023, double what it was in 2019 pre-pandemic. This demonstrates that students and youth are one of the most price sensitive groups impacted by transit fare.

"We value our young people and that means helping them get to school, jobs, and activities," said SacRT Board Chair and Sacramento County Supervisor Patrick Kennedy.

The ridership growth is a testament to the success of the program, which initially aimed to reduce truancy and absenteeism in schools. However, a study by the University of Texas, which evaluated the program, also found that RydeFreeRT not only improved school attendance and reduced congestion

from vehicle pick-up lines, it also successfully reduced the transportation barrier to get to jobs, internships and extracurricular activities after school and on weekends.

"We're introducing a new generation of riders to transit," said SacRT General Manager/CEO Henry Li. "Research shows that people who ride public transportation at a young age are more likely to use it as adults, building ridership for life."

As students head into summer break, SacRT is reminding them and their families that youth in kindergarten through 12th grade can continue to ride the entire SacRT transit network, including SacRT buses, light rail, and SmaRT Ride on-demand microtransit service for FREE! To ride free, students need to show a valid RydeFreeRT card.

New RydeFreeRT cards with a valid date of June 1, 2023, through June 30, 2024, are being delivered at various school locations and Sacramento Public libraries. The current RydeFreeRT card is still valid through June 30, 2023. Cards are also available at the SacRT Customer Service and Sales Center at 1225 R Street in Sacramento (adjacent to the 13th Street light rail station).

The RydeFreeRT program is possible with funding from all member jurisdictions that comprise of SacRT (the cities of Sacramento, Citrus Heights, Elk Grove, Folsom, Rancho Cordova, and the County of Sacramento).

New RydeFreeRT cards are available at schools, public libraries and SacRT Customer Service and Sales Center.

miniture steam trains that run in the eastern boundary of beautiful Hagan Community Park. # Man Arrested for Stealing Vehicle with Child Still Inside

**RANCHO CORDOVA, CA (MPG)** - Just before 12:30 P.M. on Friday, June 2, 2023, the Sacramento County Sheriff's Office Communications Center received a 9-1-1 call from a victim who stated her vehicle was stolen, with her 1 1/2-year-old child still inside sleeping. The vehicle was taken in front of the victim's apartment on the 3400 block of Laurelhurst Drive (in Rancho Cordova), as the victim went back inside to get her other child. Deputies and officers from the Rancho Cordova Police Department responded immediately to contact the victim.

Deputies and officers utilized License Plate Reader (LPR) technology to attempt to locate the vehicle and trace its route. A short time later, a passerby called the Communications Center stating they found a small child still in their car seat at a nearby shopping center. Deputies quickly responded and discovered the child unharmed, reuniting the victim with her child.

At approximately 12:45 P.M., an officer from the Rancho Cordova Police Department Problem Oriented Policing (POP) unit located the vehicle traveling northbound on Sunrise Boulevard, near Gold Country Boulevard, with an unknown suspect driving. Officers and deputies attempted to stop the vehicle, but the suspect, later identified as 25-year-old Aaron Lemus, refused to stop. After leading them on a short vehicle pursuit through surface streets, deputies successfully deployed spike strips, eventually rendering the vehicle immobile. Lemus pulled into a gas station near Coloma Road and McGregor Drive, where he was taken into custody without further incident.

Lemus was transported to the Sacramento County Main Jail for PC 207(a) – Kidnapping; VC 10851(a) – Vehicle Theft; VC 2800.2 – Reckless Evasion; and PC 273(a) – Child Endangerment. He is currently being held on \$100,000 bail and is scheduled to appear in court on June 6, 2023. ★

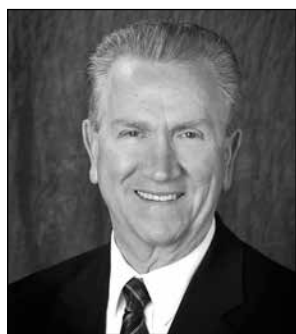

the summer months at no charge. The program serves all children ages 2 through 18 years old. Children must be present to receive a meal."

"The Folsom Cordova Unified School District FCUSD Food Services Department will be operating the Seamless Summer program at the following schools." The lunch available will be at different dates according to the schools needs.

There are 4 schools in Cordova and 7 schools in Folsom that have the lunch availability from June 1 - June 18; 1 school in Cordova and 1 school in Folsom June 3 - July 1; 7 schools in Cordova and 2 schools in Folsom June 1 - July 23; 1 school in Folsom June 7 - July 1; and 7 schools in Cordova and 2 schools in Folsom June 1 - July 23. You can find the names of the schools on FCUSD on line. I am glad that there is a program like that which helps the students who need the lunch.

The Cordova Community Council will show movies on Friday evenings in the Village Green Park, and then in August there will be bands in the Village Green Park on Friday evenings. There will be quite a few things going on in July as I said about our 20 year anniversary for our city, a get together on July in the park, and a parade on July 4 on Coloma Road, and then on to Hagan park for rides and food and families getting together there. ## Newsom's Expansive Health Care Promises to Californians Remain Elusive

Five years ago, while running for governor, Gavin Newsom pledged to transform California's medical care to a single-payer system similar to those in Canada and western Europe.

Newsom backed single-payer legislation, which had passed the state Senate, saying there was "no reason to wait around."

"I'm tired of politicians saying they support single-payer but that it's too soon, too expensive or someone else's problem," Newsom said.

His position helped solidify support for Newsom among the proposal's progressive advocates as he duelled with a fellow Democrat, Antonio Villaraigosa.

The bill stalled in the Assembly, and after winning the election, Newsom began edging away from the single-payer concept, citing difficult barriers. One is persuading the federal government to give California the \$200-plus billion it spends on Californians' health care — about half the state's total medical expenditures. Newsom segued into pursuing universal health care, meaning all of the nearly 40 million Californians would have some sort of coverage, and came close last year.

At the time, "About 3 million Californians reported

being uninsured in spring 2022," a report from the Public Policy Institute of California notes, citing census data. "Nearly seven in 10 (68%) are Latino, about 38% are noncitizens and 80% have low or moderate incomes (below 400% of the federal poverty line)."

Some of the gap was closed in the 2022-23 budget, drawing on what seemed to be a nearly \$100 billion budget surplus, by extending Medi-Cal coverage to undocumented immigrants otherwise ineligible for federally subsidized insurance.

"Beginning no later than January 1, 2024, Medi-Cal will be available to all income-eligible Californians," the final 2022-23 budget declared.

The expansion of Medi-Cal — California's version of the federal Medicaid program — was made easier during the COVID-19 pandemic when federal authorities relaxed eligibility requirements. This year, enrollment topped 15 million, or nearly 40% of the state's population.

Under his "California Blueprint," universal health care is still Newsom's professed goal. However, at the moment, coverage appears to be shrinking, and with the state facing chronic budget deficits, reaching it before Newsom's governorship ends would be difficult, if not impossible.

The federal government's "continuous enrollment" pandemic policy is expiring and hundreds of thousands of Californians who benefited from it will once again have to prove their eligibility.

Newsom's revised 2023-24 budget, unveiled last month, projects that Medi-Cal enrollment will decline by more

than a million people, still more than a third of the state's population but moving away from the universal coverage Newsom has sought as a single-payer substitute.

Single-payer advocates are, unsurprisingly, annoyed by Newsom's failure to deliver on his 2018 promise. They gave him some heat when he appeared at last month's state Democratic Party convention.

Covering all Californians would be expensive. Medi-Cal coverage costs federal and state governments about \$10,000 per enrollee. No one knows precisely how many Californians still lack coverage today but 2 million is as good a number as any, and including that many more in Medi-Cal could potentially cost another \$20 billion a year.

Meanwhile, single-payer advocates haven't given up. Last week, the California Senate passed Senate Bill 770, aimed at implementing a plan for single-payer coverage developed by the Healthy California for All Commission, which Newsom created in 2019.

The bill would direct state agencies to begin talks with federal officials about participating in a California single-payer system.

"It's time we made real progress toward eliminating the inequities and injustices of our fractured healthcare system," a co-author of the bill, state Sen. Scott Wiener, a San Francisco Democrat, said.

As Newsom finally learned, it's much easier said than done.

5,500 veterans, He said, "Last week I submitted our 51st grant request for 2023, providing a grant (an elliptical bike) to our chaplain, Terry Ledford, (U.S. Army Retired). Chace reported they have given out a dozen of the elliptical bikes to veterans. It is reported that

exercise equipment is the most requested item from OCW.

Ledford gave his testimony of how the stresses of the military had affected him, saying, "Being in the military can be stressful on the body." Even though he

would have liked to make a career in the service he was forced to retire early in 2015 after 26 years in the military. He now has braces on both his feet, making it hard to walk. Recently, he joined the American Legion which

gave him direction as he was able to help other veterans. He then reached out to OCW, saying he could not walk well and could not run. He was given a grant and received his elliptical bike in the beginning of May.

Upon receipt of his bike and working with it he felt blessed. He said he felt freedom for the first time in a long time with his machine, built to imitate running. He said, "First the American Legion gave me purpose and OCW is now helping me to rehabilitate (strengthening his muscles for a longer life)." He thanked the Legion for all they have done and continue to do for him, and Douglas Chace for being there to give him hope again.

Tickets for the ball included a full buffet, live music and dancing, raffle prizes, silent auction, and full bar. The evening ended with dancing until the lights went down and music ended. Attendees gained a new appreciation of our wounded, ill, and injured veterans and those who care for them.

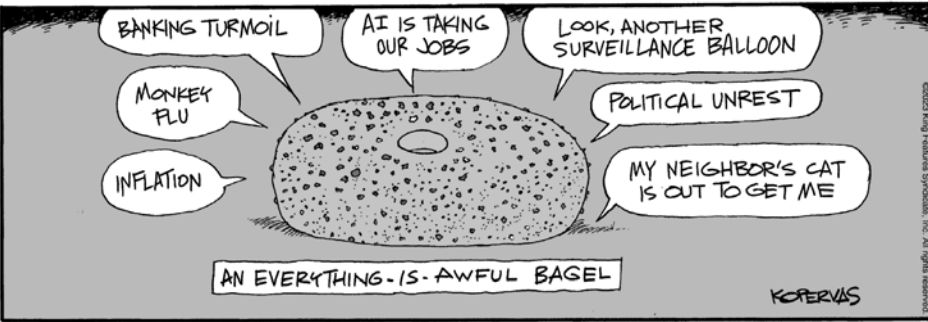

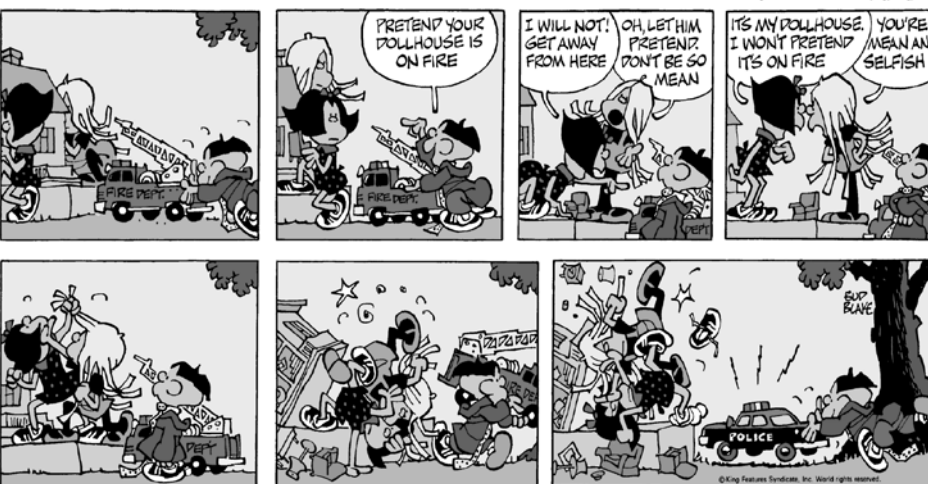

# Where Did All the Money Go?

*Newsom's plan to cover California's ballooning budget deficit*

California's estimated budget deficit has grown by \$9 billion since January, Gov. Gavin Newsom announced, though the governor downplayed the severity of its potential impact on critical government services and programs.

During a press conference at the California Natural Resources Agency in downtown Sacramento, Newsom unveiled a revised spending plan that will rely on some additional fiscal maneuvers — including shifting funding sources and internal borrowing — to address a projected \$31.5 billion gap in the 2023-24 state budget.

"We have a \$31.5 billion challenge, which is well within the margin of expectation and well within our capacity to address," Newsom said.

Despite the growing shortfall, California's overall budget is now expected to be \$306 billion, including special funds, less than a 1% decline from a record \$308 billion in the current fiscal year.

Newsom proposes to close the deficit by shifting an additional \$3.3 billion in existing commitments out of the general fund, including paying for \$1.1 billion in climate spending and \$1.1 billion in college student housing projects with bonds, and pulling back another \$1 billion in unused money from programs such as middle-class tax refunds and utility bill support for low-income residents.

Under the governor's plan, the state would also borrow \$1.2 billion from special funds and increase by \$2.5 billion a tax on managed care health plans to address the spending gap. Extensive savings would remain largely untouched, though Newsom did propose to make a \$450 million withdrawal from one

reserve account.

California's fiscal picture has largely worsened since January, when finance officials projected the state would face a deficit of \$22.5 billion. Newsom called it a "modest shortfall" and proposed to delay billions of dollars in spending commitments, reverse recent steps to shore up the state's fiscal health and shift around funding sources to limit program cuts.

Enduring high inflation, turmoil in the regional banking sector and a showdown in Washington, D.C., over raising the federal debt limit have all deepened the economic headwinds. California relies heavily on income taxes from its wealthiest residents, whose earnings have taken a hit with drops in the stock market.

Monthly tax revenues came in billions of dollars below forecasts this spring, and fears of a recession continue to loom, which Newsom

said could reduce state revenues by tens of billions of dollars even in the mildest scenario.

"That is an uncertainty that we must take very seriously and very soberly," he said.

Adding to the unpredictability, most Californians don't have to file their income taxes until October because of the intense damage and disruption from winter storms. Officials estimate that \$42 billion in payments will be delayed until the new deadline.

The governor's updated budget proposal kicks off a month of negotiations with the Legislature, which must pass a budget by June 15 to get paid, though some items may remain unresolved after the July 1 start of the fiscal year.

Legislative leaders have been largely optimistic about the budget situation, noting that the deficit is less drastic than during the last recession more than a decade

ago and arguing that they have plenty of fiscal tools at their disposal to avoid deep spending cuts. Last month, Senate Democrats pitched increasing taxes on large corporations and suspending a major business tax credit to raise new funds, an idea that Newsom quickly rejected.

The governor reiterated that it was not "the right time to raise taxes and I was crystal clear on that." He also took off the table — at least for now — dipping deeper into the state's reserves, which he said should be maintained while the state weathers the broader economic uncertainties.

"No one can be wedded ideologically to conditions that may present themselves, but right now, we're able to submit a budget that we think is prudent and it's balanced," he said. "Those are conversations for another day."

Newsom closed his remarks by encouraging the Legislature to

show restraint, both in what it seeks in a budget deal and with costly proposals that lawmakers may try to advance to the governor's desk later this year, which he said he would have to veto.

"You don't have to be profligate to be progressive," Newsom said, trotting out what has become a favorite turn of phrase. "We tend to write checks that we can't keep and then we let people down."

Aside from a brief economic downturn at the start of the coronavirus pandemic, most legislators have faced only budget surpluses and growing revenues during their tenures. Because of term limits, just a handful were around as California's economy tanked in 2008, forcing deep spending cuts.

With less money available next fiscal year, the challenge is getting everyone to agree about what should take the hit. Some lawmakers have already raised objections to potential cuts for climate programs and public transit funding that the governor proposed in January. Assembly Democrats are pushing to raise funding for subsidized child care because of complaints from providers that reimbursement rates are less than their costs.

Republicans, who represent a superminority in the Legislature and whose votes are not needed to pass a state budget, dismissed Newsom's approach to the deficit as irresponsible. In a statement, state Sen. Roger Niello of Fair Oaks, who serves as vice chairperson of the Senate Budget Committee, said the governor should not count on avoiding a recession.

"We are concerned that his crystal ball may be cloudy," Niello said. "We would recommend that the state take a more sustainable path on spending and reduce the desire to borrow during this time of high and increasing interest rates." ★

All these services helped to coordinate visitation, navigation, and safety.

**Lynn Pesely** - Lynn Pesely is the Coordinator for the Sacramento Medical Reserve Corps. During the COVID-19 pandemic she supported Sacramento County's testing and vaccination clinics and other efforts supplying hundreds of volunteers. 424 volunteers served a total of 28,000 hours, an economic value of \$1.4 million, for COVID-19 response at vaccination and testing clinics, COVID-19 Hotline, case investigation, after-hours calls, courier, and logistics.

The silver lining of COVID-19 was the 700 volunteers who stepped forward to help in a time when most people were staying home. Volunteering not only helped strengthen the Sacramento County Office of

Lynn often had too many volunteers trying to secure the same shifts - a good problem to have! Sacramento Medical Reserve Corps volunteers often served multiple days a week, including overnight and weekends. Sometimes 20 volunteers were deployed a day at 5 different locations. During the COVID-19 response, 20 volunteers served 500+ hours, earning a Gold Presidential Service Award and 6 of those served 1000+ hours. 15 volunteers served 250+ hours earning a silver presidential service award, and 51 volunteers served 100+ hours earning a bronze Presidential Service Award. The volunteers who came onboard during COVID-19 are now dedicated to the Sacramento Medical Reserve

Corps program, continue to volunteer for a variety of events, have started friendships with other members, and some even support the Sacramento Medical Reserve Corps Foundation with donations on the Big Day of Giving. In addition to the COVID-19 response, Lynn's volunteers have also supported the Sacramento County Office of Emergency Services' response to wildfires and the recent winter storms and flooding.

speaker, challenging the audience to honor those who fell in service of their country by making their lives count, too.

Representing the VA Northern California Health Care System, Heather Murphy of the Center for Development and Civic Engagement, echoed the theme of service as a way to honor the fallen.

"At the Department of Veterans Affairs, we honor the fallen and the missing in action by striving

to serve living veterans as well as they have served us, working to fulfill each day (President Abraham) Lincoln's charge to care for those who have 'borne the battle,' and their families, caregivers and survivors," she said. "That's what VA is about."

Fifth District Supervisor Pat Hume shared his special connection with Memorial Day as a time to remember his own father, a highly decorated fighter pilot in Vietnam, ironically killed in a peacetime training mission over

New Mexico when Hume was only five years old.

The Rancho Cordova River City Concert Band provided a stunning musical backdrop to the event, which included a stirring performance of the "Vietnam Veterans March," featuring powerful vocals by Dennis Cain.

As is the custom on Memorial Day, veterans organizations placed memorial wreaths. The Cordova Community Council Foundation, represented by organization president and Vice

Mayor David Sander, also placed a wreath in honor of all Rancho Cordovans who have given their lives in service of their country.

Throughout the program, prayers were shared for fallen warriors, and patriotism was celebrated.

That included a tribute to Bob Burns, Lt. Col., US Army (Ret.), who led the event for 14 years, including last Memorial Day at the age of 96. A veteran of World War II, Korea and Vietnam, Burns passed away

last October, ending an era for Rancho Cordova military service observances and a lifetime of service to country and the warriors who protect it.

The Memorial Day Observance was produced by the Cordova Community Council with the help of a community-based volunteer committee, Boy Scout Troop 363, Cordova High School Jr. ROTC cadets and assistance from the Veterans Administration Northern California Health Care System. ★
