#### RANCHO CORDOVA, CA (MPG)

- On November 3, the City of Rancho Cordova opened the Rancho Cordova Youth Center (RCYC), the first youth center in the community.

The RCYC will proride a welcoming, central and safe environment for year-round youth programs, build relationships with local youth and show local youth how much the community cares about their success and future in Rancho Cordova.

"A youth center has been a long-time dream for Rancho Cordova. While there are multiple youth programs available, our

community wanted a place that supports our youth," said Mayor Donald Terry. "Thanks to our city's \$8 million investment and our partners, this dream has come true. We look forward to seeing how our youth shine at the Rancho Cordova Youth Center."

The city invested \$8 million in capital funding to renovate the 1.75-acre property, which includes a 9,000-square-foot building, at 10455 Investment Circle. The federal government, thanks to the support of Congressman Ami Bera, will also

provide a \$350,000 grant for programming and equipment. Center of Praise Ministries in Sacramento is leasing the RCYC property at no cost to the city for 25 years, with the option to extend it for another 25 years.

"The leadership and congregation of Center of Praise Ministries pleased to partner with the City of Rancho Cordova on the momentous occasion of the development and opening of the Rancho Cordova Youth Center," said Bishop Parnell M. Lovelace, Jr. "Our unique collaboration of a faith-based organization and municipality has shown that our underserved youth are indeed a priority. Our

Lutz has nearly 20 years of public service experience leading social services programs, including more than 12 years of executive management experience. Prior to his appointment with the County, he has served as the Tulare County Health and Human Services Agency (HHSA) Director, the County Administrative Officer for Calaveras County, the Director of Fiscal Operations for the Tulare County HHSA and as the Executive Director of the Kings/Tulare Area Agency on Aging.

Throughout his career, Lutz has developed and implemented a variety of health programs and services, including behavioral health, human services, public health, primary health Federally Qualified Health Center (FQHC) look-alike clinics, inmate medical and behavioral health services, and homeless initiative services and housing, among others. He also has extensive experience collaborating and partnering with external stakeholders and community partners to advance health services and shared initiatives.

Lutz has a Bachelor of Arts degree in Psychology and a Master of Business Administration from California State University, Fresno. He also has certificates in Intermediate and Advanced Government Accounting, Advanced Financial Reporting, and Best Practices and Effective Budget Preparation from the Government Finance Officers Association (GFOA), as well as Driving Government Performance from Harvard University. ## UC Davis Health Nurse Honored for 'Rocking' Nursing World

SACRAMENTO, CA (MPG) - The National Black Nurses Association (NBNA) has named Aron King a 2022 Under 40 Awardee. King, an assistant nurse manager at UC Davis Medical Center and a 2021 graduate from the Betty Irene Moore School of Nursing at UC Davis, is one of only 16 nurses in the nation to receive the honor.

"These nurses are our present and our future. They are the next generation of nurse leaders," said Martha A. Dawson, NBNA president. "We look forward to honoring these NBNA young notables under the age of 40 who are rocking the nursing world through professional and educational achievement, leadership and civic involvement in their NBNA chapters and in the communities they serve."

After caring for patients as a bedside nurse for 8 years, King entered the master's-degree leadership program at the School of Nursing in 2019. He said through that educational experience he began to see the bigger picture of how he could serve the Black community and inspire future Black nurses. He joined the Capitol City Black Nurses Association, founded by School of Nursing alumni, to advocate for the needs of nurses and optimize health outcomes in communities where health disparities persist.

"Health care is in a battle to undo decades of valid mistrust in communities of color. From unjust medical trials to the treatment of undocumented people and those battling drug addiction," said King, the organization's former secretary who now serves as an executive board member. "Winning the trust of these communities means having a workforce that has representation. We have work to do."

In July, King served as the keynote speaker for the School of Nursing 2022 Commencement. In July, he joined Piri Ackerman-Barger, School of Nursing associate dean for Health Equity, Diversity and Inclusion, to present to an international audience of nursing researchers understanding how microaggressions in health professions schools can poise students for inclusion. She said King is deeply deserving of this honor.

"Aron is being recognized for his commitment to high quality practice, his accomplishments as a leader and his work as a scholar," Ackerman-Barger explained. "It is an honor to have him join us once again as he pursues his Doctor of Philosophy (PhD) at the School of Nursing."

Next month, King enters the school's PhD program. He expects with the rigorous research program and the demands of his nursing career, the lift to continue the drive to end disparities will be heavier.

"The role of a nurse is not limited to the bedside and we as nurses shouldn't measure our worth by looking at technical skills," he said. "We are advocates and leaders in patient care. We need to be proactive in our approach by investing our energy in preventive interventions."

NBNA honored this year's winners at its 50th Annual Institute and Conference in Chicago. NBNA is comprised of nurses at all levels and serves as the voice for Black nurses and diverse populations to ensure equal access to professional development, promote educational opportunities and improve health.

## Using Lived Experience for a Positive Change

SACRAMENTO COUNTY, CA (MPG) - Nita Webb prints out an application for a housing voucher through Sacramento Housing and Redevelopment Agency (SHRA). She has a client that qualifies for housing but has no way to fill out the application needed to get the process started. Providing these simple services for her clients is just part of the job Nita does as a Peer Counselor to help out people experiencing homelessness in Sacramento County.

Nita understands that every small bit of help can lead to big changes in someone's life. She has been there - desperately in need of a helping hand to better her situation. Nita grew up in Sacramento with her father and sister. They were poor, but always had a roof over their head and enough food to eat. Nita remembers how her father always did what he could to give back to people who were less fortunate than them. "Never look down on anyone – never treat people like they are less than you, because they aren't," she recalls him saying. Perhaps that is where her love of

helping others came from. After having a baby at a young age and dropping out of high school, Nita found work at a group home for girls that both paid her bills and satisfied her deep desire to help others in need. In 2009, when the recession hit, she was laid off from her job. Unemployment benefits were delayed for months and the money Nita received from welfare was not enough money to pay her rent. As her eviction loomed closer, she desperately searched for accommodations that would be safe for her and her fiveyear-old daughter.

year-old daughter.

She was offered a space in a congregate shelter, but she was worried about her safety. However, she knew that if she was in a shelter with her daughter, they'd be prioritized for help faster than if she looked on her own. As she was being locked out of her apartment for the last time, she received a call from St. John's Shelter for Women and Children – they had a space for Nita and her daughter.

Living in a shelter with other homeless women and

children provided her with a fresh view of her situation all the women there had stories. Stories about domestic violence or a job loss or a major medical emergency that drained their savings. They were all alike, all struggling. St. John's set her up with classes on parenting, women empowerment and job training. She earned her GED and started working at St. John's non-profit, Plates, which not only provided her with critical job training, but earned her a housing subsidy in a transitional living program for her and her daughter.

Having that rental subsidy allowed Nita to start taking college courses, while still working at Plates. But the pull to help others in her situation was strong. She got a job working for Volunteers of America (VOA) – a job that allowed her to work directly with persons experiencing homelessness. While with VOA, she worked with clients that were sheltering at the Capitol Motel on L Street. Mixed in among those that lived there, her clients had drastically different needs and barriers to exiting homelessness, but one thing remained the same – whether people were sheltering or paying rent, homeless or housed – everyone had a story, everyone had a life before they found themselves in their current circumstance. Everyone deserved love and respect and a helping hand.

Nita got a job as a Housing Specialist with Next Move at Mather Community Campus, yet another connection directly to persons experiencing homelessness that allowed her to make a tangible difference. She saw herself in every client – she was just one blessing in front of literal homelessness. Even as she connected clients to housing, she knew that housing doesn't equal final security when people need continued help and services to remain stabilized.

Today, Nita works for the Sacramento County Department of Health Services as a Peer Counselor, a person with lived experience that can identify with clients. She is part of the new Homeless Encampment And Response Team (HEART) - teams that go directly into encampments and connect people living unsheltered with benefits, shelter connections, clinical evaluations and referrals. She carries prepaid phones with her to provide to clients to remain in direct contact with them. She knows that she cannot personally help people with everything they need – but she can help them with one thing at a time, one thing that might be exactly what they need to alter their life course, stabilize and exit homelessness for good. She explains to her clients the work that she can do, and the work they need to do to help themselves – a vital piece of the puzzle to ending their homelessness.

Nita and her daughter still go to therapy together to work through the trauma of their unhoused experience. Though stabilized now, the ease of slipping into homelessness is always on her mind. As is her father – who instilled in her the heart to help the homeless – a job he never got to see her do, but one she honors him through every day. Her clients are blessings to her, as she is to them – a reminder that you can change your circumstances, you can accept help, and together - they can end one person's homelessness at



youth are worth every investment and the opportunities that will be afforded them through this unique initiative. This state-ofthe art facility will be a place where dreams and goals come true for a new and emerging generation of servant-leaders."

Programming will begin by early December for children ages 6 – 18, enrolled in 1st - 12th grade, with a focus on mentorship, academic support and sports activities. The city manages and oversees the facility and operations, and it contracts with two partners to operate and provide programming, Boys and Girls Clubs of Greater Sacramento and the Rancho Cordova Police Activities League.

"It is critical that we invest in our children's future by creating spaces where they are safe and cared for, so they have the opportunity to fulfill their potential," said Congressman Ami Bera. "That's why I was proud to secure \$350,000 in FY2022 funding through the Congressional Community Project Funding process to help complete the Rancho Cordova Youth Center, the first youth center within the community. This funding will be critical to providing a well-rounded education both in and out of the classroom."

The Boys and Girls Clubs of Greater Sacramento operates the RCYC and develops academic programming, including homework support and completion, leadership development activities and career programs and mentoring. This is the nonprofit organization's first community-wide program in Rancho Cordova.

"The Boys and Girls Club is thrilled to be a part of the Rancho Cordova Youth Center team and committed to coming together to serve more youth in Rancho Cordova than ever before," said Kimberly Key, CEO of Boys and Girls Clubs of Greater Sacramento. "Together, the city, PAL and the Boys and Girls Club will harness the power of our

reputations, strength of our relationships in the community and experience serving youth to provide a safe place where Rancho Cordova youth and teens can thrive."

The Rancho Cordova Police Activities League (PAL) provides sports, educational and mentoring programming for the RCYC, including the PAL Boxing Club, Junior Giants League and Youth Leadership Council. The nonprofit organization has offered a variety of free programs in Rancho Cordova since 2009, provides positive role models and supports our children's

"The Rancho Cordova Police Activities League is beyond excited to partner with the City of Rancho Cordova and the Boys and Girls Clubs of Greater Sacramento to provide world-class youth programming at the new Rancho Cordova Youth Center," said PAL President Lieutenant Rich Merideth. "This investment in our youth will have a long-lasting positive impact on our kids, neighborhoods and city as a whole. We are proud to work with our community partners to make this dream a reality."

Around 400 residents, children and community partners attended the grand opening ceremony and enjoyed tours of the new center and sports fields, family-friendly activities, dinner from food trucks, and more. Attendees also had an opportunity to become a part of history by painting their initials on tiles that will become a permanent art installation at the RCYC.

Starting in 2023, the RCYC will be available for rent to youth organizations or organizations that benefit youth. Rentals will only be available outside of regular after-school programming and summe programming, and hours of availability could vary.

## State Violated Environmental Laws in \$1.2 Billion Capitol Annex Project

**SACRAMENTO, CA (MPG)** - Save Our Capitol! issued on October 31, 2022, the following statement regarding the matter of Save Our Capitol! vs. California Department of General Services (DGS) and Joint Committee on Rules of the California State Senate and Assembly (JRC):

"By failing to recirculate the Capitol Annex Project's Environmental Impact Report (EIR) after making substantive changes, DGS and JRC violated the California Environmental Quality Act (CEQA), a statute which implements a statewide policy of environmental protection. The substantive changes included:

Relocating the underground parking garage from the south side of the Capitol to the east side; Destroying approximately twice as many trees as were initially identified; Expanding the project's boundary; and, Designing the new Annex with a wholly incompatible and dangerous glass exterior.

"Recirculation was required due to the Final Environmental Impact Report (FEIR) expanding the Project's boundary beyond 12th Street and more than doubling the 20-30 trees that the Recirculated Draft Environmental Impact Report (RDEIR) represented would be removed, revealing that the project would affect an estimated 133 trees. DGS and JRC failed to prove how expanding the Project's boundary and doubling the number of trees to be removed from the historic Capitol Park would not exacerbate a significant environmental impact, in violation of CEQA.

"Because the changes to the project scope include new and/or exacerbating impacts and a new unstudied alternative that would reduce impacts to historic resources, additional review by the decisionmakers and the public of the EIR was required. Yet, DGS and JRC did not recirculate the EIR, instead choosing to deprive the public and responsible agencies of their right to review and comment on the Project's true impacts to the Capitol Complex.

"As stated in our appeal, there is no urgency to proceed with the unvetted Capitol Annex Project which disregards CEQA's requirement of transparency and its protections for the public interest."

A hearing on the case before the Third Appellate District is scheduled for November 14, 2022.

The purpose of Save our Capitol! is to preserve the site of the historic Capitol and its surrounding Park as the center and symbol of Californians' right to truth, transparency, and trust in self-governance. ## Aerojet Rocketdyne Tests Next Generation Large Solid Rocket Motor

HUNTSVILLE, AL (MPG) - With the recent successful test of a next generation large solid rocket motor called eSR-19, Aerojet Rocketdyne has validated advanced motor technology while demonstrating the production maturity of new and upgraded facilities in Huntsville, Alabama, and Camden, Arkansas.

The recent design verification test of the eSR-19, funded by Aerojet Rocketdyne, highlights the company's evolution of large solid rocket motors that can function as multiple stages for a variety of defense and space applications.

"Our teams building our next generation large solid rocket motors are incorporating innovative materials and applying efficient manufacturing processes," said Eileen P. Drake, Aerojet Rocketdyne CEO and president. "We continue to invest in the future in modern facilities and a highly skilled workforce to design and produce the advanced technology needed to power defense across multiple domains."

The eSR-19 motor was designed and fabricated in Huntsville, Alabama, and cast and cured in Camden, Arkansas. The test was



conducted by Air Force Research Laboratory (AFRL) and Aerojet Rocketdyne personnel at an AFRL test facility at Edwards Air Force Base, California. AFRL personnel also supported the test with motor logistics and data collection.

The advanced motor improves cost and performance by incorporating a graphite composite case, an affordable advanced nozzle, and high-energy, long-life solid propellant.

Weighing nearly 15,000 pounds and measuring 52 inches in diameter, the eSR-19 is a large solid rocket motor program to upgrade the legacy SR-19 motors originally used in the Minuteman II. This capability demonstration is directly applicable to

legacy SR-19 applications and is a building block for multiple systems under development today.

The recent test of the eSR-19 builds upon last year's successful test of the eSR-73 demonstration motor, which served as a pathfinder for producing and handling large solid rocket motors at the company's upgraded Camden facilities.

Aerojet Rocketdyne has produced large solid rocket motors for critical defense and space programs for decades. The company transferred the production to its Camden and Huntsville sites as part of its Competitive Improvement Program, which increased affordability and positioned the company for growth.

Building on the \$5.5 million in the 2022-23 state budget for the CHP to implement the Campaign to Eliminate Street Racing and Sideshows (C.E.S.R.S.), \$1.5 the million Sideshow, Takeover, Racing, Education, and Enforcement Taskforce (STREET) grant will help efforts to decrease the number of fatal and injury traffic crashes attributed to illegal sideshows, takeovers, and street racing.

In 2019-2020, speed was a factor in

approximately 40 percent of all fatal and injury crashes in California. In years 2020-2021, preliminary data reflects the number of people killed in crashes caused by reckless driving increased 21 percent from the previous period. The CHP continues to receive a high number of reports on sideshows and street racing and the negative consequences associated with such careless exploits.

"Reckless driving behaviors are a significant threat to all who use California's roadways," said CHP Commissioner Amanda Ray. "The STREET grant will provide for a focused education and enforcement campaign, targeting aggressive driving behaviors, street racing, and sideshow activities."

During the past two years, California has seen significant increases in the number of incidents from unsafe driving behaviors, including motorists exceeding 100

mph on state highways, illicit street racing and sideshow activities, and speed-related crashes.

To address the issue, from January 1, 2021, to September 30, 2022, the CHP conducted enhanced speed enforcement operations on state routes that have seen an increase in speed-related issues. During this period, the CHP issued 40,593 citations to motorists exceeding 100 mph. CHP also collaborated with allied law enforcement agencies, leading to the creation of street racing and sideshow task forces and social media campaigns posting the dangers associated with high speed, aggressive driving behaviors, and

street racing.

The STREET grant allows for a comparable campaign starting this month through September 30, 2023. Funding for the STREET program is provided by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration.

As an added deterrent, Governor Gavin Newsom recently signed Assembly Bill 2000 (Gabriel), making it illegal for a person to participate and/or engage in a motor vehicle speed contest or in an exhibition of speed in an off-street parking facility. The measure goes into effect on January 1, 2023.

## Could the Ocean Slake California's Thirst?

"Water, water, every where, And all the boards did shrink; Water, water, every where, Nor any drop to drink."

Poet Samuel Taylor Coleridge penned those words in his 1798 poem, "The Rime of the Ancient Mariner," to describe the plight of becalmed sailors who could die of thirst while surrounded by limitless expanses of undrinkable seawater.

In a way, it also describes California's plight. Despite its 3,427 miles of Pacific Ocean coastline, including bays, inlets and tidal marshes, the state has an its demand for water and its supply.

Naturally, there has been a decades-long debate over whether the state should tap into that endless supply of seawater to bridge the gap, emulating other arid and semi-arid societies, particularly in Australia and ical tool. the Mideast.

From a technical standpoint, it's a no-brainer. Desalination plants, includin California, do exactly what they are supposed to do — strip the salt from seawater, converting it into freshwater suitable for drinking or any other purpose. The barriers to

coast are economic, environmental and political.

Such plants require oodles of electrical power to pump in the seawater, push it through filters that remove the salt and then return the uber-salty brine waste either to the sea or into another process.

A massive desal program would place a new burden on a power grid that already struggles to keep up with demand on very hot days as it evolves from natural gas-fired power plants to renewable sources such as wind and solar. Desal's power demand also contributes heavily to the bottom line costs of producing water, making it more expensive, at least so far, than water from other sources.

Finally, environmental groups have generally opposed desal projects on assertions that pumping seawater into the plants and returning brine to the sea ever-widening gap between run the risk of damaging delicate marine ecosystems. But the groups have another, unspoken reason for opposition. Restricted water supplies have been used as a tool to oppose new residential development and increasing water supply undercuts that polit-

Orange County earlier this year. The plant would have been a near-clone of a desal facility in Carlsbad, further south along the coast.

building dozens of desali- to be a death knell for the nation plants along the expansion of desalination in California — something that Gov. Gavin Newsom's administration envisions in its overall plan for closing the demand/supply gap as climate change and semi-perpetual drought diminish traditional supplies from winter rains and snowfall.

However, last month the Coastal Commission approved another Orange County desal project, one that would use somewhat different technology to pump in seawater and dilute the leftover brine before returning it to the sea.

Environmental groups gave their blessing to the Dana Point project, which made a big difference in the Coastal Commission's attitude, as is the fact that it's only one-tenth the size of the Huntington Beach project and would serve purely local customers of the South Coast Water District.

The approval was an indication that desalination could, as the state's water plan envisions, play a significant role in California's water future, which will be much different than its abundant past.

That said, desal probably wouldn't be the silver bullet of limitless supply that some have hoped it would be. It would be more of a reliability factor, something that Californians could depend on working when traditional supplies





My wife and I are looking to move from Washington, D.C., to Greenville, South Carolina, in a couple of months, and then sell our current home in February or March after she gets things wrapped up with her job. and the market as active and frenzied as they were several months ago? No. But you have to remember, the last couple of years have been crazy-strange times for the housing market.

I've been in the real estate business since 1978, and I've never seen anything like it. Usually, it takes about 90 days to sell a house. You'll get some offers, and none of them will be at full price, but everyone will have time to think about things. That's normal, and it's probably a lot closer to how things will work themselves out for you now in Greenville.

But in any economy, my advice to you would be don't buy another house until yours has sold. If you end up with two house payments and your old house is sitting empty while you're having to pay for the mortgage, taxes, utilities and all the upkeep

to make sure it's ready to show, you're going to become what's known as a motivated seller. I don't want you to just give it away, but you'll need to be very careful to make sure the timing on this deal makes sense.

## California Invests Nearly \$3 Billion for Transportation Improvements

Caltrans News Release

SANTA BARBARA, CA (MPG) - The California Transportation Commission (CTC) has allocated nearly \$3 billion for projects to repair and improve transportation infrastructure throughout the state. The allocation includes more than \$452 million in funding from the federal Infrastructure Investment and Jobs Act of 2021 (IIJA) and more than \$123 million in funding from Senate Bill (SB) 1, the Road Repair and Accountability Act of 2017.

"This allocation – which includes a significant federal investment - allows Caltrans and our local partners to continue building the equitable, sustainable, and safe transportation system on which future generations will depend," said Caltrans Director Tony Tavares.

Projects approved include:

\$3.5 million in federal IIJA funding for a City of Rancho Cordova project for roadway, sidewalk, curb ramp, bike lane and traffic signal improvements on Mather Field Road between Folsom Boulevard International Drive;

\$2 million in State Highway Operational and Protection Program (SHOPP) funds for project development and right of way costs for intersection

and safety improvements at Live Oak Boulevard/Encinal Road and State Route 99 in the Lomo Crossing area in Sutter County;

\$520,000 in SHOPP funds to develop a safety project for a new traffic signal at the intersection of State Route 32 and County Road P near Orland, Glenn County.

The CTC allocated more than \$2.1 billion to Caltrans' Division of Local Assistance in its annual federal fiscal year investment. These local assistance funds are used by more than 600 cities, counties and regional agencies throughout California to build and improve roads, bridges, tunnels and other transportation infrastructure, and for projects that enhance safety and help protect the environment. Annually, more than 1,200 new projects are authorized through the Local Assistance Program.

SB 1 provides \$5 billion in transportation funding annually that is shared equally between the state and local agencies. Road projects progress through construction phases more quickly based on the availability of SB 1 funds, including projects that are partially funded by SB 1. ## Sac State blows past Portland State, 45-17, to improve to 10-0

Hornets close the regular season at home against UC Davis in the Causeway Classic

HILLSBORO, OR (MPG) - The No. 2 ranked Sacramento State football team remained unbeaten, earned its school-record 10th regular season victory and dominated Portland State in a 45-17 win at Hillsboro Stadium on a cold Friday

The Hornets are now 10-0 overall and 7-0 in the Big Sky Conference. The 10 wins breaks the school regular season record of nine which came in 2019 and 2021. It also equals the best win total for any season, matching the effort of the 1988 team which ended the year 10-3 with the help of two NCAA Div. II playoff wins.

Sacramento State has now won 18 consecutive Big Sky games which is the second longest streak in league history. The team has also won 14 straight road games against FCS teams, and 10 road games against all opponents — the longest streak in FBS or FCS.

The game had a wild start with three combined fumbles, two plays of at least 30 yards, and a touchdown in the first six minutes. The Vikings took the opening kickoff and picked up 33 yards on their first play of the game. The team then coughed it up on the next play and the ball was recovered by Brock Mather.

Sacramento State quickly gained 44 yards on a pass from Asher O'Hara to Pierre Williams to get inside the 10-yard line. Facing 3rd-and-goal, Asher O'Hara tried to spin his way into the end zone but had the ball knocked loose and recovered by PSU for a touchback.

Two plays later, Portland State attempted a trick play with a double reverse which was bobbled on the toss and

recovered by Killian Rosko inside the 20. Sacramento State finally broke through with a 5-yard pass from O'Hara to Williams to give the Hornets a 7-0 lead.

The Hornets added to their lead early in the second quarter with a 41-yard field goal from Kyle Sentkowski. The Hornets brought the ball to the 11-yard line during the drive but were driven back to the 23 following a sack on third down. A strong headwind was no challenge for Sentkowski who made his 12th consecutive field goal this year.

The lead continued to grow with a 7-play, 80-yard drive which resulted in a touchdown with 7:49 left in the second quarter. The big play during the drive was a 41-yard rush from Cameron Skattebo and the drive ended with a 4-yard pass from Jake Dunniway to Pierre Williams for the score. The score marked, surprisingly, just the second multi-touchdown game of Williams' brilliant career. The second score moved him into a tie with Marshel Martin for third place in school history with 21 receiving TDs.

After a three-and-out from the defense, the offense kept rolling with a 5-play, 73-yard drive which ended with a 39-yard TD run from O'Hara for his longest rush of the season. The touchdown also extended O'Hara's streak to all 10 games of this season and 12 straight games dating back to last from Gianni Smith for the

Sacramento State needed just three plays to score on the first series of the second half. The drive was setup by a 38-yard kickoff return from Elijah Tao-Tolliver. Jake Dunniway then found Williams for a 51-yard gain which pushed the receiver over the century mark. Marcus Fulcher then cut back to his left for a 4-yard score just 70 seconds into the half.

Portland State started the second half with senior Nathan West at quarterback. The Vikings ran on the first 11 plays of the drive and were able to bring the ball into the red zone before settling for a 32-yard field goal

team's first points.

Sacramento State answered with another quick touchdown drive. After Skattebo went over 100 yards during the series, Fulcher took an option toss from O'Hara and eluded defenders for a 35-yard score.

The fourth quarter had another wild stretch. The Hornets first stopped Portland State inside the 1-yard line on fourth down. The offense moved the ball out of the shadow of its own goalpost but fumbled. That turnover set up a 36-yard touchdown rush from Quincy Craig for Portland State's first touchdown.

The Viks then attempted

an onsides kick which was picked cleanly by Martin who returned it 45 yards for a touchdown.

Sacramento State finished the game with 451 yards on just 56 plays for an average of 8.1 yards per play. The team rushed for 237 yards and threw for 214.

The quarterback tandem of Dunniway and O'Hara combined to complete 15-of-21 passes with each throwing a touchdown without an interception.

Sacramento State's final regular season game will come on Nov. 19 in the Causeway Classic against UC Davis at 2 p.m. The Hornets can clinch at least a share of the Big Sky title with a win.




