## It's Time for Friday Night Lights

**RANCHO CORDOVA, CA (MPG)** - Hello Cordova football fans, it's time for Friday night lights at Lancer Stadium, as the 2022 season officially gets under way.

Alongside the Cordova cheer squad, band leader Kevin Sims is tuning up his Cordova Marching Band and Mama Vaughan is stocking the snack bar. The players have been conditioning hard during the off-season and have all been given their uniforms and pads in anticipation of

participating in the "Big Red" tradition. That tradition started in 1963 and to this day is still talked about with pride and reverence.

After the head coach resigned just before the 4th of July Parade, in which the team and coaches proudly participate in each year, the Lancers are now ready to hit the turf running. This year's Cordova coaching staff consists completely of Cordova Lancer alumni. Newly appointed interim head coach Kyle Williams (Class of 2005) is ready to follow in the footsteps of his former coach, National High School Coaches Hall

of Fame inductee Max Miller, and take up the slack of a program that has been continuously challenged.

"I'm excited about this upcoming season," Williams said. "My boys have worked extremely hard, and I believe they have what it takes to win not only on the field but also in the classroom."

Joining Coach Williams on the sidelines and returning from last year is defensive coordinator Michael Brennon. Coach Brennon played football at Sacramento State and overseas after graduating from

## Williams Named Interim Football Coach

**RANCHO CORDOVA, CA (MPG)** - With the 2022 football season kicking off today, Cordova High School recently found its new varsity football coach.

On July 29, it was announced by the Folsom-Cordova Unified School District that Kyle Williams has been named the interim head football coach at Cordova HS. The move comes relatively late in the offseason following the departure of the Lancers' last coach for another school in the Sacramento region.

"It was a dream come true," Williams told the Grapevine Independent in a recent phone interview. "This is what I always wanted to do for years, and it finally happened (and) it came to fruition."

Since 2017, Cordova has had a revolving door of head coaches. With Williams, even in an interim role, the hope is for the program to create some stability starting at the top.

"I'm trying to restore Cordova's tradition and

dominance," Williams proclaimed.

Williams is a Cordova alumnus and played on varsity under former coach Max Miller for two seasons from 2004-05. The new Lancers coach played defensive tackle and was selected to the annual Optimist All-Star game as a senior.

During his junior year in 2004, Cordova nearly ran the table, going 12-0 until losing to Oak Ridge in the Division II CIF Sac-Joaquin Section championship game.

"We had great leadership. We were really a family," Williams recalled. "We had guys that were willing to lead, and we had

a lot of guys that bought into the system. We were hungry. We had great leaders, a great coaching staff and people that allowed the leaders to lead."

The Lancers were 3-7 overall last season and 2-3 in Greater Sacramento League action. Excluding the shortened 2020 season when Cordova went 3-2, the Lancers have not had a winning season since 2017, the final year under coach Darren Nill.

"We're going to work hard this season," Williams said. "We're going to do whatever it takes in the classroom and on the football field to get the job done. We really got a great group of guys out there that's willing to learn and ready to buy in to the system."

Cordova opens the season tonight at home against Bella Vista with kick off scheduled for 7:15 p.m. The Lancers' toughest test of the season will come in week four on Sept. 9 when they host regional rivals, the Rosemont Wolverines, who are ranked No. 23 in the Sacramento Bee's pre-season Top 25. ★

# Cordova H.S. students Represent at FCCLA Nationals

SAN DIEGO, CA (MPG) - The California Family, Career and Community Leaders of America (FCCLA) attended the FCCLA National Leadership Conference in San Diego from June 29 to July 3.

Members from Cordova High School, Emma Campos (Class of 2022) and Jazmine Savorn (C/O 23), along with their teacher/advisor, Grace Stockert, attended.

The organization provides students with leadership opportunities to showcase skills learned in Family and Consumer Science (FCS) courses through Students Taking Action with Recognition (STAR) events, where they can earn scholarships and recognition.

Campos placed seventh nationally in "Baking and Pastry" and earned silver based on the event's rubric. After qualifying to compete nationally in her event after placing first at the California FCCLA State Conference, she spent months leading up to state and national conferences practicing the various recipes, refining her skills and attempting multiple test runs following the event set-up and guidelines. She earned certification as a pastry cook at the National Leadership Conference through the American Culinary Federation. Emma plans to attend American River College in the fall to begin her

general education studies with the intent to transfer to a university after two years. She will continue exploring her passion for baking and pastries and continuing her involvement as a California FCCLA Alumni & Associates member.

Savorn placed first nationally in "Sports Nutrition," earning a \$1,000 scholarship to The Culinary School of Fort Worth and a Full Tuition scholarship valued at \$50,000 to attend Sullivan University. However, Jazmine also represents California FCCLA solely

in the STAR events as the only California member to place nationally at the 2022 conference.

She qualified to compete nationally by competing at the regional level to be eligible for state and placing first at the state conference in April. Their win at the state level earned them a combined total of a \$100 cash prize sponsored by Dr. Lloyd McCabe, a \$4,000 scholarship to the Culinary Institute of America and a \$20,000 scholarship to Sullivan University. Jazmine plans to complete her IB

degree this school year to graduate in 2023 while balancing her busy schedule of dual enrollment, working and being active in clubs and extracurriculars such as FCCLA.

Cordova in 2004. The new offensive coordinator, Ron Kerkus, dates a little further into Lancer lore. Kerkus graduated in 1966 and was coached by the legendary Dewey Guerra, who led the Lancers to 10 consecutive championships.

In 2003, Kerkus was Williams' junior varsity coach when he was a sophomore at Cordova.

"We have great knowledgeable coaches who are passionate about the game, but more importantly, care about (our) student-athletes and the Rancho Cordova community," Williams said. "I believe a good coach can change a game, a great coach can change a life and that's what I'm here to do."

On Friday, August 12, Big Red competed in a six-team scrimmage held at Rio Linda High School. The other participating schools were Rio Linda, San Juan, Western Sierra, Wheatland and Vanden. Each school ran a 10-minute running clock against each other's offense and defense.

Cordova played extraordinarily well considering it was their first full contact scrimmage against other teams. They scored several times on running plays, completed timely passes, had a couple of nice interceptions, a few fumble recoveries and many defensive stops. All in all, they looked sharp, focused and ready to compete.

Coach Williams is extremely thankful

for two very gifted returning seniors. One being last year's star running back and this year's quarterback, Kevin Lewis. The other senior is offensive and defensive lineman, Angel Rivera.

Another gifted player that will certainly play a key role in a successful season is junior wide receiver and defensive end Michael Brown, better known as "Big Mike." Look for Brown to be a consistent passing target for Lewis.

This year's offensive line is bigger than it has been in a while and should provide that extra time needed to properly get off a successful run or pass play. Joining Rivera on the offensive and defensive line is a talented sophomore, Orlando Gomez. Another player that may make his presence felt on the offensive and defensive line is first-year player, junior Solomon Ralbos, who told the Grapevine Independent that he loved playing in his first-ever scrimmage.

I invite all of you to "love it" as well and come out to Lancer Stadium to cheer for your team. This year's home games are August 19 vs. Bella Vista, September 9 vs. Rosemont (Jr. Lancer Night), September 30 vs. Foothill (Homecoming), October 14 vs. Valley (Staff Appreciation Night) and October 28 vs. Florin (Senior Night). All games start at 7:15 p.m. with the J.V. game starting at 5 p.m. ★

# SacRT Takes You Back to School for FREE

**SACRAMENTO, CA (MPG)** - The Sacramento Regional Transit District (SacRT) is reminding students and families that with the RydeFreeRT program, students in transitional kindergarten through 12th grade can ride the entire SacRT transit network for free. The program includes SacRT buses, light rail and Smart Ride on demand microtransit services.

The RydeFreeRT program is available for any youth that live or go to school within SacRT's service area, which includes the cities of Sacramento, Elk Grove, Folsom, Citrus Heights, Rancho Cordova and parts of Sacramento County. Approximately 220,000 students in grades TK - 12th, home-schooled students, and foster and homeless youth are all eligible.

SacRT launched the RydeFreeRT program in October 2019, at that time, SacRT experienced a 127% increase in student ridership (pre-COVID-19). Over the last year, SacRT provided over 2.4 million free rides to youth across the region.

New RydeFreeRT cards for the 2022-2023 school year are distributed by schools and have a valid date from June 1, 2022, through June 30, 2023. For students that still need a RydeFreeRT card, visit SacRT's Customer Service and Sales Center located at 1225 R Street (adjacent to the 13th Street Light Rail Station) or Sacramento Public Libraries.

Member and Sacramento City Councilman Jay Schenirer. "This is an investment in our future - connecting youth to school, work, internships and other education and career opportunities. It's great to see so many young riders on public transit!"

"At Sac City Unified our focus is on providing equitable access to high quality education. The costs and challenges associated with transportation can often create a significant barrier to that access," said SCUSD Chief Communications Officer Brian Heap. "The SacRT free transit program is a tremendous support tool for the district and our families. We have some middle and high schools where as many as one-third of students rely on SacRT to safely get them to and from school each day. Chronic absenteeism is a serious problem for schools, and we appreciate that our partnership with SacRT helps get more students to class every day."

- "Champions," a new exhibit showcasing Rancho Cordova's rich and storied sports history, opens Thursday, August 18, at the Mills Station Arts & Cultural Center (MACC).

Presented in the spirit of the Rancho Cordova Sports Hall of Fame, the exhibit brings to life dozens of Rancho Cordova area sports stars of the past, dating back to the 1960s, up to present day.

The exhibit will feature several former pro baseball players, including 11-year MLB pitcher Randy Lerch; former White Sox and New York Mets manager Jerry Manuel; pitchers Chris Bosio, Steve Finch and Zach Crouch, among others; football greats including Reggie Young; and basketball standouts including Mike McCullough, who went on to become a top

executive with the NBA's Miami Heat.

Also featured are swimmers Ryan Yantis, who served as Chief of Public Affairs for the Pentagon during 9/11, and Angie Matheu, a section-record holder, and American River College Athlete of the Year; Lee McFann, a late 1960s multi-sport athlete who went on to become a three-star USAF general; and, longtime coach Kelly Crawford, who played on the LPGA golf circuit.

A special section honors many of Cordova's coaches who laid the blueprint for the city's success in several sports. Dewey Guerra, Ron Lancaster, Clarke Massey, Dave Andreotti, and John McCants will have their stories featured as well.

Cordova's influence in the boxing and MMA world is also well-represented, with Mike Sedillo, a member of the California Boxing Hall of Fame, and, Chad "Savage" George,

who parlayed a terrific wrestling career at Cordova into becoming a world-class MMA fighter.

Loaded with gear, equipment and other accoutrements of the era, the Champions exhibit includes photos and historical anecdotes of several Cordova High teams, including the nation's No. 1-ranked football team, the 1975 Cordova Lancers; and the 1984 section champion varsity baseball and girls' basketball teams.

Also included are several notable achievements, school, section and state record-holders.

The exhibit will remain on display through Saturday, Sept. 10, 2022 - the same night that the Class of 2022 will be inducted into the Rancho Cordova Sports Hall of Fame. Hours are Thursdays and Fridays from 3-8 p.m.; and Saturdays from 11 a.m. to 4 p.m. The MACC gallery is located at 10191 Mills Station Rd, Sacramento, CA. ★

## Evaluation of Safe Stay Sites in Sacramento County

**SACRAMENTO COUNTY, CA (MPG)** - Homelessness is the top issue I hear about from residents, property owners, and business owners. It is a crisis that demands bold action.

The County of Sacramento, as well as my colleagues on the Board of Supervisors and I, have been working hard on solutions for more housing and increased mental health and substance abuse services. The County has a variety of housing from shelters, scattered site housing, transitional housing, and permanent supportive housing in all five Supervisorial Districts. The County has also significantly increased the number of treatment beds for addiction and mental illness. However, we desperately need to do more.

The County is continuing to explore shelter locations in unincorporated communities to help get the homeless connected with services and housing while providing relief to residents and businesses from the negative impacts of encampments in public places. I am firmly convinced that the best path to alleviate our homelessness crisis, especially in light of changes to state law and federal court decisions, is to create more alternatives to offer the homeless while prohibiting places they can camp and holding those who violate the law accountable for their actions.

Last year, the Board of Supervisors directed the Department of General

Services to evaluate all County property that had the physical potential to serve as a community shelter site. My office and County staff are still evaluating several parcels in the Third District, including two properties in Carmichael that could accommodate one small "Safe Stay" community for 25-30 people.

Contrary to statements being made by some community members, nothing has been proposed for a decision by the County or the Board of Supervisors, and nothing will be proposed or considered until there is extensive community engagement. Also contrary to misleading statements being made, two properties are being evaluated in Carmichael, but only one shelter site, if any, will ultimately be proposed in the community.

There has been a lot of discussion on social media about work currently occurring behind the Carmichael Library. This has nothing to do with any homelessness project. The Carmichael Water District is using the County-owned property behind the library for staging and storage as part of the La Vista Storage Tank Project.

The original La Vista Tank and Booster Pump was built in 1971 and was identified in the District's Master Plan for upgrading and replacement. This project, which has been planned since 2020, consists of constructing a new 3,000,000-gallon storage tank and booster pump station, new water line piping, and electrical conduits. The project is estimated to be completed in 2023. The Carmichael Water District has specific information about the project on its website at <http://carmichaelwd.org>.

I would like to briefly describe my plans for community engagement before a Safe Stay site is proposed in Carmichael. My office

has already hosted a meeting with community and law enforcement stakeholders who actively work on homelessness issues with the County. These stakeholders include Carmichael business organizations and homeless service providers, Carmichael Library representatives, Sheriff's officials, and the Community Prosecutor assigned to Carmichael.

The purpose of this initial, small meeting was to hear directly from these stakeholders about the County's approach to homelessness, which site might be best to continue exploring for a shelter and discuss suggestions for larger community engagement. My next level of community engagement will be direct, one-on-one meetings with residents and businesses adjacent to the preferable site to hear their concerns and ways to mitigate them if we decide to proceed with a proposal. I will then host multiple community meetings to give everyone in Carmichael a chance to make their voices heard.

As many of you know, the Board recently approved two Safe Stay shelter sites in the south part of the County to serve the homeless in nearby communities. The Safe Stay sites are designed to maximize the ability to get people off the streets and open spaces and into a safe and sanitary location that provides access to services and housing.

County staff and Supervisor Kennedy hosted several community meetings before either of these sites came to the Board of Supervisors for approval. These meetings gave the community the opportunity to express concerns and influence the design, structure, and operation of the Safe Stay sites. If the County decides to move forward with a proposal for a site in Carmichael, the level of community engagement and influence will be the same. ★

## Two Ordinances to Prohibit Camping Approved

### Sacramento County News Release

**SACRAMENTO COUNTY, CA (MPG)** - The Board of Supervisors on August 11, approved two ordinances addressing camping and encampments near critical infrastructure such as levees and government buildings, wildfire and flood risk areas during severe weather, near shelters for persons experiencing homelessness, youth-serving facilities and a separate ordinance prohibiting camping on the entire stretch of the American River and Dry Creek Parkways. The Board will formally adopt the two approved ordinances on August 23, and they will go into effect 30 days later.

As was mentioned several times by staff, county counsel and supervisors, these ordinances going into effect will not result in the wide-scale clearing of encampments. The County has both a legal and moral obligation to identify the highest priority camps, identify the needs of the campers and offer services and shelter as appropriate. The County is committed to applying a thoughtful approach in order to balance the needs of both the campers and the impacted community surrounding encampments.

"These ordinances provide another tool for County staff and our outreach partners to engage with folks experiencing homelessness camping illegally, assess their needs and determine the best course of action to move them away from critical infrastructure," said Board Chair Don Nottoli. "The time has come to balance the needs of our unsheltered population with the impacts that our communities and environment have been facing for years."

The ordinances provide law enforcement officials with the authority to specifically address the activities in these particular locations because of public health, safety and welfare concerns.

The critical infrastructure ordinance adds Chapter 9.120 to the Sacramento County Code to prohibit camping and encampments in the following priority areas:

In, on or within 25 feet of critical infrastructure or the entrance/exit of critical infrastructure; Up to 1,000 feet of a location providing year-round overnight shelter to people experiencing homelessness and the entrance/exit to such locations; Inside of, or within 30 feet of wildfire and flood risk areas during severe weather; And, within 25 feet of a youth-serving facility, defined as public or private primary or secondary schools and public libraries.

Violations would first be subject to verbal and written warnings and any

person who violates the ordinance would be guilty of a misdemeanor. This also authorizes the County Executive or designee to promulgate rules, protocols and procedures for the implementation of the ordinance.

To read the full definitions of each identified priority area, read the full ordinance at the county website.

The Board also approved a separate ordinance that addresses the Dry Creek and American River Parkways specifically.

"The American River Parkway is our region's most treasured recreational and ecological asset," said First District Supervisor Phil Serna. "As the stewards responsible for its protection, we are obligated to see that it is a clean and safe place for everyone to enjoy while ensuring those who feel their only option is to reside on the Parkway, have housing opportunities and access to services elsewhere in the county."

The following are key provisions of the ordinance:

Prohibition on camping or constructing, maintaining or inhabiting any structure or camping facility in the American River Parkway or Dry Creek Parkway, except with written permission from the Director;

Prohibition on modifying the parklands (e.g. dirt, landscaping) or accumulating furniture, household goods, or other items in order to create a structure;

Bans the use or maintenance of a container with flammable or combustible liquid or a generator, except when issued a permit by the Regional Parks Director.

The intent of the proposed ordinance is to provide the County with an additional enforcement tool to address camping and the proliferation of unpermitted structures used as makeshift shelters in the Parkways and reduce public safety concerns relating to the use of flammable or combustible liquids and generators in parks. However, the ability to enforce the proposed ordinance, like the existing Code provisions, is dependent on law enforcement capacity and prioritization as well as availability of shelter, as outlined in the proposed Park Rangers' Action Plan. In addition, the Action Plan describes the County's commitment to conduct outreach efforts to offer alternative shelter and other services to individuals camping in the Parkways.

# Public Health and Local Emergency Bera Secures Funds for Sacramento Meals on Wheels Program

## Sacramento County News Release

**SACRAMENTO COUNTY, CA (MPG)** - On Tuesday, August 9, Sacramento County proclaimed a public health emergency and a local emergency in order to ensure appropriate resources and funding are available to the County in its response to monkeypox.

The proclamations of a public health emergency and local emergency do not signify an increased risk to the residents of Sacramento County. A proclamation of emergency allows the County to provide or receive mutual aid from other jurisdictions and assists in opening up available resources, mutual aid and staffing.

The proclamations follow the State of California's proclamation of emergency on Aug. 1, regarding monkeypox and the funding that would be made available. Proclaiming a local emergency is a prerequisite for requesting and receiving

available federal or state funding.

"Proclaiming a state of emergency in response to Monkeypox helps the County to ensure uninterrupted access to resources necessary to lessen disease transmission," said Don Nottoli, Chairman of the County Board of Supervisors. "The proclamations should not be a reason for elevated concern; but rather, considered as mechanisms to assist in our mission to better respond to and contain the virus."

The County continues to work closely with the Centers for Disease Control and the California Department of Public Health on coordinated testing, investigations, and providing guidance and assistance to health providers in monitoring for monkeypox symptoms and gathering information to detect new cases for laboratory testing and confirming infection.

Transmission of monkeypox virus occurs when

a person comes into contact with the virus from an animal, human or materials contaminated with the virus. The virus enters the body through broken skin (even if not visible), respiratory tract or the mucous membranes (eyes, nose, or mouth).

Symptoms of monkeypox include; fever, headache, muscle aches, backache, swollen lymph nodes, chills and exhaustion. Within 1 to 3 days (sometimes longer) after the appearance of fever, the patient develops a rash, often beginning on the face then spreading to other parts of the body. The incubation period (time from infection to symptoms) for monkeypox is usually 7-14 days but can range from 5-21 days. The illness typically lasts for 2-4 weeks.

## Office of Congressman Ami Bera, M.D

**WASHINGTON, DC (MPG)** - Representative Ami Bera, M.D. (CA-07) announced on July 26, that he secured \$750,000 in the House Fiscal Year 2023 Appropriations package to support Meals on Wheels in the Sacramento region.

Funding for the project was included in the FY23 House Transportation, Housing and Urban Development (THUD) Appropriations bill, which passed the House of Representatives last week. The THUD bill now head to the Senate for consideration.

"Since entering Congress, I have been a steadfast supporter of critical community programs like Meals on Wheels," said Representative Bera. "I am proud to announce that I secured \$750,000 in federal funding that will support the Meals on Wheels Kitchen Project to deliver more nutritious meals to seniors living throughout Sacramento County. I will continue to work in a bipartisan manner to ensure this critical funding gets signed into law."

"With the Community Project Funding, Meals on Wheels by ACC (MoW) will be able to move meal production from Mississippi to California. Moving production

to California means we can source meal ingredients from local farms, make immediate changes to our menus, offer culturally diverse meals, and serve more seniors," said Kevin McAllister, Executive Director of Meals on Wheels Sacramento.

The funding would be used to purchase food service equipment for a commercial kitchen in the Sacramento area that would allow them to produce locally sourced, freshly prepared meals to Sacramento seniors and expand their program capacity. This project is a good use of taxpayer dollars because it will allow them to meet the growing demand for nutritious meals by a growing senior population in Sacramento and expand the number of meals they serve through collaborations with local farmers and producers. Eliminating the use of a vendor who produces meals out of state will save taxpayer dollars and support local farmers.

Representative Bera has been a longtime support of the Meals on Wheels program. Amid a government sequester in 2013, Representative Bera donated a portion of his monthly pay to Meals on Wheels.

In total, Representative Bera secured more than \$32 million to support 15 community funding projects for the Sacramento-region in the FY 2023 House appropriations bills. ★

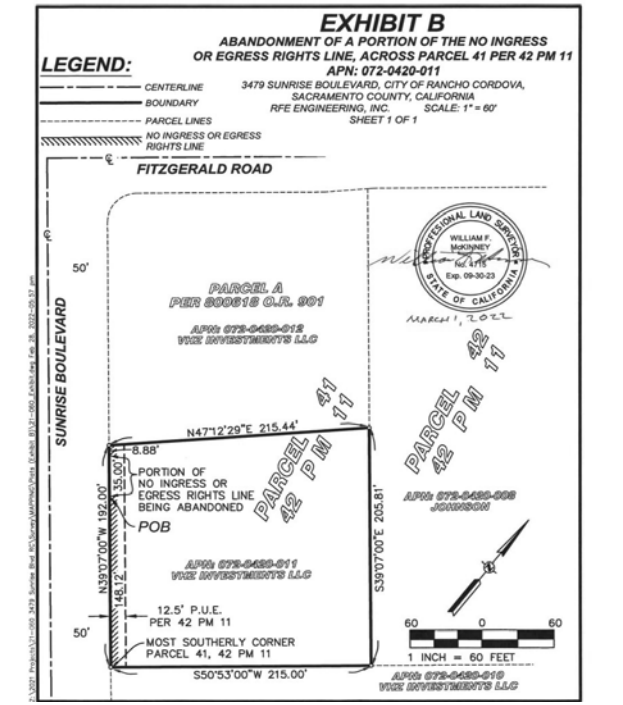
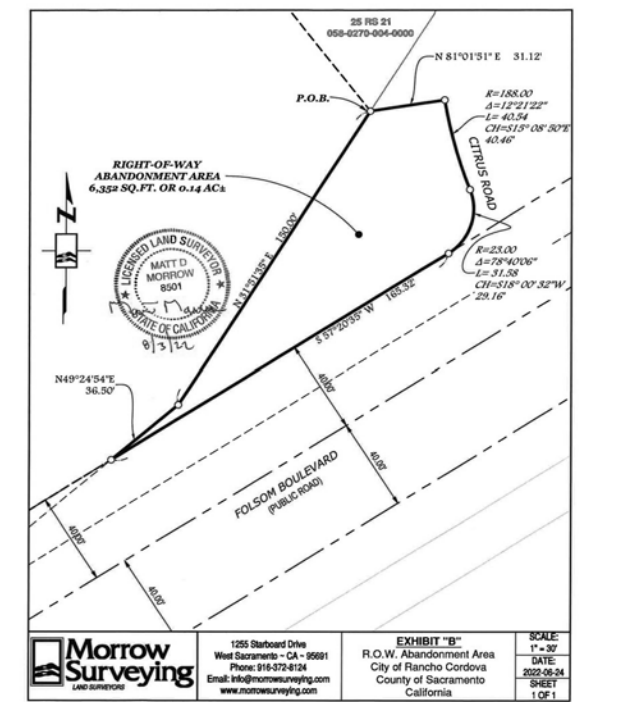

## Climate Emergency Mobilization Task Force Seated

# RCPD Gets Proactive with Marijuana Grows

**RANCHO CORDOVA, CA (MPG)**

- RCPD is taking a proactive approach to identify and halt illegal marijuana cultivation to prevent illegal activity and nuisances for residents and businesses in the City

of Rancho Cordova. According to the Rancho Cordova Municipal Code, up to six plants may be cultivated indoors in a private residence in the city. However, RCPD is seeing unsafe and illegal cultivation in residential and business areas that

far exceeds this plant requirement.

On July 13, 2022, RCPD's Problem Oriented Policing (POP) Unit served a search warrant at one residential location suspected of illegal marijuana cultivation after receiving a tip.

Officers located an illegal marijuana cultivation consisting of 285 live marijuana plants, processed marijuana, and approximately \$39,000 in cash.

Officers arrested one individual and booked him at the Sacramento County Main Jail on several felony charges related to the illegal marijuana cultivation and power theft.

RCPD and the City

of Rancho Cordova Government's Neighborhood Services Division often partner to address problematic locations and respond to incidents in the city to keep our community safe. The Neighborhood Services Division assisted RCPD in its investigation of the illegal marijuana cultivation operation, as well as cited the home for numerous building code

violations. RCPD is asking residents and businesses to be our eyes in the community to help stop illegal marijuana cultivation.
