About 3 million Californians are in families that earn little enough that they aren't required to file taxes, according to research by Public Policy Institute of California for its 2019 a program to send payments to people who don't file taxes and aren't enrolled in safety net programs that received a boost in the budget. ### SacRT Awarded \$30 Million to Improve Light Rail System

**SACRAMENTO, CA (MPG)** -The Sacramento Regional Transit District (SacRT) was awarded \$30 million in state grant funding through the Transit and Intercity Rail Capital Program (TIRCP) to help make major improvements to the Sacramento region's light rail system, reduce greenhouse gas emissions, and support jobs.

The California State Transportation Agency (CalSTA) awarded SacRT funding to help fund three major projects. SacRT will receive \$23.6 million as part of a nearly \$600 million Light Rail Modernization Project an additional \$5 million to support connectivity and planning at Sacramento Valley Station (SVS) to prepare for future development at the Railyards, and \$1.5 million for contactless fare payment devices onboard buses and light rail vehicles. • Light Rail Modernization Project: SacRT is currently working on modernizing the light rail system with new lowfloor light rail vehicles, converting 29 light rail stations on the Gold Line to accommodate new low-floor vehicles, and adding a "passing track" at the Glenn/Robert G. Holderness Station in Folsom to provide 15-minute service, rather than the existing 30 minutes. TIRCP funding will support the purchase of eight new low-floor light rail vehicles to replace vehicles that have passed their useful life. Low-floor light rail vehicles will produce operational efficiencies by speeding up train operating times and optimizing boarding convenience and safety along with needed increased capacity. • Sacramento Valley Station (SVS) Transit Center: SacRT partnered with the City of Sacramento and Capitol Corridor Joint Powers Authority on a project to improve connectivity of multimodal transit in the Continued on page 14

# **State Requires Sharing Your Data**

In March 2020, as Californians hunkered down for what many expected to be a two-week lockdown, high-ranking health officials were scrambling to find out how many COVID-19 patients were hospitalized, how many were in intensive care and how many beds remained available.

With no system in place for hospitals to report this information to the state and share it, Secretary of Health and Human Services Dr. Mark Ghaly, the state's public health director and other staff had to call 426 hospitals to assess the situation.

Now, officials hope to avoid similar scenarios in the future by changing the way patient data is collected and shared. Legislation passed last year requires all health and human services providers to sign a statewide data-sharing agreement. This includes hospitals, doctor's offices, nursing homes, public health agencies, laboratories, mental and behavioral health providers, substance use treatment facilities, insurance plans, public health departments and emergency services.

The final version of the agreement was published July 1. Most participants will have six months to sign the agreement and a year to begin sharing data.

If implementation goes as planned, a doctor or case worker could request a patient's full medical and social services history in real time. Patients could view their own records easily, and government agencies would also have access to more reliable aggregate data on patient outcomes and demographics — rendering the pandemic scramble obsolete.

The health care industry already amasses incredible amounts of patient data. John Ohanian, chief data officer for the state Health and Human Services Agency, likens it

to "freeways of information." The problem is, not everyone has an onramp to the freeway.

"Our goal was – and the governor's goal was – to make it mandatory that people exchange information and provide rules of the road and guidelines so it can be done well," Ohanian said.

It's a huge endeavor for the state, and not everyone is on board.

In a public comment responding to a draft of the agreement, the California Hospital Association and California Association of Public Hospitals and Health Systems complained that the requirements exceed the statutory authority of the law that established the data-sharing requirement. When contacted for clarification, hospital association spokesperson Jan Emerson-Shea said there was nothing to add beyond what was in the letter.

The California Association of Health Plans also commented that parts of the draft proposal go beyond the scope of the new data-sharing law, including the proposed governing body that would oversee compliance. The association also pointed out potential conflicts with a parallel federal effort to create a national data exchange for health data.

Other groups, including the County Welfare Directors Association of California, County Behavioral Health Directors Association and Planned Parenthood Affiliates of California, raised concerns about data privacy and security. They also want patients to be given the ability to choose whether their data is shared and noted that addiction and mental health records are more strictly protected than other health data. In a letter to the state, Planned Parenthood asked to delay implementation by one year.

According to a state analysis, the proportion of medical and social services organizations that currently use digital records and share that information with other providers varies widely based on sector and location.

While 97% of family physicians used electronic record-keeping methods in 2020, those who didn't tended to be small independent practices or they were in rural areas. Likewise, 90% of medium and large hospitals also used electronic-only patient records, but only 70% of small hospitals in the state used digital records.

The report found a little more than a third of addiction treatment centers used electronic records to document treatment plans and view laboratory results. Less than half of nursing homes used electronic records and only 10% reported that their systems connected with local hospitals.

Some of the organizations with the fewest digital record-sharing systems are government agencies like county public health and social services departments. The state Legislature's approved budget includes \$50 million over two years to help small doctor's offices, rural hospitals and community organizations invest in the technology needed to comply with the law.

Even before the pandemic, community clinics and social services providers like homeless shelters say disconnected record-keeping systems caused chronic problems.

On a broader scale, the patchwork of digital accessibility has made it difficult to reduce health disparities for conditions like heart disease and diabetes, both before and during the pandemic, said Kiran Savage-Sangwan, executive director of the California Pan-Ethnic Health Network and a member of the data exchange advisory group.

Communities of color make up 63% of the state's population but represent more than 80% of all enrollees in Medi-Cal, the state's health system for people who can't afford health insurance. According to a California Health Care Foundation report on health disparities, Black and Latino residents are far more likely to experience preventable hospitalizations for conditions like asthma, heart failure and diabetes than white residents. The same groups are also the most likely to report delaying health care due to cost or lack of insurance.

In recent years, the state has launched ambitious plans to transform the Medi-Cal system through an initiative called CalAIM, which aims to address the root causes of failing health, like food insecurity and housing instability. It offers coverage for services not typically thought of as medical needs, such as housing. CalAIM, along with the state's Healthy California for All Commission, which is exploring what a single-payer health care system could look like in California, relies on data.

"I can't think of a thing on our list of huge transformations that won't either depend on or benefit from this effort," Ghaly said. "All of these data systems having some ability to come together around the individual is going to accelerate – whether it's a social worker or an emergency room nurse – their ability to provide more comprehensive and coordinated services."

## Apex Predator Competitor Places Top 3 in Nation at BJJ Nationals

LAS VEGAS, NV (MPG) -Rancho Cordova native and Mitchell Middle School student Edgar Alberto placed third in the nation at the 2022 American National IBJJF Jiu-Jitsu Championship, marking the first national championship medal for his home gym, Apex Predator Mixed Martial Arts.

The build up to this tournament wasn't without drama, however, as Edgar's registration wasn't accepted until the final day of eligibility. He was also on the brink of disqualification because of International Brazilian Jiu Jitsu Federation uniform standards until a late scramble to find a regulation GI bailed him out moments before his scheduled fight.

Gym owner and head coach Rudy Vidaurri attempted to attend the Kids National Championship and was actually on the runway set for takeoff but a loud sound from the motor and mechanical problems forced passengers to deplane and he coached by way of phone instead. Vidaurri had coached Alberto in back-to-back victories leading up to nationals and couldn't be prouder of his budding young star.

"I think it's important for Edgar to face elite competition and measure himself against the best in the country and to not get complacent dominating in

a smaller pond," Vidaurri said. "We wanted to win it all, but he went against the best around and understands what it takes to get there now. Edgar fought the best fighter in the country in the highest weight class with the highest belt rank and I look forward to the challenge of closing that gap and seeing them face off again down the road.

"We will approach this next training camp more aggressively and let the rest be decided on the mat. Edgar worked very hard for this and deserves to be recognized as one of the best in the country. He went out there and brought a national championship medal back to Apex Predator and this is why we grind. At the end of the day, Edgar's preparation and experience are more valuable than anything else coming away from this thing. He took a big step forward in his development and now has the confidence to step on the mat with the very best around and hold his own.... next year we will win it all."

## Medi-Cal Holding Seniors Back

California living is expensive. So imagine having to get by on \$600 a month. That's essentially what some seniors and people with disabilities have to do in order to access Medi-Cal, the state's health insurance program for low-income residents.

Individuals with significant medical expenses – but whose income is too high to qualify for free Medi-Cal – may still access the program if they pay some of the costs.

That share of cost works like a monthly deductible; people are allowed to keep \$600 for personal use and must spend the rest of their income on health care expenses before their Medi-Cal coverage kicks in.

"If you make \$1,600 a month, \$1,000 has to go toward paying for your care," said Tiffany Huyenh-Cho, a staff attorney at Justice in Aging, an organization that is urging state lawmakers to update the income rule. Because people using this type of Medi-Cal usually have costly care, for some it's worth paying, but most can't afford it, she said.

In January of this year, the latest month for which state data is available, there were about 81,000 people who were enrolled in Medi-Cal but couldn't use it because they did not meet their share of the cost. The majority are over 65 or have a disability, data show.

Take Maxine Wells of San Diego – she is 91, and with the help of her son, Keith Wells, she recently applied for Medi-Cal. Her Social Security monthly income of \$2,000 puts her over the limit for free coverage. Keith is still waiting to get official word from the state on his mom's eligibility status, but isn't sure they'll be able to meet her share of the cost.

rates in the country - about 6% of California residents don't have health insurance. Still, pockets of people continue to struggle to afford the coverage and care they need, meaning they go without it

Aging advocates say older adults tend to live on fixed incomes but are sometimes subject to rules that haven't kept up with the current cost of living.

Aging and health advocates are now asking legislators and the governor's office to allow Medi-Cal recipients who need to pay a share of cost to keep more of their income. Assembly Bill 1900 by Assemblymember Dr. Joaquin Arambula, a Fresno Democrat, proposes to raise the monthly limit from \$600 for an individual, which is about 55% of the federal poverty level, to \$1,562, or 138% of the federal poverty level.

This adjustment would require federal approval, according to the Department of Health Care Services, which oversees the Medi-Cal program.

Arambula's bill made it out of the Assembly last week and is now before the Senate. "This is simply a matter of fairness for Californians who are struggling to make ends meet and need access to health care," Arambula said about his bill in the Assembly Health Committee hearing earlier this year.

Linda Nguy, a policy advocate with the Western Center on Law and Poverty, said it would be difficult to pass the bill if funding for it isn't included in this year's state budget. Funding for this proposal was not included in the governor's May revision of the budget.

However, the version of the budget released by the Legislature's Democratic leaders allocates \$31 million to reduce the share of cost for this population. The Legislature and Gov. Gavin Newsom must now come together and hammer out a final budget. The Legislative Analyst's Office has estimated that this proposal would cost anywhere between \$53 million and \$151 million, of which half would be paid for by the state and the other half through federal funds. Without that funding, Arambula's bill would likely get stuck in the Senate's fiscal committee, Nguy said. At least nine other states and the District of Columbia allow people who pay a share of cost for Medi-Cal (Medicaid in other states) to keep a higher amount for personal use than California does, according to the Kaiser Family Foundation.

## **Losing Ground in Protecting Our Air Quality**

For decades, California has been the nation's leader in reducing tailpipe emissions from cars and trucks and other aggressive work to clean up smog. Southern Californians old enough to remember their eyes stinging from air pollution in the old days know how important that work was.

But now, the state's hard work cleaning up the air is going up in smoke.

California has always had fires, and summer and fall smoke used to be an occasional annoyance. But the mega-fires the state is increasingly seeing send up so much smoke that the air quality gains made over the past years are being lost.

As the L.A. Times recently reported, California's 2020 wildfires sent up so much smoke that we reversed decades of progress in improving air quality. This is no surprise to Californians who spent months under apocalyptic dark skies, but it's a sad confirmation of how much progress has been lost.

And while 2020 was a record-setting wildfire year, 2021 was nearly as intense. It would have set a record if 2020 hadn't come first. This air pollution isn't just unpleasant. It is deadly. Stanford researchers, as the Times reports, estimate up to

the smoke in our air.

As a member of the state Legislature, I've been fighting for healthier forests for a decade. I've written legislation to get the government's bureaucracy out of the way of fire prevention, launch a major reversal of "no management" management practices, and supported and expanded the Sierra Nevada Conservancy, a champion of healthy forests and watersheds. I wish I could say it was enough.

A large part of the problem is leadership. The current governor says the right things, but real work to keep communities safe and reduce wildfire severity is scarce; there has been no significant reform to California Forest Law in the last 20 years. We still manage our forests under policies that reflect the reality of the 1960s, not today.

This administration is great at issuing press releases but very bad at follow-through, as multiple reports from Capital Public Radio reporters documented over the past year. State and federal policies still put countless barriers in front of the work needed to actively thin overgrown forests (in some places 400% overgrown). We can do better. We can more aggressively waive long reviews under the California Environmental Quality Act for fire-safety projects.

Environmental groups cling to the power to stall and stop projects under these laws in the name of protecting forests. Still, I defy any of them to take a tour of Plumas County, where the Dixie Fire burned a million acres last year and

3,000 premature deaths from tell me that it is a healthy environment.

We must consistently support the local governments and nonprofit Fire Safe Councils that plan and organize fuel work. Competitive grants primarily drive the state's current system. CalFire does its best to fund essential projects, but too many communities don't have the organization to ask. Many rely on volunteer groups to handle this critical public-safety work. I have the highest admiration for the people who step forward to help their neighbors, but the critical fire risks we're facing demand a 21st-century response. We have to tap the nearly forgotten wisdom of the ranchers, and the California Native tribes before them, who learned that fire in California is inevitable, but burning on purpose in the right season is safer and better for the environment.

The risks of prescribed fire are serious, but we need to expand our capacity to burn where we can do it safely. And we must work with the federal government, which manages nearly half the land in California, so it does its part to change course. Our national forests are a California treasure, but in recent decades their extreme, barely managed fire risk has made them a bad neighbor. The wildfire crisis is destroying watersheds, leveling whole towns, and blanketing the state in smoke that is literally killing Californians even if they live miles from the fire lines. We must do better.

Last month's primary election was the latest test for a state computer system that is supposed to provide timely and complete data on campaign contributions, lobbying expenditures and other financial aspects of the political process.

Cal-Access, as it's known, struggled to do what it was supposed to do, which surprises exactly no one who tries to use the system.

It's not a new problem. The shortcomings of the 23-year-old political reporting system have been known for years. The former secretary of state, Alex Padilla, once described Cal-Access as "a Frankenstein's monster of code" that is in need of "a complete rebuild" and sponsored 2016 legislation to create a replacement.

Then-Gov. Jerry Brown, himself a former secretary of state, agreed that the system needed an overhaul and signed the legislation. A successor system was supposed to be ready within a few years, but it wasn't.

Last year, Padilla was appointed to the U.S. Senate. Shirley Weber, a Democratic assemblywoman from San Diego, was named as his successor and she more or less scrapped what Padilla had done on the Cal-Access

Replacement System or CARS, as it's called.

"To ensure that the CARS project can fully meet its statutory obligations, the scheduled June 30, 2021, rollout of the project will be postponed," Weber said. "Moving forward, the secretary of state's office will assess the project's state of readiness so that on the date it goes live it will meet the expectations of the public, stakeholders and the regulated community."

It's another example of a syndrome that has plagued state government for years. While California's Silicon Valley and other technology hubs may be global leaders in the development of information technology, its state government has been chronically incapable of implementing IT systems that work as promised.

One of the most spectacular IT failures was a meltdown in the **Employment Development** Department's handling of claims for unemployment insurance benefits from hundreds of thousands of California workers who lost their jobs due to pandemic-related shutdowns, compounded by approving billions of dollars in payments to fraudsters.

The long list of IT systems that that have failed, incurred huge cost overruns and/or were delayed for years is, or at least should be, especially embarrassing to Gov. Gavin Newsom. In 2013, he published a book, "Citizenville: How to Take the Town Square Digital and Reinvent Government," predicting that technology would transform American democracy and end political gridlock. California's sorry record

of IT failure raises the obvious question of "why?" Is it bureaucratic sclerosis? Is it an inability to define missions precisely enough for software engineers to design solutions? Do vendors overpromise results to pad their bills?

The state auditor's office has identified managerial shortcomings in many specific projects, such as one dubbed FI\$Cal, supposedly a comprehensive integration of financial data. However, there's never been an analysis of what obviously is a systemic procurement failure — until now.

Last week, the Legislature's audit committee directed the auditor's office to examine the entire IT procurement system, beginning with the Department of Technology, which was created several years back to solve the chronic problem.

The audit was requested by Assemblywoman Cottie Petrie-Norris, an Irvine Democrat who chairs the Assembly Accountability and Administrative Review Committee.

"The pandemic showed us the disastrous results of state IT systems that are overloaded, antiquated, and not ready for the task ahead," Petrie-Norris said. "This audit request is a critically needed look at the technology systems Californians should be able to easily rely on every day to interact with their government and obtain vital services."

A long-overdue look.

### **Defendant Sentenced for 1st-Degree Murder** of Natomas Library Branch Supervisor

#### Sac County DA News Release

SACRAMENTO COUNTY, CA (MPG) - The Honorable Steve White sentenced Ronald Seay to life in prison without the possibility of parole.

On April 20, 2022, a jury convicted Seay of the first-degree murder of Amber Clark. The jury also found true a personal use of a firearm causing death allegation and the special circumstance allegation of lying-in wait

Amber Clark was the branch supervisor for the North Natomas Library. On December 11, 2018, Ronald Seay arrived at the library parking lot, parked his car with a direct view of the library exit and waited for Amber Clark to get off work. When Ms. Clark left work, she exited the library and walked through the parking lot to her car. As she walked past Seay's car, Seay quickly exited his car and

followed her. When Ms. Clark got into her car, Seay opened her driver side door, shot her 11 times with his 9mm semi-automatic pistol and left the scene. Ms. Clark succumbed to her injuries at the scene. Sacramento police detectives quickly discovered that Seay had previously been served with a Notice of Trespass by Ms. Clark in her capacity as the branch supervisor. Ms. Clark issued the Notice of Trespass because Seay repeatedly violated the library's rules and code of conduct, became verbally aggressive and refused to leave the library. Seay appealed the ban, and the appeal was denied.

Seay was arrested on December 12, 2018, and a search of his car revealed two 9mm semi-automatic pistols. It was later confirmed that all 11 shell cartridges found at the scene were fired from the 9mm semi-automatic pistol located in Seay's car. \*

## **Defendant Convicted** of Aggravated Child Sexual Assault

SACRAMENTO COUNTY, CA (MPG) - Andrey Yevtukh pled to three counts of committing a lewd act on a child, one count of forcible lewd act upon a child and one count of sexual intercourse or sodomy with a child 10 years of age or younger.

Yevtukh also admitted aggravating factors that the crime involved great violence, the victim was particularly vulnerable, Yevtukh took advantage of a position of trust and the crime involved planning or sophistication.

On January 30, 2021, the 9-year-old victim and her mother contacted the Sheriff's Office to report that Yevtukh had sexually assaulted the victim approximately 8 months prior. The victim disclosed that Yevtukh held her down and sodomized her when she was between 6 and 7 years old. She later

disclosed that Yevtukh sodomized her on four other occasions, had sexual intercourse with her and forced her to orally copulate him while the victim was between the ages of 7 and 9 vears old. The victim stated that Yevtukh threatened to hurt her if she told anyone.

Yevtukh faces a maximum sentence of 30 years to life in prison. Sentencing is set for July 8, 2022, at 9:00 a.m. in Department 33 before the Honorable Laurel White.



## **Seniors Missing Out** Sac Public Library Providing Free Meals

said nobody could figure out how to administer such payments.

"Ultimately, the configuration of the rebate was subject to three-party negotiations as part of the final budget, and there were concerns that there wasn't an efficient and secure way of accomplishing a grant program to non-tax filers," said a statement from the office of Atkins, a San Diego Democrat.

The Legislature "really wanted to get help to these people, but ... we were not able to do it logistically," said a spokesperson for Rendon, a South Gate Democrat.

The payments will go out to Californians who filed 2020 tax returns by October 2021, according to the Franchise Tax Board, which has a tool for calculating how much you are eligible to receive based on how much you earn and other factors.

But in California, people earning less than \$19,310 who don't have a child or someone else depending on them - one of many different gross income thresholds - aren't required to file income taxes. The state also doesn't count Social Security retirement or disability benefits as taxable income, meaning people who receive those benefits aren't required to pay taxes, so long as they have minimal other income.

Lawmakers tried to aid some low-earners who may not file taxes by increasing payments for people receiving CalWorks benefits, a program for needy families. They also increased benefits for people who receive Supplemental Security Income - a state-supplemented version of social security benefits for senior or disabled people who would otherwise not qualify for, or have extremely small social security payments.

The boosts for people in those two programs are good, said Trinh Phan, a senior staff attorney focused on economic security at Justice in Aging, which advocates for low-income older adults. But, she said, the budget package still leaves out some people who are very low-income.

For example, someone getting by just on Social Security Disability Insurance could miss out on this rebate and the boosts to CalWorks and Supplemental Security Income: They might earn little enough that they don't have to file taxes, but if they don't have kids they likely won't qualify for CalWorks. And, if their disability benefits pay more than \$1060.21 per month, they wouldn't qualify for Supplemental Security Income either, said Phan.

About a quarter of Americans over 65 live in households where 90% of the fam-

Some low-income Californians won't receive the rebate, Department of Finance spokesperson H.D. Palmer said. But he pointed out that many people who aren't required to file taxes still choose to do so, sometimes to receive other benefits distributed through the system. In 2020, an additional 500,000 low-income tax returns were filed in California, Palmer said in a statement, "presumably to qualify for a Golden State Stimulus payment or perhaps even a federal relief payment." Palmer also pointed to other forms of financial assistance in the budget, such as \$1.4 billion in aid for people with unpaid utility bills.

People who don't pay taxes and aren't in a benefits program run by California are hard for the state to reach quickly with aid. Social security benefits are administered by the federal government, and the state doesn't have data on recipients, said Jesse Rothenstein, a professor of public policy and economics at University of California, Berkeley, and faculty director of the California Policy Lab.

"It's obviously not great that we're missing people, and many of them are some of the most vulnerable people in the economy," said Rothenstein. But, he said, "It's not as if there's a mechanism available that reaches everybody." Given a set of imperfect options, using the tax system was the best choice, Rothenstein said.

It's also the choice lawmakers made when distributing two rounds of Golden State Stimulus payments in 2021. After that move, they faced criticism from disability advocates, and seniors who were left out.

"To see that they have done it again this year is just further proof that nobody's paying attention to people who need the most help," said Charis Hill, a disability advocate who lives in Sacramento.

California's government doesn't know much about the people who don't file taxes. The Franchise Tax Board doesn't track the number of residents who aren't required to file taxes, or what share of those people live in poverty, according to statements in response to CalMatters' questions. A spokesperson for the board said that no state agencies appear to track that information.

The difficulty of reaching people with this payment exposes a weakness in the state's system "that needs to be addressed on a longer-term basis," said Chris Hoene, executive director of the California Budget and Policy Center, which advocates for targeting aid to lower-income people. Part of the solution would be better data sharing between the federal government and the states, he said. But, given the options policymakers were considering - including giving money to car owners, as Gov. Newsom proposed, and cutting the gas tax - hethinks the payments based on income are a good outcome.



## Meet San Francisco's Newest Giant: The Yermínator 1-on-1 exclusive with Yermín Mercedes

**SACRAMENTO, CA (MPG)** - With two outs in the top of the ninth inning of a 15-4 blowout between the Chicago White Sox and Minnesota Twins, Yermín Mercedes swung on a 3-0 pitch and crushed it to left center field for a home run.

Most people would think that such a moment deserves cheers and admiration from the winning team's manager. However, that was not the case on May 17, 2021. White Sox manager Tony La Russa, who was 76 years old at the time with more than three decades of MLB managerial experience, called the moment a "big mistake" when he spoke to the media following the 16-4 victory.

According to Mercedes, he was surprised when he heard his manager's comments to the media. La Russa said one thing to him privately in the locker room, and then said the opposite in his post-game press conference.

Baseball is America's national pastime for a reason, and with that, comes an old school mentality from some people like La Russa who employ platitudes like the "unwritten rules" of baseball. La Russa's disapproval went on to have a negative effect on the rising star and Mercedes was never as productive for Chicago statistically following that fateful day in May.

"We don't have that rule in baseball," Mercedes told the Messenger Publishing Group before making his debut with the Sacramento River Cats on June 21. "He's an old manager. In that moment after the game, he came into my locker and he talked to me and said, 'I got you, you're okay, it's my fault.' Because I

never saw the sign and he never gave me the sign. I think he gave it to the (base) coach, but he didn't give it to me.

"I always go to home plate and make a swing; do the best I can do in the game for the whole team."

The Yerminator went from leading MLB in batting average (.364) to suddenly plummeting back down to Earth (.271) near the league average. The drop in production led to him being demoted back to Triple-A. Mercedes suffered an injury during spring training this year and had surgery in March before eventually being designated for assignment on June 12.

While with Chicago, Mercedes showed flashes of greatness. The Dominican Republic native set a major league record as the first player in modern MLB history to begin a season with eight consecutive hits, earning him MLB Rookie of the Month honors in April 2021. On April 2, 2021, Mercedes made history as the only White Sox player to record five hits in his first major league start.

"Big Yerm," as he refers to himself, said he didn't do anything abnormal during the hot streak. He just stuck to his daily pregame routine and approached the plate during each at bat with the goal of making solid contact.

"I never imagined I [would] be 5-for-5 in my first game in 2021," Mercedes said. "Then the next day, I go 3-for-3 so in that moment I had 8-for-8. My next at bat I just popped out to center field and said 'Wow, it's unbelievable.' Because I never, never imagined I would make it 8-for-8 in that moment."

On June 18, the San Francisco Giants claimed Mercedes off waivers, giving the excited 29-year-old a fresh start and a new home. Mercedes made his debut for the Giants' Triple-A affiliate, the Sacramento River Cats, on June 21. Just like in his first start for Chicago, Mercedes recorded a hit in his first at bat for Sacramento, as the starting first baseman. Mercedes went 2-for-5 in his first game for the River Cats.

It didn't take long for Mercedes to get the call to return to the big leagues as on June 26, the Giants recalled him from Sacramento to replace infielder Brandon Crawford who was placed on the 10-day injured list. Mercedes was 5-for-16 at the plate with two walks in four games for the River Cats.

Mercedes was optioned back to Sacramento three days later on June 29 after outfielder LaMonte Wade was activated off the IL. Then four days later, the Yermínator was back like he never left, returning to the Giants on July 3 to replace infielder Thairo Estrada, who was placed on the COVID-19-related IL.

"I know I can help the team out there," Mercedes proclaimed with confidence. "I know they need me because I'm a good baseball player, I know that. I need to focus on working hard every time, every day coming to the ballpark. It doesn't matter what the people say because when the people talk about you, it's because you're important. If you aren't important, the people don't talk about you."

Mercedes provides the Giants with defensive versatility as he regularly plays first base, catcher and designated hitter. With highly touted prospect Joey Bart recently demoted back to Triple-A, that could open a door for Mercedes to stay in the major leagues for the long run as a catcher.

In five games so far with San Francisco, Mercedes has gone 4-for-11 at the plate with two doubles, two runs scored and two walks. Defensively, he has started once at catcher and first base, respectively, with the other three starts as the designated hitter.

"The future has not been written," John Connor said in the 1984 film, The Terminator. "There is no fate but what we make for ourselves."

Whether or not Mercedes remains with the Giants long term is yet to be seen. However, whenever an opportunity presents itself, the Yermínator will be ready.



*Continued from page 1* downtown core. Funding will support the construction of a new north-south aligned light rail

station to connect the SVS to the future Railyards Plaza. This will catalyze the neighboring Railyards and River District developments while prioritizing transit ridership and active transportation.

• Contactless Fare Payment on Transit: SacRT partnered with the California Department of Transportation (Caltrans), Visa, Littlepay, and SC Soft to offer a contactless method for payment on board light rail trains to help improve the customer fare payment experience. The innovative touch-free fare payment technology allows riders to tap a contactless credit, debit, prepaid card, or contactless-enabled mobile or wearable device (e.g.,

smartwatch) to pay fare when boarding light rail trains. The TIRCP funding will help expand the program to buses and on all new light rail trains.

SacRT is truly thankful for the 2022 funding from the California Transportation Agency's Transit and Intercity Rail Capital Program," said SacRT Chair Steve Miller. "These funds put us one step closer to replacing our aging light rail fleet with entirely new and modern, low floor vehicles and making improvements at the Sacramento Valley Station for easier connections from buses and light rail to Amtrak and the Capitol Corridor trains."

"I want to thank CalSTA Secretary Toks Omishakin and Chief Deputy Secretary Chad Edison for these grant awards that will help modernize SacRT's light rail system and provide connectivity to regional partners," said SacRT General Manager/ CEO Henry Li. "Over the last few years, we have secured millions of dollars to improve the convenience and accessibility of our light rail system to the customer experience and quality of life for the Sacramento Region."

"Congratulations to Sacramento Regional Transit in your success of securing new funding from the competitive TIRCP program. With this state funding, SacRT will help lower greenhouse gas emissions in our region and improve public health and mobility across the region and California," said Assemblymember Kevin McCarty (D-Sacramento).

SacRT was previously awarded \$265 million in funding for the light rail modernization project, which includes the purchase of 36 new low-floor light rail vehicles. Siemens Mobility in Sacramento is building the new train cars and the first cars are expected to be delivered in summer 2022.

CalSTA awarded nearly \$800 million to 23 projects statewide to expand transit and intercity rail service and reduce greenhouse gas emissions. TIRCP funding is provided through Senate Bill (SB) 1, the Road Repair and Accountability Act of 2017, and from the Cap-and-Trade program proceeds.
