California Sheriffs Issue Public Alert Following DOJ Data Breach

SUTTER COUNTY, CA (MPG) - The California State Sheriffs' Association (CSSA) is alarmed to learn of a data breach by the California Department of Justice (DOJ) that has made public the personal information of California's citizen concealed weapon (CCW) permit holders.

CSSA is issuing this alert to make CCW permit holders aware of the situation so they can take appropriate precautions.

"It is infuriating that people who have been complying with the law have been put at risk by this breach," said CSSA President and Butte County Sheriff Kory Honea. "California's sheriffs are very concerned about this data breach and the risk it poses to California's CCW permit holders."

CSSA will continue to engage with DOJ in an effort to ensure that the risk to CCW permit holders is mitigated and a breach of this nature does not happen again. Every law enforcement agency in California that issues CCW permits is required by law to provide certain information about CCW permit holders to DOJ, which in turn is required to safeguard that information. The data breach was in conjunction with DOJ's launch of its "2022 Firearms Dashboard Portal." The breach included, but was not limited to, the names, ages, and addresses of individuals who hold CCW permits in California. It appears that before the breach was detected by DOJ, the information was copied and at least some portion of it was posted on the internet. After learning of the breach, CSSA President and Butte County Sheriff Kory Honea contacted DOJ officials. During that conversation DOJ confirmed there was a data breach involving CCW permit holder information. DOJ advised it has deactivated the dashboard and is working to determine the scope of the breach. DOJ stated it would be contacting all CCW permit holders directly to advise them of the breach and will institute a program to mitigate any harm or damages to CCW holders that result from the breach. DOJ has issued a statement regarding this situation that can be accessed on their website.

Targets for Crime, Abuse, Aggression

SACRAMENTO REGION, CA (MPG) - They claim that they live in fear. You can see it in their eyes. You can hear the fear in their voices.

Residents of the Mobil Country Club (MCC) on the border of Rancho Cordova and Gold River claim they are under a daily assault from residents who inhabit a large homeless camp behind the facility. Numerous tents and large piles of rotting trash now inhabit land originally set aside for the Citrus Road bike and pedestrian access trail. No bike rider or pedestrian dares use this path today.

"If you don't know who it is, you don't answer the door," said one rattled resident who was in fear of giving her name. "Everyone who lives back there (the back of MCC) is in a state of paranoia. They wonder what is going to happen next."

MCC is a 479-space mobile home facility that caters to residents who are 55-years or older. Storz



Mobil Country Club is a 479-space mobile home facility for residents 55 years or older described as a "quiet haven" with a "convenient and serene neighborhood."

Management Company describes the facility on its website as a "quiet haven" and a "convenient and serene neighborhood." The 10 residents who attended a recent meeting with Messenger Publishing strongly disagree. They say they live in a state of fear.

MCC residents say the problem started in 2016 but has grown worse in the past two years as the size of the homeless camp has tripled. Frustrated homeowners say they have placed numerous calls to the Rancho Cordova Police Department and the Sacramento County Sheriff's Department for help. One resident produced copies of 14 calls she made to Rancho Cordova police over the course of a single month. Officers do respond to these calls but will not take action to remove the source

of the problem and eyesore behind the MCC facility.

"I stopped calling police," one frustrated resident said. "They don't do anything."

As bad as the problem is during the day, residents say, it doesn't compare to what happens at night. Like the Mongol hordes who assaulted the Great Wall of China, MCC residents share stories of the *Continued on page 13*

Point in Time Count Report Released

SACRAMENTO COUNTY, CA (MPG) -On June 28, 2022, Sacramento Steps Forward, the lead agency for the Continuum of Care in Sacramento County, released the 2022 Point in Time (PIT) count report.

The Point in Time count is conducted every two years within Sacramento County and provides the community with a snapshot of how many people may be experiencing homelessness on any given night. The count was last done it 2019 and was delayed from 2021 to 2022 because of the pandemic. This year the count was done on Feb. 23 and 24.

As expected, the overall number of persons experiencing homelessness at the time of the count is much higher than it was in 2019. While it is disheartening to know that more of our residents are unhoused, this report is useful to the overall County strategy and response tactics.

The County now has updated data not only on homelessness overall but on many specific sub-categories such as families, veterans, those living in cars, chronic homelessness and some of the conditions and barriers that are keeping people homeless.

What Sacramento **County is Doing:**

The County has been steadily increasing funding, resources and programs to serve not only our unhoused residents but mitigating the impacts of unsheltered homelessness communitywide. The needs of the unhoused can be complex and vary drastically from person to person - but one thing remains consistent - complex wraparound services cannot be impactful until people's basic needs are met. Food, water, shelter and sanitation are just a few of the basic and essential needs people have in order to stabilize

services such as mental health treatment and/or drug and alcohol rehabilitation.

The County recognizes the need for diversified responses to this complex problem – knowing that one solution is not right for each person, no timeframe works for every person, and no one service works for everyone. Instead, the County is investing in a myriad of programs, services and new sheltering and housing concepts to not only address current homelessness but prevent or divert homelessness to begin with.

One of the new, innovative projects the County is launching that will aid in helping people exit homelessness, is the recently approved "Safe Stay Community" model. These small, individual sleeping cabin communities will provide the privacy, dignity and respect that unhoused people deserve, while also meeting their basic environment to learn about and accept services that will help them exit homelessness.

Investments and Programs Targeting Mental Health, Families and Youth-The County has made significant investments through MHSA Funding for Housing and Homeless Supports. Since 2007, \$28M have been allocated to address homelessness in Sacramento County through the MHSA Housing Program and No Place Like Home Program. The County currently has 221 housing units funded through MHSA and an additional 234 coming in the next two years.

In FY 2019-20: Housed 563 clients/households; Prevented 1,431 clients/households at imminent risk from becoming homeless; Served 161 clients/ households residing in MHSAfunded apartments; Provided rental assistance to 4,682 clients/households; Provided 7,815

flex funds.

The County currently funds more than \$1 million in prevention and intervention services, primarily targeting youth and families;

The Board allocated \$10 million from ARPA-1 to create the Landlord Engagement and Assistance Program (LEAP) to provide landlord and tenancy supports and short term rental subsidies to help people quickly exit homelessness and sustain housing. LEAP will launch in the fall of 2022, and aims to augment other re-housing programs to help households quickly divert from homelessness;

In partnership with SHRA, the County launched the Sacramento Emergency Rental Assistance (SERA) program, providing one-time financial support totaling almost \$67 million to almost 7,800 families at risk of losing housing as of May 2022;

Over the past several years,

there have been regulatory, policy changes and new investments that have allowed the County to build out services out for foster youth and youth aging out of the system to prevent them falling into homelessness. The County has increased participation in Independent Living Programs, Transitional Housing Programs and Voucher supports for youth as well.

Point in Time Count by the Numbers:

The overall count increased 67% from 5,570 (2019) to 9,278 in 2022. While the overall number of people has increased, the percentage split of sheltered vs unsheltered - 28% vs 72% respectively, hasn't changed; which is indicative of increased bed capacity over the last three years;

Those reporting chronic homelessness has more than doubled. Chronic homelessness is defined as long periods of homelessness and the presence of a disabling condition such as behavioral health issues or drug addiction-1) Nearly 50% of those experiencing homelessness are considered 'chronic'; 2) 58% of unsheltered report disabling conditions vs. 40% in 2019; 3) 74% of the unsheltered population reports being homeless continually for more than a year.

There was a substantial rise in vehicles counted - in 2019, 200 vehicles were counted; in 2022, 1,100 vehicles were counted equating to 1,782 people. The report also notes the new trend of "vehicle encampments";

In addition to the Point in Time count, the report also provides an annualized count of person that experienced homelessness at some point in the last year - up to 22,000.

Track Club Hosts 2 Huge Track and Field Tournaments

RANCHO CORDOVA, CA (MPG) - The Rancho Cordova Track Club has hosted two very large track & field events this June, The Golden West Invitational and the USAFT Pacific Association Championships. These events turned out to be extremely successful.

After decades of absence, Rancho Cordova has burst on to the state's youth track and field stage. Cordova High School has been blessed with a track and field that has professional level 48-inch-wide running lanes. These are required for state and regional track meets that other high schools don't have the facilities to host.

Additionally, last year, the City of Rancho Cordova funded, and the school district allowed the construction of new track and field throwing facilities at Cordova High School including a completely rebuilt and enlarged shot put throwing area, and a new hammer & discus throwing cage. These changes allowed the Rancho Cordova Track Club to host the internationally known Golden West Invitational track meet at Folsom Cordova Unified School District's Cordova High. In addition, other USA Track and Field meets (USATF) are being held at Cordova High.

USATF is the official national organization for track and field in the United States. It is a part of the U.S. Olympic Committee. The events being hosted at Cordova High School's track allow our local youth to participate in USATF track meets that could eventually qualify them for participation in the USATF National Junior Olympics. Indeed, last year two Rancho Cordova Track Club (RCTC) athletes - Gian Gonzalez and Charles Sander - qualified for competition in the Junior Olympics which were being held in Jacksonville, FL in 2021.

This year the Junior Olympics are being held at Hornet Stadium, at Sacramento State, so there is extra impetus to qualify for competition on the ultimate national state for track and field events.

Each of these large track meets draws in thousands of people, who stay in Rancho Cordova hotels, eat at Rancho Cordova businesses and shop at Rancho Cordova stores. This is a form of economic development, but it's also a community benefit, an added amenity, a means of improving Rancho Cordova's reputation in the region and state and a critical opportunity for our youth.

"This is one of the most exciting developments of the last decade, having a local track club to offer these opportunities to


our youth," said Rancho Cordova City Councilmember David Sander, a Jesuit High School track and field throwing coach and RCTC coach. "When you think about this opportunity, combined with a tremendous sports legacy of Cordova High School and the new and soon to be open Rancho Cordova youth center, the future for kids in our community is incredibly bright!"

Standout performances by the Rancho Cordova Track Club Athletes at the **Golden West Invitational GWI include:** Charles Sander 17/18 Boys Javelin 3rd place; Gian Gonzalez 17/18 Boys Hammer 3rd place; Lauren Riley 17/18 Girls Javelin 5th place; Jaylan Barcenas 15/16 Boys 100 meters 5th place; Gabrielle Devlin 13/14 Girls High Jump 1st place; Jazelle Johnson 11/12 Girls 100 meter and 200 meters.

"The goal is to get more kids active and learning while they are involved in these incredible events of track and field," said Josh Gruver, head coach of the Rancho Cordova Track Club. "Every kid has the potential to perform and succeed here. Whether you throw something like a shot, discus, javelin, or hammer; or jump high or long, pole vault, or run distances, sprints, relays or hurdles – there is something here for every kid. And when they do well here, they also improve their outcomes in the classroom and in life."

There were some interesting things which were said about the Governor's budget and how many things were done on the last day. The news said that many of the bills were changed during the last day of the budget. None of the public had a chance to see what the changes were. They wanted to be sure that the budget will be ready by July 1. That kind of change was done to us on the last day of legislation on August 1992. That was when an addition was added to a bill that had nothing to do with the bill itself. An attachment to a bill which was done by the county lobbyist, put in "Revenue Neutrality." It was put in to stop as many new cities being created in the state as possible.

That piece of legislation wasn't seen or heard in any committee, nor was it known of by the citizens. It was part of a bill that had nothing to do with local government. They just wanted it to pass, and it did. It was signed by the Governor and the new government code went into affect on January 1, 1993. Because of that new government code there have only been 12 new cities in California during the last 19 years.

There were 470 incorporated cities as of December 31, 1992. They began in 1850, and the finances that the cities collected didn't change until January 1, 1993. There were 3.3 new cities every year for 142 years. I am very glad we were one of the 12 new cities which began over the last 19 years. So as I said last week, Happy 19th Birthday/Anniversary to the City of Rancho Cordova on July 1, 2022.

And Another Thing Food Waste Recycling Program

Going on to something else, I was wondering about what we have been hearing about, but not seeing or receiving. That is something called "Residential Food Waste Recycling". I signed up for the Rancho Cordova News which provides quite a few bits of information. The food waste recycling was part of the news, and I think it can be helpful so I included it in my column.

"On July 4, 2022, the City of Rancho Cordova will launch a Food Waste Recycling Program to comply with a new state law, Senate Bill 1383. This program will help reduce greenhouse gas emissions and the effects of climate change, which include severe drought, warmer temperatures, increased wildfires, and severe storms.

During the first week in May, Rancho Cordova residents will receive detailed information about the Food Waste Recycling program in the mail. You can also access this information in Spanish and Russian.

In June and July, residents will receive a kitchen pail, booklet and compostable bags delivered to their homes.

Food Waste Recycling will begin on July 4, 2022 and is as easy as 1 -2 -3. Click the "How Do I Recycle My Food Waste?" There is a link for more information." More information like the link can be found in the Rancho Cordova News about the recycle, etc.

How Taxes are Decided in California

Let's start with the premise that taxation is largely arbitrary.

Despite efforts to frame tax policy in moral or at least philosophical terms, what or who is taxed and the form and level of that taxation merely reflect current political priorities.

Take, for example, South Lake Tahoe, a small city that sits on California's border with Nevada. If you live in that city, you pay the nation's highest state income taxes. However, if your home is located a few feet to the east, inside Douglas County, Nevada, you pay no state income taxes.

That explains why there's a steady rivulet of high-income Californians resettling in Nevada, or at least changing their official addresses. If a couple of pending California ballot measures are approved in November, state taxes on the wealthy will increase even more and Nevada will become an even more popular tax refuge.

California's income taxes became the nation's highest through a series of incremental decisions made by legislators or voters and they now provide more than two-thirds of the state's general fund revenue. Nevada, on the other hand, makes do without taxing incomes.

So which state is correct? Neither. They just happened to take different taxation paths for different reasons.

The arbitrary nature of taxation is evident, too, within the California revenue system, particularly in sales taxes.

One oddity is that cold food is not subject to taxation but hot food is and the differential can be very difficult to sort out. Some years ago, a movie theater chain asked the state Board of Equalization to shift popcorn from being a taxable hot food to a tax-free cold food. The rationale was that by the time theater patrons returned to their seats with popcorn in hand, it had turned cold. The board agreed.

If someone buys computer software, such as Turbo Tax, in a store to file federal and state income tax returns, that purchase is subject to a sales tax. But if a large company obtains a custom computer program to prepare its tax returns, the purchase is free of sales taxes. Why? Because those who sell custom software lobbied the Legislature for an exemption in the 1980s.

The Legislature, at the behest of Gov. Gavin Newsom, is on the verge of enacting a new and especially questionable tax anomaly.

One budget trailer bill would impose a hefty new tax on the embryonic industry of extracting lithium from the brine of the Salton Sea in the Southern California desert. Lithium is the key ingredient of long-life, rechargeable batteries used in everything from cellphones to electric cars and immense electrical energy storage banks and therefore plays a key role in the state's drive to make itself carbon-free.

Most lithium is imported from other countries, including China. The Salton Sea, however, is a potentially huge source of the mineral that, if developed, would both contribute to energy independence and create many new jobs in an economically depressed corner of the state.

Lithium companies have warned that taxing extraction, \$400 to \$800 per metric ton, would make California lithium more expensive than imports and discourage investment in the industry, but were ignored.

Another trailer bill, however, would give sellers of legal marijuana a hefty cut in taxes, responding to their complaints that taxation makes their product too expensive vis-à-vis pot from illegal growers and sellers.

So California politicians may be strangling an industry vital to their vision of a carbon-free future while encouraging – in essence, subsidizing – an industry that helps people get stoned.

That's about as arbitrary as it can get.







Defendant Sentenced for Human Trafficking, Prior Strike for Animal Abuse

Sac County DA News Release

SACRAMENTO COUNTY, CA (MPG) -On June 20, 2022, the Honorable Carlton Davis sentenced Lamar Robinson to 16 years in prison and ordered him to register as a sex offender for life.

On May 17, 2022, Robinson pled to human trafficking of a minor and admitted to a prior strike conviction for animal abuse with the use of a deadly weapon.

In 2021, Robinson met the 13-year-old victim. The victim's family repeatedly told Robinson her age. Despite this, Robinson

groomed the victim with promises that he loved her and that they would have a life together. He induced her to run away from home and to begin engaging in prostitution. Robinson gave the victim detailed directions about how to make money through selling sex and demanded that she give him her money.

On November 14, 2021, Sacramento police officers stopped Robinson while he was driving with the victim in the car. Robinson was on parole at the time and when officers searched his cell phone, they found evidence of his exploitation of the victim. Officers arrested Robinson and took the victim to a safe place.

In the prior 2017 strike case, Robinson used a leash to repeatedlv body slam a small dog against the ground. Robinson was also holding a second dog by its neck, and that dog appeared unconscious. The dogs suffered several injuries, and a radiograph of both dogs revealed multiple rib fractures in different stages of healing. **Defendant Sentenced to Prison**

for Felony Animal Abuse The Honorable Lawrence Brown sentenced Lamar Robinson to 4 years and 8 months in prison after Robinson pled to 8 counts of felony abuse.

On December 12, 2017, an apartment tenant was awakened to the screams of an animal. When the tenant went to her window, she witnessed Robinson repeatedly body slam a small dog against the ground, using a leash to increase the impact to the pavement. Robinson was also holding a second dog by its neck, and that dog appeared unconscious. The witness called 911 and Sheriff's Deputy Brian Fowell responded. Robinson

was arrested after the deputy encountered him 'walking' two dogs with obvious injuries, including a broken leg.

Radiographs of both dogs revealed multiple rib fractures in different stages of healing. Surveillance footage captured part of Robinson's horrific crime.

The case was prosecuted by the recently formed Sacramento County District Attorney's Animal Cruelty Prosecution Unit, the Sacramento County Sheriff's Department and Sacramento County Animal Care and Regulation. *

Defendant Convicted of Attempted Murder in Drive-By Shooting

SACRAMENTO COUNTY, CA (MPG) - Ladarius Murphy was convicted by a jury of attempted murder and discharging a firearm from a vehicle. The jury also found true allegations that Murphy intentionally discharged a firearm causing great bodily injury.

On May 12, 2016, the victim was walking to school when a gang member drove by and threw up gang signs. That gang member's girlfriend went to the same school and texted him saying there were "suckas" at the school. Later that day, the gang member, his girlfriend and Ladarius Murphy drove near the school and saw the victim.

Murphy leaned out of the front-passenger window and fired 6-8 shots at the victim from a 9mm handgun. The victim was struck in the arm and torso but survived. The gang member's car was quickly identified by the Sacramento Police Department and his girlfriend later identified Murphy as the shooter. Murphy was arrested on an unrelated case and his prints and DNA matched evidence from the car involved in the shooting. The gun used in the shooting was never recovered.

Murphy faces a maximum sentence of 34 years to life in prison. Sentencing is set for August 26, 2022, at 1:30 p.m. in Department 32 before the Honorable James Arguelles. *

Defendant Sentenced for First-Degree Murder of 17-Year-Old

Sac County DA News Release

SACRAMENTO COUNTY. CA (MPG) - The Honorable Marvanne Gilliard sentenced Curtis Slaton to life in prison without the possibility of parole.

On April 22, 2022, a jury convicted Slaton of the first-degree murder of 17-year-old Jaylen Betschart. The jury found true the special circumstance of firing from a motor vehicle and the allegation that Slaton personally discharged

a firearm causing death. The Court also found true an allegation that Slaton has a prior strike conviction for carjacking.

On October 3, 2020, Sacramento police officers found the victim in his car that had crashed into a utility pole on Jackson Road and Florin-Perkins Road. He had been shot once in the back. Investigators obtained surveillance video from several locations that showed the suspect car chasing the victim down Jackson Road with the shots fired just before the

intersection. Investigators identified the car as belonging to Slaton and located the car at Slaton's residence later the same day. A search warrant at Slaton's residence recovered a Glock handgun that was found in another vehicle parked at the residence. Casings left at the scene at Jackson Road and Florin-Perkins Road were later found to match the recovered handgun. Further investigation revealed additional evidence that Slaton was the driver of the suspect car and the shooter. \star

Continued from page 1 criminal element from within the homeless camp that scales the six-foothigh brick wall in the back of the facility after the sun has gone down. Anything that isn't nailed down, residents say, is stolen. The theft list includes bicycles, heavy ornaments decorating the outside of homes and even a laptop computer. Locked sheds are also targeted for theft.

Numerous residents shared stories of noise, drug use, loud music, screaming, assaults, and unwanted visits from homeless camp visitors. Late night pounding on doors and windows isn't uncommon. One homeless man tried to make his home under a trailer. Another resident claims she made the mistake of opening a late-night knock on her door, only to be confronted by a homeless man who demanded she provide him with blankets and a pillow.

An attorney representing the management company, which receives roughly \$850 per month from each resident for management and security services, is familiar with the homeless camp. Joseph Carroll says the camp is not on land owned by MCC, and his client "has neither the power nor authority" to clear it out. "The homeless and housing shortage crisis in California has affected all property owners, whether it be a gated manufactured housing community like Mobil Country Club, an apartment complex, or a single-family residential home," Carroll said in a statement to Messenger Publishing. "Mobil Country Club has nighttime security, which patrols the community multiple times each night, a 6-foot concrete wall surrounding the park, security cameras at the front entrance of the park, and a full-time community manager."



can't be removed by property management-or law enforcement.

patrols do not deter homeless from entering the grounds.

"They don't do their job," said one resident. 'We caught a homeless person in the park and security refused to kick him out."

Several MCC homeowners are banding together to fight back over frustration and mounting fears that come from non-stop noise and crime. Resident John Hunepohl has drafted, and residents have signed, a petition titled: "Seeking Relief for Our Abused Senior and Elderly Residents."

The petition, which will be presented to the Sacramento County Board of Supervisors during the July 13 meeting, reads, in part: "We believe that our elderly have a legal right to occupy their homes in peace and quiet as defined in California Health and Safety Code." Rancho Cordova City Manager Cyrus Abhar says he is just as frustrated as homeowners in the MCC park. However, he says federal and state legal restrictions limit what actions the City can take. Mobile Country Club is within Rancho Cordova city limits, but the Citrus Road bike path, where the homeless camp sits, is on Sacramento County land. "Homelessness is one of the top issues that I have to deal with on a daily basis," Abhar told Messenger Publishing. "I am an avid bicyclist. I use that Citrus Road path. I see the problem. I am MCC's biggest advocate."

cited by both Abhar and Carroll is a 2018 ruling by the 9th U.S. Circuit Court of Appeals. That ruling stops cities like Rancho Cordova from removing camps from public land like the Citrus Road path, unless the city or county provides adequate shelter for the homeless that live there.

Relief can't come soon enough for some residents. Many, like Michele Fors, are confined to wheelchairs. This means they are forced to use the bike and pedestrian access path behind MCC to go shopping or obtain needed medications.

"It's like running the gauntlet," Fors said. "I haven't been touched, but I am subject to plenty of verbal abuse.'

"The City of Rancho Cordova did take action to clean up the drainage area next to the Citrus Road path because the overgrown bushes and trees served as great hiding spots for criminals," Abhar said. "At the same time, I think the county can potentially do more."

Targets for Crime, Abuse, Aggression Sacramento selects Keegan **Murray in 2022 NBA Draft**

SACRAMENTO, CA (MPG) -Anxious Kings fans waited outside the Golden 1 Center on Thursday afternoon in scolding 100-degree weather to see who the team would select in the 2022 NBA Draft.

NBA Commissioner Adam Silver stepped to the podium around 5:30 p.m. PST and announced, "With the fourth pick in the 2022 NBA Draft, the Sacramento Kings select Keegan Murray from the University of Iowa."

The reaction among the hundreds of Kings faithful that braved the heat to witness what could be a franchise-altering selection was mixed, to say the least.

As a sophomore with the Hawkeyes, Murray was selected to the All-Big Ten first team after averaging 23.5 points, 8.7 rebounds, 1.5 assists, and 1.3 steals in just under 32 minutes a game in 35 starts. He made a huge leap in scoring from his freshman year, increasing his points per game by 16.3, which is the largest increase in PPG by a Big Ten player in the last 25 seasons.

"Keegan Murray was the best player available and we jumped at the chance to select him," McNair said in a press conference after the draft. "I think as we went along, and certainly as we got into the final days, it was just apparent to us that if Keegan Murray was there, that was going to be the best course of action for us."

The 21-year-old ranked fourth in the country in scoring average and first in total points (822) and field goals (307). He also displayed his versatility last season as the only collegiate player with at least 50 dunks and 50 3-pointers. Murray is the highest drafted player in Iowa history and the first Hawkeye to be selected in the first round of the NBA Draft since 1998.

At 6-foot-8 and 215 pounds, Murray cemented himself as one of the best power forwards in the nation in the 2021-22 season, winning the Karl



Malone Power Forward of the Year Award. Murray was also named a consensus first-team All-American and the Big Ten Tournament Most Outstanding Player.

In the second round of the draft, Sacramento was scheduled to pick at No. 37 and No. 49. However, McNair traded away both picks on Thursday, dealing the latter first. Just before 10 a.m. PST, the Kings exchanged the 49th pick for the rights to Sasha Vezenkov and cash consideration from the Cleveland Cavaliers, according to McNair. The 26-year-old was a first-team All-EuroLeague selection in 2022 and was selected 57th overall in 2017 by the Brooklyn Nets.

'Sasha, certainly the intrigue with him is his size with his shooting," McNair said. "Somebody whose hit threes at a high clip but also can playmake and just shows his feel out there on the court. The fact that he's done it at arguably the second-best league in the world at an age where he's just entering his prime, we love to see that."

Sacramento waited until they were on the clock at No. 37 to trade the other second-rounder. The Kings traded the pick to the Dallas Mavericks for two future second-round picks, according to McNair. NBA insider Marc Stein reports that the picks are for 2024 and 2028.

Following the conclusion of the draft, Sacramento reportedly agreed to deals with two undrafted free agents. The Kings agreed to a two-way deal with shooting guard Keon Ellis from Alabama, The Athletic reported. Sacramento agreed to terms with forward Jeriah Horne from Tulsa, as reported by Yahoo Sports.

Anyone who does not enroll in Part B, when they were first eligible, can only enroll in Part B from January 1-March 31 which is Medicare's General Enrollment Period, and the Medicare Part B will begin on July 1st.

Confusing, isn't it? I do not know why they (Medicare) cannot make this simpler, but that is Washington for you!

People need to understand that Medicare is not a cookie cutter situation, and one size does not fit everyone's Medicare health insurance needs.

Beware and Report Scams

RANCHO CORDOVA, CA (MPG) - There are a number of scams to try to steal your money and personal information. Scams may come through phone calls from real people, robocalls, text messages or email.

Scammers make false promises, such as opportunities to invest your money or buy products, offer you money through free grants and lotteries, or even call with threats of jail or lawsuits if you don't pay them.

RCPD wants to offer these tips to help you identify and protect yourself from scams.

(1) Hang up on suspicious phone calls, and block suspicious phone calls and text messages. Unwanted emails or emails from unknown senders could be an attempt to collect your personal information;

(2) Be cautious of caller ID. Scammers can change the phone number that shows up; (3) Never provide any credit card, Social Security or bank information; (4) Never provide passwords, PINs or account numbers; (5) Never believe promises of easy money. If it sounds too good to be true, it most likely is, especially if coming from an unfamiliar requester; (6) Never pay someone who insists you pay with a gift card, by using a money transfer

service, by depositing a check, or by sending money to someone; (7) If the caller identifies themselves as a bank, call customer service to verify what is being asked; (8) If the caller identifies themselves as a charity, make sure it is a reputable charity. A quick Google search should verify the legitimacy; (9) If the caller is requesting money transfers regarding a relative in trouble, independently verify the status of the family member; (10) Resist pressure. Legitimate companies, charities, government agencies, etc. will be happy to give you time to make a decision. If in doubt, pause and talk to someone you trust; (11) Register your phone number with the National Do Not Call Registry at DoNotCall.gov or by calling 1-888-382-1222 (TTY: 1-866-290-4236). If you still receive telemarketing calls after registering, there's a good chance that the calls are scams.

Rancho Cordova, Report! If you have been scammed or think you have been scammed:

File a report with local law enforcement; Obtain a copy of any records of the money transfers; File a report with the Federal Trade Commission at ReportFraud.ftc.gov.

Ham Radio Operators Help Save Lives

SACRAMENTO REGION, CA (MPG) - When the Loma Prieta Earthquake struck the greater San Francisco Bay Area in 1989, it knocked down power lines and knocked television and radio stations off the air. Phone lines were disrupted, and cell phone service died. However, they stepped in and helped save the day.

The same scenario played out 16-years later when Hurricane Katrina struck New Orleans and the surrounding area. Once again, television sets and radios died. The power went off. Standard telephone service and cellular service stopped working. But, once again, they stepped in and provided emergency communication.

Who are they? These men and women are all members of the same group who belong to the American Radio Relay League (ARRL). These people are all radio amateurs, who are also better known as Ham Radio operators. Despite the recent rise of the internet, the hobby of ham radio, which is more than 100years old, is alive and well.

The ARRL International Field Day took place in multiple cities and countries this past weekend, including Sacramento. This year's event was hosted by the California Department of Technology headquarters located in Rancho Cordova. State authorities know all too well from multiple

experiences that when emergencies strike, it's the independent ham operators who can be relied upon when emergency communications are needed.

Alice Austin likes to help people. That's why she became a member of the local Friends and Amateur Radio Communications Enthusiasts (FARCE) group and helped to organize this year's field day.

"It's important to me to lend a hand in any kind of emergency," Austin told Messenger Publishing. "The purpose of our field day events is to make sure our operations are intact and our radios work. We try to contact other ham radio operators located all over the world."

Hobbyists include military veterans like Dennis Merritt, who served tours in both the U.S. Navy and Army. He is better known in the ham community by his FCC assigned license name of W6UHQ. He started his field day experience by contacting other ham radio operators in places like Bozeman, MT, Boise, ID and Portland, OR.

"People like us can contact hospitals, emergency providers and other businesses when all other forms of communications fail," Merritt said. "We are there to help when people need us, but it's also fun to keep in contact with our counterparts in other parts of the world."

Merritt says wildfires that have recently plagued California is another example of where ham radio operators can play a crucial role in getting people out of danger. A Los Angeles Times article found that emergency warnings never reached many people in Paradise, CA during the 2018 Camp Fire because cell towers and power lines had been knocked out. The fire killed more than 80 people.

"The idea behind ARRL Field Day is practice," Austin said. "It encourages us to be prepared, to stay prepared and to encourage other people to join us."

Can Sanity Prevail in California?

Victor Davis Hanson is a resident scholar at the Hoover Institute and lifelong Californian from the Central Valley. He recently spoke at a conference of Howard Jarvis Taxpayers Association members. For the naïve who want an optimistic presentation about how great California is, VDH is not your guy. He gives an accurate, if depressing, view of the current state of the state. In both his writings and speeches, he assesses just how far California has deteriorated; from homelessness, poverty, cost of living, crime, taxes, business climate, etc., ad nauseum.

The decline of California has, as most know, led to an unprecedented exodus out of the state. So much so that for the first time in its history, California has lost representation in Congress. In addition to the 2 million people who have already left California, far more are seriously considering it. Facebook now has a group called "Life after California" with rapidly growing membership, but most Californians are unlikely to leave, at least anytime soon. They will stay either because they are willing to tolerate all that is wrong here, or they are not able to leave.

A Central Valley farmer isn't going to pick up his orchard and move to Texas, neither is the retired couple who want to stay close to family members, including grandchildren but simply because tens of millions will stay in California does not mean they are oblivious to its ills.

Those deciding to stick it out here in the formerly Golden State are constantly on the lookout for some faint signs that things might get better. The primary election returns might provide such a sign, although it would be foolish to believe there has been a political sea change.

First, the good news. It now appears that voters in the most liberal city in America have had it with rising crime. Given that you can count the number of Republicans in San Francisco on two hands, the rejection of the city's District Attorney, Chesa Boudin, certainly wasn't a partisan fight. San Franciscans of all political stripes simply felt unsafe on city streets as tens of thousands had their cars or homes broken into. It doesn't take a conservative to want serious criminal acts to result in serious criminal penalties, including incarceration.

The similarly Soros-backed

district attorney of Los Angeles, George Gascón, wasn't on the ballot, but it appears he is in deep trouble as he tries to deflect a recall of his own. Also, L.A. mayoral candidate Rick Caruso, previously a Republican and now registered in the Democratic party, is headed to a runoff against progressive Democrat Karen Bass, currently in Congress and previously Assembly leader.

As in San Francisco, crime and homelessness are top issues.

Throughout California, even within Democrat-on-Democrat races, the more moderate candidates seemed to be outperforming their more progressive counterparts, although many races remain too close to call.

Whether California's election results represent a meaningful shift away from radical progressivism or merely a blip in the relentless leftward movement in California is the subject of a national debate. Even the New York Times wrote that the recall of Boudin was "a stark warning to the Democratic Party."

It is way too early to predict a significant return to sanity in California, and November's election results will be more telling. But for now, even a slight movement toward responsible politics is a welcome change.

As the Chinese proverb reminds us, a journey of a thousand miles begins with a single step. \bigstar


