RANCHO CORDOVA, CA (MPG) - Rancho Cordova's vibrant iFest international festival made a colorful return Saturday with a butterfly release, camel rides and cultural performances from around the globe, bouncing back with thousands of happy attendees after a two-year pandemic hiatus.

Sponsored by the Cordova Community Council, and packing Village Green Park, iFest is intended to showcase and celebrate the rich cultural diversity of Rancho Cordova by encouraging cultural groups to display their heritage.

Stage performances featured native dance and music from more than a dozen countries, including China, Korea, Italy, Croatia, Ireland, India,

Lebanon, Egypt and Mexico. The ever-changing entertainment was hosted by Andy Gee, who guided the

audience on a musical world tour.

A special tribute honored the inspirational people of war-torn Ukraine, which was followed by a performance by Rancho Cordova Ukrainian Bandura musicians, including one who had moved to Rancho Cordova from Ukraine just three weeks ago.

Elsewhere, the Koreana Plaza International Market sponsored tastes from around the globe at "Wines of the World," while children pounded away at piñatas, visitors were adorned with Henna art, scaled a climbing wall and smiled for caricature artists.

"No other event showcases the warmth and welcoming hearts of Rancho Cordova than does iFest," said Shelly Blanchard, executive director of the Cordova Community Council. "It's a day to embrace not

Voting has Officially Begun

Sac County News Release

SACRAMENTO COUNTY, CA (MPG) - Voter Registration and Elections (VRE) has begun delivering Vote by Mail (VBM) ballots to the U.S. Postal Service for distribution to all currently registered voters in the County for the June 7, 2022, Statewide Direct Primary Election.

Voters may use any Ballot Drop Box throughout the County to return their ballot. VRE has a drive-through Ballot Drop Box in the Election's Office parking lot at 7000 65th Street, Sacramento. This Ballot Drop Box is open 24 hours a day, 7 days a week until 8:00 p.m. on Election Night.

Voters are encouraged to return their ballots early and sign their pink VBM envelope in order for their ballot to be counted. Information on the days and hours of operation for Ballot Drop Boxes or upcoming Vote Centers is available on the VRE website at <http://www.elections.saccounty.gov> or use the direct links in the Key Election Dates below. No postage is necessary for voters returning their ballots by U.S. Mail using the pink Vote by Mail envelope.

For more information, contact VRE at (916) 875-6451, email voterinfo@saccounty.gov, or use the toll-free voter assistance hotline at (800) 762-8019. The hotline has the ability to connect voters with disabilities with TTY (Text Telephone).

Key Election Dates

Monday, May 9: Mailing of ballots to all registered voters has begun. Voted ballots may be returned in any of the Ballot Drop Boxes located throughout the County.

Monday, May 23: Close of voter registration for this election. Voter registration forms must be postmarked by this date or delivered to the VRE Office at 7000 65th Street, Suite A, Sacramento, CA 95823 by 5:00 p.m. Online voter registration must be completed before midnight on this date at www.registertovote.ca.gov.

Tuesday, May 24: Conditional Voter Registration (CVR) begins.

Saturday, May 28: 11 Day Vote Centers open.

Tuesday, May 31: Last day a Vote by Mail (VBM) ballot can be mailed to you. After this date, VBM ballots are only available at the VRE Office or at any of the 87 Vote Centers.

Saturday, June 4: All Vote Centers open throughout the County.

Tuesday, June 7: Election Day. ★

"This year students have been in person for the whole school year. They've been able to participate in not only the regular academic instruction, but also their co-curricular activities."

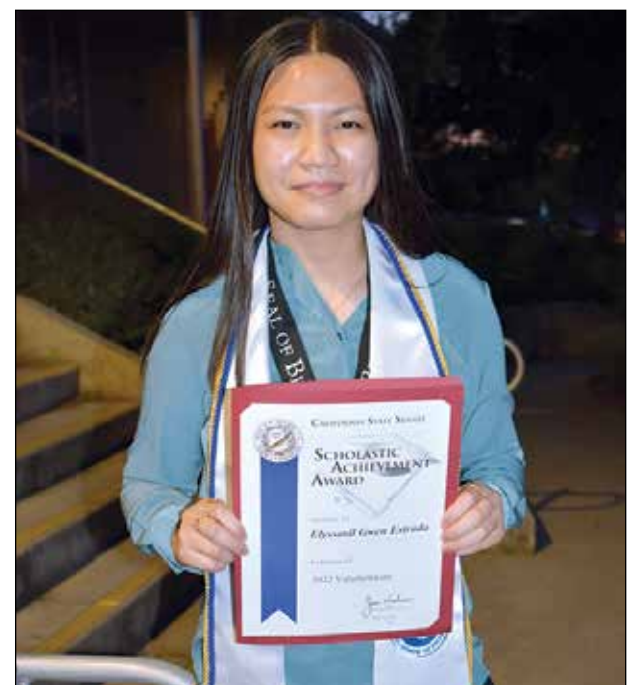

Trash and Debris Removed by Volunteers During Spring Clean-Up

SACRAMENTO, CA (MPG) - More than 400 volunteers removed over 13,450 pounds of trash and debris from the American River Parkway (Parkway) during the American River Parkway Foundation's (Parkway Foundation) Spring Clean-Up on Saturday, April 23. That's more than 33 pounds per volunteer.

Spring Clean-Up is the Parkway Foundation's second largest clean-up of the year and took place at eight locations along the Parkway this year, including: Discovery Park, Northgate Parkway Access, Cal Expo Parkway Access, Northrop Parkway Access, Howe Avenue River Access, Watt Avenue River Access, River Bend Park and the Upper Sunrise Recreation Area. This is the first time the clean-up has been held since 2019.

"We love and appreciate our volunteers. These are families and involved community members that are giving up part of their Saturday to help us conserve the American

River Parkway," said Dianna Poggetto, Parkway Foundation Executive Director. "We would not be able to make the impact we do without their dedication."

Some of the most interesting items found during the clean-up: The Sacramento Bee newspaper dispenser, a unicycle, a toy gun, a plastic barrel, shopping carts and electric scooters.

In addition to Spring Clean-Up, the Parkway Foundation hosts the Great American River Clean Up. This event takes place along all 23 miles of the Parkway and will be on September 17 this year. These large clean-ups are complemented by smaller group clean-ups the Parkway Foundation hosts year-round to form the Parkway Foundation's Clean-Up Program. Last year, more than 138,000 pounds of trash were removed by Parkway Foundation volunteers through this program.

And Another Thing

May 15 Can Mean Different Things to Different People

I began working on this column on May 15, 2022. It will appear on the May 20, 2022 Grapevine Independent. The date of May 15 means different things to different people.
