

Golden **State Water Advises** Customers of Emergency Drought **Declaration**

SACRAMENTO, CA (MPG) - Golden State Water Company (Golden State Water) is advising customers in its Clearlake, Bay Point and Arden Cordova (Arden, Gold River, Rancho Cordova) service areas of the state of California's emergency drought declaration that was expanded on May 10, 2021, to include Lake, Contra Costa and Sacramento counties. Customers in these communities, and throughout the state, are encouraged to continue using water responsibly and make water conservation an important part of their every day.

Additionally, the Sacramento Regional Water Authority (RWA) 1s encouraging all customers in the Sacramento region to voluntarily reduce water usage by 10 percent to help preserve the region's water supplies and protect local fish populations. "Our customers did a tremendous job reducing water use during the last drought, and most of them have continued those water-efficient practices and done a nice job making conservation a way of life," said Paul Schubert, General Manager of the Northern District for Golden State Water. "This week's announcement expanding the emergency drought declaration to include Lake, Contra Costa and Sacramento counties is consistent with what the data is telling us. These areas are experiencing various levels of drought, and we must all work together to help protect water supplies." Customers are asked to limit outdoor irrigation and refrain from watering lawns and gardens during daylight hours to reduce the amount of water lost to evaporation. Additionally, customers are reminded that the following practices that waste potable water are prohibited in California: Hosing off sidewalks, driveways and other hardscapes. Washing a motor vehicle with a hose, unless the hose is fitted with a shut-off nozzle. Operating a fountain or decorative water feature, unless the water is part of a recirculating system. # **Search Dog Rescue Program**

SACRAMENTO COUNTY, CA (MPG) - Sacramento County's Bradshaw Animal Shelter intakes thousands of pets in the community each year. Most of these pets are reunited with their owners or are able to find loving forever homes to be adopted into. However, some shelter pets have a difficult time finding a normal adoptive home which is where the shelter's foster and rescue program steps in. The foster and rescue program works with local foster and rescue providers in the community to help shelter pets that need a little extra assistance on the way to their happy ending.

Foster care providers provide temporary care outside of the shelter to animals such as those too young for adoption, needing to recover from an illness or injury, for behavior modification, or just because they need a break from the stresses of shelter life. Rescue group partners are also a huge help as they pull shelter animals who otherwise have a difficult time being adopted due to age, medical condition or the need for behavioral modification that cannot be resolved in a foster home.

Recently, a shelter dog named Chapo was having a difficult time finding the perfect home to suit his mental and physical stimulation needs. After a month of no luck with potential adopters, shelter staff Malinois would never be happy in a pet-only home due to his high energy,

So, they reached out the National Disaster Search Dog Foundation (NDSDF). NDSDF is an organization based in Santa Paula, California that strengthens disaster response across America by rescuing and recruiting dogs and partnering them with firefighters and other first responders to find people buried alive in the wreckage of disasters.

"Groups such as NDSDF give dogs that have no chance of placement in a normal pet home an opportunity for a great outcome and a chance to truly thrive in the world," said Shasta Stratton-Quirk, the shelter animal care attendant who reached out to the rescue. "Because some dogs are not able to be adopted out through normal routes, it is the job of the foster and rescue team to find an outlet where they can reach their true potential. We cannot wait to see what the future holds for Chapo!"

Thanks to the shelter's rescue partners and the care and dedication of our shelter staff, Chapo is on the path to have a greater purpose to help save the lives of others. In the meantime, NDSDF is letting him settle into his new environment. They report that Chapo is working on obedience training and manners, learning fitness exercises, playing with and meeting his trainers, and will enjoy a trip to their "doggy day spa" where he will receive a well-deserved bath and nail trim.

Three of the club's four steam engines are over 40 years old and another was completed just a few years ago. At 1/8th scale these steam and diesel engines are identical to their fullsize counterparts, faithfully recreating all the characteristics of their prototypes. They are real operating locomotives, just smaller.

"Since this is a hobby for us, most take several years or more to build. Even when they are built, they are never completely done. Additional details and improvements continue to be added over time," he said.

New members are always welcome, Berchelli said. "We first train our new members to become a conductor and how to properly load our passenger trains," he said.

"Members then move on to learn how to be an engineer on our diesel trains.

Once they become comfortable, they can then learn steam operation. Operating a steam engine requires much more hands-on teaching," Berchelli said.

Physical improvements of the layout continue. New track side buildings and a memorial to honor and remember past members have been added. While the main railroad line is most likely to remain the same, original aluminum rail and wood ties are being replaced with steel rail and composite ties for better durability.

"My overall goal for the club is to continue to improve the quality of our layout for the public to fully enjoy," Berchelli said.

Club members have planted hundreds of California native plants and teamed up with members of the Sacramento Tree Foundation to help plant an additional 120 trees around the layout.

An irrigation system has also been completed to improve and manage water consumption.

## Set Afloat in a Tough Year

**RANCHO CORDOVA, CA (MPG)** Opening a new brewery can be hard. Opening a new brewery in the middle of a pandemic is very hard - as the owners of one of Rancho Cordova's newest breweries attest and celebrate their One Year Anniversary Grand Opening and Ribbon Cutting on June 18-20, 2021, starting at 12 noon of Friday.

Risse, owners of LogOff Brewery, were originally tech guys who enjoyed brewing their own beer as a hobby. Risse said he had never tried a beer Noss made that he didn't like. Once they came to the realization that they knew what they were doing, they started planning to open a their desk jobs.

"It's really about our philosophy of life I think," Risse said. "We're kind of anti-stress so we believe... [in] logging off of whatever it is that's stressful in life and enjoying the things that bring you joy; and we think drinking craft beer is a great way to do that."

After building the brewery from the ground up, LogOff was set to open in March of 2020. As the pandemic hit, Noss and Risse decided to hold off on their grand opening and wait for things to die down. They both eventually realized nothing was dying down any time soon- it was now or never.

On June 10, 2020, LogOff Brewing opened community members logoffbrewing.com/

Sarah Blunt James Noss and Matt its doors with a socially distanced outdoor patio. However, due to protocols mandated days after they opened, the city stopped indoor dining and made take-out-only mandatory. Since LogOff was a brewerv, they didn't have a food menu to cater to take-out needs.

In response, the two brewery and log off from turned to their mothers, who had restaurant and food experience. Their moms began catering for the brewery daily, which kept them afloat during take-out-only mandates.

"It's been difficult navigating the restrictions... the shutdowns... mask mandates and the whole pandemic in general," Noss said.

Another challenge that LogOff faced was that they could only seat people outdoors during the heat waves and wildfires that hit from late August to early September. Smoke and heat in Sacramento made it uncomfortable to sit outside and enjoy a beer.

Luckily, LogOff has some great regulars and who have supported them through these tough times.

Beverly Littlejohn and Terry White have supported the brewery since its grand opening. As locals in Rancho Cordova, they often visit breweries in the barrel district, but now LogOff feels like their new home brewery.

"We do LogOff Thursdays every week. We meet friends and we've done that for months now. It's become our home brewery-this is our home,' Littlejohn said.

Now, Risse and Noss are working on expanding their brewery in the property adjacent to LogOff. Although it's been a long journey, they are continuing with the learning process of brewing the best beer for their customers.

"It's about the people and then also the craft itself, learning and becoming better brewers, and making better beer," Noss said.

## **Can California Shut Down Failed Projects?**

We human beings hate to admit failure. Even though our brains may know when some endeavor has failed, our emotions and our egos may drive us to continue trying to make it work.

Indeed, the syndrome has developed its own linguistic phrases, such as "throwing good money after bad," or "sunk costs," or "cutting our losses."

Private businesses are usually – but not always – willing to shut down or sell off ventures that don't pan out. Ford Motor Co. famously jettisoned the Edsel, a car named after the beloved son of founder Henry Ford, when the car failed to attract enough buyers. But the Boeing Co. stuck with an elongated ver- Brown's pet project – an sion of its 737 jetliner even online community college after two crashed and killed 346 people, and is still trying to make it acceptable.

Government officials are generally less willing to admit failure, perhaps because, unlike business executives, they have no personal financial stakes in outcomes. Their guiding, albeit informal, rule is that launching new programs enhances one's standing while shutting down those that fail just angers their stakeholders.

programs and projects that deserved merciful deaths but have continued to soak up billions of dollars in taxpayer money.

The woebegone bullet train project is the most spectacular. Voters were promised a statewide network of high-speed trains when they passed a \$9.95 billion bond issue in 2008. Thirteen years later, we have only a few concrete structures in the Fresno area - no track, no trains and no certain date when even a relatively short segment will be operative despite the many billions of dollars spent, or wasted, so far.

It would take a book – a thick book – to fully describe all of the state government's highly touted, very expensive digital information projects that have failed to deliver the promised benefits. While it lacks the scale of the bullet train and the failed information technology projects, Calbright may fall into the same category.

It's former Gov. Jerry that would offer high-quality, low-cost instruction to help working Californians upgrade their job skills.

Tens of millions of dollars have been sunk into Calbright over the past few years but it's actually provided instruction only to a few dozen students — at an enormous per-student cost, of course.

Last month, State Auditor Elaine Howle catalogued Calbright's failures, declaring that "A California's recent history primary reason...is that newspapers.

is replete with examples of its former executive team failed to develop and execute effective strategies for launching the college."

If Calbright doesn't shape up by next year, Howle told the Legislature, it should be axed. Five days before Howle issued her report, the state Assembly voted unanimously for legislation that "makes the California Online Community College Act inoperative at the end of the 2022-23 academic year."

To be fair, the legislation, Assembly Bill 1432, does not merely reflect an unwillingness to continue a project that has fallen short of its lofty goals. The bill is sponsored by the union that represents faculty at the state's 115 local community colleges and it opposed Calbright from the onset, fearing that it would undermine the existing system

However, Calbright's obvious shortcomings made it vulnerable to a political death sentence. The fight over its fate now shifts to the state Senate, or perhaps will be decided when legislative leaders and Gov. Gavin Newsom negotiate a final 2021-22 budget deal behind closed doors this month.

If Calbright is jettisoned, perhaps it would mark a new willingness to stop throwing good money after bad. Now how about that bullet train to nowhere?





## Two Arrested for EDD Fraud Totaling More Than \$600,000

#### By Shelly Orio, Sacramento County District Attorney's Office

**SACRAMENTO COUNTY, CA (MPG)** - On February 2, 2021, the Sacramento Police Department North Gang Enforcement Team conducted a traffic stop on 24-yearold Adrian Sykes and found him to be in possession of a fully automatic Glock handgun. Officers conducted a probation search of his residence and seized drugs, body armor and five additional firearms. Those firearms included a loaded Masterpiece Arms Mac-9 with no serial number, an Anderson Manufacturing AR-15, and an unregistered loaded ABC Rifle AR-Pistol. Officers also found six Employment Development Department (EDD) debit cards. At that time, Sykes was charged with six counts of being a felon in possession of a firearm, one count of possessing drugs with a

firearm, and one count of being a felon in possession of ammunition. Sykes posted bail on these offenses and was released from custody. in Las Vegas, Nevada on June 7, 2021 by agents of the Las Vegas Metro Police Department and agents from the Federal Bureau of Alcohol Tobacco and Firearms.

The Sacramento County District Attorney's Office, Sacramento Police Department, and EDD conducted a joint investigation into the six EDD cards that were located. They found that Sykes and his girlfriend, 26-year-old Brittney Murchison, had filed multiple fraudulent EDD claims. In total, 35 different fraudulent claims were filed using the personal identifying information of victims from across the country and over \$600,000 was illegally obtained.

The Sacramento Police Department North Gang Enforcement Team arrested Brittney Murchison on May 27, 2021 for committing EDD fraud. Murchison was charged with 16 counts of EDD fraud and one count of identity theft. Sykes was located and arrested

in Las Vegas, Nevada on June 7, 2021 by agents of the Las Vegas Metro Police Department and agents from the Federal Bureau of Alcohol Tobacco and Firearms. Sykes is currently in custody in Las Vegas pending extradition to Sacramento, California where he will face an additional 35 counts of EDD fraud and one count of identity theft.

According to District Attorney Anne Marie Schubert, "Law enforcement across the state has witnessed staggering EDD fraud committed by criminals and their accomplices. At the same time, we have witnessed an alarming increase of illegal firearms in our communities. This dangerous combination undoubtedly has fueled a dramatic increase in violent crime throughout the state. Sacramento's law enforcement agencies will continue to partner together to investigate EDD fraud and the additional havoc it brings to our community."

covers me and my wife. I have been told by friends that since I am still working, paying taxes and have health insurance that I do not need Part B.

A business associate, who is also selfemployed delayed his Part B because he is under his wife's employers group health insurance. I do not want to make a big mistake. Please explain the difference in my situation and my friend's.

Thanks, Bill from Tulsa, OK

#### Hello Bill:

Great Medicare question Bill, ... last week I consulted with a person that is also self-employed, but was given wrong advise about delaying his Part B. His Medicare nightmare is now starting ... Medicare does not recognize individual plans like yours as "true company" benefits with creditable prescription drug coverage for delaying your Part B. Now this fellow who is 66 will receive not only a 10% penalty for each year due to not enrolling in Part B at the right time, but a 20% penalty (2 years 65 and 66) each month for as long as he is on Medicare or should I say the rest of his life. The 20% penalty goes up as the Part B premium changes. Stinks doesn't it !!

Bill, since you currently have an individual health insurance plan not "true group" health insurance, I would recommend that you enroll in Part B during your "Initial Enrollment Period". Many believe that Medicare is automatic, this is only true if you are receiving your Social Security check when you turn 65.

Not working full time with true company benefits is what Medicare looks for to keep from giving you the 10% per year or 12-month period Part B penalty.

If you are not receiving your Social Security check and want your Medicare to begin the 1st day of the month you turn 65, you can sign up for Medicare anytime during the 3 months before your 65th birthday. Go online to www.socialsecurity.gov/benefits/medicare to apply for Medicare Parts A and B.

Your business associate who is covered under his working spouse's "true employer" group health benefits can delay enrolling in Medicare. He must follow Medicare's enrollment rules as Social Security deems.

"Still working" are magic words when it comes to enrolling past 65 and losing your or your spouse's company benefits. The Medicare and You Handbook discusses under the subtitle of "Should I enroll in Part B" about delaying Medicare Part B when you are leaving your or your spouse's group benefits and "that you can sign up for Part B anytime during the 8-month period that begins the month after the employment ends or the coverage ends, whichever happens first".

Even though the Medicare & You handbook states that there is an 8-month period that one can enroll without receiving a Medicare Part B penalty, the handbook does not clarify that those who delay will not have any of the benefits that Medicare Part B covers.

During a Toni Says Medicare consultation, we recommend that your and/or your spouse's Medicare Parts A and B begin the first day that your or your spouse's employer group health plan is ending, to be sure there is medical coverage when a healthcare need occurs.

### California State Board of Equalization Adopts **\$126.8 Billion in Assessed Property Value**

#### By Peter Kim, California State Board of Equalization

SACRAMENTO, CA (MPG) -The California State Board of Equalization (BOE) unanimously adopted the \$126.8 billion in assessed property values of 341 companies within California, which include telephone, gas, and electric companies, independent power producers, regulated railroads, and intercounty pipelines. In the upcoming fiscal year, schools and local communities statewide will receive a total of approximately \$1.99 billion in property tax revenue resulting from the Board exercising one of its core constitutional functions.

"The BOE's critical role protects the tax dollars personal property, and land.

schools and local communities depend on every day," said BOE Chairman Antonio Vazquez. "On behalf of the entire Board, I commend BOE staff for their expertise and hard work as today's action translates to funding teachers, public safety officials, parks, and roads across California."

Whereas most property in California is assessed by the 58 County Assessors, the BOE serves as the "59th assessor" by directly assessing certain public utilities, regulated railroads, and intercounty pipelines throughout the state. Also, since these properties are not subject to Proposition 13, the BOE annually determines the market value or the "unitary value" of property that Properties Program is includes improvements,

The BOE develops the fair market value by considering market conditions, use of and income generated by the property, replacement costs, investments in the property, regulatory climate, depreciation, and other factors as of the January 1 lien date.

For fiscal year 2021-22, there was a 6.7% increase in the total value from last year in the amount of \$7.9 billion which will generate approximately more than \$124 million additional tax dollars. County governments will use the values set by the BOE to levy the local property taxes.



## All Adults Should Get Tested for Hepatitis C

SACRAMENTO, CA (MPG) - An estimated 2.4 million people are living with hepatitis C in the United States. However, many don't know they are infected because chronic hepatitis C does not have symptoms for 20 years or more. By that time, serious damage can occur to your liver and can lead to death. The good news is that life-saving treatments can cure hepatitis C in 8 to 12 weeks to prevent further liver damage, cirrhosis and liver cancer. Getting tested for hepatitis C is the first step.

"We want to educate the community that lives can be saved just by getting tested for hepatitis C. This virus is the leading cause of liver cancer and liver transplants," said Sacramento County Health Officer Dr. Olivia Kasirye.

The liver is a vital organ that processes nutrients, filters the blood and fights infections. Hepatitis causes inflammation of the liver that can affect its function. Although hepatitis is caused by a virus and exposure to the blood of an infected person most often, toxins, some medications, certain medical conditions and heavy alcohol use can also cause hepatitis. The most common types of viral hepatitis in the U.S. are hepatitis A, hepatitis B and hepatitis C. Although all types of viral hepatitis can cause similar symptoms, they are spread in different ways, have different treatments, and some types of hepatitis are more serious than others.

Hepatitis C is caused by the hepatitis C virus. When someone is first infected with the hepatitis C virus, they can have a very mild illness with few symptoms or could require hospitalization. Less than half of people who get hepatitis C are able to get rid of the virus without treatment. Those who get infected will likely develop a chronic lifelong infection, which left untreated can cause serious health problems including liver disease, liver failure, liver cancer and death.

CDC recommends you get tested for hepatitis C if you: Are 18 years old and older; Are pregnant (get tested during each pregnancy); Currently inject drugs (get tested regularly); Have ever injected drugs, even if it was just once or many years ago; Have HIV; Have abnormal liver tests or liver disease; Are on hemodialysis; Received donated blood or organs before July 1992; Received clotting factor concentrates before 1987; Have been exposed to blood from a person who has hepatitis C; Were born to a mother with hepatitis C.

The hepatitis C test is a blood test that looks for HCV antibodies to find out if someone has ever been infected with the hepatitis C virus. Test results can take anywhere from a few days to a few weeks to come back. Rapid anti-HCV tests are available in some health clinics and the results of these tests are available in 20 to 30 minutes. If you are positive for the HCV antibodies, a follow-up test called NAT/PCR test will be done.

### **Bera's HERO Act Passes to Provide Mental Health Resources**

The HERO Act directs the Secretary of Health and Human Services (HHS) to report to Congress each year on first responder suicide rates, including identifying risk factors, possible interventions, and recommended interventions for further study. It also requires HHS to develop and distribute best practices on the prevention and treatment of posttraumatic stress among first responders. "Our nation's police officers, fire fighters, and EMTs put themselves in our first responders have Association of Fire harm's way every day to the tools and resources protect our community, so it's our obligation to be there for them in their time of need by ensuring they have access to life-saving mental health care," said Rep. Ami Bera, M.D. "While our first responders already experience higher mental health stress and higher risk of suicide than many other professions, responding to the COVID-19 pandemic is only increasing those burdens. Our first responders must now bear the additional mental burdens that daily exposure to the virus brings, especially in light of insufficient personal protective equipment for first responders. Today's passage of the HERO Act means we're one step closer to ensuring mental health resources get to our first responders so that they are able to cope with the added stresses of completing their jobs during the coronavirus pandemic. I look forward to getting this

The bill also creates two grant programs. The first is a program to train individual fire fighters and paramedics to provide mental health support to their peers in their organizations.

"Fire fighters and emergency medical responders deal with traumatic events on the job every day. It is a fact that the toll of these experiences are the direct cause of psychological injuries and problems with behavioral health. Sadly, we have lost some of our sister and brother members to these job-related hazards," said Edward A. Kelly, General President of the International Fighters. "Thank you to Representative Bera for his strong leadership in tackling these important issues head on and for his instrumental role in the passage of the HERO Act." "On a daily basis, firefighters are called to serve communities across the nation and are required to engage in situations that their eyes cannot unsee and their minds cannot forget. This cumulative trauma to our first responders has resulted in behavioral health impacts that include post-traumatic stress, alcoholism, divorce, and, unfortunately, suicide," said Michael McLaughlin, Fire Chief (retired), Cosumnes CSD Fire Department. "Congressman Bera's HERO Act will help us identify the extent of firefighter suicides, and implement programs that can effectively treat and develop resilience for the men and women who are here to protect us."

They routinely witness and experience catastrophic damage, significant injuries, and tragic loss of life, often leading to traumatic stress, mental health issues, and at times, even vulnerability to suicide," said Representative Fitzpatrick. "For too long, the challenges facing our nation's firefighters and emergency medical responders have gone unnoticed and untreated. We must, and we can do more to ensure they need to address mental and behavioral health needs. I commend the House passage of the bipartisan HERO Act, which will support the health and mental well-being of all our hero first responders across the country, and look forward to working with Congressman Bera in seeing the bill passed in the Senate and eventually signed into law."

The HERO Act is the culmination of listening, collaboration, and action by Rep. Bera. Over three years ago, Rep. Bera met with Sacramento-area fire chiefs who told him that firefighters face high and increasing rates of suicide. They shared with Rep. Bera that their own colleagues had died by suicide and that the first responder community lacked the mental health resources to tackle this crisis. After investigating, Rep. Bera learned that the United States does not track how many firefighters
