SACRAMENTO COUNTY, CA (MPG) - With Independence Day just around the corner, COVID restrictions rolling back and anticipated parties, please remember to know the risks of fire- Independence Day celebrations are available in case of fire; Do not use works, only use legal fireworks and stay safe when using. If you see or suspect illegal firework usage, please report it! The County has teamed up with our cities, fire and law enforcement jurisdictions to educate our community members on how to celebrate safely, how to spot a safe and sane firework and how to report illegal fireworks usage. In addition, many jurisdictions are enforcing stricter penalties this year for illegal fireworks usage. Calls for service throughout the county increase dramatically on July 4th and emergency response resources are stretched extremely

thin. During the holiday weekend, please use 9-1-1 for emergencies only – like an active fire or injury. Each jurisdiction has provided an alternative method to report illegal fireworks sale and usage.

Together, we can ensure

Keep It Safe: Always have a bucket of water to dispose of fireworks and leave in the water overnight before disposing; Always have a hose connected to water

Behavioral Health Youth Advisory Board Established

SACRAMENTO COUNTY, CA (MPG) - The Sacramento County Board of Supervisors approved an ordinance establishing the Sacramento County Behavioral Health Youth Advisory Board (YAB); the next step in an ongoing effort to promote the engagement of youth in developing programs that affect the behavioral health and wellbeing of youth in Sacramento County.

"If we want to create successful programs that meet the needs of our youth we need the youth perspective to help guide the process," says Ryan Quist, Sacramento County Behavioral Health Director. "The creation of YAB provides an empowering and supportive space for youth to advocate for youthfriendly, culturally relevant programs."

fun, safe and do not cause undue injury or fire in our communities.

Know the Risks: The unsafe use of fireworks can cause severe burns, amputations, blinding and even death; Damaging fires occur when children use fireworks unsupervised by adults; Parents are responsible for any property damage or injuries caused by all fireworks.

Keep it Legal: All legal fireworks in California are called Safe and Sane Fireworks and must bear the State Fire Marshal's seal; Safe and Sane Fireworks may only be used and sold from noon June 28 through midnight on July 4; Any

fireworks near dry grass or other flammable materials; Do not use fireworks while under a canopy, covered balcony, covered patio or under a tree or bushes.

lived experience, youth can offer the County a unique perspective to make County programs more effective and responsive to their needs. The YAB will serve as a diverse and empowered group of youth who will advise policy leaders on how to create a "youth behavioral health friendly" community, provide direct input and feedback regarding behavior health and wellness needs of youth, and create a network of trusted peer-to-peer messengers around youth behavioral health and well-being.

"Youth engagement in the creation of programs has been missing in our community," says Eboni Stallworth, California Youth Empowerment Network Board Member and youth mental health advocate. "This board creates a foundation for current and future youth to have their voices heard."

The YAB will be composed of 10 Sacramento County youth, ages 14-24, two youth representatives from each district. Once empaneled, the board will be trained and supported to work collaboratively with County Mental Health Board and the Youth Commission regarding programs and policies related to youth mental health. \star



Time for a Clock Tower?

RANCHO CORDOVA, CA (MPG) - A new telecommunication tower masquerading as a clock tower met with negative reaction at the Monday, June 7 City Council Meeting. Vice-Mayor Donald Terry referred to it as only slightly more appealing than other towers. "A good starting point but could be more attractive," said Councilmember Siri Pulipati. The placement of the tower in the southwest corner of Zinfandel Drive and Folsom Boulevard in between Target and Grocery Outlet was criticized by Councilmember David Sander.

And those were the more positive statements. Mayor Garrett Gatewood emphatically declared his distaste for putting towers up in the city using words like "god ugly" and "terrifying" to describe them. Councilmember Linda Budge also decried the location as one of the most "out of place" she recalled seeing.

Indeed, the discussion echoed meeting comments months ago when a Dutch Bros. was proposed in the nearby Grocery Outlet parking lot. With questions about how the community would react to the structure, city staff was sent back to the drawing board as the item was scheduled to be discussed again in July.

Fireworks are a symbol of America's independence, but with so many state and local limitations placed on them it's hard for Californians to feel all that liberated when celebrating Independence Day.

Reasons for that generally pertain to safety concerns. Authorities contend that injuries and fires are minimized by allowing the sale and use of only safe and sane fireworks in certain communities and for no

Due to all the uncertainty and lack of new product to test by press time, our 20th annual buyer's guide covers the highest-rated fountains likely to return this season at TNT, Phantom and Discount Fireworks Superstore locations in this region. Listed alphabetically by recommended show order are state-approved fireworks that have earned at least $4 \frac{1}{2}$ stars on a 5-star scale judged on performance, duration, distinctiveness and value.

Opening Acts

• Crickets (DFS) - If hearing crickets indicates silence, this colorful little powerhouse is sorely misnamed. Has more snap, crackle and pop than a milky bowl of Rice Krispies. 42 seconds.

• Flaring Stars Fountain (Phantom) - Virtually noiseless beauty featuring swarming fish effect in red, gold and green. 54 seconds. • Kool Kat (TNT) - Pintsized dynamo is packed with crackle, color and longevity

more than seven days a year. Not helping matters is the fact that our founding fathers signed the Declaration of Independence during one of the hottest months of the year.

"With California entering warmer weather with drought conditions in place, it is important to remember that fireworks are illegal in certain areas of California," State Fire Marshal Mike Richwine told Messenger Publishing Group. "Each year serious injuries and millions of dollars in property loss occur from wildfires sparked by fireworks."

Adding to this season's challenges, the domestic fireworks industry is dealing with another type of drought – as in the potential lack of product due to unprecedented delays in receiving ordered products from suppliers in China, maker of nearly 100 percent of product for the U.S. market.

As a result, according to Linda Hass, Sacramento-based Phantom Fireworks West Coast operations manager, "Our industry shipping costs have dramatically increased

from a year ago. In addition, space on the container ships is limited, and we are experiencing delays and backlogs in the Western U.S. ports."

Phantom and its largest California competitor, TNT Fireworks, which also owns most Discount Fireworks Superstore stands in the state, are expecting product to arrive much later than usual at their distribution centers.

"This is a very challenging year for the entire industry," Hass said. "Fingers crossed! Shop early!"






RANCHO CORDOVA, CA (MPG) - The City of Rancho Cordova is committed to fostering a beautiful and creative community. To support this commitment, the city, in partnership with Sacramento Municipal Utility District (SMUD), sought artists from throughout the region to design artwork to wrap 30 utility and traffic signal boxes throughout the community at 26 different locations. The program was supported by the city's Community Enhancement Fund, a half-cent sales tax measure that was approved in 2014.

"We are thrilled to highlight such colorful work designed by regional artists in our community," said Stacy Delaney, Community Enhancement Fund Analyst for the city. "The utility and traffic signal boxes used in the program were strategically selected to ensure that residents from throughout the city would be able to experience and enjoy them."

Each utility or traffic signal box is owned by either SMUD or the city and features colorful images of local landmarks, nature and wildlife, graphic patterns and more.

"We're proud to bring beauty and art to the City of Rancho Cordova," said SMUD Board President Nancy Bui-Thompson. "These types of partnerships highlight the talent, culture and diversity of this region, and we look forward to continued beautification efforts."

Although this art wrap program is the first of its kind in Rancho Cordova, it will not be

Cooley Focuses on Rancho Cordova

RANCHO CORDOVA, CA (MPG) - State Assemblyman Ken Cooley spoke at Rancho Cordova Luncheon on June 18 – the last in Zoom format. Referring to the Navigators Monument at Douglas Road and Eagle's Nest, Cooley said, "For many decades, the United States Air Force trained the navigators, who understood celestial navigation, long before the days of satellite tracking and GPS," Cooley said, "so that somebody could thread their way through a difficult circumstance and find their way home . . . giving them a safe tomorrow."

Cooley complimented the Cordova Community Council for their part in bearing up the community during hard times. "At this moment we need (the Council) even more, because we've all had to pull back, change our routine," Cooley said. "People have struggled the last year with . . . a much higher degree of isolation and that always makes the problem seem more daunting."

Cooley referred to the poet Rabindranath Tagore, who won the Nobel Prize for literature 108 years ago. "He said something that I think is almost timeless and of ground that is a part of certainly something we all need right now," Cooley said. He quoted the poet. "I slept and dreamt that life is joy; I awoke and saw that life was service; I acted and behold, service is joy." The assemblyman added, "We all ought to redouble our efforts and renew our devotion to acting in service to others . . . amplifying the joy in people's lives through acts of good works and service."

A representative of District 8 since 2012, Cooley was previously a Rancho Cordova city councilman, mayor and is a lawyer with a long experience as a Boy Scout leader. In the Assembly, among other things, he is the Chair of the Assembly Rules Committee, the Chair of the Select Committee on Foster Care, and Chair of the Joint Rules Committee with responsibility for rebuilding California's aging Capitol Annex.

Cooley's commented on his love of natural beauty and tied it in with the proposed development of the 41-acre Kassis property along the American River in Rancho Cordova. The property is valued as a wildlife habitat, especially for waterfowl, and also as a location where local children have been able to experience nature. "I think that is just an absolutely unique piece our community," Cooley said. "It's something that the City Council will need to struggle with, what is the right way to balance development with access for something that serves the interests of the entire community. That, of course, is the true mark of serving in public life, this balancing act, of reconciling public values with private values." One question asked of Cooley concerned the

extensive homeless camps in Rancho Cordova and throughout the State. "I don't know the solution," Cooley said, "I don't sit on the housing committee, but I know they're putting special funds into schools to support homeless kids . . . repurposing entire hotels to accommodate homeless populations . . . and various kinds of wraparound services. I'm very supportive of that. That to me is kind of our own Rancho model."

Another question addressed the difficulty finding affordable housing for people on small, fixed incomes. Cooley supports a return to some component of affordable housing in every housing development. "Policies need to provide a place for all people," Cooley said.

In the prefatory remarks to Cooley's address, Diann Rogers, CEO of the Chamber of Commerce, thanked Cooley for voting against several anti-business bills in the Assembly. With the return of open business, Rogers said, "What businesses need are customers. Be customers."

Cordova Community Council executive director Shelly Blanchard declared, "The Rancho Cordova Luncheon will return to the American River Room in City Hall next month, July 16. We are working up a special treat for that luncheon, but you are on notice that (the luncheon) cannot be attended in your jammies any longer."

Time to Baguette Up!

RANCHO CORDOVA, CA (MPG) - Looking for a hot, savory French dip or tri-tip sandwich in Rancho Cordova? You can soon expect to Baguette Up.

Owner Sam Azizi, who lives in Vacaville, said the new restaurant recently passed required final city inspections and expects to be open before the end of June.

"We expect to hire about 30 people for the restaurant and interested applicants can apply and message us love them, and they will be on baguetteup.com," he said. Azizi owns two other eateries: Benicia Grill 1 in Benicia, and Benicia Grill 2 in Fairfield.

Signage is up at the new eatery, named for the popular long French roll with its crunchy crust, in Rancho Cordova's Rivergate Shopping Center at 2320 Sunrise Boulevard. The plaza is anchored by Smart & Final and Pet Club.

Rancho Cordova is the first location for his Baguette Up, a concept which Azizi said he hopes to expand. If his Rancho Cordova location is successful, he hopes to open future locations, each with drive-thru lanes, in the general Sacramento area.

"Over the past four years, our thin-sliced French Dip and tri-tip steak sandwiches have been two of the top rated, most-requested sandwiches on the menu at both of our Benicia Grill locations," he said. "Customers

the deserving stars of our new Baguette Up menu."

Baguette Up sandwiches can be ordered as part of a combination meal, or ala carte. Combos are served with a choice of crosscut, sweet potato or crispy coat fries and a soft drink, according to a website menu.

In a combo a French Dip sandwich with au Sportsman's Warehouse, jus is \$10.95. Four different versions of their tri-tip sandwich priced from \$11.25 are featured. The menu also includes a variety of other sandwiches with sliced turkey and spicy buffalo chicken tenders. A children's menu is also available.

His new 2,813-squarefoot restaurant space was most recently occupied by Side Burn BBQ and Brew and had previously been the location of a Dickey's Barbecue Pit.

Azizi said he was drawn to open his new restaurant in the city of Rancho Cordova because he has family there. He credits his son Jordan for finding the location of the shuttered restaurant which featured a drive-thru lane, and once looking it over with him. immediately recognized its potential. Together, the pair will co-own the restaurant.

While the drive-thru is likely to be a prominent feature of the Rancho Cordova restaurant, the co-owners of Baguette Up will also offer indoor dining when it's permitted, and dining on an outdoor patio.

How Should California Confront Wildfire Threat?

Physicist Albert Einstein is widely, albeit erroneously, thing over and over again and expecting different results," but regardless of its source, the aphorism accurately reflects California's attitude about wildfires.

Year after year, destructive fires whip through communities in the "wildland-urban interface," often killing those who cannot or will not leave thousands of acres, causing their homes and causing untold billions of dollars in property losses.

The frequency and severity of wildfires appear to be increasing as our climate changes, droughts persist and greenery dries and becomes explosive fuel. What was once a relatively brief fire mortgage lenders and many season in late summer and early fall has morphed into a year-around peril.

And yet, more often than not, burned-over land soon sprouts new housing whose owners and tenants once again place themselves in harm's way.

A new study by UC Berkeley's Center for Community Innovation, commissioned by the think tank Next 10, attributes this seemingly loony practice to misguided state and local policies that incentivize reconstruction in

fire-prone areas.

"Wildfire threatens the lives and homes of more than one-quarter of California's population," F. Noel Perry, the founder of Next 10, said in a statement that accompanied the report. "We must overhaul local and state policies and planning procedures to ensure that we are not incentivizing actions that elevate wildfire risks."

The study found that replacing current homes in thought to have said that high-risk areas would cost "insanity is doing the same at least \$610 billion and that huge number scares insurers. As they pay out huge sums to burned-out policyholders and the danger of future catastrophic losses increases, insurers either shun coverage altogether or impose steep hikes on premiums.

"With climate-fueled wildfires scorching hundreds of the loss of life and property, wildfire insurance availability has shrunk while the premiums charged have increased," a commission appointed by Insurance Commissioner Ricardo Lara declared recently.

Insurance is required by property owners, unable to purchase coverage in the private market, have turned to a statewide insurance pool of last resort that has high premiums and limited coverage.

The Next 10 study recommends that the wildfire risk be approached by overhauling land use policies that lack "incentives to avoid building in fire-prone areas" and thus are "contributing to the persistent and increasing risk of significant economic and human costs associated with wildfires."

Land use in California is

largely controlled by state and county governments through zoning and construction permitting. The state's housing crisis has demonstrated that those governments are often reluctant to approve highdensity housing, especially that meant for low- and moderate-income renters, within urban areas.

10 study points out, they tend to be more supportive of housing, especially single-family homes, in urban peripheries, which also tend to be the areas of the highest wildfire risk.

The report proposes "moving homes out of the WUI (Wildlands-Urban Interface), incorporating greenbelts and wildfire buffers, increasing density in existing commercial cores, adding gentle density in the form of 'missing middle' housing and accessory dwelling units to areas not in the WUI, and embracing manufactured housing as an affordable-bydesign approach."

Lara's commission, meanwhile, suggests insurance premiums based on forecasts of future peril, rather than past experience, blanket policies that spread risk, rewards for making homes more resistant to damage and other steps that can mitigate not only wildfire impacts but the less obvious risk of destructive flooding.

Both studies underscore a fact we ignore at our existential peril: Despite its many attributes, living in California means living with constant threat of catastrophe.


- 1. MARTHA WASHINGTON DIDN'T WANT THE JOB. Neither did her successor Abigail Adams. Both were reluctant to take on the role, feeling that it would constrain their behavior and make life dull. There was a handful of women who recoiled at the title FLOTUS.
- 2. LONG BEFORE MELANIA TRUMP, LOUISA ADAMS WAS **AMERICA'S FIRST FOREIGN-**BORN FIRST LADY. Born in London, just one year before the U.S. would claim its independence. Louisa's birthplace became political ammunition for John Quincy's foes.

- 6. EDITH WILSON CAME VERY **CLOSE TO WIELDING REAL** POWER. When Woodrow Wilson was incapacitated by a stroke, Edith liaised with politicians, studied papers and briefed her husband. There is speculation she overstated her role.
- LOU HOOVER SPOKE CHINESE WHICH SHE HONED LIVING ABROAD WITH HERBERT HOOVER. He worked as a mining engineer. She also spoke Latin.
- 8. FLORENCE HARDING AND **BETTY FORD DIVORCED** HUSBANDS BEFORE MARRYING MEN WHO BECAME PRESIDENT. Rachel Jackson had attempted to divorce her husband who was abusive, but it was never finalized.



Slip in Small-Business Optimism **Draws California Comment**

By John Kabateck, National Federation of Independent Businesses

SACRAMENTO, CA (MPG) - Small-business optimism hit a bump in the road in May, according to the release of the National Federation of Independent Business' Small Business Economic Trends report, also known as the Optimism Index.

"May saw a slight pause in the recovery of small business optimism after steadily increasing each month in 2021," said a national news release issued by NFIB. "As reported in NFIB's monthly jobs report, a recordhigh 48% of owners reported unfilled job openings."

Commenting locally, John Kabateck, NFIB California's state director said, "This is not the type of news we would have preferred hearing heading into the vacation months in our state's tourist-heavy economy. I think some warning lights, if not alarm bells, should be raised especially for our State Legislature. Let's hit the pause button on the many proposals to increase regulations long enough to let the economy sort itself out – Not that I'm expecting them to do so, but California is the land of dreams."

From NFIB Chief Economist Bill Dunkelberg - "The labor shortage is holding back growth for small businesses across the country. If small business owners could hire more workers to take care of customers, sales would be higher and getting closer to pre-COVID levels. In addition, inflation on Main Street is rampant and small business owners are uncertain about future business conditions."

Other key findings include: Five of the 10 Index components improved, three declined, and two were unchanged. The NFIB Uncertainty Index decreased one point to 79. Job creation plans over the next three months rose to a net 27%, up six points. Owners expecting better business conditions over the next six months fell 11 points to a net negative 26%. Earnings trends over the past three months declined four points to a net negative 11%.

WHEREAS, The Cordova Recreation and Park District is authorized to establish Park Impact fees that are implemented and imposed through the local agency charged with land use authority within the District's boundaries, such as the City of Rancho Cordova, and County of Sacramento; and



New Home Sales in Sacramento Region Ease Back in May

North State Building Industry Association **Press Release**

SACRAMENTO, CA (MPG) - New home sales in the Sacramento region eased back during May from the frenetic pace reported during the past 12 months, but still were well above historical averages for the month, the North State Building Industry Association reported.

During May, area builders reported selling 570 new homes in the greater Sacramento region, including Sacramento, Placer, Yolo, Sutter, Yuba and Nevada counties. That is the lowest number since November, when 523

sales were reported and down sharply from the 760 sales reported in April, said Michael Strech, the BIA's president and CEO.

"Despite the modest drop-off in sales last month, the demand for new homes in our region remains incredibly strong," Strech said. "Sales during the month were far above the 448 builders have seen on average during May since 1997, and historically, March and April have been the strongest months for sales, which then gradually fall off through the rest of the year."

"It's also important to note that last month's sales were higher than all but one May's figures since 2006 and that year -2019 - was a five-week month." Sales that month totaled 585.

Strech said that even as pandemic restrictions are easing, many buyers are still looking for homes that provide the space and amenities they need, and today's new homes - particularly in the Sacramento region - meet those needs.

Still, builders are seeing headwinds, including the high price of lumber, other supply chain constraints and now a growing concern about available lots in the region as builders have ramped up production. It can take years to get government approvals to build new communities which hinders builders' ability to keep pace.

In addition, he said the excessive fees charged to builders in the Sacramento region mean some communities simply aren't feasible


"The fee study we released last week shows that government fees average \$95,000 per home in our region, which is \$40,000 more than comparable fees in the Central Valley and the Inland Empire region in Southern California. These other jurisdictions have cracked the code and everything should be on the table. We will work closely with local officials around the region in the months to come to find ways to reduce these fees and still ensure that new communities include

needed amenities."

May sales were above the monthly average. New home sales in the region were comparable to May sales totals in recent years, but still far above average for the past decade.

Placer County sales just ten fewer than in Sacramento County. Buyers were particularly interested in new homes in Placer County communities as sales totaled 246 – just ten fewer than in developments in Sacramento County.

Buyers continue to purchase higher-priced homes. The vast majority of purchase continued to occur between \$401,000 and \$750,000 during May.





Why Did COBRA Cost Me **\$40K in Medical Expenses?**

Reader Alert: Many employer benefit group plans terminate the day you are no longer working full-time. Explore employer group medical plan rules and options with Medicare if you or your spouse are 65 or older.



Toni King Toni:

I need your Medicare guidance because this March, I was rushed to the ER because of kidney failure caused from stage 4 of prostate cancer that has now spread to my pelvic bones.

Because I was working full-time, I took a leave of absence with short-term disability in January for 60 days while receiving my cancer treatment. Short term disability ended on March 15th and so I was placed on long term disability.

I was informed, while in the hospital for cancer treatment, that I had qualified for long term disability and would no longer be part of the company's health plan benefits whichever comes since I was not a full-time first. The 8-month period employee. COBRA would begin immediately.

My wife and I enrolled and paid for COBRA, so that I could continue with medical care where I am having cancer treatment. It took 6 weeks to get the paperwork to Social Security for me to enroll in Part B, since I was not working full-time, and my Medicare Part B began Medicare Part A. June 1st.

You have 8 months to sign up for Medicare Part B without a penalty if you are not "working full-time or have lost your company will run whether you choose COBRA or not. If you choose COBRA, do not wait until your COBRA ends in 18 months to enroll in Part B. You are in a Medicare "glitch" and the insurance plan is using "Coordination of Benefits" as their ruling.

Group health insurance plans are a state regulated plan not a Medicare regulated plan. Since you are past 65 and already enrolled in Medicare Part A, the health plan is passing the 80% of the doctor/medical bills on Part B to Medicare. You were not enrolled in Medicare Part B yet to pick up the difference.

It will take time to straighten this out but there is hope for you. The Toni Says® Medicare team is here to fight for you!

Dare to Live Without Limits Bryan Golden

Nice People Finish First 🦼

Chances are that you've heard the expression, "nice guys finish last." Nothing could be further from the truth. This statement is used by many to justify less than ethical treatment of others.

Under the guise of not wanting to finish last, people engage in inconsiderate conduct. At best, this type of behavior will give the illusion of short-term gains. These apparent gains come with a high price; the forfeiture of building a solid foundation of living which will last a lifetime.

Being nice is not synonymous with subjugating your dignity or your right to assert yourself. Don't as a doormat. Everyone, at one time or another, has been in a situation where they felt obligated or pressured to agree to do something that they didn't want to.

Being nice entails being considerate, polite, respectful and thoughtful. Being nice means not elevating yourself by stepping on others. Being nice requires understanding that you are not better than someone else and no one is better than you. Being nice compels you to help people without expecting anything in return.

Unfortunately, there are as a sign of weakness and as an invitation to take advantage. However, no one can take advantage of you without your permission and participation.

Your response when pressure is used to cajole someone tries to take advantage of you sets a precedent that determines how you are subsequently treated. Unless you make your limits clear, people will continually try to push your boundaries.

Your limits will be tested on several fronts: at work, by family, and by friends. Each situation requires a different approach. At work you have an obligation to perform certain services in return for your pay. But when requests fall outside your normal job responsibilities, you must decide whether you want to or should comply.

It's not uncommon allow yourself to be used to experience direct or implied pressure that your employment or advancement might be affected if you say no. This is a very uncomfortable position to be in, but it happens.

Be clear in your own mind what your limits are. Don't allow yourself to be held hostage because you are afraid to say no to unreasonable or inappropriate requests.

If you are so concerned by job security that you won't say no, you essentially broadcast that you have no limits. As a result, you will continually be taken advantage of. When appropriate, say no, those who view being nice and you will usually find that nothing bad happens and you are treated with more respect.

> Requests from family and friends are somewhat different. Guilt and peer

vou into doing what someone else wants. Exceed your boundaries and you will be taken advantage of repeatedly. Decline requests with politeness and a smile.

Be diplomatic by saying things like "Thank you for asking, but I have a prior obligation" or "I've already made other plans" or "If you had only asked me sooner" or "Thanks for thinking of me but that's not something I'm interested in."

Sometimes you will decline a request because of the way you've been treated. If this is the case, don't express it as your reason for saying no. Take the high road and don't get caught in the trap of retribution. All that matters is that you don't do what you don't want to do. You are not obligated to justify your actions or explain yourself.

If you don't respect your own limits, no one else will. Demand respect and you'll receive it. Get in the habit of not allowing others to take advantage of you.

The article featured Frank Squire, a member of Post 861, who leads a team of volunteers who pick up donated home furnishings and deliver them to the new living quarters of previously homeless veterans, including those veterans and their families at Mather Veterans Village.

The retired flag, first unfurled at Mather Veterans Village at that opening ceremony in 2016, was furled reverently while all veterans stood at attention and presented a hand salute, as TAPS played, it was given to Post 861 Commander, Don Harper, to take to VFW post for prescribed burning. The new American flag was unfurled by the Post 861 Color Guard as Nation's Finest line and staff members looked on, and members of Post 861 stood at attention and saluted as the Star Spangled Banner played. The entire ceremony, organized by Post 861 member, Bob Fitzgerald, was extremely moving and memorable.
