# Meeting the Rising Need

Big Brothers Big Sisters agencies are in critical need of men, with boys making up 70% of the waiting list for mentors, and only three out of 10 inquiries to volunteer are men. The goal of the "Man Up California" campaign is to inspire, with humor and emotion, twice as many men to volunteer as the year prior.

Across the state of California,

SACRAMENTO REGION, CA (MPG) – This year, the Big Brothers Big Sisters Association of California (BBBSAC) is launching its first-ever statewide initiative centered on the recruitment of male volunteers to become Big Brothers. This inaugural campaign will be the first time all 17 California agencies have worked together to leverage their collective reach, with the goal of significantly reducing the number of boys who are waiting for a Big Brother in California by recruiting twice as many male volunteers as the prior year.

Across the state, Big Brothers Big Sisters (BBBS) is experiencing a critical need for men to volunteer. The waiting list is nearly 70% boys, yet only three out of 10 inquiries to volunteer are men. Unfortunately, boys are waiting an average of 275 days before receiving a Big Brother.

"It's time for California to Man Up! It is our desire to give men a fun and easy way to help strengthen our communities by providing boys a quality mentoring experience that is proven to help children who face adversity succeed in and out of school," said Tiffany Siart, President of BBBSAC. "This summer is the perfect time to Man Up and find out how rewarding it is to play sports, go on a hike, eat pizza, or share your interests with a child who needs some

encouragement."

Boys served by BBBS are primarily children of single-parent, low-income, or active-duty military homes, or homes with an incarcerated parent. "I am a single mother. My son's father passed away last year, and he

needs a male role model in his life now more than ever," explained Jackie, a parent of a child on the waiting list in San Jose.

Due to complex circumstances, boys like Jackie's son are faced with a statistical spike in their likelihood to turn to

drugs, alcohol, and violence in an effort to cope with increased stress in their lives. Parents recognize the proven benefits that come from having a caring role model in their lives, and many are reaching out for help. "My son could use a more positive male influence in his life," said Jennifer of her 10-year-old son. Mothers like Jennifer are seeking better outcomes for their sons and are looking to BBBS to partner with them to support their children.

While on the bicycle at the gym I heard all about Cronut (donut meets croissant) in New York that is selling for \$40 on the black market. Dunkin' Donuts debut their Glazed Breakfast Donut Sandwich with much fanfare on this recognition day.

This entire hullabaloo re-minded me of the first recommendation I got from the locals, to make sure I tried Howard's Donuts in the Rivergate Plaza. Right away I found myself having a wonderful Glazed Old-Fashion with coffee at Howard's.

As I took in the scene, people arrived in a constant stream to get their goodies and be greeted by the members of an Asian family. We had a favorite doughnut/coffee shop in my previous hometown, which was operated by a warm, welcoming Cambodian mom and dad.

The history begins with a fellow named Ted Ngoy, who came to the United States as part of the 1975 immigration of Cambodians who fled from the

Khmer Rouge. He was in Long Beach working in a gas station when he noticed many customers going into the Winchell's across the street.

He applied for a job at the doughnut shop. He was willing to take any job, just to learn the

business. He not only learned

how to make doughnuts, but how

to make it a business and created a million dollar franchise.

He, in turn, trained and sponsored a large number of poor, unassimilated Cambodians who had fled to the United

States.\*

Back to our man, Howard

Hong, who had escaped

Cambodia with his family in

1980. The five members walked barefoot through the jungle (to avoid the mines) to a Thailand refugee camp. One year later, they were sponsored by a family and came to Sacramento.

In his heart, Howard is an entrepreneur. He educated himself on all the fine points of doughnut artistry, and then with funds borrowed from family and friends, opened his first shop on El Camino. The family worked seven days a week at the shop. He opened the present location in 1985 and with DONUT dough has provided a living for his family with all three daughters graduating from local colleges. Howard and his wife, Samon, have lived in Gold River since 1987 and recently retired. Their daughter Kimna Nou and her husband, Yut, operate the shop. Howard still comes in occasionally at 4 a.m. to start the coffee. A favorite ordered by the regulars is the Apple Fritter – SO GOOD.

They melodically beseeched us to go our own way. They sang to



# Dogfood: Local Band Looks to Break Out with New CD

RANCHO CORDOVA, CA (MPG) - Musicians waiting tables while waiting for their big break are a dime a dozen, but there are only two who add a side of Dogfood to their shifts at the Outback Steakhouse in Gold River. Not to fear, lovers of the Bloomin' Onion -- your favorite deep-fried appetizer isn't intended for Fido; Dogfood is a rock band.

Two-thirds of the group works at the local Outback. When they're not bringing socalled Aussie-Tizers and other dishes with supposed Down Under flavor to hungry patrons, Skyler Michael and Matt Harris take their brand of high-octane alternative rock to mostly stages in and around their adopted Sacramento home.

Friends since high school, Michael, Dogfood's lead singer, guitarist and lyricist, and Harris, its bassist, moved out West together from Sarasota, Fla. after graduation. Instead of ending their cross-country road trip in Los Angeles, the nation's music mecca teeming with talent, they continued up I-5 and wound up in Sacramento. Less than two months after settling in Sac, they recruited drummer J.T. Reed, a 2006 Rio Americano High graduate. Like his band mates, Reed also works at a restaurant part-time. The difference is Reed works in the kitchen instead of facing customers at the Old Spaghetti Factory in Rancho Cordova. "I'm used to being in the back. I'm the drummer," he said, matter-of-factly.

Harris explained Sacramento was chosen over L.A. and all the other large cities west of Florida.

"We wanted a big city, but an affordable big city," he said. "We have gained some traction, maybe

'We just played Concerts in the Park before 7,000 people (at downtown's Cesar Chavez Park)," Harris said. "If we were in L.A. we'd never be given that opportunity."

Another plus, Michael noted, is when the subject of Sacramento's top rock bands comes up, Dogfood is a fixture in the conversation. The buzz is about to get stronger with the release of the band's second CD. The Aug. 2 drop of selfproduced "Blink of an Eye" will be marked with a CD release concert that night at Ace of Wolf, The Three Way and James Cavern -- is on tap to support. The night promises to be epic if Reed's observation of local music etiquette holds true -- that Sacramento bands "show up when other bands start and don't leave until after the concert."

band's 10-song sophomore CD shows growth in musicianship, songwriting and production, but intact are shades of the Red Hot Chili Peppers, Sublime and Incubus as detected in earlier Dogfood works. Though the core doesn't depart from what's on the

notice what Harris described YouTube at www.youtube. as "maturity" with "Blink of an Eye." The "EXPLICIT" stamp that applied to most songs on "Alabama Voodoo" is needed for only two cuts off the new album as Michael's lyrics this time are not liberally spiced with radiounfriendly language.

The band also comes off as more down to Earth, able to carry social banners and convey provocative messages without what could be perceived as chest-beating lyrics such as these in "Gunfight" off "Alabama Voodoo": "... We don't play the same old (expletive) as them other (expletive) only tryin' to get rich, yeah! And I don't mean to come off rude, but I know we're a whole lot better than you, nah nah." Although the electric track is the band's most is," the drummer said. downloaded song on iTunes, its members agree that rockers are perceived as more genuine if vanity is kept in check. They clearly take their own advice in the fatalistic title track on "Blink of an Eve." one of three advance cuts off the new CD now up on SoundCloud (www.soundcloud. com/dogfoodmusic). out is the first music video in support of the album (on

com/watch?v=SKSsBs7oe7c). Directed by Michael and shot fully on iPhones, the video is a trippy interpretation of the CD's first single, the face-slapping "Feather in the Wind."

Floating in the air like a feather in the wind, to borrow from the song, is the opposite of Dogfood's aspirations. Together or not, and hopefully the former as they expressed, each band member wants control of where he's going as long as there's music involved. Michael's goal is to dedicate his life to the type of music Dogfood represents. Harris seconds that thought, saying that "I'd be happy living in a crappy place as long as I can play my music." Reed just wants to tour. "That's where the money

With all three members in the mid-20s and Dogfood not yet signed, the reality that the new album puts them in a potential state of now or never isn't lost on the men.

"The next couple of years are really crunch time for us," Michael said. "We understand we're getting older. You almost have to hit it by a certain age."

They may not have a recording

contract yet, but it isn't for a lack of paying one's dues. Dogfood (www.itsdogfoodbaby.com) went on a three-month tour in early 2012, playing stages from Burt's Tiki Lounge in Albuquerque, N.M. to the Blue Owl back in Michael and Harris' hometown of Sarasota, and returned to Sacramento broke.

"You get paid by the number of heads you bring in," Michael said. "We're bringing in enough each night for gas money, food and nothing else."

Their best-paying gig brought in \$1,500 for the week -- not for playing, but for painting, as in the entire wooden barn on Harris' aunt and uncle's Texas farm. Even Dogfood's manager, Eric James Hill, picked up a brush.

"We were roughing it," said Michael, noting that only on rare winter nights did they not sleep in the van. One gig in Las Vegas came with a hotel room, but otherwise accommodations were the band's 2010 Ford E-350 in a hopefully safe parking lot. Load up the manager and Harris' pet boxer Bruce and you've got some seriously reeking and cozy conditions.

It's a sacrifice they're willing to make in order to keep playing and recording. When they're not scrimping on the road, they're stretching dollars at home by sharing living expenses. Hill makes roommate No. 4, but, sadly, Bruce the boxer is no longer No. 5. The band's "slobber monster, tour roadie" and Harris' best friend had an unfortunate encounter with a car on Fair Oaks Boulevard a year ago.

On a lighter note, how Dogfood got its name has nothing to do with either the band's dearly departed mascot or a cheap meal out of desperation (no, they

"When picking a band name, you try to get the best possible name," Michael said. "We started throwing out the worst names."

Among the names in contention was "Dog Leg" until it was ruled out as being "kind of lame," according to Harris. "'Dog Food' was a joke that got carried away, but it stuck and, well, it's easy to remember," he said with Michael adding, "It sounds more punklike. It's an ironic band name."

Cool name, new CD, a growing catalog of music, strong local following and places to play. These guys are just a recording contract away from the world eating their own Dogfood.





The "Man Up" campaign is harnessing the power of social and broadcast media to reach men where they live most. Through integrated touch points such as an interactive landing page, a social media campaign, and a YouTube series featuring official "Man Up" spokesperson, Bruce – a 13th century Scottish Warrior puppet – "Man Up California" is offering a new approach to recruitment.

To qualify as volunteers, individuals must:

- Be over 18 years of age.
- Have a valid Social Security number with no criminal background.
- Be available to volunteer for at least one year.

Men and Spanish-speaking volunteers, in particular, are in high demand.

Individuals who are not able

to volunteer are being asked to consider donating to help sponsor a waiting boy, who will then be carefully matched with a screened volunteer and receive ongoing support and access to

Big Brothers Big Sisters programs are based on a data-proven model focused on creating and sustaining strong and long mentoring matches. 



#### Buying a House with 403(b) Money

Dear Dave,

Should I take advantage of a 403(b) withdrawal in order to buy a house?

- Bryan

Dear Bryan,

I wouldn't do that because it really doesn't accomplish anything. The only money you can take out is what you've put in, and any growth you've experienced has to stay in there. Basically, it's a retirement plan, and I wouldn't monkey around with retirement money to buy a home.

My advice is to make sure you're debt-free and you have three to six months of expenses set aside in an emergency fund. Once you've taken care of those issues, you can pile up a bunch of cash in a money market account toward the purchase of a home. You won't earn a lot of money, but it's a safe place to park your cash when you're saving up for a big purchase.

When it comes to saving and investing, I'm a big fan of mutual funds. The problem in this scenario is that if you start sticking money in mutual funds, then the market is down when you're ready to buy, you could've lost some money. That's not the route I'd want to go if I'm in your shoes, Bryan. I'd forego the opportunity to make money in order to keep it safe for this goal. - Dave

# Dave Says

#### What Term Does He Need?

Dear Dave,

I'm 24 years old, and I have a wife and child. We've been following your plan, and I'm about to buy life insurance. Should I get a 20- or 30-year term policy?

- Derek

Dear Derek,

I think the big question is how long will you need this life insurance. If you and your wife are planning on having more kids in the next 10 years, I'd suggest a 30-year policy. That could put you in a situation of being 34 years old with a new baby. That's not old by any means, but your wife will need

20 years' worth of coverage if this

happens, because you'd want the

kids grown and out of the house before the insurance term runs out.

But that's just one of your financial goals at this point. You also want to be debt-free. And you need to ask yourself some other questions. Are you going to have your house paid for 15 years from now? I sure hope you didn't take out more than a 15-year mortgage. Are your kids going to be grown and gone by then? Are you going to have a big pile of money in the bank by then? In other words, where are you going to be at the end of the term?

If 15 years from now you have \$700,000 in your retirement account, your house is paid for, and the kids are out on their own, then, if you die, your wife will be fine, financially speaking. But at that time, if you still have kids in the house and your home isn't paid off, then you'd probably need a 20year policy.

That's how I would look at it. How much longer are you going to need life insurance?





The AMC TV network is a basic cable channel that got its start as American Movie Classics, airing films largely made before the 1950s and in their uncut and original color

While still adhering to its primary mission to run classic movies, AMC initiated a major shift in programming in 2007 with the successful launch of the original series Mad Men, a period piece about the freewheeling advertising world of New York during the 1960s.

Soon after Mad Men made its mark as one of the best cable TV dramas, AMC struck gold for a second time with Breaking Bad, the explosive story of a high school chemistry teacher who adapted all too easily to a life of crime.

Speaking to a recent gathering of the nation's TV critics, writer, producer and director Vince Gilligan explained that the main character of Breaking Bad was once glibly described as taking Mr. Chips and turning him into Scarface.

Devoted fans of Breaking Bad are well aware of this construct, that Bryan Cranston's milguetoast Walter White, a teacher facing the worst mid-life crisis ever, turns bad. Dying of lung cancer, Walter exploits his knowledge of chemistry to embark on a volatile criminal enterprise.

The final eight episodes of Breaking Bad are just getting started during the month of August, leading to the inevitable conclusion that the sun is beginning to set on Walter's tenuous drug empire as the world around him unravels.

Whatever is happening during the finale for "Breaking Bad" is not being revealed here, not only because we don't know but it would

spoil the fun. One can only sense that it may well end badly, which makes sense given the series twisted

Meanwhile, AMC is launching a new series during August, which itself will be limited by a ten-episode run. Low Winter Sun is based on the 2006 award-winning British two-part mini-series of the same name written by Simon Donald.

The premise of Low Winter Sun is incredibly compelling. A homicide detective, played by Mark Strong, is coerced by a fellow officer into killing another detective, albeit a corrupt individual.

Strong's Frank Agnew is a Detroit investigator who becomes assigned to investigate the murder he committed. Looking over his shoulder is David Costabile's Simon Boyd, a dogged Internal Affairs officer trying to root out police corruption.

Strong is the right man for the job of the conflicted cop, primarily because the British actor reprises the same role of the Detective Agnew from Scotland's Edinburgh, a city of urban decay somewhat like Detroit.

Low Winter Sun makes great use of the rotting landscape of modern Detroit, where many neighborhoods in the urban core resemble a postapocalyptic vision you might suspect came from a cheesy science-fiction

Regrettably, decades of corruption and inept political leadership (the twin pillars of a failed metropolis) have rendered Detroit an unfortunate wasteland, which oddly enough makes the city attractive, at least, for filmmaking of crime stories.

Also starring with Mark Strong is Lennie James as Detective Joe Geddes. Together, these two mismatched officers are part of the big story of murder, deception, revenge and corruption in a world where the line between cops and criminals is blurred.

HAVE CONSEQUENCES



"I believe that we are solely responsible for our choices, and we have to accept the consequences of every deed, word, and thought throughout our lifetime." - Elisabeth Kubler-

All of our actions have consequences. This relationship is as dependable as the ripples created by throwing a pebble into a lake. Consequences can be either good or bad. Problems arise when we don't think about or recognize the consequences of our actions.

When you are not aware of the consequences of your behavior, two things may happen. In the case where the consequences are negative, you run the risk of repeating the same mistake. When you are pleased with the consequences, you may also fail to duplicate the behavior that gave you the desired results. In either case, you will be frustrated.

For example, how far could you get driving a car if you didn't comprehend the consequences of the various controls? Without an understanding of the operation of the steering wheel, gas pedal, and brakes, you wouldn't remain on the road for very long.

Your life works the same way. It's important to understand the consequences of your actions. Many of the consequences you experience are predictable. However, there may be some you didn't anticipate. They are part of your unending education.

Unexpected consequences provide you with new insights. Invaluable knowledge can be gained by analyzing exactly what happened and why. The discoveries made in this fashion provide you with new information you can use to reach your goals.

Ideally, when assessing various courses of action, an analysis of the corresponding potential consequences enables you to make the best possible decision. This is the basis of the carpenter's adage, "measure twice, cut once." You have probably been told numerous times to think before

Acting impulsively, without thinking, is the same as cutting without measuring at all. This approach is similar to attempting to drive a car by cranking the steering wheel in one direction and then correcting by cranking in the other direction. You will run off the road in short order.

Not every decision you make will be perfect. Your objective is to take the most appropriate action based on the information you have available. If the actual consequences are not what you wanted, you must then take different action and keep going. Don't waste any time lamenting what you should have done differently.

Ignoring or denying the link between your action and the corresponding consequences will often make things worse. You

won't be able to take control of your life unless you see yourself as being responsible for the outcomes you are experiencing.

When faced with undesirable consequences, you want to first identify the cause. Next, determine the action you need to take to mitigate, change, or eliminate them. Then get in gear and do whatever is necessary to correct the situation. Action, not complaining, brings results.

If you fail to take personal responsibility for your actions, you will exacerbate your situation. Those who blame others for their circumstances develop a victim mentality. The result is a belief that they have no power over the direction of their destiny. This type of thinking leads people to accept suffering as normal and unavoidable.

The only way to affect different consequences is to alter your actions. This is accomplished by being proactive in every area of your life. Then when something happens you don't like, your first response will be "what do I have to do to fix this?"




According to the Wounded Warrior Program, applicants must have served on active duty since Sept. 11, 2001, have a 30 percent or



# Why GMO Labeling Matters

I admit to being confused about GMO (genetically modified organisms). Like many Americans, I'm challenged to understand the consequences of genetically engineered organisms in my body, family, and in the environment. Knowing the facts will help guide us in the choices we make for all the things we care about.

While a long-term study of genetically engineered organisms is still lacking, significant parts of the world are concerned about their impacts: All 27 countries in the European Union now ban or limit GMO crops. Egypt and Algeria also restrict GMOs, as do Peru, Brazil, Bolivia, and Paraguay.

With over 75 percent of all non-organic foods in the United States containing genetically

engineered ingredients, why GMO: 85 percent of soy, 40 A 2011 study written up on Deputy Commissioner for haven't the FDA and the USDA – guardian angels of the nation's food supply moved in that direction, or at least taken a more cautious approach? And why aren't GMO foods labeled, so we can make informed choices?

Some things to know about GMO:

• GMO foods are made with new, uncertain technology: Older methods of crossing plants, including hybridization and selection, have been used for centuries. These methods are natural and safe. They don't try to splice flounder DNA into tomatoes to resist frost (no one has ever tasted the infamous "fish tomato," a genetically engineered failure of the early '90s). Long-term impacts of GMOs are unknown.

• GMOs are everywhere: Much of our food, though not labeled as such, is already percent of corn, 75 percent of canola, and 76 percent of cotton grown in the U.S. are GMO, reports the USDA. 1

Mostly Roundup: 80 percent of food-crop GMOs are bred for tolerance to the herbicide glyphosate, or Roundup, made by Monsanto, according to the Journal of Agrobiotechnology Management and Economics.2 A Roundup-resistant plant lives while the herbicide kills competing weeds. The problem is that glyphosate stays in the plant. If you eat GMO corn or soy, you're eating the herbicide too. In 2009, a French court found Monsanto guilty of falsifying an advertising claim that glyphosate is biodegradable, reports BBC News.3 A 2011 European study found glyphosate in 44 percent of volunteers from 18 countries. You're even exposed if you eat organically:

GreenMedInfo.com. "detected glyphosate in 60-100 percent of all U.S. air and rain samples." 4 Another 2012 study found it widespread in groundwater, reports Reuters.5

• Problems with Roundup: Glyphosate has been linked in scientific studies to breast cancer, Parkinson's disease, autism, MS, infertility, gastrointestinal diseases, and Alzheimer's.6 The American Academy for Environmental Medicine says that GMO foods "pose a serious health risk" and has called for a moratorium on the use of GMOs until further studies are done.

• If GMOs are risky, why are they everywhere? Someone left the barn door open - a revolving door between industry and government. Michael Taylor, for example, is both the former VP of Public Policy at Monsanto and the current Foods under the Obama Administration. As a regulator, Mr. Taylor approved use of rGBH, bovine growth hormone – a controversial GMO – despite links to cancer, allergies, and higher rates of childhood asthma.7

Everyone knows not to put a fox in the chicken house, because while Mr. Fox may know more about chickens than anyone alive, knowledge does not imply honorable intentions.

When I was farming, a peahen – Penelope – escaped from a farm up the road and moved in with our chickens. Eventually she sounded just like a chicken, and blindfolded, you'd never know. GMO proponents would like us to stay blindfolded and believe that genetically modified salmon is the same as its wild brethren. They want us to stay blind to potential problems by fast-tracking GMO approval

and stacking the regulatory deck. They would like us to turn a blind eye to the growing number of negative GMO studies and continue to trust that Monsanto, guilty of lying and polluting, can protect our health while telling us a peahen is a chicken.

With more states compelling food producers to make GMO labeling mandatory, it's clear that the awakening American public opposes the abuse and manipulation of our food system.

It's time for Congress to pull off the blinders for good and pass a responsible GMO labeling bill that protects the health of everyone. Safety comes first.



# Heat Wave Babies Spotted Some Moms Prefer Home Deliveries

SACRAMENTO REGION, CA (MPG) - Challenged by recent heat waves, dehydration, and predators, black-tailed deer fawns are finding American River Parkway survival particularly tough this year. Many does have instead chosen to deliver babies in residential backyards.

Thus, in recent weeks, unusual numbers of gardeners have reported surprise at what sprouted overnight in their flowerbeds. Garden deliveries are a safety measure for mothers and progeny: shade is plentiful, predators less common, and bird baths are handy troughs. Sprinklers mean greener grazing than our parched Parkway can offer.

"I looked out my window and a baby fawn tottered toward me," marveled a California Avenue woman. "Her eyes were unfocused and

her fur was wet. I guess she had just been born. I was thrilled to see nature renewed in my own yard. The mother had vanished

and the baby started crying. She was running around in distress, but she stayed in my yard. Eventually, the mom came back, suckled her baby, and they wandered off together. I haven't seen them since."

Owner of a large property near Carmichael Creek, Allan Davis headed outdoors for a stroll. "I heard a rustle and a tiny fawn was feet away from me, just staring," said Davis. "He was so cute ... eventually he ran away, but he seemed to stay in the garden."

Later, a doe showed up. Mother and child wandered down the garden path and into the sunset, together.

What Carmichael both residents observed was a rite of passage -- a behavioral norm often mistaken for maternal neglect. After does give birth, they abjure their little ones to stay put, then disappear. No matter

how frightened, the fawns wait in prescribed areas. Moms later retrieve babies already apprised of lesson one: obedience. In

following months, fawns are often left beneath thickets, camouflaged by dancing light on dappled coats. Obedience to the stay-put message is a fawn's greatest protection.

Does usually keep newborns hidden for some weeks after birth. With August upon us, new fawns are now becoming more visible on the Parkway, but from all indications, this summer presents special hardships. June/ July heat waves desiccated most grasses and dried creeks early. The staple acorns won't be available till fall.

"That might explain why so many fawns were born in private gardens," ventures Effie Yeaw Nature Center staffer Betty Cooper. "On the Parkway, deer compete with other animals to eat whatever's out there. I guess our gardens are a refuge."

Here's what to do if a lone fawn appears in your yard:

**Don't** assume it is abandoned -- mothers almost always return. **Don't** move the youngster -- this may stop mom from finding it. Don't befriend or feed fawns -- their survival depends on wariness.

**Do** fill birdbaths or leave water pans in shade. **Do** restrain Fido until the newcomer departs; even friendly dogs may initiate flight and injury. Canine odor might also scare off the returning doe. **Do** caution neighbors to drive carefully -- the mom might appear suddenly on a street or driveway.

Above all, honor the little newcomer's presence as a brief, precious gift. We are all nature's children. Responsibility to share begins in our own yards.
