Murals Planned for Sunrise MarketPlace

CITRUS HEIGHTS, CA (MPG) - Sunrise MarketPlace will continue to receive a splash of color as two additional murals are now planned.

The new mural painted by muralist Jacob Lewis wraps around two portions of a retaining wall at the entrance to the Sunrise Village Shopping Center from Uplands Way in Citrus Heights.

Lewis, a resident of Tulare and a fine arts graduate of Sacramento State, took advantage of cooler weather to spray paint a portion of his mural adjacent to the entrance to JoAnne's Fabrics, and talked about the upcoming projects in Citrus Heights he hopes to be working on this fall.

The completed mural Lewis is now painting wraps around both sides of a curved block retaining wall where a new marquee sign has been built. A third portion of the mural he has yet to design will lead towards the entrance of the Milano Nail Salon which will open in the plaza in the near future.

A new "Route 66" themed mural is planned on a side wall at Batteries Plus retail store at 8025 Greenback Lane in Greenback Square, said Kathilynn Carpenter, executive director of Sunrise MarketPlace who met with Lewis last week to discuss the concept for the project.

A second commissioned mural is to be painted in Greenback Square on walls surrounding the open seating area between a TOGO's Sandwiches and Royal Indian Cuisine in the center of the plaza.

Greenback Square is located near the intersection of Greenback Lane and Fair Oaks Blvd in Citrus Heights. Sunrise Mall is located one block to the west. Additional stores located in Greenback Square include Royal Indian Cuisine, Wasabi Asian Bistro & Sushi Bar, Starbucks and Salon Centric.

Five large murals have now been completed in the District, Carpenter said. A colorful new mural, visible from Sunrise Boulevard, was recently painted on an exterior wall of the Pet Food Express store facing Sunrise Boulevard.

In recent years, several muralists who participated in the annual summer Sacramento-based Wide Open Walls festival were invited to complete works in Sunrise MarketPlace, she said.

In addition, the District also transformed its utility service boxes into art-wrapped showcases with works by prominent world renowned artists.

"Our goal has been to bring more public art to the Sunrise MarketPlace District," Carpenter said. "We're excited to continue to do so."

Final Recommended Budget Hearings Begin Sept. 6

SACRAMENTO COUNTY, CA (MPG) - The Sacramento County Board of Supervisors will begin Fiscal Year (FY) 2023-24 Revised Recommended Budget hearings on Wednesday, Sept. 6, at 9:30 a.m. in Board Chambers in the Sacramento County Administration Building, located at 700 H Street, Sacramento, 95814. If necessary, hearings will continue on Sept. 7 and 8 at the same time and location.

The hearing schedule, in order (may be subject to change):

IHSS Public Authority Budget Deliberation and Approval; Introduction by the County Executive to the FY 2023-24 Revised Recommended Budget; Public Comment; Board Deliberation and Approval to Revisions of the Approved Recommended Budget.

The numbers in the recommended budget change between June and September when the County receives new information, including the impact of the State Budget and updated revenue totals. Because of that new information, the Revised Recommended Budget comes back to the Board for review and adoption in September.

The Board of Supervisors approved the FY 2023-24 Recommended Budget on June 7. The \$8.4 billion spending plan recognized new and enhanced areas of growth based on the Board's priorities and a survey of Sacramento residents. The budget included annual commitments of \$35 million to fund new or enhanced programs aligned with the County's jail population reduction plans to comply with the Mays Consent Decree; \$10 million in the Sheriff and Correctional Health budgets to fund continued efforts for additional staffing and services in the Mays Consent Decree Remedial Plan; \$12 million to fund new programs and services addressing homelessness; \$84 million of growth in Health Services; \$17 million in additional funding for Child, Family and Adult Services; and \$5 million to address road repairs and improvements in the unincorporated County, among others.

Members of the public may attend the hearings and be heard on any item in the budget, either publicly, over the phone or through written comments. The budget hearings will also be telecast live on Metro Cable 14 and at sccob.saccounty.gov/Pages/BOSPublicMeetings.aspx★


Dr. Jan Cooper Wants to Know Your Name

New Theater Company to Launch

CITRUS HEIGHTS, CA (MPG) - In a notice on August 21st sent to season ticket holders by Blake Flores and Vanessa Voetsch, founders and executive directors of Theatre in the Heights, the only community theater in Citrus Heights, the pair have announced being "retired from theatre permanently," and that "Theatre in the Heights has now ceased to be."

Theatre in the Heights, founded in 2016, was located at 8215 Auburn Boulevard, Suite G in Citrus Heights. The website address theatreintheheights.com has not been updated to reflect the recent management change.

"As we already informed our season ticket holders, the theater space and the 2023-24 season will be taken over by a new group, Vivid Flare Productions, which will be led by writer, actor, and director Shane Robert. They (Vivid Flare Productions) will send more details soon," the pair wrote in a prepared statement.

"We thank our patrons and artistic collaborators for your tremendous support throughout the last seven years. We have so many great memories to take away as we embark with joy on a new chapter in our lives," they wrote.

Shane Robert, who directed two recent plays, "Private Lives," and "Weekend Comedy" for Theatre in the Heights and has also self-produced shows he has written in the Sacramento area, will lead the new theater company. Robert was also unavailable for further comment.

"We hope you will embrace the new direction of the theater. We hand-selected Shane (Robert) to carry the torch, and believe your theatrical future is in good hands. Much love to all." Neither Flores nor Voetch responded to requests for comment regarding their future plans.

Theatre in the Heights featured a 52-seat auditorium and was tucked away next to a barber shop in the Aquarium Depot shopping Plaza on Auburn Boulevard. The theater was shuttered for more than a year, following COVID-19 shutdown orders and ran on donations from its many loyal fans who helped keep the theater alive.

In an earlier news interview, Flores said none of the actors and actresses who regularly performed at Theatre in the Heights were paid for their roles. The group frequently held auditions to bring in new local talent, and the theater's Facebook page had regular announcements with casting calls for upcoming shows.

Flores, who performed as an actor and director in countless shows at Theatre in the Heights, told the Messenger in an earlier interview how very much appreciative the Citrus Heights community has been towards his theater, sticking loyally with it through the pandemic, as it offered attendees a welcome chance to "enjoy quality live theater without going into downtown Sacramento."


Continued from page 1 know it's from the Holy Spirit is because I know I'm not smart enough to write things like that. I flunked English twice in high school and college."

And continuing to write he has. He is currently the author of ten books, including one translated into Spanish and a coloring book. He is also a former teacher. His career started by teaching inner city youth on an Indian reservation in North Dakota. He made \$4800 for the entire year. In 1967, he went to Sacramento and got job offers right away as a teacher in the Grant Union School District but had to "teach himself English by teaching English." He retired in 2004 but continued to pour into local young people by substitute teaching for another 17 years. He has also taught art – specifically painting and drawing – for over 20 years to both children and adults.

With a teaching career that led him to interact with inner city youth often, he did not shy

"Some considered them dangerous, some considered they just didn't care," he said. "But I loved the students, and they knew that."

His love of young people also carries into his love of his country. His books clearly have a conservative tone, and he has a passion to see faith and rationality become part

of the political landscape again.

"America has fallen asleep into a state of name calling, bickering, and fighting. Our leaders are supposed to be setting the best example for our youth. All my folks did was yell, scream, holler and fight. I don't want that in our country because I can see how it can affect our youth."

Now, Cooper is continuing his mission to share his faith, and his political concerns. He is of the camp that believes socialism is a threat to our nation, and he isn't shy about saying so.

"My main concern when the pandemic hit was I had so many good ideas, bad ideas, wrong ideas about what was happening in our country," he said. "I was raised in the military – I went to high school in Japan. I saw what was going on in different parts of the

world."

Being a writer is also healing for himself as well. Recently, he has dealt with chronic pain, and he finds relief when he is artistic.

"When I do what I know God wants me to be doing, the pain goes away," he said.

You can meet Dr. Jan Cooper in person at two upcoming book signing events. He will be at the Citrus Heights Barnes & Noble on October 28 from 11am-2pm, and at the Arden Barnes & Noble on November 4 from 11am-2pm. You can also check out his collection of books for sale on his website, drjancooper.

At his book signing events, he will have his drawing pad. For everyone who buys a book - and maybe even for those who do not - he will be ready to draw their name.

Woman Killed by Boyfriend in **Apartment on Burich Avenue**

CITRUS HEIGHTS, CA (MPG) - On August 26th, 2023, at approximately 9:30 pm, Citrus Heights Police responded to the reports of a disturbance inside an apartment located in the 6200 block of Burich Avenue. One witness reported hearing the sound of gunshots.

Officers arrived and located an adult female inside the apartment with gunshot wound injuries. An adult male was also located inside the apartment with life-threatening injuries. Officers and paramedics provided life-sustaining medical aid. The female was pronounced deceased at the scene due to her injuries. The male was transported to a nearby hospital with serious injuries and is being treated.

The deceased's identity is being withheld pending the notification of her next of kin.

Citrus Heights Detectives responded and began a homicide investigation to include interviewing witnesses and reviewing evidence. Citrus Heights Crime Scene Investigators (CSI) arrived and also collected multiple pieces of

Based on the investigation, we know this tragic event was between two individuals in a dating relationship. There are no additional threats of danger to the community, and the suspect is in police custody.

Second Community Meeting Held for Sylvan Corners Project

CITRUS HEIGHTS, CA (MPG) - A second community meeting was held Tuesday, August 22nd at Citrus Heights City Hall by Utah-based Woodside Homes to build a 95-home residential community on a 11.3-acre site, where the original Sylvan School, demolished in 2016, once stood

Michael LaFortune, vice president of land acquisition and development at Woodside Homes in his presentation to city officials led the slide presentation which provided a Sylvan Corners project update, describing the neighborhood character and lot types of the new residential community, traffic and transportation circulation, landscape concept plans and an estimated project construction timeline.

Should the Citrus Heights City Council vote to approve the project by the end of October 2023, LaFortune said general site work and construction could start in April 2024 with the first model homes completed for sale by the end of 2024.

The project is now being finalized and prepared for a hearing before the Citrus Heights City Council. Completion of a California Environmental Quality Act (CEQA) review ended on August 28th.

LaFortune said he expected the Sylvan Corners project to then go before the Citrus Heights Planning Commission at its next meeting on or about September 13 where the project plan would then be reviewed, and recommendations would be made to the Citrus Heights City Council.

A first presentation of the Planning Commission's recommendations would be made to the Citrus Heights City Council for their consideration, and a second reading of the project would take place at its next scheduled meeting before a vote

to approve the project would then be taken.

LaFortune said Woodside Homes has accepted all of the specific traffic recommendations made by city traffic engineers and has the project modified signal patterns where they were needed. Initial public comments in an earlier community meeting centered around traffic concerns with Auburn Boulevard already a heavily traveled thoroughfare.

"A number of key trees evaluated by an arborist to be in good condition will be kept in entrance locations to create a special community arrival experience," LaFortune said.

LaFortune said the project, located adjacent to Sylvan Middle School and the historic Sylvan Cemetery, may offer for-sale units designed for such specific needs as work force

housing, teacher housing or similar product type. The 11.3-acre site was pur-

chased by the city of Citrus Heights in 2019 for \$3.4 million from the San Juan Unified School District. The city hoped to turn the property around and sell it to a preferred developer for mixed-use development. Only one offer was received, which was from Woodside Homes during an offering period in 2020.

City Council members then voted 4-1 to sell the property to Woodside Homes for \$4.17 million, pending a due diligence

Project documents filed with the city describe 70 traditional single-family homes and 25 lots with an alley entrance to the garage. Those 25 homes will face outward toward Auburn Boulevard in an effort to increase the curb appeal of the busy thoroughfare.

Plans show 81 homes would be priced at market-rate, while 14 are shown as affordable units. The project features two entrance and exit driveways, both along southbound Auburn Boulevard.

A total of five open spaces are part of the development, connected by pedestrian walkways, with the largest being a detention basin for stormwater runoff at the southernmost point of the property, filed plan documents show.

A water detention and purification basin for stormwater runoff will be located at the southernmost point of the property. Five open spaces are part of the Sylvan Corners development with the largest being the detention basin that will have a natural, aesthetically pleasing look, LaFortune said.

In his presentation, LaFortune described the project as both "purposefully incorporating the existing Sylvan Plaza retail plaza across the street and meeting an important design goal by fronting all buildings, including residential units, outward from Sylvan Plaza and Auburn Boulevard."

Woodside Homes would create a homeowner's association "in perpetuity" that will own and maintain the parks and landscaping within the community, he said.

Enhanced pedestrian connections will connect the property to nearby businesses, Sylvan Plaza and the adjoining Sylvan Middle School. A pedestrian access gate, provided at the southwest portion of the project, adjacent to Sylvan Middle School, will also be provided to create a safe route for students to get to and from school, as well as to serve as an emergency exit, LaFortune said.

"Well-designed parking and service areas inside the new residential community also screen these areas from Auburn Boulevard and Sylvan Plaza," he

"We've worked diligently with the city with the same goals in mind," LaFortune said. "We want to build what we promised as a very well thought out community."

"We're excited about the next steps as we bring a great new community to the city."

Board Approves Responses to Reports on Homeless

SACRAMENTO COUNTY, CA (MPG) - The Board of Supervisors, at its August 8 meeting, approved responses to two Grand Jury reports regarding responses to homeless issues and behavioral health resources including planning, coordination, funding, and measurable outcomes.

The Grand Jury issued two reports related to homelessness that require a response from the County Board of Supervisors. The Grand Jury Report, "Homeless Should Not Mean Hopeless: Homeless Solutions Elude Local Leaders" was issued on May 26, 2023. The report asserts that local governments have failed to work together effectively to address the increasing number of homeless and related issues which has resulted in millions in direct and indirect costs. The report recommended that Sacramento County leaders prioritize a formal, comprehensive approach to homelessness. The report included five findings and four recommendations related to the information in the report along with a list of individuals and agencies required or invited to respond.

The Grand Jury Report, "Mental Health Care For The Homeless: Who Cares?" was issued on June 9, 2023. This report asserted that mental illness and substance abuse among the homeless needs to be addressed through a streamlined, coordinated, and transparent service delivery system and approach that uses measurable, quantifiable outcomes with proven success to make meaningful change. The report included 11 findings and 11 recommendations.

The landscape of the County's homeless and behavioral health programs and services have been rapidly evolving, even over the past year. Some of the Grand Jury findings may have been true at the time, but the County has already taken steps to remedy in recent months.

The County has many programs and strategies under development that will help to move the needle on some of the findings and recommendations that have either not yet been fully stood up or are still in development and have not yet seen the benefits or outcomes.

For example, the Grand Jury indicates that the outreach teams are poorly supported and understaffed. At the time this report was being researched, those

findings were likely correct, however, since that time, there has been significant progress made in not only staffing up those teams, but in allocating additional resources to these teams and to the Behavioral Health CORE centers, fostering meaningful engagement. The County has already committed to semi-annual reports on outreach efforts which can be found at our County's Homeless Services Website.

There are some findings and recommendations that the County didn't agree with either partially or fully – in part because the County has another strategy in the works that will meet the same need, or a strategy being recommended warrants further analysis. One example is the formation of a Joint Powers Authority (JPA) to address homelessness countywide.

A JPA is one model that may work. However, with the Governor's new budget requirement for HHAP funding, the County and all regional city partners and Continuum of Care (CoC) will be required to develop a regional plan to coordinate services and funding – therefore a JPA may or may not be the best structure for achieving the intent of this regional plan. As the State issues guidance and requirements, the County and its partners will do a more in-depth analysis.

There are some findings and recommendations that the County has already implemented, but the lack of broad knowledge of these strategies are an indication that the County needs more robust communication efforts. For instance, the Grand Jury indicated that there is no strategic plan that includes the mental health and substance abuse issues facing the homeless. The sixth pillar of the Local Homelessness Action Plan is mental health/substance abuse. Additionally, the Grand Jury indicated that there are not quantifiable metrics, however the plan includes both timelines and measure goals. California Comment on Latest National Small Business Findings

SACRAMENTO, CA (MPG) - On August 8, 2023, release of the National Federation of Independent Business' (NFIB) monthly Small Business Economic Trends report showed a few tiny upticks in the outlook Main Street enterprises have for a better future, but nothing that would indicate the beginning of a reversal of its continuing two-year slide.

"A lot of what it will take to move small-business owners across the nation from this current era of just coping to one of thriving will depend on what Congress does with the Small Business Deduction on their federal tax forms: to let it expire or to make it permanent," said John Kabateck NFIB's California state director. "Closer to home, our Legislature has already rendered its decision on small business by doing absolutely nothing about its outstanding loan debt with the federal government over the unemployment insurance trust fund.

"When the pandemic surprised the nation, it was understandable California was one of 22 states that needed to borrow from the federal government to keep its unemployment insurance trust fund solvent and benefits going to those in need. What is not understandable is why it remains one of only two states (New York, the other) that has not paid its UI loans back, unless, of course, our state leaders don't care about small business."

The SBET (Optimism Index) is a national snapshot of NFIB-member, small-business owners not broken down by state. The typical NFIB member employs

between one and nine workers. This latest Index rose 0.9 points in July to 91.9, but it marked the 19th consecutive month below the survey's 49-year average of 98. The SBET is released the second Tuesday of every month.

From NFIB Chief Economist Bill Dunkelberg

"With small business owners' views about future sales growth and business conditions dismal, owners want to hire and make money now from solid consumer spending. Inflation has eased slightly on Main Street, but difficulty hiring remains a top business concern."

Highlights from today's report

Owners expecting better business conditions over the next six months improved 10 points from June to a net negative 30%, 31 percentage points better than last June's reading of a net negative 61%. This is the highest reading since August 2021 but historically very negative.

Forty-two percent of owners reported job openings that were hard to fill, unchanged from June but remaining historically very high.

The net percent of owners raising average selling prices decreased four points to a net 25% seasonally adjusted, still a very inflationary level but trending down. This is the lowest reading since January 2021.

The net percent of owners who expect real sales to be higher improved two points from June to a net negative 12%, a very pessimistic perspective.

Weir Widening Project to Affect Traffic

WOODLAND, CA (MPG) - The United States Army Corps of Engineers' (USACE) contractor, Granite Construction, has begun work to widen the Sacramento Bypass flood control structure. The Sacramento Weir Widening Project is taking place along Old River Road, also known as County Road 22, just north of the City of West Sacramento city limits. This crucial step toward bolstering flood control measures along the Sacramento River aims to enhance flood stage management both upstream and downstream of the Sacramento Weir during high-flow events, thereby mitigating flood risks and safeguarding the areas adjoining the Sacramento River.

As this project gets underway, it is imperative for commuters to anticipate potential delays stemming from project construction, which is anticipated to persist until late 2026. Motorists are encouraged to exercise caution, adhere to construction signage, and reduce speeds while navigating through the construction zone. When possible, motorists are encouraged to take alternative routes.

Motorists will encounter a temporary allway stop intersection situated at the northern end of the existing Sacramento Bypass bridge structure, where County Road 126 converges with Old River Road. This temporary measure, including the installation of stop signs and detour roadway, is anticipated to be implemented by August 21 and will remain until the weir extension component of the project is completed in 2025.

A key element of the project entails the construction of a 1,500-foot-long extension of the Sacramento Weir, stretching northwest along Old River Road. This extension will be accompanied by essential improvements such as levee enhancements, roadway upgrades, utility enhancements, and fish passage improvements.

To accommodate the construction of the weir extension, a section of approximately 1,000 feet of Old River Road will be temporarily removed. In its place, a detour route will be established. This detour is projected to be operational for an estimated two-year period during the course of the weir extension construction.

Suspects Orchestrated the Theft of an ATM Machine

SACRAMENTO COUNTY, CA (MPG) - At approximately 6:15 AM on Wednesday, August 2, 2023, two suspects orchestrated the theft of an ATM machine from the Safe Credit Union on Watt Avenue in North Sacramento, While one individual operated a forklift, the other drove a white pickup truck. After the suspect operating the forklift knocked the ATM off of its platform, they eventually loaded it in the bed of the pickup truck.

The second suspect drove away with it; but during the course of their "getaway," the ATM machine fell out of the truck in the middle of Watt Avenue, causing an unrelated traffic crash. Both suspects fled the scene and have yet to be identified or located.

Defendant Convicted of Murder and Drive-by Shooting

SACRAMENTO COUNTY, CA (MPG) -

Christopher Berger was convicted by a jury of first-degree murder and three counts of discharging a firearm from a motor vehicle. The jury also found true allegations that Berger discharged a firearm causing great bodily injury or death.

On August 24, 2020, the four victims were outside in front of a residence in North Sacramento. Berger drove up to the residence in his vehicle and shot at the victims 11 times with a .45 caliber semi-automatic handgun. Alex Cardona was shot in the head, killing him. The other three men were shot multiple times, but they survived. Berger then reported his vehicle as stolen. Three days later, the vehicle was stopped with a different individual driving it. That individual stated he got the car from another person, who turned out to be Berger's friend. The driver also stated that he threw a shell casing out of the car into a dumpster. The shell casing was located and matched the shell casings at the murder scene. Eight months after the murder, an unregistered firearm was located during a vehicle stop and matched the shell casings from the murder scene. Berger and the victims were rival gang members.

Berger faces a maximum sentence of 125 years to life in prison. Sentencing is set for September 29, 2023, at 1:30 p.m. in Department 33 before the Honorable Laurel White.



Absolutely not! Do you see where I'm going with this, Thomas? As an adult, learning is your job. An entire lifetime of learning is your job. And if vou can encourage that in your kids with some level of help, financial or otherwise, then it's your obligation to help them. You can't expect a 17-year-old to figure it all out. They don't have the

tools yet. The point is this: You don't have a moral responsibility to pay for your kids' college education. Social Security Matters

What About All the Money Congress Stole from Social Security?

Dear Rusty: Is there any way that Congress will vote to pay back the Social Security funds they took for their stupid reasons, and left IOUs in place of the funds? Because of the funds they took going back many years, we didn't have any decent COLAs for a few years. In fact, there were I think 3-5 years that we didn't get any COLA. Please Rusty, can you find out if this is true or false? Help us seniors! Signed: Resentful

Dear Resentful Senior: I can assure you that I've fully investigated the allegation that politicians have squandered Social Security's money and found that charge to be, simply speaking, a myth. I've gone back and looked at Social Security revenues and expenses since the government first started collecting FICA payroll taxes in 1937 and found that every dollar ever collected for Social Security has been used only for Social Security purposes. Over the years, various claims have been made that the money has been used for other things, but I've researched each of these charges and found them all to be false.

Where the misconception mostly originates is collected from working Social Security benefit. tion.org.

Americans for Social Security is invested in "special issue government bonds" which pay interest. as mandated by President Roosevelt when Social Security began. As with any investment, a financial obligation instrument is given in return for dollars received. Remember when we used to buy "U.S. Savings Bonds?" We'd use our money to buy those bonds, hold them, and later redeem them for a higher amount than we paid. That's exactly how Social Security contributions have always worked – excess money collected from working Americans is used to purchase special issue government bonds which are held in reserve, earning interest, for future Social Security needs. These special bonds reside in a Social Security Trust Fund and, as of the end of 2022, were worth about \$2.8 trillion. Are these bonds "worthless IOUs" as some would claim? Hardly, since they are redeemable as needed

Considering that, since 2010, Social Security's income from payroll taxes on American workers has been less than needed to cover benefits paid out, redemption of bonds held in the Trust Fund is the only reason that Social Security has been able to continue paying full benefits to every beneficiary. The Trust Fund is a financial safety net which is now protecting all SS beneficiaries from having their benefits cut. Problem is, unless Congress acts soon to reform Social Security's financial picture, the Trust Fund will be fully depleted in about 2033 resulting in about a 23% cut in everyone's monthly

to pay Social Security

benefits.

I'm optimistic that will not happen (it would be political suicide) and, hopefully, Congress will act soon to reform Social Security and restore it to financial solvency and avoid a future cut in everyone's benefits.

Regarding COLA (Cost of Living Adjustment) and the lack thereof for several past years, COLA is determined by the government's standard inflation measure - the Consumer Price Index (CPI). There were several years (2010, 2011, and 2016) in which the CPI showed no inflation so, therefore, no COLA increase was given. Last year, due to soaring inflation, everyone got an 8.7% increase in their Social Security benefit, but that doesn't happen every year. FYI, the average annual COLA increase over the last two decades has been about 2.6%, although COLA for each year can be wildly different depending on each year's inflation measure. In any case, the lack of a COLA increase in past years was not a result of any political chicanery, it was the result of low inflation during

A prominent aspect of California's evolution in the late 20th century and early 21st has been the economic and political dominance of the San Francisco Bay Area over more populous Southern California.

> One indication of the new disunity is what happened when the Bay Area's all-important mass transit system, BART, experienced sharp decreases of ridership, and therefore revenue, during the pandemic. It largely failed to recover as the workfrom-home alternative to commuting has persisted.

> A \$1.50 per vehicle increase in Bay Area bridge tolls was introduced in the Legislature to bail out BART, but it immediately caused a rupture within the region's political and civic leadership, with critics denouncing its shoddy service and union domination.

> Last week, the toll increase was put on indefinite hold, unable to muster the united support needed for passage. The Bay Area is now adrift, unsure of how to cope with its economic and social woes and beginning to resemble Southern California's chaotic atmosphere.

Fugitive Antonio Lopes Moreno Extradited to U.S. for Homicide Charges

Sacramento FBI News Release

SACRAMENTO, CA (MPG) - On August 14, 2023, special agents from the Federal Bureau of Investigation (FBI) Sacramento Field Office and Legal Attaché Office of Mexico City returned wanted fugitive Antonio Lopes Moreno, 67, to Glenn County to face felony homicide charges with special circumstances. Lopes Moreno was booked into the Glenn County Jail and is currently awaiting his initial appearance before the Superior Court of California, County of Glenn, in Willows. All charges are mere allegations, and the defendants are presumed innocent unless proven guilty beyond a reasonable doubt in a court of law.

With the assistance of the FBI Mexico City Legal Attaché and the International Criminal Police Organization (INTERPOL) Mexico, Lopes Moreno was apprehended by INTERPOL in Cotija de la Paz, Michoacan, Mexico, on August 19, 2022, pending extradition.

"The FBI is committed to locating and returning individuals who evade criminal prosecution to honor the memory of victims, support those impacted by the crime, and ensure the accused can face charges before an impartial jury," said Special Agent in Charge Sean Ragan of the FBI Sacramento Field Office. "We stand ever ready to aid our law enforcement partners and effect extradition when we can to ensure justice for all."

"Today's actions show the crucial value of partnerships in ensuring that violent criminals do not go unpunished," said Mexico City Legal Attaché Angel Catalan. "For this case, the FBI would especially like to extend our gratitude to the Fiscalia General de la Republica and its INTERPOL team for their actions in locating and arresting Lopes Moreno."

Lopes Moreno's return to Glenn County to face prosecution is funded by the United States Government's Project Welcome Home, which provides funding to assist in the transportation of federal

fugitives to the United States. Lopes Moreno is alleged to have killed a woman outside of an Orland laundromat on October 11, 1989. The Orland Police Department and Glenn County Sheriff's Office investigated the homicides, and the Glenn County District Attorney's Office District Attorney Dwayne R. Stewart is prosecuting the case. The Justice Department's Office of International Affairs provided significant assistance in securing the defendant's arrest and extradition from Mexico. A warrant for Lopes Moreno's arrest was issued on October 16, 1989.

The FBI obtained a federal arrest warrant for unlawful flight to avoid prosecution on May 23, 2017, following a request for assistance from the Glenn County Sheriff's Office in January 2017 and in collaboration with the Glenn County District Attorney's Office.

The FBI continues to collaborate with its law enforcement partners to apprehend criminals charged with state crimes who then flee the jurisdiction. Cases seeking information from the public, including fugitive matters, are posted on the FBI Sacramento Field Office's Most Wanted page and FBI Most Wanted app. Anyone with information that may aid these cases may contact their local FBI office, United States embassy, or submit information online at tips.fbi.gov.

AN ORDINANCE OF THE CITY OF CITRUS HEIGHTS AMENDING SECTIONS 50-507, 50-605, 78-53 AND 98-132 OF THE CITRUS HEIGHTS MUNICIPAL CODE

The foregoing is a summary of an ordinance proposed to be adopted by the City Council of the City of Citrus Heights at its meeting of September 14, 2023.

The purpose of these amendments is to help update and bring the penalty sections into uniformity and provide alternative avenues of accountability, including options to reduce certain violations to infractions or administrative action when appropriate. The amended language for several penalty sections of the Citrus Heights Municipal Code is as follows:

Any person who violates the provisions of this section may be subject to any of the following legal enforcement remedy, including but not limited to: Criminal Prosecution of a misdemeanor or infraction, civil action, including injunctive relief, administrative enforcement actions, including administrative citation, and/or revocation of a use permit, if applicable. These remedies shall be in addition to any other remedy authorized by law.



Caltrans Honors Fallen Highway Workers with Signs at Rest Areas

MARYSVILLE, CA (MPG) - Caltrans District 3 (Marysville/Sacramento) announced on August 16, 2023, that it will install memorial signs in roadside rest areas along the California state highway system to honor its 14 workers who died in the line of duty and to encourage travelers to drive responsibly.

The memorial signs were designed, manufactured, and will be installed by Caltrans workers to recognize the 191 highway workers who have been killed on the job statewide since 1921. Every year, Caltrans employees, family members of fallen workers, and community members throughout California gather to honor these workers and to promote safe driving campaigns.

"Safety is Caltrans' top priority," said Caltrans Director Tony Tavares. "Lives are literally at stake every day. We hold a sacred duty to remember all the people who have lost their lives working with us, and I implore all Californians to please slow down and move over in every work zone, every time. A life may depend on it."

Since 1923, District 3 has lost 14 employees who were performing their normal duties on the job.

"We will never forget our fallen employees who worked diligently to ensure our roadways were safe for the traveling public," said District 3 Director Amarjeet S. Benipal. "The tremendous sacrifices by these public servants remind us of the enormous loss to their family, friends and Caltrans."

District 3's last on-the-job fatality occurred in 2010 after Chico Maintenance Leadworker Gary Smith, 57, was struck and killed by a motorist while performing traffic control for a detour around an earlier fatal crash. The driver of the vehicle that struck Smith later pleaded guilty to gross vehicular manslaughter while intoxicated and sentenced to prison.

Three years earlier, 35-year-old Highway Maintenance worker Matthew White was struck and killed by a vehicle exiting at the Interstate 5 Southbound Elk Grove Boulevard off-ramp during the morning hours. White was a second-generation Caltrans employee.

On Monday, Caltrans crews installed the first District 3 memorial signs at the west- and eastbound Interstate 80 Gold Run rest areas. The signs also will go up at the I-80 Donner Summit and Interstate 5 Elkhorn, Dunnigan, Maxwell and Willow rest areas.

District 3 maintains more than 4,385 lanes miles of state highway in 11 Sacramento Valley and Northern Sierra counties. From 2013 to 2022, 1,424 people lost their lives on the region's state highways stretching from Butte County to Sacramento County and from Colusa County to EI Dorado County. Of that number, 39 deaths resulted from 38 vehicle crashes in active construction zones.

With the passage of the federal Infrastructure Investment and Jobs of 2021 as well as Senate Bill 1, the Road Repair and Accountability Act of 2017, Caltrans and local agencies now have significant additional funds to repair and maintain California's transportation system. The additional funding has increased the number of Caltrans employees and contractors working on the state highway system, highlighting the importance for drivers to stay vigilant and aware.

According to the U.S. Bureau of Labor Statistics, highway construction and maintenance work is one of the most hazardous occupations in the United States. In 2021, more than 9,500 work zone collisions occurred on California highways, resulting in an estimated 2,971 injuries and 73 fatalities. Nationally, drivers and passengers account for 85 percent of people who are killed in work zones.

In 2022, Caltrans announced a new Director's Policy on Road Safety, which commits the department to the Safe System approach and reaffirms the vision of reaching zero fatalities and serious injuries on state highways by 2050. This policy takes steps to further a shift that began in 2020, as state transportation leaders recognized a bolder and more focused approach was necessary to combat the troubling rise in fatalities and serious injuries on California roads. The state's 2020-24 Strategic Highway Safety Plan - managed by Caltrans and involving more than 400 stakeholders – was updated to include the Safe System approach.

Caltrans has partnered with the California Transportation Foundation to develop two funds to benefit the families of Caltrans workers killed on the job. The Fallen Workers Assistance and Memorial Fund helps with the initial needs a surviving family faces and the Caltrans Fallen Workers Memorial Scholarship is available to the children of these workers. - Citrus Heights non-profit groups are encouraged to register for a free "City Grants 101" workshop offered Wednesday, September 13 from 3 to 4 pm at City Hall at 6360 Fountain Square Drive.

In the 90-minute interactive workshop led by Councilmember Porsche Middleton, participants will gain a broader understanding of everything they may need to successfully apply for city

"The city council has had many grant applicants come before us for our consideration," Middleton said. "It was a shame that many didn't qualify."

Fellow council members agreed that greater public outreach was urgently needed to take the general fear and anxiety out of making a grant application to the council, and helpful advice on preparing better grant proposals would be publicly beneficial.

Middleton took the lead towards organizing the 90-minute workshop, discovering that there are some 264 IRS designated non-profit groups in Citrus Heights, many more than she first

While the city is publicizing the event through social media platforms and has provided a registration link to the event on its website,

reaching out directly to all Citrus Heights non-profits through a direct mailing effort.

Representatives of 30 different non-profits in the city have since registered for the event, she said.

"The workshop is tailored to guide applicants through the intricate world of city grants and unveil the potential they have to make a transformative impact on our community," Middleton said.

"We'll delve into everything you need to successfully apply for city grants. From an overview of available grant opportunities, to understanding the application process, from crafting compelling grant proposals to creating a realistic budget, we've got you covered."

Marisa Brown, the city's communications officer provided some examples of the community support funding grants which have been available. The city has allocated \$20,000 during the fiscal 2023-24 calendar year on a first-come, first-served basis for historical preservation and arts promotion.

Applications for a total of \$50,000 in round one community project grants have now closed. The Citrus Heights City Council has since approved a second round of funding for community project grants, with application deadlines to be determined.

Middleton said some smaller non-profits are concerned that they can't afford the professional services of a grant writer, or that the application process is just too complex to start.

She hopes workshop participants will leave the session equipped with the creator

resources, confidence, and understanding to craft a winning grant application.

"They have to understand that as a starting point, they need to begin with a clear specific mission statement to identify what they want to use a grant for," Middleton

She encourages non-profits to be as realistic as possible with their likely budget expenses and their cost estimates as they put a grant proposal together.

"It's also important to talk to their own communities and obtain constructive feedback during the process," she

Middleton encourages non-profits to recognize the importance of actively networking with community service groups who may be willing to help achieve a common goal.

In addition, she said that grant applicants should know that the city itself has a team of people available to answer questions, and to offer valuable help and advice every step of the way through the grant approval process.

"Whether you're taking your first step into grant applications, or you're a seasoned veteran, this upcoming workshop provides the practical knowledge and insights needed to boost your funding prospects," she said.

Debt Relief and Credit Repair Finds Some Companies Fail to Live Up to Promises

SAN FRANCISCO, CA (MPG) - A study by Better Business Bureau® finds that while people in North America struggle to pay trillions of dollars in debt, some look for help from companies promising to help reduce or eliminate their debt or fix their credit score. And some of these companies make big promises, but rarely deliver, leaving people further in debt.

The 2023 study, Credit Repair and Debt Relief: BBB® study finds some companies fail to deliver on big promises, examines debt relief, debt consolidation and credit repair industries, finding a pattern of high fees and overstated promises from predatory companies. BBB has over 11 thousand complaints and a thousand negative reviews about debt and credit assistance, revealing fraudulent claims, especially in the American west.

Consumers told BBB stories about how their dedication to plans proposed by these companies, meant to boost their credit scores, or reduce crushing debt, left them worse off.

One consumer told BBB she hired a debt settlement company back in 2018 for relief from more \$36,000 in debt her father held. They agreed to a contract which would see them pay a little more than \$27,000 and wipe out the remaining obligations.

Five years later, the consumer was a few hundred dollars away from paying the full \$27,000. But when she looked at her balance, only \$5,780 was to be paid to her creditors, and the rest to the debt settlement

While some consumers report positive experiences with the credit and debt assistance industry, this study shows there are negative patterns reported by consumers to BBB about companies in the industry, and outright scams designed to deceive and

extensive fixes for low credit scores and defaulted debt, but the ability to enact change

is often much more limited than implied. Consumers report to BBB the mounting fees for debt relief programs and lackluster results from credit repair businesses have lost them thousands of dollars and left them worse off than before.

Many of the services offered by credit and debt assistance companies can be done by consumers themselves. However, difficulty in understanding their options, lack of know-how or a time crunch and other issues can lead some consumers to seek assistance. Here are some key terms and services to know when researching options.

BBB offers tips for consumers considering debt relief or credit repair:

Use AnnualCreditReport.com to get a free credit report.

Don't pay or provide payment information until service is rendered.

Critically examine any guarantee made. Few, if any, companies can ensure a credit or debt company will agree to negotiate with them or adjust reports.

If you are in default, call debt holders yourself and attempt to negotiate a lower debt payment.

Check monthly bank statements to avoid

recurring charges from companies.

Search online for free information. Don't be rushed. Unscrupulous

businesses and scammers both use high-pressure tactics. Avoid giving away personal banking

information until you are 100% certain a company is legitimate. Refuse to work with companies that won't tell you your rights when it comes to credit repair or

Be wary of anyone claiming to be associated with a government agency.


