**CITRUS HEIGHTS, CA (MPG)** - Under the canopy of a bright blue fall sky, members of the Capitol Pops Concert Band, under the direction of Susan Hamre, dressed in their crisp, black and white dress uniforms, and performed a free concert, celebrating their own 25 years of playing music as they wished a joyous "Happy Birthday" to the city of Citrus Heights, celebrating its own 25 years of cityhood.



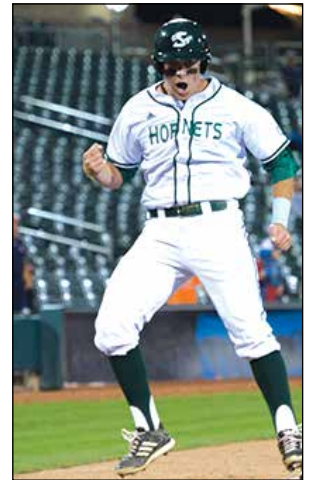
Citrus Heights City Hall was decked out in celebration of the 25 years since the City's incorporation.

Their concert program included selections by composer John Williams, big-band swing of clarinetist

## Sacramento Locals Prepare For Baseball's Biggest Stage

**SACRAMENTO REGION, CA (MPG)** - Despite the San Francisco Giants and Oakland Athletics missing the playoffs this season, Sacramentans still have a lot to look forward to with the 2022 World Series beginning this Friday, October 28. Three Sacramento-area locals will be participating in this year's Fall Classic, with two on the field and one in the dugout. Philadelphia Phillies first baseman Rhys Hoskins stands on one side representing the 916. On the other side stands utility player Mauricio Dubón and manager Dusty Baker for the Houston Astros.

Hoskins has played for the Phillies his entire career since being drafted in the fifth round of the 2014 Major League Baseball (MLB) Draft out of Sacramento State. Before becoming a Hornet, Hoskins played locally at Jesuit High School in Carmichael. This is Hoskins' first playoffs and World Series appearances as Philadelphia snapped an 11-year postseason drought this year. Baker is back for more after reaching the World Series with Houston last year. After playing 19 years in the big leagues, Baker is in his 25th year as an MLB manager. He led the Giants to the World Series in 2002 and now the Astros to back-to-back appearances in 2021 and 2022. Baker holds the record for most wins among managers who have yet to win a World Series. He went to Del Campo High School in Fair Oaks and still has a

**CITRUS HEIGHTS, CA (MPG)** - The former Perko's Café and Grill at 6215 Sunrise Boulevard near the corner of Greenback Lane in Citrus Heights has a new name, CH Café & Grill, and a familiar restaurant owner. Exterior banner signage identifies the recent ownership change. Large round Perko's logos gave been temporarily hand repainted with the new CH Café & Grill name while signage has been ordered, said owner Victor Garcia, who also owns Erica's Café down the street on 7451 Greenback Lane in Citrus Heights. According to Garcia, the

parent company, Heritage Restaurant Brands based in San Luis Obispo, was intending to phase out the Perko's restaurant brand in Citrus Heights, giving the previous owner the option to rebrand as a

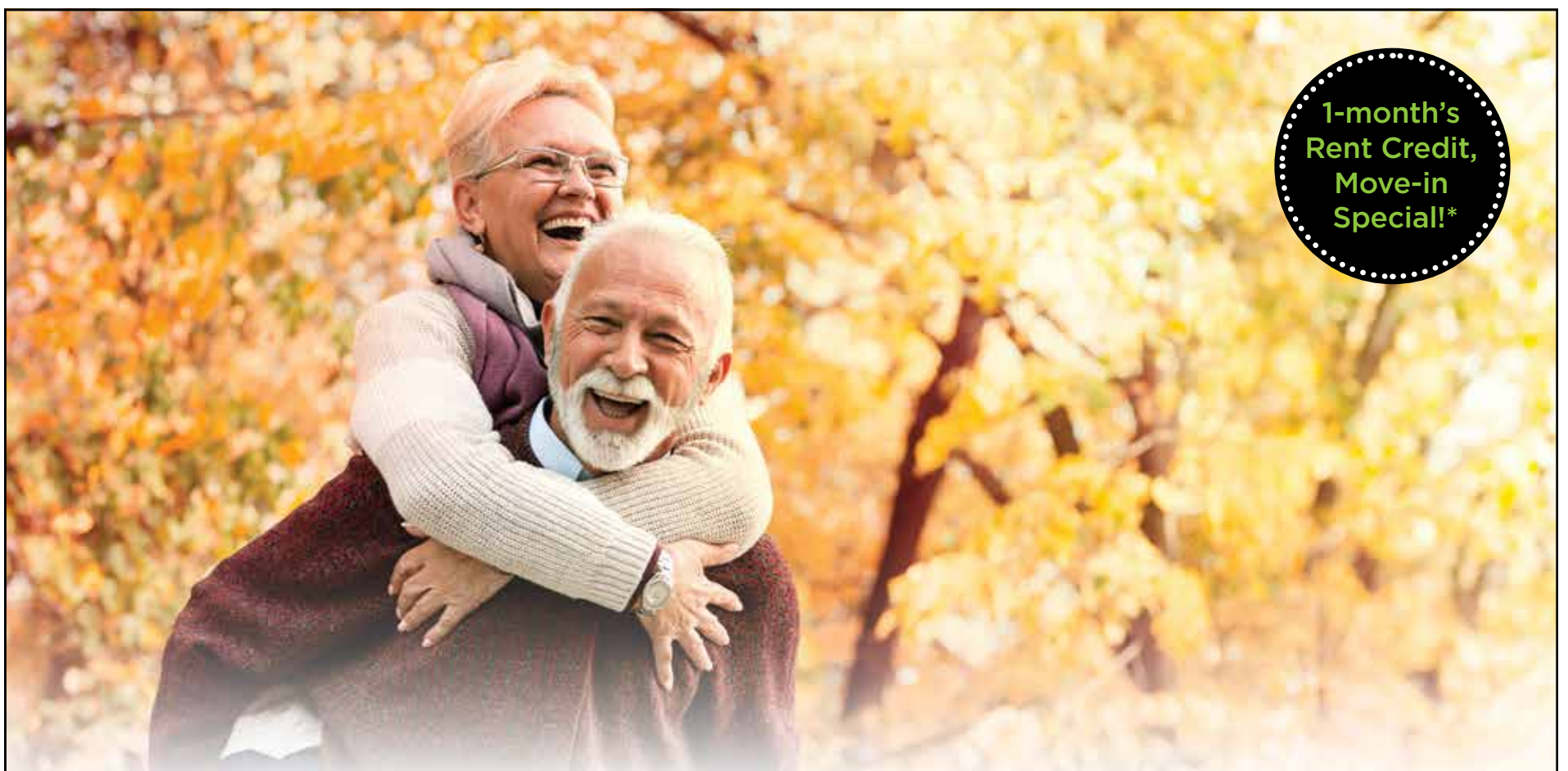
"Our STARS volunteers play such an important role in helping kids get on track with reading, but they also become role models for

the kids and help them build confidence," said Dr. Dawnté Early, president and CEO, United Way California Capital Region. "We know that if kids aren't reading at grade level by fourth grade, they will have a much harder time keeping up in all school subjects. We also know that education is a ladder out of poverty. Our STARS volunteers can truly change the course of a child's life."

The local United Way has been helping children improve literacy for more than five years, including through its AARP Experience Corps program that paired retirees with children in schools before the pandemic hit. United Way's STARS uses the BookNook platform to virtually work through literacy curriculum with participants and build their vocabulary, fluency and comprehension skills through a variety of games,

books and lessons provided in the online portal during the pandemic. The program is now offering in-person opportunities alongside its virtual platform.

# State of City in Relief

**CITRUS HEIGHTS, CA (MPG)** - The City of Citrus Heights hosted its annual State of the City Address on Thursday, October 20, 2022, in a special celebratory evening highlighting the City's 25th anniversary since incorporation in 1997 with featured speakers City Mayor Porsche Middleton and City Manager Ash Feeny.

"Tonight, we honor our history, and the hard-won foundation on which we stand in this moment that was laid for us by residents who had a dream for Citrus Heights to steward its own future," said Mayor Middleton to a group of approximately 80 community members and leaders gathered at Citrus Heights Community Center.

The young mayor was relieved that post-pandemic hurdles were winding down this year, and the community was getting back into a more optimistic "best is yet to come" vibe.

This included Sunday Funday on Sept. 25 which she said, "came back with a bang just in time to celebrate our 25th Anniversary." She reported over 4,000 attending at what has become the City's annual signature event.

Throughout the evening, Middleton spotlighted the recent book release 'Becoming Citrus Heights' by Miranda Culp and Bill Van Duker, which chronicled the City's struggle towards self-determination, to learn more about Citrus Heights history.

During her month-by-month look at the past year, Mayor Middleton focused on key accomplishments for 2022 including: City Hall's efforts during the pandemic to streamline online services and permits while maintaining high levels of satisfaction from residents

and businesses; Introducing the SeeClickFix app which "allows residents and businesses to request service for issues... around town like potholes, graffiti, and streetlight repair," and Councilmember Jeannie Bruins holding the first-ever Prospective Council Candidate Workshop, giving "community members an in-depth look at what it means to be a Councilmember while also providing a high-level overview of the City as an organization."

Mayor Middleton also celebrated the emerging trail system which is dramatically transforming the aesthetic feel of Citrus Heights as it connects parks, schools, shopping centers and neighborhoods and is imparting on respective vicinities "highly desirable amenities... already being marketed in real estate listings for nearby homes."

Newly appointed Citrus Heights City Manager Ash Feeny was the second official speaking at this year's State of the City Address.

As a new face to the Citrus Heights political scene, Feeny said he spent his first 100 days in approximately 80 meetings attempting to distill the distinct community priorities and areas which needed the most attention.

Together with City staff efforts at surveying residents, 4 main areas to focus on emerged as the strategic objectives to be held until 2024: Infrastructure, Economic Development, Community Connection and Community Image.

The manager devoted a considerable amount of attention as to "what's on the horizon" for Citrus Heights in the economic-development and

community-image dimensions.

Feeny said the one-time ARPA funds were a boon to the City's fiscal recovery because people chose to use their newly gained purchasing power locally, contributing to "revenues being higher than projected during that period."

Another immense aid to the long-term stabilization of fiscal matters, Feeny said, "[was] paying off the line of credit, thereby saving on interest payments, and returning to a debt-free status."

The new city manager noted that the budget will be short approximately \$12 million annually to keep up with infrastructure maintenance, largely due to a "long history of deferred maintenance," which was a large part of the original impetus for Citrus Heights to incorporate.

Feeny said, "As part of the 10-year forecast, we are

prioritizing infrastructure with the dollars we have modeling a dedication of general fund dollars to infrastructure maintenance starting with \$2,000,000 in FY2023 and growing to \$4,000,000 in FY2024 and beyond. This dedication of additional dollars will help in making major road repairs and significantly augment our current resurfacing budget."

While Feeny acknowledged the steep challenge the City faces in the aforementioned economic infrastructure front, he did, nevertheless, bring good news to the task at hand.

He said, "One last comment on the budget, while the future of the economy is always uncertain, one thing that is certain, is that after 25 years, Citrus Heights will finally be receiving property tax revenues that previously went to the County."

To this bright light at the end of the tunnel, the audience was compelled to give a much-awaited applause of relief for the City's economic future.

Feeny reported that Citrus Heights residents who participated in a community beautification survey expressed a desire to have homeless camps cleaned up, address illegal dumps, and remove litter from rights-of-way and open spaces.

The manager said the City is working with government agencies to share the responsibility of this task and reported that the I-80 on-ramp on Antelope Road showed a tremendous improvement in this area.

City leaders have agreed to step up the effort in dealing with homelessness in a balanced approach, said Feeny, and will be insisting that accountability and consequences will follow for those who chronically violate "local codes and ordinances" infringing on the rights of the community. ★

# Blankets for Sacramento Kids Readies for Holiday Giveaway

**SACRAMENTO REGION, CA (MPG)** - Every September, SBSK picks as many of the lowest-income elementary schools we can and finds out how many kindergartners they have, and they make double fleece blankets (about 40" x 60") for ALL of them, and a little fleece pouch with a Beanie Baby in it to go with each blanket. SBSK gives these to the kids right before Christmas break. (Even during this time of distance learning, the teachers will get these to their students.) Some of these kids live in their cars or in places without heat.

And this is ALL they get for Christmas.

The double fleece blankets and Beany Babies are WILDLY popular with the teachers AND the kids! Spread the word, too! We've done this for 9 years and hope to continue doing it, as long as we can get Beanie Babies. In 2022, SBSK will need 1,400 blankets and Beanie Babies.

Huckleberry's Breakfast Lunch with a major construction facelift or selling the franchise directly to Garcia, allowing him to be an independent owner.

"They informed us in September that we had a month to decide to rebrand as a Huckleberry's or continue on a different path. So, I did."

During the ownership change, customers will continue to order popular breakfast, lunch and dinner choices off the former Perko's restaurant menu while new menus are being printed. Breakfast will continue to be offered all day. A new milkshake machine and smoothie machine has been installed.

A re-opening celebration is tentatively scheduled Friday, November 4th for the public.

"We'll be continuing many of the popular menu favorites, but offering some new choices," he said.

Being an independent restaurant owner, and not required to purchase food through a restaurant management company, Garcia said he will be able to source his food locally, and keep his prices down,

as he has with Erica's Café, the other local restaurant he owns.

Garcia, who emigrated from Mexico, recalled working his way up from dishwasher to a Denny's general management in 20 years, before going out on his own as a restaurant owner. It's a profession he loves, he said, and enjoys meeting and serving his customers.

"CH Café & Grill is a bit larger than Erica's Café, but it will have the same family-friendly feel. We look forward to earning the trust of our customers as we welcome new ones." Garcia purchased Erica's Café in January 2019 before the pandemic and hopes to build on its success.

Customers will also be able to order through popular delivery options and a new website will debut soon, he said.

The new CH Café & Grill, which had been quite popular with local seniors under the former Perko's restaurant brand for many years, will continue to offer "classic American style home-style meals, scratch made breakfasts, burgers, and a slice of pie or a milkshake at an affordable price."

Garcia said he worked with a graphic designer to create a citrus-themed

logo to create a new brand identity which he feels identifies better with the local Citrus Heights community.

The restaurant now employs a staff of eight and looks to add more in the months ahead, Garcia said. "We're looking to be open 24 hours."

Interior renovations have already begun, with new kitchen equipment in place, new plank flooring and a fresh repaint inside. A large mural, running the length of the kitchen counter, dating back to when the restaurant was originally a Denny's continues to give customers a familiar old-style diner experience.

Renovations to a banquet room which has a capacity of 50 are ongoing, with new doors added for privacy. Garcia said he's hoping to market the room to local community groups for their use.

CH Café & Grill is located at 6215 Sunrise Boulevard in Citrus Heights near the corner of Sunrise Boulevard and Greenback Lane. Call 916-721-0670 for more information. Open 6 am to 10 pm Monday through Thursday, Friday and Saturday from 6 am to 11 pm, and Sunday from 6 am to 10 pm. ★

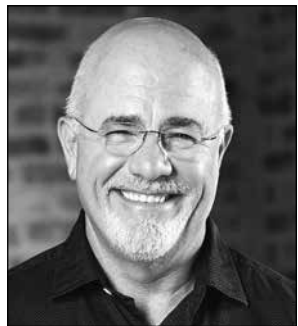

## Dave Ramsey Says

### Help! I'm Behind on Everything

Dear Dave,

I need help. I am way behind on my basic utilities and my taxes. I have tried to start the Baby Steps, but everything is so overwhelming right now that it is easy to get discouraged. I am 33, I live in Los Angeles, and I average around \$30,000 a year doing behind-the-scenes work in the entertainment industry. My total debt is about \$10,000. Can you give me some advice?

– Cameron

Dear Cameron,

I know you're in a scary place right now, brother. But I'm glad you're getting on board and that you want to move in the right direction with your finances.

Before you start the Baby Steps, you should get current on all your bills. Make a list of all the bills you're late on and how much it will take to

get current on each one. Then, create a written, monthly budget. Once that's done, and all your expenses and income are accounted for, you're going to squeeze every penny you can from there and work your late list from smallest to largest until everything's current. You're going to feel a sense of relief — and accomplishment — every time you flip one of these bills. And believe it or not, the act of simply making a list will help reduce the stress you're feeling, because just by doing that you've established the size of the dragon. This dragon must die, and you are the knight who's going to kill it.

But listen, there are two sides to this equation — income and outgo. No offense, but \$30,000 a year as an income in Los Angeles stinks. You've got to do something to make more money. Hey, \$10,000 would literally change your life. Not everyone can say that. The bad news is, you've got \$10,000 worth of debt. The good news is, you've got only \$10,000 worth of debt. I'm not talking about some

little minimum wage deal, either. I want you making some real money. Don't do anything illegal, or something that would compromise your morals, but get after making some good money.

And long term? Dude, you might want to think about taking a step up in your industry or even a full-blown career change. I mean, you don't want to be making \$30,000 a year and still working a side job when you're 50, right?

You could be debt-free, and have a much better life, in a year or less, Cameron. Go do this.

# Home Invasion Barricaded Suspect Taken into Custody

**FAIR OAKS, CA (MPG)** - On Sunday, October 13, 2022, at approximately 8:07 p.m., Sacramento Sheriff's Office helicopter assisted Citrus Heights Police Department with a pursuit of a stolen vehicle. During the short pursuit, the suspect's vehicle collided with a tree, and the suspect fled on foot carrying a handgun. The suspect attempted to get into a nearby residence and was unsuccessful. The suspect then jumped over a fence and forced his way into an occupied residence located in the 6000 block of Long Acres Court within the unincorporated county of Sacramento.

As officers surrounded the house, a resident came out and advised officers that his wife was still inside. While preparing a plan to rescue the female, she jumped from a second-story window moments after the suspect forced his way into the room where she was hiding. The elderly woman was safely rescued by officers but was injured and transported to a local hospital for treatment of injuries resulting from the fall.

The Sacramento Sheriff's Office Special Enforcement Detail (SED) and Critical Incident Negotiations Team (CINT) took over the incident and handled it as a barricaded subject. After several hours of negotiations and de-escalation techniques, the suspect was safely arrested with the assistance of a Sheriff's K9 and a less lethal

weapon deployment. Citrus Heights officers transported the suspect to a local hospital for treatment of his injuries. A firearm was recovered at the scene.

The suspect is identified as James Jarrad, a 38-year-old resident of Contra Costa County, who was confirmed to be a parolee at large with a significant criminal history. Once treated for his injuries, he will be booked into the Sacramento County Jail on charges of Home Invasion, Felon in Possession of a Firearm, Fleeing an Officer, and Elder Abuse.

In dynamic and volatile incidents like these, the Sacramento County Sheriff's Office prioritizes the public's safety and bringing peaceful resolution. Each situation is different and requires a unique response. The Sheriff's SED and CINT teams are deployed together and employ a collaborative approach balancing tactics, intelligence, technology, and time to their advantage. During this over 6-hour standoff, we are confident that their constant threat assessment of the suspect coupled with his risk to the public, the teams' patience, and our partnerships with allied agencies was paramount in the situation's positive outcome.

# All Aboard: Caltrans Has New Passenger Trains

**SACRAMENTO, CA (MPG)** - Rail passengers in Northern California and the Central Valley will start enjoying a more comfortable and modern ride after Caltrans accepted into its fleet the first of seven Siemens Mobility single-level intercity trainsets at the San Joaquin Regional Rail Commission facility in Stockton.

“With train ridership recovering from the pandemic drop, these new trainsets will provide Californians with enhanced comfort and convenience as they move around the state,” said Caltrans Director Tony Tavares.

The new trainsets will operate on the San Joaquin rail corridor between Sacramento/Oakland and Bakersfield, connecting riders to jobs, education and leisure along the way. Passengers can expect spacious and modern interiors with amenities that include enhanced onboard Wi-Fi with power and USB ports at all seats as well as enlarged windows. The passenger cars also feature wider aisles and more comfortable seats, additional leg room, larger tray tables and expanded luggage storage options, with oversized baggage and bike racks. The trains are ADA accessible, including weatherproof gangways between

cars, wider aisles, retractable steps, and state-of-the-art touchless and much larger restrooms. Each coach car seats up to 70 passengers.

“These trainsets were designed with Californians in mind, both in terms of job creation here in Sacramento and next-generation passenger rail throughout the state,” said Michael Cahill, president of Siemens Mobility Rolling Stock in North America. “Together with Caltrans, we’ve created a trainset that is both safe and modern to keep passengers connected and on the move.”

With Caltrans officially taking ownership, the department anticipates the trainsets soon will enter service. These additional trains will help restore service to pre-pandemic levels, resulting in schedule improvements throughout the state’s rail service.

The Venture Trainsets for Caltrans were ordered from Sumitomo Corporation of Americas and are being designed and manufactured by Siemens. They are Buy America-compliant and built at the Siemens Mobility rail manufacturing facility in Sacramento. Powered by the California sun with two megawatts of solar energy and 2,400 employees, the facility has been in operation for more than 30 years. ★

# CHP Receives Grant to Increase Safety for Motorcyclists

**SACRAMENTO, CA (MPG)** - The California Highway Patrol (CHP) will implement a yearlong federal grant to help save lives and reduce the risk associated with riding a motorcycle.

The goal of the Get Educated and Ride Safe (GEARS) V grant is to decrease the number of motorcycle-involved crashes and victims through education and enforcement efforts across California through September 30, 2023.

From October 1, 2020, to September 30, 2021, there were 7,078 motorcycle-involved crashes resulting in 354 deaths and 6,400 injuries within CHP jurisdiction, an increase of 3 percent over the previous 12 months.

“Motorcycle riders are statistically more likely to be injured or killed when involved in a crash,” said CHP Commissioner Amanda Ray. “In an effort to ensure every motorist reaches their destination safely, the CHP will continue to

use enforcement and non-enforcement strategies, including education and community engagement, to target the leading causes of traffic deaths.”

During the grant period, the CHP will participate in traffic safety education efforts, such as

“May is Motorcycle Safety Awareness Month.” These campaigns will promote the use of U.S. Department of Transportation-compliant helmets for all riders and raise driver awareness of sharing the road with motorcyclists. The CHP will also increase enforcement in areas with a high number of motorcycle-involved crashes, which resulted from speed, improper turns, and driving under the influence of alcohol and/or drugs.

Funding for this program was provided by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration.

The mission of the CHP is to provide the highest level of Safety, Service, and Security. ★

# Social Security Matters

## Surviving Spouse Benefits Explained

**Dear Rusty:** Y If I file at age 63 what percentage does my wife receive if I die? Does this percentage change if I wait to file closer to my full retirement age? And what does my wife receive if I die before I file for my benefits?

**Signed: Planning Ahead**

**Dear Planning:** When you file for your own Social Security benefit will affect the survivor benefit your wife is entitled to as your widow. If you claim at age 63, her benefit as your widow will be based on your age 63 amount. If you wait longer to claim your own Social Security, your own benefit will be higher and so will your wife’s entitlement as your survivor. In other words, your wife’s benefit as your widow will be based on the amount you are receiving when you die, and the longer you wait to claim your own Social Security, the higher your wife’s survivor entitlement will be.

Exactly how much your wife will get monthly as your widow depends also on her own age when she claims her survivor benefit. If you were to die first, your

wife can claim a reduced survivor benefit as early as age 60 but doing so will result in a benefit which is 28.5% lower than it would be if she waits until her own full retirement age (67) to claim. Survivor benefits do not reach maximum until the survivor reaches full retirement age (FRA) and, if claimed before that, the benefit will be reduced by 4.75% for each full year early, to a maximum reduction of 28.5%. So, although your wife’s base survivor benefit will be the actual (100%) amount you were receiving when you die, her monthly survivor payment will be reduced if she claims the survivor benefit before her FRA. It is an actuarial reduction of .396% less survivor benefit for each month prior to FRA the survivor benefit is claimed.

If you wait to file for your own benefit but die before you actually start collecting your benefits, your wife’s entitlement as your widow will be based upon the amount you were entitled to when you died. She will not lose her survivor benefit - it will be based upon the amount you were entitled to when you died, even though you had not yet claimed. Your wife can also delay claiming her survivor benefit until she reaches her FRA to maximize her benefit as your widow. But there is more to consider.

If your wife is working full time, it is often not prudent (and may not be possible) to collect Social Security benefits before

reaching full retirement age. That’s because of Social Security’s earnings test, which limits how much can be earned while collecting SS benefits before FRA. The earnings limit for 2022 is \$19,560 (changes yearly) and if that is exceeded SS will take away benefits equal to \$1 for every \$2 over the limit. If the limit is significantly exceeded your wife could be temporarily ineligible to get benefits, until her earnings are less, or until she reaches her full retirement age (the earnings limit no longer applies when FRA is reached).

Finally, it’s important to note that all Social Security rules are gender-neutral, meaning that the rules apply equally to both spouses. But in any case, a surviving spouse can only get one benefit - either their own or their survivor benefit, whichever is highest.

## Spooky, Creepy and Tasty Too

Halloween straddles fall and winter...life and death. It's thought to have originated with the ancient Celtic festival of Samhain. People would light bonfires and wear costumes to ward off roaming ghosts. The Celts, who lived some 2,000 years ago in the area that is now Ireland, the United Kingdom, and Northern France celebrated the New Year on November 1. This day marked the end of summer and the harvest, and the beginning of the dark and cold winter, a time of year that was often associated with human death. Celts believed that on the night before the New Year, the boundary between the worlds of the living and the dead became blurred. That's why on October 31, they celebrated Samhain. Then Halloween came to America, but extremely limited in colonial England because of the rigid Protestants. It was much more common in Maryland and the southern colonies. Today's tradition probably dates back to the early All Soul's Day parades in England. During the festivities, poor citizens would beg for food and families would give them pastries called "soul cakes" in return for their promise to pray for the family's dead relatives. The soul cake was encouraged by the church as a way to replace the ancient practice of leaving wine and food for roaming spirits. Merging different ethnic groups and Native American Indians gave America its own Halloween. The first ones were party-driven and public events to celebrate the harvest. Neighbors would share stories of the dead and tell fortunes. Colonial Halloween festivals added ghost stories and America began dressing in costumes and going house



to house asking for money for food. That's when "trick or treat" was born. Young women believed they could divine the name or appearance of their future husband by doing tricks with yarn, apple parings and mirrors. By the late 1800s, there was a move to mold Halloween into a holiday more about community and neighborly get-togethers than about ghosts, pranks and witchcraft.

*Through the generosity of the Citrus Heights Messenger, this column serves to provide an update about matters affecting the community of Citrus Heights.*

As I come to the close of my sixth year on the Board of Supervisors, I have seen many issues fall and rise in terms of importance for the residents of Sacramento County. For example, homelessness went from an issue that I barely ever received a phone call about when I first entered office, and transformed into one of the biggest issues on most people's minds. But one issue has remained troubling to Sacramento County residents since the day I entered office until now, and that is the deplorable condition of Sacramento County roads.

I fully sympathize with these concerns because I am also upset. My house backs up to Madison avenue, and every single day that I leave my home I am driving on road conditions that are frankly embarrassing. And due to this, one of the primary questions I receive from people when I speak in my community meetings is "why can't you fix the roads in the County?" I wish it were that simple, because if it were I would have done it years ago. So I want to take this opportunity to explain why it's not so simple, and what we can do to change things.

What many people do not understand is that the

vast majority of funds that are spent on local roads are from the state and federal government. Not only that, but many of these funds are competitive dollars, meaning we are only going to win those funds for major projects that have nothing to do with resurfacing, like the road widening happening right now on Hazel Avenue. So even if I wanted to prioritize local road resurfacings, the money Sacramento County could divert towards roads would be insignificantly small compared to what the state and federal government have the ability to do.

The problem Sacramento County is experiencing with our roads is not localized to just our county or even region. This is a problem afflicting the entire State of California, as of last count our state had over \$47.3 billion in road maintenance that has been postponed due to not having enough money for our roads, highways, and bridges (also called deferred maintenance). This enormous deferred maintenance bill would feel more understandable if California was broke, but at the same time we have this bill we are spending outrageous amounts of money on California High-Speed Rail (CAHSR), which in my opinion is only a fraction as important as having reliable roads. CAHSR has the potential to benefit a small fraction of the population, specifically those that would use it to commute. Meanwhile, roads are used by everyone, including passengers, freight, fire service, police service, etc. To top it off, the train doesn't even come close to Sacramento County, as the

furthest north it goes is San Francisco.

When voters approved CAHSR in 2008, it was supposed to cost \$34 billion and be completed by 2020 connecting San Francisco to Los Angeles. Four years ago this price tag had risen to \$79 billion, earlier this year the 2022 draft business plan estimated it would cost \$105 billion, and just three months later the "final plan" raised the estimate to \$113 billion. And not only do these costs continue to rise, but there is still no certainty the complete project will ever get built. Just the Merced to Bakersfield section of the project (which is supposedly the "easiest" section to build) has an earliest competition date of 2029, but this is a date that just keeps getting extended, as four years ago that date was 2024.

Even if we let CAHSR continue to build the central valley line and we abandoned CAHSR after that, we would save enough money to pay for every cent of deferred maintenance for all roads, highways, and bridges in California. The California Legislature and the Governor have the capacity to fix our roads, they just need to change their priorities and focus on what California needs the most.

## Veterans and Suicide

Veterans Day, November 11th, is an important day for every American and is intended to honor America's veterans for their patriotism, love for their country, and willingness to serve and sacrifice for the common good. This day of remembrance celebrates the service of all U.S. military veterans. Communities across the country plan events to honor those who have served and are currently serving. As we celebrate and recognize these brave men and women, we should also consider the struggles that they go through with mental illness.

Suicide is a national problem in the U.S. and a major concern for active-duty service members and military veterans. Members of the military may experience a variety of difficult and traumatic events including combat, natural disasters, and physical assault. According to the 2022 National Veteran Suicide Prevention Annual Report, there were 6,146 Veteran suicide deaths in 2020. That is 31.7 deaths per 100,000. During that year, suicide was the second leading cause of death among Veterans under age 45. The suicide rate for Veterans was 57.3% greater than for non-Veteran U.S. adults.

Veterans can come home from service carrying a weight they did not go in with. Without the right help, that weight can seem like too much, leading some Veterans to consider, or carry out, suicide. Some of the warning signs that Veterans exhibit include feelings of hopelessness, acting agitated, struggling with

anxiety, insomnia, outburst of anger or rage, an increase in substance use or abuse, and isolating themselves from the people close to them. Other factors related to the higher risk of suicide among Veterans are related to undiagnosed or untreated conditions, such as PTSD or mood disorders, which can increase a person's overall risk of suicide.

The VA offers a wide range of treatment programs for Veterans and their families. Also, "Vets for Warriors" is a peer support network with Veterans answering the phone for those in need. The number is 1-855-838-8255. Veterans may also use the Veterans Crisis Line Number where there is 24/7 crisis support. Dial 988, then press 1.

The Jason Foundation is another valuable resource for those struggling with suicidal ideation. Many times, a Veteran will exhibit clear warning signs prior to an attempt. By knowing the warning signs, and knowing how to help, you could save a life. # Halloween Safety Tips for Pet Owners

**SACRAMENTO COUNTY, CA (MPG)** - This Halloween, don't let your pet get spooked! From decorating to celebrating, you and your pet can enjoy a stress-free holiday by following a few simple safety precautions.

**Candy is for "ghouls and goblins," not household pets:** All chocolate can be very dangerous for dogs and cats. Symptoms of significant chocolate ingestion may include vomiting; diarrhea; hyperactivity; increased thirst, urination and heart rate; and seizures. Candies containing the artificial sweetener xylitol can be poisonous and deadly to dogs. Even small amounts of xylitol sweetener can cause a sudden drop in blood sugar, which leads to depression, lack of coordination and seizures. Ingesting tin foil and cellophane candy wrappers can pose a choking hazard or cause intestinal blockage.

**Decorate Accordingly:** Pumpkins and decorative corn used for decorations are considered to be relatively non-toxic, but they can produce

gastrointestinal upset in pets if eaten. Keep wires and cords from electric lights and other decorations out of reach of your pets to reduce the chances of injury or electrocution.

**Jack-O-Lantern Safety:** Pets can easily knock a lit pumpkin over and cause a fire. Curious kittens especially run the risk of getting burned or singed by candle flames.

**Holiday Costumes:** Don't put your dog or cat in a costume unless you know they love it. For a pet not used to dressing

up, wearing a costume can cause undue stress. Instead of a whole costume, consider a bandana or colorful collar instead. If you do dress up your pet, make sure the costume isn't annoying or unsafe. It should not constrict the animal's movement or hearing, or impede his/her ability to breathe, bark or meow. Also, try on costumes before the big night.

If your pet seems distressed, allergic or shows abnormal behavior, it's time to take the costume off. Make sure the costume

fits your pet correctly, and that it does not have small, dangling or easily chewed-off pieces that they could choke on. If you're dressing yourself up for the holiday, be mindful of what might scare your pet. Many pets can be spooked by masks, hats and heavy costume makeup. If your pet is easily scared, consider a costume that won't conceal your appearance.

**Keep Your Pets in a Quiet Environment:** Dogs and cats should be kept in a separate room away from the front door

during peak trick-or-treat visiting hours. When opening the door for trick-or-treaters, take care that your cat or dog doesn't dart outside. If hearing the doorbell ring or the sounds of strangers' voices is stressful for your pet, consider leaving a bowl of candy outside with a sign and refilling as necessary.

**IDs, please:** Always make sure your dog or cat has proper identification. If for any reason your pet escapes and becomes lost, a collar and tags and/or a microchip can increase

the chances that they will be returned to you. If your pet already has a microchip, please check that it is updated with your current contact information.

**A Word About Black Cats:** Consider adopting a black cat from the Bradshaw Animal shelter, as they are just as wonderful a pet and are only half as likely to find forever homes.

**CITRUS HEIGHTS, CA (MPG)** - A new family resource center has opened at Mariposa Elementary School at 7940 Mariposa Avenue in Citrus Heights offering a broad range of community-based, family-focused support and help for local parents and families.

Mariposa School principal Kristin Finney publicly recognized the collaborative effort to open the center located in classroom seven across from the school's main office which was almost two years in the making.

Finney thanked representatives of multiple community groups in attendance including Ruth Fox, president of the Area 6 Neighborhood Association and a member of Heights Church in Citrus Heights, her spouse, former city councilmember Al Fox, on behalf of the Citrus Heights Rotary Club, members of the Mariposa Parent Faculty Organization (PFO) and the San Juan Unified School District's Family and Community Engagement Department (FACE) who came together to help refurbish the classroom for its new purpose.

Citrus Heights Mayor Porsche Middleton said her son attended Mariposa before advancing to Sylvan Middle School. "It takes a team to create this, and I'm very blessed that it has."

Mike McKibbin, a member of the San Juan Unified School District Board also offered remarks in praise of the new center and the purpose which it will now serve.

The new Mariposa Avenue Elementary School Family Resource Center is one of two in the San Juan Unified School District (SJUSD), specifically serving students and families in the greater Citrus Heights area. A second resource center, in Greer Elementary School, serves the western portion of the San Juan School District, McKibbin said.

Finney said the center will be open Monday through Friday from 7:45 am to 9 am and 1:10 pm to 2:30 pm. Visitors to the School Community Resource Center should check in first to the school office upon arrival, she said.

Mariposa Elementary School serves

a rich diversity of students of whom, 83 percent are in a low socio-economic bracket, Finney said. Over 12 different languages are spoken by students attending Mariposa Elementary School.

"The new center will help our students and families feel welcome and an important part of their community," she said.

Bulletin boards with useful information about local resources and programs, an adults-only computer section with internet access, and spaces for families to meet one-on-one with teachers and school staff are also provided in the new space.

The center will also provide a space for parents and families to prepare for parent-teacher conferences and to support student academic progress and school attendance.

A children's play area is available. Daycare will be provided when needed to ensure a productive appointment at the center.

"We've also set up a food closet and have children's clothing here for parents and families who may need them," Finney said.

Members of the Heights Church helped collect and donate over 200 bags of groceries to fully stock the food closet.

Finney, who became principal at Mariposa two years ago, also cited the success of another community-oriented program, Soles for Young Souls established at Mariposa Elementary School, as she reached out to parents, teachers and local community groups to help realize the goal of opening a community resource center at Mariposa.

Soles for Young Souls, Inc., a non-profit tax-exempt charity, was established on the school campus in 2018. The charity was established through efforts made by former Mariposa school principal Leslee Cottrell and is fostered by Linda Fisher, charity president, Jackie Rittenhouse, vice-president/secretary and Ruth Fox, treasurer.

Ongoing donations of shoes and socks to meet the needs of the school's students, as well as gently used children's clothing in good condition, are welcome. For information about making donations, contact the school office at 916-971-5212. ★

## UC Davis Health Nurse Honored for 'Rocking' Nursing World

**SACRAMENTO, CA (MPG)** - The National Black Nurses Association (NBNA) has named Aron King a 2022 Under 40 Awardee. King, an assistant nurse manager at UC Davis Medical Center and a 2021 graduate from the Betty Irene Moore School of Nursing at UC Davis, is one of only 16 nurses in the nation to receive the honor.

"These nurses are our present and our future. They are the next generation of nurse leaders," said Martha A. Dawson, NBNA president. "We look forward to honoring these NBNA young notables under the age of 40 who are rocking the nursing world through professional and educational achievement, leadership and civic involvement in their NBNA chapters and in the communities they serve."

After caring for patients as a bedside nurse for 8 years, King entered the master's-degree leadership program at the School of Nursing in 2019. He said through that educational experience he began to see the bigger picture of how he could serve the Black community and inspire future Black nurses. He joined the Capitol City Black Nurses Association, founded by School of Nursing alumni, to advocate for the needs of nurses and optimize health outcomes in communities where health disparities persist.

"Health care is in a battle to undo decades of valid mistrust in communities of color. From unjust medical trials to the treatment of undocumented people and those battling drug addiction," said King, the organization's former secretary who now serves as an executive board member. "Winning the trust of these communities means having a workforce that has representation. We have work to do."

understanding how microaggressions in health professions schools can poise students for inclusion. She said King is deeply deserving of this honor.

"Aron is being recognized for his commitment to high quality practice, his accomplishments as a leader and his work as a scholar," Ackerman-Barger explained. "It is an honor to have him join us once again as he pursues his Doctor of Philosophy (PhD) at the School of Nursing."

Next month, King enters the school's PhD program. He expects with the rigorous research program and the demands of his nursing career, the lift to continue the drive to end disparities will be heavier.

"The role of a nurse is not limited to the bedside and we as nurses shouldn't measure our worth by looking at technical skills," he said. "We are advocates and leaders in patient care. We need to be proactive in our approach by investing our energy in preventive interventions."

NBNA honored this year's winners at its 50th Annual Institute and Conference in Chicago. NBNA is comprised of nurses at all levels and serves as the voice for Black nurses and diverse populations to ensure equal access to professional development, promote educational opportunities and improve health. ★

# California May Reallocate Shrinking Water Supply

which agricultural water agencies would curtail diversions to maintain river flows, but results have been scanty at best.

Without such agreements, the water board could implement mandatory reductions, but they would be viewed by farmers as an assault on their historic water rights and probably trigger massive legal battles.

The key principle in these conflicts is that water belongs to the public as a whole and must be put to “beneficial use,” as defined in a 1943 law that implemented a constitutional declaration passed by voters in 1928. The law commands authorities to prevent “waste or unreasonable use or unreasonable method of use of water...”

Environmentalists believe the constitution thus authorizes the state water board to curtail agricultural diversions for the protection of habitat, but the 1943 law also declares, “In the enactment of this code the Legislature does not intend thereby to effect any change in the law relating to water rights.”

That obvious legal dichotomy is the crux of the situation.

Whether, indeed, the state water board is gearing up for a showdown over water rights, some of which stretch back to the 19th century, is the subject of much speculation in water circles.

Early this year, water board chairman Joaquin Esquivel told a gathering of water officials, “We know we have to change the system. Water rights can be there as a tool to be able to manage supplies through not just a drought but when

there is water again. Our water rights system can be there to facilitate decisions on projects and help us make decisions, or they can be a hindrance.”

While the water rights issue percolates in Northern California, there’s a similar conflict underway in Southern California over how much water the state diverts from a severely threatened Colorado River.

California is legally entitled to 4.4 million acre-feet per year, with the vast majority of that going to the Imperial Irrigation District and other agricultural users, but the Colorado’s flow has dropped dramatically.

The federal government demands that California and other states that draw from the river, principally Nevada and Arizona, reduce diversions by 2-to-4 million acre-feet per year, and threatens to mandate cuts under the “beneficial use” doctrine if they cannot agree.

California has offered a 400,000 acre-foot reduction, only 9%, but that’s not enough to satisfy the other states and the outcome is very much in doubt. Meanwhile, the feds are offering Colorado water users \$400 for every acre-foot of water they don’t take.

Farmers’ water rights are clearly not as sacrosanct as they once seemed to be, and as drought persists the stage is being set for a monumental reckoning of some kind.

# Who Let the Dogs Out? We Did.

**SACRAMENTO COUNTY, CA (MPG)** - It was all fun and games for the dogs at Sacramento County’s Bradshaw Animal Shelter last month.

The shelter was chosen to participate in three intensive, all-day training workshops with Dogs Playing for Life (DPFL), a 501c3 nonprofit organization rooted in a dog’s natural instinct to play. The sessions, which taught staff how to conduct successful large-scale playgroups to increase dogs’ adoption prospects as well as provide efficient and effective socialization and exercise, took place from Sept. 28 - 30, 2022. Over three days and a series of playgroups, more than 100 dogs ran, wrestled and rolled around together.

The play model is part of an innovative approach to animal sheltering: one that aims to make a stay at the shelter more like a fun trip to summer camp and less like time behind bars. DPFL furthered staff’s expertise of dog behavior by teaching them how to assess nuances of play styles and body language in order to create dog playgroups that bring out the best in animals while minimizing the risk of injury or spread of infection.

“A big misconception is that it’s too risky to let dogs play or that shelter dogs have to be carefully taught how to socialize,” said Lauren Revier, Program and Research Administrator for DPFL. “It’s natural for dogs to interact and play, and when playgroups are approached thoughtfully, most dogs can participate and enjoy them.”

Dogs that have the most difficult time getting adopted stay in shelters the longest

and are most at risk of developing behavioral issues due to prolonged shelter stress are generally those that aren’t social with other dogs. Most adopters and rescue groups seek out dogs that play well with others since the majority of homes interested in fostering or adoption already have at least one dog at home. These playgroups can help the less social dogs develop the dog-to-dog skills they need to adopt and succeed in their new homes.

“When you focus on meeting a dog’s needs—their needs for mental enrichment, physical exercise and socialization—you see that many behavioral issues tend to disappear or are greatly reduced,” said Annette Bedsworth, Director of Bradshaw Animal Shelter. “Oftentimes, we can meet those needs through one simple thing: play. We’re not only going to see major quality of life increases for our dogs by implementing more playgroups, but by making our shelter a place that prioritizes the opportunity for dogs to safely have fun and just be dogs, we’re going to be able to save even more lives.”

Shelter staff plan to carry out what they learned from DPFL in ongoing future playgroups. In large municipal shelters like Bradshaw Animal Shelter, where the numbers often tip past 300 pets on site, it is a daily endeavor for shelter staff and volunteers to ensure every animal gets quality time outside of their kennels each day. Not only will the playgroups give dogs more time to run free, but they will enable staff and volunteers to spend individualized time with dogs that need it most, such as the ones that are extremely scared and shut down in the shelter environment. ★

# New Federal Funding to Help California

**DOT News Release**

**SACRAMENTO, CA (MPG)** - California has the green light to start using federal infrastructure funding to expand electric vehicle (EV) charging stations along the state's interstates and highways following the recent federal approval of a joint plan by Caltrans and California Energy Commission.

The U.S. Joint Office of Energy and Transportation's signoff on the California Deployment Plan for the National Electric Vehicle Infrastructure (NEVI) Program makes an initial \$56 million in funding available to install charging stations throughout the state. Funded by the federal Infrastructure Investment and Jobs Act of 2021 (IIJA),

California expects to receive a total of \$384 million for the program over the next five years. The federal funding will build on California's historic \$10 billion, multiyear investment to accelerate the transition to zero-emission vehicles by improving affordability and expanding charging infrastructure.

"Thanks to the Biden-Harris Administration's approval of California's NEVI plan, we can start putting historic levels of federal infrastructure funding to work to close gaps in our state highway system's evolving EV charging network and improve availability and reliability for low-income and rural residents," said California Transportation Secretary Toms Omishakin. "Coupled with unprecedented

levels of state investments in zero-emission vehicles, this funding will help supercharge California's nation-leading efforts to drastically cut climate-changing pollution from the transportation sector."

The IIJA funds will add to efforts to complete a 6,600-mile statewide charging network and deploy 1.2 million chargers by 2030 to meet the anticipated charging needs of the state's EV fleet.

"With this unprecedented federal investment, California can advance our vision of a unified network of charging stations along the state's busiest corridors," said California Energy Commission Commissioner Patty Monahan. "This new network will increase charging access,

particularly in the rural areas of our state, and help EV drivers charge up on long trips."

The state's NEVI plan focuses on construction of fast-charging stations near interstates, U.S. routes and state routes throughout California. These charging stations will increase the availability of charging options, improve the reliability of the charging network and remove barriers to accessing EVs. NEVI funding will also support upgrades to existing infrastructure, charging stations' operation and maintenance costs, community and stakeholder engagement, workforce development, and related mapping and signage.

California surpassed one million zero-emission vehicles (ZEV) sold in 2021 and leads the

country in all ZEV market metrics including the highest level of public funding, the largest EV market share percentage, and the most extensive public charging infrastructure. The success of the state's programs has led to ZEVs becoming a top export and has spurred major advances in manufacturing and job creation.


