

Moving Past Hard Times

Council Approves a Variety of New Funding Allocations

CITRUS HEIGHTS, CA (MPG) - The City of Citrus Heights allocates money each year to the Economic Development Support Fund, which provides grants to businesses and organizations for events, promotion, and other eligible activities. A total of \$154,000 was allocated for the 2021-2022 fiscal year and \$104,414 is currently available. At the June 23 meeting, the Citrus Heights City Council considered an application from Royal Stage (a performing arts nonprofit with both youth and adult participants), which requested

\$25,000 in grant funding to establish a performing arts venue in Sunrise Mall. The funds would allow Royal Stage to transform a vacant retail space in the mall into a performance and rehearsal space.

Economic Development and Communications Manager Meghan Huber explained that the application meets the fund's guidelines since it will promote Sunrise Mall, attract new shoppers to the location, and diversify the retail space by bringing art and culture into the environment. Huber also said the new space would provide a community benefit by enhancing vibrancy and engagement

at Sunrise Mall.

The grant would be used for construction costs, marketing, and programming, and per the grant guidelines, the funding would be distributed through reimbursement of expended costs up to grant amount.

Councilmember Jeannie Bruins said, "I think this is a really good example of innovative reuse. Not only will it bring something new to Citrus Heights that we don't have right now, which is a performing arts center that children will participate in ... this type of venue will be able to change and grow with us

California Sheriffs Issue Public Alert Following DOJ **Data Breach**

SUTTER COUNTY, CA (MPG)

- The California State Sheriffs' Association (CSSA) is alarmed to learn of a data breach by the California Department of Justice (DOJ) that has made public the personal information of California's citizen concealed weapon (CCW) permit holders.

CSSA is issuing this alert to make CCW permit holders aware of the situation so they can take appropriate precautions.

"It is infuriating that people who have been complying with the law have been put at risk by this breach," said CSSA President and Butte County Sheriff Kory Honea. "California's sheriffs are very concerned about this data breach and the risk it poses to California's CCW permit holders."

CSSA will continue to engage with DOJ in an effort to ensure that the risk to CCW permit holders is mitigated and a breach of this nature does not happen again.

Every law enforcement agency in California that issues CCW permits is required by law to provide certain information about CCW permit holders to DOJ, which in turn is required to safeguard that information. The data breach was in conjunction with DOJ's launch of its "2022 Firearms Dashboard Portal." The breach included, but was not limited to, the names, ages, and addresses of individuals who hold CCW permits in California. It appears that before the breach was detected by DOJ, the information was copied and at least some portion of it was posted on the internet.

After learning of the breach, CSSA President and Butte County Sheriff Kory Honea contacted DOJ officials. During that conversation DOJ confirmed there was a data breach involving CCW permit holder information. DOJ advised it has deactivated the dashboard and is working to determine the scope of the breach. DOJ stated it would be contacting all CCW permit holders directly to advise them of the breach and will institute a program to mitigate any harm or damages to CCW holders that result from the breach.

DOJ has issued a statement regarding this situation that can be accessed on their

Point in Time Count Report Released

SACRAMENTO COUNTY, CA (MPG) -

On June 28, 2022, Sacramento Steps Forward, the lead agency for the Continuum of Care in Sacramento County, released the 2022 Point in Time (PIT) count report.

The Point in Time count is conducted every two years within Sacramento County and provides the community with a snapshot of how many people may be experiencing homelessness on any given night. The count was last done it 2019 and was delayed from 2021 to 2022 because of the pandemic. This year the count was done on Feb. 23 and 24.

As expected, the overall number of persons experiencing homelessness at the time of the count is much higher than it was in 2019. While it is disheartening to know that more of our residents are unhoused, this report is useful to the overall County strategy and response tactics.

The County now has updated data not only on homelessness overall but on many specific sub-categories such as families, veterans, those living in cars, chronic homelessness and some of the conditions and barriers that are keeping people homeless.

What Sacramento County is Doing:

The County has been steadily increasing funding, resources and programs to serve not only our unhoused residents but mitigating the impacts of unsheltered homelessness communitywide. The needs of the unhoused can be complex and vary drastically from person to person - but one thing remains consistent - complex wraparound services cannot be impactful until people's basic needs are met. Food, water, shelter and sanitation are just a few of the basic and essential needs people have in order to stabilize

enough to receive more complex services such as mental health treatment and/or drug and alcohol rehabilitation.

The County recognizes the need for diversified responses to this complex problem – knowing that one solution is not right for each person, no timeframe works for every person, and no one service works for everyone. Instead, the County is investing in a myriad of programs, services and new sheltering and housing concepts to not only address current homelessness but prevent or divert homelessness to begin with.

One of the new, innovative projects the County is launching that will aid in helping people exit homelessness, is the recently approved "Safe Stay Community" model. These small, individual sleeping cabin communities will provide the privacy, dignity and respect that unhoused people deserve, while also meeting their basic

needs and giving them a stable environment to learn about and accept services that will help them exit homelessness.

Investments and Programs Targeting Mental Health, Families and Youth-The County has made significant investments through MHSA Funding for Housing and Homeless Supports. Since 2007, \$28M have been allocated to address homelessness in Sacramento County through the MHSA Housing Program and No Place Like Home Program. The County currently has 221 housing units funded through MHSA and an additional 234 coming in the next two years.

In FY 2019-20: **Housed** 563 clients/households; **Prevented** 1,431 clients/households at imminent risk from becoming homeless; **Served** 161 clients/households residing in MHSA-funded apartments; **Provided** rental assistance to 4,682 clients/households; **Provided** 7,815

services utilizing MHSA housing flex funds.

The County currently funds more than \$1 million in prevention and intervention services, primarily targeting youth and families;

The Board allocated \$10 million from ARPA-1 to create the Landlord Engagement and Assistance Program (LEAP) to provide landlord and tenancy supports and short term rental subsidies to help people quickly exit homelessness and sustain housing. LEAP will launch in the fall of 2022, and aims to augment other re-housing programs to help households quickly divert from homelessness;

In partnership with SHRA, the County launched the Sacramento Emergency Rental Assistance (SERA) program, providing one-time financial support totaling almost \$67 million to almost 7,800 families at risk of losing housing as of May 2022;

Over the past several years,

there have been regulatory, policy changes and new investments that have allowed the County to build out services out for foster youth and youth aging out of the system to prevent them falling into homelessness. The County has increased participation in Independent Living Programs, Transitional Housing Programs and Voucher supports for youth as well.

Point in Time Count by the Numbers:


The overall count increased 67% from 5,570 (2019) to 9,278 in 2022. While the overall number of people has increased, the percentage split of sheltered vs unsheltered – 28% vs 72% respectively, hasn't changed; which is indicative of increased bed capacity over the last three years;

Those reporting chronic homelessness has more than doubled. Chronic homelessness is defined as long periods of homelessness and the presence of a disabling condition such as behavioral health issues or drug addiction—1) Nearly 50% of those experiencing homelessness are considered 'chronic'; 2) 58% of unsheltered report disabling conditions vs. 40% in 2019; 3) 74% of the unsheltered population reports being homeless continually for more than a year.

There was a substantial rise in vehicles counted – in 2019, 200 vehicles were counted; in 2022, 1,100 vehicles were counted equating to 1,782 people. The report also notes the new trend of "vehicle encampments";

In addition to the Point in Time count, the report also provides an annualized count of person that experienced homelessness at some point in the last year – up to 22,000.

Yummy Tummy

CITRUS HEIGHTS, CA (MPG) - Five months after celebrating its grand opening, Yummy Tummy, a Mediterranean-style, Greekthemed restaurant at 7967 Auburn Boulevard in the Grand Oaks shopping center in Citrus Heights, continues to gain a growing customer following.

"My young daughter gave the restaurant its name," said owner George Abu. She said, "Dad, your food is always yummy, and my tummy loves it."

Yummy Tummy opened in January for lunch and dinner. The restaurant was previously occupied by a Mexican restaurant, Bella Cocina.

Abu appreciates the support of the Citrus Heights Chamber of Commerce which helped him celebrate his restaurant's grand opening, and efforts by the city of Citrus Heights which is continuing to work on the revitalization of Auburn Boulevard.

"It's a great location," Abu said. He said he's hopeful that the new Camp Transformation Center, a gym and fitness coaching center to open next door in early July will also increase restaurant traffic once it opens. Yelp reviews are generally positive, he added.

Abu has installed a new outdoor barbecue grill to cook his seasoned chicken, lamb and beef outside. He's hoping prospective customers will pick up the tangy, flavorful scent of his Mediterranean barbecue and give Yummy Tummy a try.

"We use the freshest ingredients possible and put love and care into each and every dish we prepare," Abu said.

Dinner specials are offered on Saturday evening, with entertainment provided by Bridggett Bess "Badia," an award-winning Egyptian-style belly dancer.

Popular Mediterranean-themed lunches are priced from \$11.99 and include seasoned rice, veggies, hummus and sauce, with a choice of kabob skewers, garlic chicken, moussaka (grilled eggplant with ground beef), grilled lamb chops, gyros and chicken or beef shawarma. Rotating dinner specials are featured each evening.

"I opened a Mediterranean market and deli on Auburn Boulevard near Garfield Avenue but that soon closed when the state's pandemic shutdown order largely forced me out of business," Abu said. With a young family to support, Abu said he wasn't discouraged, and decided to open a restaurant instead.



Popular Mediterranean-themed lunches are priced from \$11.99 and include seasoned rice, veggies, hummus and sauce, with a choice of kabob skewers, garlic chicken, moussaka, grilled lamb chops, gyros and chicken or beef shawarma.

Abu also offers customers a choice of single, double, triple or quadruple hamburgers priced from \$7.99 which are made from beef, ground fresh daily. A lunch-portioned gyro burger, a grilled chicken sandwich and a Philly Cheese Steak are also featured. Vegetarian options are also offered.

"Yummy Tummy also offers eight different varieties of seasoned chicken wings in a choice of either 8- or 16-piece portions," Abu said. "Customers just love them."

Chicken wings are seasoned with a variety of Abu's own original sauces which include barbecue, Louisiana-style, Korean, sweet chili, sweet teriyaki, mango habanero, garlic parmesan and Yummy Tummy's own lava sauce.

Salads include a traditional Greek, spinach and Caesar in small or large portion sizes and include a side of pita bread and dressing. Seasoned chicken, Gyro or shrimp can be added.

Side dishes priced from \$3.99 include freshly made hummus and eggplant dip, and falafel. A six-piece portion of falafel (\$4.99) comes with tahini or tzatziki sauce and a side of pita bread. A popular favorite, spanokopita, (\$4.99) made from spinach, onion, feta cheese in filled pastry dough is also featured.

Western-side side dishes include mozzarella sticks, onion rings and French fries.

Abu, who immigrated to the United States with his family from Bethlehem 20 years ago, said he enjoys being a part of the local Citrus Heights community and hopes Yummy Tummy will thrive.

"If you're craving something uniquely yummy for your tummy, stop by," he said with a smile.

Now You Can Use Your Library Card to Visit State Parks

SACRAMENTO, CA (MPG) -

California State Parks and the California State Library today announced an additional opportunity to advance safe and equitable outdoor access to all Californians.

Starting in the first week of April – National Library Week – California State Parks will be distributing the California State Library Parks Pass to public libraries across the state for checkout by library patrons. The new pass will allow free vehicle day use entry at more than 200 participating state park units.

"Spending time in nature is crucial to our mental health and well-being," said First Partner Jennifer Siebel Newsom. "We're lucky to have the largest state park system in the nation, and I am thrilled to partner with California State Parks and the California State Library to help make those spaces more accessible to California families. With the California State Library Parks Pass, anyone with a library card will be able to unlock the benefits and beauty of our majestic state parks."

Research shows that spending time in the outdoors is associated with better mental and physical health, and that many Californians face barriers to accessing their parks. California has a wealth of state parks, and many public libraries are likely within driving distance of one. By reducing barriers to park access and partnering with entities such as public libraries, the state can help more Californians explore the outdoors and generate positive impacts in the area of health, natural resource stewardship, and historical and cultural connections.

"Parks and libraries have the potential to be powerful symbols and agents for California's open spaces," said California State Parks Director Armando

Quintero. "It is an honor to work side-by-side with the California State Library, Newsom Administration and partners to advance outdoor access to all Californians via public libraries, inspire stewardship for the state park system and build a healthier California."

As part of a three-year pilot program starting in April, each library jurisdiction will receive at least three California State Library Parks Pass hangtags per branch for checkout by library patrons, including mobile libraries. Park Passes will enter circulation on a rolling basis throughout April and May for checkout by library patrons; library users can contact their local library for more information. Library-card holders will be able to check out the pass for the allotted number of days allowed by the local library, then return the pass to the library for others to use. The pass is valid for entry of one passenger vehicle with capacity of nine people or less or one highway licensed motorcycle at participating state park units.

"Libraries are trusted community hubs where Californians know they can find what they need to work, play, and thrive," said California State Librarian Greg Lucas. "This partnership with State Parks now allows Californians to 'check out' California's great outdoors at their community library."

Libraries are already an important part of Californians' lives. There are 1.184 public library buildings in California, and more than 23 million Californians have library cards. In 2019-2020, these libraries circulated over 97 million items free of charge, such as books, technology, Wi-Fi hotspots, videos, music, instruments, tools, telescopes and more. Additionally, the libraries hosted over 300,000 programs in 2019-2020, with almost 7.5 million people attending. The California State Library Parks Pass program is one more way that Californians can get empowered through their libraries. Additionally, the California State Library will be providing grant funding to libraries for outdoor-related items for checkout, programs that teach natural resource stewardship and outdoor skills, or to encourage their library patrons to enjoy the outdoors and make historical and cultural connections to parks.

"All Californians should have the opportunity to be outdoors in nature," said California Secretary for Natural Resources Wade Crowfoot. "Yet many of our state's residents live in communities without adequate parks and open space. This innovative new program will enable more Californians to explore our incredible State Parks system, and in the process create more equitable access to nature and the outdoors."

The 2021/22 State Budget included initiatives to advance equitable access to state parks and open spaces for all Californians. A \$9.1 million one-time General Fund investment was included in the budget to launch a state parks pilot to expand parks pass distribution, especially for youth in disadvantaged communities. The pilot includes the California State Park Adventure Pass program that provides free day-use passes for fourth graders and their families, the revamped Golden Bear Pass Program and the California State Library Parks Pass.

"California State Parks Foundation was honored to work with First Partner Jennifer Siebel Newsom to secure funding for the California State Library Parks Pass program and other innovative pilot programs to increase access to the state's magnificent park system. We firmly believe every Californian should have access to the beauty and benefits

of parks, and we know that cost can be a barrier to visiting. We're excited that local branch libraries will now be a gateway to state parks," said Executive Director of the California State Parks Foundation Rachel Norton.





Defendant Sentenced for Human Trafficking, Prior Strike for Animal Abuse

Sac County DA News Release

SACRAMENTO COUNTY, CA (MPG) -

On June 20, 2022, the Honorable Carlton Davis sentenced Lamar Robinson to 16 years in prison and ordered him to register as a sex offender for life.

On May 17, 2022, Robinson pled to human trafficking of a minor and admitted to a prior strike conviction for animal abuse with the use of a deadly weapon.

In 2021, Robinson met the 13-year-old victim. The victim's family repeatedly told Robinson her age. Despite this, Robinson

groomed the victim with promises that he loved her and that they would have a life together. He induced her to run away from home and to begin engaging in prostitution. Robinson gave the victim detailed directions about how to make money through selling sex and demanded that she give him her money.

On November 14, 2021, Sacramento police officers stopped Robinson while he was driving with the victim in the car. Robinson was on parole at the time and when officers searched his cell phone, they found evidence of his exploitation of the victim. Officers arrested Robinson and took the victim to a safe place.

In the prior 2017 strike case, Robinson used a leash to repeatedly body slam a small dog against the ground. Robinson was also holding a second dog by its neck, and that dog appeared unconscious. The dogs suffered several injuries, and a radiograph of both dogs revealed multiple rib fractures in different stages of healing. **Defendant Sentenced to Prison**

for Felony Animal Abuse The Honorable Lawrence Brown sentenced Lamar Robinson to 4 years and 8 months in prison after Robinson pled to 8 counts of felony abuse.

On December 12, 2017, an apartment tenant was awakened to the screams of an animal. When the tenant went to her window, she witnessed Robinson repeatedly body slam a small dog against the ground, using a leash to increase the impact to the pavement. Robinson was also holding a second dog by its neck, and that dog appeared unconscious. The witness called 911 and Sheriff's Deputy Brian Fowell responded. Robinson

was arrested after the deputy encountered him 'walking' two dogs with obvious injuries, including a broken leg.

Radiographs of both dogs revealed multiple rib fractures in different stages of healing. Surveillance footage captured part of Robinson's horrific crime.

The case was prosecuted by the recently formed Sacramento County District Attorney's Animal Cruelty Prosecution Unit, the Sacramento County Sheriff's Department and Sacramento County Animal Care and Regulation.

Defendant Convicted of Attempted Murder in Drive-By Shooting

SACRAMENTO COUNTY, CA (MPG) - Ladarius Murphy was convicted by a jury of attempted murder and discharging a firearm from a vehicle. The jury also found true allegations that Murphy intentionally discharged a firearm caus-

On May 12, 2016, the victim was walking to school when a gang member drove by and threw up gang signs. That gang member's girlfriend went to the same school and texted him saying there were "suckas" at the school. Later that day, the gang member, his girlfriend and Ladarius Murphy drove near the school and saw the victim.

Murphy leaned out of the front-passenger window and fired 6-8 shots at the victim from a 9mm handgun. The victim was struck in the arm and torso but survived. The gang member's car was quickly identified by the Sacramento Police Department and his girlfriend later identified Murphy as the shooter. Murphy was arrested on an unrelated case and his prints and DNA matched evidence from the car involved in the shooting. The gun used in the shooting

Murphy faces a maximum sentence of 34 years to life in prison. Sentencing is set for August 26, 2022, at 1:30 p.m. in Department 32 before the Honorable James Arguelles.

Defendant Sentenced for First-Degree Murder of 17-Year-Old

Sac County DA News Release

SACRAMENTO COUNTY, CA (MPG) - The Honorable Maryanne Gilliard sentenced Curtis Slaton to life in prison without the possibility of parole.

On April 22, 2022, a jury convicted Slaton of the first-degree murder of 17-year-old Jaylen Betschart. The jury found true the special circumstance of firing from a motor vehicle and the allegation that Slaton personally discharged a firearm causing death. The Court also found true an allegation that Slaton has a prior strike conviction for carjacking.

On October 3, 2020, Sacramento police officers found the victim in his car that had crashed into a utility pole on Jackson Road and Florin-Perkins Road. He had been shot once in the back. Investigators obtained surveillance video from several locations that showed the suspect car chasing the victim down Jackson Road with the shots fired just before the intersection. Investigators identified the car as belonging to Slaton and located the car at Slaton's residence later the same day. A search warrant at Slaton's residence recovered a Glock handgun that was found in another vehicle parked at the residence. Casings left at the scene at Jackson Road and Florin-Perkins Road were later found to match the recovered handgun. Further investigation revealed additional evidence that Slaton was the driver of the suspect car and the shooter. ★

don't see any negatives to it." The Council voted unanimously to approve the

grant application. The Council also considered annual allocations from the Community Support Fund for fiscal year 2022-2023. There is \$147,862 available in the fund and the applications received totaled \$134,950, so it was recommended that each application be granted in full: \$8,000 for Citrus Heights Marching Band, \$15,000 for Campus Life Sayonara Center, \$94,500 for Meals on Wheels, \$15,000 for Single Mom Strong, and \$2,450 for Sunrise Christian Food Ministry. Representatives from the organizations spoke during public comment to describe how the funds will support their services to the community.

Since the program is undersubscribed and additional funds remain, the Finance Committee recommended relaunching the application period so current applicants can apply for the remaining funds.

Councilmember Bruins said this was the first time since she's been on the Council that they've been able to fully fund each request: "It's always been painful in the past when we've had to make a decision where we would cut the requests, since they were all worthy." The allocations were unanimously approved by the Council.

Interim Administrative Services Director Bill Zenoni presented a mid-cycle budget review with promising numbers. The projected year-end increase to the General Fund reserves for fiscal year 2021-2022 is approximately \$1.3 million, and for fiscal year 2022-2023, the reserves could be increased by another \$6.7 million. The presentation included amendments to the operating budget based on these updated numbers

Zenoni explained that the Council decision in March to pay off the balance of the City's line of credit saved considerable interest expenses and has led to a debt-free Citrus Heights.

The Council unanimously approved the amendments to the budget.

As discussed during prior meetings regarding the allocation of the City's federal American Rescue Plan Act (ARPA) funding, the Council considered the final approval of funds for necessary equipment upgrades at the Citrus Heights Police Department. A total of \$2 million in ARPA funding will be allocated to the CHPD for the 2022-2023 fiscal year. Replacement of 22 police fleet vehicles, along with the installation of police-specific equipment in the vehicles, will

total \$1.4 million. The remaining \$600,000 of the allocation will be used to upgrade equipment in the 911 public communications dispatch center.

The Council voted unanimously to approve the funding allocation to the CHPD.

Another previously discussed allocation of ARPA funds also came before Council for a final vote - \$875,000 to fundthe Beautification Crew Pilot Program through fiscal year 2025-2026. Operations Manager Regina Cave explained that residents and businesses have concerns about blight throughout the community and the impact of trash and debris left by homeless encampments. Funds allocated to the Beautification Crew would be used to hire two dedicated staff members to address these issues by keeping public right of ways safe and clean for members of the community. The allocation would also include the purchase of a vehicle and equipment so the crew could respond

Councilmember Bret Daniels said he was "extremely excited about this." He asked that the program be fast-tracked to get it up and running before the fall. "It's such a high priority with our residents, our businesses," he said.

Several members of the public spoke in support of the program during Public Comment, including Diane Ebbitt-Riehle, executive director of Citrus Heights Chamber of Commerce and co-chair of the Auburn Blvd. Business Association. She said that community members often feel that not enough is being done in the city to address blight and homeless encampments, so she believes the Beautification Crew will show the public that "their voices are being heard."

Alfred Sanchez - known as the "Snack Man" in Citrus Heights because every day he visits homeless people in the city to provide snacks and companionship – also spoke during Public Comment, but he brought up concerns about how this program

and its planned collaboration with CHPD could lead to more enforcement and policing than the situation requires. He hoped that the enforcement would focus on the businesses that have requested that additional support.

The Council unanimously approved the funding allocation for the Beautification Crew.

During City Manager items, City Manager Ashley Feeney announced that the recruitment for a new administrative services director recently concluded with the hiring of Susan Talwar. She has worked for the Citrus Heights Water District, and also served the city through Rotary, Kiwanis, Soroptimists, and the Chamber of Commerce. Talwar said she's "excited here today to further expand my public service to the city and the community." She will take over for Interim Administrative Services Director Bill Zenoni, who the Council thanked for his hard work and expertise during a difficult financial period for the City.

California Streamlines Access to COVID-19 Testing and Treatment

SACRAMENTO, CA (MPG) - The California Department of Public Health (CDPH) and OptumServe are upgrading testing sites across the state to provide both testing and treatment for individuals who test positive and qualify for COVID-19 treatment.

Test to Treat sites allow individuals to get tested, be seen by a provider, and receive a prescription for antiviral pills. This will improve access to COVID-19 treatments for uninsured Californians, especially in communities hardest hit by the pandemic, a foundation of California's SMARTER Plan.

California is launching 146 OptumServe Test to Treat sites throughout the state over the next couple of weeks. A Test to Treat locator map is available for Californians to easily see where they can access these services.

"We are working to ensure that Californians who have symptoms of COVID-19 have access to rapid testing and immediate treatment, regardless of insurance coverage," said CDPH Director and State Public Health Officer Dr. Tomás Aragón. "Our goal is to help Californians recover if they get COVID-19 and ensure high-risk patients have access to treatments that can keep them out of the hospital."

California's expansion of Test to Treat sites aligns with the federal government's Test to Treat initiative in the National COVID-19 Preparedness Plan. Testing and treatment provided at OptumServe locations is designed for people without insurance. Sites will offer tele-health medical services and provide antiviral pills (Paxlovid or molnupiravir) or prescriptions to eligible patients. Services will be free of charge.

While COVID-19 vaccines and boosters remain the safest way to prevent the virus, COVID-19 treatments can lower risk of severe illness and hospitalization. They work best when taken soon after symptoms begin. If a person has symptoms, they should call or email their health care provider right away to ask about testing and if they qualify for COVID-19 treatments. If they don't have a health care provider or don't hear back from their provider, they can visit a Test to Treat location to get rapid testing and find out if they are eligible for treatments.

Communities may have other Test to Treat locations not included on the Test to Treat locator map. To learn about other locations, people are urged to contact their health care provider or local health department. Testing and treatment will be free of cost to all patients at OptumServe locations, but other treatment facilities may charge for the administration of an antiviral. Individuals should check with their insurance provider to see if their plan covers treatment.

Get Vaccinated or Boosted When Eligible

With COVID-19 cases increasing statewide, public health experts urge Californians to get vaccinated or boosted when they are eligible. Vaccination appointments can be made by visiting myturn.ca.gov or calling 1-833-422-4255. The consent of a parent or legal guardian may be needed for those under age 18 to receive a vaccination. Visit Vaccinate All 58 to learn more about the safe and effective vaccines available for all Californians age 5 and up. ★

Can Sanity Prevail in California?

For the naïve who want an optimistic presentation about how great California is, VDH is not your guy. He gives an accurate, if depressing, view of the current state of the state. In both his writings and speeches, he assesses just how far California has deteriorated; from homelessness, poverty, cost of living, crime, taxes, business climate, etc., ad nauseum.

The decline of California has, as most know, led to an unprecedented exodus out of the state. So much so that for the first time in its history, California has lost representation in Congress. In addition to the 2 million people who have already left California, far more are seriously considering it. Facebook now has a group called "Life after California" with rapidly growing membership, but most Californians are unlikely to leave, at least anytime soon. They will stay either because they are willing to tolerate all that is wrong here, or they are not able to leave.

A Central Valley farmer isn't going to pick up his orchard and move to Texas, neither is the retired couple who want to stay close to family members, including grandchildren but simply because tens of millions will stay in California does not mean they are oblivious to

Those deciding to stick it out here in the formerly Golden State are constantly on the lookout for some faint signs that things might get better. The primary election returns might provide such a sign, although it would be foolish to believe there has been a political sea

First, the good news. It now appears that voters in the most liberal city in America have had it with rising crime. Given that you can count the number of Republicans in San Francisco on two hands, the rejection of the city's District Attorney, Chesa Boudin, certainly wasn't a partisan fight. San Franciscans of all political stripes simply felt unsafe on city streets as tens of thousands had their cars or homes broken into. It doesn't take a conservative to want serious criminal acts to result in serious criminal penalties, including incarceration.

The similarly Sorosbacked district attorney of Los Angeles, George Gascón, wasn't on the ballot, but it appears he is in deep trouble as he tries to deflect a recall of his own. Also, L.A. mayoral candidate Rick Caruso, previously a Republican and now registered in the Democratic party, is headed to a runoff against progressive Democrat Karen Bass. currently in Congress and previously Assembly leader.

As in San Francisco, crime and homelessness are top issues.

Throughout California, even within Democrat-on-Democrat races, the more moderate candidates seemed to be outperforming their more progressive counterparts, although many races remain too close to call.

Whether California's election results represent a meaningful shift away from radical progressivism or merely a blip in the relentless leftward movement in California is the subject of a national debate. Even the New York Times wrote that the recall of Boudin was "a stark warning to the Democratic Party."

It is way too early to predict a significant return to sanity in California, and November's election results will be more telling. But for now, even a slight movement toward responsible politics is a welcome

Targets for Crime, Abuse, Aggression

SACRAMENTO REGION, CA (MPG) - They claim that they live in fear. You can see it in their eyes. You can hear the fear in their voices.

Residents of the Mobil Country Club (MCC) on the border of Rancho Cordova and Gold River claim they are under a daily assault from residents who inhabit a large homeless camp behind the facility. Numerous tents and large piles of rotting trash now inhabit land originally set aside for the Citrus Road bike and pedestrian access trail. No bike rider or pedestrian dares use this path today.

"If you don't know who it is, you don't answer the door," said one rattled resident who was in fear of giving her name. "Everyone who lives back there (the back of MCC) is in a state of paranoia. They wonder what is going to happen

MCC is a 479-space mobile home facility that caters to residents who are 55-years or older. Storz Management Company describes the facility on its website as a "quiet haven" and a "convenient and serene neighborhood." The 10 residents who attended a recent meeting with Messenger Publishing strongly disagree. They say they live in a state of fear.

MCC residents say the problem started in 2016 but has grown worse in the past two years as the size of the homeless camp has tripled. Frustrated homeowners say they have placed numerous calls to the Rancho Cordova Police Department and the Sacramento County Sheriff's Department for help. One resident produced copies of 14 calls she made to Rancho Cordova police over the course of a single month. Officers do respond to these calls but will not take action to remove the source of the problem and eyesore behind the MCC facility.

"I stopped calling police," one frustrated resident said. "They don't do anything."

As bad as the problem is during the day, residents say, it doesn't compare to what happens at night. Like the Mongol hordes who assaulted the Great Wall of China, MCC residents share stories of the criminal element from within the homeless camp that scales the six-foot-high brick wall in the back of the facility after the sun has gone down. Anything that isn't nailed down, residents say, is stolen. The theft list includes bicycles, heavy ornaments decorating the outside of homes and even a laptop computer. Locked sheds are

also targeted for theft. Numerous residents shared stories of noise, drug use, loud music, screaming, assaults, and unwanted visits from homeless camp visitors. Late night pounding on doors and windows isn't uncommon. One homeless man tried to make his home under a trailer. Another resident claims she made the mistake of opening a late-night knock on her

door, only to be confronted

can't be removed by property management-or law enforcement.

by a homeless man who demanded she provide him with blankets and a pillow.

An attorney representing the management company, which receives roughly \$850 per month from each resident for management and security services, is familiar with the homeless camp. Joseph Carroll says the camp is not on land owned by MCC, and his client "has neither the power nor authority" to clear it out.

"The homeless and housing shortage crisis in California has affected all property owners, whether it be a gated manufactured housing community like Mobil Country Club, an apartment complex, or a single-family residential home," Carroll said in a statement to Messenger Publishing. "Mobil Country Club has nighttime security, which patrols the community multiple times each night, a 6-foot concrete wall surrounding the park, security cameras at the front entrance of the park, and a full-time community manager."

MCC residents who spoke with Messenger Publishing say the security patrols do not deter homeless from entering the grounds.

"They don't do their job," said one resident. "We caught a homeless person in the park and security

refused to kick him out." Several MCC homeowners are banding together to fight back over frustration and mounting fears that come from non-stop noise and crime. Resident John Hunepohl has drafted, and residents have signed, a petition titled: "Seeking Relief for Our Abused Senior and Elderly Residents."

The petition, which will be presented to the Sacramento County Board of Supervisors during the July 13 meeting, reads, in part: "We believe that our elderly have a legal right to occupy their homes in peace and quiet as defined in California Health and Safety Code."

Rancho Cordova City Manager Cyrus Abhar says he is just as frustrated as homeowners in the MCC park. However,

he says federal and state legal restrictions limit what actions the City can take. Mobile Country Club is within Rancho Cordova city limits, but the Citrus Road bike path, where the homeless camp sits, is on Sacramento County land.

"Homelessness is one of the top issues that I have to deal with on a daily basis," Abhar told Messenger Publishing. "I am an avid bicyclist. I use that Citrus Road path. I see the problem. I am MCC's biggest advocate."

One of the problems cited by both Abhar and Carroll is a 2018 ruling by the 9th U.S. Circuit Court of Appeals. That ruling stops cities like Rancho Cordova from removing camps from public land like the Citrus Road path, unless the city or county provides adequate shelter for the homeless that live there.

Relief can't come soon enough for some residents. Many, like Michele Fors, are confined to wheelchairs. This means they are forced to use the bike and pedestrian access path behind MCC to go shopping or obtain needed medications.

"It's like running the gauntlet," Fors said. "I haven't been touched, but I am subject to plenty of verbal

"The City of Rancho Cordova did take action to clean up the drainage area next to the Citrus Road path because the overgrown bushes and trees served as great hiding spots for criminals," Abhar said. "At the same time, I think the county can potentially do more."

The Sacramento County Sheriff's Office did not respond to requests for comment on this issue.

Unfortunately, at least for the residents of MCC, Bowie's dream of a brighter future appears to have died with him.

Big Pharma Approves mRNA **COVID Shots in Babies**

WASHINGTON, D.C. (MPG) - On June 17, 2022, the U.S. Food and Drug Administration (FDA) granted emergency use authorization (EUA) for mRNA COVID shots to be injected into babies as young as six months of age. All this despite the evidence that these shots are not safe or effective for babies and toddlers. Nor are they necessary for this young age.

For the Moderna COVID-19 injection, the FDA amended the EUA to include use of the vaccine in individuals 6 months through 17 years of age. The vaccine had been authorized for use in adults 18 years of age and older. For the Pfizer-BioNTech COVID-19 Vaccine, the FDA amended the EUA to include use of the vaccine in individuals 6 months through 4 years of age. The vaccine had been authorized for use in

individuals 5 years of age and older. The announcement came just two days after the FDA Vaccines and Related Biological Products Advisory Committee voted unanimously to recommend that the agency authorize the mRNA COVID injections for children under five years of age and as young as six months. Previously, only children five years of age and older were allowed to get jabbed, and only with the Pfizer injection, while people 18 years of age and older were allowed to take Moderna. Now, infants can have their DNA permanently destroyed with either brand, thanks to the FDA.

Then on June 18, the Centers for Disease Control and Prevention (CDC) Director Rochelle P. Walensky, endorsed the Advisory Committee on Immunization Practices' recommendation that all children six months through five years of age should receive a COVID-19 shot.

Research shows that there is no benefit

to children receiving a COVID shot and the injections can cause potential harm, adverse effects and death. According to Pfizer's own study trial data, the chance of death in children from the shot is 107 times higher than death from COVID.

In addition, an analysis by two Israeli researchers shows that at least 58 life-threatening adverse events from the shots in infants and toddlers under three years old were reported to VAERS. The most common serious adverse events were life-threatening bleeding, anaphylactic shock, anticholinergic syndrome, encephalitis, hypoglycemia, and neuroleptic syndrome. In most of the reported cases, these children had multiple injuries. During the analysis, cases were removed in which it was stated that the exposure to the COVID shot was through breastfeeding.

The FDA's briefing document released before the FDA's committee meeting last week claimed that the vaccine efficacy in children under five years is 80.3 percent. However, even though the study to "determine" this included 1,678 children who received three doses of the formulation, the stated 80.3 percent efficacy claim is based only on "10 symptomatic COVID-19 cases identified from seven days after the third dose and accrued as of April 29, 2022" (emphasis added).

A recent study also suggests that the effectiveness of COVID-19 shots in children is low in the beginning and wanes rapidly to statistical insignificance. Moreover, the data suggests that vaccine effectiveness in children actually becomes negative within several months after the second dose.

Liberty Counsel Founder and Chairman Mat Staver said, "There is no significant benefit and all risk to inject a baby with an experimental COVID shot. The FDA has discredited itself."

Ham Radio Operators **Help Save Lives**

SACRAMENTO REGION, CA (MPG) - When the Loma Prieta Earthquake struck the greater San Francisco Bay Area in 1989, it knocked down power lines and knocked television and radio stations off the air. Phone lines were disrupted, and cell phone service died. However, they stepped in and

helped save the day. The same scenario played out 16-years later when Hurricane Katrina struck New Orleans and the surrounding area. Once again, television sets and radios died. The power went off. Standard telephone service and cellular service stopped working. But, once again, they stepped in and provided emergency communication.

Who are they? These men and women are all members of the same group who belong to the American Radio Relay League (ARRL). These people are all radio amateurs, who are also better known as Ham Radio operators. Despite the

recent rise of the internet, the hobby of ham radio,

which is more than 100-

years old, is alive and well. ARRL International Field Day took place in multiple cities and countries this past weekend, including Sacramento. This year's event was hosted by the California Department of Technology headquarters located in Rancho Cordova. State authorities know all too well from multiple experiences that when emergencies strike, it's the independent ham operators who can be relied upon when emergency communications

are needed. Alice Austin likes to help people. That's why she became a member of the local Friends and Amateur Radio Communications Enthusiasts (FARCE) group and helped to organize this year's field day.

"It's important to me to lend a hand in any kind of emergency," Austin told Messenger Publishing. "The purpose of our field day events is to make sure our operations are intact and our radios work. We

try to contact other ham radio operators located all over the world."

Hobbyists include military veterans like Dennis Merritt, who served tours in both the U.S. Navy and Army. He is better known in the ham community by his FCC assigned license name of W6UHQ. He started his field day experience by contacting other ham radio operators in places like Bozeman, MT, Boise, ID and Portland, OR.

"People like us can contact hospitals, emergency providers and other businesses when all other forms of communications fail," Merritt said. "We are there to help when people need us, but it's also fun to keep in contact with our counterparts in other parts of the world."

Merritt says wildfires that have recently plagued California is another example of where ham radio operators can play a crucial role in getting people out of danger. A Los Angeles Times article found that emergency warnings never reached many people in Paradise, CA during the 2018 Camp Fire because cell towers and power lines had been knocked out. The fire killed more than 80 people.

"The idea behind ARRL Field Day is practice," Austin said. "It encourages us to be prepared, to stay prepared and to encourage other people to join us."

Sacramento selects **Keegan Murray in NBA Draft**

SACRAMENTO, CA (MPG) -Anxious Kings fans waited

outside the Golden 1 Center on Thursday afternoon in scolding 100-degree weather to see who the team would select in the 2022 NBA Draft.

NBA Commissioner Adam Silver stepped to the podium around 5:30 p.m. PST and announced, "With the fourth pick in the 2022 NBA Draft, the Sacramento Kings select Keegan Murray from the University of Iowa.'

The reaction among the hundreds of Kings faithful that braved the heat to witness what could be a franchise-altering selection was mixed, to say the least.

As a sophomore with the Hawkeyes, Murray was selected to the All-Big Ten first team after averaging 23.5 points, 8.7 rebounds, 1.5 assists, and 1.3 steals in just under 32 minutes a game in 35 starts. He made a huge leap in scoring from his freshman year, increasing his points per game by

16.3, which is the largest increase in PPG by a Big Ten player in the last 25

"Keegan Murray was the best player available and we jumped at the chance to select him," McNair said in a press conference after the draft. "I think as we went along, and certainly as we got into the final days, it was just apparent to us that if Keegan Murray was there, that was going to be the best course of action for us."

The 21-year-old ranked fourth in the country in scoring average and first in total points (822) and field goals (307). He also displayed his versatility last season as the only collegiate player with at least 50 dunks and 50 3-pointers. Murray is the highest drafted player in Iowa history and the first Hawkeye to be selected in the first round of the NBA Draft since 1998.

At 6-foot-8 and 215 pounds, Murray cemented himself as one of the best power forwards in the nation in the 2021-22 season, winning the Karl Malone Power Forward of the Year Award. Murray was also named a consensus first-team All-American and the Big Ten Tournament Most Outstanding Player.

In the second round of the draft, Sacramento was scheduled to pick at No. 37 and No. 49. However, McNair traded away both picks on Thursday, dealing the latter first. Just before 10 a.m. PST, the Kings exchanged the 49th pick for the rights to Sasha Vezenkov and cash consideration from the Cleveland Cavaliers, according to McNair. The 26-year-old was a first-team All-EuroLeague selection in 2022 and was selected 57th overall in 2017 by the Brooklyn Nets.

"Sasha, certainly the intrigue with him is his size with his shooting," McNair said. "Somebody whose hit threes at a high clip but also can playmake and just shows his feel out there on the court. The fact that he's done it at arguably the second-best league in the world at an age where he's just entering his prime, we love to see that."

Sacramento waited until they were on the clock at No. 37 to trade the other second-rounder. The Kings traded the pick to the Dallas Mavericks for two future second-round picks, according to McNair. NBA insider Marc Stein reports that the picks are for 2024 and 2028.

Following the conclusion of the draft, Sacramento reportedly agreed to deals with two undrafted free agents. The Kings agreed to a two-way deal with shooting guard Keon Ellis from Alabama, The Athletic reported. Sacramento agreed to terms with forward Jeriah Horne from Tulsa, as reported by Yahoo Sports.



Plastic Tax Initiative Will Devastate Working Families

Commentary from Stop the Tax on **Working Families**

SACRAMENTO, CA (MPG) -According to a new cost impact study released by the Center for Jobs and the Economy, the average family of four could pay more than \$900 extra per year in higher costs under the Tax on Plastic Initiative (Initiative #19-0028A1) that has qualified for the November 2022 ballot.

The analysis estimates the ballot measure's tax on plastic products and complex regulatory

requirements will generate nearly \$9 billion per year in higher direct and indirect consumer costs - more than double the \$5.6 billion currently paid for recycling programs.

"This massive tax at a worse time for working families. Record-high inflation and skyrocketing food costs are already causing serious financial hardship for nearly half of California's households making less than \$40,000 per year, according to a recent poll from the Public Policy Institute of California," said Robert Gutierrez, president of the California Taxpayers Association. "Hardworking Californians can't afford to add another \$900 per year to their expenses."

The cost impact study increase could not come looks at the job, consumer costs, and business impacts of the Plastics Tax Initiative, which proposes a one-cent tax on single-use plastic packaging and food containers while adding a myriad of new regulatory requirements on plastic products. Despite the measure's significant cost increase, its flawed

provisions make it unlikely to achieve the state's current recycling goals.

Some of the report's key findings include: Adds \$901 per year in higher costs for consumer goods for the average family of four; Creates nearly \$9 billion more per year in total direct and indirect costs, including \$4.3 billion in higher taxes – one of the largest state tax increases in recent history on working families: Doubles the \$5.6 billion that Californians currently pay for recycling while likely failing

to achieve California's recycling diversion goal; Impacts more than 40,000 in-state good-paying, middle-class jobs in the packaging industry that are disproportionately held by Latinos and workers with a high school degree; Dedicates only about 30% of its tax proceeds toward increasing recycling and reducing plastic waste; and Opens consumers to even higher costs in the future by allowing the state to impose new recycling taxes and fees on other materials without a vote of the Legislature.






