Road Work for Auburn and Sunrise

CITRUS HEIGHTS - Two major boulevards will have traffic constrictions due to roadwork scheduled to start this summer right here in this city.

Sunrise Blvd from just south of Oak Ave. to just north of Antelope Rd. construction will begin in July and end in April 2013. The Sacramento Area Council of Governments (SACOG) recently awarded Citrus Heights a \$1 million grant to fund the project, which includes making sidewalks ADA curb compliant, reconstructing three bus stops (two northbound and one southbound), repaving and re-striping and new medians to reduce sections of left turn movement between the intersections, according to Management Analyst II Regina Cave. Also included is drought tolerant plants in the medians. Bids went out on May 14, 2012.

Meanwhile, the Auburn Blvd. Complete Streets Project Phase II is scheduled to begin in July and take a year to complete. This will run from Sylvan Corners to Rusch Park. Power sources will be placed underground in this area and also when complete, the boulevard will be more user friendly. Northbound lanes will be down to one lane for six months. City officials said that the construction manager will work with businesses during this time to make sure there is access to parking and that customer traffic will not be affected. Construction will start at Rusch Park and move south to Sycamore. Additionally, repaving will be done from Rusch Park north to the city line.

"The project has been designed beautifully," said David Wheaton, General Services Director.

Workers will be widening the boulevard, adding bus pull outs and planters and trees will be in place with the addition of designer LED lights.

With these two major sections of roadwork beginning at just about the same time, sections of the city will be a traffic mess. Devon Rodriguez of the Economic Development Department with Citrus Heights said, "This is not an ideal situation." Officials were not planning on both projects, but SACOG's funds have to be used within a specific time frame or the money goes back to them, according to Rodriguez. Of course, the Auburn project has been planned for some time.

Options for local traffic are using Greenback Lane to get around it and Antelope Road to Old Auburn.

Waterways Expect to See Big Crowds

The California Department of Boating and Waterway's urges boaters to be properly prepared for safe boating this Memorial Day weekend. California's waterways will be crowded with motorized and non-motorized vessels. People will boat in groups creating numerous distractions, which can have deadly consequences.

"Boating during Memorial Day weekend means being a more responsible boat operator," said DBW's acting Director Lucia Becerra. "Operators may have people on board their vessels who do not normally boat. Familiarizing passengers with the location of safety equipment and how to be safe aboard will decrease the likelihood of being involved in a boating accident."

Here are some suggestions from the DBW for boat operators to decrease the chances of being involved in a boating accident: 1) Always wear a life jacket. 2) Avoid alcohol. Everyone who drinks alcohol

SACRAMENTO REGION - on board is at risk. Passengers can easily fall overboard, swim near the propeller, or cause vessels to capsize. 3) Designate a person aboard the vessel to help you act as a lookout. 4) Carry the required safety equipment such as fire extinguishers, sound signals, navigation lights, and life jackets for every person on board.

> Boat operators should inform everyone on board where the required safety equipment is located. Operators should also turn off the engine when the boat is not moving to avoid propeller injuries.



Mesa Verde High School Scholars

CITRUS HEIGHTS – When Mesa Verde High School was approached to produce two students for scholastic and academic achievements throughout high school careers, they couldn't. They produced three.

With graduation just around the corner, please be introduced to three up and coming professional people – Leigh Sanders, Leah Turcotte and Benjamin "Ben" Munoz.

First, Valedictorian Sanders will be attending the University of California Los Angeles starting in the fall. She said her most challenging class at MVHS was Advanced Placement biology, which she must be glad she took as she plans on getting a bachelor of science in biology and a minor in business. She will not know until May 22nd if she received a scholarship as MVHS presents all senior awards that evening. Her grade point average earning her the top spot in this 2012 class is 4.38.

Sanders explains that she went to a number of elementary schools as a youngster, ultimately settling in Citrus Heights and attending Sylvan Middle School. At Mesa, she is in the AVID program as well as AP courses, as are the remaining two students to be presented.

She is president of the California Scholarship Federation Club, a member of the Key Club, which provides community service and she is involved in the Link Crew, which is a freshmen transitional club helping the younger set with high school. Also, she was in the French Club.

As are all three students, she was also involved in sports while attending Mesa.

"For track, I was in the long

jump both 400 meter and 200 meter and the 400meter 4x4 relay," she said. During junior year, she placed second in the Golden Empire League overall. This year, she placed third in the 4x4. Also, she and boyfriend Munoz have two marathons behind them, the River City Marathon and the California International Marathon.

Next is Turcotte, 17, named to the Academic All League, for students who excel academically while playing sports. Her grade point average is 4.29, and she has been named Scholar Athlete 10 times during her years at Mesa Verde. Her two choices of sports are basketball and volleyball.

She said she will attend Norwich University in Vermont, and she has learned that she will receive a \$25,000 scholarship each year she is there. She will be majoring in sports medicine with health concentration and athletic training, and she wants to minor in nutrition.

"I've met their coach and all the players and they are pretty cool," she said.

In addition to the awards mentioned, she has also received the Maverick Award (school mascot name) for volleyball and the Coach's Award for basketball.

While in high school, she did

track for two years and joined the French Club and the CSF Club. "I enjoyed the sports," Turcotte said of her years in high school.

While she was growing up, she attended Sierra View Elementary School in North Highlands and Don Julio Middle School, now known as the Academy of Arts and Design. She said that it took her a couple of years to find her spot in high school with the sports as it came with aging.

Third is Munoz, 18. He played defense on the Mesa Verde football team and was named defensive Most Valuable Player one year. He also played basketball and joined track, running the sprints, including the 4x4 relay. He won second place for All League in track for the 100 meters and first place in the 200 meters.

Academically, he achieved a 4.25 grade point average and was scouted for track by Cal Poly San Luis Obispo, where he will attend college. He is planning on majoring in electrical engineering but might branch into robotics.

"AP calculus was the highlight of my academic career," he said. "Math has always been easy for me and this was challenging. It was fun."

While in high school, he joined the Key Club, the CSF Club and the Link Crew. Additionally, he spoke to the California Legislature for Boys To Men about how to treat women correctly and is currently on the web internationally for Women Escaping a Violent Environment (WEAVE) as a spokesman against domestic violence.



My Food, My Roof

Dear Dave,

I'm a single dad with two teenagers at home. My 15-yearold son wants to open a checking account of his own, but he doesn't want me or anyone else to have access to it. Should I just let him do this and suffer the consequences I know are coming?

Dear Tim,

When it comes to 15-yearolds, as a parent you have every right to say, "My food, and my roof. You do what I say." With kids this age you never know what you're getting. Half the time you're talking to a 35-yearold, and the other half they're 5

At that age, I think you let them do, or not do, these things

based on their ability to perform well in life. To the extent they behave and show some sense, you lengthen then rope and give them more freedom and privileges. If they act like doofuses, you shorten the rope. Remember, no is a complete sentence. Can you tell I've raised teenagers?

If it were my son, I'd sit him down and gently explain that he doesn't have the capacity or knowledge to manage this idea by himself just yet. You wouldn't turn your child lose behind the wheel of a car the moment they wanted to drive, right? So make yourself a part of the experience by teaching him to handle money wisely. Then, as he matures in financial understanding, you can give him more leeway.

A Case in Point

The Case of the **Unlucky Driver**

There's a tug-of-war in society between technology, which changes rapidly and constantly. and the law, which changes gradually and infrequently. Technologies such as cell phones or "tweeting" alter the social patterns of everyday life. The law struggles to catch up and stay relevant.

That's brings us to the story of Carl Nelson, the unlucky driver.

Mr. Nelson was driving his car in the city of Richmond, California on the morning of December 28, 2009. He stopped at a red light and decided, like many of us, to make use of the waiting time. Mr. Nelson opened his "flip-style" cell phone and began dialing to check email.

At this precise moment, a police officer pulled up on a motorcycle directly next to the driver-side door. The officer saw Mr. Nelson holding a cell phone to his ear and dialing. Mr. Nelson looked over, saw the police officer, removed the cell phone from his ear and closed it. We don't know Mr. Nelson's thoughts at this point, but they probably consisted of a two-word expression beginning with "Oh."

When the light turned green and Mr. Nelson drove through the intersection, the officer pulled him over and ticketed him for using a cell phone while driving. In traffic court, the ticket was upheld and a fine of \$103 was levied.

Most people would have given up and paid the \$103. Mr. Nelson, however, was sufficiently disturbed that he retained a law firm and appealed. The

California Appellate Court, First District, agreed to hear the case.

Mr. Nelson's lawyer made an interesting argument. He acknowledged Vehicle Code, Section 2313(a), which says, "A person shall not drive a motor vehicle while using a wireless telephone unless that telephone is specifically designed to allow hands-free listening and talking..."

That's the key, argued the lawyer. Mr. Nelson wasn't driving a motor vehicle. He was stopped at a red light and posed no risk to anyone. To quote the legal lingo: "The term 'drive' requires evidence of volitional movement of the motor vehicle as an element of the offense."

To use a cell phone while stationary was no more hazardous than various other things people do while waiting for a light to change - putting on makeup, eating a messy sandwich, reading a map, or changing radio stations, according to the

The lawyer cited a 1991 decision, Mercer v. Department of Motor Vehicles. Police found a man asleep over the wheel of a car that was legally parked at the curb. The car had its lights on and engine running. The defendant was fined for driving under the influence – but on appeal the fine was overturned. Yes, Mercer was drunk; however, when police observed him, he wasn't driving. He was legally parked and asleep.

That gets us back to the Nelson case. When the Court announced its decision, it turned out that Mr.

Nelson's luck hadn't improved. He lost again.

"Driving" a car, said the decision, meant the same as "operating" a car. The court cited various cited California laws that used the words "drive" and 'operate" interchangeably.

The drunk driver in Mercer was in a different situation. Mercer wasn't going anywhere, nor was he about to. However, drivers at a red light are still "operating" a car, and could pose a hazard if distracted - by their feet letting up on the brakes, for example, or by failing to promptly move as required by the traffic laws.

If Mr. Nelson wanted to use a cell phone at a red light, the Court concluded, he should install a hands-free wireless system and be in compliance with the law.

My guess is that California will have more litigation like this. What if I am stuck in dense traffic and call home to alert my family? What if I am in line at the McDonald's drive-thru and use the time to check email or call the office? Technology and law are destined to continue skirmishing in the courtroom.

REACH Meeting Discusses Tax Proposal

CITRUS HEIGHTS – It was nearly standing room only as the Residents' Empowerment Association of Citrus Heights held an all neighborhood inclusive board meeting to hear city officials discuss the utility tax proposal coming up for vote by the Citrus Heights City Council on June 14th.

City Manager Henry Tingle, General Services Director David Wheaton, Finance Director Stefani Daniells and Chief of Police Christopher Boyd all presented to residents as to the reasoning behind the proposal. The program was similar as to what was presented to the council recently.

Tingle is requesting a 1.75 per cent utility tax increase to raise \$3 million a year to help fund street paving, four additional police detectives because of AB109 aftermath, police electronic equipment and two additional youth officers for early intervention on potential gang/crime involvement.

council then passing with 2/3 of public support in November, the tax would reach Sunset (expire) in 10 years because that is when the city can start collecting property tax revenues. Note that initially, Tingle had also asked for a property tax of \$50 per dwelling, however he said that due to the complexity of the potential tax, including property values and property sizes of residential and business properties, the request has been removed.

When asked what the city would do if the tax does not pass, Tingle told the crowd that the city would probably spend \$1 million per year out of the General Fund for paving, rather than the \$3 million needed for the 65 percent of fair to poor residential streets and additional police services. Note that he said that it would cost \$3 million a year (\$2 million from proposed tax increase and \$1 million from the General Fund) is what is actually needed to get the residential streets of Citrus Heights in much better shape.

As for the police department, If voted for approval by he said they would probably redeploy some officers.

One resident asked if the reason some streets are so bad off could be from aging and leaking underground pipes. Wheaton said the city is addressing this particular issue.

Also speaking at the meeting were representatives from Sunrise Marketplace. The executive director of the Sunrise Marketplace Business Improvement Board indicated there will not be a fireworks display this July 4th. Instead, this year they are trying out "Everything Under the Sun", offering other family oriented events, such as a summer concert series beginning August 10th with the Charlie Daniels Band and Lonestar.

Included in this series is Three Dog Night and America at one show and The Commodores and Kool and the Gang scheduled for another show. They also reminded the crowd about the Farmer's Market held every Saturday morning from 8 a.m. to 1 p.m., and will offer a carnival at the Sunrise Mall from June 28 through July 1.



I have heard some Mennonites use the term "non-violent evangelism." It is a way of sharing faith that does not harm those with whom they share. It is built on mutual respect, love for others, and a commitment to the other person's freedom. People are treated as seekers, not potential converts, without pressure, arm-twisting or coercion; and no manipulation of words or emotions.

Seekers are not vilified, targeted, pursued, or argued with. They are simply invited into radical hospitality where questions and exploration are not only tolerated, but encouraged and expected. These non-violent evangelists share their faith with a "come and see" attitude, opening their arms and hearts to others, leaving the rest to God.

The church could learn a lot from these quiet souls. Many of us, overtly and subtly, have taken a very militant approach in sharing our faith with others. We corner people. We demand immediate decisions. We use emotionally charged environments to wrangle decisions. We are sometimes disrespectful. We say, "Follow Christ and we will let you in." But maybe we need to learn to say, "Come on in, and learn what it means to follow Christ."

You Are Welcome

Here is an example: My friend Sabrina, and her husband Blake, live in a Christian community on a working farm. By "Christian community" I mean a group of people who are attempting to live out the way of Jesus while sharing life, space, and the same values. It's not a commune – Sabrina, Blake and the other two dozen folks living there are definite individuals – it is a community: A group of people helping the world and welcoming others.

Welcome, in fact, is what brought Sabrina to the farm. She wasn't a Christian when she arrived. Actually, she was rather hostile toward faith. But she loved the earth, she was trying to stay sober, and she and Blake wanted to give self-sustaining, organic farming a try while they were still young enough to pull it off.

Through a series of inexplicable events, but mostly because of the dramatic welcome others at the farm gave them, this couple found themselves moving out of the city and into the cornfields. Sabrina was going to farm with gusto, but she had no intention of getting involved with what she called, "the Jesus stuff." And her co-farmers respected that.

But one day, after being surrounded by all this grace and love, and having begun to pray again and study the way of Jesus, she woke up in half panic, in half celebration, and all surprise: "Oh, my God, I think I'm a Christian!" It was a beautiful conversion; one made possible by giving plenty of margin, not plenty of manipulation.

Maybe it is because I

hang around with too many Mennonites now, because I long ago defied my own coercive religious upbringing, or because of precious people like Sabrina, but I have come to the core conclusion that we need to give people some space. Should we share and live our faith? Absolutely! But I believe every person is capable of relating directly to God without coercion or interference by others

In the words of that old Baptist from Oklahoma, Herschel Hobbs: "The Church cannot fasten its iron grip upon anyone's soul...This is the worst of all tyrannies. And it is made worse by its claim to be in the name of God who created men and women to be free."

Thus, every person should be given the right of free choice in his or her relationship with God (or without God). Every individual should be given the dignity as image-bearing creations of God to arrive at their own spiritual conclusions, choosing to be Catholic or Coptic, a Methodist or a Muslim, a Buddhist or a Baptist, a Jew or a Jainist, an Anglican or an atheist, without heavy-handedness of any kind.

No, not everyone will "convert" to our way of thinking or adopt our ideas about faith. But faith isn't about force; it is about being set free. God entrusted people with that freedom. Let's do the same.

Strangely enough, the United Nations granted this man's unbelievable request. He took the



Memorial Day Scams Target Military, Family and Supporters

SACRAMENTO - Memorial Day is a time to honor those who serve and remember those who have died in war. Sadly, it has also become a key opportunity for scammers to target those who are serving or have served their nation, especially elderly veterans. BBB is urging consumers and donors to be on the lookout for deals that seem too good to be true, and for disreputable charities.

"The unique lifestyle of our service members makes them prime targets for scammers," said Gary Almond, president of BBB serving Northeast California. "It's imperative that we educate our service members and ensure that the support we give to them equals the effort they make every day on behalf of us." Almond said scams can include those that target service personnel and their families directly, but also those that appear to be helping military members via charities.

"Donors need to watch out for questionable charities that raise funds on behalf of military organizations," adds Art Taylor, President and CEO of the BBB Wise Giving Alliance.

"When you make a donation, always check www.give.org to see that the group meets BBB charity standards, especially around Memorial Day. Too many solicitors that fail to meet BBB standards call and say they help veterans, service members or their families, and little of the money donated will serve that purpose."

Among the scams to watch out

- Posing as the Veterans Administration to convince veterans they need to update their credit card, bank or other financial records with the VA;
- Charging service members for services they could get for free or less expensively elsewhere, such as military records and benefit filing assistance;
- Offering "instant approval" military loans ("no credit check," "all ranks approved") that can have high interest rates and hidden fees;
- Advertising housing online with military discounts and incentives, and then bilking service personnel out of the security
- Trying to sell things like

security systems to spouses of deployed military personnel by saying the service member ordered it to protect his or her

- Selling stolen vehicles at low prices by claiming to be soldiers who need to sell fast because they've been deployed;
- · Posing as government contractors recruiting veterans and then asking for a copy of the job applicants' passport (which contains a lot of personal *information*);
- Posing on online dating services as a lonely service member in a remote part of Iraq or Afghanistan, and then asking for money to be wired to a third party for some emergency.

BBB advises service members, veterans and all consumers never to give personal identification information (Social Security, bank account, military identification or credit card numbers, etc.) to anyone who contacts you by phone or e-mail, and to be wary of any solicitations that involve purchasing something or transferring money. Consumers can check out businesses and charities for free at www.bbb.org.

ACHIEVE YOUR WILD GOALS

Do you have some wild goals you dream about, and never told anyone? You probably think you can never achieve them, so why try? How would you like the map to get there in four steps? Sean Covey, along with co-authors Chris McChesney and Jim Huling, have put together "The 4 Disciplines of Execution" to change your behavior and achieve your wildly important goals. I had Chris on my POPPOFF Radio Show and he led me through these disciplines. So put aside your old ideas and get ready for some new ones. Here is the capsulated version right from their book.

1) Focus on the Wildly Important. Basically, the more you try to do, the less you actually accomplish. This is a stark, inescapable principle that we all live with. Somewhere along the way, most leaders forget this. Why? Because smart, ambitious leaders don't want to do less, they want to do more, even when they know better. Isn't it really difficult for you to say no to a good idea, much less a great one? And yet, there will always be more good ideas than you and your

teams have the capacity to execute. So, Discipline 1 requires you to start by selecting one, or at the most, two extremely important goals, instead of trying to significantly improve everything all at once. Failure to achieve it will make every other accomplishment seem secondary, or possibly even inconsequential.

2) Act on the Lead Measures. This is the discipline of leverage. It's based on the simple principle that all actions are not created equal. Whatever strategy you're pursuing, your progress and success will be based on two kinds of measures: lag and lead. Lag measures are the tracking measurements of the wildly important goal, and they are usually the ones you spend most of your time praying over. Revenue, profit, and market share are all lag measures, meaning when you receive them, the performance that drove them is already in the past. Lead measures are quite different in that they are the measures of the most highimpact things you must do to reach the goal. Once you have identified your lead measures, they become the key leverage points for achieving your goal.

3) Keep a compelling Scoreboard. People play differently when they're keeping score. This is the discipline of engagement. In principle, the highest level of performance always comes from people who are emotionally engaged and the highest level of engagement comes from knowing the score...that is, if people know whether they are winning or losing. And you must know the scoreboard. If the scoreboard isn't clear, the game you want people to play will be abandoned in the whirlwind of other activities.

4) Create A Cadence of Accountability. This is where execution really happens. The first 3 disciplines set up the game, but number four is based on the principle of accountability: that unless we consistently hold each other accountable, the goal naturally disintegrates in the whirlwind. The secret to Discipline 4, in addition to repeated cadence, is that members create their own commitments. Because they make their own commitments, their ownership of them increases.

This is a very condensed version of what "The 4 Disciplines of Execution" is all about. The good thing is when I asked Chris if this works for team participation or for single achievement, he told me absolutely for both. If you want more info on what these disciplines are all about, you can check out www.4DXBook.com. Press on. Now it's all up to you. It begins with you and it ends with you and your desire to succeed. But know you can make it







Law Enforcement, California Pawnbrokers Join to Solve Crimes

Pawnbrokers would Electronically Report Transactions to Law Enforcement

SACRAMENTO – The State Senate Committee on Public Safety has unanimously passed AB 391, a bill authored by Dr. Richard Pan (D-Sacramento) that would create a statewide partnership to build an online reporting system allowing law enforcement, pawnbrokers and secondhand dealers to work together more effectively to track potentially stolen items.

"I would like to thank the California Pawnbrokers Association and law enforcement leaders like Attorney General Kamala Harris and Los Angeles Sheriff Lee Baca for working to open a new front in the effort to keep our families and our property safe," Dr. Pan said. "AB 391 will help law enforcement, pawnbrokers and secondhand dealers to work together by creating an online database where they can talk to each other and track the movement of stolen property."

"I want to congratulate Dr. Pan for his work on AB 391 and thank all the members of the Senate Committee who voted for this bill," said Wayne Bilowit, Lieutenant, Los Angeles County Sheriff's Department. "Its successful passage brings us this much closer to enacting a law that is much overdue and will help all of law enforcement better serve our communities."

"Nothing disturbs pawnbrokers more than the chance that stolen property is entering our stores," said California Pawnbrokers Association President Diane Taylor. "Less than one-tenth of one percent of items taken in a pawn transaction turn out to be stolen and we look forward to decreasing that number even further. That is why CAPA is working hard to get this database up and running."

With over 80 Democratic and Republican co-authors in the State Legislature, Dr. Pan's AB 391 is widely expected to be sent to the Governor's desk this summer. The bill would allow the California Department of Justice to create and administer an online database to which pawnbrokers would electronically report their transactions the day they occur.

Attorney General Harris is a sponsor of AB 391. By

comparing pawn and secondhand dealer transactions reported to the database with recently reported thefts, law enforcement can identify the stolen property, anywhere in the state, putting them on the trail of those who stole the property. The California Pawnbrokers Association, representing over 700 pawnbrokers throughout the state, supports the fee AB 391 would call on pawnbrokers to pay in order to fund the database.



SACRAMENTO – On May 7, shortly before 8 p.m., a female adult was parked on Verner Avenue near Greenback Lane, waiting for assistance after her vehicle broke down.

The female victim was approached by a man who offered to assist her. When the victim refused the suspect's offer for assistance, he grabbed her and pulled her a short distance to a nearby wooded area. The suspect (see attached composite sketch) had a large knife sheathed at his side, secured on a belt loop, but did not brandish it at the victim.

The suspect exposed his private parts to the victim and said that he intended to sexually assault her. This incident was interrupted by the arrival of the victim's friend, which caused the suspect to flee the scene. A search of the area was conducted, but the suspect was not located. The suspect in this case is described as a black male



adult, between 40-42 years old, approximately 6'4" tall and weighing about 220 pounds.

He has a stocky build, dark complexion, and short, curly hair. He had a full beard during this incident, and was wearing a dirty, white T-shirt and camouflage pants. Another moment that thrilled this dad's heart was when he was playing linebacker on the high school football team. Goal line stand, and here comes the running back, and he just drilled him and drove him back, saving the touchdown. Now that was fun to watch!

His dream though was to be a big league baseball player. One summer we took "The great baseball road trip" which included seeing games in St. Louis at the old ballpark before it was torn down, Kansas City, and Denver. We saw the Royals, the Blue Javs, the White Sox, the Mets, the Rockies, the Cardinals, the Cubs, the Brewers and the Phillies all in a 10-day span in three different ballparks. how important it is to come up with his own conclusions and that life itself will teach him whether he is right or wrong or somewhere in between. He also hears that what might


disagree, I always let him know






