Property Tax Hike Trip to Uganda "Experience of a Lifetime" **Would Hurt Small Business, Kill Jobs**

SACRAMENTO - Californians Against Higher Property Taxes released a study recently by Stephen Frates and Michael Shires at Pepperdine University's Davenport Institute, showing the devastating impact of increased property taxes on jobs and small businesses.

The study shows that by increasing property taxes on businesses by \$6 billion, it would result in \$71.8 billion in reduced economic output and 396,345 fewer jobs over the first five years of the tax increase. And those impacts would grow over time.

"With unemployment numbers leading the nation, and small businesses trying to recover, there could not be a worse time to force California businesses to pay higher property taxes. Higher taxes means businesses charging higher prices for their consumers, laying off their employees or even worse, closing their doors completely," said John Kabateck, Executive Director, National Federation of Independent Business – California.

The study further concludes that not only will it hurt small businesses, but that these kinds of tax increases would disproportionately harm small businesses owned by women and minorities because these businesses usually rent their space and property taxes are paid by the lessee as part of the lease.

"This sobering report shows the devastating impacts that these increases would have on small, minority and woman owned businesses," added Joel Fox, President of the Small Business Action Committee. "California should be engaging in tax policies that help small businesses thrive and create jobs, not kill them."

The study echoes recent public opinion polls showing overwhelming voter opposition to property tax increases. A September 2011 Field Poll showed that 63 percent of Californians supported Prop 13. Another 2011 survey from the Public Policy Institute of California showed that a strong majority of Californians supported Prop 13's taxpayer and property owner protections.

"The on-going attacks on Prop 13 will go nowhere fast with voters. Public poll after public poll shows opposition to proposals to increase property tax rates because it is bad for consumers and bad for the economy," concluded Jon Coupal, President of the Howard Jarvis Taxpayers Association.

Local governments would face more instability as well as a result of a split roll property tax system, as they would be more directly affected by the boom and bust cycle of the real estate market. At a time when property values were falling in 2008-2009, property taxes from commercial and industrial property rose 5 percent, while their values declined 6.5 percent.

"Increasing property taxes is bad all the way around... It is bad for jobs, bad for small businesses and bad for local government budgeting," concluded Teresa Casazza, President of the California Taxpayers Association.

Californians Against Higher Property Taxes (CAHPT), a coalition of small businesses, taxpayers and business organizations, is committed to continuing the education and increasing the awareness about the negative consequences of a split roll tax on Californians.

Short Sale, Foreclosure and Bankruptcy: **Some Frequently Asked Questions**

Due to job loss and the poor real estate market, many of my clients are electing to get out of real estate. Most clients that I consult with are families that have always paid their bills on time and, prior to the economic decline, never would have considered bankruptcy or foreclosure as a viable option. However, making smart choices now may mean that a family can bounce back from financial hardship faster and get back into real estate again one day.

I spend a lot of my time in appointments helping families decide what makes more sense for them: foreclosure, short sale, or bankruptcy. The following are some of the most common questions I receive about getting out of real estate, and how I answer

How much will my credit be affected?

Short sale: Credit impact depends on how many months of mortgage payments you miss before the short sale is complete. If you never missed a payment, plan for your credit to drop 85 to 160 points. If you are missing payments, add additional point reductions depending on the number of days late. For 30 days late, plan for an additional drop of 40 to 110 points, for 90 days late or more plan 70 to 135 points.

Foreclosure: 200 to 300 points

depending on how good your credit was to begin with.

Bankruptcy: 130 to 240 points depending on how good your credit was to begin with.

How long will it take before I can buy a house again?

The answers provided are based on current lending guidelines if, at the time of applying for a new mortgage, you have saved enough money for a down payment and your credit has improved

Short sale: 2 years minimum Foreclosure: 5 to 7 years Bankruptcy: 2 years for FHA loans; 4 years for most other

Will the lender be able to come after me for any money?

Short sale: No. If a lender approves a short sale, California Senate Bills 931 and 458 provide that the lender cannot seek a deficiency after a short sale.

Foreclosure: Possibly. This depends on whether the loan was a purchase money mortgage or not. It is wise to consult with an attorney to help determine your liability.

Bankruptcy: Generally no. If you surrender real estate and do not reaffirm the debt in your bankruptcy case, then it will be discharged in your bankruptcy.

Can I receive money to assist me in moving out?

Short sale, Foreclosure and Bankruptcy: You may be paid "cash for keys" by agreeing to a specific move-out date with the lender and leaving the property in good condition. The amount of cash upon move-out is negotiable and varies depending on the lender.

Other Important Considerations

Short sale: The lender has to approve you to do a short sale. You must show your home to prospective buyers and usually need to hire a real estate agent to list and market the property. Plan for this process to take between 4-8 months.

Foreclosure: Many clients have difficulty tracking the foreclosure timeline and find the move-out date unpredictable. Failure to move out on time could result in an eviction being filed against you.

Bankruptcy: You must meet income eligibility in order to qualify for bankruptcy relief. If you have a foreclosure date set, bankruptcy can give you additional time to move out of the property by stopping the sale date for a period of time. Also, bankruptcy may help get rid of other debts you have accumulated.

Bear in mind that the responses above are general. Your specific income or property may not

Dangerous Fund-raiser Stunt at Greenback and Sunrise Intersection

Letter to the Editor

CITRUS HEIGHTS – Between 4:00 and 5:00 PM on Saturday, February 18th, I watched as approximately 25 members of the Sacramento Metropolitan Fire Department endangered all motorists and pedestrians in the immediate area of the Sunrise Boulevard & Greenback Lane intersection, near the Sunrise Mall shopping areas in Citrus Heights. While driving through the intersection and later while watching from the parking lot on the Northeast corner of the intersection, I repeatedly saw your officers endanger themselves and everyone else in the intersection by darting between lanes and in front of cars, including some that had a green light and had just started to move, forcing traffic to stop while they crossed.

Apparently this was part of some fund-raising event. The officers blocking traffic and causing back-ups and dangerous stops in the intersection were distracted by conversations with each other called across the lanes, and by waving boots around (apparently some part of the fund-raising ritual.) In particular, I saw one officer, on the north side of Greenback, bring moving traffic to a complete stop as he darted in front of cars that would otherwise have been making left turns. This foolish, dangrous person kept entering the through lane while all lights were red, and then blithely crossed unpredictably back and forth through the left turn lanes regardless of whether or not the left-hand arrow was green; he's lucky to be alive, and, yes, he was wearing a yellow & black coat labeled "Sac Metro FD." When I called to complain about this dangerous stunt, I

was told by the dispatcher that it was for some annual charity, as if that were important — as if a dangerous, dirt-stupid stunt done for a "good cause" is somehow made acceptable.

I've worked for several agencies in three states whose duties include law enforcement and emergency response, and it's my understanding that law enforcement may violate local laws — at any level, from Federal down to local township — ONLY when absolutely necessary, and as part of a direct response to a crime or emergency. How is raising money for a charity an "emergency" that warrants endangering everyone passing through that intersection and violating laws regarding jaywalking and traffic safety? What other laws do you think you get to ignore for random, frivolous reasons? This might be a good time to contemplate the meaning of the phrase 'exceeding your authority" and to reread the Commerce Clause in the Constitution; your authority is not absolute, especially when your self-indulgent amusements put people in danger. How many near-misses today, and in prior years? How many times have people had to slam on their brakes to avoid hitting you? I saw THREE incidents in

FIFTEEN MINUTES alone! If some fraternity or any other group of private citizens tried the same sort of dangerous, disrespectful stunt, they would have been forced to stop by local law enforcement, and possibly fined or cited. I also noticed an electronic road hazard sign on Greenback Lane about a mile

west that read something about watching for Fire Department staff. I was naive enough to think that sign was talking about some effort to keep people safe. Turns out, it was announcing the Sac Metro Fire Department's "Let's Cause an Accident & Get Somebody Killed!" party. If you know this stunt is dangerous enough to warrant road hazard signage, WHY HOLD IT IN THE FIRST PLACE?

I'm cc'ing several varieties of insurance commissioners and providers. I wonder what my insurance carrier would say if I told them I was in a vehicle v. pedestrian accident with a member of a fire department who was behaving erratically and dangerously in the middle of a heavily crowded intersection, with, apparently, the tacit approval of all local law enforcement.

I don't even have time to get into how this sends a mixed message about fire fighters and the Sac Metro FD. Why should anyone listen to you about fire safety or accident prevention when you're darting around in traffic forcing people who have the right of way to hit the brakes to avoid hitting you? I wouldn't trust you to tell me what time it is, let alone have the beginning of a clue about what constitutes safe behavior.

How dare you frivolously ignore every rule of traffic safety in existence?

How dare you put me in a position where I have that much higher a risk of hitting someone?

This event should have been shut down years ago.





Citrus Heights Police Department **Wins Prestigious Award**

CITRUS HEIGHTS - The Citrus Heights Police Department received a prestigious award on Monday, March 12, at a special luncheon in Sacramento.

The CHPD won the James Q. Wilson Award for 2012, and according to Mayor Jeff Slowey, this is very exciting for the department as they are only in their sixth year of operation.

"The James Q. Wilson award honors top projects and public safety agencies specific to Problem Oriented Policing (POP)," Slowey wrote in an email. "The CHPD submission centered on their work with the Domestic Violence Intervention Center (DVIC). More specifically, their partnership and having a Domestic Violence Response Team (DVRT) domestic violence counselors riding with officers, so they are the first on scene to domestic violence calls. There are many agencies who have counselors on call, but getting them to the crime scene with the first responders has proved invaluable in offering assistance to the victims. The key to domestic violence is to get the victim into treatment. Prior to the development of the DVRT teams, the call back ratio of victims seeking service after the first was in the single digits. With the timely arrival and counseling of the domestic violence



counselors, the call back rate is now in the mid 40% range - an absolutely outstanding increase. Under the leadership of Chief Boyd, the entire Citrus Heights police team has embraced the concept that while they might not be able to completely eliminate domestic violence, they will not tolerate it within the city limits. This effort would all be for not if it weren't for the volunteers and providers who work for the DVIC of Citrus Heights. Truly, these folks, along with the selfless efforts of the men and women of the CHPD are making a difference in and around our community."

Chief Christopher Boyd had announced at the city council meeting on Feb 9th that DVRT had responded to 798 domestic violence calls last year.

According to Robin Basinger, director of programs and development at the DVIC, Executive Director of DVIC Elaine

Whitefeather innovated the idea as she saw a need, Basinger developed the DVRT program, and Chief Boyd approved it. It has been in operation for three and a half years. Basinger also said that as far as they know, they are the only agency in the country offering this service of counseling at the time the counselor and officers arrive at the scene. As previously reported, Whitefeather is trying to make the location in Citrus Heights a one-stop shop for victims, offering childcare and employment services at other offices in their

The James Q. Wilson Award is made possible through the Regional Policing Institute-California, American Military University, in association with the California Police Chiefs Association and the Office of the Attorney General, California Dept. of Justice. Second and third place recipients are located in Southern California. The decision is based on problem solving, partnership with the community, partnership with public and private organizations/ agencies, institutionalization and results, according to the James Q. 

SACRAMENTO - The Sacramento Capitals protected the rights to Mark Knowles and Yasmin Schnack in the 2012 World TeamTennis Roster Player Draft. The team also drafted Jean-Julien Rojer, Coco Vandeweghe and Asia Muhammed, as announced by the team March 13th.

The Capitals protected Knowles, a former World No. 1 doubles player, with their first round pick. Knowles, of the Bahamas, returns for his 11th season with Sacramento. Schnack was protected in the fourth round for her second WTT season.

The Capitals used their second round pick to draft Rojer, who returns for his second season in WTT. Rojer played for the St. Louis Aces last year, and was selected by World TeamTennis as the Rookie of the Year for 2011. He has a career high ranking of No. 17 in doubles and has captured five doubles titles on the ATP World Tour. Rojer was an All-American in singles and doubles at UCLA before going pro in 2004.



"There is a long list of legendary players who have come out of the UCLA tennis program, and we are very happy to have three Bruins All-Americans in Knowles, Rojer, and Schnack," said Managing General Partner Ramey Osborne.

Sacramento drafted Coco Vandeweghe as a roster exempt selection prior to the roster draft. Vandeweghe, a 20 yearold Southern California native is currently an active US Fed Cup Team member and has a career high ranking of 89 on the WTA Tour. Vandeweghe is scheduled to play the final week of the regular season.

"It's wonderful to welcome some of the best players in tennis in Mark Knowles, Jean-Julien Rojer, Yasmin Schnack,

and Asia Muhammed to the best franchise in the League." said coach Wayne Bryan who will be returning for his 11th season.

The team's third round pick went to Asia Muhammed, a young American who won 3 ITF Doubles Titles in 2011. She is currently playing on the ITF

Women's Circuit. 2011 Capitals player Vania King's schedule is undetermined due to pending Olympic commitments.

"Last year, our goal was to make the playoffs and we did that. This year, we are looking to make the playoffs again, and give ourselves a chance to win a 7th WTT Championship. We believe we have the talent to get there," said Capitals General Manager Matt McEvoy.





21 JUMP STREET

(Rated R)

In the early days of the FOX TV network, "21 Jump Street" was a hip TV drama about undercover cops, with a novice Johnny Depp in a starring role.

With "Superbad" comedian Jonah Hill in one of the starring roles for the reinvention of an almost-forgotten TV series, it's clear the cinematic "21 Jump Street" is a different breed of cool cat.

To be kind, Jonah Hill is no Johnny Depp, but then neither is Hill's co-star and partner on the police force, Channing Tatum, even though he's a force of nature that exudes a certain amount of charisma

As the film opens in 2005, Tatum and Hill, respectively playing Jenko and Schmidt, are the polar opposites during their senior year of high school.

The good-looking jock type, Jenko is an amiable lug who coasts through the school on his charm and sense of entitlement that comes from being tight with the popular crowd.

Copying the style of Eminem's Slim Shady, complete with the bleached hair, the academically brilliant Schmidt is a walking disaster who hangs out with the perennial losers and outsiders.

Fast forward seven years, and we find Jenko and Schmidt enrolled in the police academy, where Schmidt is pressed into service to help Jenko improve his dismal written test scores.

After graduation, the duo is assigned to bike patrol duty in the local park, where one day they nab a drug dealer in an arrest that they exuberantly celebrate with

unprofessional behavior.

The fallout from this arrest lands the pair in the special Jump Street unit where youthful-looking officers are assigned to undercover duty in the local schools.

Posing as brothers and living with Schmidt's parents, Jenko and Schmidt return to their old high school to bust a drug dealing ring that's run by a snotty rich kid who's into recycling and expects to go to Berkeley.

Not unexpectedly, Jenko and Schmidt start to relive their high school days with a greater sense of purpose, thinking incorrectly that they have all the right answers this time around.

When their identities become mixed up, the results are hilarious. Jenko, the former campus stud, falls in with the nerds, while the socially awkward Schmidt finds acceptance from the cool crowd.

While their Jump Street colleagues keep solving cases, the hapless pair spends more time trying to adjust to new rules of behavior and fitting in with the school scene.

Schmidt enrolls in a drama class, determined to become Peter Pan in the school production, probably for no better reason than his forbidden crush on Molly (Brie Larson).

Oddly enough, Molly is in a semi-open but unfulfilling relationship with Eric (Dave Franco), the big man on campus who just happens to enjoy talking about composting as much as he likes being the major drug supplier.

Meanwhile, Jenko struggles through his science class, but gets teamed up with the bright kids who enjoy blowing up things and teaching him how to do the same.

As Jenko and Schmidt try to ingratiate themselves with Eric, the drug dealer requires them to consume his product in order to prove that they are ordinary students and not undercover narcs.

Fueled by the powerful drugs, Jenko nearly destroys his classroom in a crazed attempt to diagram a scientific experiment in a burst manic energy.

This being a comedy, though one full of action, "21 Jump Street" is bursting with hilarious surprises as Jenko and Schmidt trip over themselves in their charade to fool fellow students and

"21 Jump Street" may be the first movie to have a serious car chase that involves stretch limos with the cops and bad guys shooting at each other from the sun

The perceived plot of the two officers trying to do convincing undercover work is secondary to the free flowing type of mayhem that Jonah Hill and Channing Tatum bring to their roles.

Indeed, there's complete excess of wacky craziness in this enjoyable comedy. The best humor is not from the wild stunts, chases and party scenes, but from the comedic chemistry of the odd couple of the two lead characters.

Assemblymember Pan Calls for Legislative Audit of Child Abuse Prevention Funds

Child advocates concerned about misappropriation of scarce funding

SACRAMENTO – After hearing testimony from child abuse prevention advocates including Dr. Richard Pan (D-Sacramento), California's Joint Legislative Audit Committee has approved, with a unanimous, bipartisan vote, audits of two state funds to ensure scarce dollars are spent on proven abuse prevention efforts. "In recent years, funds for child abuse prevention efforts have been cut dramatically,'

Dr. Pan said. "In these tough economic times when every dollar should count and be used for critical programs and services that provide real benefits, it appears that the funds continue to be used in a fashion that warrants further scrutiny.'

The State Children's Trust Fund consists of funds received from a portion of birth certificate fees, federal funds, gifts, grants, and private donations, all of which are required to be used for innovative and distinctive child abuse and neglect prevention and intervention projects.

The Child Health & Safety Fund consists of funds from the license plate program ("kids plates") for the purpose of child abuse prevention and child safety

More specifically, the law calls for up to twenty-five percent of the funds to be used of child abuse prevention. "These two remaining funds are virtually the only sources left for child abuse prevention and safety pur- and intervention and safety projposes," Dr. Pan explained. 'The Child Abuse Prevention Center believes this audit is critically important," said Sheila Boxley, President and CEO of the Child Abuse Prevention Center. "It will ultimately help ensure and maintain the integrity of funds designated to support and protect children in a time of decreased funding and increased

Advocates believe this is a mere snapshot into the inappropriate uses of these critical dollars that could otherwise be put to evidence-based uses in child abuse prevention and safety programs. To ensure a full and effective audit, Dr. Pan's requested that JLAC consider the following questions:

1. What is the current condition of the Funds?

2. Over the last six years, for what specific programs and purposes have the dollars within the Funds been used?

3. Over the last six years, what specific entities have been provided funding by the Funds?

4. What percentage of the Funds has been used for admin-

istration purposes? 5. To what degree and for what purpose have the funds been used for administration, programs, services, or items that are outside of the scope of child abuse and neglect prevention

9. Are there legislatively required internal or external evaluations or program studies, such as cost benefit studies, that may analyze alternative approaches, and were these studies completed for expenditures from both funds?

What is the capacity and practice of management for engaging in internal reviews or audits to monitor program operations, identify program and management problems, and ensure fiscal integrity?

PG&E Moving Aggressively to Improve Records in Push for Safety

- Pacific Gas and Electric Company (PG&E) provided an update March 15th on what the company is doing to overhaul its records management system, particularly for its natural gas pipelines.

The records project began in the wake of the pipeline accident in San Bruno, as the company works to make sure such an accident never happens again. To help identify areas for improvement, PG&E hired the consulting firm PricewaterhouseCoopers (PwC) to assess its recordkeeping practices. Employing a team of records experts, the assessment has covered various aspects of PG&E's gas operations record keeping.

Based on an assessment by PwC: "PG&E proactively retained PwC to assess its recordkeeping practices across its gas operations organization. This is what businesses do when they want to improve and it is a

critical step in that process. With the initial assessment complete, PwC is working to finalize its reports and its conclusions."

Meanwhile, the company is already forging ahead on a multifaceted process to vastly improve its data management, a cornerstone of pipeline safety.

PG&E Executive Vice President of Gas Operations Nick Stavropoulos, a gas industry veteran who was hired in May 2011 to lead a turnaround in the company's gas operations, described the records efforts as a big job, but not insurmountable. He also pointed to the importance of the PwC assessment in guiding reforms.

"PG&E is well aware that we had records challenges and we're addressing them in a thoughtful manner. That's where PwC's assessment will help.

"We have a sound strategy that we are implementing and I'll leverage my deep experience in this industry to make sure of it. I have great comfort in knowing that all of us at PG&E are working every day to make things better and safer for our customers, communities and for each other," Stavropoulos said.

Stavropoulos outlined the following ways PG&E is already moving forward:

Validating pipelines' safe operating pressures: PG&E has completed its Maximum Allowable Operating Pressure (MAOP) verification effort, which involves record gathering and field investigations, for all 2,000 miles of transmission pipelines in urban areas. The records needed for this project—so far about 2.5 million paper documents—have been scanned, indexed, and stored in a new centralized electronic records system. This was a key first step in organizing pipeline records and making them more accessible to PG&E workers throughout gas operations. The process is now continuing for the remaining transmission lines.

Strength-testing pipelines: PG&E has performed high-pressure water tests on more than 160 miles of pipelines with characteristics similar to the line in San Bruno. The data from these tests have been entered into an electronic system, providing another layer of traceable, verifiable and current information. Plans call for strength testing or verifying records for about 185 miles in 2012, 204 miles in 2013, and 158 miles in 2014.

Gas Transmission Asset Management: The idea behind this program, Stavropoulos said, is to move away from reliance on paper records and toward robust electronic data management systems. PG&E will be connecting field crews to these systems through mobile technology, establishing a master index of job files, and strengthening integrity management and risk analysis tools. These steps will help employees make informed and prompt decisions to ensure public safety.

Knowledge Asset Management: This is one of eight major areas of responsibility that Stavropoulos has created in gas operations. The team oversees the massive effort to validate our pipelines' MAOP, records verification and management, the production of maps, data quality, and technology and tools. By creating this team, PG&E has made records management a priority and established a clear line of accountability.

Company-wide records organization: On a broader level, PG&E is developing a companywide records management policy that promotes accountability, protects vital records and ensures appropriate retention practices.

All of these programs, Stavropoulos said, stem from PG&E's overarching mission to establish a clear organizational structure that puts public and employee safety first. "That philosophy drives every decision and every action the company makes," he said.

"Think of it this way. Have you ever ridden a bicycle with flat or low tires? It is very hard to pedal. You inflate the tires and it gets very easy. In my opinion, it takes less energy to move the car also. As a reminder, I think people should check tire pressure at least at every oil change," Rubash elaborated.

Rubash has been working at Lone Star Auto since 1976 and became owner in 1993 when his father, who started the company in 1953, retired.

During foggy days where visibility is slim to non-existent, driving can be an eerie experience. When you have difficulty seeing your hands, much less the cars in front or behind you, fog lamps and rolling down your window are helpful. Hearing plays a vital role in driving in this situation is beneficial because you can hear oncoming traffic, honking horns and the like when you cannot see as well.

"Drivers really need to pay attention, do not get distracted by cell phones, radio, food or whatever. Stay in the right lane if possible to use the solid white line as a guide. Also, reduce speed to a safe level," explained Rubash.





What the Health Reform Law **Does for Medicare**

We hear a lot of back and forth these days about the Affordable Care Act – aka the federal health reform law - but not much about how it affects people with Medicare. When you sort through all the rhetoric, one thing is clear: the 2-year-old reform law contains some real benefits for those who get their coverage through Medicare.

Take the so-called "donut hole" in the Medicare prescription drug program, Part D. The donut hole is a gap where you don't have coverage even though you're still paying premiums. After you've paid a certain amount out of pocket, your coverage resumes. Congress intended the hole to hold down costs in the drug program, the biggest expansion of Medicare benefits in many years. Under the Affordable Care Act (ACA), the hole is being gradually closed until it completely disappears in 2020.

This year, the law gives people with Medicare a 50-percent

drugs in the donut hole, and a 14-percent discount on covered generics. In 2011, more than 319,000 Medicare beneficiaries in California saved a total of \$171 million in the donut hole. That's an average savings of \$538 per person.

The ACA also helps people with Medicare by eliminating coinsurance and deductibles on vital preventive health services. Such services can help keep people healthy and detect disease in its earliest, most treatable stages. As a result, Medicare now offers a long list of preventive health services with no out-of-pocket costs, including screenings for cancer, diabetes, cardiovascular disease, osteoporosis, and shots for flu and pneumonia.

The health reform law also adds new preventive screenings and counseling for obesity, alcohol abuse, and depression. More than 2 million Californians with Medicare received at least one Medicare-covered preventive health benefit in 2011. The health reform law also creates another important benefit for people with Medicare: annual wellness visits.

If you've had Medicare Part B for longer than 12 months, you can get a yearly wellness visit with your doctor to develop or update a personalized plan to prevent illness based on your current health and risk factors. (The annual wellness visit is in addition to the one-time "Welcome Medicare" preventive visit when you first enroll in Medicare.)

More than 165,000 Californians with Medicare took advantage of a wellness visit last year. Because of financial incentives in the ACA,

discount on covered brand-name seniors also can expect to see better quality in their Medicare Advantage health plans. Such plans are operated by private insurers and generally require you to stay within a network of physicians and other providers or face higher out-of-pocket expenses. Medicare Advantage plans that receive quality ratings of three stars or more under our Five-Star Rating System will get bonus payments.

We believe the bonuses will motivate other plans to improve their quality as well. Medicare Advantage plans that receive five stars - the highest rating - will be able to market to and enroll seniors year-round, not just during the open enrollment period in the fall. That means seniors can switch to the best plans at any time. (To check your plan's rating, go to www.Medicare.gov.)

Lastly, the ACA provides a variety of new tools to crack down on Medicare fraud. The law not only toughens federal sentencing guidelines for fraud (meaning crooks will spend more time in prison), it also allows us to suspend payments to providers suspected of trying to rip off Medicare.

In addition, we're now using sophisticated predictive analytics software to identify patterns of fraud and target crooks. This is the same type of software credit card companies use to stop fraud. 


