PCF Loses Founding Chairman, Community Advocate and Dear Friend From Placer Community Foundation

AUBURN, CA - On Tuesday, June 4th, the Board of Directors and staff at Placer Community Foundation were extremely saddened to learn of the passing of our founder, Janice L. Forbes.

Janice will be honored and remembered as the leading force in establishing Placer Community Foundation. A long-time board member of the private Auburn Community Foundation (ACF), she understood the impact giving could have on current and future needs throughout the county. She also believed strongly in honoring and sharing the legacy of those who have chosen to give back to their place of home. In 2004, she led the board in ratifying the decision to transform ACF into a public charity that could serve donors in directing their charitable intent to address a wide range of causes. That decision created Placer

Community Foundation. Since 2005, the Foundation's assets have grown to \$10.5 million and cumulatively, the Foundation has distributed over \$4.1 million in grants to local charities.

Janice was a true leader and ardent champion of many causes. It can be said that her tireless work has contributed to the quality of life we all share in this county. "Janice's passion and commitment to improving this community were unrivaled. She had a vision for local philanthropy in Placer County that guides the work of our Community Foundation. She was a dear friend to us all," said Justice Keith F. Sparks, First Vice Chairman of the Placer Community Foundation Board.

Janice Forbes was a native of Auburn, CA. A proud Placer Hillman, she attended Placer High School with some of the Foundation's current and emeritus board members. At board

State's Debt Not Addressed With New Budget

SACRAMENTO, CA (MPG)— The Legislature passed the 2013-14 state budget on June 14th—a budget that was negotiated among Democrats and with limited public review. The main budget measure—Assembly Bill 110—passed with only partisan support by a vote of 28 to 10.

"The biggest goal of the Legislature should be to get control of the budget," said State Senator Jim Nielsen (R-Gerber). "But that has not happened. There are built-in cost increases that have not been addressed."

Negotiated behind closed doors, the total state budget spends approximately \$108 billion in general fund monies, which are spent at the discretion of the Legislature.

Despite its lack of transparency, the budget did dedicate \$2 billion to partially pay down the state's debt, restored the adult dental program and child care services, and provided some funding for trial courts.

This budget, unfortunately, prioritized new spending over a more fiscally prudent approach that pays off state debt and unfunded retirement liabilities. The Governor's own Department of Finance estimated that the state's unfunded liability on employee retirement pensions is at a cost of \$180 billion to taxpayers.

It did not address many of the problems with the Governor's public safety realignment plan, also known as AB 109. It allowed prisoners more good time credit than they ever had nor will ever earn.

"Without changes to realignment, criminals will be more emboldened by no consequences for their continued criminality and will only prey upon more of us. The time to fix AB 109 is now," said Nielsen.

Assembly Bill 110 is the main budget bill that must be accompanied by 21 trailer bills – which implements the budget.

SACRAMENTOREGION.CA (MPG) - Mobile apps are a dime a dozen -- the Apple App Store just hit the 50-billion download milestone -- but not many are the brainchild of a second grader. That didn't stop 8-year-old Nicolas Come of Orangevale from pitching his idea for a nutrition-focused mobile app to potential backers and now the result, Nicolas' Garden, has been launched for iPhone and Android smartphones.

Armed with a hand-drawn wireframe of his concept for a social platform and mobile apps that promote healthy eating and cooking for children, Nicolas pitched his startup idea to nearly 100 technical experts last November at an Intel-sponsored hackathon at Hacker Lab near downtown Sacramento.

"It was at Cereal Hack II and I got up on a chair to present my idea," said Nicolas. "My dad

had told me that if I pitched my idea there he would help me, so I did it. It was exciting and

Representatives of AppMatrix, a mobile app development company, saw Nicolas' pitch at the hacker event and now the company has brought his idea to market with the recent launch of Nicolas' Garden in the Apple App Store and Google Play.

"We're very interested in the start-up craze, and to see an 8-year-old do this was awesome," said Tim Dement, senior executive vice president of the Rocklin, Calif. firm. At 8, having a vision like that and be able to wireframe it? That's just ridiculous, it's amazing."

The launch offers a cornucopia of healthy recipes, cooking tips, shopping guides and other nutrition-minded content. Enhancement plans include gamification, multiple language support, and a calendar of local farmers' markets and other healthful events.

"I want to add a 'cooktop' game," Nicolas said. "You drag and drop ingredients from the pantry and refrigerator while following recipes on the app or others that you can make up on your own. If you make your own recipe and it's really healthy, you get lots of points, and if you deep fry it, your score goes way

down." Nicolas is by far the youngest client within AppMatrix's includes portfolio, which GolfChex, Intel, Patriot Memory and Rogue Running. "I think our next youngest is 18, maybe, but every entrepreneur we work with besides Nicolas is

an adult," Dement said. The ideas around content are all Nicolas', according to his father, Stephane Come,

advisor at Hacker Lab and president and CEO of LCS Technologies, an Oracle solutions consulting company he co-founded with Gold River resident Steve Simonetto.

"Nick comes up with the ideas, and as his dad I help enable it," Stephane said. "He doesn't know you need to talk to a lawyer when starting a company, for example."

Nicolas, through a trust, is part owner of the company that was spawned by his pitch at the hackathon. The experience of starting a business has allowed the second grader to work directly with the adults doing the coding that is making his idea a reality.

"It was fun to get help from others and work as a team," said Nicolas of his collaboration with designers Devon Latzen and Jay Miller, who helped design the app, and Kathryn Lastufka, a social media coordinator for LCS Technologies, who worked on that end of Nicolas' Garden.

Nicolas' father sees it all as a valuable learning experience.

"Is it going to work? I don't know. This can fail," he said. "Today Nicolas is on TV, the next month there could be no one using the app. Either way it's a good life lesson."

And as for Nicolas' head getting bigger if Nicolas' Garden grows? Not on Dad's watch.





Seniors Need to Know: Long-Term Care Insurance

The increasing need for inhome care is irrefutable. Elderly people and some younger individuals with disabilities or chronic illnesses require help with activities of daily living such as bathing, dressing, transferring, toileting, eating, continence, as well as assistance with transportation and meal preparation. A recent report from AARP shows that the cost of unpaid caregiving provided by family and friends was \$450 billion in 2009, rivaling the cost of the entire Medicaid/Medi-Cal program. While some caregiving is provided out of love and compassion, most of those unpaid care hours result from a lack of funds to cover the cost of hired in-home care. Unpaid caregivers in California spend, on average, over 18 hours a week helping their loved one. This takes a great toll on caregivers, who often become ill due to the physical and emotional stress of caregiving or by the lack of attention to their own health.

Paying for in-home care is covered either by private funds, long-term care insurance, or, if eligible, by a governmental program. The average cost of a caregiver is about \$20/hr. Few families have long term care insurance because of denial, procrastination, and the thought that premiums are too costly; however it may not as expensive as one would think. Long Term Care (LTC) insurance premiums average \$1,500 to \$3,000 per year, depending on one's age, health, marital/partner status, amount of coverage, and the insurance company. The younger you are, the lower the premium. Without LTC, outof-pocket costs can be as much as \$40,000 to \$80,000 per year, depending on the kind of care (unskilled or skilled); the extent



of care (number of hours per day or week); and the location of care (home or facility care).

Be aware that some older policies do not cover caregiving in the home (home care), but most policies today are more comprehensive and cover home care and facility care. Many policies have a daily benefit ranging from \$100 to \$200 a day. If the costs for the home care service exceed the benefit covered by the insurance, the difference is paid out of pocket.

Long-term care beneficiaries usually have difficulty understanding (or remembering) the way the insurance policy works. Frequently, they are surprised even upset – about having an "elimination period" or "waiting period" before benefits start. Some long-term care policies do not have a waiting period for inhome care, even when there is a waiting period for assisted living or nursing home care, or the waiting period does not apply if the client is in hospice.


The most significant element of this discussion about planning ahead for long-term care is peace of mind. Reaching the point in life when you need a caregiver to assist with the activities of daily living is never easy. Those individuals who had the foresight and wherewithal to have purchased long-term care insurance now enjoy peace of mind as it relates to the financial burden of longterm caregiving. There is also a sense of relief from having the services of a nurse who will advise the family on a plan of care and can assist in the coordination of that care. If you desire, consider leaving a legacy for your children so they can care about you; not for you. Both you and they will breathe easier when the time comes.


Sacramento Capitals Announce 2013 Single Match Tickets Now On Sale





Here Comes the Final Wave of Cell Phone and Texting Enforcement

CA (MPG) - Drivers in the greater Sacramento region who are observed texting or talking on a hand-held cell phone will be targeted in a special enforcement operation that will last through June 30. Thirty-seven local police departments and the California Highway Patrol (CHP) will participate in the enforcement effort.

This is the third and final highvisibility enforcement period that was developed to test tactics that may be employed nationally in the future. In 2012, the National Highway Traffic Safety Administration (NHTSA) awarded the California Office of Traffic Safety (OTS) \$600,000 to fund three waves of enforcement along with the message "Phone in One Hand, Ticket in the Other," designed to educate drivers about the dangers of distracted driving.

A total of 3,008 citations were issued during the first wave last December, increasing to 4,750 during the second wave in February. The special enforcement region stretches from Modesto to Marysville and from Vallejo to South Lake Tahoe.

"Distracted driving is a dangerous problem," said OTS Director Christopher J. Murphy. "For everyone's safety, drivers need to focus on the road and refrain from talking or texting on a cell phone. California has strict mobile device laws in place and this "Phone in One Hand. Ticket in the Other" campaign offers a constant reminder to drivers to

do the right thing and practice safe driving."

Drivers caught talking or texting on a hand-held cell phone will receive a first-time ticket costing a minimum of \$162, with a second offense costing \$285. However, the goal of the special enforcement operation is not to issue tickets, but to raise awareness about the dangers of distracted driving.

The California Office of Traffic Safety offers these simple tips to keep you or someone you know from being a victim of distracted driving:

• While talking on a cell phone, up to 37 percent of the brain

function needed for driving is used toward that conversation, rather than driving.

- Turn off your phone, and/or put it out of reach while driving.
- · Include in your outgoing message that you can't answer while you're driving.
- Don't call or text anyone at a time when you think they may be driving.
- Remember: Phone in One Hand. Ticket in the Other.

Congressional Hearing Reveals that Children in the Womb Feel Pain

WASHINGTON, D.C. -Liberty Counsel Action pledged its full support to HR 1797, the Pain-Capable Unborn Child Protection Act, a bill to provide protection for unborn children 20-weeks or older, who have the capacity to experience pain while being aborted.

In compelling testimony, health professionals disclosed the horrors of second trimester abortions and the pain those preborn babies experience. In his testimony, Dr. Anthony Levatino, a former abortionist, described the process of inserting a thirteen-inch Sopher clamp with 2 1/2 inch jaws at the end with rows of sharp teeth. "Once you have grasped something inside, squeeze on the clamp to set the jaws and pull hard-really hard. You feel something let go and out pops a fully formed leg about six inches long. . . . Reach in again and again with the clamp and tear out the spine, intestines, heart and lungs.'

"This is the reality of so-called 'reproductive health care,'" said Mat Staver, Chairman of Liberty

Counsel Action. 'Cloaked in School of Medicine told the subcompassionate words, proabortionists do not care about women's health or fetal pain. In fact, Planned Parenthood and its minions fight against laws to bring abortion facilities up to basic medical clinic standards, require abortionists to have admitting rights at hospitals, or allow women to see a sonogram image of their unborn child before an abortion," Staver pointed out.

Dr. Levatino further revealed that after the first trimester, "any attempt to perform an abortion 'to save the mother's life' would entail undue and dangerous delay." Instead, OB-GYNs perform a Cesarean section if the mother's life is at risk, often saving both the mother and the preborn child."

The pro-abortion business does not want Americans to know what neurobiologist Dr. Maureen Condic revealed yesterday: a fetus responds to pain just like you and me, by withdrawing from the painful stimulus," Staver said. The Director of Human Embryology instruction for the University of Utah committee, "The neural circuitry responsible for the most primitive response to pain, the spinal reflex, is in place by eight weeks of development."

"In facilities hiding behind signs that advertise 'Women's Health,' nurses like Jill L. Stanek experience appalling stories of babies who survive abortion only to be zipped alive a biohazard bag," Staver noted."

At yesterday's hearing, (May 2, 2013) Rep. Trent Franks (R-AZ), the author of HR 1797, quoted Dr. Martin Luther King, Jr. who said, 'Our lives begin to end the day we become silent about things that matter.' Liberty Counsel Action will not be silent until every American has the right to life-from conception to natural death," Staver concluded.







Lots of times in these kinds of situations collectors are trying to gather up as much information as possible in order to sue you. Just offer them the \$3,000, and make it clear that your financial coach—which is me—told you not to answer any more of their nosy questions.

Make sure they understand that your offer of \$3,000 stands as a settlement of the debt today. If they're willing to accept the offer, get a statement in writing saying that the \$3,000 represents payment in full before you cut the check. If they choose not to accept your offer, and they keep asking questions that are none of their business, just tell them to call back when they're willing to discuss terms. Then, hang up!

Think of it as a "Two Week-Ten pound" challenge. You have nothing to

offset calories and boost your metabolism. Lisa has one she swears by. Drinking a shake for breakfast brings fast results, and is THE MOST important step in the process!

2) Perform metabolic boosting workouts three times a week to radically change your body fast! You'll get stronger and look better in two weeks or less! Don't know what to do? Check out Lisa's leaner lifestyle DVD series. You can exercise at home for 30 minutes saving you time and money from the gym membership you never use. All you need is a set of dumbbells! Income That May Cause Tax Problems

Here are selected income issues that are commonly misunderstood and may cause taxpayers future tax problems or possible IRS audits.

Clergy

Offering and fees such as marriage, funerals and baptism you receive as a clergy must be included in your income. If you donate your outside earnings to your own organization, you may still have to include those in your income and claim them, on the other hand, as charitable deduction.

You may ask why declare such money as income if I am going to turn around and claim them as a deduction? The law is tricky. You may claim them as income, but there may be a limit on your charitable deduction if they exceed certain percentage of your adjusted gross income.

Housing payments to clergy, generally speaking, are not taxable if they are reasonable. Also included in the deductions is the cost of utilities. Utility amount should not be questioned as to the reasonableness as long as it matches the bill you receive form the utility company.

Foreign Income

If you are a U.S. citizen or a resident alien, you must report all your worldwide income. This includes earned income such as income from W-2 or 1099's and non-earned income such as interest and dividends. You must include the income whether you receive the W-2 or not. Also subject to the tax is worldwide income from capital gains. If you reside outside the U.S., you may be able to benefit from an exclusion of some of the earned income. See publication 54 Tax Guide for U.S. Citizens and Resident Aliens Abroad

Advance Payments

If you receive advance payments or commission you must include these payments in your income. This is because we usually report our income as cash basis taxpayers. This means income is recognized when collected and expenses when paid. So if you are a doctor and you send the bill out to your patient, you don't have to include this bill unless you collect on it. Similarly if your patient pays you for a surgery in advance, you must include this amount in

your income even if you did not perform the surgery.

Sickness and Disability Income

If you have insurance for sickness pay that is paid by you, your payments received from the insurance company will be tax exempt. If your employer pays for this insurance then the amount you collect will be taxable. If the employer pays part, then you are taxable to the extent that the employer pays.

Disability Income

If you receive income from disability or disability pension you should include the amount you receive in your income. They are treated as taxable wages.

Workers' Compensation

Any amounts you receive as workers' compensation will not be taxable. The exemption continues to the survivors. The retirement plan benefits triggered because of your injury, however, are not tax exempt. If for some reason you go back to work and you are reassigned different duties to cope with your injury and you receive wages, then these wages are taxable. They are no longer workers' compensation.






