## Reunite, Reconnect and Rebuild SACRAMENTO REGION

The Capital Region Chapter of the American Red Cross is offering Reconnection Workshops, courses designed to help ease the transition after military deployment.

Four facilitated sessions will be offered to focus on skills building to enhance the likelihood of positive reconnections with armed forces personnel and their families following a military deployment.

"Deployments are a fact of life in the military," said Trisha Johnson, emergency services manager. "Whether a service member's absence is due to a training exercise, sea duty, combat, or unaccompanied duty in a remote location, separation and reunification pose unique opportunities as well as challenges for all family members. The American Red Cross, with support from Walmart, developed a series of workshops to assist all military families in managing the family's readjustment to the service member's return."

health professionals lead participants through information and discussions designed to help them identify and respond to the challenges of readjusting to and transitioning back to a changed family dynamic.

The workshops are targeted to service members and their spouses, children, parents, siblings and significant others. Topics include Communicating

Clearly, Exploring Stress and Trauma, Relating to Children, and Working Through Anger. Participants have the option

## **Placer County Sheriff Hosts National Night Out**

PLACER COUNTY - For the third year in a row, the Placer County Sheriff's Office has been honored for hosting one of the best National Night Out events in the U.S. in 2011, placing thirteenth, just behind much larger jurisdictions like Los Angeles County and Houston, Texas.

National Night Out is celebrated annually on the first Tuesday of August, when first-responders caravan in emergency vehicles to dozens of Placer County neighborhoods. They visit established Neighborhood Watch groups, which hold ice cream socials, barbecues and all sorts of gettogethers. In 2011, more than 37 million people in 15,325 communities across the U.S. participated.

Dedicated members of all the Neighborhood Watch groups in Placer County are given credit for the department's win.

"The commitment these neighbors have shown by taking control

of their neighborhoods and watching out for each other is the reason we earned national recognition again," said Sheriff Ed Bonner.

## **Grange Supports GMO** Labeling for **November Ballot**

Thousands of volunteers are now fanning out state-wide to launch a petition drive to get the California Right to Know Genetically Engineered Food Act on the ballot in November. In the thick of the grass-roots initiative is the California State Grange, one of the leading partners in the effort.

The California State Grange has long supported the idea that GMOs (genetically modified organisms) in the food supply should be adequately tested and that consumers are entitled to know what's in food they eat. The American people agree. Yet despite overwhelming support for GMO labeling, for over a decade regulators and legislators at the national and state level have largely ignored public concerns.

That's why the Committee for the Right to Know is taking the issue directly to the voters of California. Now, with petitions in hand, over 1,500 volunteers will be gathering signatures at stores and farmers markets up and down the state.

"The bottom line is Californians have a right to know what's in the food we eat and feed our children. It's time to send a strong, direct message to those who govern us, whether they be agency or elected, that we want genetically engineered foods labeled," says Pamm Larry, founder of the Committee For the Right to Know.

## Taxes Not the Answer for California's Economy

SACRAMENTO - This month marks Presidents Day, and as we celebrate Lincoln's birthday it's timely that we look at the tax farce troubling his home state of Illinois. Last year, in a move that must have left legislative Democrats dizzy with admiration and envy, the Illinois legislature jacked personal income tax rates up by 67 percent and corporate tax rates up by nearly 50 percent. Despite assurances that were made when the taxes were passed, the legislature still has not closed their budget gap, and they won't until they get the political will to control their spending.

Let Illinois be a lesson to everyone who believes in the magical powers of tax increases. They do not occur in a vacuum. Unless governments have the discipline to rein in spending - which California certainly does not – tax increases just enable more extravagant spending plans and takes money away from the working families who have earned it.

California's problem is not that the people are taxed too little, but that the government spends too much. We have to examine every possible avenue for saving money so that we can keep providing core government services, such as education and public

safety, at a price we can afford. For example, why does California have a full-time legislature? Texas and more than 40 other states do just fine with parttime legislatures that meet far less often than California's and where the legislators make far less than we make every year.

Besides the savings, it's a good idea to get legislators away from the Capitol cocoon more often and out in the real world, living and working under the rules they pass in Sacramento. I own a business and I'm constantly frustrated by the maze of regulations that grows and changes with every legislative session. I know how hard California makes it for businesses to succeed.

In my business I can't just keep spending and spending and then force my clients to pay more and more to cover my spending. When times are tight, I have to cut back, find ways to save money, provide the same services more efficiently. Government should be taking that same approach, when unemployment is eleven percent and state government is running multi-billion dollar deficits. Now is not the time to be growing government.

But, incredibly, Governor Brown's budget plan spends \$6

billion more in 2012-13 than in 2011-12.

And to pay for it, Governor Brown and the Democrats want to pass the bill along to their customers. The Governor is pushing for a five-year, \$35-billion tax increase. Sales taxes and income taxes will go up during those five years, costing families precious dollars that they could use for groceries, vacations, school clothes and thousands of other necessities that are already hard to afford in our high-cost, highly regulated state.

Let's take a private-sector approach before we shake down taxpayers any further. How about putting a stop to the \$100 billionplus High Speed Rail plan that will soak up billions of dollars a year for decades? How about allowing schools to contract with the private sector to provide services like transportation or food

I oppose Governor Brown's call for higher taxes. State tax rates went down last year but state tax revenues are growing and are expected to continue growing for the next several years. This indicates that our economy - slowly and precariously – is moving forward. Let's not kill that momentum by larding on even higher, unnecessary

## Long Term Care Basics

PLACER COUNTY - A prospective new client wanted to utilize their long term care insurance for homecare. Jane needs an in-home caregiver to help provide care for her husband, Don. However, Jane has held off using their long term care insurance due to concerns that their benefits would run out prematurely. Don has a 3-year policy but expects to live longer than that. He needs a caregiver's help with activities of daily living such as standby help with bathing, dressing, transferring, other personal needs, and domestic chores such as cooking and laundry; he is currently in relatively good health.

What many people don't know is that long term care is not a 'use it or lose it' type of insurance; rather, it is a 'use it or save it' type of insurance. The length of the policy assumes that the claimant will utilize the daily benefit amount every day of that period of time, for example, every day of the three year term. But if they utilize half of that every week, the policy would last six years. If they received respite care one day a week, the policy would last 21 years. Even though Don is in pretty good health, he probably won't live to

LTC insurance is based on a "pool of money" concept. For example, \$200/day benefit for a 3 year plan is equivalent to an initial policy value of \$219,000



(there are options to include inflation protection). If a policy holder uses his/her daily benefit to the maximum level every day, then in this example, the "pool of money" will last 3 years from when benefits started. However, if a person utilizes half of that daily benefit every day, then the "pool" will last 6 years. LTC policies are not based on time (i.e., 3-years); and the policy will last as long as you have money in the "pool."

A key point of consideration is Jane's health. We know from statistics that family caregivers can become stressed and typically tend to undermine their own health. How will Don's care look like if Jane got sick? How soon would they be able to arrange for home care? A side benefit to initiating LTC benefits is the establishment of a working relationship with an in-home care agency and having additional

care readily available.

So, Jane started with twice a week in-home care under their insurance's daily cap. At the current level of outside caregiver services, their policy will last for over 12 years. Should Don's health worsen, Jane is ready to step up the outside in-home care. In that case, the insurance will not last as long, but then Don will probably need it for a lesser period of time as well.



## **Water Supply Outlook: Drought!**

AUBURN – The current rainfall season is on pace to be as dry as the drought year of 1976-77, it was reported at Thursday's (Feb. 16) meeting of the Placer County Water Agency Board of Directors.

The water supply briefing was offered by Pacific Gas and Electric Company partnership coordinator Dave Ward, who provided statistics and projections on local and statewide water supply conditions.

Ward said that as of Feb. 16 seasonal precipitation across the Sierra was 42.6 percent of average. Seasonal precipitation is measured each year from July 1 through June 30.

"This year is barely above 1976-77," he said. "If the current pattern continues, it could be the sixth or seventh driest year in 117 years of record-keeping."

PG&E is currently projecting that less than half of normal runoff will occur on the Yuba River watershed (44 percent) and American River watershed (45 percent).

Conditions could change, with March and April often bringing wet conditions, but the shortterm outlook is for dry weather to continue through February, said Ward.

On a positive note, PG&E is storing above average levels of water in the mountain reservoirs that supply the PCWA water system, however reduced flows through the Bear River Canal to PCWA are likely this year if dry conditions persist, he noted.

PCWA Director of Field Services Mike Nichol and Senior Engineer Tony Firenzi said the water agency is making contingency plans for dry year water deliveries. "March and April will be the decisive months," said Firenzi.

**Director of Customer Services** Matt Young has been making preparations to provide customers with ongoing information via www.pcwa.net and public outreach meetings, as well as through coordination with other local agencies and the agricultural community in the event that dry conditions worsen in 2012.

Board members applauded staff for their proactive approach and expressed hope that more normal precipitation patterns will return over the next few months.

In other business, directors:

• learned that the agency has won three awards from the American Society of Civil Engineers (ASCE), Sacramento Section, for its work in 2011. Director of Technical Services Brian Martin said the agency won the Outstanding Engineering Project Award for the spillway enlargement at French Meadows Reservoir and the Utility Project of the Year Award for its Gold Run Pipeline replacement project. PCWA also won the ASCE 2011 Emergency Response Award for its water supply actions following last April's failure of the PG&E Bear River Canal. Award presentations are scheduled Feb. 22 in Sacramento.

• heard a presentation from Director of Administrative Services Michael Willihnganz on his department's 2011 accomplishments and 2012 goals.

## Stopping SNAP Fraud in its Tracks

Americans expect and deserve a government that ensures their hardearned tax dollars are managed with accountability and integrity. Without that commitment, we risk undermining public confidence in the value of SNAP, the Supplemental Nutrition Assistance Program – formerly known as food stamps. This critical nutrition program helps millions of people in need put food on the table through tough economic times until they can get back on their feet. In support of this commitment, and as part of the Obama Administration's ongoing Campaign to Cut Waste and root out fraud and abuse in federal programs, USDA announced new steps to strengthen anti-fraud efforts in SNAP.

In that same spirit, I am pleased

to report on the first quarter results of our anti-fraud efforts in 2012. From Oct. 1 through Dec. 31, 2011, we penalized – with fines or a temporary disqualification - more than 225 stores found violating program rules, and we permanently disqualified over 350 stores for trafficking SNAP benefits.

While fraud is a relatively limited problem in SNAP - the violating stores represent less than ½ of one percent of more than 230,000 food stores authorized to redeem benefits - we have a zero tolerance policy for fraud. USDA's Food and Nutrition Service conducts ongoing surveillance and investigation, to find bad actors and remove them from the program. In fiscal year 2011, FNS reviewed over 15,000 stores, and permanently disqualified over 1,200 for program violations.

As Undersecretary of the Food, Nutrition and Consumer Services, at USDA - the federal agency that oversees the state administration of the program – and having run the program at the state level in Maine, Oregon, and Iowa, I know firsthand the importance of SNAP. I don't tolerate fraud and abuse in the program, and neither do the American taxpayers.

So last December I announced new and expanded anti-fraud activities to strengthen USDA's commitment to promote and preserve the integrity of SNAP, a critical nutrition assistance program that feeds more than 46 million low-income and working Americans.

To adapt state-of-the-art tech-

nology to identify suspicious activity, we awarded a 10-year contract to further develop the next generation of fraud detection systems. We are in the process of developing even stronger sanctions and penalties against retailers that misuse the program, we are increasing documentation requirements to verify identity and assure business integrity

as well as researching high-risk stores using tax and business databases, and we recently updated our policies to clarify that advertising the sale of benefits through social media is a violation.

To round out our aggressive steps to combating fraud and trafficking, we recently launched a Fighting SNAP Fraud website (www.fns.usda.gov/fightingsnapfraud) help raise awareness of the issues and provide a direct portal to report suspicious activities. Public assistance is vital to wiping out fraud and trafficking. If you see suspicious activity, report it. Or persons can always call our fraud hotline, at (800) 424-9121.

Taken together, these steps underscore USDA's commitment to combat fraud, waste and abuse and inspire the confidence in government Americans deserve. I'm proud to say that USDA takes protecting taxpayer dollars very seriously and we are working hard to make sure others do, too.







While traveling in Central America, I had the opportunity to worship at an international, interdenominational, Englishspeaking church. The congregation contained Africans, Italians, Spaniards, Latinos, Americans, and Asians. We sang old Irish hymns and modern, Australian worship choruses.

The service was a mixture of Lutheran, Reformed, and Pentecostal elements. The welcome was given by a Canadian, a German read the Scripture lesson, and an American did the preaching. It was a wonderful, diverse experience, and for a little while I thought the kingdom of God had

This, I thought, is what worship should be: People of various Christian traditions, streaming together from all tribes and nations, gathered in an idyllic setting, worshiping Christ together. Then the sermon began, and things changed.

The pastor's sermon could have been heard in many an evangelical congregation in North America. It was about who was "right" and who was "wrong," who was "in" and who was "out." He summed up his sermon, and his philosophy for life, with these words: "Real life is full assurance that you will go to heaven when you die. That is the gospel." At great risk of being misunderstood, I could not disagree more.

## The Gospel **According to Jesus**

As those words were spoken in that Latino church, the surrounding countryside had just endured its worst flooding in five decades. Gang graffiti clung to the walls and sidewalks just steps from the church's front door. Thousands of people were trying to survive grinding poverty.

To say to all these people and in all these of conditions, that "real life" is checking out of this life for the next one, is a mockery of reality and a refusal to heed the gospel that Jesus actually proclaimed. When Jesus began preaching his gospel in the Galilean hills, his message was clear and singular: "The Kingdom of God is at hand. It is here and now," he said. "It is today."

Jesus' intention, it seems, was not to rescue people from earth, per se, transporting them to a far removed heaven. His intention was to put heaven inside of people. A gospel that ignores this fact – and this current world because our status in the next world has been properly secured, is a distortion of Jesus' redeeming message.

Thus, the gospel according to Jesus, is not just about a harp-playing, cloud-riding, hymn-singing, glory-praising, pie-in-the-sky heaven. It is holistic, all-encompassing deliverance, now. I'm not denying the existence of the afterlife; no, not at all. But I do not believe that we have to die to personally experience the life God has for us.

Jesus' first disciples did not have the benefit of two-thousand years of Christian tradition and theology. All those disciples had were Jesus' words: "Follow me, for the Kingdom of God is at hand." They had no promises of a big heavenly payoff. No fluttering angels' wings, no crossing over the River Jordan to the Hallelujah Shore, no promises of golden streets or pearly gates, no "full assurance that you will go to heaven when you die." All they had was the invitation of Jesus to "Follow me." For them, that was enough.

This may sound strange - it sounds a bit peculiar to my own ears – but even if there was not a heaven, I would still be a follower of Jesus. Why? Because I believe that how Jesus taught us to live and the life he has to give, is the greatest hope for our world today. He offers redemption, in all its magnificent and diverse manifestations, as more than the blessed hope of heaven. He offers it as the blessed hope for people today.

So the choice before us plain: We can give up on the present, pack our bags, and wait for the paradise rescue from above; or we can join Jesus in bringing some of that not-here-yet of God's heaven to the here-and-now earth. The choice, I think, is clear for the present – not the future – is the arena in which we follow Christ. Today - not tomorrow - is wherewe live out the gospel according

#### JOURNEY 2: THE MYSTERIOUS ISLAND

(Rated PG)

Only upon digesting the complete title of "Journey 2: The Mysterious Island" was my mind nudged ever so slightly by the thought of Jules Verne.

The problem, which remains for this film as well, is that the first film, titled "Journey to the Center of the Earth" and released in 2008, is entirely forgettable.

"Journey 1," starring Brendan Fraser, now nowhere to be found and not even lost on a mysterious island, was a Jules Verne-type adventure, one that may have pleased kids.

The sequel is equally designed

to satisfy the adolescent filmgoers, such that the teen hero remains Josh Hutcherson's Sean, who's been given permission by his mother (Kristin Davis) for another globe-trotting quest.

Dwayne "The Rock" Johnson, who flexes his pectorals as if he were hanging out at Venice Beach, plays the role of Hank, stepdad to the peripatetic Sean.

In what is expected to be a bonding experience, Hank takes Sean on a journey to a mysterious island, following secret clues that Sean believes Jules Verne left behind.

Curiosity runs in the family because it is apparent that Sean's missing grandfather Alexander (Michael Caine) was so obsessed with the writings of Jules Verne

that he invented the familial craving for wanderlust.

Once in the South Pacific, Hank, in what appears to be a dubious idea, hires goofy, excitable helicopter pilot Gabato (Luis Guzman) to locate the island.

On the upside, at least for Sean, is that Gabato's pretty daughter Kailani (Vanessa Hudgens) tags along for the ride. This, of course, sets up the film's only love interest subplot.

Meanwhile, a crash landing on an island immediately brings to mind that "Journey 2" could detour into a missing episode of "Lost."

Alas, that is not to be, for our intrepid travelers are exposed to the mystery of an upside-down world, where elephants are small and bees and lizards are giant prehistoric beasts.

Naturally, grandpa Alexander, who was busy sending out radio signals with his coordinates, is found on this exotic South Pacific island, which is notable for the fact that it is rapidly sinking into the sea like Atlantis.

The soon-to-be extinct tropical paradise is a wonder of special effects, none more thrilling than watching Sean riding bareback on a giant bee.

Since the story is family-friendly, "Journey 2" lacks the inherent menace of prehistoric threats found in "Jurassic Park," though giant iguanas appear threatening.

To be sure, "Journey 2" is a formulaic adventure story relying heavily on special effects, which is as satisfying as a giant tub of popcorn and a big cone of cotton

candy. It's fun in the moment for

the adolescent crowd.

Two of my favorite things in sports are rivalries and The Zone.

With the limited number of hours in a day to tune into sports, I always prefer to zero in on the classic matchups — the rivalries.

There have been a lot of rivalry games in college basketball lately. I really like the college game, and I don't care what anybody else says. Many on-air personalities make a habit of ripping college hoops and the quality of play. Sure, it's not up to professional standards, but I like following my favorite teams, St .Mary's and Cal, and the rivalry games still make it an attraction for me. And, I'm often rewarded with some classic games.

St. Mary's, back in the days when they were rarely good, it was all about beating USF and Santa Clara. I'll scour the weekly listings for the best matchups and, I have to admit, I get a good charge out of the North Carolina/Duke feud. Duke won the last meeting a couple weeks ago, 85-84, with a late comeback and a buzzerbeater shot.

As for our area pros, the Sacramento Kings and Golden State Warriors are two lousy teams lost in the ozone again, but when they play each other it is usually pretty good. Or, take either playing against the L.A. Lakers and it could be good because our loveable losers usually raise their level of play, though they usually lose.

Raising the level is all about that over-used word in sports, focus. Focus is all about trying to get into The Zone. The Zone is tunnel-vision, total focus on the task at hand. Everything is clicking. The basketball is part of your hand and the hoop is as big as the ocean. Teammates are like siblings, you are familiar with their every move. 



## IRS Releases the Dirty Dozen Tax Scams for 2012

The Internal Revenue Service today issued its annual "Dirty Dozen" ranking of tax scams, reminding taxpayers to use caution during tax season to protect themselves against a wide range of schemes ranging from identity theft to return preparer fraud.

The Dirty Dozen listing, compiled by the IRS each year, lists a variety of common scams taxpayers can encounter at any point during the year. But many of these schemes peak during filing season as people prepare their tax returns.

"Taxpayers should be careful and avoid falling into a trap with the Dirty Dozen," said IRS Commissioner Doug Shulman. "Scam artists will tempt people inperson, on-line and by e-mail with misleading promises about lost refunds and free money. Don't be fooled by these scams."

Illegal scams can lead to significant penalties and interest and possible criminal prosecution. The IRS Criminal Investigation Division works closely with the Department of Justice to shutdown scams and prosecute the criminals behind them.

The following is the Dirty Dozen tax scams for 2012:

#### **Identity Theft**

Topping this year's list Dirty Dozen list is identity theft. In response to growing identity theft concerns, the IRS has embarked on a comprehensive strategy that is focused on preventing, detecting and resolving identity theft cases as soon as possible. In addition to the law-enforcement crackdown, the IRS has stepped up its internal reviews to spot false tax returns before tax refunds are issued as well as working to help victims of the identity theft refund schemes.

Identity theft cases are among the most complex ones the IRS handles, but the agency is committed to working with taxpayers who have become victims of identity theft.

The IRS is increasingly seeing identity thieves looking for ways to use a legitimate taxpayer's identity and personal information to file a tax return and claim a fraudulent refund.

An IRS notice informing a taxpayer that more than one return was filed in the taxpayer's name or that the taxpayer received wages from an unknown employer may be the first tip off the individual receives that he or she has been

The IRS has a robust screening process with measures in place to stop fraudulent returns. While the IRS is continuing to address tax-related identity theft aggressively, the agency is also seeing an increase in identity crimes, including more complex schemes. In 2011, the IRS protected more than \$1.4 billion of taxpayer funds from getting into the wrong hands due to identity theft.

In January, the IRS announced the results of a massive, national sweep cracking down on suspected identity theft perpetrators as part of a stepped-up effort against refund fraud and identity theft. Working with the Justice Department's Tax Division and local U.S. Attorneys' offices, the nationwide effort targeted 105 people in 23 states.

Anyone who believes his or her personal information has been stolen and used for tax purposes should immediately contact the IRS Identity Protection Specialized Unit. For more information, visit the special identity theft page at www.IRS.gov/identitytheft.

Phishing is a scam typically carried out with the help of unsolicited email or a fake website that poses as a legitimate site to lure in potential victims and prompt them to provide valuable personal and financial information. Armed with this information, a criminal can commit identity theft or financial

If you receive an unsolicited email that appears to be from either the IRS or an organization closely linked to the IRS, such as the Electronic Federal Tax Payment System (EFTPS), report it by sending it to phishing@irs.gov.

It is important to keep in mind the IRS does not initiate contact with taxpayers by email to request personal or financial information. This includes any type of electronic communication, such as text messages and social media channels. The IRS has information that can help you protect yourself from email scams.

#### **Return Preparer Fraud**

About 60 percent of taxpayers will use tax professionals this year to prepare and file their tax returns. Most return preparers provide honest service to their clients. But as in any other business, there are also some who prey on unsuspecting taxpayers.

Questionable return preparers have been known to skim off their clients' refunds, charge inflated fees for return preparation services and attract new clients by promising guaranteed or inflated refunds. Taxpayers should choose carefully when hiring a tax preparer. Federal courts have issued hundreds of injunctions ordering individuals to cease preparing returns, and the Department of Justice has pending complaints

against many others.

In 2012, every paid preparer needs to have a Preparer Tax Identification Number (PTIN) and enter it on the returns he or she

Signals to watch for when you are dealing with an unscrupulous return preparer would include that

Do not sign the return or place a Preparer Tax identification Number

Do not give you a copy of your tax return.

Promise larger than normal tax

Charge a percentage of the refund amount as preparation fee. Require you to split the refund to pay the preparation fee.

Add forms to the return you have never filed before.

Encourage you to place false information on your return, such as false income, expenses and/or

#### **Hiding Income Offshore**

Over the years, numerous individuals have been identified as evading U.S. taxes by hiding income in offshore banks, brokerage accounts or nominee entities, using debit cards, credit cards or wire transfers to access the funds. Others have employed foreign trusts, employee-leasing schemes, private annuities or insurance plans for the same purpose.

The IRS uses information gained from its investigations to pursue taxpayers with undeclared accounts, as well as the banks and bankers suspected of helping clients hide their assets overseas. The IRS works closely with the Department of Justice to prosecute tax evasion cases.

While there are legitimate reasons for maintaining financial accounts abroad, there are reporting requirements that need to be fulfilled. U.S. taxpayers who maintain such accounts and who do not comply with reporting and disclosure requirements are breaking the law and risk significant penalties and fines, as well as the possibility of criminal prosecution.

Since 2009, 30,000 individuals have come forward voluntarily to disclose their foreign financial accounts, taking advantage of special opportunities to bring their money back into the U.S. tax system and resolve their tax obligations. And, with new foreign account reporting requirements being phased in over the next few years, hiding income offshore will become increasingly more difficult.

At the beginning of this year, the IRS reopened the Offshore

Voluntary Disclosure Program refunds, including interest and (OVDP) following continued strong interest from taxpayers and tax practitioners after the closure of the 2011 and 2009 programs. The IRS continues working on a wide range of international tax issues and follows ongoing efforts with the Justice Department to pursue criminal prosecution of international tax evasion. This program will be open for an indefinite period until otherwise announced.

The IRS has collected \$3.4 billion so far from people who participated in the 2009 offshore program, reflecting closures of about 95 percent of the cases from the 2009 program. On top of that, the IRS has collected an additional \$1 billion from up front payments required under the 2011 program. That number will grow as the IRS processes the 2011 cases.

#### "Free Money" from the IRS & Tax Scams Involving Social Security

Flyers and advertisements for free money from the IRS, suggesting that the taxpayer can file a tax return with little or no documentation, have been appearing in community churches around the country. These schemes are also often spread by word of mouth as unsuspecting and well-intentioned people tell their friends and relatives

Scammers prev on low income individuals and the elderly. They build false hopes and charge people good money for bad advice. In the end, the victims discover their claims are rejected. Meanwhile, the promoters are long gone. The IRS warns all taxpayers to remain

There are a number of tax scams involving Social Security. For example, scammers have been known to lure the unsuspecting with promises of non-existent Social Security refunds or rebates. In another situation, a taxpayer may really be due a credit or refund but uses inflated information to complete the return.

Beware. Intentional mistakes of this kind can result in a \$5,000

#### False/Inflated Income and **Expenses**

Including income that was never earned, either as wages or as selfemployment income in order to maximize refundable credits, is another popular scam. Claiming income you did not earn or expenses you did not pay in order to secure larger refundable credits such as the Earned Income Tax Credit could have serious repercussions. This could result in repaying the erroneous

penalties, and in some cases, even prosecution.

Additionally, some taxpayers are filing excessive claims for the fuel tax credit. Farmers and other taxpayers who use fuel for off-highway business purposes may be eligible for the fuel tax credit. But other individuals have claimed the tax credit when their occupations or income levels make the claims unreasonable. Fraud involving the fuel tax credit is considered a frivolous tax claim and can result in a penalty of \$5,000.

#### False Form 1099 Refund

In this ongoing scam, the perpetrator files a fake information return, such as a Form 1099 Original Issue Discount (OID), to justify a false refund claim on a corresponding tax return. In some cases, individuals have made refund claims based on the bogus theory that the federal government maintains secret accounts for U.S. citizens and that taxpayers can gain access to the accounts by issuing 1099-OID forms to the

Don't fall prey to people who encourage you to claim deductions or credits to which you are not entitled or willingly allow others to use your information to file false returns. If you are a party to such schemes, you could be liable for financial penalties or even face criminal prosecution.

#### **Frivolous Arguments**

Promoters of frivolous schemes encourage taxpayers to make unreasonable and outlandish claims to avoid paying the taxes they owe. The IRS has a list of frivolous tax arguments that taxpayers should avoid. These arguments are false and have been thrown out of court. While taxpayers have the right to contest their tax liabilities in court, no one has the right to disobey the law.

#### **Falsely Claiming Zero Wages**

Filing a phony information return is an illegal way to lower the amount of taxes an individual owes. Typically, a Form 4852 (Substitute Form W-2) or a "corrected" Form 1099 is used as a way to improperly reduce taxable income to zero. The taxpayer may also submit a statement rebutting wages and taxes reported by a payer to the IRS.

Sometimes, fraudsters even include an explanation on their Form 4852 that cites statutory language on the definition of wages or may include some reference to a paying company that refuses to

issue a corrected Form W-2 for fear of IRS retaliation. Taxpayers should resist any temptation to participate in any variations of this scheme. Filing this type of return may result in a \$5,000 penalty.

#### **Abuse of Charitable Organizations and Deductions**

IRS examiners continue to uncover the intentional abuse of 501(c)(3) organizations, including arrangements that improperly shield income or assets from taxation and attempts by donors to maintain control over donated assets or the income from donated property. The IRS is investigating schemes that involve the donation of non-cash assets — including situations in which several organizations claim the full value of the same non-cash contribution. Often these donations are highly overvalued or the organization receiving the donation promises that the donor can repurchase the items later at a price set by the donor. The Pension Protection Act of 2006 imposed increased penalties for inaccurate appraisals and set new standards for qualified appraisals.

#### **Disguised Corporate Ownership**

Third parties are improperly used to request employer identification numbers and form corporations that obscure the true ownership of the business.

These entities can be used to underreport income, claim fictitious deductions, avoid filing tax returns, participate in listed transactions and facilitate money laundering, and financial crimes. The IRS is working with state authorities to identify these entities and bring the owners into compliance with the law.

#### **Misuse of Trusts**

For years, unscrupulous promoters have urged taxpayers to transfer assets into trusts. While there are legitimate uses of trusts in tax and estate planning, some highly questionable transactions promise reduction of income subject to tax, deductions for personal expenses and reduced estate or gift taxes. Such trusts rarely deliver the tax benefits promised and are used primarily as a means of avoiding income tax liability and hiding assets from creditors, including the IRS.

IRS personnel have seen an increase in the improper use of private annuity trusts and foreign trusts to shift income and deduct personal expenses. As with other arrangements, taxpayers should seek the advice of a trusted professional before entering a trust arrangement.

## Writing Medicare's Prescription

The Republican primary in Florida brought discussions of healthcare, particularly Medicare, back to the forefront of the national discourse. With its sizeable senior population, Medicare and Social Security were top of mind to Florida voters.

It is certainly important that health care, and particularly Medicare, be debated thoroughly during the Presidential campaign, as entitlement reform is one of the most pressing issues that Congress and the White House will face next year. Indeed, the latest annual Medicare and Social Security Trustees report projected that the Medicare trust fund will run out in 2024 - five years earlier than previously expected - and the Social Security trust fund will run out by 2036.

The good news is the emerging national consensus, across the ideological spectrum, that we

must address the nation's budget problems and that Medicare reform must be a part of any agreement. It's essential, though, that changes to the Medicare program be made responsibly, starting with the principle that reform must protect the elements of the program that are working efficiently now.

One Medicare program that should be kept intact is Part D, the prescription drug benefit program. Part D is the most cost-effective and successful entitlement program the federal government runs. Even Newt Gingrich, presenting himself on the campaign trail as the champion of conservative voters, has spoken up several times in support of Part D. He has touted the market-based program's success and effectiveness in saving lives, saving money and offering people more choices.

Thanks to competition among insurers, the prescription drug program costs the government and beneficiaries far less than

initially projected. Last year, the Congressional Budget Office (CBO) reduced its baseline 10-year spending projection for all of Medicare by \$186 billion, two-thirds of which is accounted for by a reduction in Part D spending.

While Medicare Part D is an example of a Medicare program that works, it is clear that not all Medicare policies and programs are as useful and valuable.

The Independent Payment Advisory Board (IPAB) that was created with the passage of President Obama's health care law is one such provision that should be eliminated. IPAB would allow an unelected and unaccountable board to make program cuts to meet spending targets.

Proponents of the board have argued that IPAB will improve the quality of care as a result of the cost-cutting measures it enacts. In fact, IPAB is a threat to critical medical treatments and services for all Medicare beneficiaries. The cuts it imposes will only reinforce systemic problems, not fix them, and create unsustainable savings.

Major changes in the Medicare program should not be decided by bureaucratic fiat in a process lacking transparency and oversight. Rather, they should be debated and decided by elected officials who will be held be accountable for their decisions. Everyone knows that tough choices lie ahead. It's up to our political leaders to explain that reforms are essential to make Medicare secure for future generations of seniors.

There are many possible ways to reduce Medicare spending. A broad reform debate will enable people to better understand the tradeoffs involved.

To make sure program benefits remain available for those who need them most, lawmakers should consider eligibility requirements and need-based benefits. By raising the eligibility age for Medicare to 67 from 65, for example, \$124 billion would be saved.

The bipartisan Simpson-Bowles commission has proposed gradually limiting the Medicare benefits the wealthy receive. Last fall, President Obama proposed higher Medicare premiums for high-income seniors as part of the deficit reduction plan that he submitted to the Congressional "supercommittee." Obama's plan would save about \$20 billion over 10 years in Medicare.

Increasing premiums beneficiaries pay for Medicare doctors' coverage to 35 percent of program costs from the current 25 percent could save \$241 billion. Modernizing Medicare's benefit package to include copayments, deductibles and an out-of-pocket maximum could save about \$14 billion through 2018. A cutback in subsidies for "Medigap" supplemental insurance would save \$92 billion.

A still-bolder proposal going beyond Medicare itself would be to remove the distortion in the

tax code that keeps health insurance tied to employment. The tax write-off for employer-provided health care benefits is the single largest tax expenditure. It is estimated to cost the government more than \$1 trillion over the next five years. Capping the tax exclusion in 2018 and then phasing it out over 10 years would result in massive savings that could be devoted to shoring up Medicare and other programs for seniors.

The American people are ready to accept some difficult choices as part of a comprehensive deficit reduction program. It is time for Congress to begin the
