New Banquet Facility Approved

CITRUS HEIGHTS, CA (MPG)

- Citrus Heights Planning Commissioners have unanimously approved a use permit for the new Citrus Town Event Center at 7942 Arcadia Drive.

Commissioners only had brief comments during the 10-minute portion of the meeting on September 13th that addressed the event center proposal. No members of the public spoke during a public hearing held prior to the vote.

After the meeting, the center's owner, Sam Hameed, said he's looking for a late December or early January 2024 opening date.

The Citrus Town Event Center will be used for weddings, birthdays, baby showers, graduations, conferences, and seminars, he said. The facility will have a parking capacity of 100 spaces under a shared parking agreement with Citrus

Town Shopping Center.

Hameed said he has begun to actively market the new facility, launching a website which provides an email contact and business telephone listing for future bookings.

Interior construction has

started, and the building's exterior recently received a fresh coat of paint.

"The hall will be available and affordable for a wide range of celebratory personal and public events, including weddings, business gatherings and corporate functions." Hameed said.

The 6,000-square-foot brick façade building, vacant since 2018 and built in 1975, features a prominent round glass-block turret. The interior is being fully refreshed with new interior designs.

A second-floor bridal room is also planned, Hameed said.

Planning Commission Hears Sylvan Corners Housing Project

CITRUS HEIGHTS, CA (MPG) - Members of the Citrus Heights Planning Commission voted 4-1 at their most recent meeting on September 13th to approve seven individual recommendations prepared by planning staff for the proposed Sylvan Corners subdivision.

Specific recommendations included a general plan amendment, a tentative subdivision map, a design review permit, a tree permit, and a change

Approval of the general plan amendment changes the designation of the project site from public to medium density residential (MDR). The city zoning code amendment rezones

the property into the

Sylvan Corners Special

Planning Area.

A project presentation to the commission was led by city project planner Alison Bermudez.

Michael LaFortune, vice president of land acquisition and development at Woodside Homes followed her presentation with a slide presentation recently featured at a second community meeting on August 22nd, which provided a Sylvan Corners project update, described the character and lot types of the new residential community and illustrated traffic circulation patterns. An overview of landscape concept plans and the features of a water retention basin which will face Old Auburn Boulevard was

also described. Commissioners Marcelle Flowers, Thomas Scheeler,

Andrew Van Duker, Oleg

Shishko voted to approve the recommendations of planning staff, and vice chair Natalee Price voted no. Commissioners James Remick and Max Semenenko were absent.

The development proposal by Woodside Homes includes the creation of 94 lots and 6 open space lots to allow for 94 single-family homes on a 11.3-acre site where the original Sylvan School, demolished in 2016 once stood.

Plans show 81 homes would be priced at market-rate, while 14 are shown as affordable units. The project features two entrance and Boulevard.

LaFortune said general site work and construction could start in April 2024 with the first model homes completed for sale by the end of 2024.

The 11.3-acre site was purchased by the City of Citrus Heights in 2019 for \$3.4 million from the San Juan Unified School District. The city hoped to turn the property around and sell it to a preferred developer for mixed-use development. Only one offer was received, which was from Woodside Homes during an offering period in 2020.

Enhanced pedestrian connections will connect the property to nearby businesses, Sylvan Plaza and the adjoining Sylvan Middle School. A pedestrian access gate, provided at the southwest portion of the project, adjacent to

Council **Approves** Agreement for Homeless **Assistance Program**

- At the September 14 meeting, the Citrus Heights City Council considered a Memorandum of Understanding with Sacramento County in order to address homelessness in the Citrus Heights community.

The City's previous Homeless Navigator Program - which provided resources to help homeless individuals in Citrus Heights find housing and other assistance - was temporarily suspended in May when the service provider, Sacramento Self-Help Housing, was dissolved due to bankruptcy. Staff spent the summer looking into options to bring the program back. The City recently reached an agreement with Sacramento County's Department of Homeless Services and Housing (DHSH), which contracts with the nonprofit Sacramento Covered, to expand Community-**Based Navigation Program** services into Citrus Heights.

The funding -\$344,836from Sacramento County's federal American Rescue Plan Act (ARPA) award - was approved by the Sacramento County Board of Supervisors, with the support of District 4 Supervisor Sue Frost. The funding will run through December 31, 2025, to cover one full-time Sacramento Covered community health worker (or Navigator) focusing on Citrus Heights clients. And City staff are working to identify permanent funding sources to maintain the position when that funding term ends.

Kyle Stefano, vice president of clinical programs at Sacramento Covered, said the nonprofit helps homeless people get medical care, cell phones, transportation, ID cards and documentation, and anything else they need to pursue housing opportunities. Stefano said that just this year alone, they have made about 350 housing placements; some were at shelters, but the majority were permanent housing. They currently have 22 Navigators who work in the community, reaching out to the homeless population. Many of them have experienced homelessness

Meals on Wheels Seeks Volunteers

SACRAMENTO REGION, CA (MPG) - When COVID-19 hit our world, many businesses and organizations were paused or shut down completely, never to reopen. For some that were fortunate enough to survive, bouncing back after such an event hasn't been simple. While the shutdowns may now seem like ancient history to many people, non-profit organizations in particular are still recovering. One such local group is Meals on Wheels by ACC Senior Services.

Meals on Wheels is a well-known national organization, and locally it's quite known as well. The group helps keep seniors in their homes and communities by providing nutritious meals, safety net services, social contact, and community resource information. Sacramento Valley's Meals on Wheels division alone is home to 126 routes that deliver meals all throughout the region - stretching all the way out through the delta, as well as 13 congregate programs where seniors can go eat at a cafe and socialize.

According to Michelle Bustamante, the operations manager of the Sacramento Meals on Wheels division, they adjusted during the pandemic by switching from hot delivered meals to frozen meals that arrived with little to no face-toface contact. And now, they are aiming to work their way back up to their full meal distribution services pre-pandemic.

"We need volunteer

drivers," said Bustamante. "We are still looking to convert four routes back [to hot meals with faceto-face contact] and need drivers."

Meals on Wheels also has several programs outside of its home meal delivery service. All Seasons Cafe is an in-person restaurant-style space.

"It is for people who are more mobile and can get out and want to go have lunch with peers," Bustamante explained. "It's an opportunity for them to socialize."

While All Seasons Cafe

currently has 13 locations, they are looking for one more. Meals on Wheels currently does not have a Citrus Heights location. They are urgently seeking anywhere with a commercial kitchen and enough space for seniors to congregate. These cafes typically take place in community centers, senior centers, or in senior apartment complexes. With each lunch hosting 20-90 folks each meal, Bustamante hopes to raise awareness of the need and find a willing partner so they can serve the seniors of Citrus Heights.

With the holidays quickly approaching, Meals on Wheels will also again host Project Warm Wishes, which distributes gifts to seniors served by their organization. Both fun and functional items are appreciated, including toiletries, small household items, blankets, gloves, and amusements like adult coloring books and magazines.

"We just want to make sure those people know that they're not forgotten and are cared for," Bustamante said about the holiday project, which is completely delivered by volunteers.

Project Warm Wishes starts in mid-October and donations are accepted through December 8. Used items are not accepted, but brand-new donations are enthusiastically welcomed.

One other very special program operated by Meals on Wheels? Animeals. Through this, they deliver food to roughly 200 cats and dogs throughout Sacramento County. After it was discovered that some home-bound seniors were sharing their meals with their animals to get by, the

group realized the need and took action. Most of the pet food or the funding for the program are donated.

"Pets are more than just animals - they are family to many of our seniors," says Bustamante.

From cafe workers to route drivers, all of Meals on Wheels' volunteers receive a background check and go through a training program. When Bustamante asked how volunteers are chosen and implemented, she mentioned that both individuals and groups like churches and service clubs apply. The goal is to plug people in where their heart is.

"The initial onboarding is done online nowadays, and we meet up with a volunteer and find out what their availability is and what they would like to get out of volunteering."

Volunteers are greatly needed at Meals on Wheels in Sacramento, and any adult with a passion to help can get involved. While help for the organization comes through various sources including Community Block Grants, city funding, private donors, and the Agency on Aging (Area 4), volunteers are still very difficult to find at times.

Meals on Wheels currently has a waitlist for seniors needing services, and the more volunteers they can train and recruit, the smaller that waitlist gets. Those hoping to get involved can contact Michelle Bustamante at (916) 444-9533 or by emailing mbustamante@ mowsac.org

Outreach Regarding Homelessness in Citrus Heights Continues through County MOU

City of Citrus Heights News Release

CITRUS HEIGHTS, CA (MPG) - The City of Citrus Heights is pleased to announce City Council's approval of the Memorandum of Understanding with Sacramento County Department of Homeless Services and Housing to deliver the Community Based Navigation Program to the City. This program will provide homeless outreach and navigation services to unsheltered individuals in the City of Citrus Heights.

Sacramento County Department of Homeless Services and Housing (DHSH) will expand on its new service model used throughout unincorporated Sacramento County, with non-profit Sacramento Covered, to provide support services, emergency shelter, interim, and permanent housing. Sacramento Covered employs Community Health Workers (CHWs) to deliver services and establish a positive relationship with local community organizations, residents, and businesses in order to foster a supportive coalition for unsheltered individuals in the City.

Through this collaboration and ARPA district-directed funding allocation of \$344,836 from Sacramento County District 4 Supervisor Sue Frost, funding will be directed to DHSH to support one (1) full-time CHW, client assistance support, and associated administrative costs for the City through December 2025.

"I'm proud to help support the homeless outreach efforts of Citrus Heights through funding for their partnership with Sacramento Covered," said Board of Supervisor for District 4, Sue Frost. "We've seen the services provided by Sacramento Covered work throughout the County and are looking forward to the impact this partnership will have on those affected by homelessness in the City of Citrus Heights."

"This partnership with Sacramento County and Sacramento Covered will allow us to continue our efforts in helping those experiencing homelessness in Citrus Heights. The funding provided by Supervisor Sue Frost has given this partnership the support it needed to get to work on improving the quality of life for all our residents," said Mayor Tim Schaefer.

This partnership is an opportunity to build on the foundation the City established through the prior relationship with Sacramento Self-Help Housing, which closed in June of this year. The Community Based Navigation Program partnership with DHSH and Sacramento Covered provides for a more effective service delivery model that results in greater efficiencies and advancements in addressing this important challenge.

Continued from page 1 in the past, and Stefano said, "They are all heart and in it to serve the community."

Vice Mayor Bret Daniels said he is excited the program is back. "It's been an unfortunate gap, and visually I think we can see what is the result of that gap." He said that by getting people the resources and help they need, he is hoping to soon see a reduction in the number of homeless residents in Citrus Heights

Mayor Tim Schaefer said, "I hope we're able to sort of move the needle with this additional funding."

The Council voted unanimously to approve the agreement with Sacrament County DHSH to expand the Community-Based Navigation Program into Citrus Heights.

The Council also considered recommendations from the Finance Committee (comprised of Vice Mayor Daniels and Councilmember Jayna Karpinski-Costa) on the allocation of Fiscal Year 2023/2024 Community Support Funding. This limited one-time funding is available for non-profit organizations that provide services to residents of the Citrus Heights community. For this fiscal year, \$180,000 is available in the fund and six applications were received.

Campus Life Connection requested \$20,000 to support their after-school programs at the Sayonara Center. Citrus Heights Marching Band requested \$20,000 for instructional staff compensation, equipment, and materials, as well as support and traffic control for their Howl O' Ween Parade. Community Link Capital Region requested \$2,498 to support their home delivery of meals using an existing partnership with DoorDash to deliver food pantry items from Sunrise Christian Food Ministry to those in need. Meals on Wheels requested \$82,000 for meal delivery to seniors in Citrus Heights. Single Mom Strong requested \$25,365 to increase existing programs and services to support single-parent families. Sunrise Christian Food Ministry requested \$21,600 to support the daily redistribution of recovered food from

local grocery stores to those experiencing food insecurity.

The Finance Committee recommended the approval of all applications except for the Sunrise Christian Food Ministry. They also added a stipulation to the Meals on Wheels request that, if approved, 20 Citrus Heights seniors on the waitlist be included and covered with these funds.

Councilmember Porsche Middleton asked the Committee why they didn't recommend approval for the Sunrise Christian Food Ministry application. Councilmember Jayna Karpinski-Costa explained that the request specified the funds would help cover rent costs and porta-potties. And she added that only about 25% of their clients are in Citrus Heights, while the Committee wanted to focus more on non-profits specific to Citrus Heights. But she said that the City does generally approve other funding to support the Sunrise Christian Food Ministry through their annual Community Development Block Grant (CDBG) award.

After funding the applications recommended for approval, \$30,137 would remain available in the Community Support Funding, which can be used for other economic development and community engagement grant programs this fiscal year.

In a written comment, Sunrise Christian Food Ministry Director of Operations April Jacek asked Council to reconsider the recommendation. She wrote that there has been a huge increase in need in the community over the last couple years, and that has, in turn, increased their costs as they work to collect food every day from the large grocery stores and package it for redistribution to families in need. "By denying our request, you are sending a message to the residents of Citrus Heights and our volunteers that the work we do does not hold value," wrote lacek

Mayor Schaefer asked if the Finance Committee wanted to reconsider their decision, but they declined.

The Council voted unanimously to approve the funding allocations as recommended.

Finally, the Council considered the Objective Design and Development Standards (ODDS) for the Auburn Boulevard Special Planning Area. Since the Boulevard Plan (which envisions a dynamic, livable, and walkable urban community) was adopted in 2005, the State has passed a series of housing laws intended to streamline the construction of qualified housing projects. These laws eliminate the use of subjective standards that might cause a project to be rejected by local governments, thus limiting the City's ability to ensure new developments meet the architectural and aesthetic vision of the Boulevard Plan. So, in order to comply with new legislation, Objective Design and Development Standards (ODDS) need to be adopted.

The ODDS essentially take the existing standards from the Boulevard Plan and transition them into objective design rules, including things like parking requirements, minimum and maximum setbacks, building height, building density, and architectural design. These objective standards will ensure that the appearance of new development is compatible with the City's vision for the Boulevard, while still complying with State laws.

Vice Mayor Daniels expressed concern that the standards don't do enough to restrict the possibility of tall apartment complexes being built behind single-family residences: "We have an obligation to protect those people out of the gate." He asked about adding building height restrictions for certain locations within the plan area. But the ODDS are only quantifying existing standards in the Boulevard Plan, and City Manager Ashley Feeney suggested that such questions required "a deeper dive, and a much wider conversation" about the Specific Plan, so he suggested an upcoming Work Plan discussion could provide Council with the time for "a more informed conversation."

The Council voted unanimously to approve the ODDS to comply with current State housing legislation.

The next Citrus Heights City Council meeting is scheduled for September 28, 2023. ★

Little Rally for Homeless Struggles Riehle Running to End the Tyranny

The struggle of the unhoused and homeless community and those who would decide where they can sleep at night continues in the city of Citrus Heights.

On September 14, a handful of those who call Citrus Heights home but without an address of their own and their supporters gathered for the 5th Peaceful Assembly for Homeless Rights in front of city hall to call attention to their ongoing plight of being made to "keep moving" when trying to sleep at night or even

rest during the day. According to rally organizer Alfred Sanchez, aka Snack Man, "By the strict wording of their Citrus Heights ordinance, a blanket is camping. Camp means to pitch or occupy camp facilities, to use camp paraphernalia. Camp facilities include, but are not limited to tents, huts, or temporary shelters. Camp paraphernalia includes but is not limited to, bed rolls, tarps, cots, sleeping bags etc."

Sanchez questions the constitutionality of an ordinance that punishes someone for sleeping outside when they have nowhere else to go.

It is a complex issue. Citing the words of Circuit Judge Marsha Berzon in a federal court ruling in 2018, "sitting, lying and sleeping on the streets was an 'unavoidable consequence' of homelessness, and that it would be an Eighth Amendment violation for cities to punish that conduct when their shelter had

too few beds. As long as there is no option of sleeping indoors, the government cannot criminalize indigent, homeless people for sleeping outdoors, on public property, on the false premise they had a choice in the matter."

The 2018 decision by the U.S. Court of Appeals for the Ninth Circuit was the response to Martin vs. Boise, a 2009 lawsuit by six homeless plaintiffs against the City of Boise, Idaho regarding the city's anti-camping ordinance. The ruling held that cities cannot enforce anti-camping

ordinances if they do not have enough homeless shelter beds available for their homeless population. It did not necessarily mean a city cannot enforce any restrictions on camping on public property.

The decision was based on the Eighth Amendment to the U.S. Constitution's prohibition on cruel and unusual punishment. Source: Wikiwand

There are two issues being worked on to allow those who must be outside to maintain a quality of life that does not impede on those around them, and to make more beds available to those who want them.

A new program which the General Services Department oversees is the City's new Beautification program. The team's goal is to "patrol and proactively maintain public areas, including removing abandoned carts and debris, unlawful camp abatement, illegal dumps, trash/litter removal, graffiti, debris removal, illegal signs from poles and public spaces, and weed abatement."

This includes items abandoned in public areas and anything blocking roads, sidewalks and other areas.

This may have been successful, however, Shane, a resident of Citrus Heights his whole life who found himself homeless since 2017 when his grandmother died, recently had all of his clothes and bedding stored in a duffle bag next to the Citrus Heights library taken by the Beautification team. He has pride that he keeps everything he owns close by, keeps his area and the park clean and only leaves his belongings for

recycling to survive, but now is not looking forward to the



Social Security Matters Compromise Settles Dispute Over Status

Will Opening a Joint Account Affect My Disabled Father's "SSI?"

Dear Rusty: I live in Michigan and my senior disabled father lives in rural Kentucky. His income is part Social Security and part disability. I talked to a local credit union near his home and explained I would like to open a joint account. They said as long as he comes in with his ID it's possible. My question is - will adding money to our joint account affect his SSI and disability? Signed: Caring Daughter

Dear Caring Daughter: First, I need to clarify that there are two types of disability programs administered by the Social Security Administration -Social Security Disability Insurance (SSDI), and Supplemental Security Income (SSI). The acronym "SSI" normally refers to "Supplemental Security Income" which is a benefit for disabled senior adults (and children) who have very little income and very few assets. "SSI" is not Social Security income; rather it is a general benefit program jointly administered by the Social Security Administration and the State in which your father lives. In contrast, Social Security Disability (SSDI) benefits are earned from working and are not affected by the recipient's assets, as are "SSI" benefits.

From what you've written, I assume that your father may have a small Social Security retirement benefit (because he has reached his full retirement age and SSDI isn't available after full retirement age), and he is also receiving Supplemental Security Income (SSI) disability benefits. If this is the case, although your father's Social Security retirement benefit would not be affected by opening a joint account at the credit union, his Supplemental Security Income (SSI) disability benefit likely will be. As co-owner of the joint account your assets would count towards your father's "SSI" asset limit, and your assets, as well as any "in kind" assistance you otherwise provide, would likely put your father over the SSI income/asset eligibility limit and result in his SSI benefits being terminated.

So, although the credit union may be willing to open a joint account for you and your father, I'm afraid that would result in your father losing his SSI (Supplemental Security Income) benefits, leaving him with only his small Social Security retirement benefit. You may wish to review the SSI

eligibility information at this link: www.ssa.gov/ ssi/eligibility or you could contact the Social Security Administration and ask to speak with someone experienced with Supplemental Security Income matters. For clarity, "SSI" assistance is jointly administered by the Social Security Administration and each State's Human Services department, and assistance available varies somewhat depending on the recipient's state of residence. Thus, since your father lives in Kentucky, you might also contact that state's human services agency to discuss your options for providing remote assistance to your father without jeopardizing his Supplemental Security Income (SSI) benefit: www.chfs.ky.gov/ Pages/contact.aspx.

Of Franchises In Fast Food Industry

In some ways, the most interesting — and perhaps most significant — event of the 2023 legislative session's closing days was a compromise agreement on state oversight of the fast food industry.

Last year, unions pushed through legislation that would have created a new state commission to set wages and working conditions in the industry.

Inferentially, the legislation set aside the industry's franchise system and treated local outlets of as merely branches of their corporate franchisors.

While the wage increases that would have resulted garnered most of the media attention, erosion of the franchise model was most worrisome aspect to the fast-food corporations and their franchisees.

Immediately, big guns in the industry pledged tens of millions of dollars for a campaign to challenge the legislation via a referendum that qualified to go before voters in 2024.

The Legislature's response was entertaining another bill that would have doubled down on attacking the franchise model by making corporate franchisors legally responsible for labor law violations in their franchisees' fast-food outlets.

With the outcome of the referendum election in doubt, the long-warring factions began negotiating and last week a bargain was

The 2022 legislation would be repealed, the 2023 legislation would be scuttled and a substitute for both would retain the fast-food council, but alter its membership slightly, limit its authority to set wages and working conditions, provide a new \$20 per hour minimum wage for fast food workers, prohibit local efforts to affect wages, and remove threats to the franchise model.

Like all legislative compromises, this one, written into Assembly Bill 1228, had something for everyone but didn't give every stakeholder everything it wanted.

"For the last decade, fastfood cooks, cashiers and baristas in California have been sounding the alarm on the poverty pay and unsafe working conditions plaguing our industry," Ingrid Vilorio, a fast-food union leader, said in a statement. "We have always known that to solve these problems, we need a seat at the table with our employers and the power to help shape better rules across our industry."

"It provides meaningful wage increases for workers, while at the same time eliminates more significant — and potentially existential - threats, costs, and regulatory burdens targeting local restaurants in California," International Franchise Association CEO Matt Haller said in a statement.

Haller's statement hints that on balance, it appears that given the circumstances, the fast-food industry's big players, such as McDonald's, came out ahead, although their franchisees will feel whatever financial pinch ensues.

The \$20 minimum wage is only slightly over what, on average, fast food workers are being paid now, the industry having boosted wages sharply in the last few years in an effort to fully staff the outlets. Current California fast food wages average \$19 an hour.

More significantly, the agreement protects the franchise system's assumption that the operators of fast-food outlets are independent businesspersons who invest their money and are fundamentally responsible for hiring, training, paying and sometimes firing their workers.

Had state regulation of fast-food wages and working conditions survived as originally proposed, with franchisees indirectly considered to be merely branch managers rather than entrepreneurs, it could have undermined franchising in other consumer industries.

Union leaders much prefer

to deal with large scale sectors rather than individual employers in both organizing workers and negotiating contracts. The recently ratified labor contract affecting every West Coast port is an example of sector-wide negotiations, as is the current standoff over a new auto industry contract.

Cracking the fast-food franchise system would have been a big step in that direction.





CDPH Recommends All Californians Stay Up to Date on COVID-19 Vaccine

CDPH Release

SACRAMENTO, CA (MPG) - Following federal approval of the updated COVID-19 vaccine and recommendations for the upcoming winter respiratory virus season, the California Department of Public Health (CDPH) is recommending all Californians stay up to date on the vaccine and get the updated shot when available.

For renewed protection against severe illness, hospitalization and death, all Californians 5 years and older should receive one dose of the updated COVID-19 vaccine, as long as it's been 2 months or more since their most recent dose. Getting vaccinated may also minimize your symptoms if you do become infected so you can return to your daily activities more quickly. Recommendations for younger children depend on the number of doses received previously.

CDPH strongly urges vaccination for individuals who are at high risk of serious illness from COVID-19 due to advanced age or underlying illness as this is the group of individuals most vulnerable to severe disease and the worst outcomes.

"Staying up to date on the COVID-19 vaccine is the best way to keep your immunity strong and protect yourself and others from severe illness, hospitalization, and death," said CDPH Director and State Public Health Officer Dr. Tomás Aragón. "As we enter the winter season, it is crucial that all individuals remain up to date with vaccinations when they're eligible, including flu, COVID-19 and RSV."

WHO SHOULD GET VACCINATED

•Everyone Age 5 and Up: Everyone 5 years of age and older, regardless of previous vaccination, is eligible to receive a single dose of the updated COVID-19 vaccine as long as it's been at least 2 months since the last dose.

•Younger Children and Infants: Infants and younger children, 6 months through 4 years of age, who have previously been vaccinated against COVID-19 are eligible to receive one or two doses of the updated vaccine. The timing and number of doses depends on the previous COVID-19 vaccine received.

•Unvaccinated Younger Children and Infants: Unvaccinated infants and younger children, 6 months through 4 years of age, are eligible to receive three doses of the updated Pfizer-BioNTech COVID-19 vaccine or two doses of the updated Moderna COVID-19 vaccine.

WHEN & HOW TO SCHEDULE

YOUR UPDATED COVID-19 VACCINE: Initial supplies of updated COVID-19 vaccine are expected in California in the coming weeks. For added convenience, COVID-19, flu, and RSV vaccines can all be administered in the same visit. Schedule a vaccine appointment by visiting MyTurn.ca.gov or contacting your local pharmacy or health care provider.

HOW TO PAY FOR A COVID-19 VACCINE: COVID-19 vaccines will continue to be free for most Americans through their health insurance plans, including Medi-Cal and regular health care providers.

The CDC's Bridge Access Program will provide limited quantities of COVID-19 vaccines to uninsured and underinsured adults through December 2024. The Vaccines For Children (VFC) program is a federally funded program that provides vaccines at no cost to children (18 and younger) who might not otherwise be vaccinated because of inability to pay.

CDPH'S VIRUS PREVENTION TIPS: The best defense against COVID-19 and other winter viruses starts with good prevention. Follow these five tips to protect yourself and others:

•Stay Up to Date on Vaccines: Vaccines reduce the chances of infection and are the best defense to limit severe illness and death. COVID-19, flu, and RSV vaccines will all be available for this winter season.

•Stay Home if You're Sick, Test for COVID and Treat if Needed: Staying home when you're sick slows the spread of COVID-19, flu, RSV, and even the common cold. If you have symptoms, test for COVID-19 and contact your doctor immediately to seek treatment. Treatments work best when started right after symptoms begin.

•Consider Wearing a Mask in Indoor Public Places: Wearing a mask significantly reduces the spread of respiratory viruses, especially in crowded or poorly ventilated spaces.

•Wash Your Hands: Frequent hand-washing with soap and warm water, for at least 20 seconds, is an easy and very effective way to prevent getting sick and spreading germs.

•Cover Your Cough or Sneeze: Remember to cough or sneeze into your elbow, your arm, or a disposable tissue to help prevent the spread of winter viruses. Wash or sanitize your hands and dispose of your tissue after.



Nature on Parade

CARMICHAEL, CA (MPG) - Birds, reptiles and marsupials will be among educators during the Effie Yeaw Nature Center's NatureFest event. The October 8 event is the center's largest educational open day of the year.

Among visiting presenters will be Gabe Kerschner, who runs an animal sanctuary in Placer County. His rescued animals are stars of hundreds of school programs. They include an alligator, a lemur, a kangaroo and a kinkajou. NatureFest supporters will also view a more regional menagerie: this could include a skunk, a raccoon and an opossum and raptors.

NorCalBats, an organization that rescues and rehabilitates bats will bring wee flying mammals and discuss their benefits to the environment. A bee keeper will exhibit a hive with its industrious inhabitants. Folsom City Zoo Sanctuary will have rescued native species on display and Miridae Nursery will offer native plants for purchase.

Save the Snakes, a nonprofit that champions one of nature's most misunderstood species, will offer slithering gopher and king snakes for supervised handling. Volunteers from Sacramento Splash will detail microscopic species found in wetlands.

Resident Nature Center animals – including Einstein the tortoise and several crowd-pleasing raptors – will also interact with visitors. Deer and wild turkey sightings are likely on hosted walks through the center's 100-acre wildlife preserve.

The Nature Center is a hub for Native American studies. Maidu skill demonstrations will include basketry and tule doll-making.

Kids' games will be offered, and youth groups are welcome at the event. Snacks can be purchased from food trucks.

NatureFest runs from 10 a.m. to 3 p.m.
