Not Your Grandparents' Food Closet

Food Ministry Adapts to Seniors, Organic Waste Mandate and More

CITRUS HEIGHTS, CA (MPG) - Sunrise Christian Food Ministry at Advent Lutheran Church on San Juan Road is run like a huge, well-oiled machine with a lot of moving parts. Today, it takes much more time, money, resources and manpower to put that bag of food and other products in the client's car.

To help the process run more smoothly and serve clientele better, a new senior hour has been implemented to help those 60 and over have a shorter wait time in the heat.

Registration begins at 11:00 am, the parking

lot opens at 11:30 while food donations are being processed.

After a short wait, cars

work their way up the hill to the drive-thru area where volunteers fill their cars with donated perishable

and non-perishable food, and items such as cakes, cookies, pies and other specialty items. Donating stores include Costco, Walmart, Sam's Club, Safeway, McClellan commissary and many more. Some restaurants such as Olive Garden donate. Costco also provides non-food items returned which cannot be resold such as sunglasses, clothing and adult products on a table at registration.

About 130 cars and up to 600 seniors and their drivers pass through the three rows set up with colorful barriers beginning at 11:00. Following the seniors,

Theatre in the Heights Confirms Closure

CITRUS HEIGHTS, CA (MPG) - The final curtain has come down on Theatre in the Heights in Citrus Heights. Confirmation of permanent closure came in an additional email to season ticket holders on Saturday, September 9th.

Blake Flores and Vanessa Voestch, founders and executive directors of Theatre in the Heights announced in an August 21st notice to season ticket holders that they were retiring from the theater and turning management over to Vivid Flare Productions.

On September 1, the Messenger reported the upcoming management turnover to Vivid Flare. An email sent to season ticket holders after publication which was sent by Flores and Voetsch announced they considered Vivid Flare Productions "not ready for prime time," and the pair would resume management of Theatre in the Heights through the end of the fall season and promptly respond to emails and voicemails which had been left for them.

Eight days later, on Saturday, Sept. 9th in another email to season ticket holders, Theatre in the Heights announced its final closure.

"It has been a crazy rollercoaster ride this last week as we tried to bring the theater back but were met with an onerous impediment at each turn," the pair wrote in a statement.

"After much deliberation, we made the difficult decision to shut down all theater operations, effective immediately."

Timely financial help to keep the non-profit Theatre in the Heights open could have come from the City of Citrus Heights, said Citrus Heights City Manager Ashley Feeney, a regular patron of Theatre

in the Heights.

Feeney said he received the same email closure notice sent to season ticket holder from Flores and Voetsch. He called and emailed Flores, offering his personal help, urging the non-profit Theatre in the Heights to promptly apply for available grant funding under the city's Community Support Fund program where third fiscal quarter applications are being accepted.

Individual efforts by both Feeney and the Messenger to contact either Flores or Voetsch to tell them of available city grant funding by telephone or email proved unsuccessful.

Theatre in the Heights, founded in 2016 at 8215 Auburn Boulevard, Suite G was the only community theater in Citrus Heights. The website address theatreintheheights.com has been updated to reflect the immediate notice of permanent closure.

"Once again, we thank our patrons and artistic collaborators for your tremendous support throughout the last seven years. We have so many great memories to take away."

Theatre in the Heights featured a 52-seat auditorium and was tucked away next to a barber shop in the Aquarium Depot shopping Plaza on Auburn Boulevard. The theater was shuttered for more than a year, following COVID-19 shutdown orders and largely ran on the donations from its many loyal fans who helped keep the theater to stay alive, they said in earlier public interviews.

"We will be liquidating all theater assets in the next few weeks and making every attempt to refund all ticket holders, so please be patient. Much love to all," Flores and Voetsch said.

CITRUS HEIGHTS, CA (MPG) - Citrus Heights Arts, and community partners Sunrise MarketPlace, the Marketplace at Birdcage and the city of Citrus Heights team up to present ArtBeat, a first-ever, art and music festival, Saturday, October 14th from 11 am to 3 pm at the Marketplace at Birdcage, located at 5975 Birdcage Centre Lane, just behind Jamba Juice.

"This upcoming free festival is all about celebrating artistic expression and providing entertainment for everyone in the community," said Gigi Rayford, executive director and founder of Citrus Heights Arts.

Rayford, mother of Citrus Heights city councilmember Porsche Middleton, describes its overall mission to "enrich the cultural life by providing opportunities for individuals of all ages and backgrounds to engage with the arts."

"Citrus Heights Arts had announced plans to present ArtBeat in July, but the event was cancelled due to a

high heat weather advisory in the greater Sacramento area," she said. "I'm hoping cooler fall weather will lead to a much larger turnout."

Rayford said she sees a thriving cross-generational local arts scene unfolding in Citrus Heights which needs more positive opportunities to come together and thrive. ArtBeat, which is still welcoming and inviting artists and vendors to participate, is a step forward towards creating that scene, she said.

"Mark your calendars and don't miss out on a day of immersive art experiences and very engaging performances," Rayford said.

Citrus Heights Arts was founded in 2016 and continues to host monthly events at the Sylvan Community Center at 7521 Community Center on the third Saturday of each month.

ArtBeat will be headlined by Brady Shammar, a captivating Afrocentric singer, songwriter, producer and arranger from Kingston, Jamaica.

Shammar has graced

prestigious stages across the country alongside luminaries such as Max Romeo, the Original Wailers and Toots and the Maytals. She has also performed at the "One Love One Heart" Festival in Sacramento, Calif., "Reggae on the River" in Humboldt and the Sierra Nevada World Music Festival in Mendocino.

The area behind Jamba Juice in the Marketplace at Birdcage will also be turned into a dance floor as the electrifying beats of "master of the mix", DJ Troy, will take ArtBeat attendees on a "musical journey like no other," she said.

"So, grab your dancing shoes, turn up the volume, and also have some fun while you discover a wide range of creative and original work done by area artists."

the waiting area begins to fill up with others and the homeless who arrive until 2 p.m. by bike or on foot.

A lot has gone on long before even one bag of food and other products reach the client. The food has gone through three to four hours of processing and is handled up to seven times. From the grocery store or restaurant donating it, to the volunteers delivering it, every single perishable item at the center is being weighed, entered into a database and repackaged. If not donated, the items must be reweighed and repackaged.

Sunrise Christian Food Ministry Director April Jacek is quick to point out that the food closet program has strict guidelines on food safety that take time and energy to fill.

According to Jacek, the Sunrise Food Closet has become much more than a charitable food organization. It's become not only an organic waste re-distribution facility, but also a new social experience for many. Newly immigrated neighbors struggling with food issues are supporting each other in a way new to this country. They travel to the food closet together, arriving in different sized family groups, using wait time to socialize. Adult children are driving their parents for some time to spend together.

Jacek describes their products, "We are fresh, sustainable, and most times organic. Whatever you find in stores and feed your own family is what [we] handout. It is a bounty we hand out to our clients which we would eat ourselves."

Younger volunteers in their service capacity at the closet are being taught through social skill building skills in high school and college classes, how to interact with co-workers and clients in a more personal way, seeing the person, not just the job they are doing.

The goal at the end of the day is to bring in their donations with nothing left at the end of the day. When the perishables they received are no longer viable, the first stop is not the landfill. This is the last-ditch effort.

To minimize the amount

of perishable food in landfills, due to the new organic waste laws, the closet works with a local goat farmer, pig farmer and even a chicken farmer who picks up the waste for their farms. Following that, Jacek says there are many other places they can donate.

Hopefully the perception of today's food closet is changing. According to Jacek, it is not just for the needy. Anyone needing food assistance is welcome, no judgment.

Keep Your Pets Safe During a Disaster

SACRAMENTO COUNTY, CA (MPG) - As September unfolds, it's not only a time when the seasons begin to change, but also a poignant reminder that preparedness is a vital aspect of responsible pet ownership. September, designated as National Preparedness Month, serves as a timely prompt to underscore the importance of preparing for emergencies that can impact our furry companions. While many of us diligently stock up on emergency supplies and develop evacuation plans for our families, it's equally crucial to extend this preparedness to our beloved pets. After all, they are not just animals, but cherished members of our households, relying on us for their safety and well-being when unforeseen disasters strike. Pet parents should follow seven quick steps to ensure their pet's safety during an emergency:

- (1) Ensure your pet can be identified by both a microchip and collar ID tag, and that contact information is up-to-date. Pet owners can talk to their current veterinarians about microchipping their pets, or they can visit a clinic hosted by Bradshaw Animal Shelter;
- (2) Prepare a "Pet Emergency Go-Kit"

of pet supplies and make sure it is readily accessible in an emergency;

- (3) Display a pet rescue decal on your front door or window to let first responders know there is a pet in the house. Include your veterinarian's contact information.
- (4) Learn where your pet likes to hide in your house when frightened. Finding your pet quickly will help you evacuate faster;
- (5) Identify a location to take your pet if you need to leave your immediate area. Keep in mind that disaster shelters for people may not be open to pets. Scout hotels and motels with pet-friendly policies in advance and ask relatives or friends if they could house you and your pet;
- (6) Carry pictures of your pet in the event of separation. Pictures should be high-resolution and well-lit so that your pet is easily identifiable;
- (7) If you need to evacuate, consider taking a pet carrier or crate for transport and safe-keeping.

These seven steps can help ensure that all family members – including our beloved pets—are ready to face an emergency together. Families looking to learn more about disaster preparedness and safety for family members both two- and four-legged can visit the Ready Campaign website. ★

SACRAMENTO REGION, CA (MPG) - Written in 1787, the American Constitution was celebrated recently with a patriotic event in Folsom. Sacramento, El Dorado and Solano Constitution education groups sponsored a 236th birthday for the document that solidified a republican form of government in a new nation. Lions Park (Folsom) hosted the gathering; more than 80 visitors heard speakers and viewed exhibits. "Our country is being divided in every way possible," said organizer Kari Benton, who leads an El Dorado County

An Oasis of Hope Helps the Homeless

Homelessness is a hot topic in California, with both everyday residents and politicians taking note of its increase and the issues it triggers. According to a recent census count conducted by Sacramento Steps Forward, there are upwards of 9,000 unhoused individuals on Sacramento streets on any given night. While there is a war of many words as to what causes such a high population and what should be done to resolve it, some local groups are looking for solutions instead. Oasis Ministries is one such group.

Woods, along with her husband Pastor Thomas Woods, started Oasis several years ago as a ministry of their church, Living Water Assembly of God in Citrus Heights. Pastor Thomas became the senior pastor four years ago. The church itself is small – only 35-40 attend the Sunday morning services – but their impact is mighty.

“We are so very outreach minded. We wanted to make sure church is what you do between the Sundays,” says Julia. “If all we do is meet inside of a

building, we’re never going to be able to talk to anybody about Jesus. We are never going to grow the kingdom.”

For the Woods family, their kingdom focus comes in the form of true help for the low income and homeless. Every Friday, Pastor Thomas brings a grill into the church parking lot and makes hot dogs for local kids and their families. The church also brings out basketball hoops and cornhole for the young people to enjoy. The pastor enjoys the moniker “Pastor Hot Dog,” which has been given to him by the kids who frequent the parking lot on Friday nights.

“That’s their meal for the night, and sometimes they ask to take a few extras for the weekend,” Julia said.

On Mondays, the focus is on the homeless. The church was approached by the Citrus Heights Navigators, in partnership with Citrus Heights HART, about opening the doors of the church to serve the homeless. Now every Monday from 11am to 3pm, the church turns into a hub to help this vulnerable population with hope and dignity. From meals to showers to social time, Oasis has become a sanctuary.

Oasis stays too focused on that hope to bother with the stigmas some people zero in on when thinking about the homeless crisis. They know from their firsthand

interactions that not all unhoused individuals have the same story, and it’s important to love them where they are.

In speaking about one frequenter to the church that they’ve helped, Julia said.

“He comes to church every Sunday, he comes to Bible study every Wednesday. He’s still on the streets. He does not have an addiction problem, but life happens and he was on the streets for a few years. He has housing and a job lined up – he was so excited to have someone come alongside him.”

The pastors believe in what they do partially because of where they’ve been. Life hasn’t always been smooth sailing.

“We’ve been on the streets. We’ve been addicted. We’ve been pastors,” said Julia, “One of us comes from money, one doesn’t. There’s not a lot we can’t relate to in some form. He [God] keeps bringing us back to people who are hurting, people who are broken, people who are looked down on... we want to be that non-judgmental person and place.”

The organization benefits from donations like casual clothing and camping gear and picks up donations a few times per week. Financial donations are also gladly accepted both in the church dropbox and through their website, livingwaterag.com.

Donors and volunteers are welcome to head over to the church on Mondays between 11 and 3 to see the group in action and where donations go. The church is also holding a Harvest Celebration on October 14, where “Pastor Hot Dog” and his crew will be out distributing hot dogs, chips, and candy.

Through Oasis, the homeless are not just receiving practical resources – they are receiving hope and healing.

“They are so comfortable. They can leave the worries of outside for three hours and know they are safe. They are loved. They are respected. If they need help, we will do everything we possibly can.”

Through the generosity of the Citrus Heights Messenger, this column serves to provide an update about matters affecting the community of Citrus Heights.

During my tenure on the Board of Supervisors, I’ve observed various approaches and strategies addressing the County’s homelessness dilemma. In the past I have referred to the age-old concept of “the carrot and the stick” which frequently emerges in conversations about the governance and regulation of the homeless community. At its core, this idea reflects the universal balance we all strike between rules and rewards.

The complexity of this issue increases when considering a segment of our community that is battling mental health challenges and drug-related disorders. Such individuals can lose track of their possessions, remain unaware of their conditions due to “anosognosia,” face the harshness of outdoor living, and regrettably, some become targets for nefarious elements within and outside their community.

My recent discussion with the Sheriff’s Office brought forth a key insight: the homeless are not an isolated group, but an intrinsic part of our broader community. Their primary distinction is the lack of a fixed address, and the conscious choice to detach from societal norms. This, understandably, presents

unique challenges for our tax-paying society. For example, how does one monitor parolees without an address?

In the unincorporated areas of the County, the Board of Supervisors addresses these challenges by bridging the divide. Programs such as Navigator outreach, Park Rangers, Sheriff HOT Teams, and sweeps serve to maintain a connection with our homeless community. These operations identify encampments, determine if there are criminal records among inhabitants, combat human trafficking, and shield the most vulnerable. Sheriff Cooper’s pragmatic approach to law enforcement underscores a simple truth: the laws exist, they merely need consistent application.

Recently, DA Thien Ho took an unprecedented step, sending a message to the City of Sacramento that reiterates this sentiment. His letter emphasizes the necessity for the City of Sacramento to uphold existing laws, especially concerning the management of the downtown homeless population. The point isn’t to demonize, but to highlight the importance of consistent enforcement of laws.

The current policy direction in our state has unfortunately widened the gaps in public safety and how we enforce laws. But a lingering question remains, how much longer do taxpayers have to bear the burden of problems amplified by legislative

inaction? This isn’t just an abstract statement; it’s a call for accountability!

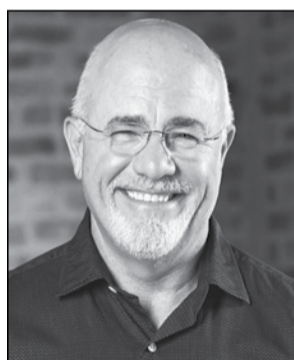
Despite the obstacles, I remain hopeful. With leaders like DA Thien Ho and Sheriff Cooper standing up for justice and law, there’s a silver lining. Even in the face of criticism, I hold a positive outlook for our Safe Stay communities. Their mission is to pave the way for treatment and brighter prospects for those who need it most. DA Thien Ho’s commitment to tackling Sacramento’s homelessness issue signals a tide of change.

His candid criticism of Sacramento City’s officials, especially regarding the inconsistent enforcement of rules, such as the encampment-clearing ordinance, resonates with many. A new approach is overdue. Residents of Sacramento, both in the County and City, should reside in a place free from illegal encampments, and most importantly everyone deserves an opportunity for a stable future.

Take the Bigger Check

Dear Dave,

My car was declared totaled because of hail damage, and my insurance company says I have two options. One is to take a higher total loss settlement check of \$19,000 and use it toward the purchase of another car. The insurance company would then take possession of the car. The other option is to accept a check for \$13,000 and have the car on a salvage title. The car is worth \$15,000, and I have 20% car replacement assistance on my policy that increases the total loss settlement to the \$19,000 amount I mentioned earlier. I’m on Baby Step 3 of your plan, and I owe nothing on the car. What should I do?

– Meagan

Dear Meagan,

Take the bigger check! That’s a quick and easy decision, but give me a minute to explain why. It’s not about being greedy – it’s a little more complicated than that.

If you had \$19,000 in your pocket, would you go buy a \$6,000 hail-damaged, salvage-title vehicle for everyday driving? Of course, you wouldn’t do that! The insurance company is probably hoping you’ll overlook the \$19,000 offer and essentially pay \$6,000 for this beat-up car. No. Thank. You. I’ll pass on that deal.

With \$19,000, you’ll have plenty of cash to rent a car for a couple of weeks and take time to find a great-quality used car at a good price. You might even be able to negotiate with the insurance company to give you a little time to look for another ride before they come pick up the old one.

But no, you don’t want that messed up, old car. Why would you? That thing probably looks like a kid with a bad case of acne right now. Go find yourself a nice car, hon. There are plenty of affordable, slightly used vehicles on the market right now. There’s no reason for you to drive around in something that’s all beat up if you don’t have to.

Social Security Matters

Nonagenarian War Veteran Asks About Extra Credit for his Service

Dear Rusty: I'm turning 95 this year and am caretaker for my wife in our 70th year of marriage. I served before 1968 (1951-53) during the Korean War. How do the "special extra credits for military service" work for me? Is it retro-active? My wife, who only worked a short time, gets half of my Social Security so would it affect hers, too? **Signed: Korean War Veteran**

Dear War Veteran: First, I want to express my gratitude for your war-time service to our country and I also applaud your 70 years of marriage. Thank you, and congratulations!

Regarding the "special extra credit" for military service, Social Security FICA taxes weren't withheld from military pay prior to 1957 so you didn't pay Social Security payroll taxes (FICA) from your military earnings during the years you served. As a result, Social Security would have no record of your military earnings during those 1951-1953 service years. But when you claimed Social Security later in life they would have asked if you

served in the military and given you "special extra credit" in the form of presumed earnings for your service years. They likely would have asked for a copy of your DD-214 and would have added \$160 to your earnings record for each active duty month during those 1951-1953 years. Note they do not give you an extra amount of Social Security; rather, for benefit computation purposes, they reflect your earnings for those years a bit higher than are shown in your earnings record (which would likely show zero for your service years). For example, if you served 12 months active duty in 1952, when your Social Security benefit was calculated they would consider your 1952 earnings as \$1,920 (\$160 x 12), instead of the zero shown in your record because you didn't actually pay FICA tax on your military pay. But whether those extra earnings credits would have any effect on your Social Security benefit is a separate item.

Assuming you had earnings from regular employment over your lifetime and paid into Social Security from those non-military earnings, you became eligible for Social Security benefits from earnings outside of your military service. If you worked and earned a decent salary for at least 35 years, then those special extra credits for your military service years would have no effect on your Social Security benefit. If you had less than 35

years of regular non-military employment, then those extra earnings added for your military service years counted and provided you with a slightly higher Social Security benefit when you claimed.

So, the bottom line is this: if, over your lifetime, you worked for at least 35 years paying into Social Security via FICA payroll or self-employment tax, then the "special extra credits" for your military service years had no effect on your Social Security benefit. But if you worked less than 35 years in which SS taxes were withheld from your earnings, then those "special extra credits for military service" contributed to and increased your Social Security benefit when you claimed. However, even if you worked for over 35 years outside of the military and the extra credits didn't matter for your Social Security benefit, your service to our country did, indeed, matter a great deal. From one veteran to another, thank you again for your service to our country.

California Legislature Whiffs On Insurance Crisis, Punting to Newsom and Lara

Before the California Legislature adjourned this month, it managed to fulfill most of wishes of majority Democrats' favorite interest groups, most notably labor unions.

However, legislators left town without doing anything concrete about something that threatens the psychic and economic wellbeing of millions of homeowners and those who aspire to ownership: the rapidly shrinking availability of residential fire insurance.

One by one, insurers have been reducing or eliminating their exposure in California, having paid out billions of dollars to cover losses from years of major wildfires and, they say, facing a fire threat that is likely to increase with climate change.

With Gov. Gavin Newsom and Insurance Commissioner Ricardo Lara involved in the background, there were weeks of private negotiations among legislators, insurance lobbyists and other stakeholders on how to bolster the state's insurance market.

However, the negotiations ended a week before the Legislature adjourned without agreement, signaled when state Sen. Bill Dodd, a Democrat whose Napa-centered district is one of the state's most fire-prone regions, sent a text

message: "Deal is dead. Very frustrating."

The discussions revolved about changing the way insurers calculate risk, from basing it on past experience to including potential future risk. Such a change would probably increase premiums and legislators wanted ironclad assurances that the companies would continue writing policies in fire-prone areas if the change was made. As the session ended, there were public assurances that the issue would not be forgotten.

"We hear loud and clear from our residents that access to insurance is a problem," Assembly Speaker Robert Rivas said in a statement.

The Legislature's departure punted the issue, at least for a few months, to Lara and Newsom, who said, "We can do a lot of things. And I'm very mindful. We can do all of that."

However, Newsom didn't list any specifics. Last Thursday, he issued an executive order urging Lara to "take action to stabilize and improve California's property insurance marketplace."

Almost immediately, Lara issued new rate-setting regulations, which he had described earlier as "a package of regulatory solutions that will streamline the department's rate review process, opening it equitably to public input – not just the entrenched interests that have benefited materially from the status quo."

Newsom, Lara and the regulations drew praise from the American Property Casualty Insurance Association, which said, "Everyone understands that California's insurance market is in a spiraling crisis that requires immediate

policy solutions to protect consumer access to the coverage they need."

Given industry support, it's likely that the new regulations will allow it to include, at least to some extent, estimates of future risk from wildfires in their rates which would probably lead to premium increases.

Newsom stopped short of declaring an emergency in Thursday's executive order, which would have given Lara the authority to issue new rate-setting rules without going through the usual procedural hoops.

Earlier in the day, Consumer Watchdog, the organization that sponsored a 1988 overhaul of insurance regulation, Proposition 103, and has been a critic of Lara from virtually his first day on the job, issued a warning to Newsom and Lara about proceeding on an emergency basis.

Later, the organization said, Lara's move "would allow insurance companies to use secret algorithms to set rates for homeowners' coverage for wildfire and to add reinsurance costs to premiums will lead to higher insurance premiums."

So, there it is, a complex mélange of economic, political and societal factors and a huge tradeoff between the availability of coverage, which is mandatory for anyone having a mortgage, and the costs.

Oriental Fruit Flies Detected in Sacramento County

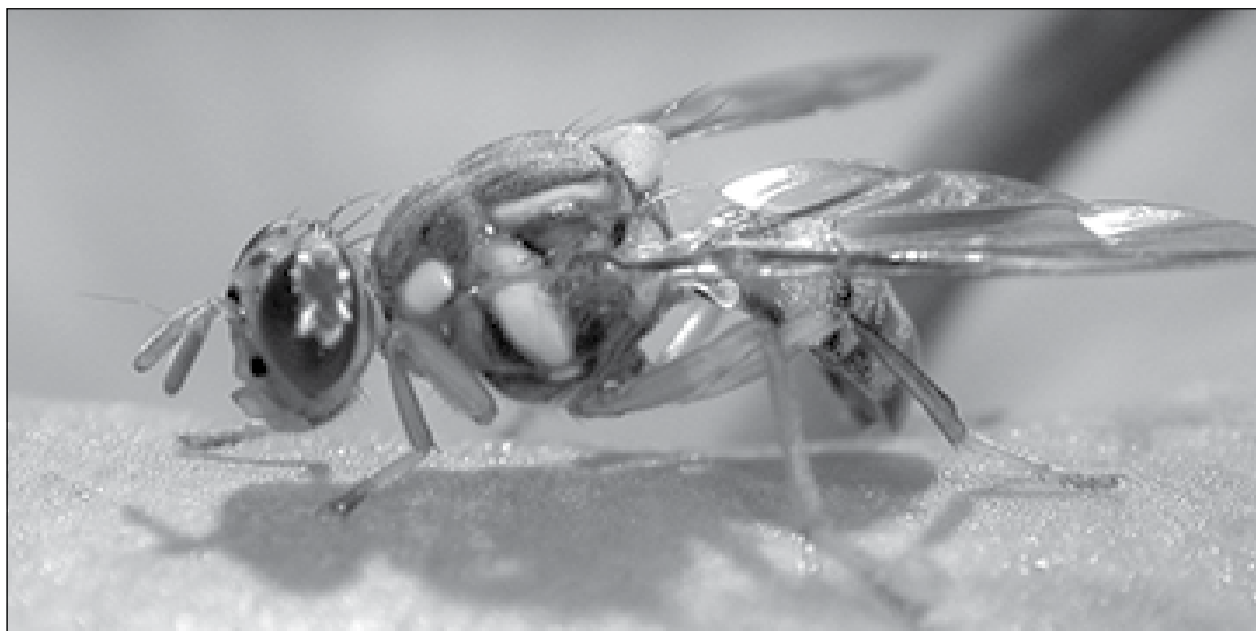

SACRAMENTO COUNTY, CA (MPG) -

The Sacramento County Agricultural Commissioner, in cooperation with the California Department of Food and Agriculture and the United States Department of Agriculture, have initiated an extensive survey and eradication plan in response to the detection of nine male oriental fruit flies (OFF), *Bactrocera dorsalis*, near the city of Rancho Cordova and the American River Parkway in Sacramento County.

The initial detection was confirmed on Sept. 12, 2023. The detections were made as part of our coordinated pest prevention system that protects our agriculture and natural resources from invasive species, with early detection as a key component to successfully eradicating an infestation before it can become established.

The extensive survey, also known as a delimitation survey, consists of multiple oriental fruit fly traps at prescribed densities going out 4.5 miles in each direction from the oriental fruit fly detection sites. These nine OFF will trigger a quarantine, which will be announced

shortly by the California Department of Food and Agriculture.

Following the principles of Integrated Pest Management (IPM), agricultural officials use "male attractant" technique as the mainstay of the eradication effort for this invasive species. This approach has successfully eliminated dozens of fruit fly infestations in California. Trained workers squirt a small patch of fruit fly attractant mixed with a very small dose of Spinosad, a natural pesticide made by a soil bacterium and approved for use on organic crops,

approximately 8-10 feet off the ground on street trees and similar surfaces; male fruit flies are attracted to the mixture and perish after consuming it. The male attractant treatment program is being carried out over an area that extends 1.5 miles from each site where the oriental fruit flies were trapped.

While fruit flies and other invasive species that threaten California's crops and natural environment are sometimes detected in agricultural areas, the vast majority are found in urban and suburban communities. The most

common pathway for these pests to enter the state is by "hitchhiking" in fruits and vegetables brought back illegally by travelers as they return from infested regions of the world or from packages of homegrown produce sent to California. Help protect California's agricultural and natural resources; please don't pack a pest when traveling or mailing packages.

"Invasive non-native fruit flies are serious pests for California's agricultural industry and backyard gardens," said Sacramento County Agricultural

Commissioner Chris Flores. "These recent detections remind us that we need to remain vigilant in protecting our agricultural and natural resources. When traveling abroad or mailing packages to California, we urge the public not to bring back or ship fruits and vegetables as they are pathways for oriental fruit flies and other invasive species entering our state."

The oriental fruit fly is known to target over 230 different fruit, vegetable and plant commodities. Important California crops at risk include grapes, pome and stone fruits, citrus, dates, avocados, tomatoes and peppers. Damage occurs when the female fruit fly lays her eggs inside the fruit. The eggs hatch into maggots, which tunnel through the flesh of the fruit, making it unfit for consumption.

The oriental fruit fly is widespread throughout much of the mainland of southern Asia and neighboring islands, including Sri Lanka and Taiwan, and it has invaded other areas, most notably Africa and Hawaii.

Federal, State and County agricultural officials work year-round, 365 days a year, to prevent, deter, detect, and eliminate the threat of invasive species and diseases that can damage or destroy our agricultural products and natural environment. The efforts are aimed at keeping California's natural environment and food supply plentiful, safe and pest-free.

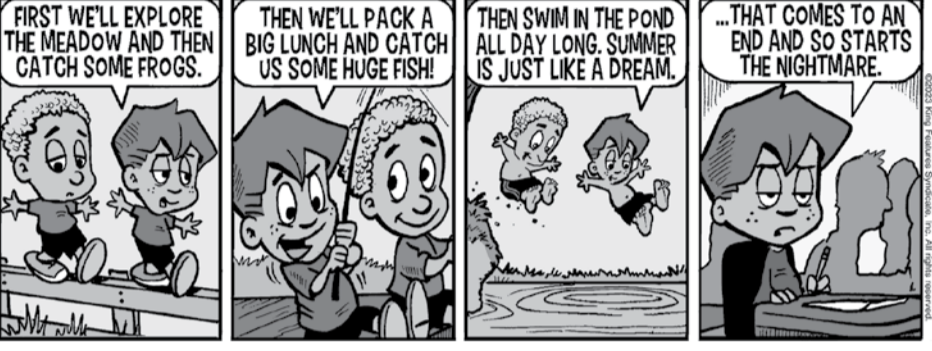

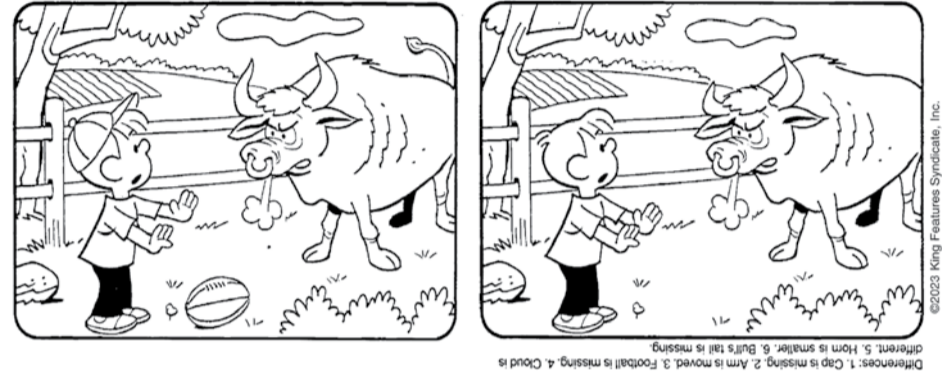

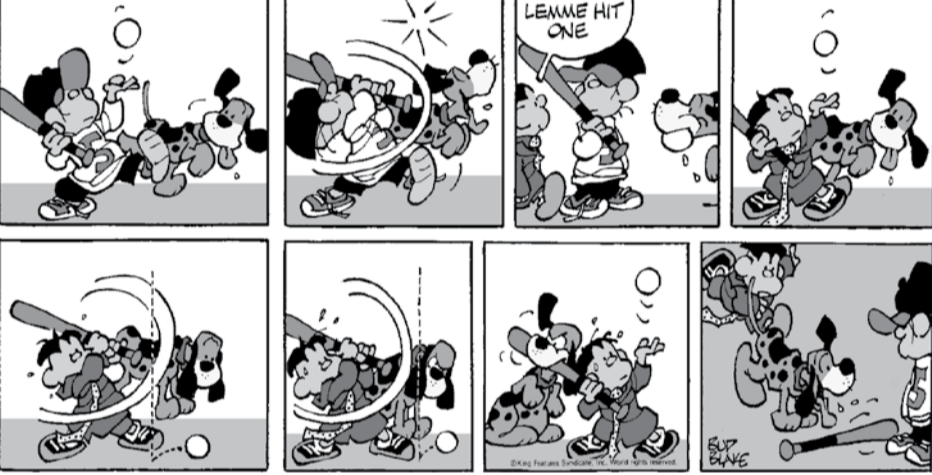

Tickets are \$30 per person and must be purchased by Friday, October 13, 2023. Individual Tables of 8, 9 or 10 people may be reserved in advance of the event. Citrus Heights HART is using Eventbrite for all ticket sales.

“Each year we raise approximately \$15,000 to \$20,000 through this very important event,” she said.

Carpenter said if individuals or groups are interested in purchasing a table, they should click the table option at citrusheightshart.org/spaghetti-fest and send Citrus Heights HART an email at citrusheightshart@gmail.com listing who will be seated at their table.

Citrus Heights HART was established in 2016 to help with the many challenges which face its local at-risk population. This includes low-income students and their families, those at risk of becoming homeless, and those who are living on the streets.

“These are local issues, and best dealt with at a local level,” Carpenter said. Examples of ongoing HART problems include the annual Winter Shelter program, housing and rent assistance and at-risk student support.

“We depend on the generous donations of individuals, churches, businesses, as well as government and private grants,” Carpenter said.

The Citrus Heights HART Spaghetti fundraiser started in 2016 at Holy Family Catholic Church in Citrus Heights but quickly outgrew the space. The event moved to the Citrus Heights Community Center in 2018. Due to the pandemic, the event was not held in 2020 or 2021.

“Citrus Heights HART aims to serve the homeless of Citrus Heights with the goal of getting folks off the street and into self-sufficiency,” Carpenter said. “The people we work with may be sleeping on the streets, in a car, or couch surfing; they may have been homeless for a week or for the last ten years,” she said.

“Our goal is to help Citrus Heights locals develop a stable living situation through connecting them with the resources they need – whether that be a homeless navigator or a winter shelter,” she said.

The mission of Citrus Heights HART is to provide critical resources which will enable at-risk people and people experiencing homelessness in Citrus Heights and adjacent areas to become independent, self-sustaining and participating members of the community.

“As a volunteer-run organization, we rely on the generosity of our volunteers to donate their time and resources towards the fight to end homelessness in Citrus Heights,” she said.

“Our members come from the business sector, schools, faith communities, and city government – to name just a few – to partner with local churches, government agencies, and nonprofits to provide services and support for those attempting to break the cycle of poverty in Citrus Heights.”

Event sponsors include California American Water, Ascension Lutheran Church, the City of Citrus Heights, John Youril and Margaret Cleek, Fair Oaks Church and Sacramento County Supervisor Sue Frost.

Tickets must be purchased by October 13, 2023. Tickets are \$30 per person. Tables of 8, 9 or 10 people can be reserved in advance of the event.
