#### Ohio's Center for Oral, Facial & Implant Surgery

Having any type of surgery is always a bit intimidating, even scary. That's why a trusted surgeon—and a calm, friendly atmosphere to ease your fears—is as important as the surgery itself.

When it comes to procedures of the face and mouth, Dr. Keith M. Schneider, DMD, not only has the experience as an oral and maxillofacial surgery specialist and periodontal surgeon, but grew up with the business.

"My father, Dr. E. Karl Schneider, began his oral and maxillofacial surgery practice in 1975 in Willoughby before moving into the Mentor area in 1981," he says. "I've been running the practices now since 2012 and am happy to be working alongside Dr. Donald P. Lewis, Dr. Jill M. Weber, and Dr. Nishant Joshi."

With three offices in Mentor, Highland Heights, and Bainbridge, Ohio's Center for Oral, Facial & Implant Surgery offers myriad services that include dentofacial anomalies, facial reconstruction, abscess or cyst drainage or aspiration. They also address cracked teeth, dental bridges and veneers, along with more common procedures such as the removal of wisdom teeth, and the placement of dental implants. "Wisdom teeth are most commonly removed between the ages of 16-30," says Dr. Schneider. "There is a high risk of issues that arise later in life if they're left in place."

He adds that dental implants are most often placed in those between the ages of 30 and 80 and the practice provides a range of options that include replacement of individual teeth to full mouth replacements. Patients may get their teeth replaced in one day. "We can care for patients of all ages, from age 1 to over 100," he says.

Aside from these services, Ohio's Center for Oral, Facial & Implant Surgery provide adjunctive procedures for pediatric and orthodontic colleagues. This includes removal of baby teeth, impacted canine teeth, and removal of teeth for crowding, as well as working with root canal specialists when teeth cannot be saved. The practice is on staff at eight medical centers: Hillcrest Hospital, Rainbow Babies and Children's Hospital and University Hospitals Cleveland Medical Center, Beachwood Medical Center, Ahuja Medical Center, Geauga Medical Center, West Medical Center, and TriPoint Medical Center. This includes adult and pediatric treatment centers.

For those interested in esthetic procedures, they will perform facial surgeries to correct small or misaligned jaws, the placement of facial implants, as well as facial fillers and Botox.

"We want patients to feel comfortable in our care, from the first staff member they encounter, all the way to recovery," says Dr. Schneider. "We take time to ensure a proper diagnosis and that the treatment being performed is necessary. We provide a full range of anesthesia options to ensure that the procedures are comfortable and painless."

Patients are provided comfortable blankets and even get to choose what music they'd like to hear through the procedure.



When it comes to medical and dental benefits, there are treatment coordinators to help patients with a clear financial plan. "People deserve to know what to expect and be able to make plans for a smooth procedure throughout. That includes recovery because postoperative expectations are just as important."

There is a 24-hour call service for those wishing to discuss and evaluate any concerns. A telehealth service is also available for those who are unable to make an office visit. In addition, they arrange same-day surgical appointments, when possible,

allowing for other family and work schedules.

"From the moment a patient walks through our doors, we want to provide them with the best care, and comfort for patients who are anxious of whatever procedure they're having," Dr. Schneider says. "And we're always accepting new patients to treat the needs of both adults and children."



## White Rabbit Kids Toy Store opens in Downtown Willoughby

A place where kids can play, shop, learn, and enjoy a sense of community

Like many of us during the pandemic, Lauren Dannemiller had some time to rethink her future. A longtime manager at a Cleveland design studio, she wanted to use her organizational skills and work experience to start a business she could call her own.

"Being a mom of two small children, I noticed that I had difficulty finding good, educational toys for them so that they could learn as well as have fun doing it," says Dannemiller, 39. "Parents are always seeking new and different places to take their kids so I thought if I had a place where I could sell these fun, educational toys, and offer space where they can enjoy learning through play, that would be ideal."

That idea became reality in 2022 when Dannemiller found the perfect spot for her new business. In the heart of Lake County's cultural hub—Downtown Willoughby. "I definitely wanted a place where kids can play, shop, learn, and enjoy a sense of community. I knew I'd found the right place when I found this space."

The store, located off Erie Street near the post office, sells products that encourage education and imagination. What Dannemiller calls "mindful learning." Next, she had to think about just the right name that would fit her vision. She recalled her time with the 4-H programs and her joy of raising rabbits there. She also recalled her love for the story of Alice in Wonderland that fueled her imagination. She decided her new store would be called White Rabbit Kids.

From the start, her focus is centered around that mindfulness of what she's presenting to the children. She hand chooses all the toys, along with having a variety of play activities that keep the children entertained and yet have educational value.

A toy store with scholastic programs and activities?

That's the difference between this Willoughby toy store and the big box retailers. White Rabbit Kids has an array of toys that encourage learning and creativity, such as drawing books, word cards, craft and design kits for kids, along with a selection of fun costumes for kids to play dressup. Dannemiller stresses that if customers are not in the market for toys, children are still welcome to stop in and participate in the activities.

Dannemiller also found the perfect person to help her out. "Our store manager, Jenni Foote-Harper, helps run the activities and is just wonderful with the kids. She makes sure everyone is having fun and is a great storyteller for our storytime." She adds that Jenni had worked in a Montessori school and uses that same educational philosophy and self-motivating approach in their everyday activities.

Aside from weekly story times, programs range from various workshops celebrating upcoming holidays and events. "For example, the weekend of November 24–26, we'll be making ornaments out of bird seed and while they're doing it, we'll talk about the different kinds of birds you see in winter," says Dannemiller.

The store also offers Yoga for Kids classes. The sessions (that can include the caregivers) run various days and times for children ages 4 and up. All programs and workshops have a small fee and require registration which you can do instore or on the website. Add items and events to the "wish list" and receive a \$10 discount on anything in the store.

And what would a store for children be without play dates and parties? "We welcome birthday parties, and craft and STEAM parties," she says. "There are different packages for any budget and age groups. We do like to keep the parties limited to 12 so that all the children can inter-





act and get equal attention."

Dannemiller also understands, and appreciates, the importance of supporting local businesses. "I love my store and the great sense of community here. We're going to keep our finger on the pulse of what's going on so we always stay interesting, fun and of course, educational."

#### **Words Have Power, So Listen Well**

Talking about ideas, thoughts and feelings can be difficult, whether you're a child, a teen, or even a full-grown human. People require time and space to process what's going on inside, and then to choose the right words that best convey their thoughts or ideas. In the rush of busy schedules, and the hectic pace of the coming holiday season, it can be hard to grant time or space to really hear what's being said.

For young people, the words they choose to share have power, giving meaning to sometimes messy feelings, even when limited vocabulary or life experiences give them few examples to draw from. Often, their unconventional descriptions have a way of cutting straight to the heart of the matter at hand, leaving little room for misunderstanding.

My older daughter, when asked to describe her first day as the new kid at school put it to me this way. "It felt like I was trapped all day in a room full of farts." Yikes! Sure, that mental image made us giggle, but it also highlighted her feelings of being alone and out of place, stuck in an unpleasant situation. ing the natural light, non-musty atmosphere, and the availability of caffeine to get her homework done that day.

Even as an adult with a college degree and a supposed better grasp on vocabulary, I often find myself resorting to the same technique of using visuals to relay my thoughts or feelings. Like when I'm feeling unwell, but not sick enough to stay in bed. Sometimes a long hot shower is enough to rid myself of that thick-headed feeling. And a serious dose of Crest gets rid of the tiny sweaters all my teeth seem to be sporting. Sure, it may be a silly example, but I bet it got the point across and helped you understand what I'm trying to say.

Who knows, maybe making unorthodox descriptions is hereditary, but I think this skill is something we each use from time to time when trying to share a thought or idea out loud with someone else, to try and help them understand. Isn't that what we all hope for – to be heard and understood?

#### Pumpkin pie was not served at the first Thanksgiving meal.

The Pilgrims didn't have ovens for baking and they lacked the butter and flour necessary for pie crust. animal shaped balloons made their first appearance in the parade in 1927.



#### **Adoption: An Alternate Path to Parenthood**

The perception of adoptive parents may be of a loving wife and husband who are unable to have children of their own. The couple go to a private adoption agency, shell out tens of thousands of dollars and, after what could be a years-long waiting period, bring home the newborn son or daughter they've always dreamed about raising.

Working with a private adoption agency with the goal of adopting an infant is an admirable approach to offering a home to a child in need. But some folks—married or not—find the process to be too costly and drawn out. Fortunately, there are other avenues for adoption, especially if prospective parents are open to providing forever homes for youngsters with special needs, older children, sibling groups or children of different races or ethnicities.

November is National Adoption Month, a 30-day platform for raising awareness and bringing attention to the need for permanent families for minors in foster care. It is an initiative of the Children's Bureau, which is part of the United States Department of Health and Human Services.

"National Adoption Month is a celebration of those members in our community who have taken a chance on children and made them a member of their family," says Eugene Tetrick, supervisor of the Substitute Care Unit (foster care/adoption) for the Lake County Department of Jobs and Family Services. "These people had the courage and determination to 'change their normal' by bringing a child in need into their home."

Beverly Torres, senior manager for permanency support (adoption) at the Cuyahoga County Division of Children and Family Services, says many children are in county custody because of abuse, neglect, a parent's mental health issues and other reasons. "When they can't be safely reunified with their caregivers and when parental rights are terminated, we owe these kids a family. November highlights foster care, and especially adoptive care, for our families and children."

In honor of National Adoption Month, Today's Family answers questions about adopting young-sters currently in the foster care system.

#### What is the difference between fostering and adopting?

Foster parents are state-certified caregivers, who provide a temporary home for children while social service agencies attempt to reunify youngsters with their families. If reunification with birth parents does not happen, the public agency holding temporary custody of the child receives permanent custody of them, matches them with an adoptive family (most often in the dually licensed foster/adoptive home they are currently in) and works with the adoptive family to finalize an adoption through probate court.

#### Who is eligible to adopt children in foster care in Ohio?

Prospective adoptive parents must be at least 18 years old, have sufficient income to meet the child's

basic needs and be in good physical, emotional and mental health. They may be single, married, part of a same-sex couple or the child's older sibling. If part of a couple, they must be in a stable relationship for at least one year. Education level, religion and home ownership are not factors.

#### How great is the need?

Every day, children throughout Ohio enter the custody of children services. This results in 2,000 to 3,000 children at any given moment waiting to be adopted in Ohio. The need for adoptive families is great and every child deserves a forever family.

According to Torres, Cuyahoga County has permanent custody of 900 children. The county has potential adoptive parents for about two-thirds (slightly more than 600) of them; the remainder are still in need of forever families.

Tetrick adds, "From 2020–2023 we finalized adoptions for 29 children. With those adoptions, our foster homes close as their families are now "complete" when the adoption is finalized. Therefore we are continuously trying to recruit new families to replace the ones that left after they completed their families."

And the need is definitely very real as Lake County has 105 children in their custody in 2023.

#### So many people wish to adopt. Why haven't these children found forever families?

It's important to match youngsters with families who are committed to meeting the children's specific needs for the long term. Many children in foster care deal with physical, psychological or behavioral concerns as they all have been exposed to abuse and/or neglect.

"Any time a child moves from one home to another, it's a traumatic experience," Torres explains.

"Some adoptive families are looking for a specific type of child. When kids come into our custody, they are experiencing a trauma in their life, a separation, a loss. That comes out in different ways for different children. Sometimes they've been removed from their home because of mental-health issues within the family that are not being managed in a healthy way, and that child is experiencing the same mental health issue. The specific needs of our children dictate the kind of families we're looking for."

Placing older children, such as teenagers, can be challenging because some people prefer to adopt infants or toddlers. Keeping siblings together can also be difficult if families wish to adopt one child at a time.

#### What is the cost?

"Oftentimes, those who become licensed as foster and adoptive parents through the county are looking to grow their family through adoption as the costs of private adoptions are too expensive," Tetrick says. "Some costs involved in the adoption process are court costs for the adoption and paying for updated birth certificates, which are minimal comparatively to private adoptions. Adoption of a child in the custody of Lake County costs less than \$200."

Cuyahoga County's Torres says a required fire inspection may run \$30-\$100. If the compulsory home study visit reveals the need for making home improvements to meet Ohio mandates, there may be costs associated with those upgrades.

By comparison, voluntary adoption of a newborn at a nonprofit organization in Ohio typically costs \$10,000-\$25,000, according to the Franklin County Law Library website.

#### I want to adopt a child currently in foster care. Now what?

Those in Lake County may dial 440-350-4218 and those in Geauga County may call 440-285-

Start with contacting the county agency. Cuyahoga residents may call 216-881-5775 or visit https://hhs.cuyahogacounty.us/adoptable-kids.

According to Torres, prospective adoptive parents are required to attend preservice training to become licensed as a foster or adoptive parent. Once licensed, they will complete an application and undergo a home study, which includes a fire inspection. Following approval, the county agency will work to match the adult and child. After a match is made, an adoption assessor and the child's social worker will present the prospective adoptive parent with the child's social, medical and educational records, photographs and other pertinent information. The adult and child will then have preplacement visits in the adoptive home and the child's current home. After the child moves in with the adult, a judge or magistrate can finalize the adoption. Classes, support groups and referrals to community agencies will then be available to the new family.

## Financial assistance available for home sewage treatment system repairs and replacements

A program for Lake County residents by the Lake County General Health District

The Ohio Department of Health (ODH) and the Ohio Environmental Protection Agency (EPA) have continued a financial assistance program for the repair or replacement of failing household sewage treatment systems. This program will provide \$13.3 million in funding to qualifying Ohio homeowners of which the Lake County General Health District (LCGHD) applied and was awarded \$150,000 by the Ohio EPA through the Water Pollution Control Loan Fund (WPCLF). The Environmental Health Division at the LCGHD will head this program and coordinate the repairs.

The grants will provide 100% of the total system improvement costs for eligible systems where the homeowner is at the federal poverty level. The grant will provide 85% of the cost when the homeowner is at 200% of the poverty level with a 15% homeowner match and 50% of the cost when the homeowner is at 300% of the poverty level with a 50% homeowner match. See the poverty guidelines for a breakdown of each income level and how much coverage you may get based on your income.

U.S. Dept. of Health & Human Services poverty guidelines for households:

• For 1-4 persons in a family/household: 100%

- poverty guideline (100% PF) \$26,500; 100%-200% poverty guideline (85% PF) \$53,000; 200%-300% poverty guideline (50% PF) \$79.500
- For 5 persons in a family/household: 100% poverty guideline (100% PF) \$31,040; 100%-200% poverty guideline (85% PF) \$62,080; 200%-300% poverty guideline (50% PF) \$93,120
- For 6 persons in a family/household: 100% poverty guideline (100% PF) \$35,580; 100%-200% poverty guideline (85% PF) \$71,160; 200%-300% poverty guideline (50% PF) \$106,740
- For 7 persons in a family/household: 100% poverty guideline (100% PF) \$40,120; 100%-200% poverty guideline (85% PF) \$80,240; 200%-300% poverty guideline (50% PF) \$120,360
- For 8 persons in a family/household: 100% poverty guideline (100% PF) \$44,660; 100%-200% poverty guideline (85% PF) \$89,320; 200%-300% poverty guideline (50% PF) \$133,980
- \* For families with more than 8 persons, add \$4,540 for each person.

- \* Based on total family income of all occupants who are 18 or older.
- \* Homeowners with aggregate income exceeding \$133,980 are not eligible for WPCLF assistance LCGHD expects that between 10–15 systems can be repaired or replaced depending on the number of qualified households and the cost of each project. Funding will be awarded on a first come/first served basis, so homeowners who believe they meet the income limits and other qualifications are encouraged to contact Chris Loxterman at the Lake County General Health District at 440-350-2543 to begin the prequalification process.

#### What else does the Environmental Health Division at LCGHD do?

The Environmental Health Division manages and implements many programs and services for the residents and businesses in Lake County: mosquito control, food safety and inspections, storm water sampling, solid waste disposal management, tattoo and body art safety, private water system testing, and other services that all can be viewed at www.lcghd.org.

Do I have to be a Lake County resident to use other services at the Health District?


