CARMICHAEL, CA (MPG) - Carmichael's Vietnam Memorial was last weekend central to Veterans Day commemorations. Flags, music and memories were shared by more than 120 visitors. The ceremony was also livestreamed.

The first-known California monument to the Vietnam War, the memorial is considered a hallowed part of the Koobs Nature Area. First dedicated in 1973, its steel edifice honors La Sierra High School graduates who died in the Vietnam War. Speaker Edric Cane, an educator and veteran of the French Army, said he was grateful to be at Carmichael's monument every year. He had visited



Louis Armstrong's "What a Wonderful World," an anthem to peace that came out of Vietnam War years.

La Sierra High School administrator Tony Asaro read the names of deceased La Sierra teachers who served in WW II. Korea, and Vietnam conflicts.

The Vietnam Monument is located in Koobs Nature Area, 5325 Engle Rd, Carmichael. Access is available first Saturdays of every month, March through October. For information, go to the Koobs Nature Area Facebook page. CHP Focused on Tackling Distracted Driving **Epidemic**

SACRAMENTO, CA (MPG) - Every year, thousands of people are seriously injured or killed statewide in vehicle crashes caused by distracted drivers - crashes that are 100% preventable. To address the problem, the California Highway Patrol (CHP) is launching a statewide "Distracted Driving Education and Enforcement for Adult Drivers" traffic safety campaign, boosted by a \$350,000 federal grant.

The yearlong education and enforcement initiative continues through Sept. 30, 2024. Throughout the year, the CHP will conduct at least 90 enforcement operations targeting adult distracted drivers. In parallel with a CHP program targeted at teen drivers, the adult distracted driving campaign also includes 300 adult traffic safety presentations statewide.

"The CHP encourages drivers to make the conscious decision to drive distraction free every time they get behind the wheel of a vehicle," said CHP Commissioner Sean Duryee. "Every distraction, even for just a few seconds, increases your chances of being involved in a crash. Ultimately, it is never worth the potentially devastating consequences." With multiple modes of communication and instant entertainment, cell phone use is the biggest driver distraction. Between 2019 and 2021, there were a total of 6,343 fatal and injury crashes within CHP jurisdiction stemming from distracted driving. During those same years, CHP officers issued more than 200,000 citations to drivers violating California's handsfree law. Some of the most common types of adult distracted driving includes texting, talking on a cell phone, eating, grooming, operating a navigation system, and adjusting the radio. Public education and increased enforcement are designed to encourage drivers to recognize the dangers of distracted driving and reduce the number of people impacted by this reckless, preventable behavior. Funding for this program is provided by a grant from the California Office of Traffic Safety through the National Highway Traffic Safety Administration. The mission of the CHP is to provide the highest level of Safety, Service, and Security.

SacRT Celebrates Its Light Rail Modernization Project

SACRAMENTO REGION, CA (MPG) -

The Sacramento Regional Transit District (SacRT) recognized a significant milestone on November 8, 2023, with the celebration of the Light Rail Modernization Project and groundbreaking ceremony for Folsom 15-minute light rail service. This groundbreaking marks the beginning of construction for the passing track near Glenn/Robert G. Holderness Station, a pivotal step in enhancing the transit experience for Folsom area riders.

Starting January 2024, construction will require a temporary light rail service disruption between Historic Folsom and Iron Point stations. To minimize inconvenience, SacRT will offer shuttle bus service during this period, ensuring riders can still access the impacted stations. For park-and-ride users, Iron Point Station will serve as the primary boarding point for downtown-bound trains. Construction is expected to last approximately six months.

Upon completion, the new passing track will allow for 15-minute light rail service frequency, compared to 30-minutes today, for Hazel, Iron Point, Glenn/Robert G. Holderness and Historic Folsom stations. Also, the new low-floor light rail trains will begin service along the Gold Line.

"As we embark on this transformative journey, we recognize the temporary disruptions and inconvenience this may cause our riders," said SacRT General Manager/CEO Henry Li. "We are working diligently to streamline the construction process and provide alternative transit options to mitigate any inconvenience for our valued passengers."

"This construction project represents a significant leap forward in our efforts to modernize Sacramento's transit system," said SacRT Board Chair and Sacramento County Supervisor

Patrick Kennedy. "The 15-minute Folsom light rail service will not only reduce travel time but also enhance the overall commuter experience, aligning with our commitment to providing efficient and accessible public transportation."

"Efficient public transportation is a keystone for economic development, educational opportunities and a healthier future," said Congresswoman Doris Matsui. "Earlier this year, SacRT was awarded a \$45 million federal grant to advance the purchase of new low-floor light rail cars that will greatly improve accessibility and support more frequent service to the last seven miles of the Gold Line. We are excited to see the Light Rail Modernization Program come to fruition."

"The Sacramento Regional Transit Light Rail Modernization Project extension to Folsom will provide residents with more options to travel through the Capital region, create jobs and boost the local economy, and increase safety by reducing traffic on local highways," said Congressman Kevin Kiley. "I am glad to support this project that will help residents of the Sacramento area, and I look forward to seeing the completed project in the coming years."

"We are now on the path to alleviating congestion and creating a more efficient, accessible and sustainable transportation network for our community, thanks in part to the Solutions for Congested Corridors grant from the state in 2018, which secured \$20 million for this transformative project," said Assemblymember Kevin McCarty. "I'm thrilled to see the positive impact it will have on the lives of our residents. Together we are shaping a brighter, more connected future for Sacramento."

The Light Rail Modernization Project, including the addition of new low-floor trains and station platform modifications, underscores SacRT's commitment to sustainable, state-of-the-art public transportation solutions.

SacRT is currently in the testing process for 17 new lowfloor trains, which were built at Siemens Mobility in south Sacramento. SacRT has an order of 36 trains with the option to purchase up to 76. SacRT has also been actively modifying station platforms along the Gold Line to meet the height requirements of the new low-floor trains. The trains are expected to be in service on the Gold Line by summer 2024.

Sunrise Marketplace Promises Magical Moments in December

CITRUS HEIGHTS, CA (MPG) - Christmastime draws near and the Sunrise Marketplace (SMP) is ready to jump into the community with events designed to inspire togetherness, holiday spirit, and great opportunities to stay engaged and entertained locally.

The first event on the roster – a portion of what is known as Magical Moments at Sunrise Marketplace – is the Laser Light Show Spectacular and Night Market in partnership with Kauai's Night Market, guests of all ages can enjoy crafts, activities, vendors, and then a 45-minute laser light show as the grand finale of the evening.

The laser light show was formerly put on in the Lowe's parking lot across the way from the Sunrise Mall, but due to space limitations it was moved to the Sunrise Mall parking lot in recent years. This year, it is in the Macy's Men's parking lot on the Greenback side of the mall.

Last year, the laser show was projected onto the wall of the mall, but this year it will be displayed on a jumbo screen in order to allow it to be in the Macy's location with higher visibility. Besides the night market and show, there will also be carnival games, face painting, and even a magic show. It is a family-friendly activity that SMP hopes to continue on as a tradition as in years past.

According to Lisa Cordell, SMP's Marketing & Special Projects Manager, the main goal of the Magic Moments series is "to bring the community out together – to just have a fun, safe event and maybe attract consumers from our secondary trade area."

"Hopefully they will come back to shop and dine in the district," she said.

The laser show and night market is expected to draw between 500 and 1000 people to its two showings. Performances are at 6pm and 7pm, and the market and activities open at 4pm. All activities are free, and food will be available for purchase.

While the evening is sure to be a hit, visitors are encouraged to keep in mind that they will be sitting outside in December.

'It's going to be cold," said Cordell. "Bundle up. If you would like to bring chairs to watch, you are more than welcome to."

If you attend the Laser Light Show Spectacular and Night Market and love it, you can continue the Magical Moments fun throughout the month. Next up is a Nutcracker performance happening inside of the Sunrise Mall and performed by Sac Civic Ballet. This special condensed version is being performed at 5:15 PM and 6:10 PM on December 14. Outside of the performances, there are plenty of interactive opportunities including an Elf on the Shelf story hour, character visits with Nutcracker characters, and special giveaways.

Lastly, on December 21 from 6:00 pm to 9:00 pm, join other members of the community for a Winter Wonderland skate party at Sunrise Rollerland. Tickets are \$10 and the three-hour session starts at 6pm.

SMP hopes to offer more events in 2024, including the return of Burgers and Brew in May of 2024. Cordell encourages those interested in community events to visit shopsmp. com and get on the newsletter list.

"Always check back for all the activities that go on in the district. That [website] is a really good place to find out what's going on," said Cordell. "There are contests going on continually too, including money and gift card prizes."

CARMICHAEL, CA (MPG) - The heart of rock 'n roll is a big one. One of Carmichael's most popular bands, Wasted Space, recently staged a fundraiser to help Hawaiians devastated by Maui wildfires.

"Our lead guitarist Frank McClory has a cousin from the island who lost everything," explained singer Michelle Barnes. "I've been there several times and I love the spirit of the island. My friend Lisa McGovern - who worked for The Eagle Radio station - used to live there and her son Ryan Clark (now a drummer living in Carmichael) was born in Maui.

"Between Lisa, Frank and me, we decided it would be awesome to do something to help. We wanted to share Maui's Aloha spirit among our fans, and to do it in our neighborhood. My daughter Jennifer Holman runs the Time Out Tavern (Fair Oaks Boulevard) and offered the place. We booked a Hawaiian food truck and

called our event 'Mai tais and Tie Dyes for Maui."

The benefit brought more than 200 rockers, decked in tie-dves to echo the band's beachy brand. Drummer Ryan Clark sat in during the final set. Raffles buoyed admission charges; musicians donated their performance, and the tavern threw in a chunk of bar proceeds.

"Our goal was \$5000 but we hit \$6,500," reports Barnes. "We're so grateful to everybody who participated. We are all a piece of what it will take to rebuild beautiful Maui."

Event funds have been directed to the Maui Strong Fund, a nonprofit that provides support for those affected by the wildfires.

SACRAMENTO REGION, CA (MPG) - St John the Evangelist School's blowout - "A Holiday Show of Hands" - will ensure a crafty Christmas for thousands of shoppers on December 1, 2 and 3.

Now in its 45th year and boasting more than 150 vendors, the market annually fills the entire Locust Avenue campus with up to 10,000 guests. Proceeds benefit the Catholic school.

Entrepreneurism annually soars during the fundraiser. Wares range from funky sweaters to metal sculptures and glittering ornaments. A preview (4-9 pm on December 1) requires an admission fee, but Saturday and Sunday browsing is free. Doors open at 9 am on both weekend days.

Organizers have this year added a prize opportunity for admission; guests will be included in a draw for a \$100 Visa gift card. A silent auction will offer hundreds of items; bids close on Sunday afternoon. Santa and Mother Claus will visit from 11 am to 2 pm, Saturday and Sunday.

The fair's gourmet pavilion has been enlarged to include more food vendors. "December is a cold month, so hot toddies and Sister Margaret's famous Irish coffee will take the chill off," promises organizer Pat Holbus. Home-cooked lasagna and other hot dishes will be available as sit-down or take-out meals throughout the event. The fair offers a gift wrap service and Carmichael's Boulevard Coffee will host an Espresso bar, with specialty coffees.

St John the Evangelist School is located at 5701 Locust Avenue, in Carmichael. Because fair traffic clogs surrounding streets, free shuttles will run from Carmichael Elks Lodge parking lot to St John's Church.

"People come here from all over Sacramento - even from out of state," says Pat Holbus. "Our market is a Sacramento tradition. It's a weekend that says Christmas is here at last."

These brave men and women have selflessly dedicated their lives to preserving our freedoms and protecting the values we hold dear.

Sacramento County is proud to be home to more than 84,000 veterans. As this vital segment of our population continues to increase, Sacramento County Veterans Services, part of the Department of Human Assistance, encourages veterans to take advantage of the available benefits and resources that are in place to not only assist veterans but family members and dependents.

Benefits range from disability compensation (due to injuries/illness resulting from service-related activities) to VA Pension, which is monthly financial assistance to low-income, wartime Veterans over the age of 65 and/or those who are "totally disabled." Surviving spouses may also receive benefits.

We assist local veterans in applying for benefits offered through the U.S. Department of Veterans Affairs, the State of California and local government entities.

Veterans Services is also responsible for administering the College Fee Waiver Program for Veterans' Dependents. This program is afforded to spouses, unmarried surviving spouses, and children of service-connected disabled or service related deceased veterans. Eligible dependents are not required to pay "mandatory system wide" tuition and fees while attending either a California community college, a campus of the California State University (Cal State) system, or a campus of the University of California (UC) system. This program not only provides eligible dependents with the incentive but also the opportunity to pursue their goals.

Bureau Praises Bill to Aid Drone Use

SACRAMENTO REGION, CA (MPG) - On October 9, 2023, California Farm Bureau President Jamie Johansson applauded the signing of Assembly 1016, which will expedite training and licensing programs so that more farmers may use drones for pesticide applications.

"I am proud that the California Farm Bureau is leading the effort to ensure that farmers have access to precision technology," Johansson said. "We thank Gov. Gavin Newsom for supporting us by signing Assembly Bill 1016. With aerial spray technology within reach of all farmers for the first time, this will help them save on to target affected areas instead of entire fields. Drone use can also replace backpack spray and ground-based delivery systems with remote technologies, which protects our agricultural employees from close contact with pesticide applications.

"California's farmers and ranchers lead the world in innovation – producing amazing yields of fresh produce, dairy, and meats while decreasing water, fertilizer and pesticides use. AB 1016 is a bill in that spirit. It allows farmers better access to innovative technology to gain even more efficiency and safety.

Niello Responds to the Acceleration of the Sites Reservoir Project

SACRAMENTO, CA (MPG) - Senator Roger Niello (R-Fair Oaks) released the following statement regarding Governor Newsom's announcement to accelerate the Sites Reservoir Project: "As we prepare for another wet winter, it is imperative to continue pushing water storage projects forward for California's future," said Niello. "Even though the benefits of the Sties Reservoir have been clear from the beginning, the project has unnecessarily been on hold. While we are still multiple approvals and years away from the construction process, I am pleased

to hear that the Sites Reservoir project is finally getting the chance to move forward in an expeditious manner."

Currently, much of the rainfall California receives is not captured. As proposed, Sites Reservoir will be a 1.5 million acre-foot reservoir located in the Sacramento Valley west of Maxwell and will capture storm-related runoff and a portion of storm-related flood water to increase water supply in drier years.

Country Day School Receives Grant for Tech-focused Learning



What went wrong at EDD? An Investigation of its Managerial Meltdown

In theory, we humans practice politics as a pathway to governance – providing an array of laws, regulations and services to protect and otherwise enhance the lives of the governed.

In practice, politics often - too often - become all-consuming exercises that bear only the faintest relationship to governance. Case in point: the U.S. Congress.

An aspect of that disconnect is the eagerness of those in office to build their images by constantly offering up proposals for new laws, services and programs while ignoring whether earlier laws, services and programs that officialdom birthed are performing as promised.

Often they are not, but even when informed about the shortcomings of design and/or implementation, officials tend to minimize or brush aside the criticism, fearing that acknowledgement would be a sign of weakness. Management and oversight just don't have the political sex appeal of some shiny new notion that promises boundless benefits.

Examples of the syndrome abound, particularly in a state as large and diverse as California.

The state's bullet train project is certainly one. Billions of dollars have been consumed and various

structures have been built but the project has become a zombie, something that's neither alive nor dead.

Oroville Dam is another. It was poorly designed and shoddily constructed in the 1960s and those who managed it knew of its deficiencies, particularly spillways that couldn't handle Feather River flows from extraordinary storms.

But the interest groups that provided financial support for the dam in return for water were evidently not willing to spend the money necessary to make it safe. Officialdom didn't make it

a priority, even when safety issues were raised in 2005 during the dam's relicensing. In 2017, it came extremely close to a collapse that could have killed thousands of people.

There are many others but the poster child for governmental dysfunction has to be the Employment Development Department, which imploded during the COVID-19 pandemic as millions of Californians lost their jobs and needed unemployment insurance benefits.

EDD managed to simultaneously deny countless unemployed workers of the life-sustaining benefits to which they were entitled and parcel out countless billions of dollars in benefits to clever fraudsters.

A preview of EDD's dysfunctional tendencies was felt during the Great Recession a decade earlier and the state's watchdogs, the state auditor's office and the Legislature's budget analyst, issued timely warnings of potential disaster. But three governors and hundreds of legislators couldn't be bothered to fix them and

the result was cruel chaos. In the aftermath of the near-catastrophe at the Oroville Dam, an exhaustive and damning analysis of what went wrong was commissioned. EDD deserves similar scrutiny.

After a year of painstaking research and interviews, CalMatters investigative reporter Lauren Hepler has written a four-part series that delves into what happened and why. She also catalogs the pain that EDD's managerial collapse imposed on people who needed unemployment insurance benefits when the state shut down their jobs.

"Once COVID hit," the series' foreword summarizes, "public records and interviews reveal that California's system was initially friendlier to scammers than to many real workers – and then the state got so aggressive that many workers struggled to prove their own identities. New financial reports requested by CalMatters show that amid the chaos, the EDD and its unemployment payment contractor Bank of America split a half a billion dollars in revenue, though the bank says it ultimately spent more to cover fraud losses. Another large EDD contractor, Deloitte, made more than a quarter of a billion dollars on tech contracts and emergency contracts to build systems that state reports say buckled during the pandemic."

Will it be fixed or will EDD melt down again when another recession hits?

Social Security Matters Social Security Disability vs. Spouse **Benefits vs. Survivor Benefits (and COLA)**

Dear Rusty: I retired from working in June but will not sign up for Social Security until age 70 and, to do that, I plan to draw from my IRA for the next 3 years. My wife is receiving Social Security disability benefits and will reach her full retirement age in March of next year. I know that my wife simply reaching her full retirement age will not mean an increase to her benefit – except for COLA. What I'm wondering is, can my wife get spousal benefits of any sort based on my Social Security benefits - either before I draw or after I am drawing - apart from her benefits at my death? Her Social Security disability amount is only a fraction of my maximum benefit. Signed: Baffled Husband

Dear Baffled: Looks like you're confused about your wife's Social Security disability benefits, retirement benefits, spousal benefits, and survivor benefits. Here's what you need to know:

When your wife reaches her full retirement age (FRA) next year, her current Social Security Disability Insurance (SSDI) benefit will automatically convert to become her regular SS retirement benefit at the same amount she was receiving on SSDI (disability). The amount stays the same because your wife's SSDI amount is based on her FRA entitlement.

Your wife cannot get any spousal benefits from you until you claim your own Social Security retirement benefit. Since you plan to delay claiming until you are 70 several years from now, after your wife's SSDI converts to become her regular retirement benefit at her FRA next year, she will continue to receive her own SS retirement benefit until you claim. At that point your wife will get a "spousal boost" added to her own SS retirement benefit. The amount of her spousal boost will be the difference between her FRA entitlement (same as her SSDI amount), and 50% of your FRA entitlement (not half of your age 70 amount spouse benefits are always calculated using FRA amounts, regardless of when Social Security is actually claimed).

Your wife cannot get a spousal benefit from you until you start your Social Security, but after you claim she will receive her higher spousal benefit (her own SS retirement benefit plus a spousal boost) for the rest of her life, or until you predecease her. If you die first, your wife will get 100% of the amount you were receiving at your death (e.g., your age 70 amount), instead of the smaller amount she was receiving as your spouse while you are both living.

Regarding COLA, after becoming eligible for benefits, everyone gets the annually awarded COLA increase whether they are already collecting SS benefits or not. The next annual COLA increase will be added to your wife's SSDI at the end of this year and added to her SS retirement amount each year thereafter, and then to her higher amount as your spouse after you claim. And even though you are waiting until age 70 to claim, the annual COLA will still be added to your Primary Insurance Amount (PIA) each year, and you will receive that past COLA in your monthly payments after you later claim.





Defendant Sentenced for Child Endangerment Causing Death

SACRAMENTO COUNTY, CA (MPG) - The Honorable Shauna Franklin sentenced Roberto Escobar-Montes to 6 years' state prison. On September 1, 2023, Escobar-Montes was convicted by a jury of two counts of child endangerment with circumstances likely to cause death and the enhancement that the death of a child resulted from these circumstances.

On November 28, 2021, Escobar-Montes was at home taking care of his children. He placed both of his babies (8-month- old Freyja and 2-year-old

Eros) in the bathtub and turned on the water. He left the room and began playing a pornographic video game in another part of the home, leaving the children alone in the bathtub for at least 12 minutes. When he stopped hearing Freyja, he came back to the bathroom and found she was floating face down in the tub which was $\frac{1}{2}$ full of water. He grabbed the 2 year old, who was not drowning, out of the tub and turned off the water. Only then did he grab Freyja and unplug the drain. Freyja was without a heartbeat for 90 minutes despite life-saving efforts. She died a few days later from her drowning injuries.

Grant Enhances CHP's Strategies to Combat Speed and Aggressive Driving

SACRAMENTO, CA (MPG) - Speed and aggressive driving continues to be a major concern on California roadways. Federal funding awarded to the California Highway Patrol (CHP) will help implement safety measures to reduce dangerous driving behaviors statewide.

The \$2.5 million Speed Prevention, Education and Enforcement Deterrence (SPEED II)

grant aims to reduce the number of fatal and injury crashes related to speed and the number of victims killed and injured in these crashes. To achieve this, the CHP will deploy enhanced enforcement and public awareness campaigns statewide.

Speeding and aggressive driving behaviors are a significant danger to the motoring public, pedestrians, and individuals using alternate forms of transportation. In federal fiscal year 2021-2022, speed was a factor in nearly 40% of all fatal and injury crashes in California. During this period, there were in excess of 28,000 speed-related crashes, resulting in over 400 deaths and more than 42,000 injuries. "The receipt of this grant will enable the CHP to reinforce our commitment to road safety," said CHP Commissioner Sean

Duryee. "Through a combination of proactive enforcement and community education, we aim to eliminate the threat of speed and aggressive driving, while

> making our roads safer for everyone."

During April 2021 to July 2023, the CHP used federal funding to employ educational and enforcement efforts to combat dangerous driving behav-

iors. The federal funding allowed the CHP to conduct enhanced speed enforcement operations on state routes with increasingly speed related incidents. During this period, the CHP issued over 48,000 citations to motorists exceeding 100 miles per hour; collaborated with allied law enforcement agencies and posted anti-speeding and aggressive driving behavior ads on social media.

Funding for this program was provided by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration.

The mission of the California Highway Patrol is to provide safety, service, and security. ★



2022 Crop and Livestock Report Released

Sacramento County News Release

SACRAMENTO COUNTY, CA (MPG) -During her presentation of the 2022 Sacramento County Crop and Livestock Report at the Nov. 7 Board of Supervisors Meeting, Agriculture Commissioner, Chris Flores reported that the gross production value of all agricultural commodities in Sacramento County was more than \$602

million, up 5% from \$568 million in 2021!

Even with an 8% decrease from 2021, wine grapes were once again the leading cash crop in Sacramento County, with a value of more than \$188 million, or more than 31% of the total gross value of all crops. More than 38,330 acres of wine grapes were harvested in Sacramento County in 2022.

Market milk held on to the number two spot with a total value of more than \$91 million, while pears kept the number three spot with more than \$56 million.

"Agriculture continues to be a significant contributor to the local economy and plays a crucial role in preserving the region's rural character," said Flores. "The County's diverse agricultural landscape includes farms, ranches, orchards, and vinevards and produces crops such as rice, tomatoes, pears, and grapes, as well as dairy and livestock commodities."
