CITRUS HEIGHTS, CA (MPG) - The Citrus Heights Pet Hospital, formerly located at 7404 Auburn Boulevard in Citrus Heights celebrated the completion of its move to the Greenfaire Village Center at the corner of Greenback Lane and Fair Oaks Boulevard with a formal ribbon cutting on Friday, November 17th.

of Commerce, veterinary practice staff and other local officials took

time to recognize the history of one of the city's oldest full-service animal

hospitals as it moves on to a new chapter in business. Citrus Heights Pet Hospital, founded in 1962, with over 63 years in business, thoughtfully cares for dogs and cats which require emergency care, as well as providing basic wellness checks, and attending to their general medical, surgical and dental needs.

The veterinary practice is owned and operated by Dr. Avery Brickson and her husband Erik who serves as hospital administrator.

Thanksgiving Blessings Delivered

CITRUS HEIGHTS, CA (MPG) - Over the last few weeks, Sunrise Christian Food Ministry at Advent Lutheran Church at 5901 San Juan Ave., distributed reservations/tickets for 2,000 clients to receive holiday food baskets and gift cards provided by Sacramento Food Bank and Family Services and other sources.

Reservation holders began to arrive at 10:00 a.m. on Thursday, November 16 and Friday, November 17, until 1:30 p.m. A new system to regulate traffic for high volume events was developed so there would be no back-up to Greenback as experienced in 2022. On the first day, a much larger number of clients than expected appeared at the same time creating a memorable day for food closet workers and the Citrus Heights Police Department. This year it all went smoothly. The homeless and those with no vehicle were given food following the holiday handout.

Holiday boxes included the staples with all the traditional trimmings. The Sacramento Food Bank along with Raley's and the Citrus Heights Grocery Outlet provided 1,500 gift cards for clients to purchase the meat of their choice or other items.

The distribution would not have been possible without the hundreds of volunteers that worked tirelessly to pull it all together.

At the end of day one all the remaining food had to be returned up the hill to the food closet and returned down to the parking lot the next day. Volunteers are always ready to do whatever is needed at any time.

Pastor Gabrielle (Gabi) Schroeder of Advent Lutheran said of the work of the ministry, "We receive more by serving than we give. We are thrilled that our church facilities are used as much during the week as they are on Sundays."

Food Ministry Director April Jacek said in an email, "The food distribution was also made possible by donations generously provided by Raley's, our locally owned and operated Grocery Outlet of Citrus Heights as well as other supporters of the food closet including Advent Lutheran Church, Ascension Lutheran Church, Carmichael Kiwanis, Harding San Juan Masonic Lodge,

Popular Seniors Meal Program Looks to Resume in January 2024

CITRUS HEIGHTS, CA (MPG) - A popular Meals on Wheels program, its All-Seasons Café, which offered hot meals to seniors Monday through Friday living in Citrus Heights, is looking to resume in early 2024, once an agreement between all participating parties can be finalized, said Ash Feeny, Citrus Heights city manager.

The popular hot meal program, sponsored by Meals on Wheels which gave seniors a place to meet and socialize, was suspended during the pandemic and did not resume in Citrus Heights.

The All-Seasons Café is an in-person, restaurant-style space, with each lunch hosting typically 20-90 seniors per meal.

The two nearest Meals on Wheels café sites are located at the Mission Oaks Community Center at 4701 Gibbons Drive in

Carmichael and in the Rio Linda Elverta Recreation and Park District, 810 Oak Lane, in Rio Linda.

"We've been listening to seniors in Citrus Heights who said they very much would like to see the (All-Seasons Café) meal program resume," Feeny said.

In September, Jennifer

Massello, director of programs for Meals on Wheels in Sacramento and Francisco Alvarado, a Meals on Wheels Café program specialist said in an email they were both interested in finding a café partner in Citrus Heights and whom to contact at the city for further information. Their inquiry was

shared with Ash Feeny.

An initial meeting between a team of city officials which was led by Feeny and the Sunrise Recreation and Parks District to consider the matter took place on November 9th.

With the issue brought to the attention of all parties,

All Aboard the Sacramento Valley Live Steamers Santa Train!

RANCHO CORDOVA, CA (MPG) - All aboard the Santa Train!

Members of the Sacramento Valley Live Steamers Railroad Museum (SVLSRM) welcome the public to ride their annual Santa train, weather permitting, during the first and second weekends of December at Hagan Community Park in Rancho Cordova.

Club members also help kick off the holiday season with their participation in the 23rd Annual Rancho Cordova Community Tree Lighting at Village Green Park at 3141 Bridgeway Drive from 4 to 7 p.m. on Sunday, November 26 when a special train for young riders will loop around the brightly lit community tree.

Upcoming run times for the Santa Train at Hagan Community Park are 11 a.m. to 3 p.m. on Saturday, December 2, and Sunday, December 3, and the following weekend, Saturday, December 9 and Sunday, December 10th. The SVLSRM museum is located at 2197 Chase Drive, just past the petting barn in the rear of Hagan Park.

The Santa Experience train ride is \$8 per person. Children, ages two and under, ride free with a paid adult ticket. Advance tickets can be purchased on the SVLSRM web site at: www.svlstrm.org/

Personal keepsake photographs taken with Santa Claus are free. Guests will receive a login and password to an online gallery where they can later view and download their digital photos.

"This is the largest fundraiser for the SVLSRM each year," said club president Andy Berchielli.

Over the two weekends, well over 2,400 riders and visitors, both young and old, are expected to visit Santa, he said. "It's also a lot of hard work and a lot of fun."

"Our Santa Train is a yearly event that many have made their tradition," Berchielli said. "We continue to make small changes to improve the flow and wait time of our guests," he said.

This year, tickets are being sold for three individual trains which will pull five cars each around the 6,300-foot main line loop which is festively decorated by club members to enhance the holiday train ride experience. Passengers will pass under a large inflatable gateway on their way to meet Mr. and Mrs. Claus.

"We will also be handing out candy canes this year to everyone, and each group will receive a keepsake Santa train ornament," he said.

"Santa will also take time to talk to each child about their Christmas wishes before the train departs back to the main station. It's a special event that brings smiles to everyone, no matter the weather," Berchielli said.

SVLSRM began in 1965 and trackwork was completed with a ceremonial Golden Spike ceremony in 1973. Track and guest improvements have continued ever since with new features added each year, Berchielli said. Live steam engines carry passengers through wooded areas and the nearby American River. The railroad also features wooden trestles, a 40-foot truss bridge as well as a girder deck bridge.

Roller Derby Community Has Bright Future Ahead

SACRAMENTO REGION, CA (MPG) - While speaking with Amanda Dunham and Christina Watts from Sacramento Roller Derby, one theme was consistent throughout the entire conversation – Roller Derby isn't just a sport – it is a family with so many positives for Sacramento youth and women.

The two skaters, who always go by their derby names LOLZ Lemon and Jessamine Killawatts at the rink, are passionate about roller derby in a way that is so contagious it compels the listener to want to strap on some skates and give it a go.

Now, Sacramento Roller Derby is gliding towards a new era of excellence – rebuilding its teams post-COVID, and looking forward to their future home facility.

Sacramento Roller Derby was founded in 2018 as the result of two different leagues merging after skating as separate entities for over ten years. The leagues realized that they were better together both functionally and financially, and united to form the current team. The current league welcomes over 100 participants, of which approximately 50 are adults and the rest children and various officials including referees.

The group currently uses the Andy Morin Sports Complex in Folsom for their practices, but there are big dreams ahead.

"We have a facility in downtown Sacramento that we are working on," says Dunham. "We purchased it with a donation someone made to us."

That donation was no small gift – the donor, who wishes to remain anonymous, gifted the group up to \$2 million to build their facility. The excitement and relief of finding a permanent home was evident from both women.

"It's been a struggle – Sacramento doesn't have a lot

of affordable facilities. The landscape of Sacramento has changed – the town is so much larger and venues we have rented in the past have quadrupled their prices," said Dunham.

The new rink will be located near the Blue Diamond almond factory.

Both the generous donation and influx of new participants post-COVID are two examples of how the Sacramento community is embracing a sport that once had a reputation in popular media for being aggressive and less than ladylike. Today, roller derby carries a reputation of strength, togetherness, and courage for many.

Watts, who is a board member for the team, recently lost her husband and found support within the derby community.

"The whole derby community helped me to find a new normalcy," says Watts. "Everybody

has been really positive and will check up on me. Everybody in the community binds together to help people in a time of need."

Dunham seconds the fact that roller derby isn't just about the game. "That's the most rewarding thing – the growth and the community that supports that growth. A lot of people come to roller derby during a hard time in life. They know the community of roller derby will be there."

Sacramento Roller Derby has no paid employees and finances are always a challenge. A lot of the players within the league are also the ones running the entire show.

"There are challenges on and off the track when you play roller derby," explains Dunham. "We have both the typical athlete struggles plus business struggles. Most recreational sports don't have both. For us, it's really serious – it is comparable to minor

league sports. But there's the added pressure of running it. Most sports have administrative oversight – that's not us. We are off the track running the game and then we put on our skates and play the game. You're always doing two things at the same time."

But is it worth it? Dunham absolutely believes it is.

"It makes you grow in ways you never thought you could. In myself I've grown a lot in confidence."

She also mentions that derby skaters not only grow in what their bodies are capable of, but also personally and professionally. Confidence found in roller derby can lead to the courage for everything from pursuing job promotions to leaving harmful relationships.

Also notable is Sacramento Roller Derby's junior program. Children as young as eight years

old can join the team.

"The kids find their own way there," says Dunham when asked how they recruit children to the program. Current league kids share with friends via word-of-mouth, and the league's numbers have also benefited from a popular graphic novel featuring a roller derby girl.

However, the junior program is hardly new. "We've had a juniors program for as long as Sac Roller Derby has been around."

Safety comes first, and just like the adults, junior skaters wear helmets, mouth guards and pads. And they aren't afraid to completely wipe out and try again.

"The kids are super resilient and dedicated," says Dunham. "They are just like Gumby and fall in weird ways that make my heart stop and then get up and skate away."

"They are all amazing," adds Watts. "They are always striving to do better."

Perhaps that's the true magic of roller derby. Beyond the sport itself, skaters are inspired to do better both on and off the rink.

Those who would like to watch a game can head out to the Andy Morin Sports Complex on December 2 for the Red Red Tournament – a chance to see not only Sacramento Roller Derby but other leagues play on mixed teams. Or, take things a step further and consider trying out for the league next spring. Anyone can try out, and skating experience isn't necessary. The tryouts include everything from skating lessons to teaching the rules of the game. The junior program is for boys and girls aged eight through seniors in high school. Females aged 18+ make up the main league.

Brickson, who earned her Doctor of Veterinary Medicine (DVM) from Iowa State University is the daughter of Dan and Irene Warshauer of Citrus Heights.

Dan is the choir director of Celtic Cross Presbyterian Church and is the inspiration for the practice's business logo which he and Irene collaborated to design. Its background story is displayed in the main lobby.

The logo features the silhouette of Dan and his military service dog Lock n' Load from a photograph taken on the top of a bunker, at the start of one of his guard duty shifts in Dak To during his tour of duty in Vietnam from 1968-69. Warshauer served as a U.S. Army chaplain's assistant with 1st Brigade Headquarters, 4th Infantry Division.

"My husband Eric and I purchased the practice in 2010 from Dr. Dean Henricks and now care for some 15,000 active patients," she said.

Citrus Heights Pet Hospital was opened by Dr. Frost, (no relation to the family of Sacramento County Supervisor Sue Frost). Dr. Frost then sold the practice to Dr. Dean Henricks in 1997 who grew it further.

The couple provided guests with a tour of the practice's treatment areas and an opportunity to meet hospital staff. A public grand opening ceremony was held throughout the day on

Sunday, November 19th with refreshments and a silent auction.

"We actually still have clients who started with the practice in 1962 and who through the generations of pet families have continued with us ever since," Dr. Brickson said.

The new veterinary space in Greenfaire Village Center is almost double the size of the practice's former Auburn Boulevard facility.

"Having the opportunity to design and build it to our specifications allowed us to fully maximize the use of this new space," she said.

"We love how much natural light comes into the new facility from windows on all four

sides," she said. "We also have advanced air handling to minimize stress for our pet patients, to minimize the chance of infectious disease transmission, and to maximize the movement of fresh, clean, temperature-controlled air throughout the building," she said.

The finished interior features an intentionally chosen color palette with patients in mind. Natural, calming colors on the floors, cabinets, counters and walls, and art from local artists have been chosen for their non-stressful content.

The practice in its new location has the physical capacity to add three to four doctors and between nine to 12 support staff in the

future, Brickson said. "It's one of the most exciting aspects of our upcoming expansion," she said.

"I'm proud of the great team of veterinarians and supporting staff we have at Citrus Heights Pet Hospital," Brickson said. "We're excited to welcome our pet patients and their parents to our new facility."

Citrus Heights Pet Hospital has four full-time doctors, herself as owner/veterinarian, Dr. Zoe Wichman, associate veterinarian: Dr. Audrey Sloan, associate veterinarian; and Dr. Tami Rosich, associate veterinarian. Dr. Dean Henricks, an associate veterinarian who originally sold the practice to the Bricksons, attended the ribbon cutting and

continues to work part-time.

In its Auburn Boulevard facility, situated across from Sylvan Cemetery, veterinary staff had worked in approximately 2,500 square-feet of space which wasn't designed for a modern style of practice and workload, Brickson explained.

"We'd been exploring opportunities to expand for years and when this property at Greenfaire Village came up for sale, we decided it was an ideal location to meet the needs of our rapidly expanding clientele," she said.

"As general practitioners, we are family doctors, focusing on preventive care, wellness and public health," she said. When patients require the next level of specialty care, Brickson said referrals are then placed to a robust community of boarded veterinary specialists in the greater Sacramento area.

a collaborative effort between all parties has been underway to resume the program, Feeney said. Hours of operation and a final location have yet to be determined.

"Nicole Piva, Sunrise Park and Recreation District (SPRD) district administrator Kevin Huntzinger, and Jennifer Massello and Krystal Sharpnack with Meals on Wheels have toured two sites, the Rusch Park Community Room and the Crosswoods Community Center behind Sylvan Oaks Library, for consideration," Feeney said. Piva serves as the city's housing and human services program coordinator.

"The Crosswoods Community Center which is located in Crosswoods Park at 6742 Auburn Blvd. is the preferred

option," Feeney said. "This is a great location, it's accessible, and available on Tuesday, Thursday, and Friday where it can be used for the All-Seasons Café program."

The center is located at the intersection of Auburn and Van Maren, behind the Sylvan Library. Crossroads Park is situated in a serene natural wooded area with a year-long stream and has been used for small gatherings including weddings, birthday parties and meetings. The facility has a complete kitchen, seating capacity for 60 people and has hosted small gatherings including weddings, birthday parties and meetings.

In a recent email, Feeney said the next step will be for SRPD to formalize an agreement with Meals on Wheels to resume the All-Seasons Café which will

then require approval of the SRPD board at its upcoming December 13th meeting.

Another similar presentation to board members of the state Agency on Aging/Area 4 will also take place at a future date, Feeney said. Agency on Aging/Area 4 is one of 33 area agencies on aging (AAAs) in California. In Sacramento County, the state has projected there will be more older people than young people by 2030.

Representatives of Meals on Wheels will have to obtain a required Health and Safety Permit and file for a charitable food fee application with the state. The shared goal between all parties including the city of Citrus Heights, SRPD and Meals on Wheels is to relaunch the Citrus Heights All Seasons Café in mid-January 2024, Feeney said.

The objective of Meals on Wheels, which currently serves seniors 60+ years of age, is to keep seniors in their homes and communities longer by providing nutritious meals, safety net services, social contact, community resource information and much more.

The city webpage does note that the All-Season Café has not yet resumed but does describe other alternative meal programs which Citrus Heights seniors may want to consider.

Home delivered meals are also available to seniors aged 60+ who are homebound due to illness or recovery, disability, or other causes which may prevent

them from leaving their homes. Eligible participants may receive either hot, home-delivered meals every weekday or a box of five frozen meals once a week.

Seniors who are interested in Meals on Wheels ongoing home-delivered meal program, can call (916) 444-9533 for more information.

The Citrus Heights Community Center also has a dedicated Senior Room available for local seniors to play cards, eat together, laugh, and simply enjoy each other's company. The senior room is located at 6300 Fountain Square Drive and is open to the public Monday-Friday from 9:00 am to 4 pm. Seniors who are interested in programs at the Citrus Heights Community Center can call (916) 727-5400 for further information. ★

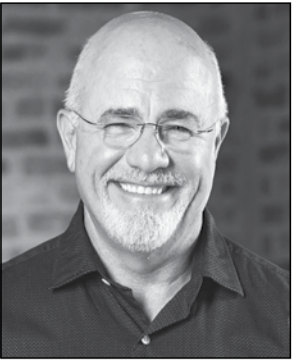

SACRAMENTO REGION, CA (MPG) - St John the Evangelist School's blowout – "A Holiday Show of Hands" – will ensure a crafty Christmas for thousands of shoppers on December 1, 2 and 3.

St John the Evangelist School is located at 5701 Locust Avenue, in Carmichael. Because fair traffic clogs surrounding streets, free shuttles will run from Carmichael Elks Lodge parking lot to St John's Church.

"People come here from all over Sacramento – even from out of state," says Pat Holbus. "Our market is a Sacramento tradition. It's a weekend that says Christmas is here at last."

Social Security Matters

Can I Voluntarily Suspend My Social Security Payments?

Dear Rusty: My wife retired in 2015 and is receiving Social Security. I am past my full retirement age, and I still work. I recently filed for Social Security benefits and received my first payment earlier this month, and my benefits are around three times my wife's. I now find that, due to other income, I am having some regrets about filing for Social Security, as the taxes will be complicated. So, my questions are:

1. If I do a "Voluntary Suspension", can my wife still apply to get up to 50% of my benefits, or do I have to be "actively" receiving Social Security benefits? In other words, does the "Bipartisan Budget Act of 2015" prevent this?
2. If I do a "Voluntary Suspension", how soon could I "restart" my benefits?

Signed: Having Second Thoughts

Dear Second Thoughts: The Bipartisan Budget Act of 2015 closed a

loophole which previously allowed someone to file for their Social Security retirement benefit in order for their marital partner to claim a spousal benefit, after which the primary beneficiary could suspend their own benefit and allow it to grow to maximum at age 70. That "file and suspend" option went away in April of 2016; thus, your wife cannot claim her spousal benefit while your Social Security retirement benefits are suspended (you must be "actively" receiving benefits for your wife to get benefits on your record).

Nevertheless, because you've already reached your full retirement age, you can voluntarily suspend your benefit payments at any time to allow it to continue growing by simply calling Social Security at your local office (or at the national number 1.800.772.1213) and asking them to do so. Your wife will not receive her spousal benefits for any months your benefits are suspended, but she would continue to get her own SS retirement amount (only the spousal portion of her monthly amount would be suspended).

You will be able to restart your benefits at any time by calling Social Security again and asking that your benefits be resumed. You can suspend and restart your benefits as needed (no restriction on how many times), but they will only start/

resume the suspension effective with the month following the month you call. And, as you likely already know, for each month your benefits are suspended you will earn Delayed Retirement Credits (DRCs) resulting in a higher payment amount later.

Just for clarity, voluntary suspension of benefits is only available to those who have reached full retirement age but is an excellent way to increase your monthly Social Security payment. Your benefit will grow by .667% for each month suspended and, if your benefit is still suspended when you turn 70 years old, Social Security will automatically resume payments at that time, at your higher maximum monthly amount.

California Keeps Expanding School Curricula. What About Improving Key Subjects?

Last week, the attorney general's office completed paperwork for an initiative that, if qualified for the 2024 ballot and approved by voters, would require California's nearly 6 million public school students to take a course in personal finance.

The proposal, by an organization called Californians for Financial Education, is the latest of several efforts to make personal finance a required subject.

"California has lagged behind the rest of the nation when it comes to personal finance education," Tim Ranzetta, a financial executive in Palo Alto and founder of the organization, said in a statement. "Only 1% of California students are required to take a personal finance course as a condition for graduation compared to 48% nationally."

Ranzetta's proposal is also the latest of many efforts to add specific topics to California's school curricula. Scarcely a year passes without new proposals to expand required coursework, either as stand-alone classes or woven into other required classes.

A new state law, dealing with media literacy exemplifies the latter. Beginning next year, the state's schools

must modify existing curricula to include skills in differentiating legitimate journalism from fake news meant to sway opinion, prompted by the proliferation of social media with dubious validity.

"I've seen the impact that misinformation has had in the real world — how it affects the way people vote, whether they accept the outcomes of elections, try to overthrow our democracy," Assemblymember Marc Berman, a Menlo Park Democrat and the bill's author, told CalMatters. "This is about making sure our young people have the skills they need to navigate this landscape."

Another new requirement, this one for high school graduation, is ethnic studies, which the Legislature and Gov. Gavin Newsom decreed after years of often heated debate over what should be taught and how.

The first draft of a model curriculum basically suggested that high school students be indoctrinated into believing that anyone in America not a white male is oppressed.

"At its core," the draft initially declared, "the field of ethnic studies is the interdisciplinary study of race, ethnicity, and indigeneity with an emphasis on experiences of people of color in the United States," adding, "The field critically grapples with the various power structures and forms of oppression, including, but not limited to, white supremacy, race and racism, sexism, classism, homophobia, islamophobia, transphobia, and xenophobia, that continue to impact the social, emotional,

cultural, economic, and political experiences of Native People(s) and people of color."

In response to criticism, particularly from Jewish legislators who said the draft was antisemitic, it underwent two revisions before being adopted as a graduation requirement beginning in 2030. It still contains tinges of left-wing dogma.

New curriculum mandates might seem justified on a standalone basis. Conceptually, it's laudable that students become more aware of California's ethnic diversity, more adept at separating legitimate journalism from fake news, and better able to manage their personal finances.

However, there are only so many hours of instruction in a school year and the level of academic achievement in California's schools is pretty dismal. In the latest round of state test results released last month, fewer than half of students met standards in English skills and scarcely a third in math.

California's high school students are already required to pass the equivalent of 13 year-long classes in specific subjects for graduation, and a number of additional courses if they want to attend four-year colleges.

Adding new mandates takes class time away from basics that too many students are not already mastering. Financial or media literacy classes are pointless for kids who can't do math or read at their grade level.
