ELK GROVE, CA (MPG) -The Elk Grove Fine Arts Center celebrated its move to a new location with its First Saturday Reception on Dec. 2, and its biggest show of the year is giving locals a chance to browse the work of dozens of

The fine arts center spent the last several weeks preparing its new space at 9020 Elk Grove Blvd., Suite 101, and President Erin Martinelli told the Citizen that "everyone is just so happy to be here." She appreciated that the center is now back in Old Elk Grove after five vears on Elk Grove-Florin Road. She also felt that the

center would fit in with the area's increased focus on entertainment, food and shopping.

For the grand opening, the center programmed a full day of art demonstrations and workshops. Martinelli said attendees praised the location.

"The space is so open. It's bright. There's so much light. It just feels really

grand because of the scale of the ceilings. It's very industrial looking," she

The center is holding its 12th annual Small Treasures Show and Sale, featuring more than 60 artists. Each artist submits five works on 5-by-7inch panels. Compact and less expensive than many

Martinelli said the new location makes the art show look more expansive than it did before.

She noted that the center is planning the second edition of its Festival of the Arts for April 27. There will continue to be art shows, and possibly art walks on Elk Grove

Boulevard. Martinelli also said that the center may eventually rent work space for artists.

Small Treasures Show and Sale continues through Dec. 30. Individual works cost \$50 each, or \$45 each for three or more pieces from a single artist. The center is open Wednesday-Saturday, 11 a.m. to 5 p.m.; and Sunday, 11 a.m. to 4 p.m. For more information, visit elkgrovefineartscen-



Utilizing a green infrastructure approach, the Elk Grove Nature Park located behind the Cosumnes CSD Administration Building at 8820 Elk Grove Boulevard helps manage stormwater runoff, provides wildlife habitat, promotes environmental awareness, and contributes to the well-being of our Elk Grove Community.

The first phase of this new park includes over a quarter-of-a-mile of new walkways, seating areas for relaxation, interpretive signage for education, and natural areas for wildlife to thrive. Future phases of construction are planned, as funding becomes available, to include a nature play area, a visitor center, and additional stormwater management





Sheriff Jim Cooper's Open Letter Regarding Retail Theft and the CRA

Dear Constituents.

The California Retailers Association (CRA) has made several misleading and inconsistent statements regarding a pending ballot initiative to address California's retail theft crisis

The CRA president was an officer of the committee supporting the ballot measure and has repeatedly stated her support for this initiative. As recently as November 10, 2023, she told local media that she has been working "so hard" to fix Proposition 47 and put this initiative on the ballot.

FACT: In direct contradiction of this claim, in a November 15th Sacramento Bee article, the CRA president stated, "passing a ballot initiative isn't the solution,"

suggesting that the crisis can be cured by simply making retail theft misdemeanors subject to a mandatory appearance in court.

Anyone with experience in this realm should know that a misdemeanor approach will solve nothing. Existing law already requires individuals to appear in court when cited or arrested for misdemeanor crimes. In fact, thousands of individuals in jurisdictions across California fail to appear on misdemeanor crimes following the issuance of a citation, arrest, or even court order. In Sacramento County alone, we have over 33,000 outstanding misdemeanor warrants. The volume of misdemeanor warrants issued for those who fail to appear is enormous and already unmanageable for law

As a result of Proposition 47 ("Safe Neighborhoods and Schools Act"), individuals who repeatedly commit theft and drug crimes suffer no consequences. People with drug and mental health issues, therefore, have no incentive to get treatment. Proposition 47 clearly states that any effort to increase penalties related to theft or drug crimes requires voter approval.



Per Proposition 47, the legislature has no power to make any meaningful change to address the retail theft crisis California faces. Given the extraordinary losses suffered by the retail industry and the significant impact it has on the consumer, I express my deepest concerns about California Retail Association President Rachel Michelin's willingness to misrepresent to the public the facts on these critical matters.

While I still have my reservations because of their past history, I am hopeful we can find some common ground with the big box retailers and work together to resolve the crisis of retail theft.

This is the time of year that many of us consider our charitable-donation budget. But as we decide how much to give, perhaps we also ought to calculate why we

give.

In his list called "Eight Degrees of Charity," the 13th century Rabbi Moses Maimonides offers wise council for weighing our motives.

I've mentioned his list a few times in this column, but like Dicken's "Christmas Carol," the list inspires me each time I revisit it. The unabridged catalogue can be found on my website, but since it has many nuances, allow me this paraphrased summary.

Maimonides describes his list as a ladder, so let's begin at the bottom rung, the lowest form of charity.

8. Sometimes we give only because we are uncomfortable with our wealth. This sentiment is aptly described by Tibetan Buddhist Trungpa Rinpoche as "Idiot compassion." You can see it in the actions of retirees like me who did this during the pandemic. As our savings bulged with stimulus checks and investment returns, we started giving to the local foodbank. No judgment here. I think Maimonides would say that most charity is good charity. Still,

it's hard to sort our good motives from our lesser ones. That's why the rabbi encouraged us to work our way up the ladder.

7. Let us give cheerfully but not too much. We do this by dropping a few bucks in the Salvation Army kettle or the church offering. We smile generously, but we know it's woefully inadequate.

6. Just ask me and I'll donate. Generous, yes. But why must we be asked first? In Honduras, as in many Latin countries, people of all income levels will carry charity money to give to those who ask. The San Francisco company GoFundMe began with the premise of giving to those who ask. The tragic drama in many requests inspires us to give. In 2021 they generated \$22.6M in revenue.

5. Let's give without being asked. This sounds like a clean motive but it's low on the ladder because the giver may be doing it to gain attention. On one hand, it's the kind of giving we might do when we say we pick up the dinner check. On the positive side, it's the kind of giving we do when a neighbor needs our assistance.

4. We should give to those we don't know, but they should know who we are. A lot of us achieve this when we give to the homeless woman at the intersection. It's a kind act, but there's no way to avoid making the recipient feel less-than.

3. I like to give anonymously but I need to know who's getting it. This may seem like a high form of giving, but not quite. Maimonides cautions that since "subconsciously, the giver might gain a pleasure and a sense of power over the recipient, this detracts from his act."

2. I like to give anonymously and don't want anyone to know This one is tricky, but the best modern-day example is the Salvation Army Kettle. Your donation helps the poor, but you will never know who they are, and they will never know who you are. You have no say in where the money goes and cannot take it back. And the highest degree of charity motive on Maimonides list is...

1.Let's form a business partner-ship with the poor. "What?" you ask. "Business is not charity!" The rabbi considered this the highest charitable form because it "strengthens the hand of the poor through either a gift or an interest-free loan." Surprisingly, Maimonides considered the loan better than an outright gift "since the poor are not shamed."

This charity is best illustrated in the saying, "Give a person a fish and he will eat for a day. Teach him to fish and he eats for a lifetime."

It's this charitable approach that has

inspired me to proudly promote Chispa Project in this column for the past eight years. Chispa establishes libraries in Honduran

elementary schools with the help of Honduran teachers, parents and students who will organize, plan and monitor the libraries. Each Honduran community is asked to

raise a symbolic portion of the costs (less than 4% of the total project). In this way Maimonides highest principle is applied and the schools establish ownership, pride, and better sustainability of the library.

"Pure" charity is about improving the

lives of others, not our own. Yet still I think even Maimonides would have to admit that sometimes we need to do something to feel better. Regardless of our motive, someone is helped.

In any case none of us have a pure heart, so thankfully most charities are able to help those in need regardless of our motive to give.



Sac State Turnovers Costly in FCS Playoff Loss

--Sacramento State fell behind early with two first half turnovers and was not able to recover in a 34-24 loss at No. 3 South Dakota in the second round of the NCAA FCS Playoffs Dec. 2 at the DakotaDome.

The victory ends the Hornet season with an 8-5 overall record. The Coyotes improved to 10-2, and will host the winner of the North Dakota State-Montana State game in the quarterfinals next weekend.

A week after playing a near-perfect first half in the first-round win at North Dakota, Sacramento State was plagued by early miscues which led to South Dakota taking control of the game. The Coyotes scored first with a 37-yard field goal from Will Leyland.

The lead quickly grew early in the second quarter as USD scored twice in the first minute of the period. The team's first touchdown was set up by an interception on a pass which deflected off the hands of a Hornet receiver. South Dakota faced 3rd-and-10 from the Hornet 18 but was able to convert with a strike from Aidan Bauman to Javion Phelps.

The Hornets had a great start to the ensuing drive with a 33-yard rush from Marshel Martin to bring the ball into USD territory. However, on the next play, the ball was jarred from the ball carrier and recovered by Mi'Quise Grace who returned it 56 yards for a touchdown to make it 17-0 and give South Dakota two touchdowns in 38 seconds.

Sacramento State found the end zone for the first time on its next drive. Kaiden Bennett was shaken up on the first play of the series and replaced by Carson Camp who completed 2-of-3 passes for 36 vards and also rushed for 24 yards during the drive. Marcus Fulcher scored enth rushing, and ninth 10 total tackles and was Sports Editor

total touchdown, of the season.

USD answered quickly needing just two plays to score a touchdown of its own. Tight end JD Galbreath found himself uncovered in the Hornet secondary and traveled 75 yards for a score.

Following a fumble recovery by Dillon Juniel, the Hornets traveled 59 yards on eight plays to make the score 24-14 at the half. The Hornets scored on another 2-yard rush from Fulcher with 14 seconds left in the second quarter.

South Dakota was able to dim hope of a Hornet comeback with a 10-play, 63-yard touchdown drive late in the third quarter. The Coyotes chewed over five minutes off the clock and scored on 3rd-andgoal with a 3-yard run from Travis Theis.

The Hornets moved the ball to the 10-yard line but were forced to settle for a 28-yard field goal from Zach Schreiner to pull the team within two scores (31-17). The drive was aided by a 48-yard completion from Camp to Anderson Grover. The field goal was the 14th of the season for Schreiner who moved into a five-way tie for third place in school single-season history.

After USD matched the score with a 34-yard field goal from Leyland, Sacramento State added the final points of the game with a 3-yard pass from Camp to Jared Gipson. The Hornets' onside kick attempt was recovered by South Dakota which was able to run out the clock.

The stats were balanced between the two teams with Sacramento State compiling 350 yards on 62 plays while the Coyotes had 368 vards on 58 plays.

Fulcher led the team with 63 rushing yards while Martin added 41 rushing yards. Gipson had a gamehigh six receptions, and Grover led all players with

79 yards on three catches. Gavin Davis-Smith from 2 yards for his sev- paced the Hornets with

ELK GROVE, CA (MPG) - The Bill Cartwright Classic has for many years been the eight-team boys basketball tournament that marked the start of the high school season. 
The Mustangs' Sarah Horrell won the 130pound classification over Aolani Gaspar of Pleasant Grove on a pinfall in 1:00.

Huge Disparity in Football Talent With No Apparent Solution



The local football season is now over for the most part with the CIF State Bowl Games coming up this weekend. But, for our local teams the equipment has been turned in and equipment stored for the winter.

A few of our schools got into the playoffs for more than one game led by Bradshaw Christian who went to the Sac-Joaquin Section's Division VI championship game for the first time in seven seasons. They lost in a heartbreaker to Hughson, 40-39.

Cosumnes Oaks played a terrific game at Lincoln of Stockton and then were laid out flat by eventual Division I champion Folsom. Monterey Trail, which earned a firstweek bye, looked out manned by Inderkum. Elk Grove handed Vacaville a Division II win thanks to crummy ball control technique. And, Sheldon was just no match for Turlock in a Division I playoff

In these days of everyone gets a trophy and playoff brackets loaded with too many average to poor teams, we should expect these kind of results in the first couple weeks of the post-season.

Reflecting back on the 2023 season a trend some football coaches in Elk Grove have been talking about since the end of the pandemic has seemed to have become quite well pronounced. In this Section, and likely in other Sections of the CIF, we have now three classes of football programs; the elite, the goods and the rest.

Look at the teams who have made the Section semi-finals and beyond the past three seasons and it's the same ones, the elites. I'm talking about Folsom, Oak Ridge, Rocklin and most of the teams in the Sierra Football League, along with Grant, Inderkum, and the parochial schools in the area; St. Mary's, Central Catholic and Jesuit. You might also toss in the top three teams this season in the Trans Valley League, Escalon, Hilmar and Hughson.

Then there are a similar number of football programs in the region who are in the next pack, "the Goods." Elk Grove, Monterey Trail and Bradshaw have to be tossed in here along with teams such as Vanden, Vacaville, Woodcreek, Twelve Bridges, Casa Roble, Oakdale, Lincoln of Stockton, Turlock and Downey. You also have to add small schools with solid programs like Woodland Christian, Sutter and Sonora.

Then there is the rest. Competitively speaking, they just aren't in the same stadium as those above. For proof take any a look at the scoreboards this fall of any of the teams in this group when they played any of the above mentioned. The running clock was turned on in the second half.

The analytics of CalPreps.com backs up this premise. Their top ranked league in this Section is the SFL with a 43.9 rating. Second is the Valley Oak (Central Catholic, Manteca, Oakdale and others) at 17.5. Third is the Tri-City (St. Mary's, Tracy, the Lodi schools) with a 15.3.

The Delta League, mostly with EGUSD teams, is rated sixth-best with a 7.3.

Thirteen of the Section's 23 leagues/conferences have negative ratings from CalPreps.

It didn't used to be this way. The talent base was spread out more. We didn't have the same few teams playing deep into the playoffs year after year like we do now.

I talked to several football coaches and a couple local administrators about this, and they see the same thing. We remember the years, not that long ago, when Valley and Florin had not only competitive football programs, but strong JV and freshman squads. Now they don't. Those two schools were a combined 2-18 in a league competitively-ranked by CalPreps.com 22nd out of the Section's 23 leagues. They struggle to field a varsity squad.

These coaches/admin also note that the elite

teams are from one- or two-school towns. Elk Grove has nine comprehensive high schools from basically the city limits, plus a bit of Sacramento County. Folsom has two schools (Folsom and Vista del Lago). El Dorado Hills, one school (Oak Ridge). These same men with

whom I discussed this issue shrugged their shoulders when I asked what could be done to level the football field competitively. It isn't fun to walk out of stadium after the team on the other sideline just beat you by 50 points. Nor is it enjoyable for most of the guys on the other sideline who know they will beat you by 50. Notice I write, "most."

Why are the elite schools in that classification? Money and lots of it. Players get lots of things for playing at these schools; t-shirts, hoodies, jackets, sweats, shoes, etc. Facilities are top-notch. Plus, the administration does everything it can to support the football programs. Their boosters and alumni get on board to help. It's like a "precollege-type" football program. That's attractive to the parents of an up-and-coming middle schooler who has some

Discuss the ethical aspects of this all you want, but reality is parents are taking their boys to these schools bypassing the neighborhood high school on their way. That trend doesn't seem like it will end.

One idea, though, that came up in my discussions recently is the idea of competitive equity in football, not just in setting up the CIF State Bowl Championships. Do it when setting up football playoffs. The Section does have a competitive success rule whereby those schools who consistently are winning playoff games and championships are moved up a Division or two. That's why Central Catholic, a school of 379 students, played in the Division I

post-season. Why not shove down football programs who haven't had recent success into the "smaller"

divisions?
