

New HomeGoods Store Coming to Marketplace at Birdcage

CITRUS HEIGHTS, CA (MPG) - HomeGoods, a major home decor retailer is planning to open in the Marketplace at Birdcage in Citrus Heights in 2024.

The names of HomeGoods, and two other new businesses, Teriyaki Madness and Flawless Fix have been added to leasing materials by Gerrity Properties for Marketplace at Birdcage, a retail center along Sunrise Boulevard in Citrus Heights as coming soon.

HomeGoods sells items such as furniture, rugs, bedding and storage accessories. The chain's website lists seven other locations in the greater Sacramento area. A marketing representative from HomeGoods did not respond to an email request for comment.

The 25,020-square-foot HomeGoods will fill the space labeled "6130A" previously occupied by discount retailer Stein Mart which closed in early 2020.

A separate 6,729-square-foot space, labeled "6130B," is identified in leasing materials just behind HomeGoods, next door to Cost Plus World Market where a grove of tall trees now stands.

Broker Chris Campbell of the Gerrity Company did not respond to a telephone or email request for comment concerning the pending three openings listed in Gerrity's leasing materials.

A new interior wall separates the former vacant Starbucks coffee shop at 6121 Birdcage Center facing Sunrise Boulevard from its adjacent neighbor, Barnes and Noble Booksellers.

In August, the Business Journal confirmed that restaurant chain Teriyaki Madness, an Asian fast-casual restaurant chain based in Denver would open in the Citrus Heights retail center at 6121 Birdcage Center next to Noodles and Company, with a projected opening date in the second quarter of 2024.

Another new business, doing business as Flawless Fix is listed to fill suites B-111-112 just behind Bath and Body Works. No opening date has been set for Flawless Fix.

In a statement to the Business Journal, HomeGoods spokesperson Arielle Abramek confirmed a Citrus Heights store "will open in the future," as did Kathilynn Carpenter, executive director of Sunrise MarketPlace in an email.

HomeGoods is one of the retail chains owned by Framingham, Massachusettsbased The TJX Companies Inc.

Marketplace at Birdcage, built in 1975, is anchored by businesses such as Walmart Neighborhood Market, Best Buy, Old Navy, Michaels, Barnes & Noble and Chuze Fitness. The center spans more than 325,000 square feet, according to leasing materials

Sacramento Tall Club Memorial Scholarship Available

SACRAMENTO REGION, CA (MPG) - Members of the Sacramento Tall Club (STC) affiliated with Tall Clubs International (TCI) are seeking outstanding eligible high school seniors throughout Sacramento, Yolo, Placer and El Dorado counties to apply for their competitive annual 2022-23 academic scholarship.

The number of submitted scholarship applications dropped off last year, said STC Club President Harry Lehman of Orangevale. STC did not award a local scholarship for the 2021-22 school year.

"We wanted to take an extra step to reach out to all high school districts throughout our region in a focused direct mail effort, and through the media to make sure that both public and private schools received this year's application materials in a timely manner.

"We recognize that the potential pool of eligible scholarship candidates across the Northern California region is quite large, and we wanted to take all steps possible to encourage high school seniors to apply."

TCI divides California geographically into four scholarship areas with membership of the Sacramento Tall Club responsible for student scholarship applications in some 29 inland counties, large and small, north to the Oregon border, Lehman said.

Locally, STC has provided scholarship materials to high schools in the San Juan Unified School District serving Citrus Heights, Folsom, Rancho Cordova, and Sacramento city and county high schools.

application process is now completely entirely online," Lehman said.

Individual applicants can upload their application, current high school transcripts, reference letters, and personal photo to the TCI scholarship website at www. sacramentotallclub.org/scholarship starting January 1st where they will receive an immediate receipt email acknowledgment of their application and responses to any direct questions which they may have. Lehman said. STC scholarship applicants may also contact scholarship@sacramentotallclub with additional questions or for more information.

A complete summary of STC scholarship application guidelines, sample essays and photos of current and past winners are also posted on the club website.

Every year, the Sacramento Tall Club awards academic scholarships to qualified and talented high school seniors who meet the tall club height requirements (at least 5'10" for women and 6'2" for men.) The annual STC scholarship award is dedicated in memoriam to former TCI and STC members, many of whom were big supporters of young scholars and their many talents and merits. Scholarship amounts can vary year to year.

Local Sacramento Tall Club (STC) scholarship winners also compete for annual scholarships awarded by both Tall Clubs International (TCI) and by the non-profit Tall Clubs International Foundation. Annually, the TCI foundation awards scholarships of up to \$1,000 each.

While grade point average and test scores are especially important scholarship criteria, so too are participation in school activities and community involvement.

General membership in the social Sacramento Tall Club is open to men that are over six feet and women that are nearing that mark.

The 2023 STC scholarship winner will be notified later in March 2024 by the club membership.

All signed STC scholarship applications should be submitted with a good headshot photo, preferably a senior graduation photo. Partial applications submitted online are not accepted, Lehman said.

Spiritual Care **BY NORRIS BURKES**

Before my retirement as a healthcare chaplain, I was privileged to hear the prayers of patients who were hurting, sick and discouraged. They were heavenly appeals that I wanted to share with you, but patient privacy prevented that.

However, in many cases, patient families recorded their prayers in the public journal of our hospital chapel. The journal was a spiral notebook on the altar where visitors wrote anonymous requests.

I recently rediscovered some of those requests that I feel comfortable sharing with you now.

As you read these collected prayers, I encourage you to do two things. First, recall similar situations where God answered your prayers and granted his grace. Second, I ask you to offer your own prayer for these writers.

Some of the prayers are simple one-liners, like the short prayer of a child asking, "Lord, help me to be a football player." But most are deeply moving entreaties searching for healing, acceptance and understanding.

One of the writers was earnestly searching for meaning:

"God, or whoever,

"I don't know if there is a Creator/God. I only know that my day to leave this life will come. I just hope that the memories of my mother and father will be with me just like my parents were with me the day I was born. If there is a Creator/God, he/ she will know that I tried to live my life with a clean heart." Some of the petitioners, like this one,

were clearly scared:

"I need your guidance now. I don't have my mom anymore, so my dad and I are lost. My son and his wife have a sick baby girl. I need you to help us. Please hold my family tight. I love you, dear Father.

"In the name of the Father and Holy Spirit."

Other prayers showed a struggle that no

one wants to face: "Dear Lord.

"Mom's accident crossed your desk and you approved it. Now we have to turn off the ventilator. It's the hardest decision this family has ever made. My sister is hanging on with vain hope. Please help her see the truth and let mom go.

"Mom is your child, Lord. I know she has a mansion waiting for her. The rest of us have peace about letting her go. Please pass that peace on to my sister. Time is a factor, Lord. Finances are a factor, too.

"The life she's living now isn't life. It isn't fair to mom to have to be like she is. Please help my sister to understand that we are all suffering. Give our family the strength to cross this bridge and give mom a peace that only you can give.

Amen.'

One writer, likely a caregiver, compared her pain to that of her patients. She expressed the guilt many of us feel when seeing our problems in the light of the tragedy experienced by others:

"Dear God,

"No one I know is dying or suffering, so I need to stop being a baby about my problems. I should be praying for those who truly need love and support. I'm going through a divorce, and I feel depressed all the time. However, I'm grateful for my health, friends and family.

"Please help me overcome this feeling of anguish, loss, anxiety and jealousy. It's not good for my health, and I'm unable to help my patients who truly need it.

"Thanks for listening. "Amen."

Finally, the last page of these col-

lected prayers offers a benediction for this "To anyone who reads this:

I hope God answers all your prayers in

the New Year. The Lord is good!

California's Push For Labor Laws Can **Have Negative Consequences For Workers**

When the federal government and state governments passed laws governing wages, working hours and other workplace conditions prior to World War II, agricultural labor was exempted.

Many years later, after the 40-hour work week became standard, California's Industrial Welfare Commission decreed that farmworkers could work up to 10 hours a day or six days a week before overtime pay kicked in. In 2016, however, years

of lobbying by unions and other groups finally paid off when the Legislature decreed that the eight-hour day and 40-hour work week for agricultural labor would be phased in. Then-Gov. Jerry Brown signed the legislation, Assembly Bill 1066, despite warnings from farm groups that it would disrupt their industry.

Recently, the University of California's Cooperative Extension branch, which researches agricultural issues, released a study indicating that having a 40-hour work week has not been as beneficial to farmworkers as its sponsors promised. Alexandra Hill, an

assistant professor at UC Berkeley, concluded that many workers who had hoped for a cornucopia of overtime pay saw their

incomes reduced when employers limited them to on farm labor, unions and 40 hours a week. Her study found that many workers experienced reductions in the \$100-\$200 range each week because farmers could not automatically pass on overtime costs to their

customers. "It's really important to think carefully about how we can best implement policies that really benefit the people that we're trying to (help)," Hill told The Sacramento Bee.

Hill's research exemplifies the phenomenon of unanticipated consequences that often afflicts political actions. Legislators may have thought they could help farmworkers by giving them a 40-hour workweek but failed to consider the potential downsides when applied in the real world.

In recent years, the Legislature has been particularly prone to passing laws affecting workplace conditions – not surprisingly, given the close relationship between the Capitol's dominant Democrats and labor unions, which seek benefits they are unable to achieve in unionization drives or negotiations with employers.

The most spectacular example was 2019 legislation that severely limited employers' ability to use contractors, in effect converting several million workers to payroll employees.

Hill's study was released just months after the Legislature had set new minimum wages for the fast food and medical care industries, \$20 per hour for

the former and \$25 for the

latter, to dampen threats of

ballot-box wars.

As with the 2016 law other advocates of the new minimum wages said they would lift workers in the affected industries out" of poverty.

"Today California is putting a stop to the hemorrhaging of our care workforce by ensuring health care workers can do the work they love and pay their bills – a huge win for workers and patients seeking care," Tia Orr, executive director of SEIU California, told CalMatters.

However, there will be real world impacts.

Fast food franchisees will adjust by hiring fewer workers, raising prices or adopting more technology, such as the self-serve kiosks now common at McDonald's.

One effect of the health care wage bill has already surfaced. When it was passed, legislators were not given any estimates of the financial impact, but after Gov. Gavin Newsom signed the measure, his administration said it would cost the state budget, which has a \$68 billion projected deficit, about \$4 billion a year split 50-50 between state and federal taxpayers. And that doesn't include the multibillion-dollar impact on private health care providers and insurers. On one level, it's per-

fectly understandable why politicians would like to raise wages for some of the state lowest paid workers. But they shouldn't ignore the potentially negative effects of their actions. Dan Walters has been a

Arrest Made in Homicide on Georgia Drive in North Highlands

SACRAMENTO COUNTY, CA (MPG) - At approximately 1:15 PM on Wednesday, December 13, 2023, Sacramento County Sheriff's Deputies assigned to North Patrol responded to a residence on Georgia Drive in North Highlands regarding a fight involving 30 people and possible shots fired. Upon their arrival, they contacted several individuals who indicated a male was shot but had been transported to the hospital by family members or friends.

Shortly thereafter, Deputies learned that the victim, described as a 33-yearold adult male, had been transported to a local hospital with a gunshot wound. The victim was pronounced deceased at the hospital a short time later.

Sheriff's Homicide Detectives and Crime Scene Investigators responded to the scene, interviewed witnesses, and gathered evidence. Based on their investigation, Detectives determined that the victim and his girlfriend were involved in an argument with her ex-boyfriend, later identified as 30-year-old Jarell Triplett, regarding child custody arrangements. During the argument, Triplett shot the victim and fled the scene.

At approximately 10 AM, Detectives from the Sheriff's Major Crimes Bureau located Triplett in the Sacramento area and took him into custody without incident. Triplett was booked into the Sacramento County Main Jail and is ineligible for bail. He is scheduled to appear in court on December 18, 2023 at 3 PM. ★

"Our personnel work through the holidays to help ensure people arrive safely at their destinations," said CHP Commissioner Sean

Duryee. "The goal is to maintain a safe environment on California's roads, which is achievable when all motorists make responsible decisions behind the wheel."

> In addition to assisting drivers and looking for traffic violations, such as failure to wear a seat belt, speeding, and

distracted driving, CHP officers will be paying close attention to people suspected of driving under the influence of drugs and/or alcohol. During the last New

Year's Day MEP, CHP officers made 570 DUI arrests statewide.

As we close out 2023, avoid becoming a statistic. Have a plan and designate a sober driver or use ride-share services, avoid distractions while driving, and always wear your seat belt. If you see or suspect an impaired driver, call 9-1-1 immediately. Be prepared to provide the dispatcher a description of the vehicle, the license plate number, location, and direction of travel. Your phone call may save someone's life.

Sacramento Public Library Puts Out Call for Artists

SACRAMENTO, CA (MPG) - The Sacramento Public Library (SPL), which has 29 locations spanning from Orangevale to Isleton, recently announced its new Parks and Tranquility project. With the intention of bringing visual and performing arts to a selection of the region's many outdoor spaces, artists are invited to apply for grant awards that range from \$5000 - \$10,000.

"We will engage and collaborate with community members, community-based organizations, and arts and justice collectives," states the official website, "to create site-specific art and educational experiences at multiple California State Park sites around Sacramento County."

A schedule of the public events developed through the Parks and Tranquility program are expected to be announced in early 2024.

The idea to bring the arts into parks and other outdoor spaces was inspired by the California State Library's statewide Parks Pass program. This program allows any California resident with a library card to borrow free passes to approximately 200 state parks. SPL specifically was granted funds to identify and create art installations to complement these passes. While any artist may apply, selected projects should carry one of the specific themes being prioritized by

the library.

According to Ricardo M. Ramirez, the system supervisor of SPL, these themes include a project goal to "generate positive measurable impacts in the areas of health, natural resource stewardship, and historical and cultural connections with an equity lens."

"SPL will engage and collaborate alongside our Sacramento community members, community-based organizations, and arts and culture collectives on arts and recreational equity experiences

that include community events and field trips," Ramirez also

Selected artists will work with a special project team that consists of both library staff and community members. The original visual artwork will be featured at pre-selected California state parks, while other artists will prepare and execute community workshops featuring their art discipline.

"All types of art mediums are eligible," said Ramirez. "We encourage a wide range of artists and all levels of experiences to apply for these grants. We are fortunate to be in a dynamic and lively arts community, and are continually inspired by what we see, hear, and experience. We plan to curate a number of public programs that will incorporate the work of the selected artists that reflect our communities and the joy of being in natural spaces."

While any type of artist is welcome to apply, it is with the understanding that their art form may be converted to accommodate

a realistic outdoor art installation. A watercolor or acrylic painter, for example, may complete their piece and see it converted into a more durable digital print. Dancers should expect to accommodate an outdoor learning or performance space in lieu of a traditional indoor studio.

In order to be eligible for the Parks and Tranquility grant, applicants must be a resident of the Sacramento region and aged 16 or older. Applicants cannot be currently employed by SPL, and should be eligible to receive taxable income. The selected artist(s) must also be available for public events and installations related to the finalized artwork at the select

The grant application and selection process is a quick turnaround — applications are due by December 30th, and artists will be notified by the end of January. Time is of the essence for those artists wishing to be considered. With all levels of experience welcome to apply, SPL understands there will be questions. These remedies shall be in addition to any other remedies authorized by law.

California Slips in National **Ranking of Judicial Hellholes**

NFIB California News Release

SACRAMENTO, CA (MPG) - The American Tort Reform Foundation today released its latest Judicial Hellholes report showing California now the third worst jurisdiction in the nation, a two-place drop from its previous perch at No. 1 in last year's report. "It's nice to see California drop a few

rungs on the Judicial Hellholes ladder," said John Kabateck, California state director for the National Federation of Independent Business (NFIB), the state's leading small business association. "But it wasn't because our Legislature tried. Business owners, especially small business owners, still are in the crosshairs of the most egregious PAGA, Prop. 65, ADA, and now Consumer Privacy Act lawsuits, which give trial attorneys full rein to sue Main Street employers."

PAGA, the Private Attorneys General Act, comes in for justified criticism in the Judicial Hellholes report, the California section of which begins on Page 30, but just as troubling is the "Trial Lawyers' Newest Statutory Gold Mine" section (Page 33), which forewarns:

"On January 1, 2023, the California Privacy Rights Act of 2020 (CPRA) went into effect. This Act replaced the California Consumer Privacy Act (CCPA) and addressed some of the CCPA's ambiguities. It eliminates a business' 30-day window to cure, grants new rights to consumers, and increases business's

contractual obligations. It also creates the California Privacy Protection Agency to enforce the CPRA, which will fine businesses \$2,500 for violations and \$7,500 for intentional violations and those involving a minor. While the Act took effect in 2023, it applies to data collected beginning on January 1, 2022. In July, California Attorney General Rob Banta announced that his office was doing an 'investigative sweep' of all large employers in the state to ensure they are in compliance with the Act. Apart from the attorney general investigations, consumers can sue for cash awards following a data breach without proving an actual injury, making it easy for trial lawyers to bring massive class actions. The law also provides for treble damages and attorneys' fees, creating a large incentive for the plaintiffs' bar to file lawsuits."

From the Executive Summary, "Endless Prop-65 litigation targets a variety of industries and no-injury Private Attorney General Act (PAGA) and Americans with Disabilities Act (ADA) accessibility lawsuits bog down business. The state's unique Lemon Law is a gold mine for plaintiffs' lawyers and arbitration is under attack in both the courts and the legislature. California also is at the forefront of the environmental litigation battle."

Area Doctor Charged with Distribution and Possession of Child Pornography

SACRAMENTO, CA (MPG) - A federal grand jury returned a two-count indictment on Thursday, November 30, 2023 against Khursheed Haider, 48, of Roseville, charging him with distribution of child pornography and possession of child pornography, U.S. Attorney Phillip A. Talbert announced.

According to court documents, Haider, a Sacramento Area pulmonologist, used an application called Wire to post, distribute, and request child pornography that included videos and images of prepubescent boys and girls being sexually abused. After a search warrant was executed, agents discovered additional prepubescent child sexual abuse material on one or more of Haider's electronic devices.

This case is the product of an investigation by the Federal Bureau of Investigation. Assistant U.S. Attorney Alexis Klein is prosecuting the case.

If convicted of distribution of child pornography, Haider faces a mandatory minimum sentence of five years in prison, a maximum statutory penalty of 20 years in prison, a lifetime of supervised release, restitution, and a \$250,000 fine. If convicted of possession of child pornography, Haider faces a maximum statutory penalty of 20 years in prison, a lifetime of supervised release, restitution, and a \$250,000 fine Any sentence, however, would be determined at the discretion of the court after consideration of any applicable statutory factors and the Federal Sentencing Guidelines, which take into account a number of variables. The charges are only allegations; the defendant is presumed innocent until and unless proven guilty beyond a reasonable

This case was brought as part of Project Safe Childhood, a nationwide initiative launched in May 2006 by the Department of Justice to combat the growing epidemic of child sexual exploitation and abuse. Led by the United States Attorneys' Offices and the Criminal Division's Child Exploitation and Obscenity Section, Project Safe Childhood marshals federal, state, and local resources to locate, apprehend, and prosecute those who sexually exploit children, and to identify and rescue victims. 






SACRAMENTO COUNTY, CA (MPG) -

On Thursday, December 14, 2023, Sacramento County Supervisor Patrick Kennedy cut the ribbon on the County's second Safe Stay Community for people experiencing homelessness. The sleeping cabin-style shelter campus has a capacity of 56-34 single cabins and 11 double occupancy cabins and was approved by the Board of Supervisors in June 2022. The Safe Stay is located at 7001 East Parkway, in the parking lot of the County's Department of Health Services.

"I'm thrilled to open up a second Safe Stay Community in my district." Said District 2 Supervisor Patrick Kennedy "We've already had really positive results at our first location – both for the guests and the neighborhood, that I'm hopeful we'll see an immediate impact once this opens next week."

WHAT CAN GUESTS EXPECT?

On-premises guests can use the bathroom and shower trailers, laundry services and eat three meals a day in the common area. The campus also has a pet relief area, a computer lab, an entertainment space, employment development and housing-focused case management. Guests will also connect with transportation resources for off-site needs such as medical appointments or jobs.

Each cabin is outfitted with a bed that folds down from the wall, two storage containers, basic toiletry supplies, a desk and chair, overhead light, HVAC, power outlets, smoke alarm and fire extinguisher and a locking door. Cabins also have enough space to accommodate a dog bed or pet crate. The campus has storage containers for possessions that do not fit in the sleeping cabins.

The East Parkway Safe Stay community is operated by City Net. City Net is also running the County's first Safe Stay

Community on Florin and Power Inn. The Florin Safe Stay opened in August 2023, has served 137 people, 32 pets and had five people exit to permanent housing.

HOW ARE GUESTS REFERRED?

The East Parkway Safe Stay Community is currently a closed referral process, through homeless services providers engaging with people living outside near the shelter. Existing street outreach providers will engage with people living outside to evaluate what services and shelter programs they are eligible for and that will best meet their needs.

People experiencing homelessness and looking for shelter resources should contact the Housing Crisis Line by calling 2-1-1 and pressing 8 or the toll-free number at 1-844-546-1464.

HOW CAN THE COMMUNITY GET INVOLVED?

City Net accepts in-kind donations by appointment only. To schedule a donation drop-off or volunteer, email getinvolved@citynet.org.

Board Approves Regulations for Converting Wastewater to High Quality Drinking Water

State Water Resources Control Board News Release

SACRAMENTO, CA (MPG) - Further advancing the Administration's all-of-the-above Water Supply Strategy to make California more resilient to hotter, drier conditions, the State Water Resources Control Board approved regulations on Dec. 19, 2023, that will allow water systems to develop treatment protocols to convert wastewater into high quality drinking water.

drinking water.

The board's unanimous vote gives California the most advanced standards in the nation for treating wastewater to such an extent that the finished product meets or exceeds current drinking water standards. Known as direct potable reuse, the process will enable water systems throughout the state to generate a climate-resilient water source while reducing the amount of wastewater discharged to rivers and the ocean. In fact, recycling water allows water systems to add millions of gallons of additional drinking water to their supplies over time while avoiding costlier and more energy intensive water supplies.

"This is an exciting development in the state's ongoing efforts to find innovative solutions to the challenges of extreme weather driven by climate change," said E. Joaquin Esquivel, chair of the State Water Board. "On top of helping us build drought-resilient water supplies, direct potable reuse offers energy savings and environmental benefits. And most importantly, these regulations ensure that the water produced is not only safe, but purer than many drinking water sources we now

rely on."

The final version of the regulations came

together over many years and after an expert panel of 12 scientists and engineers evaluated work by the board's Division of Drinking Water and determined the standards are protective of public health. Proposed regulations were released to the public in July; board staff gathered public comment and made adjustments based on that input. These revisions include added flexibility for alternative treatment techniques and clarifications about the collaboration among partner agencies on reuse

Direct potable reuse relies entirely on immediate, multi-barrier treatment that can recycle wastewater to drinking water standards in a matter of hours. This contrasts with the method currently being deployed in major projects launched throughout the state, called indirect potable reuse, which further improves treated wastewater over time through groundwater recharge or dilution with surface water. While no formal direct potable reuse projects could be initiated in California until the regulations were adopted, water agencies in Santa Clara, San Diego and the city of Los Angeles have launched pilot projects in recent years.

The newly adopted regulations comply with California's Safe Drinking Water Act, which ensures that the water delivered by public water systems in California shall at all times be pure, wholesome, and safe to drink.

Once the new regulations are finalized through the Office of Administrative Law in 2024, water systems can submit plans for direct potable use projects to the board for approval.

Social Security Matters *I'm 65 and Working;*

Can I Collect Ex-spouse Benefits?

Dear Rusty: I turned 65 earlier this year, and I still work full time. I was divorced four years ago after 38 years of marriage, but my ex-husband has been collecting Social Security for at least 10 years now. Can I start collecting Social Security and still work full time? And can I collect my ex-husband's amount if it is more than mine (and what is the best way to achieve this)? When I went to my local SSA office, they said they had no way of knowing that. Signed: Working Divorcee

Dear Working Divorcee:
Although you are eligible to claim Social Security at age 65, because you are working full time you may wish to wait a bit longer to do so. That's because Social Security has an "earnings test" which applies to anyone who collects benefits before full retirement age, and you have not yet reached yours.

The earnings test imposes a limit on how much you can earn before SS takes away some of your benefits. If you exceed the annual earnings limit (\$22,320 for 2024), Social Security will want back \$1 in benefits for every \$2 you are over the

limit and you will need to repay that, usually by having future benefits withheld. If you significantly exceed the limit, you may even be temporarily ineligible to receive SS benefits until you either earn less or reach your full retirement age (FRA) of 66 years and 8 months. So, if your earnings from working will significantly exceed the annual earnings limit (which changes yearly), it's likely that your wisest move would be to wait longer to claim your Social Security. As a bonus for doing so, your monthly payment will have grown and will be higher when you claim later. The earnings test no longer applies after you reach FRA.

Regarding benefits from your ex-husband, you cannot collect his instead of yours. What you may be able to do, when you claim your own benefit, is to get an additional amount which brings your monthly payment up to 50% of his. In order for that to happen, you would need to satisfy the following criteria:

- You are not currently married.
- The personal benefit you are entitled to at your FRA must be less than 50% of your ex-husband's FRA entitlement.

If the above are true, when you claim your own SS retirement benefit you will also get a "spousal boost" to bring your payment up to what you're entitled to as an ex-spouse. The amount of the spousal boost, if you claim Social Security at your FRA, will be the difference between half of his FRA entitlement and your FRA entitlement. If you claim your benefit before

your FRA, not only will your own benefit be reduced for claiming early, but the amount of your spousal boost will also be reduced (benefits claimed before FRA are always reduced).

Whenever you decide to claim Social Security, you will be automatically deemed to be filing for benefits from your ex-husband as well (you shouldn't need to apply separately). You've already satisfied the basic criteria of at least 10 years married to get benefits from an ex-spouse and, if you satisfy the above criteria as well, you will be entitled to a spousal boost when you claim. But your current earnings from working full time will likely affect your eligibility to collect Social Security benefits at this time, so waiting until your full retirement age to claim may be your best choice.

If you will only slightly exceed the annual earnings limit you can consider claiming earlier, as long as you are comfortable with receiving a permanently reduced amount, and the prospect of not getting benefits for a number of months if you exceed the earnings limit (the number of months you will go without benefits depends on how much you exceed the limit by)

Citrus Heights Man Arrested for Actions During Jan. 6 Capitol Breach

WASHINGTON, DC (MPG) - A California man has been arrested on felony and misdemeanor charges related to his conduct during the breach of the U.S. Capitol on Jan. 6, 2021. His actions and the actions of others disrupted a joint session of the U.S. Congress convened to ascertain and count the electoral votes related to the 2020 presidential election.

Kyle Travis Colton, 36, of Citrus Heights, California, is charged in a criminal complaint filed in the District of Columbia with a felony offense of obstruction of law enforcement during civil disorder and misdemeanor offenses of entering and remaining in a restricted building or grounds, disorderly and disruptive conduct in a restricted building or grounds, disorderly conduct in a Capitol building or grounds, and parading, demonstrating, or picketing in a Capitol building.

Colton was arrested on Dec. 15, 2023, in Folsom, California, and made his initial appearance in the Eastern District of California.

According to allegations contained in court documents, Colton was identified on closed-circuit video (CCV) footage taken from within the United States Capitol building on Jan. 6, 2021, taking pictures in the Capitol with what appeared to be a mobile telephone. Colton was later identified among a crowd of rioters in the Capitol Rotunda engaged in a physical confrontation with law enforcement officers.

Body-worn camera footage taken from Metropolitan Police Department (MPD) officers in the Rotunda revealed Colton failing to obey orders given by law enforcement officers to leave the Rotunda. Instead, Colton stood in line as rioters continued confrontations with police officers.

Court documents say that officers then initiated crowd-clearing measures, including forming a police line, giving loud verbal commands, and using batons to move persons toward the exit door. However, Colton only moved when the crowd was physically pushed towards the exit and remained standing side-by-side with other rioters who were combating law enforcement officers. At one point, Colton grabbed a flagpole that a rioter was using to assault an MPD officer. Colton gained control of the flagpole, which the officer had also grabbed, and then gave it back to the rioter, who then fled into the crowd of rioters with the flagpole.

Colton exited the Capitol building at approximately 3:30 p.m.

This case is being prosecuted by the U.S. Attorney's Office for the District of Columbia and the Department of Justice National Security Division's Counterterrorism Section. Valuable assistance was provided by the U.S. Attorney's Office for the Eastern District of California.

This case is being investigated by the FBI's Sacramento and Washington Field Offices. Valuable assistance was provided by the U.S. Capitol Police and the Metropolitan Police Department.

In the 35 months since Jan. 6, 2021, more than 1,230 individuals have been charged in nearly all 50 states for crimes related to the breach of the U.S. Capitol, including more than 440 individuals charged with assaulting or impeding law enforcement, a felony. The investigation remains ongoing.

A complaint is merely an allegation, and all defendants are presumed innocent until proven guilty beyond a reasonable doubt in a court of law.

Sac Diocese to Seek Bankruptcy Protection, Facing over 250 Sexual-Abuse Cases

- The Roman Catholic Diocese of Sacramento will seek Chapter 11 bankruptcy protection next year, Bishop Jaime Soto announced on Dec. 9, as it faces hundreds of lawsuits alleging child sexual abuse by clergy. The diocese oversees Catholic parishes in much of Northern California, including Sacramento County.

In a letter published online and distributed to parishioners at local churches, Soto said he expects to file for bankruptcy protection in March 2024.

"It is now clear to me that the only respectful, transparent, and fair way to address the substantial number of claims by those who have been abused by clergy and other members of the Church is to seek a court-supervised reorganization. This process will also allow me to sustain the sanctifying, teaching, and charitable work of the Catholic community in Northern California," the letter read.

Chapter 11 bankruptcy protection generally allows an organization to continue operating while negotiating with creditors to restructure its debts. The letter noted as much and said parishes and schools in the diocese "would continue their operations uninterrupted."

Soto said more than 250 lawsuits alleging abuse have been filed against the diocese. Without reorganization, "it is likely that not all the abuse victim-survivors would receive a fair consideration of their claim," he said, with available funds being "depleted" in the first

cases brought forward.

"Bankruptcy is a costly and lengthy process, but it also provides supervision and transparency for all the parties involved so that a fair resolution is offered to the victim-survivors of abuse," Soto continued. He expressed hope that the diocese would "emerge from this necessary, penitential exercise with greater resolve to be a humble sanctuary of holiness and healing for all the sons and daughters of God in Northern California."

Law Group Decries Plan

A law firm that represents people alleging clerical abuse, including cases in the Sacramento diocese, criticized the decision.

"On behalf of the many survivors who were gravely hurt, we react with deep disappointment in the choice made by the Bishop of Sacramento to seek bankruptcy protection from accountability," Jeff Anderson and Associates said in a press release. "We know from all the work

we have done with survivors across the country that bishops and dioceses have continuously utilized Chapter 11 to shamefully protect themselves."

The release said other dioceses have used bankruptcy filings to delay court cases and prevent "full disclosure."

"The Diocese might change, but their motivations for filing bankruptcy remain the same – the desire to protect their reputation and their assets, no matter the moral expense," attorney Jeff Anderson said in a statement.

The Sacramento diocese is the fourth in California to seek bankruptcy protection after a wave of sexual-abuse claims under state Assembly Bill 218. The legislation took effect in 2020 and extended the statute of limitations on childhood sexual abuse, allowing much more time for accusers to come forward after reaching adulthood.

The other dioceses filing for Chapter 11 protection are Santa Rosa, San Francisco and Oakland. ★
