Highway Patrol Gets New Officers

SACRAMENTO, CA (MPG) - Many people spend years begrudging the California Highway Patrol because they were pulled over by a CHP Officer for some reason they did not feel was warranted. But after attending one of the graduations at the California Highway Patrol Academy in Sacramento, one might easily hold feelings of respect and honor

Every facet of the program was succinctly orchestrated from being directed where to park to lining up to enter the event Guests were greeted professionally with a genuine smile by blue-shirted cadets. Hundreds of family members waited in anticipation.

Upon entering the huge gymnasium with rows and rows of seats, one saw an entire wall of 4 x 8-feet photos of pictures—each portraying a different division of the service including SWAT Team, Mounted Horse Patrol, Academy Instruction, Road Patrol, Air Operations, Motor Officer, Motorcycle and Bicycle Patrols. What they didn't show was task force members. Headquarters and Division Personnel uniformed and Nonuniformed, Dispatchers, Auto Theft Task Forces, Commercial Enforcement Personnel, K-9s and more.

"There have been thousands of officers in this place," said Jim Ward, a retired CHP Officer who lives in Dixon. "But, it is far from routine. This is extraordinary. You are seeing less than 3-percent of those who actually apply."

Ward served for 16 years on the Santa Ana freeway before moving to northern California duties.

Soon after the families and friends were seated, nearly 100 men and women marched into the California Highway Patrol Academy graduation ceremony with eyes straight ahead and showing serious faces wearing the traditional CHP uniform symbolizing authority and professionalism: the camel-colored pants, olive green jacket, and the cream-colored Trooper hat.

Commissioner Sean Duryee opened the ceremony and spoke about CHP training which is revered worldwide and consists of a regulated system of academics, exercise, diet, and self-discipline. Those honored had just completed Continued on page 3

In his varied career, Gregg was a news reporter and anchor at KFBK and KGO Radio, a public information officer at SMUD and the California Independent System Operator (California ISO), and communications coordinator for the California State Association of Counties. He currently works at Sacramento Regional Transit as the Sr. Community Relations Officer.

Gregg is an active volunteer with the Sacramento Tree Foundation and has led a neighborhood effort that has planted more than 2,000 new trees since 2001. He received an award from the MLK 365 organization for helping to make it easier to remove racially restrictive clauses from local property records. He is a 25-gallon blood donor and a frequent volunteer master-of-ceremonies for Project Ride in Elk Grove.

Gregg is a graduate of California State University, Sacramento with a bachelor's degree in journalism. He and his wife live in Arden Park and are the parents of two daughters.

First Snow Survey of the Season **Finds Below Average Conditions**

SACRAMENTO, CA (MPG) The Department of Water Resources (DWR) conducted the first snow survey of the season on January 2, 2023, at Phillips Station. The manual survey recorded 7.5 inches of snow depth and a snow water equivalent of 3 inches, which is 30 percent of average for this location. The snow water equivalent measures the amount of water contained in the snowpack and is a key component of DWR's water supply forecast. Statewide the snowpack is 25 percent of average for this date.

After one of the largest snowpacks on record last season, the start of this water year has been dry despite some recent storms in the last weeks of December that pro-

vided a small boost in the

snowpack. While state

reservoirs are still above average for this time of year and strong El Niño conditions are present in the Pacific Ocean, the outlook for the rest of the winter remains highly uncertain. "California saw first-

hand last year how

historic drought conditions can quickly give way to unprecedented, dangerous flooding," said DWR Director Karla Nemeth. "Although El Niño does not guarantee an above average water year, California is preparing for the possibility

of more extreme storms while increasing our climate resilience for the next drought."

DWR's electronic readings from 130 stations placed throughout the state indicate that the statewide snowpack's snow water Continued on page 3



Citrus Heights Rents Down 2.1% From Summer Peak



As 2023 came to a close, rent prices across the country continued on a downward trend that began in late summer.

CITRUS HEIGHTS, CA (MPG) - As 2023 came to a close, rent prices across the country continued on a downward trend that began in late summer. December saw rents fall 0.8% nationwide - marking the fifth consecutive month of declines. Today, the median monthly rent in the U.S. is down \$45 (3.2%) from the mid-year peak last August. Seasonality plays a role in these market fluctuations, with rents typically bottoming out around the end of the year before starting to regain ground. Now is the time when renters have the most sway in lease negotiations, but it likely won't be long before rents begin to trend up again. For the latest data, see our full January

First Snow Survey of the Season Finds Below Average Conditions

equivalent is 2.5 inches, or 25 percent of average for this date, compared to 185 percent on this date last year.

"While we are glad the recent storms brought a small boost to the snowpack, the dry fall and below average conditions today shows how fast water conditions can change," said DWR's Snow Surveys and Water Supply Forecasting Unit Manager Sean de Guzman. "It's still far too early to say what kind of water year we will have, and it will be important for Californians to pay attention to their forecasts and conserve water, rain or shine."

Last year, California experienced climate whiplash when the driest three year-period on record ended with extreme storm events in January and March that caused damage and flooding across the state. These extreme weather events highlight the need for all Californians to prepare for flood risk. DWR is working with tribal, federal, state, and local partners to provide flood resources and training to communities across the state.

The State-Federal Flood Operations Center (FOC) has pre-positioned flood fight materials at more locations across the state and is starting this winter with more supplies on hand, including 2.2 million more sandbags. This fall, DWR coordinated pre-flood season meetings with emergency response agencies across the state and organized 38 flood-fight trainings for city, county, state and tribal agencies to prepare for possible local emergencies.

One year ago, the January survey at the Phillips location showed a water content of 177 percent of average and was followed by a series of damaging atmospheric river storms in January and March that caused flood impacts across the state and produced one of the largest snowpacks on record.

In addition to deploying resources including over 1.9 million sandbags across the state last year, the FOC coordinated a joint state, federal and local response to snowmelt-driven flooding concerns and prepared for the historic snowmelt by providing hydraulic and hydrologic modeling and snowmelt forecasts that allowed agencies to deploy resources, reinforce levees and protect communities.

On average, the Sierra snowpack supplies about 30 percent of California's water needs. Its natural ability to store water is why the Sierra snowpack is often referred to as California's "frozen reservoir." Data from these snow surveys and forecasts produced by DWR's Snow Surveys and Water Supply Forecasting Unit are important factors in determining how DWR manages the state's water resources. Due to last year's above average conditions and historic snowpack, a total of 3.5 million acre-feet of water was captured in State Water Project (SWP) reservoirs. Lake Oroville, the SWP's largest reservoir, is currently at 130 percent of average to date and state water managers are prepared to capture and store as much water as possible.

the 6-month live-in Academy where their commitment meant missed birthdays, anniversaries, births of children, and holidays.

He told how they would receive their badge number and badge stating they would stay with them for life and talked about what each point of the star represents: character, integrity, judgment, loyalty, courtesy, honor, and knowledge.

"You've earned the right to wear it," he said. "That badge belongs to the people behind you. That badge represents the trust they have in you." He also spoke to the graduates about their futures. "The tragedies of others will become your daily routine. You will show empathy, take time to listen, give a shoulder to cry on, and show compassion.

Don't ever become cocky or arrogant. The moment you stop learning and growing, you start limiting your future."

Keynote speaker Barbara Rooney, California Office of Traffic Safety Director shared the wide variety of backgrounds that the graduates came from. There were a couple musicians, EMTs, and firefighters.

"Almost all branches of the military are represented here and 1st to 3rd and even 4th generations of officers in the family. There was a preschool teacher, marathon runner, private pilot, computer engineer, and even a juggler," she said. "Ten have received the Governor's Medal of Honor."

She reminded them they were all joining a 100-year-old agency created in 1929 to provide uniform traffic law enforcement throughout California, assuring the safe, convenient and efficient transportation of people and goods on its highway system.

"Now, there are 7,000 uniform personnel in our state with 40 million people," she said congratulating them.

The governor added his remarks through a televised message.

"I'm adding my voice to the chorus who honors you," said Governor Gavin Newsom. "We have the 5th largest law enforcement agency in the country and you have earned our respect and trust.

We extend our gratitude, thanks, and welcome."

A video presentation of the extensive training followed and the audience saw situational experiences where cadets were drilled on how to fight criminals and save lives.

Special recognitions were given for class officers, marksmanship, outstanding athlete, and most inspirational cadet. Afterwards, they lined in front of the buildings for the official 'badge pinning' while taking photos with proud spouses and family members. They will earn a generous base salary of \$109,248 during their first year plus full health and dental benefits for themselves and their families.

The ceremony is one of three per year and was closed with the entire graduating class reciting the Code of Honor with raised right hands swearing that they "would lay down their life rather than swerve from the line of duty."

Watch Soon

The CHP has just released to the public an inside look at its live-in training facility with this month's programming of the new reality series, Cadets. Premiering Jan. 17 on the CHP's YouTube page, the nine-part docuseries focuses on a cadet class navigating the six-month journey through the CHP Academy on the way to becoming officers.

"Cadets is not just a series; it's a testament to the CHP's commitment to excellence, diversity, and the relentless pursuit of transforming individuals from all walks of life into dedicated officers ready to serve the community," said the Commissioner Duryee. "We are excited to offer a start-to-finish look inside our Academy as future law enforcement officers are brought to life."

Viewers will "ride along" with nine cadets as they overcome physical and mental adversity throughout the journey to earning their badge and becoming a CHP officer. The audience will also hear firsthand from the cadets as they speak candidly about their experience.

"By sharing their experiences, in their own words, we hope to inspire more service-minded individuals to follow in their footsteps and join us for a rewarding career in law enforcement," added Commissioner Duryee.



Public Health Awarded Grant for Child Safety Seat Education

SACRAMENTO COUNTY, CA (MPG) - In our continued effort to enhance child safety on the road, Sacramento County Public Health (SCPH) has once again joined forces with partner agency Mercy San Juan to continue the successful car seat safety program. Aimed at educating parents and caregivers on the proper installation and use of child safety seats, this initiative is made possible through a \$78,546 grant generously provided by the California Office of Traffic Safety (OTS).

The grant, which funds an array of com-

•No-Cost Child Safety Seats for Families in Need: Families facing financial constraints will have access to child safety seats at no cost, ensuring that economic barriers do not compromise the safety of children.

•Community Outreach Efforts in Underserved Communities: Collaborating with local organizations, the program will actively engage in community outreach efforts to promote car seat safety in underserved areas.

Dr. Kasirye, the Sacramento County Public Health Officer, highlighted the essential role of OTS grant funding in assisting families, caregivers, and education professionals in ensuring children's safety. Emphasizing that safeguarding children is a collective priority,

NFIB Releases Top Five **Compliance Headaches for 2024**

SACRAMENTO, CA (MPG) - California's leading small business association today released its list of the top five compliance headaches hitting small business owners

"California small business owners are no different from their counterparts elsewhere in the nation in struggling to find qualified employees and in dealing with inflation," said John Kabateck, California state director for the National Federation of Independent Business (NFIB). "What does separate them from other small business owners in other states, however, is having to live with a Legislature that takes an almost sadistic delight in hamstringing them further with more and more regulatory compliance, and 2024 shows no letting up."

The five soon-to-be laws are:

SB 553 (Cortese) - Workplace Violence Prevention Plan. Effective July 1, 2024.

This bill requires employers to establish, implement and maintain a workplace violence prevention plan and record information in a violent incident log, the post-incident response and internal workplace violence injury investigation. The log must include: the date, time and location of an incident, a detailed description of an incident, a classification of who committed an incident, the type of incident, including whether an incident involved physical, verbal, sexual or animal attacks, the consequences of an incident such as medical treatment received, whether security or law enforcement was contacted and the contact information of the individual completing the violent incident log.

AB 2188 (Quirk) - Discrimination in Employment: Use of Cannabis. Effective January 1, 2024.

Passed last year but going into effect on January 1, 2024, this bill amends California's Fair Employment and Housing Act (FEHA) by making it unlawful for an employer to terminate, penalize or otherwise punish an employee for cannabis use outside the workplace. Existing law prohibits an employee from being impaired by cannabis in the workplace. One of the challenges for employers, however, is that since there is currently no

reliable testing method for determining if an individual is impaired by cannabis, the thresholding for proving such impairment is extremely difficult to meet.

SB 700 (Bradford) - Discrimination in Employment: Use of Cannabis. Effective January 1, 2024.

This bill amends California's Fair Employment and Housing Act (FEHA) by making it unlawful for an employer to request information from an applicant for employment pertaining to the applicant's prior use of cannabis unless obtained from the applicant's criminal history. Takeaway from a recent NFIB California Podcast guest: Don't ask about an applicant's cannabis usage history. (NFIB does not provide legal advice. For legal advice about compliance with these or other laws, we recommend consulting with an attorney or human resource specialist.)

SB 616 (Gonzalez) - Paid Sick Leave. Effective January 1, 2024.

This bill increases paid sick leave from three to five days a year. Paid sick leave can still be front loaded and the current accrual methodologies remain in place.

SB 848 (Rubio - Reproductive Loss Leave. Effective January 1, 2024.

This bill amends California's Fair Employment and Housing Act (FEHA) by making it unlawful for an employer to refuse to grant a request by an eligible employee to take up to five days of reproductive loss leave. The leave must be taken within a three-month window from the time of the loss. A reproductive loss event can include a failed adoption, failed surrogacy, miscarriage, stillbirth or unsuccessful assisted reproduction.

How Will California Respond To The Home Insurance Market Meltdown?

While Gov. Gavin Newsom and state legislators wrestle with a massive state budget deficit this year, a few blocks from the Capitol another crisis that could have far more impact on California families will be playing out.

Ricardo Lara, California's insurance commissioner, will be trying to dissuade companies that provide insurance coverage to millions of homeowners from fleeing the state. Citing heavy losses from disastrous wildfires and the potential for more destruction in the future, the largest insurers, such as State Farm and Farmers, have already cut back on new policies and renewals.

As a result, many homeowners in fire-prone regions have been forced into the state's last ditch insurance plan, called FAIR, which offers reduced coverage at high premiums, to protect themselves and comply with their mortgages.

The industry wants to include actuarial projections of future losses and the costs of reinsurance in their premiums. Neither factor is now allowed under regulations approved by voters more than three decades ago under a ballot measure that also made the insurance commissioner an elected official.

As the list of insurers reducing their exposure in California mounted last year, the Legislature briefly tried to come up with a revised regulatory process that would induce them to keep writing policies, but adjourned in September without action.

Newsom punted the crisis to Lara and he quickly laid out in broad terms new rules that would allow estimates of future losses to be folded into premium requests and hinted that including reinsurance might be approved. In return, Lara would require insurers to maintain at least 85% of their market in fireprone regions.

His announcement set in motion what could be a year of hearings and other processes to write new rules that would, in effect, modify much of the 1988 ballot measure that created California's highly regulated insurance system and strictly limited the factors that could be included in rate requests.

It has exacerbated a running feud between Lara and Consumer Watchdog, the organization that sponsored the 1988 ballot measure and has benefited handsomely from "intervenor fees" for participating in premium rate proceedings ever since. Consumer Watchdog has been highly critical of Lara throughout his tenure, and charges that his proposed systemic changes would be a sellout to the insurance industry.

"He's basically capitulated to the industry," Jamie Court, the group's president, said of Lara at one point. "There's not really much coming back for the consumer in here.

In response, Lara cites his duty to maintain a viable insurance market and accuses Consumer Watchdog of protecting its own financial interests.

"One entity is involved in nearly 75% of all interventions for rate approvals, materially benefiting from a process that is meant for a broader public participation," Lara responded to the allegations, adding, "throwing bombs is easy and putting out bombastic statements from entrenched interest groups doesn't benefit anyone."

Until the crisis, California's average homeowner premium was slightly lower than the national average.

There's no question that if Lara makes major changes to insurance regulation, homeowners' premiums will increase. In fact, last month, he approved a 20% premium increase for State Farm, which holds more than a quarter of the state's market and had announced a moratorium on new policies.

It's a trade-off, one that not only affects current homeowners but those who aspire to ownership and therefore must obtain insurance to obtain mortgages. Moreover, the availability of insurance for their potential customers affects developers who build and sell new homes.

As with the budget crisis, politicians cannot repeal the unwritten laws of economics. Ultimately, there's no free lunch.

National Average Price of Gas Projected to See Yearly Decline in 2024

GasBuddy News Release

DALLAS, CA (MPG) - GasBuddy, a PDI company, today released its annual Fuel Price Outlook with some good news for drivers: expect lower gasoline and diesel prices in 2024. The outlook highlights key trends in gasoline and diesel prices, forecasting that, after two years of above average gas prices, 2024 will bring relief at the pump for consumers as several factors contribute to less of a pinch at the pump. GasBuddy expects the yearly national average will drop from \$3.51 per gallon this year to \$3.38 in 2024.

Highlights from GasBuddy's 2024 Fuel Outlook:

Gas prices still could fall below a national average of \$3 per gallon this winter before starting to rise in late-February, getting close to \$4 per gallon as summer approaches, then mildly declining into summer, with hurricane season presenting uncertainty in late summer.

Drivers in some California cities could again briefly see prices above \$6 per gallon if major refinery issues develop during the summer, although most major U.S. cities will see prices peak at or slightly below \$4 per gallon in 2024.

Americans are expected to spend a combined \$446.9 billion on gasoline in 2024. Average yearly spending per household will fall to an estimated \$2,407, down 2% from 2023, and over 12% less compared to 2022.

Electric vehicles (EVs) and the 2024


presidential election have the potential to impact fuel prices in the year ahead, with a potential slowdown in the EV transition at stake.

Memorial Day will be the priciest 2024 holiday at the pump, with the national average price of gasoline expected to be \$3.56-\$4.04 per gallon on the holiday.

'As 2023 fades away, I'm hopeful those \$5 and \$6 prices for gasoline and diesel will also fade into memory," said Patrick De Haan, head of petroleum analysis for GasBuddy. "The global refining picture continues to improve, providing more capacity and peace of mind that record-setting prices will stay away from the pump in 2024. I anticipate that we'll still have some volatility, unexpected outages and disruptions, and potentially weather-related issues, but I do not expect it to lead to record prices. Offsetting OPEC+'s production cuts is contributing to the rise of U.S. oil production, which now stands at record levels. Combined with Canada, North American oil production could further stabilize countries that have decided to curb oil production."

The outlook forecasts the highest prices will be seen at the peak of the summer driving season in May, with the national average potentially rising as high as \$3.89 per gallon. More uncertainty is expected with hurricane season in late summer. Diesel prices are also predicted to fall incrementally from 2023, peaking at \$4.13 per gallon in March 2024.





Sadly, both my proofreader and my wife schoolteacher wife missed it this time.

I can't begrudge people their grammar peeves. My wife gets in a dither anytime she sees a misplaced apostrophe.

Recently, she let out a shriek while typing an email.

"What's wrong?" I asked, expecting a

I save my battles for people who insist on using what I call "comfort grammar." I call it that because it's used to comfort the

bereaved. The language consists of at least

four common phrases. 1. "Everything happens for a purpose."

When I hear this one, I want to scream, "Really? Is there a purpose for drunk drivers, tornadoes or incompetent medicine? I haven't found it.'

I think it's better to tell the grief-stricken person, "God is here. I am here. We will walk through this together."

2. "They are in a better place."

If you heard that after losing a son or daughter, wouldn't you want to ask, "Why is that better than being with me?" Or maybe you'd be ready to conclude, "Then I want to go there too!"

Maybe a better response would be, "Tell me about what you believe happens after

3. "I know how you feel."

I actually heard a woman say while commiserating with a new widower, "I know it's not the same thing, but I lost a dog once."

It's better to say, "I can't know how you feel, but I'd love to hear what she meant to you."

4. "God won't give you more burdens than you can handle."

Just one big problem with that comfort grammar – The Bible doesn't say that! The phrase is a poor paraphrase of 1

Corinthians 10:13 which is more accurately paraphrased as "God will not allow us to be tempted beyond our ability to escape." The verse refers to the temptation to steal,

lie or cheat. It has nothing to do with the number of tragedies we experience. This misquote will often burden people with a message that God "gives" them calamities. People who use this comfort grammar

aren't really trying to comfort the bereaved.

They are trying to wrap the tragedy into a neat box so they can assure themselves that it won't happen to them. The truth is that comforting grieving

people has nothing to do with saying the correct thing. It has nothing to do with your thoughts and prayers. Instead, it has everything to do with being present to those who

That's why I'm leaving you with this better alternative.

Don't speak. Just do.

Avoid the halfhearted offer, "IF there is anything I can do, just ask."

Don't make them ask. Just do.

At my father's funeral, my sister made a sign-up list for those who said, "If there's anything I can do....

"Yes," she said. "Here's our volunteer sign-up list."

Using the list, people agreed to answer phones, drive relatives to the airport or bring meals. One man agreed to mow my mother's lawn for a year.

Not everyone will know what to say to the anguished, so my best advice when you find yourself at a loss for words is this:

"Say little. Do much."

The doing will say more than you can ever imagine.



The Paid Sick Day Dilemma

California workers will be guaranteed five paid sick days a year starting Jan. 1, up from the three days that employers are currently required to provide, thanks to Senate Bill 616.

The bill, authored by Long Beach Democratic Sen. Lena Gonzalez, also extends protections against retaliation to workers who are in a union, but excludes provisions that would have granted railroad employees access to unpaid sick leave.

It was a significant, but partial victory for proponents, including

advocacy groups for families and women and dozens of unions. They originally sought seven days, but the final version was reduced in negotiations during the legislative process.

The California Work & Family Coalition hailed the law — one of several measures last session aimed at improving work-life balance — as "a commonsense change."

But trade associations representing various industries such as the California Grocers Association and California Hotel & Lodging Association, as well as chamber of commerce groups throughout the state, argued that the law would hurt small businesses that have not recovered from the pandemic, are now dealing with inflation and can't afford the additional cost of covering for sick workers.

The National Federation of Independent Business lists the new law among its top five "compliance headaches" for California's small business owners in 2024, along with SB 848, which makes it unlawful for employers to refuse as many as five days of "reproductive loss leave" for miscarriages, failed adoptions and other events.

The state Chamber of Commerce had the sick leave law on its "job killer" list and recently issued guidance for employers to navigate the law's complexities.

There's no federal law that requires employers to give workers paid sick leave. California became the second state in the nation to adopt a paid sick leave policy in 2014, but now provides less time than 15 states and many of its own cities, including San Diego, Los Angeles, San Francisco, Oakland and Berkeley.

Upon signing the bill on Oct. 4, Newsom said too many people were still having to choose between skipping a day's pay and taking care of themselves or their family members when they get

"We're making it known that the health and wellbeing of workers and their families is of the utmost importance for California's future," he said in a statement.

This isn't the first time a

sick leave expansion has been introduced, but the COVID-19 pandemic amplified the need. In March 2021, a new law required larger employers to provide as many as 10 more days for quarantines or vaccine side effects. But that benefit went away, along with federal tax credits that paid for it, six months later.

Social Security Matters

Will My Friend's Fiancée be Entitled to a Survivor Benefit?

Dear Rusty: I have a very good friend who has cancer and will begin chemotherapy this week. He is 71 years old and is currently receiving Social Security benefits. He has been living with his fiancée for a little more than 2 years, but they have been a couple for about 15 years and will be married in the next few weeks. She is 60 years old.

I am naturally concerned about his, and her, future so my questions are:

What, if anything, should he and his wife do to ensure that she gets his Social Security benefits?

What benefits will she be entitled to, and how soon will she be able to begin receiving them after his death? Signed: A Friend with Questions

Dear Friend: You are kind to be concerned about your friend and his fiancée. Here's what you need to know:

Social Security goes by state rules when it comes to what is often referred to as "common law marriage." That means that whether your friend's fiancée will receive any benefits as a surviving spouse in a "common law" relationship depends on whether they live in a state which recognizes common law marriage. Most states do not, but state laws have changed over the years and many states which once recognized such unions as "marriage" no longer do. Although they may have "been a couple" for 15 years, if your friend and his fiancée have been living together for only two it is likely only the last two years will count for Social Security benefit purposes. So, whether your friend's fiancée will get anything when your friend dies depends on where they live - unless they get married, in which case the rules are different.

In order for a married widow(er) to receive surviving spouse benefits, the couple must have been married for at least 9 months. If they marry and vour friend lives longer than 9 months thereafter, then his wife will be entitled to a surviving spouse benefit from her husband. The amount of his wife's benefit will be based upon the amount your friend is receiving at his death, adjusted for her age when she claims her surviving spouse benefit.

A surviving spouse can claim benefits from the deceased as early as age 60, but those benefits will be reduced for claiming before full retirement age (FRA). Taken at age 60, the wife's benefit would be 71.5% of your friend's SS benefit at his death. The wife need not claim the survivor benefit immediately; she could opt to delay claiming in order to get a higher percentage of the husband's amount. Survivor benefits reach maximum - 100% of the deceased's benefit amount - at the recip-

So, if your friend and his fiancée now live in a state which currently recognizes common law marriage (CO, IA, KS, MT, NH, SC, TX, UT, RI, or in the District of Columbia), then your friend's partner will be considered his "wife" and entitled to survivor benefits as normal (the fiancée would need to prove they cohabitate in a marriage-like relationship to claim benefits).

If they do not live in one of those states, but they get married and the marriage lasts for at least 9 months, then the wife will be entitled to normal benefits as a surviving spouse (as described above).

But if the couple do not live in one of the above states which recognize "common law" relationships, or if their soon-to-occur marriage doesn't last at least 9 months, or if they do not get married, I'm afraid your friend's partner will not be entitled to any survivor benefits from your friend.



Proponents Withdraw Referendum Challenging 2022 Fast-Food Worker Law

California Secretary of State News Release

SACRAMENTO, CA (MPG) - Secretary of State Shirley N. Weber, Ph.D. announced today that a referendum eligible for the November 5, 2024, General Election ballot has been withdrawn by the proponents.

The Attorney General's official title and summary of the referendum is as follows:

REFERENDUM CHALLENGING 2022 LAW AUTHORIZING CREATION OF COUNCIL TO SET MINIMUM WAGE AND WORKING STANDARDS FOR FAST-FOOD WORKERS. If the required number of registered voters sign this petition and it is timely filed, a 2022 law will not take effect unless approved at the next statewide general or special election after November 8, 2022. The challenged law:

-Authorizes creation of Fast Food Council (upon submission of 10,000 fastfood worker signatures) to set working standards and minimum wage (up to \$22/ hour in 2023, with capped annual increases) at fast-food restaurants with 100+ nationwide locations;

-Prohibits retaliation against fast-food workers for making certain workplace

Pursuant to Elections Code section 9604(b), proponents may withdraw a referendum at any time before the Secretary of State certifies it as qualified. As a result of the withdrawal, certain pro-

visions of Assembly Bill 1228 (Chapter 262, Statutes of 2023) become operative on January 1, 2024.





Evictions on the Rise

Eviction cases soared across California in the year after the last portion of a statewide moratorium lapsed, a CalMatters analysis of court data shows.

The elevated numbers - in some places beyond pre-pandemic levels — show a significant portion of renters remain at risk of losing their homes, despite the state's rollout of a \$5 billion rent relief program during the pandemic and a yearslong pause on many eviction cases that many landlords have said disrupted their businesses and income. A nationwide study published this year found increases in eviction filings are associated with slight upticks in the population of homeless people living in shelters.

The statewide moratorium was extended until June 2022 for those who had applied for rental assistance by March, barring evictions in cases where tenants had not paid rent and said they couldn't because of financial hardship wrought by the pandemic. The law didn't stop evictions completely thousands were still locked out under various exceptions — but it dropped cases to record lows. After it ended, a patchwork of local protections for tenants kicked in for cities that had passed their own eviction limits. which then phased out later in 2022 or earlier this year.

Recently obtained data from when the statewide moratorium was lifted through the summer of 2023 show that in a dozen of the state's most populous counties the average monthly eviction filings surpassed pre-pandemic averages.

Counties that extended local moratoria also are seeing waves of landlords seeking to remove

tenants, albeit delayed until after their own rules end.

The post-moratoria spikes could reverse a nearly decadelong trend of evictions falling, both in California and nationwide. While the overall number of eviction cases filed post-pandemic remains far lower than the peak years following the Great Recession, researchers and tenants' advocates said they were dismayed that while the moratorium and rental assistance kept eviction filings relatively low for about three years, those state interventions don't appear to have significantly blunted the number of evictions sought afterward.

'We're facing the eviction cliff we tried to prevent during the pandemic," said Tim Thomas, a sociologist and director of the Urban Displacement Project at UC Berkeley who analyzed the data for CalMatters. "Being back to normal this quickly is concerning."

Thomas attributed the wave of eviction filings to a combination of state and local moratoria expiring, inflation and the recent expiration of several other pandemic aid programs that kept families afloat, such as expanded food assistance and loosened eligibility to stay on Medi-Cal.

Landlords' groups say the yearslong moratoria gave property owners no recourse when tenants failed to pay rent even when the economy started to recover during the pandemic and said lasting rental debt from the pandemic is leading landlords to now be more aggressive in seeking evictions.

Landlords can only file for evictions over unpaid rent from the past 12 months, but that does not forgive old debt, and tenants' advocates say there's little to stop landlords from applying newly paid rent to old debt. The National Equity Atlas, a research group, estimates that as of

September, 605,000 California households owed a total of \$1.8 billion in back rent.

A state program that was open from March 2021 through March 2022 required landlords and tenants to apply for federally funded rental assistance to cover back rent from the pandemic before landlords could seek an eviction. But thousands who applied are still waiting for the aid to cover debts from that time period while the program appears to be on track to run out of money. Many landlords said they had trouble handling the program's red tape or had tenants who weren't approved for assistance for every month that they owed rent.

Tenants' advocates, however, also blamed recent rent increases for the high number of filings. Even in counties that haven't been governed by any eviction limits since last summer, cases filed remained above pre-pandemic averages more than a year later. Landlords who are subject to a 2019 rent cap law have been allowed to raise rent on tenants by as much as 10% this year, due to last year's record inflation, though some cities have stricter caps.

But in some counties including Sacramento, Los Angeles and San Mateo — the number of cases of tenants facing eviction increased this year by more than 10% compared to pre-pandemic levels, according to the CalMatters analysis. The highest leap was in Santa Clara County, where evictions filed in 2023 through August were more than 35% higher than in 2019, on

Eviction filings do not necessarily mean a tenant gets kicked out. But the court filing known as an unlawful detainer — starts a legal process with strict timetables that could result in a landlord being granted legal possession of the unit, allowing them to send a sheriff's deputy to perform a lockout.

The wave has swamped tenants' attorneys, most of whom work for understaffed legal aid organizations that represent low-income residents. Few tenants have attorneys in eviction court, compared to landlords who are represented most of the

The recent eviction case spikes put California in line with other Democratic states that extended tenant protections during the pandemic well beyond a federal moratorium, such as Oregon or Minnesota, Thomas said.

Kyle Nelson, a senior policy and research analyst at Strategic Actions for a Just Economy who has studied evictions in Los Angeles County, said based on how long it took for evictions to stabilize after the Great Recession, some counties should expect cases to remain elevated for years.

CalMatters obtained more than a year of data from courts in 19 of the state's most populous counties showing the number of eviction cases filed each month through August 2023, along with nearly a decade of corresponding historical figures compiled by the Judicial Council, the agency governing the state's court

In counties that did not extend additional local eviction protections after the state law expired, eviction filings began spiking the month before the statewide moratorium ended and reached their peaks in late 2022. But they remain elevated.

The court process allows for landlords and tenants to settle a case before it goes to trial, which could include a payment plan to avoid eviction or an agreement to leave. But tenants' advocates point

out there are numerous ways a tenant could also be "informally evicted," by moving out due to the threat of a court case. The filings data do not include those cases or show if a tenant moved out during a court case. Eviction cases are sealed from public view — but not if the tenant loses in court, making it more difficult for them to rent again.

Landlords' associations said most property owners only file for an eviction as a "last resort."

In eviction court in Sacramento one recent morning, tenants said the process felt designed to pressure them.

To avoid a trial, Keyarra Dunn made a deal with her landlord to stay in her apartment by agreeing to pay a portion of her back rent in the next four days, and the remainder — more than \$7,000 - in three and a half weeks.

Dunn, 23, said she knew of nowhere else to live if she and her four young children had to move out. She acknowledged that she had fallen behind on rent for at least four months, but said she was getting divorced, had been in and out of the hospital and spends much of her income as a car rental shop manager on childcare.

She said it would have helped to have had an attorney, and wasn't sure she could come up with the money in time. Because the settlement was made instead of a judge's ruling, it had all the force of a court order. If she can't keep her end of the deal, the eviction process would move ahead quickly in court.

"I felt like I had to," she said of making the agreement. "It was like, now or never, to pay a rent amount that I might not have all of."

Over 30 Years in Citrus Heights for Ray's Jewelers

There's a saying in the profession that "old watch repairers never die, they just slowly wind down.'

That's certainly not the case for Ray Soto, owner of Ray's Jewelers and Watch Repair in Citrus Heights, who for the past 13 years has continued to provide batteries, watch bands, ring sizing, watch and jewelry repair to his customers. He's looking to the future, considering adding custom laser engraving to his skillset.

The general amount of walk-in business isn't what it was before the pandemic — it is slowly coming back, Soto said. His shop sees a steady number of repeat local and out-of-area customers, and new business from the children of long-time customers who still trust him with their repair needs. Other referrals come from the jewelry departments of a nearby Kohl's Department store and Sam's Club, as well as Batteries Plus on Greenback Lane.

"I love my work," Soto said. "I genuinely enjoy the challenge of bringing a smile to my customers' faces when I take something, whether it's a muchloved watch, or a piece of a favorite costume, or fine jewelry that's especially of sentimental value to the owner that's in need of attention and bringing it back to something they can continue to wear and cherish."

Just behind a display counter, his workbench is filled with tools and supplies of his trade.

It didn't take long for Soto to replace a missing watch stem crown on a vintage Mickey Mouse Disney watch brought in for repair. Without a stem crown securely in place, its owner couldn't set the time. Refreshed, with a new battery and replacement leather band, the watch

Another customer sought his opinion on the best approach to clean and size a platinum ring.

Soto purchased the business in 2011 from his stepfather Ray Tallman when he retired. Tallman, a long-time and semi-legendary local watch repairman moved to Citrus Heights from the Bay Area in 1980, and opened the store which still bears his name. Ethel Tallman, Ray Tallman's mother, was his business partner for over 29 years.

"Ray's Jewelers and Watch

San Juan Avenue and Greenback Lane," Soto said. "It was rather common at the time for a retailer to lease space to a specialty shop like his where it provided an extra measure of physical security for him." That location is now home to a 99-cent discount store.

"I'm largely self-taught, but I learned quite a lot from Ray while I worked with him part-time," Soto said. He had enjoyed a satisfying professional career in commercial real estate, before deciding to purchase the business from him.

Soto, married for 30 years and now a grandfather, is the

father of two daughters, neither of whom he expects will follow him into his active profession. "One's a nurse, and the other is leaning in that career direction."

Other local competitors include Fast-Fix Jewelry and Watch Repairs in Sunrise Mall and Express Watch & Clock Repair & Service on Greenback Lane.

The retail corner of San Juan Avenue and Greenback Lane has seen a lot of developmental change since the 1980s, Soto said. He's pleased that his repair shop has been able to weather those changes through the years.

Situated in a shopping plaza

next to the Cornerstone Café and Bar, nearby businesses include the Cayuga Boxing Club and All About Pets.

"The site of a former Ralph's grocery store which later became Orchard Supply Hardware (OSH) is where Green Acres Nursery has since opened," he said. "It's especially good to see the area thriving again."
