

Record Number of Volunteers Count People Experiencing Homelessness in Sacramento

Sacramento Steps Forward News Release

SACRAMENTO, CA (MPG) - A two-night effort to

count the number of people experiencing unsheltered homelessness kicked off tonight at the primary deployment center at Sacramento State University's Harper Alumni Center on College Town Drive.

Hundreds of the more than 800 registered volunteers showed up at the University site and two additional locations, Citrus Heights and Rancho Cordova, to receive their maps and directions to locations where unhoused neighbors are likely to be found, while offi-

Sacramento Steps Forward Chief Executive Officer Lisa Bates told

leaders gathered that "your presence sends a powerful message to those experiencing homelessness -- it says you are not alone. We see you. We hear you. And you count!"

Sacramento's regional civic leaders have become more united than ever in addressing homelessness, taking responsibilities within an "All In" Local Action Plan finalized in 2022. This year the Plan is expanding to include more cities and significant community input and regional focus. The PIT Count data will be used as one measure of progress and help shape future programming to serve the unsheltered and

others experiencing homelessness or at high risk. It will take two nights to reach all the areas selected for the 2024 PIT Count. On Thursday night, additional volunteers will deploy from Sacramento as well as Elk Grove. Outreach workdaylight hours along the American River Corridor

in the coming days. All census takers will be using a new "Counting Us Mobile App" on their smart phones to conduct the Count. The application was developed by Simtech Solutions and is used in many cities and counties across the U.S. The new method will allow volunteers to gather observational and survey data and upload it to a central command center. The new app replaces a previously used app and paper-based collection methods.

Point in Time unsheltered homelessness counts are conducted in communities across the nation every two years. They are mandated by the U.S. Department of Housing and Community Development (HUD) for communities that seek federal resources to address homelessness. HUD uses this information to create a comprehensive

national picture. The last PIT commu-

nity wide effort, held

in 2022 in Sacramento, accounted for 6,664 unsheltered individuals. The report, which takes several months to complete, also documented 2,614 sheltered individuals experiencing homelessness, for a combined total number of people experiencing homelessness of 9,278. "We are grateful for this unprecedent turnout this year," Bates said. "This effort gives ordinary citizens a chance to make a meaningful contribution toward better understanding where this community is when it comes to homelessness. By being here, and working tonight and tomorrow night, they are making tangible contributions toward Sacramento's united vision of preventing and ending homelessness."

to support single mothers in the Sacramento region.

The Single Mom Strong Empowerment Center, a SMUD Sustainable Communities partner, offers support for single mothers, including affordable daycare, practical workshops, life skills training, and other events and activities. Its EmpowerME Preschool & Childcare programs make quality early childhood education accessible to all young children by making preschool affordable, even on a single income budget.

"We've had both a one-to-one peer counseling program in place and a wardrobe closet available to help them prepare for interviews and to dress professionally to re-enter the work force."

"What we haven't had before, is a workshop where single moms can get together to explore non-traditional trade careers in growing business sectors which offer high-income potential with low barriers to

The rapidly growing solar, electrical and manufacturing fields are just some which offer a variety of high-wage jobs in careers in safe, clean and tech-oriented environments which often don't require a college degree, Taylor said.

Participants will have a one-to-one opportunity to talk with fellow women already working in these industries and ask real questions about what it is like to work in their field, and how they balance work and family, and learn about their experience with career advancement, Taylor said.

Many will also have an opportunity to learn and consider career opportunities which are offered by the city of Citrus Heights. Some 86 women are employed at City Hall and the Citrus Heights Police Department, and many are in more trade-oriented roles, said city communications officer Marisa Brown.

These include Regina Cave, General Services Director, 24 years; Leslie Blomquist, City Engineer, 8 years, Alison Bermudez, Senior Planner, 24 years in March and Susan McClendon, Development Services Technician, 17 years in June.

"Come and explore your options in the safe, friendly Single Mom Strong environment you know and love," Taylor said. "It's a great first event and it's open to all women, with single moms given priority for childcare."

Single Mom Strong is lead by founder Tara Taylor and by its president Meghan Huber, the Economic Development and Communications Manager for the City of Citrus Heights. Huber joined the SMS Board of Directors in 2019 with a goal to affect positive change and support families in the community.

CITRUS HEIGHTS, CA (MPG) - On January 21, 2024, at approximately 1:53am, Citrus Heights Police responded to the report of a man who had been stabbed and was laying on the ground outside a business in the 6400 block of Antelope Road in Citrus Heights. Officers arrived within two minutes

and located an unresponsive adult male laying on the ground outside of a closed business. Officers immediately began life-saving medical aid for the man. Fire personnel arrived and continued life-saving measures but were unable to revive him due to his significant injuries. The identity of the victim is not being released at this time pending notification of his

Citrus Heights Police Detectives responded and began a homicide investigation, detectives learned the victim and suspect were both part of the unhoused community and were general acquaintances. The suspect is identified as 35-year-old

investigation. Through the course of their

Steven Cardenas and detectives secured a warrant for his arrest for 187 PC - Murder.

At approximately 7:40pm this evening (January 22, 2024), Citrus Heights Police, in cooperation with the Roseville Police Department, took Cardenas into custody for his warrant on the shared border between both cities. Additionally, Cardenas has a history of multiple contacts and arrests with Citrus Heights police during 2023.

Al Gonzalez spoke on behalf of the Chamber, outlining the various activities and events they hold each year to promote local businesses. Gonzalez said that 17 businesses joined the Chamber in 2023-2024, for a total of 312 current members.


Councilmember Schaefer didn't have questions about the requested funds, but instead asked Gonzalez for details about the Citrus Heights Chamber of Commerce Political Action Committee (PAC). Gonzalez said the purpose of the PAC was "to support the members that are running for local office."

Schafer asked, "How many of the members on this Board (the City Council) has the PAC ever supported?" Gonzalez said he didn't know.

Vice Mayor Karpinski-Costa said, "Not me. Not him."

Councilmember Lopez-Taff explained that Gonzalez wouldn't be able to speak on behalf of the PAC, because the Chamber and the PAC are separate entities: "The PAC has its own governance and membership ... although they sound similar, they're very separate."

Schaefer continued, "But the PAC is using the credibility of the name of the Citrus Heights Chamber to convince voters that this is their influence. So, they are connected. It's very difficult to say they're not connected." He said that while he heard the Chamber was suspending their relationship with the

PAC, he wanted to know how the PAC was funded. Gonzalez responded,

"Well the PAC isn't funded anymore, because we're looking at, they go their way, we go our way."

Schaefer said in his personal experience with the PAC, "there have been times where they completely denied me an opportunity to interview. ... I had some questions that I directed toward one of the PAC members, and he basically told me it's none of my business. ... It's very difficult because the names are the same. The perception of the public is going to be that the Citrus Heights Chamber, that is you, are going to support a particular candidate, when you may or may not be supporting that candidate. So that's a problem for me."

Mayor Daniels brought up a concern of his own, that the current executive director of the Chamber had stepped down and a new one had not yet been selected. Mayor Daniels said, "I think everybody here supports the Chamber. ... The effort, and what it does, and the need for it, too. ... If our businesses don't thrive, Citrus Heights doesn't thrive. We die. It's plain and simple." But he said that while he was prepared to support covering the cost for the Chamber's use of the Community Center, he did not want to support the \$10,000 sponsorship until after a new executive director was chosen and had discussed future plans with a representative from the City Council.

Vice Mayor Karpinski-Costa said, "Well, I disagree with the mayor. I think that this is a budget item, and this money is in our pot now, and it may not be in the pot when you

2 lbs REG. \$9.99/ea get your executive director. ... We have just a limited amount in the pot, and when that pot goes, it's gone. ... I don't think our vote should reflect on whether or not they have a Chamber person in charge today or next week or next month. That's not what they're asking. We're not funding that position." The request was for the facility cost and the sponsorship, and she said, "We are beneficiaries of all their events, we're always invited."

Councilmember Lopez-Taff moved to approve the full request, which was seconded by Councilmember Middleton. Mayor Daniels requested a substitute motion, seconded by Councilmember Schaefer, to vote on the two funding requests separately. The Council voted first on the request for funding to cover the facility rental, which was approved 5-0. Then the Council voted on the \$10,000 sponsorship, which passed 3-2, with Daniels and Schaefer dissenting.

Gonzalez invited all councilmembers to attend the Chamber luncheons: "I would like our membership to get to know the City Council members. It's vitally important. ... We're the connection between them and you. And if you come and they come, they have an opportunity to get involved and be more active in the Chamber."

The Council then heard an update from the Citrus Heights Police Department (CHPD) about their plan for crime detection and prevention in commercial areas—specifically looking at ways to use technology to maximize resources and improve efficiency.

Lt. Wesley Herman said, "We understand, obviously, the significance of the commercial businesses. ... It's clearly the economic engine of our city and it's vitally important that we protect that asset and the future of our city."

Plans for new technology include equipment such as license plate readers at intersections, anti-loitering devices at business locations, mobile cameras and lighting that can be moved to various locations as needed, and vehicle and property trackers. The CHPD is also planning to implement live 911 software so patrol officers can hear calls as they are answered by dispatch, which will improve response time.

The plan also includes staffing increases such as a real-time information center operator (in collaboration with Elk Grove Police Department) and part-time detectives focusing specifically on retail theft. Collaboration with officers throughout the region will allow related cases to be consolidated, leading to more effective prosecution.

Councilmember Lopez-Taff said, "I just want to thank our police department for being innovative, getting these grants, and making a plan to protect our businesses. ... We want to say loud and clear that criminals are not welcome here. And you are making a tremendous effort to support our business owners."

Councilmember Schaefer agreed: "This is really a great step in the right direction."

The next City Council meeting is scheduled for February 8, 2024.



California Regulators Want to Spend Billions to Reduce a Fraction of Water Usage

Hydrologists measure large amounts of water in acre-feet – an acre of water one-foot deep, or 326,000 gallons.

In an average year, 200 million acre-feet of water fall on California as rain or snow. The vast majority of it sinks into the ground or evaporates, but about a third of it finds its way into rivers. Half of that will eventually flow into the Pacific Ocean.

That leaves approximately 35-40 million acre-feet for human use, with three-quarters being applied to fields and orchards to support the state's agricultural output, and the remaining quarter - 9-10 million acre-feet -

being used for household, commercial and industrial In other words, nearly 39 million Californians wind up using about 5% of the

original precipitation to water their lawns, bathe themselves, operate toilets and cook their food.

That number is important because it is such a tiny amount, even though the state's perennial household water conservation programs imply that taking fewer showers or reducing lawn watering will somehow solve the state's water problems.

f those propagandistic appeals is quite evident in the state Water Resources Control Board's new plan to force local water agencies into cutting household water use even more, no matter the multibillion-dollar cost, and with penalties if they fail to meet quotas.

The water board says the plan, which was authorized by the Legislature in 2018, would reduce household use by 440,000 acre-feet a year when fully implemented. That would be about 5% of current use, which is only about 5% of average precipitation – scarcely a drop in the bucket.

The plan is drawing some well-reasoned criticism from two independent observers, the Legislative Analyst Office, an arm of the Legislature, and the Public Policy Institute of California, the state's premier think tank.

The LAO, in a report to the Legislature, said the plan "will create challenges for water suppliers in several key ways, in many cases without compelling justifications."

In essence, the LAO said, local water agencies would have to jump through the state's hoops by spending billions of dollars for a tiny reduction in overall water use that could have an adverse impact on low-income families.

The PPIC is similarly skeptical, summarizing the plan as "very high cost for little benefit." PPIC fellows David Mitchell and Ellen Hanak also pointed out its effects on low-income communities and the difficulty it would impose on local governments' programs to

The ludicrous nature plant and maintain trees as a shield against hot summer weather.

> California does indeed have a water supply problem, mostly because its political leaders for decades have failed to expand the state's water infrastructure that had been built during the mid-20th century.

> Household use is not the problem. It cannot be because it is such a tiny part of the overall water picture and actually has declined, in relative terms, as the state's population reached 40 million, more than twice what it was when the last major water works were constructed.

> The major mismatch of demand and supply occurs in the two largest categories of water use, agriculture and the environment. Agricultural water agencies and environmental groups have been jousting for decades in the Legislature, in Congress, in courts and in regulatory agencies such as the water board over how much water farmers can draw and how much should remain in rivers to protect habitat for

> fish and other wildlife. That's the issue that must be resolved by reallocating existing supplies, building new storage and/ or creating new supplies, such as desalination of seawater. Spending billions of dollars to save a few gallons of household water is just an expensive exercise in virtue-signaling that accomplishes virtually nothing.



– Not a Fair Shake

"That's not fair," is a common child-hood mantra. It's typically heard when a child doesn't get what he or she wants. Sometimes the sentiment is valid, more often it's not.

As we grow up, adults, whether it be parents or others, tend to intercede on our behalf to demonstrate fairness. The problem is we then develop a false expectation of fairness. This leads to great frustration as we mature since fairness in life is not guaranteed.

Harboring resentment impairs your judgement. You are then more likely to react emotionally instead of logically. The goal is to make your situation better, not worse.

Julie had applied for an open position in her company. She was eminently qualified and consistently received excellent performance reviews. Julie was optimistic about her chances. She really wanted the promotion. To Julie's dismay, Cathy, a friend of her boss, was hired for the job. Julie felt it wasn't fair. Cathy didn't have nearly as much experience as her.

What were Julie's options? She

could go to work each day filled with

bitterness, determined to get even. She didn't have to perform at such a high level. Julie could do just enough to get by. Why should she work so hard only to be treated unfairly?

The second option was for Julie to accept that such things happen. As a

accept that such things happen. As a well-regarded employee, other opportunities would emerge. If Julie wasn't happy with the growth path at her company, she could get another job elsewhere.

If Julie picked the first option, she would only be hurting herself. As her productivity dropped, her reviews would suffer along with her chances for a promotion. Should Julie then look for another job, she certainly wouldn't get any glowing references.

The second option is much more beneficial to Julie's future. Regardless of whether she looks for a new job or not, Julie would not be acting in a self-destructive manner.

Regardless of what unfair situations you face, you have a chance to improve your situation. Understand what sequence of events lead you to your current circumstances. It may not always make sense, but that doesn't matter. What's important is optimizing your chances to make the best of it. Moving forward always beats getting mired in the past.

Social Security Matters

Will Withdrawing from 401(k) Affect My Social Security?

Dear Rusty: My full retirement age (FRA) is 66 and 8 months, which I'll reach in September 2024. I'm still working 3 days a week. I want to cash in my 401K and want to know if I have to wait until my FRA for IRS purposes or can cash it in anytime in 2024. I don't want to affect my Social Security or end up paying taxes on my benefits. Signed: Seeking to Avoid Taxes

Dear Seeking: We're not experts on IRS matters here at the AMAC Foundation so I can't address 401(k) questions, but we can provide information on your Social Security circumstances and how 401(k) withdrawals may affect your SS. I assume from your question that you are now receiving early Social Security and wish to avoid any tax consequences thereto by cashing in your 401(k), as well as from working. Here's what you need to know:

• Since you will reach your

what you need to know:

• Since you will reach your full retirement age (FRA) in 2024, your 2024 work earnings limit will be \$59,520 up to the month you reach FRA. If you were born in January 1958, you'll attain FRA in September 2024. After you have reached your FRA there is no longer a Social Security

limit to how much you can

earn from working, so your

work earnings thereafter

will not affect your monthly Social Security benefit regardless of how much you earn. If your part time work between January and August 2024 won't put you over the \$59,520 limit, your work earnings will not negatively affect your gross monthly Social Security benefit.

· Assuming you are on Medicare, the premium for which is deducted from your Social Security payment, withdrawals from your 401(k) might affect your net monthly Social Security payment in two years hence. Medicare premiums are based upon your combined income from all sources, including 50% of the SS benefits you received during the tax year. If your 401(k) withdrawal(s) put you over an income threshold for your tax filing status, you may be required to pay an "IRMAA" (Income Related Monthly Adjustment Amount) on top of the standard Medicare premium. That IRMAA supplement would be deducted from your Social Security, which would affect the net amount of your Social Security payment. Your Medicare premium for each coming year is determined by your combined income from two years prior, so if you "cash in" your 401(K) in 2024, it would affect your net Social Security payments in 2026.

would affect your net Social
Security payments in 2026.

• Whether you will pay
income tax on your Social
Security benefits is determined
by your combined income
from everywhere, which the
IRS calls your "Modified
Adjusted Gross Income"
or "MAGI." MAGI is your
income from all sources

(except ROTH IRA withdraw-

als) and includes half of the SS

benefits you received during

the tax year. If you file your

taxes as a single, and your

MAGI is over \$25,000 – or if you file your taxes as "married-jointly" and your MAGI is over \$32,000 - then 50% of the Social Security benefits received during the tax year becomes part of your overall income taxed by the IRS (at your normal IRS tax rate). But if your MAGI as a single filer is more than \$34,000 - oras a married/jointly filer over \$44,000 – then up to 85% of the SS benefits received during the tax year becomes part of your overall income taxed by

the IRS. So, to recap:

1. Your part time work earnings in 2024 won't affect your monthly Social Security benefit, unless your 2024 work earnings prior to September 2024 exceed \$59,520.

2. Depending on the amount of your 401(k) withdrawals, your 2026 net Social Security payments may be impacted by Medicare's IRMAA provision. But your 401(k) withdrawals will not affect your gross Social Security payments.

3. Depending on the amount of your 401(k) withdrawals, some of the Social Security benefits received during the 2024 tax year will likely be subject to income tax. That is, if your annual total income, including your 401(k) withdrawals, exceeds the MAGI thresholds described above.

I mailed the required paperwork and avoided losing our non-profit status. Good public servants hire good staff. I voted for Josh Hoover last election and will do so again.

Enter Harrison Barnes. Yes, the much maligned Harrison Barnes, and rightfully so. Harrison has under-performed nearly all season, and I have been critical of his effort: to the point of calling for coach Brown to give Trey Lyles his starting spot in the lineup.

So, after four miserable games, the Kings have now won three straight, and Mr. Barnes has played prominently in all three. 32 points, then a career best 39, and finally a solid 20-point performance against the Dallas Mavericks to help the Kings string three wins together.

The most prominent name mentioned in trade talks has been none other than Harrison Barnes, and this most recent resurgence in productivity has fans and pundits alike scratching their heads. For many of us that have followed

Another positive is the positive sight of Davion Mitchell coming off the bench again with regularity!

Like most players, Davion is at his best when he sees regular playing time, and he played well in all three of the Kings recent wins.

I would be remiss if I didn't mention the recent change in the Kings effort on defense. Davion Mitchell brings it every game, and his ferocious defensive style is contagious. When Davion disappeared for games at a time, getting no playing time, the defense struggled. Collectively the Kings have been getting better every game as their defense is currently at the best I've seen all season. The Kings implausible nine blocked shots

in the first half of the Maverick's game is without a doubt a record for most blocks in a half for this team, and one notable standout was none other than Keegan Murray. Three blocked shots against Luka Doncic in the first half set the tone for the game, and although the Mavericks made it closer than was necessary, the Kings defense rose to the occasion, and truly was the principal reason for the victory. If we have learned anything about this

Be Prepeared

A new year is here with all the good, the bad and even the ugly, like landing in a hospital. With all the new variants in Covid, Flu, RSV and the common cold, would you be ready if you land in a hospital? Kati Kleber, Bsn, Rc and CCRN told me we need to be aware of what we need to do. It's a maze in the hospital and you don't want to get lost in the shuffle, so I got seven tips from Kati that she says is a 'need to know' in her book "Admit One." Kati is a nationally certified care nurse, and she has seen it all. Here's some information you should know before it all comes crashing down and you become a statistic instead of a patient.

1. BRING A LIST OF HOME MEDICATIONS. Know what medications you take on a regular basis. When you are admitted someone will ask you to provide a list of your med and will put them in your chart. Your attending doctor will decide which to keep you on in the hospital. On this one, I asked Kati if it's a good idea to have a list of vitamins and herbs you take, and she said absolutely because of interactions.

2. MAKE A LIST OF HEALTH CARE TEAM MEMBERS. An extensive team of health professionals will come and go from your room. It's hard to tell which is which...doc, nurse, consultant etc. You and your support person will want to write down who is who, along with their instructions.

3. KNOW YOUR CODE. Your code status informs staff what to do if you stop breathing or your heart stops. Patients without chronic health issues who aren't nearing the end of their life may want health professionals to do everything to revive them. Others with terminals diagnosis or advanced age may choose not to be revived. This is called DNR or Do Not Resuscitate.

4. ASSIGN A SPOKESPERSON. Identify someone the hospital staff can call when changes occur. It is important this person can be easily reached and that you trust.

5. WRITE DOWN QUESTIONS AS YOU THINK OF THEM. Except for nurses, most team members stop by your room once a day, review your care plan, and make adjustments. It's not easy to remember all your question.

6. ADVOCATE FOR YOURSELF. Let the nurse know of any changes in your condition so the information can be relayed to your health care team. Also, if for any reason, you are not happy with a member of your health care team, let your nurse know that you'd like to speak with a nurse manager.

7. LEAVE THE EQUIPMENT TO THE EXPERTS. Hospitals are full of elaborate, high-tech equipment. If any equipment becomes dislodged, always alert a nurse. Unfortunately, incidents have occurred where patients or family inflict irreparable harm when trying to fix things themselves.








Solving an Impossible Problem

Supreme Court will hear case about homeless encampments, with huge implications for California

The U.S. Supreme Court will weigh in on whether cities can legally ban or limit unhoused people camping in public spaces - a case that could grant California officials more power to sweep homeless camps.

The case, originating from the Oregon city of Grants Pass, could overturn or narrow a fiveyear-old precedent from a federal appeals court that limited how much cities in Western states could criminalize those who sleep on the streets when there aren't enough shelter spaces available.

In the older case — Martin v. Boise — the Ninth Circuit Court of Appeals ruled in 2018 that it's cruel and unusual punishment to criminalize camping on public property when the people in question have nowhere else they can legally sleep. The ruling was binding on West Coast cities, where rising rates of unsheltered homelessness that later spiked during the pandemic were driving local politicians to pass public camping prohibitions. In 2019 the Supreme Court declined to hear an appeal of that case.

Since then, California cities have often been subject to federal lawsuits after passing restrictions on when and where the unhoused can set up camps. Relying on

the ruling in the Boise case, judges have delayed or outright halted camping bans from being enforced in cities including San Francisco, Sacramento, Chico and San Rafael, finding that the cities had failed to provide adequate alternate shelter options for the residents they were about to sweep from their encampments.

The situation has led city officials —and Gov. Gavin Newsom to complain that the Boise ruling has tied their hands from addressing the state's sprawling encampments, arguing they need to sweep camps both for health and safety reasons and for the well-being of encampment residents. It's led liberal state and local officials, including Newsom, to join conservatives in asking the court for more power to penalize the homeless for sleeping outside. The high court has a 6-3 conservative majority.

In a high-profile case that has particularly drawn Newsom's ire, the Ninth Circuit Court of Appeals this month backed a judge's 2022 ruling restricting San Francisco's enforcement of certain bans on sleeping on sidewalks and in parks, because the city hadn't shown there were other locations that were "realistically available" to unhoused residents before a city sweep.

"California's elected officials who seek in good faith to improve what often appears to be an intractable crisis have found themselves without options, forced to abandon efforts to make the spaces occupied by unhoused people safer for those within and near them," Newsom's administration wrote to the Supreme Court in September.

An attorney for the homeless Grants Pass residents said in a statement today that politicians were wrong to blame judges for the homelessness crisis. He said cities have always been allowed to regulate encampments, even

under the recent rulings. "The issue before the Court is whether cities can punish homeless residents simply for existing without access to shelter," said Ed Johnson, director of litigation at the Oregon Law Center.

The case is being closely watched by officials across California and could widely affect how they respond to encampments. Newsom's statement was part of an amicus curiae brief the administration filed in the case. Amicus briefs are legal briefs submitted by parties not directly involved in a given case, but who typically take one side or the other in a case. The majority of the amicus briefs filed in the case were from California entities and, though more than a dozen mostly-Republican-led state governments also filed a brief, Newsom was the only governor to weigh in.

In addition to Newsom's, other filings include the California State Association of Counties, the California State Sheriffs' Association, district attorneys for Sacramento and San Diego counties, the cities of Los Angeles and San Francisco, the Los Angeles Area Chamber of Commerce, the Bay Area Council, and even the Brentwood Community Council.

But advocates for the unhoused say the Boise ruling is clear. They point out that most cities have hardly enough shelter beds to accommodate their homeless populations and that shelters are often near-full on any given night, and say banning public camping or restricting it does more harm than good by pushing homeless people from location to location.

"All you need to do to be compliant with (the Boise case) is stop using our criminal system as the stick here to solve this problem," said Will Knight, decriminalization director at the National Homelessness Law Center, last year.

In particular, the court rulings have led to a patchwork of interpretations across the state on what qualifies as the "adequate shelter" cities must provide before sweeping homeless camps. The Oregon case that the Supreme Court agreed to hear could provide some clarity — or

so California officials hope.

While the Boise ruling said the government can't broadly ban any public camping without giving people alternative places to stay, Newsom and city officials across California said in briefs filed before the Supreme Court that they want to know whether they can set restrictions on times or locations where camping is

allowed. Other questions include whether cities can criminalize public camping for those whom they call "voluntarily" homeless — people who refuse offers of shelter. And California cities have asked the court to rule on whether, in order to ban camping, they need to have a suitable shelter space available for every individual unhoused person no matter their circumstances. or simply have general shelter beds open the day they sweep a camp. .

In Chico, for example, a federal district judge in 2021 ruled that sending unhoused residents to camp on an unshaded airport tarmac on the outskirts of town was not "adequate" enough shelter to justify banning encampments in town. In response, the city settled the case by setting up a site of tiny homes where it can offer encampment residents a room before proceeding to sweep their camp.
