## **Storm Season** Safety: **Evacuation** Warning vs. **Evacuation Order**

California Governor's Office of Emergency Services News Release

SACRAMENTO COUNTY, CA - As a significant series of storms continue to impact parts of the state, the California Governor's Office of Emergency Services (Cal OES) reminded all Californians Monday about the importance of being prepared.

Extreme weather such as heavy rainfall and snow are contributing to dangerous conditions. To keep Californians safe, law enforcement issues evacuation warnings or orders ahead of major emergencies, such as weather events.

An evacuation warning means there's impending danger to your life or property. If a warning is given, assume an evacuation order will follow. Start gathering important items for your family and pets. Any individuals who need extra time to evacuate, or anyone with large animals, should pack up and leave when a warning

The Old Auburn Road Complete Streets Plan was adopted by the City

walking, and taking transit along the route which runs northeast/southwest between Sylvan Road / Auburn Boulevard to Garry Oak Drive, connecting to the commercial corridors of Auburn Boulevard and Sunrise Boulevard.

In all, the federally funded grant project creates 7,000 feet of protected bikeways and sidewalk enhancements as well as road resurfacing, traffic signal upgrades, new street lighting and upgrades to storm drain infrastructure. The project reduces traffic to two single travel lanes and a center twoway left turn lane, drawings show. Since incorporation, the city has Continued on page 5

The stretch of road is a little over three-quarters of a mile and extends from Tiara Way to Garry Oak Drive. The specific construction project timeline and cost are still to be determined as additional funding from

state and federal sources continues

The route has a speed limit of 35 miles per hour and shifts between two and four travel lanes.

is issued.

An evacuation order means there's an immediate threat to your life and you need to leave immediately. Follow all directions from law enforcement to ensure you and your family evacuate safely.

Leave as soon as evacuation is recommended to avoid being caught in flood waters or road congestion. In some emergencies, officials might not have time to knock on every door. If you are advised to leave, don't hesitate!

Officials will determine the evacuation areas and escape routes based on the danger's location, behavior, terrain, etc.

You will be advised of potential evacuations as early as possible.

Do not return to your home until officials determine it's safe. Notifications will be given as soon as possible.

When a disaster hits, you might not have time to gather necessary supplies. Pack a Go Bag so it's ready to grab when there's an emergency. Items to take are important documents, cash, medicine and important medical information, and phone charger and backup battery.

Plan ahead for your pets and know where you will take or leave them during an emergency. During an emergency, local animal rescue organizations work with law enforcement and fire departments to rescue as many animals as they can. You Continued on page 3

SACRAMENTO COUNTY, CA (MPG) - On January 31st, Sacramento District Attorney Thien Ho gave a public safety address to a packed room at Clunie Hall. Guests included Police Chief Kathy Lester, elected officials, colleagues, community leaders, crime victims, and friends. D.A. Ho laid out his department's mission and here are a few important highlights.

To begin, since January 2021, more than 600 people have died in Sacramento County of Fentanyl. D.A. Ho explained those numbers are expected to rise. Most parents don't know social media is the leading platform for drug dealers. Counterfeit pills mixed with fentanyl are marketed online as "prescription pills."

Laura Didier was there to share her story about how her own son got access to

one such counterfeit pill. It was Christmas break in 2020. Her son Zack was a straight-A student, athlete, and musician. He was a good kid, and parents didn't seem to have any reason to worry. Unfortunately, Zack went online and bought a pill marketed as a

prescription Percocet, but it wasn't. He tried it once, and his father found him dead in his bedroom. It was a somber reminder deadly drugs are now easily accessible to anyone, anywhere. With tears, Laura said, "He'll always be 17."

Heartbroken, she wanted

to make something good from this tragedy. Didier partnered with the District Attorney's office to promote "one pill can kill." Now she joins Thien Ho and Angela Webb to speak at educational school forums about fentanyl awareness. They plan *Continued on page 3*

# Local Author Calls Up Baseball Fans with New Book

NORTHERN CALIFORNIA (MPG) -The San Francisco Giants baseball team clearly has countless fans across Northern California, and have inspired many young baseball players to dream of going on to the Major Leagues themselves. One of those dreamers was Zak Ford, who grew up in the 1980s and 90s - the heyday of Candlestick Park.


Ford not only enjoyed cheering from the stands at many a Giants game growing up, but he also heralded from some pro-ball genetics. His great-uncle, Larry Powell, pitched in 14 professional seasons in the 1930s through 1950s. He was picked up by the Boston Red Sox out of spring training, but was released two weeks later. Powell was then signed by the Boston Braves, but again was released ---this time after only one week. His MLB dreams died without ever stepping into a game.

Ford grew up knowing of Powell's experience, but never asked him how that journey felt. Instead, Powell — who struggled to hit .200 throughout his own Little League years — decided to write about baseball instead.

Ford's book, Called Up: **Ballplayers Remember Becoming** Major Leaguers, may not include Larry Powell's perspective, but it does delight readers with 109 stories of MLB players reflecting upon the moment they were called up to the big leagues. Written in a first-person narrative, it's a human interest book that will obviously be enjoyed by baseball fans, but written with such skill that it will also draw in readers that have limited knowledge of the process and history of the game.

"It really captures the feelings and emotions of becoming a MLB player," says Ford. "To be able to capture 109 stories about the achievement is something I'm very glad of being capable to do."

Out of the 109 featured in the book, about 10 of them are local

to the Sacramento region — those that either came out of the area, and reside in the Sacramento region now. Ford himself grew up in the Rancho Cordova area and now lives in Cameron Park. He works in workforce development policy, which aims to improve outcomes for people with disabilities. He was also a member of the Folsom-Cordova School Board from 2010-2018.

Ford clearly has a passion and enthusiasm for people and bettering the world around him, but the world of baseball — and later writing about it - has always captured him.

"I've always been a fan of baseball dating back to when I was a 7- or 8-year-old kid," says Ford. "I kind of realized that I was going to have to choose a different avenue for me to find my niche in the game and decided to pursue writing. I've basically been doing it as a hobby since I was a teenager. One of the goals I've always had was to write a baseball book, and now at 45 [years old] I've achieved it."

To write the book, Ford interviewed former MLB players for about two and a half years. When asked what stories really stuck out to him, Ford took a thoughtful pause to answer.

"All of these players had to exhibit extreme dedication and perseverance to meet the goal of becoming a MLB player," he said. "All of them are great inspirational stories. I grew up a Giants fan, and I was able to capture the stories of some of the guys who came up with the Giants during the time I was a young baseball fan. Those are the stories that stick out to me."

Sean Estes, who is now active with Giants broadcasts, is one example of a player that shared his story of being a number one pick.

"It took him four or five years to reach the major leagues," Ford recalls. "He was up in the major leagues for the majority of the next 12 or 13 years."

The lesson to be learned? Never give up on your dreams.

"There are many stories that show ups and downs, that show hardship and overcoming adversity. It's an inspirational book about going through that journey and showing dedication and perseverance," said Ford.

Since his book's publication, Ford has done virtual presentations for baseball groups, as well as a local book signing. He's also working on a second book. Potentially entitled Next Up, the new manuscript will focus on MLB players' lives in the normal workforce outside of baseball ---perhaps disproving the belief that all MLB players retire wealthy.

"The vast majority of them need to have jobs after their playing careers," says Ford.

"There are players that have had pretty big challenges trying to find what's next, while others have that hustling mentality they picked up in baseball that serve them well after their playing days. That scrappy mentality has paid off."

on expanding their youth-focused program in 2024. To learn more about One Pill Can Kill and watch Zack's story, go to: 1pillcankillsac.com.

Awareness is vital to helping protect our communities, but accountability is equally essential. Thien Ho is working with other District Attorneys to provide harsher sentences for drug dealers. The loss of even one life is too much to allow a dealer to walk away without real consequences.

He noted January was Human Trafficking Awareness Month. According to the California Department of Justice, California is the #1 state for human trafficking. (https://oag.ca.gov/human-trafficking/ what-is). The Human Trafficking Unit in the District Attorney's office partners with the Sacramento Child Exploitation Task Force (CETF), which includes the Sacramento County Sherriff, FB, and Sacramento Police Department. And while they aggressively pursue and prosecute human traffickers, child predators, and domestic abusers, there is a new outreach arm. Victims of these crimes can go to GetHelpSac.org for answers. There, they can access organizations like My Sisters House, Weave, and the Community Against Sexual Harm (CASH).

The discussion moved to the fear and crime our local businesses and property owners are experiencing. It's no secret that retail theft has skyrocketed in California. The D.A.'s office is taking aim with a new organized retail theft unit. Not only are they focused on fighting the crimes that shutter our local businesses, but D.A. Ho is advocating for answers to nearby encampments as well. He noted that these homeless camps "put people between compassion and chaos."

To help people on the street get back on their feet, Thien Ho supports the development of a shelter model called Hope for Sacramento. This model allows anyone on the streets to get shelter and move toward sobriety and housing at a reasonable pace (hopeforsacramento.org).

District Attorney Ho knows Incarceration isn't the only solution to crime. This is why his office has another answer. Non-violent offenders will receive an opportunity at redemption with the new Changing Courses program. Instead of prison, those accused of a crime can choose to enter an apprenticeship program in the trades. If they complete the program, they can move toward a lucrative job, and a real future. D.A. Ho explained, "This allows them to change their course from a life of crime to a life of construction."

Still, there is another hurdle that our law enforcement professionals can't handle alone. Current legislation in California is one of the biggest obstacles to public safety. That is why Thien Ho and District Attorneys across California are advocating for a measure to be added to the fall ballot called The Homelessness, Drug Addiction, and Theft Reduction Act. Many law enforcement professionals point to

Prop 47 as a contributor to the rise in crime across California. It's been ten years since the proposition passed, and they believe it is time to change things. Interested folks can review the petition details and how to get involved go to; casafecommunities.com.

The presentation ended on a hopeful note. D.A. Ho believes Sacramento has been sleeping, and although it's a slow process, she is waking up. The sunrise is coming, and our Thien Ho is welcoming us with coffee.

# New Citrus Town Center Banquet Facility Opens

**CITRUS HEIGHTS, CA (MPG)** - The Citrus Town Event Center, a new multi-purpose banquet hall located at 7942 Arcadia Drive, just across from the Mitchell residential subdivision in the Citrus Town Shopping Center is officially open for booking, said owner Sam Hameed.

"We just passed our final inspection," he said in a telephone interview. "I'm excited to now be able to share with the community what this new center has to fully offer the public."

"If you're ready to host an event that will leave a lasting impression on your guests, just look no further than Citrus Town Event Center," he said.

Hameed recalled the lengthy construction process which has now completely transformed the interior and exterior of the 6,000-square-foot former bar and nightclub into an upscale modern banquet facility suitable for a wide range of celebratory personal and public events, including weddings and banquets. The hall can seat up to 300 guests, he said.

"Whether you're planning a wedding, a milestone celebration, a quinceanera, graduation, a baby shower or a corporate event, our versatile banquet hall can accommodate your every need," Hameed said.

The two-level Citrus Town Event Center building, which features a signature round glass-block turret, was built in 1975 and once operated as The Sand Bar, a bar and nightclub featuring live music and entertainment before its closure years ago. Inside, neatly dressed round banquet tables were ready to seat awaiting guests. The interior has a fresh modern feel, with bright, high white walls, offset by white and black marble flooring tile. Upstairs, a renovated second floor features a bridal room and a staircase for any bride to descend. Temporary exterior signage announcing the grand opening of the Citrus Town Event Center hasn't been finalized yet, but will be put up soon, Hameed said.

Until then, Hameed has begun to market the venue to a wide range of potential users and will be in conversation with the membership of Citrus Heights Chamber of Commerce and representatives of Sunrise Marketplace as he plans an upcoming special grand opening event.

"Right now, we've now launched our website to accept bookings and the public is welcome to call me to arrange to tour the facility and to discuss their event requirements," he said. "When they do, they will be delighted to discover a full-service, and very affordable facility for all their needs."

Hameed has been in the banquet hall business for the past 11 years and had been involved in the operations of his uncle's Fleur de Lis Banquet Hall in Modesto before looking to open a similar facility in Citrus Heights. With his family's help and financial support, he seeks to build on their ongoing success with his new venture.

In time, Hameed said he anticipates the center will be able to host multiple events at the banquet hall each month with a typical capacity per event of 200 guests at a time. Most events would likely end by 10 to 11 p.m.

The Citrus Town Event Center has a parking capacity of 100 spaces under a shared parking agreement with Citrus

# Citrus Heights Rents Increased 0.3% in January

**CITRUS HEIGHTS, CA (MPG)** - Our first data update of 2024 shows nationwide rents down another 0.3% in January, capping off a slow winter season where rents fell for six consecutive months. Today, rent is at its lowest level since March 2022. Looking ahead to the rest of the year, the start of the moving season should provide a boost of demand, but strong supply growth is expected to keep rents from skyrocketing.

For the latest data, see our full February

Rent Report here. Some highlights include:

-Rents in Citrus Heights increased 0.3% in January, compared to a 0.3% decrease nationwide.

-Year-over-year rent growth in Citrus Heights now stands at -0.9%, up from -2.8% one year ago.

-Since the start of the COVID-19 pandemic in March 2020, citywide rents have risen a total of 22.6%.

Today the median rent in Citrus Heights is 1,494 for a one-bedroom apartment and 1,644 for a two-bedroom apartment.

# Update On The Citrus Heights And Rocklin Gun Store Burglaries

# How Will California Overcome High Living Costs, High Poverty And High Debt?



points. These data are the grist for perpetual debate in California's political, media and academic circles over causes, effects and remedies, and the conversations will be heating up this year. The state faces multibillion-dollar budget deficits well into the future due to what appears to be a semi-permanent plateau in revenues that cannot cope with sharp increases in spending during Newsom's governorship. Advocates for the poor and their legislative allies are pushing Newsom and legislators to protect the safety net programs from cuts as they confront the deficit, but they will be competing with other spending categories that enjoy heavyweight political support, such as K-12 and higher education and prisons. There's another aspect to California's high living costs and high poverty rates - high levels of debt that have gotten scant media and political attention. Americans have amassed \$17.3 trillion in home mortgages, auto loans, student loans, credit cards and other forms of personal debt, according to the Federal Reserve Bank of New York. Californians owe at least \$2.5 trillion of that and perhaps as much as \$3 trillion, thanks largely to its high housing costs and the large mortgages needed to handle those costs. In fact, according to a newly released study by CreditDonkey, a personal finance website,

Californians are carrying the most debt of any state, driven by an average mortgage of \$422,909 for homeowner families.

Californians debts for student loans, auto loans and credit card balances are also fairly high, although not terribly so vis-à-vis other states. It's mortgage debt, at least \$2 trillion, that truly sets California apart from other states, although a third of the state's homeowners don't have mortgages. That said, Californians seem to be handling their high debts fairly well. The state's personal bankruptcy rate is well below the national average and a fraction of those in states, mostly in the South, with skyhigh rates. However, the PPIC, using census data, found that a million of California's 9 million renters are behind on their rent. California's unique combination of high living costs, high poverty and high debt makes the state something of a personal finance experiment. The test will be how people fare during the next recession. During the Great Recession, California had one of the nation's highest levels of mortgage defaults and repossessions, and it took years for the housing industry to climb out of the cellar. "How many of you remember the first time you saw a black person?" asked my sociology professor in my freshman class at Baylor University.

Several students answered with stories about the first time they saw a black person walking beside the road or working in their backyard.

I was shocked. But I really shouldn't have been. It was 1975 and my southern friends had enjoyed school holidays for "confederated heroes," yet not for Abraham Lincoln.

As a Californian, I was out of my element, but I counted myself lucky to be free of their racist upbringing.

Or was I?

With the beginning of Black History Month we might find how confessing our own history can provide insight into understanding racial issues.

As a boy growing up in the San Francisco Bay Area, my skin was as white as the fog that shrouded my hometown hills. But it was mostly the fog of my family's southern roots that made me "color blind" to other races and cultures.

It was from the distant listening post of my Richmond, Calif., home where I began hearing the cries of social change, muffled and off-key.

In 1967, I started fifth grade with the announcement that our school, Balboa Elementary, would soon receive our first black students.

Few of my classmates said anything, holding our comments for the playground, where we assembled around Keith, our class troublemaker.

Keith seemed to always be fighting someone on the schoolyard. It was even rumored that he was once suspended for hitting a teacher.

He persuaded us that we needn't fear these black children – as long as "us white kids stick together."

# **A DREAM FOR ALL**

"Don't anyone talk to them," he commanded. We agreed. We'd follow our appointed leader and stick together.

"If they cause any trouble," Keith said, slamming his fist into his palm, "we'll show them who really runs this playground."

We weren't just counting on Keith; we were counting on our geography too.

For you see, while many U.S. towns were segregated by only railroad tracks, Richmond was segregated by a freeway. And with the district out of money for bussing, we thought our school would be safe from integration.

And it would have been – except for one thing.

"The tunnel," as the kids called it, was a darkened pedestrian walkway under our freeway that reeked of urine and was paved with broken soda bottles..

Located only a few hundred yards from our playground, the tunnel was forbidden territory. All of our parents warned that none of us were to ever cross through the tunnel that connected the black community to the white one.

So, one September morning in 1967, as troop strength in Viet Nam approached 500,000, a small group of 10-year-old soldiers in the war on prejudice emerged from the tunnel. They carried the look of a scraggly group of Pop Warner football players returning to a halftime deficit – overwhelmed both by the size of the field and the stakes of the game.

Among those kids were Deborah, Agnes, Geoffrey and Gregory. I still remember their names because that was the first time I truly "saw" a black person.

Usually my columns work toward a dramatic climax, but the most dramatic thing in today's story is that nothing happened. No drama. Nothing

No drama until that first Thursday in April 1968. Sometime after the evening fog returned to the Richmond hills, a friend came over to tell me he'd just heard that Martin Luther King had been assassinated in Memphis.

Now, almost fifty-five years, it seems to me that in the end, our little school became part of King's dream as it was "...transformed into a situation where little black boys and black girls will be able to join hands with little white boys and white girls and walk together as sisters and brothers."

That's my history. What's yours?  $\bigstar$

routinely received concerns from residents regarding safety along Old Auburn Road.

Concerns include excessive vehicle speeds, lack of pedestrian and bicycle infrastructure, safe crossings, increased congestion and a history of collisions.

Prior public outreach workshops which discussed the project were held in March and December of 2019.

New landscape buffers, enhanced pedestrian crossings, a consistent two-way left turn lane, roadway and pedestrian lighting and traffic signal modifications are just some of the features of the project, Kehrer said.

Kehrer said reducing the number of lanes not only aims to improve safety, but also discourages cut-through traffic along Old Auburn Road.

His presentation also described four "hot spot" intersections along Old Auburn Road that will be modified for increased safety. These include the intersections at Tiara Way, Sunrise Boulevard, Dannon Court, and Fair Oaks Boulevard.

Specific changes along the route help create what Kehrer described as protected intersections.

New corner islands will provide physical protection for bicyclists and pedestrians waiting to cross, reduce crossing distances for people bicycling or walking, and reduce speeds for turning vehicles, project illustrations show.

Set back crossings allow space for a turning vehicle to stop and wait for a bicyclist or pedestrian to clear the crossing without blocking through traffic, according to city engineers.

Residents voiced their comments concerning plans to improve the intersection of Old Auburn Road and Fair Oaks Boulevard and the outcome of initial steps installed in early 2020 to reduce traffic collisions.

The intersection has been the site of more than three dozen collisions involving a left-turning vehicle from Fair Oaks Boulevard colliding with a planter along Old Auburn Road.

The City of Citrus Heights has installed new signage to increase visibility of planter barriers, added striping to channelize turning cars, converted a right traffic lane to right turn lane only, installed clearer markings and placed a speed feedback sign. Some suggested the installation of speed tables along Fair Oaks Boulevard to further slow traffic.

These recent modifications have since reduced the collisions at the intersection by half, Kehrer said.

To improve both bicycle and pedestrian safety, a free right-turn lane from Old Auburn Road onto Antelope Road will also be eliminated along with the free rightturn lane from Old Auburn Road onto Fair Oaks Boulevard, Kehrer said.

The project is in its environmental compliance and public outreach phase, with the next phase of final design and rightof-way slated for 2024-2025. Next steps for the city through 2025 will be acquiring right-of-way permits and coordinating with utility companies.

The City of Citrus Heights has contracted with GHD, Inc., a San Francisco engineering consulting firm, to conduct first-phase design services. A timeline for phase two of the project has yet to be announced but will extend from Sylvan Corners to Tiara Way.

"We're hopeful to obtain additional funding for this project and begin construction before the end of this decade," Kehrer said.

# Missile Site's TCE Spreading to Border of Active-Adult Community

**SACRAMENTO REGION, CA (MPG)** -Remediating a trichloroethylene (TCE) plume that moved from the defunct Titan 1-A missile site in Lincoln to properties across the street and today bordering an active-adult community is a U.S. Army Corps of Engineers (USACE) priority.

That's what U.S. Army Corps' Sacramento District Deputy District Commander Lt. Col. Dianna Lively stressed during a Jan. 31 meeting with the grassroots Lincoln-based Titan1-A Missile Site Environmental Contamination and Remediation Committee. Right before an Army Corps' public informational meeting about the former missile site's soil vapor and groundwater contamination, Lively and other Army Corps representatives assured the committee that the agency was working on removing the contamination.

Minutes later at the public meeting, however, Army Corps representatives told about 250 residents that remediation would not begin until at least 2027. Army Corps representatives at both meetings would not estimate when remediation would start.

The Titan 1-A Missile site at 401 Oak Tree Lane in Lincoln was one of 18 former intercontinental ballistic missile (ICBM) silo sites in California, Colorado, Wyoming and Washington during the Cold War.

Each Titan 1 missile site stored three missiles in the underground silos. Beale Air Force Base 851st Strategic Missile Squadron near Marysville oversaw the Titan I missile sites in Lincoln, Chico and Live Oak. Lincoln's missile site operated from 1962 to 1965.

According to the Jan. 31 public meeting presentation, the Army Corps will place three soil vapor probes and a groundwater monitoring well at a church property located in between the missile site and the Sun City Lincoln Hills (active-adult community) border. The Army Corps will add probes and five monitoring wells along the Sun City Lincoln Hills border. The reason for the probes and the monitoring wells is because the federal agency "wants a better understanding of the amount of contamination in the area," according to Army Corps Deputy Chief for Public Affairs Tyler Stalker. "It's hard to say when everything will be finished," said Army Corps technical lead Matthew Marlatt during the public presentation. "We don't know yet." Asked by the Messenger Publishing Group when remediation could possibly start, Marlatt would not answer and said to look at the meeting slide that described the CERCLA process. CERCLA stands for the Comprehensive Environmental Response, Compensation, and Liability Act.



Sun City Lincoln Hills residents looked at charts and information from the U.S. Army Corps showing a trichloroethylene (TCE) plume bordering the activeadult community. The residents also listened to a presentation by Army Corps representatives saying that more information was needed to determine the contamination's extent.

The project is in the Remedial Investigation/Feasibility Study (RI/FS) phase. Samples of soil, soil vapor and groundwater are collected and analyzed to determine the contamination's extent. The Army Corps expects to finish the study in 2024, followed by a proposed plan in 2025 and an approved record of decision with the state of California in 2026, according to the Jan. 31 public presentation.

The U.S. Army Corps of Engineers is the federal agency responsible for cleaning up the contamination and the Central Valley Regional Water Quality Control Board is the state agency responsible for remediation oversight.

Exposure to high TCE concentrations can cause dizziness, headaches, sleepiness, confusion, nausea, unconsciousness, liver damage and death, according to the Centers for Disease Control and Prevention.

The Army Corps included a fact sheet in a Jan. 18 email blast inviting the public to the Jan. 31 public informational meeting.

The fact sheet stated, "However, the data collected as part of the Remedial Investigation (2018-2023) indicates that there is no imminent risk to residents that live or work near the former missile complex as the impacted soil vapor is within undeveloped land to the southwest, and groundwater is not used as a drinking water source. The Central Valley Regional Water Quality Control Board (Water Board), the government regulatory agency coordinating with USACE on this project, concurs with this finding.<sup>2</sup> The grassroots Lincoln committee has said that the health risks are not from the drinking water supply, but from TCE vaporizing from the groundwater.

view of the contamination and its spread or movement," said Lincoln City Manager Scully on Feb. 1. "...We consistently heard from USACE personnel about how important it is for the city and community to remain engaged on this issue as a partner in the process, so we will continue to advocate, participate and coordinate until remediation is complete."

Lincoln City Councilmember Bill Lauritsen had another perspective.

"The USACE presentation was disappointing on several fronts. although I have two main concerns. The first was the 'Area of Concern' or testing zone outlined within the yellow border on their maps. This 'Area' excluded Sun City, even though it goes right up to the Sun City fence and the area immediately downhill south from the already contaminated zone...," Lauritsen said. "My second concern is the timeline. If what I heard is right, the Army Corps of Engineers won't really begin remediation until 2029 at the earliest. This is not a pleasant thought. Developers want to build on this land and residents of Sun City are rightly concerned about the spreading contamination... We need to begin testing beyond the yellow line and push for a speeded-up calendar."

Eliminating the TCE "is not a fast process," said U.S. Army Corps Project Manager Tim Crummett. "When the record of decision is done, there's always the unknown. Things don't go as planned."

The Jan. 31 presentation was the Army Corps' second public presentation on the Lincoln missile site's remediation efforts.

During the first public presentation on May 31 at Sun City Lincoln Hills, Crummett said, "We have a carcinogen in the groundwater. It's under the ground. It's not too far from you. It's in your neighborhood. want it removed."

Crummett, at the May 31 presentation acknowledged that several Lincoln residents and the Army Corps representatives disagreed about the health risks and levels of TCE contamination in the groundwater. He said residents were not at risk.

Others, including Center for Public Environmental Oversight Executive Director Lenny Siegel, Lincoln resident and grassroots committee member Anne Constantin Birge, Lincoln City Councilmember Bill Lauritsen and Lincoln City Manager Sean Scully strongly disagreed and have pushed for remediation.






