# Breakfast is for the Birds



Bird-watching safaris promise sightings of up to 40 avian species at the Effie Yeaw Nature Center on March 16 and 24.

CARMICHAEL, CA (MPG) -Effie Yeaw Nature Center's popular Bird and Breakfast fundraiser has for 33 years proven there's more to ornithology than ogling birds.

In acreage resonant with morning song, experts will lead nature lovers next month on safaris to view birds in their most industrious season. Hot brunches will follow. Two Bird and Breakfast programs will span two weekends. Because these events sell out, reservations are required.

Participants will see dozens of avian species during incubation, courting, feeding and nest-building

activities. No bird gets excited by tiny finches as by majestic raptors.

The wildlife foray follows trails in the Effie Yeaw Nature Center's 99-acre reserve and continues to the American River, where ducks and waders abound.

Sacramento Audubon scouts visit the reserve beforehand to locate spots where wren, hawk, woodpecker and titmouse nurseries are under construction. Higher up, hummingbirds might be seen camouflaging walnut-sized cradles. Nestwatching is enhanced by viewing scopes.

The \$55 safari on Saturday, March 16 is followed by a hot breakfast. This excursion is best suited to participants aged from 12 to adult. On Sunday, March 24, a \$35

## Two in the **Carmichael** Murder-**Suicide Named**

**CARMICHAEL, CA (MPG) - As** of Monday, Feb. 26, two of the three people who died in the Feb. 17 murder suicide near the 5700 block of Shadow Creek Drive have been identified, according to the Sacramento County Coroner.

On the afternoon of Saturday, Feb. 17, Sacramento deputies were called to a townhome in a quiet area of Carmichael for a welfare check. At the residence, they stumbled upon the tragic discovery of three deceased individuals, two men and one woman. The cause of death for all three is gunshot wounds, according to media sources.

It is reported by media sources that the older male individual had shot and killed both the female victim and the younger male victim. It is also reported by media sources that the older male and the female victim were married and the younger victim is presumed to be their son but it has not been confirmed by

According to the Sacramento County Coroner, the female victim has been identified as Jennifer Elaine Evans-Brown of Sacramento. who was 45 years old at the time of her death by homicide.

authorities.

The deceased older male, allegedly the shooter, has been identified by the Sacramento County Coroner as Larry James Brown of Sacramento, who was 56 years old at the time of his death allegedly by suicide.


The 18-year-old male victim has still not been publicly identified as of press time.

# **Resident Travels to France** for Love of Braille

RANCHO CORDOVA, CA (MPG) - Elizabeth Symington of Rancho Cordova remembers the book that inspired her to learn braille. In college studying art, Symington found a children's book at the library. "A Color of His Own" by Leo Lionni, which paired color with texture and used braille.

The book inspired a series of artwork that Symington created in college and it began her lifelong love of braille.

"All art is texture driven and designed to be touched, so that was my draw to braille," Symington said. "I also love the allure and mystery of writing in a secret code."

Fully sighted, Symington decided to learn braille, starting with "A Very Hungry Caterpillar" by Eric Carle. She became a certified braille transcriber and executive director of the Sacramento Braille Transcribers, which produced her beloved braille children's books.

When the group merged with Sacramento-based nonprofit Society for the Blind in 2022, Symington began running the Society for the Blind's Braille Production and Training Program and will receive her credential and master's degree in May to become a teacher of the visually-impaired.

In braille's 200th anniversary year, Symington found herself with an extraordinary opportunity: in January, she went on a two-week trip to Paris with friends to study the history of braille and current usage, and to visit the small town of Coupvray outside Paris where Louis Braille lived.

Exploring Coupvray was a trip highlight. She walked through Braille's neighborhood and took a two-hour tour of his home.

"I learned so much at Louis' home," Symington said. "So much was on display and the tour guide let us touch whatever we wanted. It was really magical."

Symington toured the school where he taught, which is still in operation today with 125 youth in elementary through high school studying and living there while exploring their career passions. Across the street is a school for adults with vision loss and Symington was struck by the number of residents with low vision walking on the streets.

"I've never seen so many blind people walking around a city," Symington said. "Everywhere I looked, there was someone with a guide dog or cane out there being independent. I was seeing Louis' legacy and it was really powerful.'

Symington visited the church where Braille played the organ, went to his gravesite with wine and cheese and "just hung out with Louis."

"Sometimes, heroes can be larger than life," Symington said. "Visiting his grave reminded me he was a human and had his own struggles. He was an organist, teacher and inventor but he also was human.'

Symington was fascinated with seeing how France is using braille and supporting individuals who are blind or have low vision in public spaces. There were braille boxes of painkillers on pharmacy shelves and braille and tactile models that viewers could touch at museum exhibits. The braille was accurate, the dots were in good condition and the creators

knew how to communicate using texture, according to Symington.

Symington came home even more inspired to get individuals of all visual abilities excited about braille.

"Seeing how France is using braille and supporting people who are blind and low vision in public spaces really inspired me to want to make braille as cool as American Sign Language is," Symington said. "I want people to say, 'You read braille? Awesome!' Braille is literacy and so important, and I want to reduce the stigma around it."

Through the Braille Production program at Society for the Blind, Symington is seeing a high demand for braille. The program has about 30 transcribers nationwide with different specialties, from standard braille and varying language translations to tactile graphics, brailled music and proofreading. The program produces the Braille and Talking Book Library's newsletter, playbills for various theaters and more.

Eventually the program will include a training component where individuals with vision loss can train to produce braille as a career.

"You can spend a lifetime becoming an expert in one aspect of braille," Symington said. "I just love learning, and I love going to work every day. We have a strong and highly-skilled team working with everyone from preschoolers up to seniors. I'm really proud of all that we do at Society for the Blind."

Celebrating its 70th anniversary this year, Sacramento-based Society for the Blind creates innovative ways to empower individuals living with low vision or blindness to discover, develop and achieve their full potential. Since 1954, Society for the Blind has grown from a dedicated group of volunteers to a nationally-recognized agency and the only comprehensive rehabilitative teaching center that provides services for a 27-county region of Northern California and Nevada. The nonprofit organization provides low-vision eye care, life and job skills training, mentorship and access to tools to maintain independence for more than 5,000 youth, working-age adults and seniors experiencing vision loss each

# Local Girl Scouts Reach Outer Space!

Continued from page 1 California (GSHCC), and was bustling with camera crews, families, friends, and media. And cookies, of course.

Because the opportunity is so rare, the Girl Scouts were preparing since November for the event. Each Girl Scout prepared individual questions to ask Moghbeli, a very accomplished woman. Moghbeli is not only a NASA astronaut, but a United States Marine Corps test pilot, a Massachusetts Institute of Technology (MIT) graduate, a flight engineer, and the Mission Commander of SpaceX Crew #7. She is qualified to fly at least 25 different aircraft. Adding to her list of accomplishments, Moghbeli is the first professional Iranian American astronaut to fly to space. While on her space mission, Moghbeli spoke to the Girl Scouts for about 10 minutes until connection was lost.

Before the connection was established, the event began with comments from various speakers. Sue Richards and Amanda Bates, troop leaders for Troop 1089 and GSHCC volunteers, spoke briefly about how honored they were to have this opportunity and how it happened. According to Bates, there are only about 60 to 100 International Space Station contacts globally made per year, which is about two per week. In fact, the last two contacts occurred in Rome and Spain.

Next, Jennifer Garland spoke. Garland was the event's primary volunteer and is a River City Amateur Radio Communications Society member. She helped prepare the Girl Scouts for the big day by helping them practice their media and public-speaking skills. Garland told the crowd what to expect for the rest of the event and answered audience questions until playing a short video before the big moment arrived.

In the video, a pre-recorded Jasmin Moghbeli told a little bit

about her story. "I still wake up every morning and it feels like a pinch-me moment to think that I am actually an astronaut right be heard, and then Moghbeli's voice broke through, all the way from outer space, and the questions began. Each Girl Scout had

The time finally came to contact the astronaut: 10:24 a.m. precisely (as planned). A hush fell over the room as Garland began the countdown. Loud static could

To highlight some of the questions, Girl Scout Avery T. asked her what she is most excited for upon her return to Earth, to which Moghbeli responded, "My children, my husband, a shower with running water, and normal food."

On the other hand, Elsa W., another Girl Scout, asked what Moghbeli will miss about space. Moghbeli replied that she would miss her six crewmates who she has grown close to, floating and flying around in space, and looking back at Earth from her vantage point.

Then, Girl Scout Edie B. asked for what advice Moghbeli would give to a girl wanting to be an astronaut, and she replied that space exploration is very challenging to get into and that failing is inevitable but failing is also OK. And realizing that

failure is OK is the best way to keep moving forward with your dreams.

Next, Leia B., another Girl Scout, asked if Moghbeli believes in life beyond Earth and the astronaut said she does. "There's just too much out there," she said.

Moghbeli continued to answer questions about what she does in her free time up in space, what she eats there, what the average workday looks like and if she would live on Mars.

Alyssa S. asked if she listens to music or podcasts in space. Moghbeli highlighted a few of her favorite artists she listens to: Hozier, Whitney Houston, and Stevie Wonder.

Much was learned in such a short time span. Each question was well-executed, and the process went smoothly. The room erupted into cheers once the Girl Scouts wished Moghbeli a safe return to Earth and signed off.

After the call, each Girl Scout was handed a special badge to commemorate what they accomplished. Then, each Girl Scout, all in high school, took to the microphone to briefly discuss how this event might inspire them to study science and/or space exploration.

"Through events like this and other STEM programs, Girl Scouts is committed to helping our future female leaders become better problem-solvers, critical thinkers and gain the confidence to turn their ideas into breakthrough inventions to help others," said Dr. Linda E. # Failing Our Newborns

She opened a business to deliver babies, then California policies drove her out of the country

Madeleine Wisner dreamed of making community midwife services available to all expecting parents regardless of their income when she opened Welcome Home Community Birth Center in south Sacramento.

But 451 births and five years later, Wisner is packing up her family and moving from California to New Zealand, where government policies are far more favorable to midwifery. She closed her birth center in October.

Wisner was the only licensed community midwife who took Medi-Cal patients in the greater Sacramento region, but she's leaving, she said, because it was impossible to sustain the birth center. Insurance refused to pay two out of every three claims she submitted for services including prenatal visits, labor and delivery, at-home postpartum check ups, and lactation consultations, Wisner said.

"The entire system is not made for us," Wisner said. "I look at Medi-Cal as the standard of care, and midwives should be part of the standard of care."

Her experience and decision to leave reflects larger problems for California midwives highlighted in a new study released today from UC San Francisco's Osher Center for Integrative Health. It focuses on community midwives who work outside of hospitals but have licenses and training to perform much of the same reproductive care doctors provide to women with low-risk pregnancies.

The report warns that access to maternity care will worsen in California if the state does not increase the number of community midwives who are Medi-Cal providers at a time when hospitals are shutting down labor and delivery wards and maternal mortality is trending upwards.

Seventy-five community midwives are registered with Medi-Cal, according to data provided by the state6. More than 1,000 nurse midwives are registered with Medi-Cal, but the majority of those providers work in hospitals and not in community settings, researchers said.

Outdated licensing requirements, tortuous state regulations and cumbersome insurance policies make it nearly impossible for community midwives to accept Medi-Cal patients, the UCSF report found.

Medi-Cal is the state's health insurance program for extremely low-income residents. It pays for 40% of all births statewide, and midwife care is a guaranteed benefit for expecting mothers.

On paper, the benefit includes community midwifery, which focuses on providing care close to where people live either at a birth center or in the home. But the reality is different, researchers and providers say.

"So many people who have taken Medi-Cal in the past have had to stop or close their practices, and so many people who want to have not been able to make it happen," said Ariana Thompson-Lastad, lead author of the study.

#### California's Momnibus' Act

The UCSF findings come at a time when the state is trying to make inroads against persistent maternal and infant health disparities, particularly among Black families. Statewide surveys show Black mothers are the most interested in alternative birth support through doulas and midwives, which have been shown to improve a variety of birth outcomes. Doulas are birth workers who

provide non-medical social and emotional support during and after pregnancy while licensed midwives are clinically trained professionals who can provide a range of independent reproductive care for low-risk moms and babies. In an effort to chip away at

at-home birth outcomes show that when trained midwives care for low-risk patients, cesarean section and preterm birth rates decrease while breastfeeding rates and reports of satisfactory birth experiences increase. Severe outcomes and deaths of mother and baby are exceedingly rare and similar to the rates found in planned hospital births. UCSF researchers also found that community midwives see patients more frequently before and after birth and are able to catch complications early.

The majority of Medi-Cal births – more than 80% — are babies of color. They and their mothers suffer some of the worst infant a maternity desert situation. Literally hospitals are closing, and birth centers will be a necessary strategy for that."

#### One Of Her Last **California Patients**

In a cozy house in Sacramento's Oak Park neighborhood, Wisner has Chloé Mick lie back on her couch while her kids and husband play outside. Wisner measures the length of Mick's uterus, feels for the baby's position and they both listen to the baby's heartbeat. Mick is 25 weeks pregnant and tired.

"I feel the most depleted probably just from having two other children that I hope I have the inner strength to not get a bad attitude during the process and make it through," Mick tells Wisner.

Wisner responded, "Has it occurred to you that having a bad attitude is OK?"

Mick is planning a home birth, and Wisner assures her that going to the hospital would not be "giving up." It would be listening to her body's needs and responding appropriately. They make plans for what to do if the baby is breech or if Wisner's New Zealand visa comes before Mick gives birth. When Mick's second child was born, she was on Medi-Cal and Wisner was the only midwife who would take her.

"(The hospital) really feels like a business. You're in and out, and you don't have a rapport or relationship with them... It feels like your bodily autonomy is taken away," Mick said. "And then you look back, and you wish you had done things different."

Wisner wishes her birth center's story had ended differently. Her practice finally had enough patient volume to maybe be sustainable, she said, but the other community midwives who worked with her didn't want to argue with Medi-Cal insurers day in and day out. Over the past five years, Wisner estimates she poured \$250,000 into the birth center to keep it open. It's a big reason why she's leaving California for another country where she'll make \$60,000 a year working four days a week with a team of other midwives. "There was always this prom-

ise that the system would be reformed, you know, Medi-Cal is gonna get reformed," Wisner said. "I was really let down."

inequities, state lawmakers passed the "California Momnibus Act" three years ago. It required Medi-Cal to cover postpartum care for a full year after birth — the period when most maternal deaths happen — and added doula benefits. In January, rate increases for California doulas made them the highest-paid in the nation.

But state regulations simply aren't designed to accommodate the services community midwives provide, UCSF researchers found.

For example, the Medi-Cal application until recently asked midwives to list a supervising physician even though licensed midwives are authorized to practice independently. Providers also said most community midwives conduct home visits during pregnancy and especially after birth, but Medi-Cal billing policies make it difficult to get reimbursed for services that happen outside of a clinical facility. "The overarching policy

issue for licensed midwives in California is that we continue to be regulated under a very dysfunctional arrangement," said Rosanna

Davis, president of the California Association of Licensed Midwives. Wisner, who served mostly

Medi-Cal patients, said on average

insurance reimbursed just 17% of her costs — roughly \$1,451 out of \$8,500 for a full course of prenatal, birth and postpartum care — and frequently took months to pay her.

"We've had people have two or three babies with us before we get paid for the first one," Wisner said.

The state is trying to make improvements, said Holly Smith, co-lead of the California Midwifery Learning Collaborative, but the system is still "failing a lot of people." The midwifery learning collaborative is a five-state initiative aimed at improving access to midwife care. The state agency that oversees Medi-Cal recently joined,

In an emailed statement, the Department of Health Care Services said it is working closely with the midwifery learning collaborative to help midwives "successfully navigate and work within Medi-Cal." The department is using a document drafted by the collaborative to "continue making program and policy improvements" on issues related to billing and applications, the statement said.

# Midwives Could Help

Fill Maternity Gaps Large studies of birth center and

and maternal health outcomes. Even though the state has made improvements overall, it has struggled to curb severe pregnancy complications and death among Black women and babies. Black women of all income levels are more than four times as likely as white women to die from pregnancy-related complications and their babies are nearly three times as likely to die within a year, according to state data. Physicians deliver the vast

majority of babies in California, and while the percentage of babies delivered by certified nurse midwives has increased slightly in the past decade most certified nurse midwives work in hospital maternity wards under doctors. Often when maternity services end, providers leave

At least 46 hospitals have closed maternity wards since 2012, leaving a dozen counties without a single hospital delivering babies, a CalMatters investigation found. Smith, with the midwifery

learning collaborative, said historically state laws and policies have supported physician-only maternity care.

Honestly? This idea isn't a lot like real estate at all. Real estate will run itself for the most part—once you find a tenant. Also, the number of hours you'd have to put into selling real estate on the side is nothing like the time you'd spend getting a new business off the ground.

Here's the deal, Victor. The secret ingredient to your small business success is you. You are the ideas, the passion and the energy. The problem with your plan is that you are only a small part of the equation. Franchises and chains try to train this kind of stuff into people with pep talks and other forms of motivation, but when something's your

Why does milk cure the spicy feeling in your mouth after you eat something spicy but water doesn't? - Eloise, 10, Minnesota

My work as a science cat has introduced me to human foods—like chips and salsa. I love the spicy taste of salsa, but I always keep a saucer of milk handy.

I talked about why milk calms the spicy feeling with my friend Emily Cukier. She's a chemistry librarian at Washington State University.

She told me that the spicy feeling comes from something called capsaicin. The amount of capsaicin in a pepper determines how hot it is.

When you bite a hot pepper, little bits of capsaicin stick to special proteins that sit on the nerve cells on your tongue. The proteins are called receptors.

"When capsaicin binds to its receptor, the receptor opens up and tells the nerve cell to fire," Cukier said. "That sends a signal to your brain where it's interpreted as heat and irritation."

One way to stop the spicy feeling is to unstick the bits of capsaicin from the receptors. But capsaicin doesn't mix well with water. No matter how much water you chug after eating hot peppers, the water will just slosh over the receptors. It won't wash away the capsaicin.

But milk has two things water doesn't have: fats and a protein called casein. That protein attracts capsaicin like catnip. If the protein is around, the bits of capsaicin will hop off the receptors. The protein forms globs around the capsaicin. It's like how soap forms globs around dirt and grease when you wash your hands. Then, the protein and fats in milk work together to wash away the capsaicin.

Once all the capsaicin has left your receptors, the "spicy" signal to your brain stops.

Cukier told me that another way to deal with the spicy feeling is to eat dry, rough foods. Like crackers or chips.

"Those foods will produce different sensations in your mouth that can distract your brain from the spiciness," Cukier said. "That why they're often served with spicy foods."

Like my chips and salsa.

So, why don't we just avoid foods that hurt? It turns out the spicy signal also causes your brain to release endorphins—sometimes called "happy hormones." They're the same chemical signals your brain releases when you play or hug someone you love.

So, capsaicin can make us feel good at the same time it makes us feel a little bad.

Eating lots of spicy food could make you less sensitive to it, too. Over time, your tongue can adjust to having lots of capsaicin around. The nerve cells slurp in some of the receptors so they're no longer poking out of the cells. That means there are fewer places for capsaicin to stick—and less of that spicy feeling.

Maybe that's why, after years of living and eating with humans, salsa makes me pep-purrr.

# **Social Security Matters** About Medicare's Dreaded "IRMAA" Provision

Dear Rusty: My wife is on Medicare and receiving Social Security benefits each month. We built a house and used money from our investments to pay for it. We knew we would pay taxes on that withdrawal, but my wife got a letter from Social Security saying that because the money we withdrew was listed as income, her 2024 Medicare premium went up over \$500. And since Medicare is taken out of her Social Security, that results in a \$6,000 loss to our budget.

Is there anything that can be done about this situation? We sent a letter to Social Security, but they responded that unless her situation was one of only a few categories (loss of house, divorce, etc.) nothing could be done for the year.

The money was used strictly on another investment - our new house. It wasn't like we took it out and spent it wildly. Can you please advise? Signed: Frustrated Homeowner

Dear Frustrated: Unfortunately, it sounds like your wife is a victim of the Medicare provision known as "IRMAA" - the "Income Related Monthly Adjustment Amount." Each person's Medicare Part B premium (coverage for outpatient healthcare) is determined yearly from their income from all sources as reported to the IRS two years prior. IRMAA sets income thresholds, depending on your IRS filing status, and if those thresholds are exceeded you must pay a higher Medicare Part B premium (and also a higher Part D premium if you have prescription drug coverage). Assuming you file your

taxes as "married/jointly," if your combined 2022 income as a couple was between \$206,000 and \$258,000 your wife's 2024 Part B premium is \$244.60 (instead of the standard \$174.70); if your combined 2022 income was between \$258,000 and \$322,000 then your wife's Part B premium for 2024 is \$349.40; if your combined in 2022 was between \$322,000 and \$386,000, her Part B premium is \$454.20; if your combined 2022 income as a married couple was between \$386,000 to \$750,000 then your wife's 2024 Part B premium is \$559; and if your 2022 income as a married couple was over \$750,000 your wife's Part B premium is \$594. If your wife also has private Part D prescription drug coverage, IRMAA also increases those premiums. Note that the IRMAA thresholds are different for other income tax filing

As the Social Security office has already explained, you could appeal your wife's IRMAA premium increase if she had a "life changing event," but the list of acceptable life changing events is quite small (see form SSA-44). The only good news is that your wife's Medicare premium will be calculated anew for next year, so her Medicare premium for 2025 will – if your 2023 joint income is less than the first IRMAA threshold - revert to the standard 2025 premium.

FYI, it doesn't matter what you used the money for. Your withdrawal was reported to the IRS as taxable income, which is what caused IRMAA to apply to your wife's Medicare premium for 2024. Many people don't realize that Medicare premiums are higher for those with a higher income, but since your withdrawal was a onetime event, your wife's Medicare Part B premium next year should be much less and her Social Security benefit correspondingly higher.

# Sacramento, California's Capital, Is Also The Capital Of Official Sneakiness

Sacramento California's capital, but that distinction is quickly being overshadowed by the city's penchant for official sneakiness.

City officials' hide-thepea tendencies first became obvious in December when the city council, after adjourning its regular meeting, reconvened for a special meeting to ratify new contracts with two employee unions.

Then, without any advance notice, it voted to give City Manager Howard Chan, already the state's highest paid city administrator, and several other top officials hefty salary raises.

Doing so was a blatant double violation of California's Brown Act, which requires local governments to do their business openly. One section of the law requires 24-hour public notice of special meetings and another bars local governments from considering salary increases for their executives in special

Moreover, the council voted for those raises even though Chan and other city officials knew that Sacramento had a \$50 million hole in its budget, although that was not publicly announced until a month later.

The Sacramento Bee blew the whistle on the illegal meeting and the city quickly retrenched. "The city agrees that an item regarding the salaries of its charter officers should be voted on at a regular meeting of the council," city spokesman Tim Swanson told the Bee. "The city will bring this item back at the next regular meeting of the City Council on Jan. 9."

When the \$50 million deficit was finally revealed in January, Chan said it resulted from union contracts and other spending that outstripped revenues.

"What you all approved we can't afford," Chan told the council. "It's not sustainable." He ordered city departments to freeze hiring, travel and purchases to save money.

The obvious implication is that Chan and other officials wanted to lock down their salary increases before revealing the big gap in city finances

However, it was not the only example of municipal sneakiness.

This month, after materials for the March 5 election were distributed to voters, Sacramento's small businesses and professional service providers were surprised to learn that a city-sponsored ballot measure, if passed, would increase their city business license fees by 70%.

Why, one might wonder, were those affected by the fee increase so surprised?

In turns out that the city council, with little discussion, had voted to place Measure C on the ballot way back in November, but

city officials failed to honor a provision of the city charter requiring that a notice of the action be published in the city's official newspaper within 10 days.

In fact, it didn't publish it until Feb. 7, much too late for opponents to submit ballot arguments against it, and "only after The Bee Editorial Board had repeatedly requested a copy," the newspaper reported.

There are late-blooming efforts by business groups to mount a campaign against Measure C, the Bee has editorialized that it should be rejected due to the sneaky process and if it passes, its validity will certainly be challenged in court.

City officials continue to insist that the delay in publication was an innocent mistake that should not invalidate the measure because the city published it on its own website.

During a city council meeting this month, Mayor Darrell Steinberg acknowledged the error but insisted "it was not a mistake ... that in any way was attempting to mislead, and I think the best evidence of that, again, is the fact that the ordinance and the deadlines for filing the arguments were published online the very same night."

The message to Sacramentans from these two incidents is that sneakiness is now official policy and they cannot rely on its officials to reveal what they are doing.





# **California Continues to Expand** Hydrogen-Powered Passenger Rail Fleet

#### SACRAMENTO, CA (MPG) -

Caltrans today announced a \$127 million agreement with Stadler Rail, Inc. for six more zero-emission, hydrogen-powered passenger trainsets, building upon an earlier order to deliver the first four hydrogen-powered intercity trainsets in North America, furthering California's standing as a world leader in clean

The trains will help California adapt to climate change by strengthening the state's zero-emission passenger rail capabilities. The first trains are expected to enter revenue service in 2027. The trainset design will make them more efficient, lighter weight and more affordable than traditional locomotive-hauled coaches.

transportation.

The purchase is funded through Governor Gavin Newsom's historic \$10 billion, multiyear zero-emission vehicle package, which included \$407 million for the California State Transportation Agency (CalSTA) to purchase or lease state-of-the-art clean bus and rail equipment and infrastructure.

The first trains will operate between Merced and Sacramento on the future Valley Rail service - an expansion of the existing **Altamont Corridor Express** (ACE) and Amtrak San Joaquins services that will eventually connect with the first section of California's high-speed rail service. The trains will also be demonstrated on corridors throughout the state in coordination with intercity and regional rail partners. With this option order, there are 19 option trainsets remaining on the base contract that Caltrans signed with Stadler in October 2023.

"California continues to lead the way to a cleaner, more connected transportation system," said California Transportation Secretary Toks Omishakin. "By expanding our fleet of hydrogen-powered passenger trainsets, we are showing we are serious about deploying innovative and sustainable transportation options for the people of this state."

"These clean-energy trains are the future," said Caltrans Director Tony Tavares. "California is

building a climate-resilient transportation system that will help every community move around the state in a safe and sustainable way."

The vehicles will be based on Stadler's successful Fast Light Intercity and Regional Train (FLIRT) concept, extending work done with the San Bernardino County Transportation Authority to develop self-powered multiple-unit trains using zero-emission hydrogen fuel cells without the need of a separate locomotive.

"We are very proud to be

providing additional hydrogen trains to the California State Transportation Agency and Caltrans. With our multiple units, we are jointly driving the decarbonization of rail transportation in the U.S.," said Stadler CEO Martin Ritter. "We thank CalSTA and Caltrans for their trust and look forward to deepening our partnership."

California continues to build momentum in its nation-leading effort to harness clean renewable hydrogen power, critical to cutting planet-warming pollution and expanding the clean energy economy statewide. Caltrans' purchase of the first four trainsets in October came one day before the U.S. Department of Energy announced California will receive up to \$1.2 billion as one of the country's hydrogen hubs to accelerate the development and deployment of clean renewable hydrogen.

# As California Closes Prisons, the Cost of Locking Someone Up Hits New Record at \$132,860

#### SACRAMENTO REGION CA (MPG) -

The cost of imprisoning one person in California has increased by more than 90% in the past decade, reaching a record-breaking \$132,860 annually, according to state finance documents.

That's nearly twice as expensive as the annual undergraduate tuition — \$66,640 — at the University of Southern California, the most costly private university in the state.

California's spending per inmate jumped steeply during the COVID-19 pandemic and it continued to increase despite recent cost-cutting moves, including Gov. Gavin Newsom's recent move to close three state prisons.

It's propelled by lucrative employee compensation deals and costly mandates to improve health care behind bars, according to fiscal analyses by the nonpartisan Legislative Analyst's Office. Newsom's most recent budget proposal includes \$18.1 billion for the Department of Corrections and Rehabilitation, up from \$15.7 billion when he took office in 2019.

Some lawmakers and advocates have argued California should focus on rehabilitation and shut down additional prisons to save money in the face of what the governor's office projects to be a \$38 billion deficit.

Last year, the Legislative Analyst's Office suggested the state could close as many as five more state prisons because of California's declining inmate population.

That would stand to save upwards of \$1 billion in operating costs, and even more money on unfunded capital improvement projects, the report said.

Newsom's three closures and the cancellation of a contract for a fourth privately run prison save the state an estimated \$667 million over the next year, according to the Department of Finance, but the savings are not enough to offset increased operational and employee costs.

employee costs.

The California Correctional Peace Officers Association, which represents 26,000 prison guards, last summer negotiated a contract with successive 3% raises and other perks that will cost the state roughly \$1 billion over the next three years. The prison doctors' union, which represents 1,700 employees, also negotiated a two-year contract with a combined 5.5% general salary increase and a range of other incentives. The Newsom administration estimates it will cost \$234 million over

three years.

But Newsom, at least for now, is not recommending any additional prison closures. Instead, his state budget proposal recommends keeping prisons open with fewer inmates in them to provide more space for rehabilitative programs.

"The administration is not currently proposing any additional prison closures," H.D. Palmer, spokesperson for the Department of Finance, said in a statement. "We remain committed to meeting the needs of staff and the incarcerated population while right-sizing California's prison system as the

the need for cost-efficiency while maximizing public safety, the wellbeing of incarcerated people and successful rehabilitation."

The actual cost to house a prisoner is much closer to \$15,000, said Caitlin O'Neil, a criminal justice analyst for the nonpartisan Legislative Analyst's Office. Direct

Capitol. It has contributed \$2.2 million to the campaigns of current state legislators and it gave \$1.75 million to help Newsom defeat a 2021 recall campaign. It also recently contributed \$1 million to support Proposition 1, the measure Newsom placed on the March ballot to build housing and treatment

"If you don't cut (budgets) carefully, that makes prisons worse places to be. It makes them more dangerous, more traumatic," Pfaff said. "I say that as someone who is not a fan at all of prisons as a general institution."

Medical care is one area of increased spending where the state, under court order, is trying to improve prison conditions.

The average cost per person for medical care has more than doubled in the past 10 years, and total health care spending by the corrections department has increased by about 67%. Although the recent prison closures have cut about 2,700 correctional positions, medical spending has eaten up those savings.

Former Assembly Budget Chair Phil Ting, a Democrat from San Francisco, said corrections is the only state program where having fewer people translates into more spending. In 2022 Ting proposed closing three more prisons to bring down fixed costs and account for the shrinking number of prisoners.

"If we were educating 50% less kids, you'd see the funding go down. If we had 50% less people in health care or 50% fewer families using CalFresh, the programs would go down," Ting said. "So how is it at a time when the prison population has not just gone down a little bit, has gone down significantly, that spending increased?"

There were roughly 15,000 empty beds last year in prisons across the state, according to the Legislative Analyst's Office. That number, driven largely by decades of sentencing changes and court-ordered mandates to decrease prison crowding, is expected to reach 20,000 over the next three years.

"We're not not talking about some very small number where they want to keep a little bit of a buffer," Ting said. "They want to keep three to five empty prisons up and running."

Ting, who is no longer the budget chair, said he may still push this year to shut down more prisons.

prison population declines over time, and to addressing space needs as the state transforms the carceral system to one more focused on rehabilitation."

Opponents of mass incarceration say the administration's argument for keeping empty prison beds open doesn't align with how the money is spent.

"This is a cash grab by (the corrections department)," said Brian Kaneda, deputy director of the prison abolitionist group Californians United for a Responsible Budget. Newsom has touted transforming San Quentin State Prison into a rehabilitation center, but advocates like Kaneda and state advisory groups say the plan is vague.

Rehabilitation costs, which currently include prisoner education and activities, only make up a fraction of total correctional spending — roughly 3% — over the past decade, according to state budget documents.

In a written statement, the corrections department said its spending plan "judiciously uses taxpayer dollars in a manner that balances costs include things such as food and clothing while the remaining 91% of spending per prisoner comes from fixed costs like salaries and facility upkeep.

She found that compensation for employees at the corrections department increased by 43% between 2010 and 2019 — from \$110,000 to \$158,000 — nearly triple the rate of inflation.

Last summer, the state prison guard contract included \$10,000 bonuses for officers at certain prisons and a new guaranteed 401k contribution in addition to regular pension benefits.

The state's current savings from prison closures, about \$200 million per facility, is not nearly enough to offset those pay and benefits boosts.

"We would have to close one or more prisons per year just to offset employee compensation increases that happen regularly," O'Neil said.

The peace officers' union did not respond to requests for comment. Prison labor advocates often argue that jobs are dangerous and difficult to staff, warranting high compensation benefits.

The union can be a force in the

facilities for people with serious mental health conditions.

Despite a precipitous decline in prison populations, corrections spending has remained relatively stable. In 2018, the average daily prison population topped 120,000 compared to a projected 90,240 people in 2024. That's a 25% decrease. In contrast, correctional spending as a share of the total state budget has barely dropped in the same time period from 7% to 6%.

What should be good news to opponents of mass incarceration — decreasing populations — has not resulted in a leaner criminal justice system.

"If you have \$700 million in annual savings from prison closure, but you're spending hundreds of millions of dollars on new prison infrastructure and giving prison guards a billion dollar raise (over three years), that starts to show why the math isn't mathing," Kaneda said.

But wholesale cuts to correctional spending don't necessarily always equate to better prison conditions, said John Pfaff, a law professor at Fordham University.

# Reducing Ambulance Patient Offload Time

#### SACRAMENTO REGION, CA (MPG)

- Every second counts in an emergency, and when it comes to medical emergencies, time is of the essence.

The time it takes for an ambulance to offload a patient to the emergency department (ED) can make all the difference; the longer the wait, the more critical their condition can become.

It's an emotional and stressful situation for patients and their loved ones, who are already worried about the outcome of their medical emergency.

As the population of Sacramento County continues to grow, so do the demands on its emergency medical services. One crucial metric that affects patient outcomes and the overall efficiency of emergency medical services is the Ambulance Patient Offload Time (APOT).

The time interval is between the arrival of an ambulance patient at an ED and the time that the patient is transferred to the ED gurney, bed, chair or other acceptable location and the emergency department assumes the responsibility for care of the patient. In Sacramento County, that time has hit a high of 72 minutes but the county has an ambitious goal to drop that time to 20 minutes.

This goal comes as Assembly Bill 40, which takes effect on July 1, will require every local EMS agency to develop a plan not to exceed 30 minutes for 90% of ambulance arrivals and report the standardized time to the authority.

Sacramento County, with prehospital providers, local hospitals, interested community members and Sacramento County Board of Supervisors Patrick Kennedy and Pat Hume,

shared their innovations and best practices Feb. 13 to address the Ambulance Patient Off-Load Time crisis.

Dr. Gregory Kann stated the importance of sharing ideas and innovations to create better services for all, adding that out of this crisis comes opportunity.

Sutter Roseville, a not-for profit hospital that is part of the Sutter Health network, shared a real-time data system implemented to monitor its Ambulance Patient Offload Time. By using its medical health record system, EPIC, Sutter Roseville tracked a patient's emergency room trip from entrance to transfer, allowing obstacles to be identified and any issues to be corrected.

The hospital leadership also educated staff to help identify when a patient needed ER treatment or could be moved to another department or service. These efforts helped the hospital reduce the time from 100 minutes to 31 minutes, according to the Sutter Roseville presentation.

A Sacramento Metropolitan Fire District (SMFD) presentation approached the Ambulance Patient Offload Time issue another way. The fire district implemented the county's revised protocol (Policy Number 5050 – Destination), which authorizes patients to be taken to their medical health system's hospital, instead of the closest hospital, allowing for

faster treatment since their medical records were already there.

The Sacramento Metropolitan Fire District also determined if a patient needed to be directly taken to the ER or if they could safely wait in the lobby. The fire district also partnered with other ambulance providers to provide additional ambulances to support the 9-1-1 system.

The fire district implemented a Mobile Integrated Health program, which means a Physician Assistance/Nurse Practitioner teams with a paramedic who responds to calls and determines what a patient might need and if they can be treated at the scene without going to the emergency department.

The Sacramento Metropolitan

Fire District's innovations aim to get patients to the right place the first time, whether that's the ER, lobby or another service, according to the presentation.

The Feb. 13 event demonstrated that local hospitals, prehospital provider and the Sacramento County Board of Supervisors are strongly committed to improving Ambulance Patient Offload Time and emergency medical services, according to the county. With continued collaboration, innovation and inspiration, Dr. Kann emphasized that these conversations are what will fuel the plan to better lead the Ambulance Patient Offload Time and deliver better outcomes for patients in Sacramento County.
