# **Community Garden and Composting Hub** in Gridley: The Garden at St. Timothy's

GRIDLEY, CA (MPG) - What can you do with a plot of land that's empty and full of weeds? Plant a garden and start composting with your neighbors! St. Timothy's Episcopal Church in Gridley, with the help of generous grants from the Episcopal Foundation of Northern California and California Alliance for Community Composting, has transformed the lot next door to the Church at 450 Jackson Street into a garden and composting center for the community. It is a place to grow food or learn how to garden, a drop-off site for compostable kitchen scraps, and a peaceful outdoor space for people to enjoy.

The Garden at St. Timothy's opened to the public in May 2023 with 20 newly- built and filled garden beds for rent in the following sizes: 5'x6' at \$15 per year, 5'x8' or 4'x10' at \$20 per year, and 5'x10' at \$25 per year. Each bed has drip irrigation. The yearly enrollment price includes both water and irrigation supplies,

which are provided by St.

children's garden and mud kitchen, an outdoor sink and potting area, as well as shaded seating and pleasant surroundings for those who gather.

#### **Energy Efficiency** Programs, Planner vs. Consultant, and the AT&T **Decision**

GRIDLEY, CA (MPG) - The Gridley City Council meeting came to order at 6 p.m. on Tuesday, February 20. Council Members in attendance were Mike Farr, Bruce Johnson, J. Angel Calderon, Catalina Sanchez, and James Roberts.

The January 2024 Expenditure Report was produced and can be viewed by the public at http://gridley. ca.us/public/uploads/ pdfs/022024 Agenda.pdf.

Items on the agenda for consideration and discussion were:

Item #4, the 2024 energy efficiency rebate programs, presented by Finance Director Elisa Arteaga.

Item #5, discussion concerning city consultants, presented by Vice Mayor Bruce Johnson.

Item #6, AT&T phone utility service discussion, presented by Council Member Catalina Sanchez.

Elisa Arteaga began

the discussion for item #4 with the staff report. "We've talked about this in the past, bringing forth rebates and what programs we want to bring to the residents of this town. Historically we have had energy efficiency services that have helped us with a lot of these programs. They usually come in and do the energy audits where they would go into people's homes and do a review. We used to send them out when a customer would come in with concerns about their utility services. This was pre-COVID. We also used to refer customers to HEAP which is an energy program where they give an allotment of a flat amount based on income. The issue with HEAP is, you can give a customer funds every year, but other than rebates, assisting customers with finding ways to lower their costs is important. There is also the website development where customers can click on a link and find which rebates they may be interested in. This will be a new format coming soon." She asked the Council to consider the need to

develop programs that will assist not just low-income and seniors, but will be available to everyone, including commercial customers. And getting the information out there through bill inserts and online. When asked where

the money would come from for these programs, Arteaga pointed out, "There is a section

thing in situations like yours. But more than feeling indebted to someone or experiencing a sense of guilt or shame, it's really a discussion about differing views of marriage.

You're never in debt to your spouse. You should be all in where your husband or wife is concerned. Remember the vows? For richer, for poorer. In sickness and in health. If she makes you chicken soup when you're sick, does she charge you for it? Of course not. When you get married, you agree to take on each other's burdens. Once you walk down the aisle with someone, you're choosing to serve each other. You're also choosing to take on each other's debt, each other's income, each other's assets and each other's crazy parents. Every-

It all boils down to having a shared view of a proper marriage relationship. And the proper (and biblical) view is we own everything. There's no mine and yours anymore. Now, you can't make her feelor not feel—a certain way. But you can ask her questions to understand where she's coming from and what blockers are keeping her from being totally together in this. Talk about it. Put your heads together and practice thinking about your marriage as a union.

It will take some encouragement from you and some getting used to on her part, but if you work together, it's a muscle you can grow and develop together!

on everyone's utility bill titled 'Public Benefit.' It is a percentage of the consumption that customers are getting billed for. There's a formula where 2.85% of the bill is taken each month for the public benefit programs. It can go up or down depending on how much energy you use, but that percentage is put into a special fund. The city cannot use that fund for anything other than something that benefits the public. That would be utilized to establish the programs and also to continue to fund some of these programs."

In conclusion, Arteaga said she would like to get back with the consultants and find out how much it's going to cost for each program. She also suggested looking into EV (Electronic Vehicle) programs. "A rebate could be available for anyone who purchases an EV. There is one EV project that is currently underway. Two properties in Gridley have been purchased specifically for establishing EV charging stations," she said.

Item #5 was presented by Vice Mayor Bruce Johnson. He put forth the possibility of opening a full-time planning position as opposed to having consultants on call, and also wanted to review the contracts that are over five years old. "The financial cost of doing a full-time planning position would be the main thing for sure. But we need as much information brought back to us so we can make a decision on that,"

A study was suggested by Sanchez to look into what other cities in the area are doing with their city planning departments. "Other cities have a full planning department and we don't. We could do a city-to-city comparison and find out what benefit or what hardships that may bring."

Mayor Farr said, "I believe that is a good idea to bring that forward and look at it because our city is growing. Housing complexes are going up — a lot of things are growing too. I think we need a fulltime planner behind the desk downstairs to facilitate the projects as things move on."

Arteaga added, "It's important that we do a study session. Because we can look at all the services and we can tackle it by looking into services vs employee comparisons." The Council agreed.

Item #6 was brought to the Council by

Catalina Sanchez. "AT&T wants approval from the CPUC (California Public Utilities Commission) to discontinue the obligation of providing landline services. There is a map available online as to who would be those impacted customers, and that would be around 500,000 people. So right now that process is pending and they are having a few scheduled public hearings in February and March on this matter. Basically, there have already been people speaking up, saying they are really concerned about this. They believe AT&T is a reliable service to them, especially in rural areas where wi-fi may not be reliable."

AT&T sent out a letter to their customers stating, "that no customer is being left without service, and we are not canceling service in California. Our customers will not lose access to voice services. If they do not have alternatives, ATT will continue to provide them with copper-based traditional service. AT&T is working to update antiquated copper phone lines to ensure customers have better technologies from them or another provider."

Sanchez said, "The letter says, no changes are being served at this time and we'll let you know when and if any changes will affect your service. So that means after, whether they are approved or not, that all this can change, so I don't see any clear commitment."

Sanchez called for a motion to submit a letter of opposition to AT&T's request to the CPUC to end their obligation under their current obligation as a carrier. A roll call vote was called and passed by 4 to 1.

The city administrator reports included a Butte County COVID review, recommendations on a public health plan, and a plan on emergency operations in the future. Gridley needs to be prepared for not just viruses, but floods, earthquakes, and such. When COVID hit, all were unprepared. Grants are available for health and emergency services. The Council agreed to address the emergency preparedness of Gridley.

The meeting adjourned at 6:53 p.m. The next meeting is scheduled for March 4.

Continued from page 1 August of 2023 with generous help from the Butte Environmental Council. Anyone in the community may sign up to drop off kitchen compostable materials at the garden, for example: fruit and vegetable scraps, eggshells, coffee grounds, and paper napkins (no meat, bones,

fat, oil, or dairy). All compost produced at the garden will be used at the garden or shared with those who donate kitchen scraps, while reducing the amount of organic waste going to the landfill. The Garden at St. Timothy's is part of a larger effort by the Episcopal Diocese of Northern California (and The Episcopal Church across the U.S.) to return its unused property to agrarian uses. Plenty of grant money is available for garden and farm projects. Locally, St. Timothy's wanted to offer Gridley a garden that is both useful and beautiful, to encourage people to grow food with their neighbors and to increase food security in

With faith that the grant funds would come through, St. Timothy's began preparations for the garden in July 2022: cutting weeds and clearing rubbish, grading and leveling the ground and solarizing. The Church paid for a new chain link fence on the alley side of the garden.

the community.

By the fall of 2022, volunteers were digging trenches, repairing existing piping, and installing new in-ground irrigation pipe and sprinkler valves for the watering system. Old lumber leftover from the first garden was repurposed to build a potting bench, outdoor sink, and mud kitchen for children.

In March of 2023, new redwood was purchased

to construct the garden beds, and many volunteers showed up to tackle the job of filling the beds with soil and compost. Pathways between beds were covered with donated wood chips.

\*The newest addition to the garden is an 8'X16' greenhouse that is currently under construction. Other plans include comfortable benches and a small fountain at the center of the garden, espaliered fruit trees, a rainwater recovery system, and a redwood deck at the front garden

Gardeners and volunteers at The Garden at St. Timothy's get together monthly to learn more about gardening and preserving food while enjoying each other's company. Everyone is welcome to attend the meetings, which take place in the church offices.

Volunteers are needed for a variety of projects, ranging from garden maintenance and composting to building projects, publicity, and social media. If you would like to learn more about what's going on, volunteer to help, or donate to the garden, email st.timothygarden@gmail.com.

Recently, Butte County Local Food Network donated a free food stand to The Garden at St. Timothy's, so that gardeners can share their produce with the community, and the community can bring food to share with others as wellfresh, whole vegetables or fruit are welcome. The food stand will soon be located in front of the church at 410 Jackson Street.

The Garden at St. Timothy's is growing, thanks to the gardeners, volunteers, and many other folks who have given their ideas, effort, interest, and support. There's plenty of room in the garden and it's always open ... come and take a look!

# Senator Dahle's Bill Aims to Save Rural Hospitals

SACRAMENTO, CA (MPG) - Working to preserve vital emergency and acute-care services for California's rural residents, Senator Brian Dahle (R-Bieber) introduced Senate Bill 1423 which would require Medi-Cal to pay the actual costs of providing outpatient services in

designated critical access hospitals.

As it stands, the 37 critical access hospitals serving rural communities in California are not fully reimbursed for providing outpatient services to patients covered by Medi-Cal, meaning the hospitals lose money for every dollar spent on care for needy patients.

"It's disheartening to see that rural hospitals face the only options of either declaring bankruptcy or scaling back their services. We cannot continue to ignore the needs of millions of Californians who rely on these critical access hospitals. It's time for us to do better and ensure that these facilities have the resources they need to provide quality

care to those who need it most," said Dahle.

Federal law recognizes the vital importance of hospitals, especially those that provide emergency care, in rural communities and allows them to be paid for Medicare services for the elderly and disabled based on actual costs.

Over the years, enrollment in Medi-Cal, which serves lower-income Californians, has increased dramatically, but reimbursements below the cost of care put small hospitals serving these patients in critical financial straits. SB 1423 changes that so these hospitals continue to be an indispensable part of our health care system for rural California.



Everything is well watered! The Aprium was in full bloom when the rain and wind started. I can only hope some brave bees had already visited those blossoms I've been chanting "wait to open, wait to open" to my early Peach. It likes the milder temperatures and wanted to pop its buds. I really wanted it to wait, I felt that it could cooperate

because the night temps were lower. Sadly, not that much lower. A few blooms have started to open. I keep telling myself that some brave stray bee will visit those little blooms. I don't think insects like the low 40s. Wishful thinking can be a betrayer. The positive side is that the Blueberries are blooming and their flowers don't seem bothered by the rain. They also last a long time. Should I be so lucky as to have them fruit up, it will be a great Blueberry year. Hopefully you've got-

ten in at least two spray times on your peaches for leaf curl. If your blossoms are not open you can spray. Once they are open don't do it. I did feed my fruit trees right before the rain. I'm hoping that helped them. I'm getting ready to mulch around all of them to help with moisture retention this year. Soon it will be time to start fertilizing your Japanese Maples. I always want to jump the gun on my bonsai Japanese Maples because I want them at their best. Not a good idea, so I resist until the end of March. There is an Arbor Day

Festival in Oroville on March 16th. I go to this event with the Chico Bonsai Society. It is a delightful day full of a lot of tree information and some crafts booths. Admission is free. There are programs for kids throughout the day. Come on over.

# **Enrollment Opens for Beginning Farmers and Ranchers Program**

California Farm Bureau News Release

SACRAMENTO REGION, CA (MPG) - The California Bountiful Foundation, the 501(c)3 science, research, and education nonprofit organization of the California Farm Bureau, began enrollment last week for a new program called Expanding Our Roots: Beginning Farmers and Ranchers Mentorship Program.

The program has a website where beginning farmers and ranchers with one to 10 years of farming and ranching experience in California may enroll for free in the mentorship program.

Farmers and ranchers interested in serving as mentors may also sign up via the webpage. Mentors are financially compensated for providing six hours of mentoring services to beginning farmers and ranchers.

The program will allow 200 beginning farmers to be paired up with mentor farmers and ranchers with more than 10 years of experience. Half of the program participants must be specialty crop growers. Under program funding requirements, priority consideration will be given to socially disadvantaged farmers and military veterans in farming and ranching.

Mentoring will focus on a range of topics, including market access, climate stresses, navigating the regulatory system,

production management and business aspects of farming in California.

The program will also provide educational workshops that offer insights on regulations for farming and ranching in California. Additionally, participants will learn about financial incentives, including grant opportunities that can help them fund conservation management practices and climate-smart agriculture. They will be exposed to resources from the University of California Agriculture and Natural Resources and UC Cooperative

Grant funding for this project was made possible through a cooperative agreement with the U.S. Department of Agriculture Agricultural Marketing Service and the National Institute of Food and Agriculture.

"This program is designed to bring our agricultural community even closer together as a family through mentoring opportunities," said Dr. Amrith Gunasekara, science and research director for the California Bountiful Foundation. "Mentoring the new generation of farmers and ranchers by experienced farmers and ranchers will ensure agriculture and food security is sustained into the future."

The California Farm Bureau works to protect family farms and ranches on behalf of more than 26,000 members statewide and as part of a nationwide network of 5.8 million Farm Bureau members.

After the death of her husband, she moved to Cedar Creek Senior Living in


Survivors include her

He always had a story to tell. There was the time he was on patrol at Clark Air Base, and he got jumped by five thieves. They broke his jaw, but he managed to chase them off. The Air Force awarded him a medal for his bravery. Then there was the inmate a foot taller and 100 pounds heavier who stared him down menacingly. Miguel squared his stance and held his ground. The inmate backed away, met his eyes and said "respect." He was fearless and resolute in everything

he did. All who knew Miguel are heartbroken by his unexpected passing. His 93-year-old father, five siblings, 12 nieces and nephews, and scores of family and friends are grieving for his loss. In retirement, Miguel had found and cherished the love of his life in Theresa Grolig. They were inseparable. They worshipped together, traveled

# AT&T Upgrades, is it Unsafe to Fliminate I andlines?

YUBA CITY, CA (MPG) - It was March 15, 2022, when disaster struck in the tiny Butte County community of Forbestown. A fire broke out in a double-wide trailer that was the office at the Peaceful Pines Mobile Home Park.

Dale Mansfield, co-owner of the mobile home park, received a phone call on his landline just after 11:00 pm from a tenant. "Your sister's house is on fire and it looks fully engulfed!"

"I told my wife to call my nephew, my sister's son, tell him there's trouble. I live about a mile from the park, and when I got there, the whole valley was lit up by a plume of fire. I was there before the fire department arrived. I started walking back towards my sister's place and there was a power line down and it was arcing and bouncing around on the ground. And the flames burned clear to the top of a hundred-foot cedar tree right there. The whole back end of her double-wide mobile home was gone. I realized there was absolutely nothing I could do, the blaze was out of control." Cal Fire arrived and was

able to extinguish the fire. Unfortunately, Mansfield's sister died in the blaze. The Fire Investigator told him that the fire had been burning in the kitchen where she had been using the stove to heat the place for at least 15 minutes before it caught the rest of the home on fire. Evidently, she had no work-

ing fire alarms. Neighbors tried calling 911 on their cell phones but

were unable to get through due to no cell phone service. Eventually, someone was able to contact the fire department, and according to Mansfield, showed up later than would have if there had been reliable cell phone coverage.

Like so many other people who live in remote areas, Mansfield does not like the idea of landlines being eliminated. "This is my personal feeling about it, but I don't think you should trade a perfectly good, sound working technology for something that only works half-assed. A dropped call is strictly something that happens on cell phones. Because you don't get a dropped call on landlines. So many might hang up on you, but you never get disconnected."

What is COLR? Here is an explanation taken from the California Public Utilities website; "COLR is a telecommunications service provider that stands ready to provide basic telephone service, commonly landline telephone service, to any customer requesting such service within a specified area. At least one telephone company in a specified area is legally required to provide access to telephone

service to anyone in its ser-

vice territory who requests it.

This is known as the Carrier

of Last Resort (COLR)

obligation, which ensures that everyone in California has access to safe, reliable, and affordable telephone service. AT&T is the designated COLR in many parts of the state and is the largest COLR in California. Where AT&T is the default landline telephone service provider means that the company must provide traditional landline telephone service to any potential customer in that service territory."

Public hearings began in February at the California **Public Utilities Commission** on the matter. The commission also is taking public comments. So far, at least 3,500 have filed public comments - most of them opposing the waiver.

AT&T assures customers will continue to have access to emergency services 911, and that no customers will be disconnected. "We are working with the few remaining consumers who still use traditional copper-based phone service to upgrade to newer technologies from AT&T or other providers." For more information

# **Public's View on Signing Sheriff's Contract Wanted**

LIVE OAK, CA (MPG) - Much of the Live Oak City Council special session on Feb. 28 was on discussion points that council engaged in at the end of the year about the proposed Sheriff's contract for police services.

One option is to sign the contract and come back to the table to iron out details that can be added to the contract in an addendum.

The second option is to authorize a study to determine if the proposed contract does not leave the city with lack of control over its fleet of police cars and city officials not knowing where officers are or how many extra officers might be needed. The City Council could then better determine if more money is needed in the budget for the final contract.

No decision was taken at the session but Councilmember Lakhvir Ghag requested through Zoom that if any of the viewing public wanted to express an opinion on action they wanted taken on the budget, to let the city know by calling 530-695-2122 or emailing at lghag@liveoakcity.org.

Councilmember Bob Woten asked how much it would cost to just request a detective on an ad hoc basis rather than budget for one and was told \$100 per hour. He responded that it was like "buying an extended warranty."

Councilmember Jeramy Chapdelaine agreed, saying "I am not opposed to this as it is now." Chapdelaine added the detective, if included in the contract up front, could, when free, jump in a car and patrol or use a motorcycle, and the budget shows a trend of \$300,000 but it could go down substantially, making it even more cost effective. For Year One, Chapdelaine suggested, it might be an increase of \$150,000 to \$200,000.

Having a detective present all the time, Ghag said, would serve as a deterrent to crime, adding that "the Sheriff's Office does not compensate for cars, fuel

and other things." Ghag said, "It would

be nice to have the extra officer avail-

able so he could get in his car, but if he

is going to be out in the county, we have

to take it to our conscience (to deal with

anything that happens)."

Vice-Mayor Nancy Santana commented, "I don't think either of these proposals are good enough for Live Oak." Santana added, "I think we need a police presence at the school; at least two on duty at a time. I'm thinking we are going to need our own police station. The sheriff isn't showing he really wants to work with our city. We need to dig a little deeper, look a little harder."

Mayor Ashley Hernandez spoke of the Live Oak cars being driven elsewhere.

"We should be reimbursed; we don't charge for substation, we pay for canine, bikes, equipment. We are at an 88% cost share; it's 88 1/2 in this contract. The mayor wanted a monthly itemized report. I feel it is disappointing that statistics are showing officers create contacts to jam up bills. I would like to have a consultant assess our true needs, including what the length of the contract should be," Ghag said. "It would only take one incident, when they are not here, to put this town's rating into the dirt."

According to City Manager Aaron Palmer, "...we are not being charged for dispatch for 17 years; that's a pretty good deal. We could put into the contract that we want the vehicles left here. If they have an accident, they have the liability."

Ghag suggested that there was laxity in letting the council know about incidents to which deputies respond. Palmer said he would ask that the

Sheriff's Office send the general email on logs "so we can sit down and determine what we need... they would charge us." Chapdelaine added, "Our approach

needs to be more transparent and more robust and done in a workshop manner. It will take looking at tax increases and other things to determine we cannot afford this anymore as is." Santana said she "thought the Live Oak

residents would pass a tax increase as it voted to do for all of Sutter County."

Council members want to engage in a study as the contract is not due until June. While Ghag called out to the public for its opinion, he said, "We need to continue with the current contract until we have a sure method to protect the people of Live Oak. We can end up adding more money."
