# **Camellia Show Celebrates 100 years**

Show to be Held on March 2, 3

SACRAMENTO REGION, CA (MPG) - It's not every day that nonprofit organizations celebrate a centennial so Camellia Society

SACRAMENTO REGION, CA (MPG) - A winner has been announced for the 2023 California Wildlife Photo of the Year. This year's winner is Paulette Donnellon, who took "Juvenile Burrowing Owls" at Sonny Bono Salton Sea National Wildlife Refuge.

Burrowing Owl nests are not made public to protect this endangered species.

While discovering Burrowing Owls can be a challenge, Paulette's experience and time in the desert have taught her where to look. Her entrée into photography started as a pandemic hobby in 2020, and she has never looked back.

"They are so amazing

to photograph," said Donnellon, who loves burrowing owls so much she can often be found wearing an owl necklace, "Their eyes, they are just full of personality, and I really enjoy photographing them."

# Approval of **Subdivision** Map and **Two Restarts** Zip Through

ELK GROVE, CA (MPG8) -The Elk Grove Planning Commission wasted no time moving through three agenda items on Feb. 15, disregarding a couple of public complaints that reviewing water agencies had not been properly identified by staff on a proposed subdivision map.

Summer Gardens Estates raised a few questions about whether water oversight agencies were listed appropriately. It would be located in a rural area at 8577 Bader Road where the parcel would be subdivided into 19 lots on one to two acres with a well and septic system permitted for each lot.

A homeowner questioned whether Bader Road would remain the size it is or if present homeowners would lose their easements along the

Commissioner George Murphey stated that no changes would be made to their properties. Murphey asked if the development would reduce the flood plain of the nearby river and appeared satisfied that it would not be an issue.

The resolution that unanimously passed was to exempt further environmental review under California Environmental Quality Act (CEQA) guidelines, and to approve the tentative subdivision map and design review for subdivision layout.

The project for approximately 40 acres states that no municipal water will be pulled. Speakers expressed concern that the subdivision map might not be "up front as to what it will really be." The Sacramento County Water Review Board reportedly was given an opportunity to comment on the project at this stage but did not do so. Murphey also suggested that there be limited street lighting in that area to reduce glare.

Applicant Amanda Holliday provided her profile and history in operating her business, Hard 2 Love Tattoo and Supplies in Sacramento, as part of her request for a conditional use permit to relocate the business to her Elk Grove hometown to 8819 Elk Grove Blvd. Kathy Wilson made a statement of support. The Planning

Vierra has more than 100 of the flowering plants in her West Sacramento front and backyard.


#### America's Best Butcher?

A conditional use permit was requested for an auto body and auto paint service business to be located at 9882 Waterman Road, Suites 140 and 160. Applicants previously operated Premier Autobody

but stated they had to close it because of a downturn in business during the COVID-19 lockdown. The commission unanimously exempted the project from a CEQA review and approved it to receive a use permit.

Staff informed the Planning Commission that the deadline for

submissions on the Zoo Environmental Impact Report was Feb. 20.

Commissioner Murphey announced he was stepping down, but at the mayor's request, would stay until his replacement is selected.

Staff requested that the March 7 regular meeting be vacated.

# **Community Service District Improvement Committee Debates Use of State Money**

RANCHO MURIETA, CA (MPG) - The idiom "Don't look a gift horse in the mouth" might hold wisdom, but members of the Rancho Murieta Community Services District (CSD) Improvements Committee found themselves doing just that when they convened on Jan. 6.

The proverbial gift horse in question amounted to \$1.3 million in funding, courtesy of former Assemblyman Ken Cooley, nestled within the 2021 California budget. The intended purpose was to cover the entire cost of three vital CSD infrastructure projects. Among them, two aimed to replace the chlorine disinfection systems at the water treatment and wastewater treatment plants, while the third aimed at enhancing safety at Granlees Dam, the intake point for the district's water system from the Cosumnes River.

Director of Operations Michael Fritschi unveiled some sobering updates during the meeting. The initial estimate of \$1.3 million for the three projects had burgeoned to \$2.74 million, a staggering escalation in costs.

"Staff is concerned that delays in moving forward will result in increasing costs which could potentially jeopardize the district's ability to utilize the funding within a reasonable time," Fritschi said.

After a thorough deliberation, the committee devised a strategy to optimize the allocation of the state funding in light of the inflated construction costs. Essentially, the majority of the state funds would be allocated to cover the safety enhancements at Granlees Dam, originally earmarked at \$174,000 but now estimated at \$834,000. Some of the state funds had already been disbursed to engage consulting engineering firms for the three project designs.

Directors Randy Jenco and Martin Pohl directed Fritschi to expedite the GranleesDam project bidding process. "Let's get this thing out to bid and see what it is really going to cost us," urged

The Improvements Committee, consisting of Jenco, Pohl, and Fritschi, alongside General Manager Mimi Morris, Plant Supervisor Travis Bohannan, and other staff, meticulously analyzes infrastructure matters, offering recommendations to the entire board.

## Losing state money

Morris initially expressed doubts about whether the SB 170 projects represented the most prudent use of reserves. "This \$1.3 million gift is turning into \$1.3 obligation forcing us to do these projects, as opposed to anything else that might be more necessary," she said.

Citing her experience with state auditors, Morris highlighted a shift in their scrutiny towards local expenditures. raising concerns about the potential ramifications of inactivity on the SB 170 projects.

"My concern is they could just come back and say, well you didn't do anything with it so you need to pay it back," Morris said. "But I don't think that would necessarily be the worst outcome because it doesn't seem like the great gift it seemed three years ago because it was insufficient to fund the projects."

## Granlee's Dam is priority

Morris asked Fritschi if there were any other projects on his "gotta do" list that go back even further than the SB 170 projects. Fritschi said his priority would be the Granlees project.

Fritschi said his contact at Department of Water Resources, which is administrating the state money, told him the district can move the money among the three projects "So, we could put a lion's share of resources towards one project,"

Fritschi said he became increasingly amazed at how high construction bids have been coming in over the past years. "So, that Granlee's bid is probably very conservative," he said.

Pohl asked him if there were a way to cut costs on the Granlees project. Fritschi said he couldn't think of anything except

cutting the contingency allowance. "There are a lot of things that probably should have happened a long time ago to have a fully functioning forebay, which is really the heart of our water system as far as intake goes," he said. "We've also got two gates that aren't there anymore and a gate that should have been replaced 15 years ago," he said.

Jenco asked about completing only part of the project. He said when Paul Siebensohn, the prior operations director, first envisioned the project he was only thinking about replacing the cover that was already there. "And, sometimes his idea was just to use our people and not even put the thing out to bid," Jenco

Fritschi said that in his opinion the district should move forward on the Granlees project because of what has happened in the past and how long it has taken. He also said the gates pose a safety and liability issue, which is why he included a guard in front of the gates (that was incorporated into final design by the consulting engineers.)

"So, if the gates are open, which they are most of the time, someone jumping into the water won't get sucked into the forebay and stuck to the gates," he said. "There's no way we can stop people from walking across the dam and there are people who kayak out there."

(The past incident to which Fritschi referred was the drowning of a teenager in 2002 after the youth jumped into the water intake diversion to retrieve some swimming goggles and was trapped by the currents.)

Fritschi said his second priority would just be replacing the recycled water contact basin at the wastewater plant, which is part of the conversion to bleach project.

Morris asked if CSD staff could be used for the Granlees project as envisioned by Siebensohn.

Fritschi asked Bohannon to explain why the answer was no. Bohannan said that Siebensohn designed a bleach conversion project for the wastewater plant, bought the materials and equipment and began construction with staff before he left the district.

Bohannon said when the consulting engineers looked at their work, they said nearly everything had to be scrapped because it wouldn't operate and wasn't appropriate. "The staff here doesn't have the knowledge to do that stuff and do it safely," Bohannon said. "Just by past experience alone, doing the work in-house has created more issues than it is solved."

When asked how much money remained from the state grant, Fritschi said his "just off the top of my head" estimate is that the district has spent \$250,000 so far to design the three SB 170 projects.

After further discussion, Morris recommended moving forward on the Granlees project. "A big chunk of the \$1.3 million has already been eroded by thinking and planning for it," she said. "My worry is that it is just going to be more expensive, so I feel like you might as well dive in and take care of it."

By the close of the discussion, Jenco and Pohl agreed that the district should move forward on advertising the requests for a proposal in March, aiming for construction in late spring or early summer. They also directed that the district's engineering firm prepare the bid documents.

Fritschi and board members have lamented at prior meetings that didn't ask Cooley for more money for the projects. When Cooley advised of the funding possibility in 2021, Siebensohn had already submitted his resignation. Given the time constraints before he walked out the door, Siebensohn probably came up with the best project cost estimates he could, according to comments at past meetings.

In other business, Jenco and Pohl tasked Bohannan with soliciting additional bids to address rust issues at the Rio Oso water storage tank, with plans to put the repair approval on the consent agenda at the upcoming board meeting on Feb. 21.

# **CSD Security Supervisor** Kelly Benitez Resigns

#### **RANCHO MURIETA, CA (MPG)**

- Kelly Benitez, the former chief of security chief of the Rancho Murieta Community Service District (CSD), has stepped down from his position to join law enforcement. His resignation was effective

Benitez has secured a position as a police captain with an undisclosed law enforcement agency within the Sacramento Metropolitan Area. He refrained from disclosing the specific agency because he hadn't officially assumed his new role.

Benitez initially planned to stay with CSD for at least five years after his recruitment 2 ½ years ago. However, his plans shifted after residents voted down Measure R in November 2022.

Placed on the ballot by the CSD Board, Measure R would have provided additional funding so CSD could deliver patrol services 24/7 without using property taxes to supplement the security budget. The underfunding stemmed from insufficient revenue generated by Measure J over the past decade.

Benitez said Mark Matulich, the CSD director of finance and administration, will take over security supervisory responsibilities with help from Sgt. Mel Outram who will help handle day-to-day operations.

The arrangement will free up his salary so that CSD can hire another patrol officer. "I think that is the best thing to do because Rancho Murieta needs some patrol help," he said.

Board President Tim Maybee said he understood and respected Benitez's decision to leave. "Kelly has brought a level of professionalism and calmness to the security services, for both customers and staff," he said. "He has always been one to identify the issues and bring them forward."

Maybee said Benitez used his skills to work effectively with other law enforcement agencies. He also was "the 24-hour, on call - go to person...On numerous occasions Benitez had to come back in to staff the gates or patrol services," Maybee

Maybee also addressed the district budget. "Everything comes back to one issue and that is, very simply, the lack of Measure J funding. The current board has been stating this for several fiscal cycles, and it was also identified in the Grand Jury report," he said. "No one in the community can be surprised at the lack of resources currently available for security."

Benitez has extensive law enforcement experience, including 20 years with Los Angeles Police Department, were he served 14 years as a sergeant, before opting for early retirement in 2015. While at LAPD, he earned a bachelor's degree in criminal justice and a master's degree in leadership and management. After moving to the Bay Area, he worked as a police officer for the City of San Rafael and then as an investigator for the San Francisco Department of Police Accountability for five years. He accepted the CSD position in August Upon assuming the role

Another accomplishment was hiring good people, three as full-time gate officers and two part-time and one patrol officer who was promoted to sergeant. With continuous training and ongoing evaluations, the newest full-time employees are nearing two years on the

Benitez also terminated employees because they weren't appropriate for the work. "The bad news is they weren't replaced," he said.

On the other hand, "The officers we have left are really squared away," he

Benitez said another major accomplishment was improving officer safety by securing board approval to buy ballistic vests for patrol. "You have guys going to quasi-police calls all by themselves, so at least they have that level of protection," he said.

He also secured approval for the replacement of older vehicles and equipping the units with life preservers and trauma kits.

An unmet goal was setting up an emergency operations center inside the James L. Noller Safety Center, located in a trailer across from the CSD office.

Benitez cited a low turnover rate among CSD security personnel, attributing it to the organization's supportive environment. He highlighted the board's decision to introduce a second tier of pay as a morale booster and emphasized the competitiveness of CSD job offerings, particularly its comprehensive benefits package.

Since Rancho Murieta is essentially a city with 6,000 residents, Benitz believes the community should increase patrols. Ideally, two patrol officers would cover each shift, and a supervisor would overlap on nights and weekends.

Although the security department has operated three patrol officers in the past year, versus five or six positions in earlier years, Benitez believes he managed fairly well by assigning them to shifts with the most call volume. Having two Rancho Murieta Association (RMA) compliance officers working the day shift also helped mitigate the reduced coverage.

He said another factor that would help compensate for a decrease in patrol would be better coordination between CSD and RMA surveillance cameras.

Benitez said he has already begun strategizing with RMA, Sacramento County Probation, the Sacramento Sheriff's Office, and the sheriff's POP (problem-oriented police) officer to prepare for next summer. Last summer, large groups of juveniles trespassed through private property to drink and set bonfires on the South Beach. Some of the same juveniles gathered at the Gazebo for the July 4 fireworks show, one of whom set off an illegal firework that injured seven people.

Benitez has asked that at

least six deputies respond to future beach incidents to cite every participant to ensure real consequences instead of just ordering them to leave. Whether that will happen remains to be seen.

Although the long response time from sheriff's deputies continued to be an issue during his tenure, Benitez has recently enjoyed a closer connection to the sheriff's office after a Rancho Murieta resident took over as the day watch commander. He said that Lt. Greg Coauette has helped him a half dozen times.

Benitez said the extent of drinking by 13 and 14 olds probably has been the most shocking behavior he has seen in Rancho Murieta. On July 4, several kids nonchalantly admitted drinking a six-pack at the river before coming to the gazebo.

Benitez also has been shocked at how angry some residents become over small issues such as open garage doors. Benitez didn't see that level of anger even when working as a police officer in high-crime areas of Los Angeles.

When asked to speak at a security committee chaired by RMA Director Chris Childs last September, Benitez compiled some footage from the security officer video cameras to show them. Childs, who was number three at the California Highway Patrol before retiring, told the other RMA directors he was shocked by the misbehavior directed at patrol officers that was captured in the video footage.

Benitez said the gate officers encounter more "yellow language" than patrol officers because of sheer numbers. About 15,000 motorists pass through the

visitor gates each month.

Another serious problem Benitez has seen in the community is the failure to report crimes to law enforcement and the security department. Residents frequently say they don't make a report because they believe nothing will happen. Others worry about property values going down in the community.

Benitez said reporting crimes to the sheriff's office is essential so that the patterns and frequencies can be ascertained to help determine response to the community. "At least make it a statistic," Benitez said. Ideally, such crimes

should also be reported to Security because the patrol officers work inside the community and can be on the lookout, he said. In a recent instance, however, a business owner refused to share surveillance video with security because they had already given it to the sheriff's office. Even though Benitez is

leaving the district, he sees light at the end of the tunnel. "I have great confidence that Mimi Morris (general manager) and Mark Matulich (director of finance and administration) will solve or greatly resolve the security and financial issues with the current work they are doing," he said. "I wish I was around to see the final outcome."

# Council Selects Development Partners for Affordable Housing Projects on City-Owned Land

ELK GROVE, CA (MPG) - At the Feb. 14 Elk Grove City Council meeting, the city's Housing and Public Services Manager Sarah Bontrager provided an update on two potential affordable housing developments on city-owned properties.

Affordable housing is such a critical issue in California and "more investment is needed in this area," Bontrager said.

So, in recent years, the city has shifted the focus of its Affordable Housing Fund (which collects the fees generated by new housing developments) into the acquisition of suitable properties for affordable housing projects. The city owns four sites and two were discussed at this meeting: sites at Old Town (two acres at Elk Grove Boulevard and Webb Street) and Sheldon Farms North (five acres on Bruceville Road near the Sheldon Road intersection). Both properties are zoned for high-density

residential, and the city envisioned affordable housing for seniors at the Old Town site and affordable family housing at Sheldon Farms North.

The city's goal was to find developers to partner with on these sites, so a Request for Proposals (RFP) was issued and a total of 23 responses—11 for Old Town and 12 for Sheldon Farms North — were received.

"We got an incredible number of responses," Bontrager said. "These were very popular sites. A lot of folks were interested in partnering with

Staff narrowed down the options by looking at each developer's financial capacity, as well as their experience in construction and long-term management of affordable

"We looked at how closely they were aligned with the city's vision for the site and how they would approach partnership with the city, because the city wants to be very involved in the process," Bontrager said. "These are sites we acquired for very

specific purposes and we want that design control or to share that vision."

For the Old Town site, Mutual Housing California was selected as the potential partner. Proposed were 89 units of senior housing in a three-story building with an elevator. Mutual Housing California, an established local developer with solid in-house resident services and a strong and creative financial plan, had the lowest proposed cost and a good track record of community engagement.

For Sheldon Farms North, Abode Communities was selected. Its project vision is a seven-building community with a total of 240 units of affordable family housing. Staff liked the overall design ideas and the high number of proposed units, as well as the developer's community engagement strategies and creative funding ideas.

Staff recommended that the City Council approve Letters of Intent with both Mutual Housing California and Abode Communities. The Letters of Intent are not loan

commitments or guarantees of land transfer. However, they do offer the developers exclusive rights to develop the properties and provide the initial terms of agreement as the city and the developer begin their collaboration. The city can terminate the agreements at any time, but if it terminates without cause, would have to pay any fees that the developers had invested into the projects up to that point.

Bontrager said it will be a long process and construction on these projects would likely not begin until 2027. "But we need to move for-

ward at this point to get that process started," Bontrager

Mutual Housing Project Manager Danny Kolosta spoke at the meeting about the company's excitement to "keep the ball rolling" on this project. Mutual Housing is a Sacramento-based nonprofit founded in 1988, with a track record of successfully competing for state affordable housing funds. He said that their vision for supportive senior housing includes various in-house services as well as indoor community spaces and inviting outdoor courtyards.

Abode Communities Associate Vice President of Development Maegan Pearson also shared her firm's excitement to work with the city on developing affordable housing in Elk Grove. Founded in 1968, the mission-based nonprofit has experience on large-scale projects that are well integrated into the surrounding community. Its vision is to deliver responsive in-house resources that will stabilize families and create a place to belong.

During the meeting's Public Comment, Elk Grove resident Randy Becker said he and others from Old Town are planning to "cautiously move forward," as they keep an open mind about the project. He said that they plan to be "extremely involved" in the design process.

Jackie Perez from Old Town agreed: "The design is very important."

Perez said it was critical

that any new building match the existing aesthetics of Old Town. While Perez acknowledged the need for affordable housing, she expressed concern that new housing in that area would increase traffic. But, Perez also said, she wants to see plans to draw people in, such as commercial spaces including coffee shops on the new building's ground

Councilmember Kevin Spease said he was excited to have developers "who are willing to work with us."

Mayor Bobbie Singh-Allen

said, "This is much needed in our city. We're far behind. ... We're not as far behind as other cities but we can continue to do more. So, I appreciate this."

City Council voted unanimously to approve the Letters of Intent and begin the collaboration with Mutual Housing California and Abode Communities, with community engagement as the next step in the process.

The next Elk Grove City Council meeting is scheduled for Feb. 28.

It was at that moment the young man caught the pole in outstretched hands. Tragically, the pole had lost its electrical ground and our patient fielded 220 volts. From that moment on, neither his grieving lifeguard friends, nor the valiant paramedics were able to encourage another breath from this

As the doctors explained the events of the boy's heroic sacrifice to his grieving parents, I struggled for the words that would begin some kind of closure. I noted how remarkable it was that their son had given his life for his friend, naively referencing John 15:13.

The mother thanked me kindly for the "sentiments," adding sardonically she was sure her son's heroics would be a comfort someday, but right now she would beg my forgiveness for wishing it was some other boy in that morgue instead of her son.

For love to be complete, the sacrifice has to be accepted. The friend whose life had been saved undoubtedly accepted the sacrifice, but the mother of the boy who made it could not. Knowing she had reared a brave son who would "lay down his life for his friends" didn't ease her pain.

Not yet anyway.

Meanwhile, back in the shop of roses, I was contemplating the same principle. No matter the sacrificial cost of roses, my love can only be fulfilled

if my wife accepted equal part in that

After leaving the florist shop, I called my wife. "You know I love you

more than \$70, right?" "Yeah," she said, her answer unsuccessfully masking her suspicion. "I

suppose so." 'Valentine's Day roses are \$70!"

"That's crazy," she said, releasing an exhausted breath. "Forget about it!"

"But you know I love you more than that, right?"

"Yes," she cooed. "I know you love me more than that." Then she paused. "You can buy me roses for my birthday next month — they'll be cheaper



# Season's Over for Sheldon, Franklin, and Perhaps, Monterey Trail

ELK GROVE (MPG) - It happened all within the same three hours the evening of Feb. 16 that three Elk Grove Unified boys basketball teams are were potentially knocked out of the Sac-Joaquin Section Division I playoffs. Sheldon, a six-seed, dropped a 71-62 decision to No. 3 Rocklin, while No. 8 Franklin sort of hung around but couldn't overcome the always-powerful and, this season, the No. 1 seed Modesto Christian, losing 62-50. Then, No. 2 Monterey Trail saw their offense go flat midway through the fourth quarter, squandered an 11-point third quarter lead and then drop a 93-88 double-overtime game to No. 7 Lincoln of Stockton.

To clarify the adjective "potentially" in the opening sentence, the top four teams left in the playoffs will all proceed next week into the CIF NorCal Regionals, but the Section does have the option for one "at-large" team to be selected. Being the No. 2 seed and going 26-4 this season with the only two losses to Section opponents being games that went into overtime, the Mustangs may be a prime candidate.

"I think we had a tremendous season, great in league, great in non-league, it took a lot to put us down, so if you invite me to the dance, I'll bring my dancing shoes," Mustang coach Robert Fields said of that prospect of more basketball this month for his team. That may not be determined by the State CIF officials until Feb. 24 or 25.

The possibility may give this talented squad some relief from the pain inflicted by the Feb. 16 loss. Coming out of the locker room for the third quarter, Monterey Trail had a 40-36 lead and quickly added to that. A quick three by Derron White followed by a bucket by Kentrell Kelly and then a jumper by White and the Mustangs were up 47-36. From there, though, things turned south. They turned the ball over twice which led to Lincoln baskets and then Quentin Thompson's three-point play and the Trojans were back to within two. The rest of the way, the teams were back and forth within one bucket of each

Brandon Gibson, who led the Mustangs with 29 points, was about the only scorer for Monterey Trail who put up points while his teammates struggled in shooting. Monterey Trail led 72-70 with :08.7 remaining and Thompson drew a foul from Kelly to send himself to the free throw line. He made both tosses to tie the game. Thompson ended up leading the Trojans with 29 points.

Fields called a double timeout to set up a play for the game winner, but White's shot was blocked by Zeke Davis and the game went into overtime.

At the end of the first overtime and the score tied at 80 Lincoln's Anthony Moore had a shot at the horn that hit the front of the rim. In the second extra period Davis and Moore each hit key free throws to solidfy the win for Lincoln, who advanced to a Feb. 19 semi-final showdown at Rocklin. Davis ended up with 28 points.

"We feel really great," Lincoln coach Anthony Matthews said. "We haven't been to the third round (of the playoffs) in, like, 30 years. Hats off to (Monterey

106 – Hoover, Laguna Creek (1st) 113 – David Maxson, Elk Grove (5th) 120- Sandoval, Elk Grove (1st)


126 – Bulanin, Elk Grove (4th) 157-Noah Daniels, Sheldon (3rd) 285-Follette, Laguna Creek (1st)

To make it worse the game was marred with continual shoves and bumps on both sides. The yellow cards, though, pretty much stayed in the referee's pocket. Numerous free kicks were called for the offended team, but the guy wearing the lime green jersey let them play, even on collisions that left players laying on the turf for a prolonged period. If it was

American football, there would have been pass interference, roughing the kicker and clipping penalties galore.

The student section on the Elk Grove side was loaded with comments for Golden Valley players. Early in the game, the referee and a linesman stopped play and headed over to the home bleachers to say something to the students.

That really didn't do

At the 24-minute mark of the second half, the Cougars got on the board when Miranda scored his 42nd goal of the season. In jubilation he and a handful of his teammates then ran onto the running track, a few feet away from the Herd student section and started trash talking. They were greeted with a chorus of middle fingers.

Calmer heads quickly prevailed, and the Cougars quickly headed back to their own side of the pitch

While Golden Valley moved on to face top-seeded Del Oro in the Division II final on Feb. 24, Elk Grove's Johnny Cuatecontzi did what he could to console his emotionally wrecked team afterwards. He pulled

Meanwhile across town, the No. 1 seeded Valley Vikings took its Division III semi-final, 1-0, over Rio Linda. The Vikings advanced to the Section championship game Feb. 22 at Cosumnes River College against No. 7 Pacheco. Valley is now 23-4-4 going into that game.

But the season is over for the Franklin girls soccer team. The No.1 seed in Division I was upended by Del Oro, 1-0 in overtime on Feb. 16. They ended the season 16-3-2. The Wildcats are the defending champions in Division I.
