## Regional Business Broadband Master Plan

Valley Vision News Release

#### SACRAMENTO REGION, CA (MPG) - Background and Purpose

Valley Vision has received a grant from the U.S. Economic Development

Administration (EDA, Department of Commerce) to identify recommendations and create a roadmap for urban, suburban and rural areas in Sacramento, Sutter, Yuba, and Yolo Counties. The priorities set by this plan will accelerate broadband adoption and implementation of cutting-edge internet-based tools and platforms for business operations and assist communities in economic recovery.

#### Project Activities

The project activities include connecting with regional Internet Service Providers to identify business internet service levels and collaborating with regional stakeholders on local broadband and digital service needs. Another activity is conducting a business tier broadband gaps/needs analysis of future proof broadband services, digital and online tools, platforms, resources, and digital training to enable businesses to adopt and implement cutting-edge online business operations. Lastly, the project activities involve developing and disseminating a multi-stakeholder Strategic Business **Broadband Adoption Plan** with resource materials and capacity assistance for organizations working with target businesses and agricultural operations. Valley Vision, a civic leadership organization serving the Sacramento region, has received a grant from the U.S. Economic Development Administration to research the availability and quality of broadband and Internet service for local businesses and their digital needs. This analysis will be used to develop a Regional Business Broadband Master Plan to identify strategies, tools, and solutions. For this analysis, Valley Vision is surveying businesses of all types in the four-county region. The online survey takes just a few minutes and offers an important opportunity to provide input on your existing broadband and Internet conditions and needs. It can be completed on any computer, laptop, smart phone, or device connected to the Internet. If you have questions or would like to provide further input beyond the Continued on page 3

**SACRAMENTO REGION** - (MPG) -"2THEXTREME! MathAlive!," the newest exhibit at the Aerospace Museum of California at McClellan Park, has 40 unique interactive exhibits to inspire students and their families to discover the world of Science, Technology, Engineering and Math (STEM). The exhibit runs through May 31. Museum hours are from 9 a.m. to 4 p.m. Thursdays through Sundays.

In a world where mathematics is often relegated to the realm of classroom tedium, the MathAlive! exhibition emerges as a vibrant testament to the beauty ever present and the sheer fun of math. This large-scale, interactive showcase is a journey through the mathematical bedrock of our everyday lives, designed to captivate families and students alike. With an emphasis on engagement and hands-on learning, MathAlive! proves that math is not just about numbers and equations—it's a key to unlocking a world of possibilities. Math is everywhere. From the way we play to the technology we use, math serves as a foundational building block, shaping our experiences and innovations. The exhibit highlights this concept, ensuring visitors leave with a newfound appreciation for the math that surrounds us, often hidden in plain sight.

By discovering math in unexpected places, the exhibit ventures into the realms of sports, music, fashion and entertainment, revealing the surprising ways in which mathematical principles are essential to creativity and artistry. At the heart of MathAlive! are its interactive exhibits.

Extreme Sports: Visitors can design and test virtual snowboards, exploring the geometry that influences their performance, or experience the thrill of a snowboarding simulator, embodying the physics of snow sports.

Fashion and Design: Here, the fusion of geometry and creativity takes center stage. Participants can play with geometric patterns, delve into fabric design and see their ideas come to life in 3D garment models.

The Science Behind Video Games: Offering insights into the mathematical backbone of game design, this area allows attendees to peek behind the curtain of video game programming and coding, offering the chance to create a simple video game.

Robotics: By programming miniature Mars rovers, visitors engage directly with principles of navigation and engineering, confronting the complexities of robotic exploration.

The Mathematics of Architecture: This exhibit sheds light on the math behind iconic skyscrapers and gives visitors the opportunity to design their architectural marvels applying mathematical principles.

MathAlive!'s overarching mission is multifaceted: spark a lifelong interest in math, build confidence in math's accessibility, promote Science, Technology, Engineering and Math (STEM) careers, and revolutionize how visitors perceive mathematics. SACRAMENTO COUNTY, CA (MPG) - District Attorney Thien Ho announces applications are now being accepted for the 2024 Citizens Academy. The Sacramento County District Attorney's Office hosts the program in partnership with the Sacramento Police Department, Sacramento County Sheriff's Office, and Sacramento County Probation Department.

The program is designed to engage citizens from all backgrounds and communities in discussion about public safety and criminal justice issues. Participants learn about our local criminal justice system – including the roles of law enforcement, prosecutors, and the courts. Topics include the anatomy of a criminal case; specialized areas of prosecution; CSI and crime lab analysis; use of force; innovative programs and partnerships; and community-focused public safety partnerships and initiatives. There is also an opportunity for a field trip to the District Attorney's Crime Lab and Sacramento Police Department's 911 Communications Center.

Representatives from the District Attorney's Office, Probation Department, Public Defender's Office, law enforcement, the judiciary and community organizations will provide information, answer questions and address community concerns.

There is NO cost to participants. The 10-week course is held on Tuesday evenings starting April 2, 2024 - June 11, 2024, from 6 p.m. - 8 p.m. at the Sacramento Police Department's Safety Center (5770 Freeport Blvd., Sacramento).

The deadline to apply is Friday, March 22, 2024.

## **Measles Exposure at UC Davis**

#### Sacramento County News Release

SACRAMENTO COUNTY, CA (MPG) -Sacramento County Public Health (SCPH) confirms one case of measles in a child who was seen at the UC Davis Medical Center Emergency Department on March 5, 2024, between 12 p.m. and 5 p.m.

Unvaccinated persons or those with unknown vaccination status who were in the UC Davis Medical Center Emergency Department during the aforementioned time are at risk of developing measles from 7 to 21 days after being exposed. These individuals should do the following:

Review their immunization and medical records to determine if they are protected against measles. People who have not had measles infection previously or who have not received thee measles immunization may not be protected from the measles virus. These individuals should talk with a healthcare provider about receiving measles, mumps and rubella (MMR) immunization.

their health care provider as soon as possible about a potential exposure if they are pregnant, an infant, have a weakened immune system and/or are not immunized, regardless of vaccination history. Do not go to your provider in-person or go to the emergency department for potential exposure.

Monitor themselves for illness with fever and/or an unexplained rash from 7 days to 21 days after their exposure (the time period when symptoms may develop); if symptoms develop, stay at home and call a healthcare provider immediately. If you become ill enough that you need to seek medical attention in person, please wear a mask and inform the registration staff that you have had a measles exposure so that appropriate isolation can occur in the healthcare setting. UC Davis Medical Center, Sacramento County Public Health (SCPH) and Public Health and Health Departments in surrounding counties are contacting identified patients to assess their immunization status and provide guidance to individuals who were exposed.

Control Your Mind and Money

#### Dear Dave,

I'm trying to work my way out of debt, but it seems like something always happens to stall things or knock me backwards. I make \$55,000 a year, I'm single and I have \$15,000 in debt, along with a mortgage payment of \$1,224 a month. I've been trying to live on a budget, but I'm still not sure where all my money goes. Can you help?

- Lindley

#### Dear Lindley,

I know living on a budget can be hard at first. And honestly, it usually takes folks who are new to doing it about three or four months of practice before they start getting it right and seeing the results.

For starters, your house payment is a little heavy for someone making

\$55,000 a year. I generally recommend keeping your mortgage or rent payment at about 25% of your takehome pay. Sometimes you can slide by paying a little more, but in those cases, you'd really have to be on top of your finances. So, the biggest thing you can do right now is take control of your money, instead of letting it-or a lack of it-control you. And the best way to make all this happen is by consistently living on a realistic, written monthly budget.

Once you start doing this, you've taken your first big step toward having a real gameplan for your money. At that point, the idea of trying to live on a budget ends, and the fact that you are living on a budget, and telling your money what to do—instead of a lack of it dictating what you can do—becomes more of a reality.

Remember the Star Wars movie "The Empire Strikes Back"? At one point during Luke's training, Yoda tells him, "Do, or do not. There is no try." In a larger sense, Yoda is urging Luke to focus and work harder, instead of continuing with half-hearted attempts and giving up easily. If you want to accomplish a difficult task, Lindley, you have to throw yourself into it completely. You must fully commit, and stop making excuses. You have to focus, and fight to make it happen.

It's no fun waking up broke at the end of every pay period. We both know this. So, put your head down and get your mind in gear. Make. This. Happen.

You can do it!

## **Social Security Matters** Will My Benefit Increase if I Work While Collecting Disability?

Dear Rusty: I will be 64 in March and currently receive Social Security Disability Insurance (SSDI) payments. My full retirement age is 67, but I'm thinking about trying to return to work.

If I work and my earnings exceed the monthly disability payment limits, but do not exceed the annual limit, how will my disability payments be affected? Will working while receiving Social Security disability payments change my Social Security benefit amount when I reach my full retirement age of 67? Signed: Mending

Dear Mending: Social Security doesn't go by annual earnings when it comes to disability (SSDI) - they go by monthly earnings. If your work earnings in any one month of 2024 exceed \$1,550, that will be a flag to SS that you are no longer disabled (\$2,590 per month if you're blind). If that happens for a few months in a row, they will most likely stop your SSDI payments. Often, this happens retroactively - they won't find out until sometime later that you repeatedly exceeded the monthly limit - but they will likely cancel your SSDI benefits and require you to repay any benefits you received in months vou exceeded the monthly

SSDI earnings limit, or months they deem you were capable of working without restriction.

I suggest you consider enrolling in Social Security's "Ticket to Work" program. While enrolled, you can work and will have a rolling 9 month "Trial Work Period" over 5 years, during which you can earn more than \$1,110/ month (in 2024) without jeopardizing your SSDI benefits. If, after completing your 9 month trial work period, you are taken off of SSDI (because you're no longer considered disabled), and you again become disabled and unable to work, your SSDI benefits can resume without requiring you to go through the entire application process again. You can test your ability to work, will be able to work some and can earn more than the limit in some months, which makes the Ticket to Work program your best option. Read more about it here: https://choosework.ssa.gov/.

As for whether working while on SSDI will improve your benefit at your full retirement age (FRA), that depends. Your current SSDI benefit is equal to your FRA entitlement from your earnings record at your disability onset date (but paid to you prior to your FRA). The method for determining your benefit under SSDI is complex and depends on the age at which you became unable to work and the number of Social Security credits you had accumulated at that time. Although SS retirement benefits normally require you earn at least 40 SS quarter credits and are based on your highest earning 35 years, those approved for SSDI can get benefits with fewer than 40 credits

and less than 35 years of lifetime earnings. Since each case is unique, I cannot say whether your earnings while on SSDI will improve your FRA amount, but Social Security will monitor your earnings and increase your benefit if appropriate.

FYI, your SSDI benefit would normally automatically convert to become your regular SS retirement benefit at your FRA at the same amount you were receiving while on SSDI. It's possible that the limited earnings you may have from working while on SSDI may increase your benefit, but that's impossible for me to predict. Your benefit is based on your lifetime earnings history (adjusted for inflation), not on your contributions to Social Security while working.

So, if you are on SSDI and wish to try returning to work, and you think your monthly earnings will occasionallv exceed the SSDI limit, I suggest you contact Social Security (1.800.772.1213 or your local office) to explore enrolling in the Ticket to Work program. That would be your best option to avoid jeopardizing your SSDI benefits, and your benefit amount will be automatically adjusted by Social Security if appropriate.

## Fewer Students And Higher Absenteeism Plague California's Public School Financing

California's public schools live – or die – by the numbers.

They are utterly dependent on how much money the state budget allocates each year under Proposition 98, a formula adopted by voters in 1988 that only a few wonks in and around the Capitol profess to understand - and even they often disagree.

Prop. 98 computations are also subject to political horse-trading during each budget cycle. Whatever number emerges is then distributed to school districts, primarily based on "average daily attendance."

California is one of only a few states that use attendance to distribute state aid and a perpetual debate over whether it should continue is becoming more intense because two major factors in school attendance - enrollment and student absences - have been regressing.

California experienced rapid population growth over the last two decades of the 20th century, due to a wave of migration from other states and a baby boom. That translated into a 50% increase in K-12 school enrollment, eventually topping out at 6.3 million kids.

After reaching a plateau, however, enrollment started declining as the state began losing population, thanks largely to movements to other states, and as the state's birthrate dropped dramatically.

"Demographic projections suggest enrollment will continue to decline across the state over the coming decade," according to a recent report by the Public Policy Institute of California. "The California Department of Finance (DOF) projects that declines will persist at roughly 40,000 to 60,000 students per year, resulting in enrollment levels below 5.2 million by 2032."

The inexorable decline in enrollment is exacerbated by a startling large number of students who may be enrolled but are chronically absent - what once was known as playing hooky.

During the early months of the COVID-19 pandemic almost all of California's schools were closed, but even with online classes, attendance took a nosedive. After schools were reopened, however, chronic absenteeism - students missing from the classroom 10% or more of the time - continued to be a problem. Prior to the pandemic 12% of the state's students were chronically absent, but in the first year after schools reopened the rate was 30% and since then has declined marginally to 25%, according to a new PPIC study.

PPIC researchers learned that the most absence-prone children these days are in kindergarten or the early primary grades while, prior to the pandemic, high schoolers were most likely to be missing classes.

"High levels of absenteeism among the youngest students is particularly concerning since absenteeism tends to have a snowball effect: a student is more likely to be chronically absent in later grades if they are chronically absent in earlier ones," PPIC's report noted.

During the pandemic, school finances were bolstered by billions of dollars in federal relief funds and a temporary respite from attendance-based state aid, but both of those programs have expired, so districts are beginning to feel the full impact of enrollment declines and absenteeism.

As the gaps between income and outgo widen, school officials throughout the state are contemplating school closures - which almost always generate neighborhood opposition - while pressing the state to change the attendance-based system.

"Between 2012 and 2021, nearly 700 schools across the state were closed, resulting in roughly 167,000 students being displaced," Policy Analysis for California Education, a multi-university research project, reported recently, adding that "Black students were more likely to experience school closure than any other racial subgroup. Black students represent nearly 14 percent of the student body in schools that were closed."

Demography is destiny and California's school conundrum of declining enrollment, high absenteeism and unstable attendance will become more intense. It warrants urgent attention by the state's political figures, from the governor downward.



## **LETTER TO THE EDITOR**

### Carmichael Water District and Sacramento Suburban Water District Combination

Dear Ms. Lee,

The boundaries of the Carmichael Colony Neighborhood Association and the Carmichael Creek Neighborhood Association (both referred to as "CCNA") span from Oak Avenue to the south, Fair Oaks Blvd (N-S) to the west, the American River to the east, and Fair Oaks Blvd (E-W) to the north. The area that the two CCNAs represent encompasses approximately 1,800 single family homes, various apartment complexes and businesses. Both CCNA Boards are very appreciative of the time your organization has taken to educate us on the proposed combination currently being considered between the Carmichael Water District (CWD) and the Sacramento Suburban Water District (SSWD). We appreciate the considerable analysis and attention that has been given to determine if a combination is in the best interests of CWD customers. Our two CCNA Boards of Directors would like to take this opportunity to offer the following comments on the proposed combination.

From our perspective, CWD has good water rights; a high-quality surface water supply with state-of-the art filtration; a high-quality ground water supply with finances identified for additional new wells; a consolidated office and field operations center; a long-term capital improvement and infrastructure replacement program with a rate structure to support that program; and a strong and competent team that maintains top-tier water service and has excellent rapport with the Carmichael community and regional water agencies. Given all this, we wonder how the district would benefit from a combination with SSWD. What is the problem that would be solved by this combination? We don't see the problem and cannot see the benefit of the combination.

Both CCNA Boards believe that CWD has some of the highest water quality in the region, while SSWD water, while fully potable, is harder and does not taste as good as CWD water. We also understand that the system water pressure in the SSWD is lower than that of CWD. We are concerned with growth rates occurring and projected in the SSWD boundaries which may threaten our water rights and draw down our water supply to meet SSWD needs in the future. Further, we are concerned CWD will face higher fees in the long run with the incorporation of SSWD.

If the two systems were connected, we have significant concerns about long-term water security, diminished water quality and water pressure that would likely result for our CWD system. While SSWD will appear to benefit from this proposed combination, it does not appear that CWD will benefit or has a need for this combination to continue its excellent service.

en all the evidence presented in written materials and response to public comments in public meetings, the two CCNA Boards have conferred and at this time do not support the proposed water combination. If discussions are to continue towards a combination, we request CWD revisit its analyses to provide clear, demonstrable justification and assurances that the CWD's water rights will not be lessened or compromised, that our level of service will not be diminished, and that our rates will not rise with this a combination. Further, we request that a vote among CWD customers be conducted before any combination is formally pursued by the CWD Board. Again, at present, given our current understanding and without compelling justification coming to light, both CCNA Boards are opposed to the proposed combination.

## LETTER TO THE EDITOR Dear Carmichael, I'm Leaving You!

To our neighbors in Carmichael, In 2021, the Carmichael Water District (CWD) Board of Directors went into an agreement with the Sacramento Suburban Water District (SSWD) to perform a combination study. The boards spent \$140K of district funds on this to determine whether merging the two would benefit both districts. Widely unknown to the Carmichael community is that the studies objectives weren't just fact finding but also to install a pathway designed to consolidate the CWD into the larger SSWD along with all of its resources.

The problem is the CWD isn't in need of SSWD and has considerable advantages over it including surplus water which it sells, modern pumping and filtration facilities, an abundance of clean quality water and a very capable service department.

Carmichael Water District has

served Carmichael since 1915 providing a reliable source of water that our community has depended on since Carmichael began. Carmichael has its own unique hometown identity, and the Carmichael Water District has always been a part of it. Carmichael has the longest standing river rights established in 1915 and has always met the needs of its community.

SSWD's population is expected to grow aggressively and will need water. Expensive infrastructure projects will be needed, and the added cost will be shared by its new "Carmichael Area District" customers after the consolidation has been completed. Conversely, Carmichael isn't expected to incur additional costs in the near future. The surplus water Carmichael pulls from its river access and ground wells is sold and the benefit goes to its customers by generating additional revenues to offset operational costs. That would go away as the water is expected to be diverted and used by the thirstier growing SSWD.

Even more impactful will be the large cost of reorganizing both districts into one. This alone is expected to raise rates to its customers for at least two to five years as stated in the consolidation report.

If the Combination Agreement is completed the Carmichael Water District would be dissolved and absorbed into the larger Sacramento Suburban Water District. Carmichael residents lose its longstanding ability to govern itself. The vote to make this happen will be at a special board meeting held on Tuesday Mar 26th 5 p.m. at the Carmichael Water District office located at 7837 Fair Oaks Blvd in Carmichael.

The Carmichael Community is

widely unaware of the expected loss of its community water district. The boards have outreach programs to educate the community but only 56 individuals had attended its February 24th public workshop out of a population of nearly 40,000. Additionally, the language used to inform the community about this on its website and literature in my opinion is vague, misleading and doesn't clearly state its true objectives. It is referred to as a "combination study" but actually opens a path of no return. It can't be reversed once the process has been completed and that is expected to happen soon. Besides the board of directors' obligation to protect its customers, it has largely ignored the numerous concerns voiced by Carmichael residents.

In fairness to its Carmichael customers and community the Board of Directors should discontinue its efforts until the community has been well informed and heard from. Even CWD's own employees' union voiced its opposition to the merger.

As a fellow Carmichael resident and neighbor, I'm asking you to help in this effort of opposing this! The CWD contact information is below. 

## Sacramento County Behavioral Health Serving Those in Need

**SACRAMENTO COUNTY, CA (MPG)** -Sacramento County Behavioral Health Services (BHS) provides programs, services, outreach, education, and engagement to eligible residents of Sacramento County with prevention and early intervention, outpatient services, case management services, crisis intervention and stabilization services, and inpatient psychiatric hospitalizations to better connect individuals to necessary supports, including mental health and substance abuse services.

#### **Community Outreach Recovery Empowerment (CORE) Program**

CORE provides specialty mental health outpatient services at 11 sites throughout Sacramento County. In addition to these sites, services are delivered in the community, wherever requested. Each CORE site has a co-located peer run community wellness center, which is open to any Sacramento County adult seeking meaningful activities.

CORE sites have the capacity to serve 7,700 throughout the system at any point in time. Each program includes flexible dollars for preventing or helping resolve homelessness. Of the 7,700, as of February 2024, there is an available capacity for 3,115.

#### Mental Health Urgent Care Clinic (MHUCC)

MHUCC is a 24/7 resource with a team of peers, clinicians, and medical staff who can assist in a calm and supportive environment. If anyone is having an immediate mental health and/or co-occurring substance abuse need and contemplating using an emergency room, the clinic is a great alternative for care. The County is also working to open a second MHUCC.

#### Substance Use and Prevention Treatment

Sacramento County Behavioral Health provides a range of substance use treatment programs for the prevention and treatment of alcohol and drug use/abuse. We contract with an array of community-based service providers throughout Sacramento County. The range of services provided through these organizations includes outpatient treatment, medication-assisted treatment, withdrawal management (detoxification), residential treatment, perinatal services, and sober living environments/recovery residences.

#### Programs Earmarked for People Experiencing Homelessness and Mental Health Crisis

While persons experiencing homelessness that have mental health treatment needs can access any of the County's behavioral health services and programs, there are specific teams and programs designed to serve the unique needs of these clients. **Full-Service Partnerships (FSPs)** FSPs provide individually tailored intensive services for clients who are most at risk - including those experiencing homelessness and have a serious mental illness. Clients receive intensive case management and mental health services as well as HUD funded housing subsidies. Not all persons that are living with a mental illness and are homeless qualify for an FSP. Currently there are 12 FSPs capable of serving a total of 2,751 eligible individuals – with availability for 379 additional clients – many of which are earmarked for seniors and transitional aged youth (TAY). The County also has and is expanding three programs for those who meet medical necessity (Medi-Cal), have a mental health diagnosis (can be provisional) and are justice involved (exiting incarceration).

Community Justice Support Program (CJSP) serves 175 persons, Transformative, Healing, Renewing, Inclusive, Voice, Empowerment (THRIVE) FSP – currently in contracting - 200 persons, and THRIVE Adult Outpatient Program – three walk-in locations under development – 750 persons.

#### Flexible Integrated Treatment (FIT) Program

Serving youth under age 21 with a mental illness and their families experiencing homelessness or at imminent risk of homelessness. In addition to mental health services, FIT can also assist with housing services and support. FIT serves approximately 9,000 youth annually with outpatient mental health services that includes flexible dollars for preventing or helping resolve homelessness.

#### Homeless Engagement and Response Team (HEART)

Staffed with counselors and peers HEART uses a phased approach to help encampment and shelter residents enroll in needed behavioral health services and support. From rapport building to offering basic services to building enough trust to offer behavioral health assessments and eventually, referrals – the timeline for these phases can be weeks or years. The team's goal is to reach enrollment phase so that encampment and shelter residents will consent to and can obtain the behavioral services they need.

In 2023, HEART had 3,200 outreach encounters with people experiencing homelessness in encampments and shelters.

Nearly 600 were screened for mental health services, 463 were admitted to outpatient programs, and 123 were linked to a full-service partnership (FSP) intensive outpatient program.

Sacramento County has capacity for 2,751 FSPs with nearly 400 available for use – including those for targeted sub-populations like transitional aged youth.

#### Permanent Supportive Housing (PSH)

PSH units offer long-term stable housing and services to support individuals and families who need ongoing assistance to maintain housing stability and prepare to enter the job market, school, and other community activities. Each of these projects also include a subset of units that are specifically funded through the Mental Health Services Act (MHSA) or No Place Like Home (NPLH) dollars and are earmarked for those with living with a severe mental illness.

Some facts are that there are 434 dedicated apartments across 16 projects since 2008, 264 MHSA funded units currently in operation (plus 33 units waiting for natural turnover, 137 NPLH funded units currently in operation, 175 Units currently in the pipeline in varying stages of construction, 138 MHSA funded units, and 37 NPLH funded units.

## Five Solutions to Some of California's Woes

California's biggest problem is up for debate. Sadly, there are many contenders vying for that dubious distinction. But instead of focusing on the problems, we need to be focused on solutions. Without rank, here are five chronic California problems where state leadership has completely failed and one simple idea for each to help improve governance and boost our quality of life.

Budget: This budget year, California faces a nearly \$40 billion deficit. To avoid such massive shortfalls, California should adhere to the state's "Gann Limit," a law passed by the voters in 1979 that limits annual budget growth to a combination of population growth and inflation. The Gann Limit is ignored or avoided by legislative trickery, but it provides a simple structure that would avoid the massive budget growth that contributes to massive deficits whenever state revenues drop. Gann addresses California's spending problem.

**Housing:** One of many reasons housing is so expensive is excessive government fees, which can run as high as \$135,000 for building a single-family residence. Right now, an El Dorado County man is battling these fees in his Sheetz v. County of El Dorado, California case currently before the US Supreme Court. I hope he wins, but the state doesn't need to be forced into fairness by a court decision. Developer fees serve a specific purpose but have morphed into a revenue source for governments. They should all be reviewed to ensure they are meeting their purpose only and not as a backdoor funding source for general government operations. This could help lower housing costs.

Crime: California's empowered criminals do not fear punishment and retailers are paying the price. Governor Newsom just recently witnessed this himself at a Target store. Thieves can afford to be cavalier, and casually stroll out of stores with arms full of merchandise because we've essentially eliminated punishment for shoplifting anything under \$950 in value. I'm encouraging Californians to sign the petition to repeal Prop. 47 that has wreaked havoc on our state and give prosecutors the ability to charge smaller retail thefts as felonies once again.

**Insurance:** The only thing leaving the state faster than its residents might be its insurers, who are pulling out of all or some of California's markets seemingly by the day. California must repeal Prop. 103 and make it easier for insurance companies to adjust rates and offerings. While this may lead to some price

increases in the short term, providing a framework for more insurers to write policies here will lead to more competition, more choice, and more options for consumers.

Homelessness: This problem may be most emblematic of the California Way, where taxpayers pay the most but get the least. Cities in some of the state's most beautiful and valuable areas have been overrun by a permanent cadre of homeless, many of whom are obviously mentally ill and who, by their own admission, are addicts. The state must dramatically expand the concept of forced care in Governor Newsom's "Care Court" proposal, to promote the health and safety of the homeless, but also to reclaim our streets, parks, and sidewalks for their intended purposes.

President Reagan once said there are no easy answers, but there are simple answers. And it won't get better overnight. California holds all the promise it ever did and it can again be a national leader in all that is right and good. It has been in decline, but this can all be turned around by showing the political will to implement simple ideas that would reverse some of the state's chronic problems. With the right choices, our future is bright.

#### Additional Intensive Treatment Programs and Beds

Sacramento County Behavioral Health Services also funds a variety of programs and services that serve those experiencing more acute behavioral health challenges, such as severe mental health needs or substance abuse.

There are 484 Acute Psychiatric Hospital Beds, 98 Psychiatric Health Facility (PHF) beds, Youth specific beds in planning, 266 Subacute beds, a plan to add a 64 Bed Mental Health Rehabilitation Center, 14 Adult Residential Treatment (ART) beds, 210 beds in Safe Stay Communities in 2024/25 Behavioral Health Bridge Housing, 60 Crisis Residential beds, and 104 Augmented Board and Cares beds. ★
