

## Woten Says 'Get Something Going' for Sheriff's Contract

LIVE OAK, CA (MPG) -Live Oak City Council appointed two replacement members to the Planning Commission from seven applicants on March 6.

Matt Cashman and Mike Tuman will serve four-year terms. Applicants were publicly interviewed either in person or by Zoom at the meeting. Much general discussion was about a desire to see Live Oak retain a quiet, small-town atmosphere, while at the same time focusing on rehabilitation and upgrading its downtown, and to preserve the structures it has. Another two applicants will be selected at the same time in 2025, no applicants will be selected in 2026 and another two applicants will be appointed in 2027 to fill the staggered terms.

High school student Aubrey Lopez requested the city's permission to paint a mural on a mechanic's shop in town to honor the community as one with

the legacy of a strong work ethic. The Municipal Code

does not provide guidance on murals so city staff was asked for direction to establish such a process. It was announced that 10 largescale murals have been painted in Live Oak since

Lopez gave City Council members copies of her mural vision of two men working in a field in the foreground with trees fading into the background. The council responded positively to the request. Live Oak City Manager Aaron Palmer reported that \$20,000 annually is put into grants for the arts, suggesting that it could be a source to defray Lopez' expenses.

Councilmember Jeramy Chapdelaine encouraged it as a great project for matching funds, with Vice-Mayor Nancy Santana, also an Arts Commission member, saying she will pass the word along to encourage this project.

Four Q Street residents pleaded with City Council

to address dilapidation and

garbage on properties there,

especially near Date Street.

One Q Street resident said that she has complained about this problem for 10 years. Another said she has spent more money than she earns fixing her own fence with nothing done by the city about the street. They said that the sidewalks aren't paved and the sidewalks turn to mud when it rains. With the need to repair potholes and add stop signs, the Q Street residents said, the area needs to be cleaned and made safer for children and dogs. The residents were told that a code enforcement officer would be in contact. City Manager Palmer's

All Consent Calendar items were passed, including updates to the General Plan and Housing Element. The latter, said contract planner Kevin Valente. is updated annually. Councilmember Bob Woten reinforced what he expressed in the last council meeting about refocusing on the unsigned sheriff's contract.

"Can we just analyze it again, just get something going? I feel an urgency," said Woten and warned, "...they (the Sheriff's Office) must plan a budget and we have our own budget. We need to dig down and see if we can get this taken care of."

Councilmember Lakhvir Ghag concurred.

Santana complained that citizen complaints on Councilmember Facebook pages are not always interfaced with and complainants redirected to the City's website where transparent answers might be available.

### **Gridley Waste Rate Increases Proposed**

GRIDLEY, CA (MPG) - A rate increase is proposed for Gridley waste management services affecting all customers, beginning next Jan. 1. A public hearing will be held at a date not announced by press time.

Gridley City Administrator Elisa Arteaga addressed the possible solid-waste rate adjustments at the March 4 Gridley City Council meeting.

"Initially, waste management did provide a presentation on Nov. 20th, and during these discussions, we confirmed the rates on the current contract were set at lower rates compared to other jurisdictions. They provided information and our city attorney reviewed the proposal that was submitted by waste management," Arteaga said. "On Dec. 18th, the City Council approved the extension with the caveat that we would come back because we are required under Prop 218 to provide a public hearing and allow for comments on the proposed solid waste rates. There is a 45-day notice period. And there is a recommendation reviewing approving the resolution and also confirming the extension of the contract. It's my understanding that we have not

received any objections."

Arteaga responded, "Waste management bills quarterly. We're not sending out collections, we receive funds through franchise. However, they are responsible for collecting their own bills. Waste management said property owners were responsible for providing waste services on their property and they also said they will be sending out notices to the property owners and to the tenants. Those will be going out on a quarterly basis and will be brought to the council in June for public hearing on liens." The five council mem-

bers unanimously approved holding a public hearing to consider the contract's solid waste rate adjustments and to confirm the contract extension of five years. The time and date of a public hearing will be

According to Gridley utility director Ross Pippitt, the city wells are in need of repair, He said that the Liberty Well located at the Industrial Park suddenly stopped working in early January. Commercial Pump and Mechanical, Inc. staff found that the shaft was bad in one spot and broken in another and that the shaft's wellhead at the bottom is broken and needs to be replaced."

In addition, Pippitt said that the Eagle Meadows Well is making unusual noises that should be examined.

"We felt like this was an emergency. It gets a little nerve-wracking, especially when two out of the five wells decide to quit working," Pippitt said.

Commercial Pump and Mechanical, Inc.'s invoice for the repairs, which included tearing the units apart, replacing the broken components and checking the electric motors; is for \$45,803.

The council members unanimously approved awarding a contract to Commercial Pump and Mechanical (CPM) for well repairs.

Pippitt also introduced the next item on the agenda, the recommendation that City Council consider approving the removal of concrete slabs and concrete debris on the Gridley Electric Department property at 57 E Gridley Road.

"There are three large concrete pads on the property. One has already been broken up and needs to be hauled away and the other two still need to be jackhammered into movable pieces and hauled out," Pippitt said.

The three bids presented to City Council ranged from \$13,320 to \$17,700 and Pippitt suggested going with the lowest bid. City Council members unanimously approved removing the concrete and awarding the lowest bid, which was from Kegan Waite.

City employee Katie Hill received a recognition certificate, presented by Gridley Police Chief Rodney Harr.

"We want to recognize Ms. Hill not only for her work ethic but also as an affirmation of what she does for us and the city. We present her with the California Associates of Code Enforcement Officers Certificate," Harr said. "To do this, she had to pass numerous amounts of hours and training. This is one of the goals of the city and the council to push forward this agenda by getting our staff certified and more educated, which makes us a better city and better department. Katie Hill has completed all the necessary requirements, accepted exemplary knowledge and dedication to the profession and she has earned the designation of a certified Code Enforcement Officer." Congratulations to Officer Katie Hill."

The next City Council meeting is at 6 p.m. March 18 at 685 Kentucky St.

GRIDLEY, CA (MPG) - The Gridley Museum is reaching out to Vietnam veterans in honor and recognition of the National Vietnam War Veterans Day, which is

The national day pays special tribute to the 900,000,000 Americans who served during the era, to the 58,000 names memorialized on the Vietnam Veterans Memorial in Washington, D.C. to those who never received the recognition they deserved when they returned home, according to the American Legion.

The Gridley Museum is asking residents to share their experiences serving in the Vietnam War.

GRIDLEY, CA (MPG) - After waves of heavy storms dropped inches of rain throughout the valley and foothills and feet of snow in the mountains, local reservoirs and rivers have swollen to healthy levels, not seen for quite some time.

State agencies such as California Water Watch reports that major reservoir levels currently sit at 117% of average levels, snowpacks currently at 99% average peak snowpack, and the percentage of dry wells below normal level have dropped to just 37% across the state.

As for Butte County, Drought.gov reports that February was the 30th wettest February on record and this year has been the 29th wettest year on record over the last 130 years. As a result, the word "drought" might not be heard much this year.

Lake Oroville currently sits 863.05ft, which is at 84% capacity according to California Data Exchange Center, California Department of Water Resources (CDEC, CDWR).

Water is currently being released from the Oroville Dam spillway, swelling the Feather River as snow melt is expected.

As of March 1, of this year, DWR reports that "Feather River flows remain at 3,50 cfs through the City of Oroville with 10.350 cfs being released from the Thermalito Afterbay River Outlet (Outlet) for a total Feather River release of 14,000 cfs downstream."

Releases from the Oroville Dam are expected to continue.

According to the CDECCDWR, as of March 12 Northern Sierra/Trinity Mountain

ranges boast 112% snowpack or snow water equivalents, and the Central Sierra ranges sit at 96%.

The Honcut-Headwaters-Lower Feather watershed in Butte County sits at 96% of the historical average. Historically the precipitation statistics for this area state that water year to date is typically 19.96" and as of March 11, 2024, it is currently at 19.17%.

## Michelle Solis Hearing Delayed

YUBA CITY, CA (MPG) - Michelle Christine Solis' preliminary court hearing on March 7 at the Superior Court in Oroville was rescheduled to April.

Solis' lead attorney, Matthew Clinton Smith, did not appear, due to a scheduling conflict at federal court in Sacramento, according to attorney Pat Beecham. Beecham requested the preliminary hearing be rescheduled for 8:30 a.m. April 23, which Judge Raymond J. Giordano

Solis, who taught at Sycamore Middle School in Gridley, was charged with having unlawful sexual intercourse with a minor and with distributing sexually explicit photos to a minor, both filed on Nov. 21, 2023 by Supervising Deputy District Attorney J. Bennett. Gridley Unified School District wrote

in a statement that Solis has been on administrative leave since October 2023, when police were first notified of the allegations.

In November 2023, Solis was arrested and booked into Butte County Jail after the Gridley Police Department investigators said they found evidence of a sexual relationship with a former student who is a minor. Solis posted bail and was released.

Solis plead not guilty on Jan. 12, 2024 to the two felony charges.

### **Feather River Fish Hatchery Steelhead Planting**

**OROVILLE, CA (MPG)** - The Feather River Fish Hatchery raised approximately 452,000 yearling steelhead trout around 8.5 to 9.5 inches in length for 2024 releases. Around 7,000 steelhead were released in the Thermalito Afterbay the week of Feb. 12 to support recreational fishing. In addition, 1,011 adult male steelhead were released into the Thermalito Afterbay from December to February after they had been spawned at the hatchery. Hatchery-spawned females were released back to the Feather


Approximately 445,000 steelhead were released into the Feather River at Boyd's Pump Boat Launch between Feb. 5 and Feb. 13 to meet mitigation requirements. Releasing the young fish further downstream improves their chances of survival.

Like the salmon that populate the Feather River, steelhead trout migrate from the river to the ocean, returning to the river as adults to spawn. Unlike salmon, they can spawn several times during their lifetime. The name "steelhead" comes from their appearance, a more streamlined shape than Chinook salmon with a silvery or brassy color as an adult.

The Feather River Fish Hatchery is a California State Water Project (SWP) facility built in the late 1960s to mitigate impacts on fish migration resulting from the construction of Oroville Dam. DWR owns and maintains the facility and provides funding to the California Department of Fish and Wildlife (CDFW) to perform spawning, rearing, and stocking operations.

## Bok Kai Parade Dazzles

MARYSVILLE, CA (MPG) - 2024 is the year of the Dragon according to the Chinese zodiac. The last Dragon year was in 2012 and the next one won't be until 2036. So, on March 9 and 10, the 144th annual Bok Kai Parade and Festival in Marysville was extra special, celebrating

Bok Eye, the Chinese water

god. POW! POP! POP! CRACKLE! FIZZZZ! According to Jon Lim, a fourth-generation Chinese American and president of the Marysville Chinese Community, the sound of the firecrackers are to scare off the bad spirits during the Bok Kai parade, especially just before the giant dragon,

Hang Won Lung, dances by. The crowd saw plenty of firecrackers, cymbals, bells, drums and chimes as the parade passed by.

Bok Kai Grand Marshall Judy Mann and Bok Kai hostess Naomi Houston rode in antique and vintage

Speaking of cars, there were many, ranging from antique to classic to recent, and an impressive line of Yuba County Sheriff Department vehicles, including a boat and a Jeep that looked like a tank. The shiny red firefighting vehicles drove by with horns blaring. One of them was a steam pumper used to fight fires in the mid-1800s. Riding atop and waving was Marysville City Council Member Stuart

Smith Gilchrist. The parade also included colorful dragon floats, dragon costumes, dancing and martial arts displays. One tiny red dragon rode on a classic Radio Flyer wagon. The Lincoln Elementary School from Oakland brought a baby pink, extra-long dragon that undulated and danced for the crowd. The Marysville Charter Academy for the Arts had its Dragons Marching Band, which added upbeat music to the moving displays.

The firecrackers went off again and the anticipation was high when the star of the whole parade, the great Hang Won Lung showed his colorful head. Bobbing and weaving, the 100' dragon followed the Pearl of Wisdom held high upon a pole just out of his reach.

At intervals, the dragon would curl up his long body and take a quick nap, then uncurl and continue chasing the pearl.

Much of Chinese art depicts a dragon holding a pearl and the story about the dragon is one of the oldest and best-known legends in Chinese folklore. The story goes that during a famine in central China, ruled by a greedy emperor, a young boy looks for food in a field. He digs up a patch of turf to bring home, and under it, finds a pearl. He takes the pearl and hides it in a sack of rice. The field of turf dies but the sack of rice overflows, and the boy and his mother share their good fortune with their neighbors. The greedy emperor hears about the pearl and wants it for himself but the boy hides the pearl by swallowing it, which then transforms him into a mighty dragon. From that day forward, the dragon would protect the land and its people.

Another legendary tidbit: Did you know you can feed the dragon as it passes by? Often during the dragon's dance, business owners and homes will hang a cabbage or lettuce on a string outside their doorways. When the dragon eats the offering, he then spits it back out, which seems a bit rude but represents the dragon spreading wealth, prosperity and good luck. Stacy Federico and Maureen Sala of the Fabulous Finds vintage store hung a big cabbage outside their establishment which sits along the parade route.

During and after the parade, the Chinese American Museum of Northern California was open to the public. Speaker David Lei gave a fascinating talk about "Customs, Rituals, and Beliefs" of the

Chinese people, and Brian Tom, museum director, conducted tours.

At the end of the day were fireworks and then live music at the WoodButcher bar until 10 p.m.

On Sunday, the festivities continued with the Bok Kai Temple opening its doors to the public. Inside sits the 1878 head of the oldest surviving dragon puppet, Moo Lung. The temple was built in 1880 and is one of the oldest operating Taoist temples in the country. On this special day, it is traditional that worshipers bring offerings for the saints: roast pigs, chickens, cakes, dumplings, fruits and nuts are placed on altars to be blessed and then later eaten at extensive family picnics.

The graceful movements of the cultural dancers entertained the crowd throughout the celebration. There was a car show and a rib cook-off where you could sample and vote for the most delicious ribs and browse through the many custom cars (without touching the chrome with sticky fingers).

An extravagant finale was the "Firing of the Bombs," a loud and boisterous activity where the colorful firing of the bombs highlights the celebration, which is in tribute to the Chinese Water God, The Bok Eye. According to the Bok Kai Temple website, the bombs are fired in a roped arena where the young scramble for "good fortune" rings, which are shot into the air from the bursting bombs and traditionally bring luck throughout the year. The rings can be kept by those who retrieve them in the scramble.

The 144th annual Bok Kai Parade and Festival was a huge success and enjoyed by all who attended.

Suzanne Gray passed away on October 12, 2023 from appendiceal cancer, a condition as rare as she was. She was full in family, friends, and purpose, and her story continues through all who knew her.

Suzanne was born in Gridley, California to Dr. Harold Farnsworth Gray and Jayne Ellen Gray, RN, taking the honored role of "middle child" among five kids. Suzanne inherited her parents' love of nature and community, and learned to live with many passions and pursuits while staying true to her roots. While Suzanne left Gridley for college, ultimately earning a BA in dance therapy from UCLA in 1976, a close friend said of her, "You can take the girl out of Gridley, but you can't take Gridley out of the girl."

Suzanne lived most of her adult life in the greater Bay Area region, and wherever she was, she made a home and invited others in. She backpacked the Pacific West from the Olympic Peninsula to the Desolation Wilderness. Suzanne was a performer, educator, and storyteller by nature. She enjoyed acting in everything from commedia dell'arte to Brecht, and was a skilled and active multi- instrumentalist and vocalist with a special gift for harmony.

Suzanne moved from Oakland to Petaluma in 1990 along with her husband Bob, and daughters



Willow and Elena, and stayed for three decades. She flourished from an outsider and newcomer to, as friends dubbed her, the "Mayor of Petaluma,". In the arts, she was a beloved member of Petaluma's own bluegrass band "Side Dish," in which she sang and played a mean guitar, dulcimer, and percussion. In her spiritual life, Suzanne was a longtime parishioner at St. John's Episcopal Church and a mainstay in their choir. Through it all. Suzanne remained as at home outdoors as in, evidenced by her daily walking ritual.

But it was in her professional life that Suzanne found her greatest love and calling: teaching. Suzanne taught young children, from kindergarten to third grade, at McNear Elementary. She was proud to work alongside esteemed colleagues and friends for 26 years. Generations of students can share in how Mrs. Gray remembered those special details about each pupil, and marveled in seeing the people they became.

In 2022, Suzanne received her cancer diagnosis, which was followed by an outpouring of support from her many communities. Given a prognosis of less than 14 weeks, she lived for 14 months. ## Jury Convicts in Chico Robbery Homicide of Local DJ

**Butte County District Attorney** News Release

CHICO, CA (MPG) - A 24-year-old Chico gang member was convicted recently in the 2021 robbery-homicide of a 24- year-old Chico disc jockey. A Butte County jury returned a verdict after approximately four hours of deliberation, finding Diontanae Jerome Tillman guilty of first-degree felony murder, second-degree murder, and robbery. The jury also found Tillman personally used a firearm when Tillman robbed the victim of his property and his life.

The jury found that Kevin Murillo, 24, a local disc jockey known as "DJ Kam", was murdered on January 5, 2021, when Tillman set up a fake drug transaction to lure Murillo into meeting with Tillman and selling Tillman cocaine. The evidence showed that Tillman, believing Murillo to be an easy target, brought a .40 caliber handgun and attempted to steal narcotics from Murillo.

Surveillance footage at the arranged meeting spot in the parking lot of the 7-11 store on Walnut Avenue in Chico showed Tillman getting into the passenger seat of Murillo's vehicle and shots being fired about a minute later. Tillman then fled the scene of the crime, being driven away in a separate vehicle by a co-defendant, Max

Escobar, 23. Escobar had pleaded guilty prior to Tillman's trial to being an accessory after the fact for acting as a getaway driver from the scene and was given probation at the time.

A good Samaritan, who was in his car in the 7-11 parking lot, had seen Murillo's car lurch forward and high center on a planter at the edge of the parking lot. Seeing a black car fleeing from the scene, the good Samaritan thought he had just witnessed a hit-and-run DUI incident and followed the black car and blocked its path some blocks away until the Chico Police officers were able to detain and arrest its occupants – Escobar and Tillman. Unfortunately, Murillo was pronounced deceased at the scene in his car.

With assistance from local California Department of Justice criminalists, investigators were able to determine bullet trajectories inside Murillo's vehicle. That evidence showed Tillman fired at least 14 rounds, striking Murillo 12 times. It also showed Murillo was able to fire one round from a gun he had, ineffectively striking the ceiling of his vehicle, before bouncing off and hitting Tillman's shoulder, leaving a bruise.

In an interview that night with Chico police detectives, Tillman admitted he met up with Murillo to rob him, but claimed Murillo pulled his own firearm and shot at Tillman first. At trial, Tillman testified on his own behalf that Murillo pulled his gun out and shot at Tillman first, and it was actually Murillo who was robbing him. Tillman also claimed in his testimony that the Chico detectives pressured him into admitting he went to the 7-11 to commit a robbery and that he was actually high on drugs at the time of his interview.

The trial prosecutor, Butte County Deputy District Attorney DJ Lee, pointed out to the jury that Tillman's story was inconsistent with the forensic bullet trajectory evidence. Lee pointed out that the trajectory of Murillo's bullet into the ceiling of his own car was inconsistent with Murillo shooting first, and the trajectory of Tillman's bullets suggested almost an execution-style shooting.

Lee pointed to text messages and social media evidence from Tillman's cell phone that corroborated Tillman's initial admission to detectives that he intended to rob Murillo, and showed the jury Tillman's videotaped interview with the Chico detectives to debunk the idea Tillman was pressured or under the influence of drugs. Additional evidence from Tillman's phone showed he intended to rob Murillo the night before, but Murillo's supplier ran out of products and the meeting was canceled.

Evidence of other robberies by Tillman was also introduced before the jury.

Finally, Lee presented evidence that while awaiting trial in Butte County Jail, Tillman had gotten a teardrop tattooed on his right cheek signifying that he had killed a person.

Lee argued before the jury that under California felony murder law, when a person intends to commit a felony, such as a robbery, and a killing occurs, even accidentally, the killer is criminally liable for first-degree felony murder.

Butte County District Attorney Mike Ramsey noted the California legislature recently severely limited the felony murder law, making it inapplicable to accomplices, such as getaway drivers like Escobar.

Ramsey thanked the jury for their patience and attention to detail during the trial that stretched over six weeks. Ramsey noted that it is only through the diligence and dedication of local prosecutors and juries that justice can be served, and criminals held accountable for their actions.

Tillman faces multiple life sentences for the murder of Kevin Murillo, as well as for the use of a firearm in the commission of the crime. Tillman's sentencing is scheduled for May 1, 2024, at 9:30 a.m in Oroville.



#### Winegrape growers pull out vineyards amid shrinking market demand

A once-in-a-generation downturn in the wine market is reshaping California's grape growing regions as farmers tear out vines to rebalance supply with declining demand. Throughout this winter, bulldozers have plowed through Lodi's wine country, leveling vineyards and piling vines in mangled heaps on either side of Highway 99 in San Joaquin County. Thousands of acres in the region have been removed or are slated for removal, according to an ongoing survey of its members by the Lodi District Grape Growers Association.

#### As pistachio production surges, California growers seek new markets

California pistachio growers are searching the globe for potential emerging markets to handle expected record-shattering crops during the next few years. A market outlook for the surging pistachio sector was offered at the American Pistachio Growers annual conference last week in Monterey. Pistachio shipments to Europe, Asia, Canada and Mexico allowed the sector to avoid overproduction with a 2023 crop that approached 1.5 billion pounds. Pistachio harvests are expected to

grow exponentially as nonbearing acreage comes into production.

#### Sunflower growers seek new contracts after seed firms leave state

A second contractor of hybrid sunflower seed production has pulled out of California in as many years, sending growers scrambling to find new seed-production contracts or replacement crops. Early this year, Syngenta told growers it was shutting down its California hybrid sunflower planting seed program and would no longer be contracting the crop. The company planned to close its Hamilton City seed-processing facility after finishing the 2023 crop. Last year, Pioneer Hi-Bred International Inc. closed its Woodland commercial seed lab. Sacramento water forum focuses on

#### improving data collection

Improving data practices to best manage California's water resources helped drive discussions last week as state and local water managers, farmers, environmentalists and others gathered in Sacramento for the California Irrigation Institute Conference. With a theme of "Fluid Futures: Adapting to Extremes," the Feb. 26-27 event focused on leveraging information and data technology to make water-management decisions.






