ELK GROVE, CA (MPG) - About 300 attendees helped raise funds at the annual Spring Tea, an event associated with the Strauss Festival of Elk Grove, on March 23 at the Center at District56.

Planners Discuss Storage, Wireless, Lighting

ELK GROVE, CA (MPG) - Elk Grove Planning Commission items at the March 21 meeting included approving a use permit for Guardian Yards, a storage facility for contractor equipment and work trucks. The commission also approved changing language in the Municipal Code to read that wireless antennas have a 10-feet clearance from power lines "all around," not just horizontally. It also weighed language for defining lighting power and range for residential exteriors in the Municipal Code.

Applicant Tomasello owns Guardian Yards, which is an open-space storage in development at Waterman and Grant Line roads. Tomasello informed the Planning Commission that the site was prohibited from having structures due to overhead power lines and described how the layout was a needed one-of-a-kind facility. Commissioners asked about his using optional ground cover rather than just using asphalt.

Tomasello agreed to work further with the engineer to use bio-filters and perhaps an asphalt base to develop a more porous ground cover. The Planning Commission approved a motion that no further CEQA (California Environmental Quality Act) guidelines need be met and for a Conditional Use Permit with modification that hybrid paving be pursued.

The Planning Commission considered a motion to amend the Zoning Code to require 10 feet of clearance between a wireless antenna and any power lines when the wireless antenna is not integrated with a utility tower or facility. Existing code requires 10 feet of horizontal separation. The revision would delete the word "horizontal." Upon discussion, the rec-

ommended resolution was adopted unanimously.

It was suggested the Planning Commission review and provide direction to staff on the text amendment update for the city of Elk Grove Lights Standards as to exterior residential lighting. The light fixture shall not exceed the roof height to which it is attached. Bulbs will not exceed 1,600 lumens, each lumen being 100 watts and 1,600 candle powers. The lighting will be focused downward. The Continued on Page 3

Sheriff Cooper Supports Initiative to Restore Safety

Sacramento County Sheriff's Office News Release

SACRAMENTO COUNTY, CA (MPG) - In 2014, the voters passed Proposition 47 (Prop 47). Those who wrote the initiative deceived the public by naming it the "Safe Neighborhoods and Schools Act." I actively opposed Prop 47 because it was clear to me that this initiative would severely hurt our communities and eliminate much-needed programs to ensure the public's safety. The proposition nearly decriminalized narcotic possession for personal use, including fentanyl, cocaine, heroin, and methamphetamine.

It also made retail theft very lucrative for serial thieves by reducing penalties to virtually the same as receiving a traffic ticket. It also prohibited adding the dollar amounts from multiple thefts, resulting in an illegal industry in which career thieves could repeatedly steal with minor consequences.

However, the most damage caused by Prop 47 was the decimation of mandated drug and alcohol courts that were used to get people help in lieu of jail time. Just in Sacramento alone, drug court participation dropped over 70% because of the so-called "Safe Neighborhoods and Schools Act."

After its passage, I spent eight years in the California Legislature attempting to correct the reckless impacts of Prop 47. After many attempts to amend the proposition, California courts and Legislative legal counsel deemed that Prop 47 could not be fixed by the Legislature and had to be returned to the voters for any meaningful amendments. In 2020, because the only way to return to common sense and restore

public safety was through the action of the voters, I was one of the proponents of Proposition 20 (Prop 20), which would have fixed the problems we are all witnessing today.

Once again, the advocates for criminal lawlessness lied to the voters, claiming that Prop 20 would result in "mass prison incarceration." Sadly, that measure failed, and the problem of rampant retail theft, homelessness, and drug addiction has only gotten worse.

As Sacramento County Sheriff, I have witnessed first-hand the horrific problems brought about by Prop 47 in our community. It continues to devastate businesses of all sizes and types. Many small community-based businesses have been driven to the brink of closure. Additionally, the catastrophic impacts of Prop 47 on drug addiction left untreated cannot be denied in Sacramento. Without the ability of the courts to mandate drug treatment, many people's lives continue to be ravaged by addiction, leading to homelessness and death.

As Sheriff, I have tried to address the homeless and theft crisis. Through our intervention efforts, data has been collected and analyzed, which shows in Sacramento County alone, 66% of our homeless population has a drug or alcohol addiction. I have also conducted major retail theft operations. One operation named "Operation Bad Elf" netted over 300 misdemeanor arrests for retail theft in just a 7-day period. This is nothing short of unabated lawlessness caused by Prop 47's misguided provisions promoting criminal behavior with no accountability.

I conducted these operations because I refuse to have the citizens of Sacramento County be

victims of the unjust laws created by Prop 47. However, those arrests are still misdemeanors and operations that size are costly to the taxpayer and unsustainable. Furthermore, those addicted to drugs and alcohol will continue to have their lives caught in substance abuse turmoil until we have the courage to mandate their treatment. I will continue doing what the law allows me to keep you safe and increase your quality of life, but it will not be enough.

This is why I am endorsing the Homelessness, Drug Addiction, and Theft Reduction Act Initiative, which is in the qualification phase and if qualified, it will give the voters an opportunity to amend the dangerous and failed aspects of Prop 47.

This initiative will classify repeated retail thefts as a felony if they have two or more theft convictions. It allows for stolen property values to be combined so serial thieves can be charged with a felony if that amount exceeds \$950.

Also, it adds fentanyl to the list of hard drugs that are illegal to possess with a firearm, enacts the "treatment mandated felony" that would give drug addicts the option to get treatment instead of going to jail, and allows drug-addicted offenders who successfully complete drug and mental health treatment to avoid jail time.

This initiative does not repeal Prop 47, does not lead to "mass incarceration," and is necessary because the California Legislature cannot, by statute, fix the chaos created by Prop 47. It must be fixed by the voters.

I urge you to join me in this effort to return our neighborhoods and schools to safer places that have been devastated by Prop

Jemuel Johnson Shares Society's Wonders with Readers

Sacramento author Jemuel Johnson's new book, "21 Wonders (That You Don't Know)," tells the tale of influential figures that time has forgotten, including Nikola Tesla, Benjamin Banneker and John Brown.

Johnson also wrote the romance novel, "And The Tears Revived" in 2013. and a collection of suspense tales, "Needles" in 2021.

Now, he has added historical accounts, recognizing heroes of the past to his repertoire. "21 Wonders (That You

Don't Know)" revolves around 21 unsung revolutionaries of yesteryear. "I'm essentially giving

them their flowers. Isn't that a wonderful thing?" Johnson said.

He is proud to provide recognition to those who did not necessarily receive it in their lifetime or ever for that matter.

"Unfortunately, many figures of massive influence are relegated to the shadows of history or are eventually acknowledged 200 years later," Johnson said. "Better late than never, I suppose."

A busy entertainment entrepreneur, the Arden-Arcade-based Johnson is a novelist and also a former TV host and producer of "Half Circle," which broadcast on Comcast On Demand (Channel 17) from 2009 to 2014. Johnson values his read-

ers and tries to write with the knowledge that many don't have much spare

"'Wonders" is a book that can be finished within a week during someone's lunch breaks," Johnson said. "This book is for people who have a lust for life, who engage with nonfiction, love harrowing, inspirational and aspirational storytelling, and are honest with themselves that they don't read 500page books anyway."

Readers will find stories that tell the true struggles and dreams of each of the 21 individuals featured.

"I'm obsessed with people who have been through the fire for a desired result," Johnson said. "I want people so badly to own and develop their gifts. These gifts are their upper hand in life. This is not taught in our schools in a dynamic way."

Outside of his creative endeavors, Johnson works in ride-sharing for both Uber and Lyft from 3 to 8 every morning for the past five years. The job includes airport drop offs, chatting with truck drivers and assisting those going to and from dialysis appointments.


The wide range of individuals that he interacts with daily serve as inspiration. Through these conversations, which include challenging circumstances such as dialvsis treatments, Johnson receives inspiration by hearing and observing how everyone's life counts and the desire that others have to share their perspectives.

the best February sales volume since 2005 when 908 homes were sold during the height of the housing boom. The average sales total for the month is 504.

February's sales were up 31% from January and 37% from February 2023. During the first two months of the year, 1,342 homes have sold – 28% higher than last year's total for the same period.

The BIA's sales figures cover 190 active new home communities in Sacramento, Placer, Yolo, Yuba, El Dorado, Amador and Sutter counties.

for an incandescent light, and 14 watts for LED.

The other commissioners were taken with Commissioner George Murphey's comment that eyes are deemed "sensitive receptors" and lighting installed from eight to 12 feet high needs to be installed as fully shielded down-lighting to protect from glare into a person's eyes. Murphey said that manufacturers aren't making the lighting to be shielded, so most residents would likely install carriage lights; most of those lights are 60 watts. Reflective light behind and above must be turned out and down, it was reported.

Discussion covered that

standard bulb is 100 watts than 12 feet, the prop- it should be added "...no erty owner must apply for design review and file a photometric plan for a proposed light review. That would be a public hearing before a zoning administrator and take three to four months. A resident cannot ask for more than 20 feet of height for lighting. As to all lighting, it cannot blink or flash.

Planning Commissioner Vice-Chair Juan Fernandez referenced www.darknight.org as a site to access to study lighting. It was mentioned that illegal lighting can be cited as a public nuisance. Direction was given to staff to indicate these restrictions in the code. Although it reads that night lighting can be

Commission, the Historical Society




and served in the Volunteers in Partnership program for the Sheriff's Department.

It seems the marketing folks won't leave us alone. They are constantly trying to sell us something.

They follow us everywhere. "Buy, buy, buy!" It's the mantra of a marketing world where the word "miracle" is defined by how quickly our plants grow or how white our teeth become.

The solicitations blast through TV commercials, emails, voicemails, texting, even through recorded infomercials wailing in medical waiting rooms. Thankfully, I can ignore most of those sources.

But there's one place I can't escape the gas pump.

Service stations often use video displays on the pump pontificating such things as the wisdom of buying good rain tires.

Yet, despite all the pleas to buy things,

my hospital chaplain experiences tell me that whatever I buy will likely one day be packed away in a plastic garbage bag.

I know this from the numerous times I was present for the end of life. Those moments usually started with a squawk over the public address system.

"Code Blue, 5 North. Code Blue, 5 North.'

That announcement was my cue to join medical staff running toward the Intensive Care Unit. Inside the unit, the resuscitation team would surround the patient while I'd stand a few feet away beside a frantic fam-

We'd watch together as clothes were cut off. IVs inserted. Chest compressions

The doctor often held defibrillator paddles and rubbed them together, merging confidence and chance.

"Charge - clear - shock - charge - clear shock.'

Nothing.

"One ampule epinephrine," called the doc to the nurse.

More compressions and more shock. Heads turned to the monitor. Nothing. The doc placed his stethoscope on his patient's

"I'm calling it," he'd say.

This was the official pronouncement for everyone to cease their lifesaving efforts and allow the time of death to be recorded.

As you might imagine, I'd spend the next few minutes with the family in closing rituals and prayers.

Those were highly meaningful moments to the family, but eventually we came to a rather awkward time of gathering the loved one's belongings.

Of course, the family was unprepared for this duty, so the nurse would offer the easiest packaging available -- often a plas-After the family filled the bag, staff

would say their goodbyes and I'd walk the family out of the hospital through the main lobby where the TV typically wailed another pitch to buy one more thing.

Those walks often had me wondering what it might be like when my time comes.

Will my bags be filled with things the marketers persuaded me to buy? And what will my children do with those bags?

Whatever they decide, I hope my physical possessions aren't the only things I'll pass on to them. I hope they carry a part of my faith as well. Of course, faith can't be inherited from

parents. That's why it's been said that

"God doesn't have grandchildren, only children" - meaning a person must find his or her own faith.

However, it is still a legitimate part of my faith journey to regularly ask myself questions like: Will there be a part of myself worth commending to my children? What part of me do I wish they

would become? And what part of my faith

ends with my death? I guess all those questions can only be answered superimposed with Jesus' question in Mark 8:36 and repeated throughout modern history by Gandhi, King and Kennedy.

"What does it profit a man if he gains the whole world and loses his soul?"

Keep that question in sight and the answers you find will become a legacy worth sharing. H

Matsui Comments on Emission Standards

Office of Rep. Doris Matsui

WASHINGTON, D.C. (MPG) - Congresswoman Doris Matsui (CA-07) released the following statement in response to the Environmental Protection Agency (EPA) finalizing new light-duty vehicle tailpipe emission standards for cars and SUVs, model years 2027 and beyond.

The transportation sector is the largest source of greenhouse gas emissions in the United States, accounting for 27% of all greenhouse gas emissions. Congresswoman Matsui has been one of the foremost voices in Congress calling for new, stronger emission standards for passenger cars and light-duty trucks.

In March 2023, the Congresswoman led 54 lawmakers in urging EPA to issue and swiftly finalize a new emissions rule for light-duty vehicles.

In July 2023, after EPA proposed a new rule, the Congresswoman again led 91 colleagues in urging EPA to swiftly finalize a strong emissions rule.

"Today's announcement by the Biden



Administration is an unprecedented step toward a cleaner, safer, and more resilient future," said Congresswoman Matsui.

"The n e w emissions rule for light-duty vehicles announced

today will cut emissions from passenger cars and trucks by more than 50%, helping America and the world avoid the worst consequences of climate change and delivering \$13 billion annually in public health benefits. I have fought for years to see this day, and I applaud the President and the EPA for taking this historic leap

As co-chair of the Sustainable Energy and Environment Coalition (SEEC), Matsui led a letter campaign urging the EPA to finalize the strongest heavy-duty vehicle emission standards.

Hidden Gems Await in Small Delta Towns

CALIFORNIA DELTA REGION (MPG) - The California Delta: home to many school geography lessons you vaguely remember, and if at any point you took a casual drive through the region, you might think California as a whole vaguely remembers the Delta. There are no fancy main streets, no fabulous exclusive neighborhoods, no prime retail experiences that Californians have come to expect. To put it bluntly: the Delta doesn't care to dazzle any tourist, and for the overstimulated, distracted locals that we are, this suddenly sounds mighty nice. The Delta

is sleepy? Meandering? Humble? Indifferent? Count us in.

We've driven from Sacramento to Antioch on a regular routine for years now, and this means having the opportunity to focus on the simpler Delta life with the many pit stops along the way. With that said, we love to share the hidden-inplain-sight gems we have found in the many small towns that dot the path.

First and foremost, we must pay homage to the bridges. You can twist and turn all across the delta on various brightly colored and uniquely-engineered bridges.

There is even a ferry vou can ride from here to there, and if you're lucky to catch a large boat


passing through, you can also watch as the bridges twist and turn to let them

No matter where you begin your day trip, there is a relatively easy path to follow: just go up one way along the Sacramento River on Highway 160 and then down the other side and you'll have basically touched it all.

For this travel reference, Freeport is the furthest north and Antioch is fur-

thest south.

Clarksburg: Many weekend warriors will head straight to the Old Sugar Mill for a one-stop shop of a dozen local wineries, and if you've never been, it's definitely worth checking off your list at least one time. But for those who

want a little more out of Clarksburg, we suggest a walking tour of sorts the architecture of many of the homes and schools easily bring us back to The Wonder Years nostalgia, with the old growth trees shading the streets confirming the timeline. There is also a colorful community garden to stroll, and a pit stop at Husick's Restaurant to grab an iced

There we admired the pickup truck that also came to its final resting spot out front during those years.

Isleton probably has th most revitalized main street along this entire drive, still keeping with the Chinese heritage mixed with some classic and eclectic shops to peak your curiosity. Mei Wah Bar Room boasts one of the few opium dens in the region, The Mcboodery sandwich shop has residents raving, and a combination of antiques, museums and a coffee shop make for a perfect jaunt to admire it all. And while some of the classics have sadly gone out of business, the nostalgia is holding strong with neon signs, vintage buildings and land markers of crawdads. Also worth spotting? The

colorful gazebo in the town center and businesses that are "coming soon" (make mental note for when you return).

Locke: In our humble opinion, Locke is by far the most unique and exciting town on the Delta. Unlike any other town we have come across in California, Locke is a historical landmark dedicated to preserving the history and contributions of our Chinese citizens.

It has been preserved just as it was built some 100 years ago, and walking the Main Street is like taking a walk back in time, and in China. The buildings are nothing like the typical gold rush/Victorian homes we tend to see. They bend, they lean, they are chipped away, but still they stand.

There of course is a Chinese restaurant, an eastern medicine shop, some souvenirs, a museum and antique stores but most famous: having a drink at Al the Wop's. This town is an absolute must-stop and explore and needs to be on every California travel bucket list.

Courtland: Pear capital of California. Maybe? We haven't verified that. But what we have verified is the lovely slow winding drive through walls of pear orchards with the ultimate stop: Hemly Cider tasting

Cider sampling for adults and kids, this family-friendly destination is set inside an old hangar with sweeping views of growing crops all around. A tasty-sweet way to appreciate our state's abundant agriculture.

Antioch boasts the most regional parks, wildlife preserves, and fishing docks to choose from on this route.

Notably, Black Diamond Preserve with its dozens of trails and historical landmarks to check in on, but one could also spend time bird watching and picnicking at the Delta Discovery shoreline & museum. Both offer fantastic educational experiences.

And of course, the Antioch bridge is one of the most exciting: on a foggy day it can feel as if one is ascending into the clouds with the sharp climb up over the Delta waters.





He had coached some of the players since they were little and was able to coach his son who was a freshman at the time, Justin Mariano.


Justin recalls his dad wanting to get 100% attitude and effort out of his players as it translates to life and on the field.

CRC's Kirby Turns Around Women's Basketball Team

SACRAMENTO REGION, CA (MPG) - During a scrimmage to prepare for a big tournament game in late February, Cosumnes River College women's basketball coach Samuel Kirby started shouting out "terrible calls" to get the team in a championship mindset.

Some of the players got irritated and upset with the calls and muttered under their breath. They were told to run the court.

When the practice was done, Kirby called a huddle and spoke to his team. The huddle broke with a shout of "family on three!"

Kirby's unique approach and ability to connect with his players has led to a lot of success at the college. The team's revival started with the hiring of Kirby in fall 2022.

Kirby quickly embedded himself in history at Cosumnes River College with the team this year winning the most number of games in a season since joining the Big 8 Conference in 2005. The team made the California Community College Athletic Association playoffs for the first time since the 2013-14 season. They were defeated in the third round in early March by Butte College.

"I didn't think about it much to be honest," Kirby said. "I knew I wanted to be part of basketball but I didn't know in what way and it kind of just happened."

The Player

Kirby grew up in the North Highlands region of Sacramento and became interested in basketball as a child, due to his father's passion for the game.

"It started when I was 4 years old," Kirby said. "My dad was a huge sports fan but a big-time

basketball fan. He built the basketball court in our backyard when I was like 10 and from there, it's been the love of my life."

Kirby's passion followed him as he attended Sacramento's Foothill High School and graduated in 2003 after helping his team reach the Division III state championship.

"I always tell people I was a shooting guard trapped in a point guard's body because I really love to score and I can shoot," Kirby said.

He played two years at San Joaquin Delta College and two more at Seattle University.

The Assistant Coach

Kirby had to stay another year at Seattle University to get his degree but his coach, Joe Calero, saw an opportunity for him to stick around the basketball team as a student assistant

"It was good from the aspect that I'm kind of seeing both sides," Kirby said. "The coaching aspect and why they're doing things that they're doing and the player aspect." Kirby became a top

assistant coach at Shoreline Community College, Cañada College, Cal Poly and Sacramento State University.

Then Cosumnes River College's women's basketball head coach position became available.

Bernard Seals, assistant coach to Cosumnes River College's men's basketball team, was a former shooting guard for Seattle University and a former roommate of Kirby's.

Kirby listened to Seals and asked for advice from Mark Campbell, a former coach at Sacramento State University, who transitioned from men's to women's basketball.

Their guidance was

enough for Kirby to apply for the position and reach out to Cosumnes River College's Athletic Director Collin Pregliasco.

'We were kind of blown away from not only his background but who he is and what he stands for as a coach," Pregliasco said.

The Head Coach

Cosumnes River College's women's basketball program was struggling. Pregliasco said there was no head coach, no returning athletes and a need to establish a winning culture on and off the court.

"We wanted to make sure that they were being provided the best atmosphere not only to be successful as an athlete but overall," Pregliasco said.

Kirby was able to shift from men's to women's basketball with help from experts.

"Trust me, I was so lost in a lot of areas when it comes to women's basketball just based on simple stuff like hair ties," Kirby said. "It was just great to have people on my staff to just tell me the truth." Kirby didn't have to

look far for an assistant coach because he had one in the family.

"I've been training kids

since I got out of college." assistant coach Brittany Shine said. "We were having a family barbeque and I told him, 'If you ever get a coaching position I want to be on your staff."

Not only does Kirby know Shine but she has played professionally for Iraq, Egypt, Portugal, China with the USA Select Team, Spain, Turkey, Cyprus, Morocco, Tunisia and most recently Kenya.

Shine received the call from her cousin while she was in Cabo.

"He called me and was like, 'ready to coach?'" Shine said. "I'm like, 'let's do it.' Didn't ask him where or nothing."

The Culture Builder

Kirby's first season ended with a 9-19 record and 3-13 record in the Big 8 Conference.

"I've never been the type to just take losing and be OK with it," Kirby said. "There's some games last year where we lost by 60 and I'll never forget that."

Kirby has a competitive fire in him, taking the losses and looking for ways to improve himself as a coach and his team's performance.

"There's a lot of great coaches in this conference and I respect all of them,"

Kirby said. "But I want to beat all of them, too."

One way to beat them is with a great recruiting class.

In Kirby's first year, he had about two weeks of recruiting. Three of the players he recruited returned to the team in his second.

One of them was sophomore guard Ashley Gonzalez from Texas.

Gonzalez has been a co-captain of the team since her arrival and has taken on the task of bringing up the new recruits to the expectations of Kirby as well as preaching the importance of achieving success in the classroom.

"I usually try to tell them to stick to school and basketball because if you're not doing good in school, then you're not going to play basketball," Gonzalez

Approaching Adversity One player injured her

ankle walking out of practice and missed a few games, another had a concussion. The team had battled

through adversity, whether it was losses, injuries or sickness, but Kirby has made it a focus to prepare for the unexpected and get better.

"I don't believe in getting sick," Kirby said. "Obviously, sickness is a real thing but when it comes to me, if I do the right things, take care of my body, eat right, workout; the chances of me getting sick is very, very low."

This might sound familiar to avid basketball fans out there who followed Michael Jordan in 1997.

"If you want to win, there's a process to winning," Kirby said. "That process is going to help you because it is going to equate to wins."

What is the process to winning games?

According to Kirby, it's showing up to practice with the mindset of improving, taking care of yourself and improving your game when you're not on the court.

Family First "Your family is always

going to have your back, right or wrong," Shine said. "We try to tell our players that it's a family." The coaches treat their

team just like a family. Everything they do is to help the team but also the individual players with whatever they are facing on and off the court. "We try to have an open-

door system," Shine said. "I feel like it's important to have that relationship on and off the court, so they know that we have their back as a family, not just for basketball."

Gonzalez said she had gone to Kirby for many reasons throughout the season, not just for basketball but for "whatever reason."

"He has a really big heart," Gonzalez said. "As a player, I've never seen that in a coach." Pregliasco said that the

goal at Cosumnes River College goal is "to make this better to work than wherever you're going." Kirby has helped the ath-

letic department achieve that and more.

"He has jumped right in, whether it was facility stuff, whether it's the coaching side, whether it's stepping up to help each other, out of season, in-season, all of that," Pregliasco said. "He's been a perfect
