Council Slows Cannabis Discussion, **Approves Increased** Salary

CITRUS HEIGHTS, CA (MPG) - At the April 11 meeting, the Citrus Heights

City Council continued a discussion about the possibility of allowing cannabis dispensaries to operate in the city. Medicinal marijuana use was approved by California voters with the passage of Proposition 215 in 1996 and recreational use was approved with Proposition 64 in 2016, with yes votes from 52% of Citrus Heights residents

at that time. While Citrus Heights has maintained a ban on retail cannabis dispensaries, City Council recently brought the issue up for reconsideration and requested staff conduct public outreach.

A total of 342 residents responded to an emailed FlashVote survey and 59% supported recreational marijuana use. When asked if they would support retail cannabis shops within the city, results were more split, with 49% in support and 48% opposed.

About 60 individuals attended a community workshop, with 61% of attendees supporting a retail cannabis industry in the city. An online feedback form on the city's website gathered 20 responses, with 54% in support of allowing dispensaries.

Many attendees spoke during Public Comment on this item and others submitted written comments. Some spoke in support of allowing dispensaries, citing the potential for additional tax revenue and the benefits to residents who are already patrons or operators of these businesses.

"We can't build a wall around Citrus Heights and hope that cannabis doesn't come into our community. ... It's here whether we like it or not," audience member David Warren

Warren said he supports allowing dispensaries to operate in the city because he views them as a "public safeguard," because it would drive out illegal sales on the streets.

Others spoke against the idea, such as Ray Reihle, who said that dispensaries will "degrade the character of our community."

New Galaxy Game Café Opens

CITRUS HEIGHTS, CA (MPG) -"Unplug. Connect with others." That's the philosophy of the new Galaxy Game Café, a unique family-owned board game play space that celebrated its grand opening last weekend in Citrus Heights.

Husband-and-wife owners Robert and Melisa Roden, Roseville residents, opened the welcoming 4,800-square-foot space with a starting library of more than 700 board and card games, providing something for enthusiasts of all ages and interests.

You'll discover the Galaxy Game Café not in a "galaxy far, far away" but at 7700 Sunrise Blvd., Suite 1900, in the shopping plaza near neighbors In-Shape Family Fitness and Aspire Hair Design across the parking lot from Leatherby's Ice Cream.

"Robert and I noticed you can't go anywhere today that doesn't have screens on the walls and tables full of people staring at their phones," Melisa Roden said. "We wanted a space where people look at each other, laugh with each other and engage in conversations right in front of them."

Inside, opening weekend gamers settled into an array of individual comfortable booths distributing game pieces and setting up their games for a fresh round of play.

Melisa Roden is an entreprenuer and graphic designer, and her husband, Robert, is an English professor at Sierra College in Rocklin. He's also an admitted Star Wars enthusiast, having built an extensive collection of figures and memorabilia since the movie's premiere in 1977.

His curated collection, which features figures, creatures, ships and playsets, are displayed in a diorama fashion in multiple museum-style glass display cases throughout the café reflecting

various scenes from the multiple movies and shows.

"It's great to be able to share that collection with everyone," Robert Roden said.

You'll find references to the "galaxy far, far away" all over the Galaxy Game Café, from the Galaxy Grub themed snack shop with its food and drinks to the "Bounty Box" retail store with games, apparel, toys and various pop-culture merchandise.

The couple considered multiple locations, including Roseville, before signing a lease for the Citrus Heights space. They obtained a federal Small Business Administration (SBA) loan to help with financing and recently completed three months of interior

tenant improvements, they said. "We've raised six kids and brought them all up playing board games from the time they were toddlers," Melisa Roden said.

Family game play fostered interaction, in addition to developing reading, math, strategy and coping skills, according to Melisa Roden.

"Our house was always full of activities to keep their hands and minds busy for hours at a time," she said. "Now that our kids are grown, we want to recreate that type of environment and opportunity for the greater community."

The café employs a staff of 12, including family members.

A designated "Kids' Play Space" offers a separate area for families with young children to select from age-appropriate games, books and bins of various activities to build, create and use



their imagination.

Drop-in daily play is \$10 per person for unlimited play at one sitting. Individual table reservations for up to six players, a \$20 one-time fee plus \$10 per person are required to be paid in advance. Individual memberships priced at \$30 include unlimited access to the game space and a 10-percent discount off the Galaxy Grub and all Game Academy activities. The cost of a family membership is \$100 for a family of four.

Players are not allowed to bring in their own games to play.

"Many of these games are highend and expensive, and we're doing our best to maintain inventory control," she said.

Patrons who have a favorite game they frequently like to play, which are not yet in the café's inventory, can suggest they can be added. Game donations are also welcome.

The couple also hopes to launch a game academy with a variety of pre-scheduled activities, such as after-school camps for kids, game classes, leagues, tournaments and special events.

The Galaxy Game Café at 7700 Sunrise Boulevard, Suite 1900 in Citrus Heights is open 11 a.m. to 9 p.m. Wednesdays through Sundays.

CARMICHAEL, CA (MPG) - San Juan Unified School District will celebrate six outstanding individuals, three of them students, at its 11th annual Spirit of San Juan Awards on May 9. One of those students is DaeChole Reed-Herbert from Citrus Heights.

"We are incredibly proud of DaeChole's 'Spirit of San Juan' award, acknowledging her actions and efforts as an exceptional leader on our campus," said interim Principal Roxanne Stellmacher. "DaeChole exemplifies the type of student we strive to develop at Lichen P-8, one who stands up for what's right and leads by example. We could not be prouder to call her a Lichen Bear."

The awards recognize individuals within the district's school communities who exhibit

exceptional character, remove barriers and provide an inclusive environment for all, according to district spokesperson Elysse Fresquez.

The three students being recognized this year are Julia Clauson from Bella Vista High School, Fair Oaks; Reed-Herbert from Lichen K-8, Citrus Heights; and Ethan "E Train" Minton, Winston Churchill Middle School, Carmichael.

The three other honorees are Robert Anderson, a Mary Deterding Elementary School teacher in Carmichael; Nancy Carter, a Mission Avenue Open Elementary School volunteer in Carmichael; and Greta Scholtes, Encina Preparatory High School principal at Arden Arcade.

Clauson, an 11th-grade student, advocates to ensure student voices are heard at Bella Vista. Clauson actively participates at the school and district level as a Superintendent's Student Advisory Council member, as the Bella Vista's writing club president and as one of two student representatives on the school's equity team. This year, Clauson is also spearheading her new project, a district-wide literary magazine aimed at sharing student voices.

Reed-Herbert, a seventh-grade student, mentors and encourages her Lichen K-8 School peers to promote a positive school environment. As the Black and Brown students club founder and Student Senate member, Reed-Herbert has fostered a welcoming and inclusive experience for Lichen students and staff.

Minton, a seventh-grade student, has advocated for and promoted literacy through his online platforms. He has organized book donations and author visits, and has also volunteered his time by reading books to kindergarteners in the district. Minton's work will leave a lasting impact on Winston Churchill Middle School students, who now have increased access to books.

Anderson was chosen for his dedication to young learners both in and outside of the classroom. As a kindergarten teacher at Mary Deterding Elementary School, Anderson promotes a welcoming and accessible classroom environment for his students and their families by making their first years at San Juan Unified School District memorable

Carter is a San Juan Unified retiree who continues to make an impact through her math tutoring volunteer work at Mission Avenue Open Elementary School. Her energy and enthusiasm for helping students succeed has been extended to all students, especially those who need extra support to get the job done.

Scholtes, as Encina Preparatory High School principal, actively removes barriers to make education accessible for all students. She works closely with students and families to solve attendance barriers, increases access to resources by working with resettlement agencies and community partners, and leads by speaking up for marginalized groups.

addiction and some predicted that it would not result in a significant increase in tax revenue for the city.

Elderly residents also pointed out that they were not represented in the data gathered from the online surveys, so future outreach should include mailers to registered voters.

Councilmember Mari-Jane Lopez-Taff has said she grew up with a parent addicted to marijuana, so she has a personal reason to oppose the marijuana industry. When looking at the city's goals to grow the economy, attract businesses, combat homelessness, reduce crime, and raise education and community awareness, she said, "cannabis does not have a place in that vision."

"For me, it is about the money," Councilmember Tim Schaefer said.

It will take decades to get all the roads repaved, Schaefer said, and while there is currently a surplus in the city's General Fund, "tougher times are coming," so it doesn't make fiscal sense to allocate more funding to roads than they already have.

Schaefer said that is why he wants to look for alternative revenue sources. He added that some of the anti-marijuana propaganda sent to them since this topic was introduced was "ridiculous," including documents attempting to link marijuana usage with mass murder: "Do you think we're idiots?" He said he toured a dispensary and found it to be clean, highly secure, and quite impressive.

But, Schaefer said, he understands the community concerns and "it would be best to slow this down." He suggested, "Let's take a year. ... Let's look at this carefully. Let's not rush to a conclusion here and let's really develop a plan. ... I need more time, and I think the community needs more time."

Councilmember Porsche Middleton agreed that they should slow down the process.

"We want to make sure we get it right" with regards to equity, said Middleton, with a focus on ensuring Citrus Heights residents have a place in the industry if this idea moves forward. She also wanted to further explore other non-public-facing aspects of the industry, such as cultivation or manufacturing, instead of just retail storefronts.

"For me, this has always been about local control," Middleton said. "We have always been great stewards of our own tax dollars. If we are allowing other cities to take advantage of our families who are living here, of their hard-earned money, however they choose to spend it, and it's going somewhere else, that is an opportunity that is lost to reinvest those dollars right here in our city."

Citrus Heights Vice-Mayor Jayna Karpinsky-Costa said, "It is about the money." She wants the streets in her district paved, so she wants more details about how much revenue they "could really expect to receive" to weigh that against "how many roads can we do, how many police can we add to our force?"

Mayor Bret Daniels said, "I don't see any concern on the crime aspect of it." He said the dispensaries "are incredibly safe," with armed security on site, which decreases loitering and the potential for crime. While Daniels fully supports medicinal use, he does not support recreational use. So, he said, "the tax means nothing to me. I don't care to gain a dollar off of the recreational use of drugs." He agreed with the City Council consensus that they should "tap the breaks for now," and focus on more research and more

outreach. City Council then considered requests

for funding from the city's Neighborhood Improvement Partnership (NIP) Program, which provides funding for projects and programs that improve the quality of life for residents and increase community engagement. Several groups requested funding to attend the annual Neighborhood USA (NUSA) Conference, which is being held this May in Lubbock, Texas.

Sunrise Ranch Area 6, Sylvan Old Auburn Road (SOAR) Area 10 and the nonprofit Citrus Heights Arts all requested \$1,800 each to cover attendance, travel and lodging costs for the conference. (Councilmember Middleton recused herself from this discussion and vote due to a conflict of interest, since her mother is the executive director of Citrus Heights Arts).

City staff said each application met the eligibility criteria for the funding and recommended approving the full amount for each group, for a total of \$5,400 from NIP funding. If approved, there would still be \$7,100 in NIP funding available for other requests through the end of this fiscal year, in June.

Karpinsky-Costa said the intention of this funding is for projects proposed by neighborhood groups. She suggested that the city institute stricter guidelines for this funding and limit how many groups are approved to use the funds for conference attendance. And she said that Citrus Heights Art should apply for funding from a different source, rather than the NIP funding.

Daniels said he supported all the applications because the funding was available, there were no neighborhood projects up for consideration at this time and the funding is for this fiscal year (which will end soon). Daniels said he had no objection to establishing more criteria to guide approval for such requests in the future, but at this time, no applicable policy is in place. Daniels said the individuals are taking time out their lives to attend this conference to find ways to improve the community: "I don't think it's anything but a benefit to the city at this point."

Daniels moved approval of all three requests but the Citrus Heights Arts request did not receive a second, so that motion failed. The requests from Sunrise Ranch Area 6 and Sylvan Old Auburn Road (SOAR) Area 10 were both seconded and Council voted 4-0 for approval.

City Council considered an amendment to the city ordinance that would increase the compensation for City Council members. Senate Bill 329 was recently approved, which allows for an increase to the maximum pay for local councilmembers in California for the first time since 1984. When Citrus Heights incorporated in 1997, the pay for councilmembers was \$600 per month and the compensation has not been updated since that

The updated compensation schedule is based on the population, so with a population of 86,000, Citrus Heights councilmembers would be eligible to receive a salary up to \$1,900 per month. However, the compensation change would not apply during any councilmember's current term of office. The new salary would go into effect for all members after an election cycle, when a new member is elected or when any current member is re-elected to a new term.

City Council voted 4-1 to approve the compensation increase, with Karpinsky-Costa dissenting.

The next meeting of the Citrus Heights City Council is scheduled for 6 p.m. April 25 at 6360 Fountain Square Drive.

UC Davis Health Successfully Implants Triclip™ System

SACRAMENTO, CA (MPG) - UC Davis Health cardiology team members are among the first in the country to treat patients with tricuspid regurgitation, or a leaky heart valve, by using a groundbreaking

The minimally invasive procedure, a transcatheter edge-to-edge repair (TEER), is made possible with a new medical device called the Abbott TriClipTM system.

UC Davis Medical Center is one of the first sites nationwide to have commercial access to TriClip and is the first hospital in Western United States to utilize the system since it was approved by the U.S. Food and Drug Administration (FDA) last week. UC Davis also hosted clinical trials for the procedure in 2023.

"We are excited to offer our patients this novel treatment that offers meaningful improvement in quality of life without the high procedural risk often associated with tricuspid surgery," said Gagan D. Singh, associate professor of cardiovascular medicine and the surgeon who performed the first procedure at UC Davis Medical Center.

Tricuspid regurgitation is a condition in which the tricuspid valve of the heart fails to close completely. This can allow blood to leak backward into the atrium from the tricuspid valve, causing the patient's heart to pump harder to move blood through the valve.

Tricuspid regurgitation affects an estimated 1.6 million Americans. Symptoms include active pulsing in the neck veins, enlarged liver, fatigue and swelling throughout the body.

Current nonsurgical treatments include diuretics (medicines that help remove excess fluid and salt) and drugs aimed at easing symptoms. Left untreated, tricuspid regurgitation can lead to atrial fibrillation, heart failure, kidney disease and even death.

"Severe tricuspid regurgitation is a debilitating condition that is associated with substantial morbidity," said Jason H. Rogers, professor of cardiovascular medicine. "Patients with tricuspid regurgitation are extremely high risk for any type of surgical intervention, so historically they have just been monitored and treated with diuretics."

Tricuspid Transcatheter **Edge-To-Edge Repair Procedure**

The human heart has four valves, and if any of them leak, there is no universal way to repair them. For example, the mitral valve can be repaired with a catheter-based system. But the same catheter can't be used on the tricuspid valve due to the valve's location, thinness and variability.

The new system is designed specifi-

cally for the tricuspid valve's position, location and shape. With the patient under general anesthesia, the device is delivered to the heart through a catheter, starting in the groin and guided by X-ray and ultrasound. Once in place, the clip brings together portions of the leaflets (flaps of the valve), improving the seal and reducing the leaking.

The device was tested for its safety and clinical efficacy as part of the TRILUMINATE Pivotal trial. UC Davis Health was one of the sites with the highest enrollment rates in the national trial.

"This minimally invasive approach allows the heart to pump blood more efficiently and relieve symptoms of tricuspid regurgitation," said Rogers, who will be performing additional tricuspid TEER procedures.

A Leader In Transcatheter **Edge-To-Edge Repair**

UC Davis Health has been a leader in transcatheter edge-to-edge repair for nearly two decades. In addition to the transcatheter tricuspid valve repair procedure, the medical center's cardiac services offer several minimally invasive catheter-based mitral valve procedures.

"Being one of the first centers in the country to offer commercial availability of the TriClip system is a true honor and a testament to the outstanding teambased approach to patient care at UC Davis Health," added Singh. "The UC Davis Structural Heart Team is among the best and most comprehensive in the nation. Our mission of providing complete, efficient and high-quality care to the patients we care for is what drives us to lead the field."


Your sister is very lucky to have a big brother like you. Walk her through this advice. Be there for her. Look out for her. She needs you right now, and she'll need you in the years to come.

Lost in the Translation



Anytime I tell people that I'm a chaplain, I can never be sure they understand the title, much less spell it. (I'm not a Chaplin, like Charlie.)

Some people think a chaplain is just like a church pastor. Some think chaplains are exclusive to the military. Some assume chaplains are always Christians.

After I encourage them to disavow these assumptions, they still aren't sure what chap-

Chaplains serve in many roles, but during the years I was fully employed as a hospital chaplain, I often told folks that I was a religious translator. When they cocked their heads for better understanding, I offered this story.

In the early 1990s, I was working at Houston Northwest Medical Center when I found the ICU nurse manager, Grace Heffron, madly flipping through a patient's chart.

Grace was five feet three inches of greeneyed Italian. She charged her work with a no-nonsense approach and didn't fancy interruptions. Nevertheless, I asked her to suggest which patients might need to see a chaplain.

Grace shot me a look over the top of her glasses. She didn't see her job as birddogging problem-patients for me.

"How about bed number two," she suggested. Her voice was baited with East Coast sarcasm, but I bit nevertheless.

"Why, what's going on?"

"Oh, nothing really," she said, her volume increasing. "Nothing except for a bill passing two million and their religious family is call-

"That actually makes some sense," I said. Grace slapped the chart down. None of it made sense to her.

"Give me a few minutes and I'll come back to say more."

Having her undivided but somewhat undesired attention, I retreated into the patient's room to find a 75-year-old man, suffering from a massive stroke and nearly brain-dead. Now, sixty days after admission, he was on a ventilator and radiated a nauseous aroma from multiple bedsores.

His daughters greeted me with suspicion, but when I offered a prayer, they instantly raised their open-palmed hands and began shouting a prayer something like this:

"God, we believe you've already healed our father! These doctors are liars. Our father will walk again because Romans 3:4 says, 'Let God be true but every man a liar!'"

It's a bit disconcerting to hear people quote the Bible back to God. It's as if they found a contractual loophole that forces God to act as they say.

Nonetheless, I quickly recognized their prayers were coming from "Word of Faith" theology. So after the final amen, I excused myself to the nurses' station. Grace had obviously overheard the prayer because she was fit with her best told-you-so expression.

"I don't think they are literally calling you liars," I said.

Grace leaned forward, so I offered more.

"They come from a faith tradition better known by the less flattering terms of 'nameit-and-claim-it' or 'Prosperity Gospel.' It's a Pentecostal-like group that believes a miracle only has a chance to work when believers publicly proclaim the desired outcome to be true; despite it being obvious to all others that it isn't true.

"Just think of it as a coarse expression of Norman Vincent Peale's Positive Thinking," I said. "The word 'liar' is a faith expression."


With Grace starting to see the connection, I offered a translation. "I know it's like trying to buy a yacht by telling the salesman, 'I'm a millionaire who's waiting for my lotto check to clear the bank,' but they are sincere in their expression."

"So what do I do?" she asked. Like most supervisors, she appreciated solutions, not problems.

"If you'll listen to the daughters, and not react or take it personally, I think they'll be ready to disconnect life support in a few more days."

When Grace relayed my translation to the nursing staff, they began responding to the daughters with a new understanding. And once they realized that faith finds translation in all different kinds of words and rituals, they were able to obtain consent to remove the patient from life support.

Three days after my translation, the daughters held hands, prayed and watched their father go home to his final miracle.

Social Security Matters

Can I Claim Social Security and Still Work?

Dear Rusty: I will be turning 63 soon. Can I apply for Social Security and continue to work? Would I be limited to how many hours or how much I could make? I know my monthly SS amount would be cut by 30%, or somewhere around there, but how would working affect me? I was trying to read up on this, but the \$1 and \$2 thing confused me. I have an offer to take a work-athome position and need to decide soon, but it is a cut in income. The cut would be okay if I could draw my Social Security too. Signed: Wanting Work at Home

Dear Wanting: If you claim your Social Security to start in the month you turn 63, you'll be claiming 4 years before your full retirement age (FRA) of 67, which means your monthly benefit at 63 will be about 25% less than it would be if you claimed SS at age 67. And if you are working before your FRA, you'll be subject to Social Security's "earnings test."

The 2024 earnings limit for those collecting early Social Security benefits is

\$22,320 (this limit changes annually). If your annual earnings exceed the limit, Social Security will assess a penalty of \$1 for every \$2 you are over the limit. They will recover that penalty amount by withholding future benefits until they recover what you owe. If your work earnings are under the annual limit, you will get all your monthly SS benefits. But if you exceed the limit, they will find that out after you submit your income tax return (the following year) and issue you an overpayment notice, telling you how much you owe for exceeding the limit last year. They will then withhold your benefits until they get back what you owe, or you can repay them in a lump sum. To avoid the overpayment notice, it is best to inform Social Security in advance that you will exceed the annual earnings limit, and they will simply withhold your monthly SS benefits during the year for enough months to avoid overpay-

So, what you should do depends largely on how much your earnings from your new work-at-home position will be. If your earnings are below the annual limit, no penalty will be assessed. If you only exceed the annual limit by a little bit, then you can still work and earn and simply repay them what is owed for exceeding the limit (or have your SS benefit temporarily withheld). If you only exceed the earn-

ings limit by a little, you'll

ing you.

still get benefits for most months of the year. But if you significantly exceed the annual earnings limit, you could even be ineligible to receive SS benefits until you either earn less or reach your full retirement age (the earnings limit goes away at your FRA).

So, what you should do depends on what "a cut in income" means in terms of your expected annual earnings amount. If your total annual earnings will be under the annual limit, your SS benefit won't be affected. If you only exceed the limit by a little bit, then you will get SS benefits for most months of the year. But if your annual earnings are significantly over each year's annual earnings limit, then you won't get SS benefits for most months of the year and may even be temporarily ineligible to receive

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CITRUS HEIGHTS CALIFORNIA, AMENDING CITRUS HEIGHTS MUNICIPAL CODE SECTION 2-32 REGARDING CITY COUNCIL COMPENSATION

The foregoing is a summary of an ordinance proposed to be adopted by the City Council of the City of Citrus Heights at its meeting of April 25, 2024.

The purpose of this ordinance is to amend the Citrus Heights Municipal Code Section 2-32

regarding City Council compensation. On January 9, 1997, the Citrus Heights City Council enacted Section 2-32 of the Citrus Heights Municipal Code which set the City Council's compensation at \$600.00 per month pursuant to the

provisions of Government Code Section 36516. The compensation for Citrus Heights City Council has not been adjusted since 1997. On June 29, 2023, Governor Newsom signed Senate Bill 329 (SB 329) into law amending Government Code Section 36516, which allows the first increase to the city councilmembers pay

maximums since 1984. Effective January 1, 2024, the maximum allowable compensation rate for a city with a population of 75,00 up to and including 150,000, the bracket Citrus Heights falls in, is \$1,900 per month. The proposed amendment would increase the City Council compensation to the maximum allowable compensation, effective when a new council member is sworn into office or when a member of the City Council beings a new term.

Business Groups and Lawmakers Battle Over Ballot Measure to Limit Tax Increases

Californians will be coughing up many billions of dollars this month as they file their federal and state income tax returns and pay the second installment on their property taxes.

How much?

Annually, individual Californians and Californiabased businesses pay roughly a half-trillion dollars in federal taxes – personal income taxes, Social Security and Medicare payroll taxes, primarily. They also pay at least another half-trillion dollars to state and local governments - personal income taxes, sales taxes and property taxes, primarily.

By any measure, California is a high-tax state.

The Tax Foundation, a Washington-based organization that tracks nationwide tax trends, recently reported that California's state government levies the nation's highest taxes per capita at \$7,200, which translates into about \$280 billion a year. As a portion of California's \$4 trillion economy, its \$540 billion in state and local taxes rank fifth highest at 13.5%.

These numbers – and the state's multibillion-dollar budget deficit – set the stage for a monumental, multifront war over taxation this year, including three statewide ballot measures that could dramatically alter the politics of taxation.

The Democratic Party's progressive wing, strongly backed by public employee unions, contends that new taxes are needed to maintain vital welfare, education and health care services. However, Gov. Gavin Newsom has publicly rejected tax hikes and proposes a budget that closes the deficit, at least on paper, with spending deferrals, bookkeeping maneuvers, loans and an injection of money from the state's rainy day reserves.

Two years ago, California's two most authoritative polling organizations, UC Berkeley's Institute of Governmental Studies and the Public Policy Institute of California, asked residents about their tax burdens and both found increasing discontent, in part because they were feeling the pinch of other costs of living.

The polling punctuated voters' rejection of a tax increase measure on the 2020 ballot that would have changed Proposition 13, the iconic property tax limit approved by voters in 1978, by increasing taxes on commercial property.

Hoping to leverage popular resistance to tax increases, business and anti-tax groups led by the California Business Roundtable have qualified a measure for the November ballot that would make raising state and local taxes much more difficult.

If passed, the measure would require two-thirds votes for any local tax increases, effectively overturning a state Supreme Court ruling that local taxes proposed via initiative require only simple majority votes. It also would subject any state tax increases to voter approval as well as two-thirds votes by the Legislature.

The measure's qualification has touched off a legal and political war with Newsom, the Legislature and pro-tax interests, such as unions. Newsom and the Legislature have filed suit, hoping to persuade the state Supreme Court that the measure is a constitutional revision, rather than an amendment, and thereby cannot be enacted by initiative.

The contending interests have filed written arguments with the court, which has not formally decided whether to accept the case. If it does, it will have only a few months to declare whether or not the measure goes on the ballot.

The Legislature has also placed its own measure on the ballot that, if passed, would require the business tax limit measure itself to get twothirds voter approval. And it passed another ballot measure to reduce vote margin for local tax and bond measures that increase spending on housing and infrastructure to 55% from the current two-thirds, potentially nullifying the Business Roundtable measure.

It's a showdown that's been building for nearly five decades, ever since Prop. 13 won approval. With countless billions of dollars at stake, hundreds of millions of dollars are likely to be spent for and against the three interrelated measures.



Five Ways Counties Can Prepare **Now That Prop 1 Has Passed**

After two weeks of counting votes, California voters passed Proposition 1 by a hair. The proposition, a two-part initiative aimed at improving equitable access to behavioral health services, provides new funding for treatment facilities and housing support while updating the 20-year-old Mental Health Services Act (MHSA). Millions of Californians who cope with behavioral health conditions — mental illness or substance use disorders (SUD) — rely on services and supports primarily provided by California's 58 counties through MHSA, and increasingly their needs include housing.

Prop. 1 directs the State to borrow \$6.4 billion through bonds to fund new housing and treatment facilities. The State will also reallocate MHSA funds at the state and county levels, with a slightly greater proportion of MHSA revenue shifting to the State. Where 95% of MHSA funds were previously distributed to county behavioral health systems, now they will receive 90% with an additional 5% funding expansion of statewide efforts, including training, evaluation, innovation, and administration. There will also be new restrictions on how funds can be used, thus funding is likely to decrease for some behavioral

Improving equitable access to needed services regardless of race, age, gender identity, sexual orientation, or county of residence is a critical step in building a more comprehensive behavioral health system in California. And the challenge to ensure access falls primarily on county leaders. Expectations are high, tensions are high, and the divided voter support may lead to challenging conversations around the changes that will inevitably raise questions for county leaders and families with individuals facing behavioral health challenges. Still, with Prop 1's ratification, we believe that the answers to five key questions are essential to begin paving the way for the measure's implementation.

How will funds be allocated at the county level? First and foremost is the process of allocating funds locally. County officials will be required to spend pre-allocated amounts on housing interventions, services, and treatment for adults with severe mental illness, and for behavioral health services. County leaders will need to drive discussions internally and among stakeholders to determine how to implement this spending while expanding community partnerships to extend service provision.

How will programmatic changes resulting from revisions to the MHSA be addressed? Second, each county must adjust programming from previous MHSA requirements to correspond to the new Behavioral Health Services Act (BHSA). The BHSA expands programming to address the needs of people living with SUDs. County mental health plans will need to determine the degree to which they will expand SUD service provision and further integrate mental health and SUD treatment. It is possible that in some locales, reallocating funds will necessitate changes to or elimination of some county

How will counties balance the provision of behavioral health services and affordable housing? The BHSA also

prioritizes supportive housing for veterans and individuals with behavioral health challenges who are at risk of experiencing homelessness. Decision-makers will need to weigh the impact on existing services while expanding housing options for vulnerable populations based on the new funding requirements.

How will county leaders advise and advocate for effective implementation of Proposition 1? When MHSA was adopted 20 years ago, it not only changed the flow of funding but also the flow of data. County leaders were instrumental in advising the State regarding these issues. With BHSA, leaders will need to convene stakeholders, including mental health advocates, providers, and community members, to shape policies and programs. They must take the results of these conversations to their colleagues at the County Behavioral Health Directors Association of California (CBHDA) to triangulate opportunities and challenges, and to collaborate with state agencies to ensure the most seamless implementation possible. County leaders and communities will need to balance the new mandates with the unique, local challenges they hope to address.

How will county leaders monitor and measure the outcomes of the new BHSA? Counties will need to monitor whether new housing interventions are effective. They will likely need to examine how SUD services align with existing mental health services and any gaps created in their communities. And they will want to look at how the changes in programming affect access. Within a year or so of implementation, counties may want to conduct needs assessments to determine how the changes have affected the clients each county serves as well as needs and gaps in resources to guide adjustments and improvements among providers.

Proposition 1 adds significant funds to support behavioral health and housing. It also calls on county-level decision makers to rise to this moment. The months ahead will require thoughtful planning, collaboration, and strategic choices to enhance behavioral health services and housing support for Californians. With thoughtful implementation, Proposition 1's new mandates should serve the changing behavioral health needs of Californians.

The Dangers of Distracted Driving: **Three Things Parents Can Do**

SACRAMENTO, CA (MPG) - Distracted driving is one of the leading causes of teen death and injury in the United States. The National Highway Traffic Safety Administration reported that 3,308 people were killed in distraction-affected crashes on U.S. roadways, including 193 teens, in

"Here at UC Davis Medical Center, we treat over 300 young drivers every year who were injured in preventable crashes," said UC Davis Injury Prevention Specialist Jennifer Rubin. "The injuries we treat are often severe with life-long consequences like brain injury, paralysis, chronic pain, even death. Again, the sad part is that these injuries could have been prevented."

To mark Distracted Driving Awareness Month, we asked Rubin how parents and families can keep their teenage drivers safe behind the wheel.

What Types of Distractions are **Causing Car Crashes?**

Everyday activities that we don't think are dangerous can be deadly distractions on the road. Music, eating, drinking, texting, and talking to our passengers are some of the most common causes of distraction. As the number of distractions present in a vehicle goes up, so does the likelihood of being involved in a prevent-

Why Is Getting Distracted When You **Drive So Dangerous?**

Any time you take your eyes off the road or your hands off the wheel, even for a second, you give up control of your car. On average, texting while driving takes your eyes off the road for five seconds. At 55 mph, that's like traveling the length of a football field blindfolded.

People take it for granted that cars are safe or that they're good drivers. But we see first-hand what happens when they lose control in that split second and how much damage a vehicle can cause.

Is Driving Distracted More of a Problem for Teens Than Older Drivers?

Distracted driving is dangerous

regardless of your age. For teen drivers, the lack of driving experience makes any type of distraction even more dangerous. New drivers are less prepared to make split-second driving decisions that may prevent a collision. When their attention is pulled away from driving, they have even less time to react.

Are all the car crash injuries you treat in teens due to distracted driving?

Distractions and inexperience are the most common causes of teen crashes. But we also see the consequences of reckless driving choices, like speeding, driving while intoxicated and not wearing a seat

Teens can sometimes be a tough audience to reach. What can parents do to improve the safety of their children as they start driving?

There are three things that parents can

Set a good example. We know children follow their parents' actions more than their words. This goes for teens, too. It's going to be hard for any parent to convince their child not to use a phone while driving if they're doing it themselves.

Talk to your teens about distractions so they understand it's more than just texting. Enforce the restrictions of the California provisional license laws. Provisional licenses are special restrictions for new drivers. We've seen a dramatic reduction in teen driving fatalities in states like California that require provisional licenses for new drivers, but parents need to help enforce the rules. The provisional licenses set restrictions on driving teen passengers and driving after 11 p.m. without adult supervision. This is really important because we know that having multiple teen passengers in the car can quadruple the risk of a crash.

What is UC Davis Health doing to address the problem of teen distracted driving?

Fentanyl Dealer Receives 15 Years to Life in Prison

ROSEVILLE, CA (MPG) -On April 4, 2024, the Honorable Judge Jones sentenced Arron Dare age 26, to 15 years to life in the California Department of Corrections and Rehabilitation following his murder conviction for the death of a local young woman, Haleigh

Yarbrough. "We will continue to hold those who sell this deadly poison in our community accountable," said Placer County District Attorney Morgan Gire. "Our team is dedicated to disrupting and dismantling this market- from both supply and demand. Our hearts are with the victims and families of those lost in this terrible crisis and we will continue our aggressive pursuit until the dealers of this poison claim no more lives."

On Dec. 6, 2023, Dare pled guilty to murder for causing the fentanyl death of a local young woman.

The arrest was made after an investigation by the Placer Special Investigations Unit (PSIU), a collaborative effort by the California Department of Justice, Placer County Sheriff's Office, Roseville Police Department, Rocklin Police Department, Auburn Police Department and the Placer County Probation Department.

Court last Thursday morn-

ing for the sentencing.

The defendant appeared in Placer County Superior

Haleigh's dad and stepmom made victim impact statements with the support of their victim advocate from the Placer County District Attorney's Office Victim Services Unit. Family and community members also attended today's court hearing in support of the victim's family.

Haleigh's dad said in his victim impact statement "With fentanyl

being 50-100 times stron-

ger than heroin, the

defendant still chose to line his pockets with money. Instead of making an honest living, he chose a life of exploiting others."

Haleigh's stepmom stated in her victim impact statement, "No more Mother's Days, no more Father's Days with Haleigh. Her sister is now left to make wedding plans without her sister. No more Christmas mornings, no more Easter this is the devastation of this crisis."

Dedicated to Preventing Falls

FOLSOM, CA (MPG) - A \$15,000 community grant awarded by SAFE Credit Union is aiding many residents in the Sacramento region to live safer and fuller lives.

The credit union recently awarded the funds to Rebuilding Together Sacramento's Safe at Home program dedicated to preventing seniors and those with disabilities from experiencing falls at home. The program's volunteers and staff build and install free safety improvements to the homes of qualifying area residents including ramps, railings and grab bars.

"We have an aging population in the Sacramento area that are finding it harder and harder to do the things they love. Much of that is because they can't get in and out of their homes safely," says Rebuilding Together Sacramento Executive Director Bonnie Patterson. "Donors like SAFE Credit Union allow us to help more and more people. We are very, very thankful to have received this grant."

In 2023, Safe at Home volunteers and staff helped 623 area individuals in 400 homes in El Dorado. Sacramento, San Joaquin counties and in West Sacramento.

According to the Centers for Disease Control, one in four older adults over 65 experienced a fall in 2020 equating to an average of 3 million subsequent visits to emergency rooms each year. The CDC also reports

that at least one out of five falls can cause serious injuries resulting in adverse quality of life situations for patients, including difficulty getting around, doing everyday activities, and living independently.

"SAFE Credit Union has a long history of helping improve the health of residents through philanthropy in the communities we serve," says SAFE Credit Union Vice President of Community Relations and Financial Education Rebecca Delmundo. "This grant exemplifies that, and we are so glad to have been able to support such a timetested nonprofit."

Founded in 1991, Rebuilding Together Sacramento works to fill the need and enhance affordable housing for older adults and those with disabilities.

"If you go in and install a handrail or a grab bar, a lot of times the folks are just so grateful and so thankful and are just delightful people," says Safe at Home volunteer Dan Ward of Carmichael. "It's good just helping folks out."

Volunteer Stan Jones of

the Greenhaven-Pocket area says he has put in hundreds of grab bars in the 12 years he's worked as a volunteer. "The clients are very grateful for the help that they receive, and our work prevents falls," Jones says.

Rebuilding Together Sacramento's grant was one of two grants selected by a public vote to receive \$15,000. Foster Youth Education Fund also received a \$15,000 grant for its program supporting former foster youth in the Sacramento region with financial scholarships, as well as laptops for students enrolling or attending a college, university or trade school.
