# Queens and Ambassadors Shine

GRIDLEY, CA (MPG) - Gridley has been privileged to watch as the Miss Butte County Scholarship Program has grown and evolved over decades of being part of Butte County and the Butte County Fair.

This year, the program has progressed and become more inclusive of not only the young women in our communities, but young men with the addition of their Ambassador program.

The new category of Butte County Ambassador invites young men ages 13 to 20 years of age to compete for the role of Ambassador. According to Raina Wright-Reynolds, Miss Butte County Scholarship Program Director, this program directly mirrors that of the Miss Butte County

program, competing in the resume and interview portion before the fair, and then speech, impromptu and presentation of skills on-stage during the fair. Winners will take home a trophy and ambassador sash, officially representing Butte County and the Butte County Fair and area events.

New this year to the competition is the addition of the "Butte County Fair Test" and a service platform for Miss Butte County and the Ambassadors contestants. Contestants' basic knowledge of the fair will be tested in a written exam. Community service is already a part of the scholarship program, but the service platform takes that to the next level, either asking the older contestants to support an established non-profit or community organization as the focus of their platform or start their own service

project that they work on throughout their reign.

Wright-Reynolds tells the Herald, "The Fair Board, the Miss Butte County Advisory Committee and myself wanted to find a way to be able to provide these opportunities to more youth...the best option we could think of was finding a way to incorporate young men into our program."

She explains that with the Miss Butte County Scholarship Program, both Royal Courts and Ambassadors have the unique opportunity to be of service throughout the county, not just locally, and have access to industry professionals that can hone interview, resume and public speaking skills.

## Live Oak to Get Fire Training Site

### LIVE OAK, CA (MPG8.COM)

- Advance planning on fire projects and inventory took precedence at the April 17 Live Oak City Council.

**Battalion Chief Richard** Epperson presented a slide show on what could be Live Oak's training center for future generations. Decision was also taken to order a new pumper engine on a five-year wait list.

The training site will cost about \$350,000. Work will take approximately 20 weeks, Epperson said, adding Live Oak "could get thousands of fires out of it." Fire control certified instructors could be trained there. Discussion included when to get an electric

Fire training project funding to begin immediately was unanimously approved.

Interim Live Oak City Manager Mark Scott discussed Live Oak investment in a new pumper engine for the fire department at the March 20 meeting. At that meeting, it was stated "Council was told costs for new engines were going up quarterly, the current price being \$898,000 with a 48to 52-month wait time." Brad Hanson, a sales representative of Golden State Fire Apparatus, made an informational presentation explaining there is a 6.000-engine backup and only 1.500 engines can be built in a year. New emission standards will go into effect in January 2028, and with that, an additional \$110,000 will be added to the cost. The city was informed that the price would be \$850,000 if it prepays now and \$998,000 if it buys later.

Scott suggested the city buy it on the first option of the financing package presented, with a first payment in two years, and on a 10-year payment plan. The equipment will cost nearly \$1 million before the prepayment discount. Alternatively, he said, "the city could have looked into doing it with its own financing but we are not recommending that. This looks like good financing."

Scott said that it is a high-quality Pierce engine, which "allows us to save quite a few more dollars on this project."

The council was enthusiastic about going forward with the project and unanimously approved the recommendation.

There were no public comments.

Scott requested that the next agenda have a Continued on page 2

Butte County District Attorney Mike Ramsey has this statement on the Butte County website: "I have dedicated my career and the resources of my office to ensure that justice is done, no matter who the offender or victim may be. Everyone deserves to be protected from the criminal element. Everyone deserves to have their constitutional rights protected. I believe in holding people accountable for their actions." Ramsey has been elected ten times. People have run against him, and on more than one occasion, he has beaten back a recall. He is widely respected and accomplished in his chosen vocation. I asked Mike if he saw his latest press release about criminal felony sex offenders on page seven of the Gridley Herald? I explained that sometimes newspaper deadlines - and when news happens (or is released) don't line up and that means important sto-

ries get placed where they

fit. He thought his press release should be closer to the front like page 1 or 2. I agreed. So here it is again: FORMER GRIDLEY TEACHER PLEADS TO SEX WITH A MINOR. A former female Gridley school teacher pleaded no-contest this morning to having sex with a 14 yearold male student in June 2021. Michelle Christine Solis, 46, of Gridley, appeared in Butte County Superior Court this morning for her scheduled preliminary hearing on the sex charge, but instead changed her plea and admitted her guilt. Butte County District Attorney Mike Ramsey said the charges stem from conduct during the boy's 8th grade year at Sycamore Junior High School. Solis was the boy's teacher. She "friended" him on Instagram and began messaging him in the weeks leading up to his graduation. Evidence showed that Solis sent the boy four explicit photos of herself before having sexual intercourse with him in a locked classroom on the day of the student's 8th grade graduation. Rumors and copies of the photos began to circulate in the Gridley community in October 2023. A Gridley Police investigation ensued and investigators contacted the boy and reviewed the contents of his phone. There

they found communication between Solis and the boy, including two explicit photographs of Solis that matched the descriptions the boy previously provided. Gridley Police arrested her November 13, 2023 and she immediately bailed from the Butte County Jail on a \$15,000 bond. Ramsey said as part of her plea today, Solis stipulated that she would be registered as a sex offender and could face up to four years in state prison. Solis remains out on bail pending her sentencing on June 6, 2024, at 1:30 p.m." Mike's website also says "If you are a victim of a crime, contact the D.A. Victim Assistance Bureau at 530-538-7340." There will be a process as part of the sentencing hearing in which the victim (or in this case the parent of a child victim) can make a statement in court about the impact the convicted criminal has had on the life of the victim, which the judge is required to consider when issuing a sentence. That victim statement would be something worth printing on page one, next to the Gridley School Board's response.

Ambassador Program, the non-competitive "future" program has also been expanded to include young men ages 4-7 as Future Ambassadors. For Future Missette and Future Ambassadors, only the first 20 applications will be considered, and others will be put on the wait list. Wright-Reynolds urges those interested in participating in the "Future" programs to act quickly as those programs tend to fill quickly and the deadline is June 28th. The deadline for Missette, Teen, Miss and Ambassador applications is June 14.

closed session on permanent city manager recruitment.

In other business, Scott asked if the council was ready for a food trucks and sidewalk vendors discussion.

"We need to see how law has changed and bring council up-to-speed at state level," Scott said. "You can't forbid or prohibit them anymore but you can do 'time, place and manner' (for allowing them). You do have a right to prohibit. I can put it on the agenda to have that discussion."

Scott also briefly addressed water rates. "On a future agenda, I will talk to you about the water study. The one real weakness in the budget is the water enterprise and whether or not the council decides to change rates," Scott said. "I will raise in a future agenda how we would go about doing that. We have to have policy on how council is dealing with that."

In City Councilmember reports, Lakhvir Ghag commented on traffic islands at the entrance to the city that are "super dangerous" and "extremely dangerous, if you are not watching. People hit the curb but they don't report this."

"Pennington Road is not safe at all; drivers proceed so fast," Ghag added.

Ghag reported that the Sutter Yuba Mosquito and Vector Control organization started the dead bird program.

"If you find a dead bird, turn it in and they will dissect it. If it died from a mosquito, they can determine what it was and whether it was diseased," Ghag said.

Vice-Mayor Nancy Santana noted the passing of her mentor, Paula Ford, a 12-year alumni of the Live Oak Council.

Ghag said that Jerry Dollins from a local well-known large family also passed.

Mayor Ashley Hernandez reported she attended a Pioneer Energy meeting, saving it can offer residents cheaper electricity rates than PG&E.

City Council held a moment of silence at the end of the meeting for Dollins

## Fire/EMS Dispatcher Assists with Home Birth

BUTTE COUNTY, CA (MPG) - On April 18, at approximately 7:30 a.m., a 9-1-1 call came into the Oroville Emergency Command Center for a mother in labor in the area of Clark Road and 2 Creeks Road in the Butte Valley area.

Fire Captain Ryan May, a new dispatch team member, answered the 9-1-1 line and encountered a frantic father in need of help with an imminent childbirth. The mother and father underestimated the contractions and the baby's arrival was not going to wait for them to drive to the

May immediately jumped into action by calming the father down and ensuring that he was going to help, and that Fire and EMS personnel were enroute. May utilized the Pro QA software on the CAD computers, which is a program that dispatchers use for pre-arrival instructions for calls dealing with cardiac arrest, burns, difficulty breathing, and in this case, imminent childbirth.

May remained calm and talked the

father through the whole birthing process, utilizing his training and the pre-arrival software. The baby was successfully birthed before Fire and EMS responders arrived. May instructed the father with after-birth instructions to ensure the baby's airway was clear and the baby was wrapped in a clean blanket. Fire and EMS resources arrived at the same time and ambulance personnel cut the umbilical cord and transported the mother and baby to an area hospital.

It is not every day that first responders encounter imminent childbirth. May's reassuring demeanor and professionalism over the phone calmed the father down and together, they delivered a healthy

The Emergency Command Center is staffed daily 24 hours by fire captains and communication operators (dispatchers), providing the highest level of professionalism and service to citizens in their time

## **GUSD Wants YOU for Parent Council**

GRIDLEY, CA (MPG) - Every spring, a series of three to four parent meetings is held for the purpose of reviewing and/or revising the school district's Local Control Accountability Plan (LCAP), the big picture plan for where funding is going and what the district's priorities are.

If that sounds a little dull and hard to digest, well, it can be. But it doesn't have to be, and Gridley Unified is eager for more parents to be involved and vocal in the workings of local schools.

This year's meetings have pulled in very few parents. At the April 17 meeting there were only two, to represent a student body of 1,990. This meeting obviously doesn't capture the full range of parent involvement, and many parents do participate in school programming and events, and either board, PTA, or site meetings within each school.

Why go to another meeting? You may ask. With one meeting left, planned for May 15, 2024, the opportunity for meaningful impact on this year's LCAP is limited, however, Michael Pilakowski is hoping to help a broader vision take hold in the Gridley and surrounding

Pilakowski is the director of curriculum and technology for Gridley Unified School District. He organizes and oversees Parent Council meetings, and he represents GUSD in pursuing more meaningful parent engagement.

School board meetings, which happen twice monthly, are busy and informative meetings, providing a snapshot of what is happening within the district at a given time, however the opportunity for discussion and community input or questions is minimal. While parents and/or community members are welcomed to make comments and ask questions, formal response is generally not made at the time of the question, but saved for another meeting if it is brought up again at all.

Site councils convene at least monthly to review and revise plans for each school site. Ideally, these meetings can be used to raise questions or address concerns, but the focus is on review of academic progress and completion of established site

Parent Council provides a platform for back-and-forth discussion with site and district officials. In addition to Mr. Pilakowski, Ms. Treat and Dr. Schumann, principals of McKinley and Wilson schools, respectively, were in attendance at the April 17 meeting. If you haven't met your child's principal, or you want to get to know district officials, or you have questions about how to get the school's attendance calendar adjusted, these meetings have the potential to be valuable to

Pilakowski's vision for what Parent Council can be involves a monthly, well-attended meeting where parents discuss what they are seeing, what is working, and what needs adjustment within school and community realities. The LCAP is only one piece of the picture; concerns about bussing, afterschool program supervision, specific teachers or curriculum, special education services, facilities, sports, or anything else could be addressed and action plans generated in this setting.

With Pilakowski as a district liaison and school principals available for engaged discussion, we have the potential to shape programs and shrink the gaps that exist between parents, teachers, and students. Current data in Gridley schools suggests that student engagement and sense of belonging is going down every year will you come and be involved in finding solutions?





## Order Up, Dutch Bros

**GRIDLEY, CA (MPG)** - Rumors have been circulating now for some time regarding an incoming Dutch Bros Coffee making its home in Gridley, and residents can officially get excited.

At its most recent meeting held April 17, Gridley's Planning Commission reviewed the proposed Site Development Plan for a 970 sq. ft. Dutch Bros Coffee to be located on the eastern side of State Route 99, sandwiched between the south side of Dollar General's parking lot and the entrance to Sunrise Village senior apartment complex.

At this time, the new business will sit on 1.06 acres, and while construction has not broken ground, representatives from Dutch Bros told the planning commission that building permits had been submitted to the county and they were anxiously

awaiting the approval to start construction.

Concerns were raised by planning commission members regarding lighting and entry/exit to the new business.

Caltrans has required entry to the site to be through existing roadways, which in this case, means the entrance to Sunrise Village apartments will double as the access route for the new coffee establishment.

Representatives from GSE Engineering shared that studies had been done to identify the peak number of vehicles visiting a Dutch Bros on "sticker day," which according to the discussion at the planning commission meeting, is allegedly one of Dutch Bros' busiest days. The study identified the average max number of vehicles in the drivethrough these days is 22. Gridley's Dutch Bros' design has allotted for

and will accommodate up to 25 vehicles in line.

Gridley Dutch Bros' preliminary design allows for 17 parking spaces, a direct access route to-and-from Sunrise Village apartments, two bike racks, and to help control traffic, a stop bar and stop sign will be located at the exit of the Sunrise Village road.

Landscaping has also been planned, but due to a future Caltrans SHOP project, which plans to install curb/gutter and detached sidewalk on the eastern side of State Route 99 from W. Liberty Road to about Ford Ave. north of Gridley, front landscaping will be completed at the time that project is finished.

Planning commission members voted unanimously, determining the project was categorically exempt per CEQA Section 15332, Class 32 for infill development projects and approving the site development plan.





OROVILLE, CA (MPG) - Heavy rains caused slope failure along a portion of the Brad Freeman Trail near the Hyatt Powerplant, making a quarter mile long trail section unsafe for public recreation. **BUTTE COUNTY, CA (MPG) -**Construction of the Ord Ferry Bridge Replacement Project was scheduled to begin May 1. Crews are currently on-site completing final utility relocations and installing construction area signs.

This project was awarded by the Butte County Board of Supervisors on September 26, 2023, to Steelhead Constructors JV of Palo Cedro CA with a low bid amount of \$15,158,892. It will replace a relatively narrow existing bridge just west of the town of Dayton with a new 640-foot-long by 43-foot-wide bridge along the section of Ord Ferry Road that crosses Little Chico Creek. Traffic shall be maintained by staging construction of the new bridge thus requiring a single traffic lane through

the project site which will be facilitated by using signalized traffic controls for two construction seasons.

Motorists are encouraged to exercise caution when traveling through the area and use alternate routes if possible, as minor delays are to be expected. The project is funded by the Federal Highway Bridge Program (HBP) and local SB1 gas tax funding. The work is scheduled to be completed in the Fall of 2025.

## **CDFW Warns Dog Owners to Be** Mindful of Salmon Poisoning Disease

Salmon Poisoning Disease is a potentially fatal condition seen only in dogs after they eat certain types of raw or cold smoked fish like trout and salmon that are infected with a bacteria-like organism, Neorickettsia helminthoeca, which is transmitted by the parasitic flatworm (or "fluke") Nanophyetes salmincola.

Nanophyetes salmincola occurs naturally in waters of northern California and most of the north state can be considered the native range for the fluke. But dogs throughout the state are susceptible. Dog owners are advised to be cautious and to keep their dogs away from salmon, steelhead, trout and other freshwater fish carcasses. The parasite cannot survive in cooked fish, is not harmful to humans and does not affect pets other than dogs.

If your dog has eaten or is suspected of eating raw fish, watch for signs of the disease. Symptoms are similar to distemper and may include some or all of the following: a rise in body temperature, loss of appetite, vomiting, diarrhea, listlessness and/or rapid weight loss. If signs of the disease appear, promptly take your dog to a veterinarian. Salmon Poisoning Disease is treatable if caught in time. If untreated, death usually occurs within two weeks of eating the infected fish. Without treatment, 90 percent of dogs showing symptoms die.

While all fish caught or originating from streams in California could potentially be infected, the California Department of Fish and Wildlife (CDFW) cautions that trout stocked in some waters in CDFW's North Central Region are more likely to be infected with the flukes that cause Salmon Poisoning Disease.



Dear Dave, I own a small business with about 20 team members, and we're doing pretty well. Last year, we had revenues of about \$1.2 million and profits of \$250,000. How do I find leadership within my company that cares about the vision and value of my company enough to help me grow it to the next level? I have two people in mind here who have impressed me a lot in the last two years, and I'd like for one of them to take a step up in the company. I'd like for this person to also challenge me and help me grow as a leader.

I want leaders on my team who aren't afraid to bring things to my attention. If there are things they feel I need to work on, or look at differently, I want them to let me know. I'm not perfect, that's for sure. And I've

made plenty of mistakes during my 30-plus years in business. But when it comes right down to it, it's not their iob to challenge me and help me grow. As a leader, that's on me. It's my responsibility to make sure I'm constantly challenging myself and growing as a leader and businessman.

Now, developing your team members and getting them to actually care and align with your mission? That is part of your job. You don't want leaders within your organization who aren't aligned with what you're trying to accomplish. When that happens, you've got a leader working a J-O-B. And at that point, they're no longer a leader. They're just a boss. Leaders lead. They show the way, they encourage and they lead by example. A boss just tells people what to do.

Over the years, I've had more luck promoting from within than I have bringing in someone new and plugging them in. Maybe there's someone there who's smart, already showing potential and demonstrating they care about the place and your mission. That's someone you can tap on the shoulder and start to move in a leadership direction. That kind of person is already fired up and wired up, so take

the bridle off them and give them a chance to run.

Here's an easy step: Find a really good small-business and leadership book, buy three copies and start a series of study sessions with you and the two team members you mentioned earlier. Let them know you feel they have real leadership potential, then read through the chapters together and discuss one or two over a lunch each week. Open up the discussions, and just let them talk. After a few weeks of this, it'll start to become clear really fast if either one is suited for a bigger role in the company. It'll become the ultimate interview process.

Great question, Troy. Best of luck to you and your company as you take this next big step!



### Tulare Lake Subbasin tets Probation Over Inadequate Plans to Protect Aquifers

Farmers in the critically overdrafted Tulare Lake Subbasin in the San Joaquin Valley are bracing for escalating costs as state and local agencies assess fees on wells and groundwater pumped. The California State Water Resources Control Board last week placed the subbasin on probation as part of regulations under the state's landmark 2014 Sustainable Groundwater Management Act. The board concluded that local agency sustainability plans failed to address overdraft by limiting groundwater pumping, land subsidence and impacts to drinking water.

### Rainstorms Help Farms, **Hurt Farmers Markets**

Heavy rainstorms this spring have boosted the state's water supply for farming, but they have dampened farmers market attendance and crop selection in the immediate term. While grocery stores are already stocking imported summer fruits and vegetables, farmers market produce remains in transition, with many farms still selling cool-season offerings such as broccoli, cauliflower, hard squash, beets and navel oranges. More fragile crops such as strawberries have taken a beating from the wet weather.

### Almond Board CEO Stresses Innovations, Exports to Help Sector Rebound

Facing challenging times, California's almond industry is looking to expand foreign export markets and increase the diversity of almond products in domestic supermarkets. That was the strategic roadmap outlined by Almond Board of California President and CEO Clarice Turner. In a recent media briefing, Turner said the state's almond sector hopes to grow its array of products, developing demand for innovations from oils to flours to perhaps even almond pastas. The Almond Board is also seeking to grow exports to India and other fast emerging markets.

### Study: California Pork Prices Rise **Under Proposition 12**

Pork products subject to California's Proposition 12 animal welfare law have increased in price by an average of 20% since the law began to take effect, according to a new economic analysis. The findings in the University of California's Agricultural and Resource Economics Update noted that pork prices in the state have risen more sharply than the rest of the nation under initiative requirements. Bacon, ribs and loin products had higher per-pound prices of \$1.04, 54 cents and \$1.42, respectively, than similar products in other states.

Both teams were successful with putting the bat on the ball throughout the game. Davis Jr. was walked and able to give the Bulldogs their first base runner of the inning.

Following the Davis Jr. walk, Stogsdill was hit by a pitch and senior infielder Adrian Santillan hit a single to load the bases with

Gridley senior outfielder Cesario Villalobos struck a 1-2 pitch to right field and the ball dropped into the outfield. Davis Jr. scored easily from third and Stogsdill raced home to end the game.

On top of the league title, it was senior day and the first victory for the Bulldogs over Las Plumas since the 2021 season.

Villalobos expressed to the Herald that it was a breath of fresh air and a great feeling to see the hard work the senior class has done to pay off and be a BVL champion.

Gridley had their final game of the season this past Wednesday at Wheatland, and the seedings for the CIF Northern Section playoffs are scheduled to be today, May 3, according to the NS website.

The Bulldogs were in the top spot of the NSCIF Division III playoff points as of Sunday, April 29. ★
