# Western Festival Canceled

#### ELK GROVE, CA (MPG)

After the Western Festival's recent cancellation, community members voiced anger and disappointment at the May 1 meeting of the Cosumnes

Community Services District (CSD) board of directors.

The festival was scheduled to return for the first time since 2019 on May 4 and 5. However, the Community Services District revoked authorization less than two weeks before the event, citing the organizers' failure to get the proper permits and licenses in time.

Lynden King, the festival board's vice-president, spoke first during public comment.

"The Western Festival board was late getting some of the paperwork finished. We know that but we were working on it with the fire department to get all the final paperwork finished and it hurts the whole community to cancel the event this year," King said, citing various attractions Continued on Page 4

# **Development Fuels Elk Grove's Growth**

ELK GROVE, CA (MPG) -Already home to nearly 180,000 residents, Elk Grove has continued to grow in the past few years even as most of the state has seen population declines.

From 2019 through 2023, Elk Grove added about 4,000 residents, for a growth rate of 2.3%, according to the state Department of Finance. During the same period, California's population declined by 1.7%.

Experts say the addition of hundreds of homes, several shopping centers, a casino and the Elk Grove's potential acquisition of the Sacramento Zoo have helped drive the city's growth.

The Ridge shopping center began development in 2019. Since then, it has introduced 20 retailers and restaurants, as well as drawing 30.2

million visits, according to Tishiana Mann, an economic development specialist at the city of Elk Grove.

There are 7,332 community shopping centers nationwide, and Elk Grove's The Ridge ranks No. 157 in terms of visits since its opening in 2019 (97th percentile). It also ranked No. 49 out of 791 statewide (93rd percentile), and No. 1 within a 15-mile radius of its location, according to data from Placer.ai, which uses location data from electronic devices to measure how many people visit various places.

Sky River Casino opened in August 2022 in the southern part of Elk Grove. Since its opening, there have been 5 million visits and it ranks as the 73rd most visited casino out of 5,685 nationwide (98th percentile). Sky River also ranks as the sixth most-visited casino in the state out of 737 casinos (99th percentile); and the most visited within a 15-mile radius, Placer.ai data shows.

"They (The Ridge) opened in 2022 and they're doing really well. They're drawing in a lot of visitors. In their first year, they exceeded their revenue expectations," Mann said.

Another aspect of Elk Grove's growth over the past few years has been

the addition of hundreds of homes and businesses. In 2023 alone. Elk Grove had more than 400 new business licenses, along with more than 800 new affordable homes that began development, according to Mann.

With the speed of the city's growth, residents are asking for more restaurants and retail options, which has led city economic developer managers to put programs in place that encourage vitality and placemaking, which can lead to economic growth.

"I think we've invested a lot in infrastructure and keeping neighborhoods safe. There's a lot of programs that encourage businesses," Elk Grove District 1 Citv Councilmember Darren Suen said. "Plus the sheer factor of people moving to the area and the population growing. When more people come, there's more things that people depend upon to support them. Businesses, retail, restaurants, coffee shops, nail salons."

Elk Grove leaders said the city is attractive to new residents, due to its high standard of living and diverse population.

The city's housing affordability, wealth creation opportunity, high quality of life and diversity are among the leading factors that attract young families, according to Mann.

One of the main problems Elk Grove has faced over the past decade is housing affordability. Since 2019, the number of Elk Grove homes sold has gone down, while the median sales price has risen, according to data from Redfin.com, meaning the increase in pricing might have driven future residents away.

A decade ago, city leaders faced criticism over "sprawl" and building too many homes. Much of the criticism today has shifted to housing affordability and lack of homes.

This shift in narrative shows how the city has been on the correct path the entire time, according to Suen.

"I've been living here now for 23 or 24 years, but since I came into office (2014), we've built a lot of affordable housing in our community. Many people don't recognize it or are not aware of it. But the reason why you don't recognize it is because it (housing) looks so good. It doesn't look run down or anything; it's really done well," Suen said.

Elk Grove resident John Cortez moved from the Bay Area in 2019.

"I used to live in Fremont and I'd say the price here is about 10% to 20% more expensive but I'd say it's worth it because of the condition

of the city," Cortez said. "It's very nice, it's clean, it's developed really well, and since I moved here, it's definitely gotten a little bit bigger. You're starting to see more parks, and it's getting a lot busier."

Elk Grove will soon be a destination for the beloved animals at the Sacramento Zoo.

The Sacramento Zoo is more than 100 years old and has quite small enclosures. With the increased animal welfare standards, the size of the compound will no longer suffice, so the Sacramento Zoological Society and the city of Elk Grove are hoping to partner on a relocation project to move the zoo to the southern part of Elk Grove, according to Mann.

The city's Planning Commission unanimously voted to recommend the approval of the zoo's relocation and the Elk Grove City Council was set to consider its approval in a public meeting on May 8. If approved, the zoo is set to open sometime in 2029. City leaders hope it will help to grow Elk Grove's economy.

"I appreciate what the zoo can bring for the region," Suen said. "It's going to cost a lot of money. That's something that's not lost on me, and I take it very seriously. But it looks like it'll be a good decision for our city to go into partnership with

them '

Mann said the zoo could bring in 1 million visitors annually and support 250 iobs.

"So you've got more visitors coming, plus more residents. Those people are spending money in the economy, which leads to the city getting more funding so we can expand our programs and services," Mann said.

Suen said that, looking ahead, the city is working on Project Elevate, a mixed-use project that would allow residents to live next to shopping, arts, entertainment and restaurants.

Project Elevate is a multiyear development project that is set to be on the corner of Big Horn and Elk Grove boulevards. The development is meant to "elevate" the level of retail, dining and entertainment in the city, while also encouraging pedestrian activity, such as with public gathering spaces. According to the city of Elk Grove's website, Project Elevate could possibly take up to 15 years to fully develop; however, it would "push the local and regional market forward."

Suen said, "There's always been a desire to have more jobs in our city. One of my visions is to have a balanced community where people can just live, work and play here."

# **Baa-aad News for Fire Fuels**

SACRAMENTO COUNTY, CA (MPG) - We've goat some exciting news for ewe (ok, no more puns)!

The Sacramento County Department of Regional Parks is gearing up for its multi-pronged efforts to reduce fire risk, defend

(and other manned crews through contracts with the California Conservation Corps and Sacramento Regional Conservation Corps) to maintain fire breaks, and is issuing fuel break maintenance permits to properties bordering Regional Park properties.

"We had another wet winter and a surprisingly critical this year."

To decrease the number and size potential of wildfires in our parks system, the techniques used will be applicable for each area and will include:

Firebreaks - A combination of mowing, soil discing and targeted herbicides will be used where appropriate to create perimeters around open fields, along fence lines and behind neighborhoods. This work is scheduled to be completed by the end of June. Ladder Fuel Hand-Crews - In limited, hard-to-reach areas, hand-crews will remove vegetation that allows the potential for a



fire to climb up or move into urban areas.

**Permits** – Residents who live adjacent to Regional **Grazing** – There are Parks' properties are able to apply for free annual encroachment permits to maintain a fire break behind their property line. ### **Salmon Poisoning Disease** Warning Given to Dog Owners

#### SACRAMENTO, CA (MPG) -

Salmon Poisoning Disease is a potentially fatal condition seen only in dogs after they eat certain types of raw or cold smoked fish such as trout and salmon that are infected with a bacteria-like organism, Neorickettsia helminthoeca, which is transmitted by the parasitic flatworm (or "fluke") Nanophyetes salmincola.

Nanophyetes salmincola occurs naturally in waters of Northern California and most of the north state can be considered the fluke's native range. But dogs throughout the state are susceptible. Dog owners are advised to be cautious and to keep their dogs away from salmon, steelhead, trout and other freshwater fish carcasses. The parasite cannot survive in cooked fish, is not harmful to humans and does not affect pets other

#### than dogs.

If your dog has eaten or is suspected of eating raw fish, watch for signs of the disease. Symptoms are similar to distemper and might include some or all of the following: a rise in body temperature, loss of appetite, vomiting, diarrhea, listlessness and/or rapid weight loss. If signs of the disease appear, promptly take your dog to a veterinarian. Salmon Poisoning Disease is treatable if caught in time. If untreated, death usually occurs within two weeks of eating the infected fish. Without treatment, 90

percent of dogs showing symptoms die.

While all fish caught or originating from California streams could potentially be infected, the California Department of Fish and Wildlife cautions that trout stocked in some waters in the department's North Central Region are more likely to be infected with the flukes that cause Salmon Poisoning Disease.

# **May is Mental Health Awareness Month**

Since 1949, Mental Health America and its affiliates across the country have led the observance of May as Mental Health Awareness Month by reaching millions through the media, local events and screenings. It raises awareness of trauma and the impact it can have on the physical, emotional, and mental well-being of children, families, and communities. Cities and businesses across the country hold events to support mental health and open the lines of communication. Many websites provide ideas for businesses to support employees during May and beyond.

According to the Centers for Disease Control and Prevention (CDC), suicide rates in our country increased by 36% between 2000 and 2021. Suicide was responsible for 48,183 deaths in 2021 alone, which is about one death

every 11 minutes. We know that many mental health disorders, including depression, bipolar disorder, borderline personality disorder and PTSD, come with heightened risk of suicidal thoughts or attempts. While seeking help for suicidal thoughts or behaviors is critical regardless of the cause, securing a specific diagnosis might help the individual receive treatment, especially ongoing treatment, that is best suited to their mental health needs.

Mental Health America says that up to 60% of people who die by suicide have major depression and research suggests that the majority of suicides are related to a psychiatric condition. If you or someone you know is depressed, there are effective treatments available. Talking to your doctor is a fantastic first step and you can visit the National Alliance on Mental Health Illness to learn about support groups that you might find helpful.

The Jason Foundation is another valuable resource. JFI is dedicated to the prevention of the "Silent Epidemic" of suicide through educational and awareness programs. On its website, you will learn about warning signs and risk factors associated with people who may be struggling with mental health issues and suicidal ideation. JFI's website also has more information about finding a Jason Foundation location near vou.

We know that four out of five individuals considering suicide give some sign of their intentions, either verbally or behaviorally. In 80% of those considering suicide, we have an opportunity to recognize the warning signs and intervene. Take the time to educate yourselves on the warning signs and risk factors associated with suicide.

This knowledge might help you save the life of a friend or loved one.

### **Esplanade Madeira Receives Approval for Lodge Design**

ELK GROVE. CA (MPG8) - Elk Grove staff senior planner Kyra Killingsworth presented the Planning Commission with a design review on the Lodge project at Esplanade Madeira, requesting a resolution be adopted finding no further environmental review required pursuant to state CEQA (California Environmental Quality Act) Guidelines Sections 15162 and 15183.

Graphics setting out details for the Lodge building to be used privately

by members only revealed a new, approximately 21,658-square-foot private clubhouse to be constructed with parking, lighting, landscaping and indoor and outdoor amenities for a private, age-restricted community in the Esplanade subdivision.

The address is 8500 Lodge Way. It is to be constructed in compliance with the city's Climate Action Plan measures.

The Lodge design is of natural stone and earthtone colors in compliance with the overall project.

The property owner and project applicant is Taylor Morrison, LLC Jay Pawlek (Representative) 81 Blue Ravine, Suite 220, Folsom.

Staff recommended that the Planning Commission find no further environmental review necessary under CEQA.

The project site is located on Lodge Way, south of Poppy Ridge Road and east of Big Horn Boulevard within the Southeast Policy Area (SEPA) The fiveacre site is vacant and bordered by approved single-family dwelling

subdivisions (Souza Dairy and Esplanade West) under construction to the north, south, east and west.

It is in the Southeast Policy Area (SEPA) with a designation of Parks/ Open Space on the SEPA Land Plan. The Private Residential Open Space use is a permitted use in the designation of Parks/ Open Space.

In January, the director made a Similar Use Determination that the use of the private clubhouse on a park site would be substantially similar to the "Private Residential Open Space" use and that the property would be subject to the Parks and Recreation development standards.

Commissioner Oscar O'Con inquired why this private construction was brought before the Planning Commission. Killingsworth explained that all such projects more than 1,000 square feet are required to come before the commission. Upon review, Scott Johnson from the Sierra Club said his organization had no comment.

Commissioner Sandra Poole moved that no further CEQA was required. The design review, based on findings and approvals, was passed unanimously.

As recommended by the Planning Commission on April 4, Development Services Director Darren Wilson reported that the zoo project will go to City Council for consideration on May 8, after press time.

Wilson indicated no matters were scheduled to come before the Planning Commission on May 16 and recommended that meeting be cancelled. Chairman Suman Singha concurred on behalf of the Planning Commission. ★

"We are working with the CSD very closely, and with their support, we will put on a Western Festival in 2025 in the Elk Grove

The festival was last celebrated in 2019, when the long-standing tradimissed deadlines for various documents and the board had received "multiple extensions."

The letter, dated April tion featured its signature 22, highlighted a required certificate of insurance. with a deadline of April 5. "Unfortunately, your organization has failed to provide the required documents for this event. Thus, leaving no alternative but to terminate the agreement," the Community Services District letter read. At the May 1 meeting, Elk Grove resident Brian Coulson told the Community Services District board that he didn't "know how you guys can think that something like this could just disappear." He said that the district should have done more to ensure the festival happened. Resident Randy Bekker encouraged Community Services District staff to look into how they can do better next year.

statement on the district's decision, sometimes over interruptions from audience members. He said the missing documents created a public-safety risk.

"The Western Festival board had been aware of the deadlines for submitting required documents as far back as last summer. ... We support the organizations through the process, including regular communication, several extensions and application for permits. We kept an open line of communication and assigned a dedicated representative to attend meetings and help with paperwork. Despite our collective efforts, the flexibility extended, we did not receive permits and licenses and insurance in

time. With only two weeks remaining until the event, proceeding without the required documents would have compromised public safety and created a public liability risk," Luttrell read. He added that Community Services District is "committed to supporting the Western Festival and events like the Western Festival." Luttrell said the district had assigned three more staff members to work with the festival next year. He continued, speaking on his own behalf. "From my heart, I mean, I've been an Elk Grove citizen for a long time," Luttrell said. "We're going to make it work next year. It just happened too late this year. I'm sorry."

The four-part nurse training series covers a range of topics, including disaster readiness, a clinical refresher and training for shelter leaders.

In March, DHS held its third training event, partnering with California State University Sacramento's School of Nursing faculty, local hospital nurses, nursing honor society members

and student nurses to provide three sessions of the Nurse Disaster Worker Clinical Skills Refresher, which began with a classroom lecture followed by lab work.

"We went through a little bit of dyadic information, as far as taking care of non-obvious emergencies, in shelter situations," said Laura Cravens-Ray, assistant professor, California State University, Sacramento. "They will also be practicing some hands-on skills, basic patient assessments, mobility, how to use some of the equipment, and how to use some of the first aid

equipment that's going to be available to some of these nurses."

"Something I really wanted to learn, even before this, was wound care. So, I am really glad that we got to learn," said Darya Eslamian, pub-





I saw a young man with trousers riding low enough to qualify him for entrance into the Plumbers Union. I saw old men wearing pants high enough to double as

a face mask. And of course, more than enough middle-aged men wearing sweatpants to accommodate their growing bellies.

The fashion didn't improve much on the plane, where I sat across from a girl with fingernails painted traffic-cone orange. She was prewired to her phone and didn't notice me.

With so many fashion-challenged children of God, airport crowds do make a good segue. Cue Bible study.

That's because the airport crowd reminded me of the one Jesus likely encountered as he walked into a city looking to recruit a Band of Brothers who would change the world.

Like me, he was a people-watcher, just not as smug as me. Go figure.

Unlike me, he had a keen eye for the quality of the soul over the quality of the fabric, the cut of a man's character over the cut of his shirt.

This is the Jesus used to quickly single out an eager young recruit named Phillip who followed him without so much as blinking.

Exhilarated at being chosen, Phil found his bud, Nathanial, and begged him to come and meet the teacher from Nazareth. "Nazareth?" Nat rightly exclaimed, "You've got to be kidding."

No, Phil wasn't kidding.

"Come see for yourself," he challenged. Upon meeting Nathanial, Jesus quickly pronounced, "Now, here's the real deal. Not a false bone in his body."

Nat, not easily moved by flattery, asked, Where'd you get that idea? You don't know me.'

# **The Pride Look Strong Ahead of Playoffs**

ELK GROVE, CA (MPG) - A dominant season by the Bradshaw Christian Pride culminated with a 23-1 win over the Union Mine Diamondbacks to cap off their first-place finish in the Sierra Valley Conference.

"It's awesome. One of the strengths of this team is pitching, as they entered their last league game with a 1.04 ERA as a pitching staff.

"Pitching wins and baseball has always been that way so they're ready (for playoffs) and they work hard during their bullpens. They take it seriously and always work on trying to locate," Rickerts said. "We don't have a senior in the group so it's all youngsters and they're a pretty good group."

One of the key contributors to this team ERA is the starter against the Diamondbacks, junior Alex Crosno, who entered this game with a 1.69 ERA.

"He's a good kid, works hard, throws the ball well and he's only a junior

who will only get better," Rickert said.

Crosno would give up an unearned run in the first inning, but The Pride brought an offensive explosion in the bottom of the first with 11 runs which can be attributed to playing the game aggressively," Rickert said.



Having been born

in Seattle, WA in 1934, Janet experienced a life of challenges and grace. During the heart of the depression era, prospects arose in the Philippines. This lead to family members, including her father, Raymond Flatland, to relocate and successfully establish themselves in this far away country. Soon after, Janet and her mother, Alice Flatland, made the journey as well. While initially a prosperous venture, the Japanese military invaded the islands.

Her father fought in Corregidor and survived the Bataan Death March. Janet and her mother endured life in a prison camp in Manila, while her father was eventually captured and barely survived prison camp for military combatants. Fortunately, she and her mother were reunited with her father after the Allies liberated the Philippines, near the end of World War II. However, the harrowing events in the prison camp impacted her throughout her life, including living with the loss of family members. In 2004, she was interviewed about her experiences, with her filmed narrative permanently published for view in the Library of Congress.

After returning to the states following their liberation, her father and mother eventually moved their small family to the state of Oregon, where Janet attended high school and went on to enroll

**ELK GROVE, CA (MPG)** -The first round of the CIF Sac-Joaquin Section boys' volleyball playoffs kicked off on May 2 with a handful of local high schools competing.

The Division I bracket featured two Elk Grove high schools, two others in Division II and a lone school in Division IV.

#### Division I: No. 2 Pleasant Grove

**Eagles** The Eagles finished their regular season in second place of the Delta with a 10-2 league record and an overall 22-5 to obtain the No. 2 seed in the playoffs.

The Eagles matched up against the No. 15 seed West Wolfpack from Tracy where they swept them 25-15, 26-24 and 25-14.

Senior Tin Le leads the

Eagles with 255 kills on offense, and the team is defensively led by junior Mathew Barbusca with 39 total blocks throughout this season, according to MaxPreps.

The Eagles move on to the second round and will face the No. 7 seed Monterey Trail Mustangs on May 7, after press time. **No. 7 Monterey Trail Mustangs** 

The champions of the Metro with a record of 13-1 and an overall record of 23-8 obtained the No. 7 seed to face the No. 10 seed Enochs Eagles from Modesto.

The Mustangs swept the Eagles 25-17, 25-19 and 32-30 to move on to the second round.

Offensively, the Mustangs were led in this matchup by junior Dehryn Brown with 18 kills to add to his 504 total kills from the regular season, according to MaxPreps.

The Mustangs advance to the second round and will face the No. 2 seed Pleasant Grove Eagles, which will guarantee an Elk Grove school will reach the semifinals in the Division I bracket.

#### Division II: No. 13 Elk Grove Thundering Herd

The Thundering Herd finished their regular season with a 5-7 record in the Delta and an overall record of 12-18.

This record matched them up with the No. 4 seed West Park Panthers from Roseville, where they were swept 25-16, 25-19 and 25-20.

Despite the loss, the Herd were led offensively by junior Thomas Perrera with 131 kills, while defensively junior Caleb Stone had 16 total blocks and senior Benjamin Ly had 186 digs, according to MaxPreps.

The Herd failed to reach the quarterfinals this season after reaching that instance last year and hasn't been able to replicate the success of their 2019 NorCal Volleyball Championship.

#### **No. 16 Florin Panthers**

The third-place Panthers in the Greater Sacramento League with a record of 8-4 and an overall record of 11-6 obtained the last seed to face the No. 1 seed Rio Americano Raiders.

The Raiders showed why they were the No. 1 seed with a sweep over the Panthers 25-11, 25-16 and 24-14.

With sweeps over both the Panthers and the Herd, no Elk Grove squads are left in the Division II bracket.

The lone local school in Division IV was the Bradshaw Christian Pride, which was the runner-up in the Sierra Valley Conference with a 6-3 record and an overall of 15-10.

This record granted them the No.11 seed to match up against the Bear River Bruins of Grass Valley as The Pride went down swinging, losing three sets to two. The Bruins took the first set 25-16 but the Pride would even it up by a score of 25-23, which led to them taking the upper hand with a 25-12 set. Set four went to the Bruins 27-25 and finally the Bruins took the victory in the fifth set 15-13.

Despite this elimination, this program has turned around with The Pride reaching the semifinals last year after unsuccessful seasons like in 2022 where they posted an overall record of 1-13.

# **Cardinals to Adjust Approach for Playoff**

**ELK GROVE (MPG)** - In the bottom of the second inning in the Metro League matchup of the Laguna Creek Cardinals and the McClatchy Lions, one of the Cardinals' top players, senior Ariel Burton, came to the plate down 4-2 with the bases loaded.

The Cardinals were down thanks to a four spot in the first inning, then going down quietly in the bottom of the first.

The Cardinals returned to the plate in the bottom of the second, grinding out at-bats with walks and singles. Burton came into this game with a .451 batting average and leading the team with 27 RBIs.

"There were a lot of opportunities to make plays that weren't made," Wardlaw said. "There were balls popping out of their gloves and Little Leaguetype errors that can't happen."

The Cardinals' starter was junior Jazmine Johnson, who Wardlaw gives credit to because Jazmine found out about her start right before the game due to the team's normal starter being sick.

The second inning, when the Cardinals took the lead, Wardlaw was happy to see this fight from his team, but he said his team needs more innings like that.

"That one inning was great; we just need more innings like that, and they did a great job putting the ball in play," Wardlaw said.

The big hit that gave the Cardinals the lead was Burton, who Wardlaw praised on how much she cares and the way she plays the game.

"She is every coach's dream with her being the nicest, sweetest and respectful kid, along with being intense, coachable, a dream to have in the dugout and a great teammate," Wardlaw said.

Although the Cardinals defeated the Lions earlier in the season by a score of 6-2, Wardlaw said again, the biggest difference was defense, but he gave praise to the Lions' hitters who put the ball in play and constantly applied pressure.

With two league games left and the Metro League Championship secured, Wardlaw would like for his team to adjust their approach up at-bat ahead of their playoff run. "We have to have an approach in the box and believe in that approach and that would be a major adjustment heading into playoffs and next week with Burbank and Kenned," he said.

The biggest concern for the Cardinals ahead of playoffs will be defense, Wardlaw said.

"That's my biggest concern heading into playoffs is our inability to make simple plays, so we have to address that," Wardlaw said. "We have to get right. We've already won league so it's not about that; it's about getting right for playoffs."
