California American Water Partners with the San Diego County Water Authority and four other partners on new Sustainable Landscapes Program

Utility offers \$1.75 per square foot for landscape improvements based on sustainable practices

SAN DIEGO, Calif., March 16, 2017 – California American Water has partnered with the San Diego County Water Authority, the City of San Diego, County of San Diego, Surfrider Foundation and the Association of Compost Producers to create the Sustainable Landscapes Program, the go-to resource to assist San Diego County residents in adopting sustainable landscaping best practices through education and training, technical assistance, landscaping materials and financial incentives.

The Program encourages customers of California American Water who are residents of the San Diego region to take a watershed approach to landscaping their yards and offers qualified applicants \$1.75 per square foot to replace water-intensive turf grass with landscaping that provides several environmental benefits. Proposition 84 grants from the California Department of Water Resources are funding a limited number of incentives to promote residential landscape upgrades in the San Diego service area.

"California is in its sixth year of drought. Although California American Water and the regions' water utilities have sufficient water supplies to last three additional dry years under the state's rigorous 'stress test,' we are continuing to encourage our customers to always use water efficiently regardless of weather condition," said Patrick Pilz, Manager Field Operations of California American Water. "This important and timely program is designed to advance resource efficiency in urban landscapes by emphasizing water conservation and stormwater management."

To qualify, proposed projects must have:

- Existing turf grass. Turf grass should not be removed before applying and officially enrolled in the program
- An operational, in-ground sprinkler system

In addition: Homeowners must calculate storm-water runoff and capture, and show how much of the new landscape will be covered by water-efficient plants.

- Artificial turf is not eligible for reimbursement
- Projects must incorporate rainwater capture and detention, soil enhancements, climateappropriate plants, water-efficient irrigation methods and are subject to site inspections.
