Dear President Trump,

On January 20, 2017, just a few hours after taking office, you issued Executive Order 13765, *Minimizing the Economic Burden of the Patient Protection and Affordable Care Act Pending Repeal.* The executive order stated that your Administration planned to "seek the prompt repeal of the Patient Protection and Affordable Care Act" (ACA). Pending the repeal of the ACA, your executive order also directed the Department of Health and Human Services (HHS) and "all other executive departments and agencies" to, "exercise all authority and discretion available to them to waive, defer, grant exemptions from, or delay" the "regulatory burden" imposed by the ACA."<sup>2</sup>

Since issuing this executive order, you and Republicans in Congress have advanced legislation that would eliminate health coverage for more than twenty million Americans, increase costs for millions more, and make devastating cuts to the Medicaid program.

Last month, in the midst of these repeal efforts, HHS issued a request for information, seeking public comments to help inform its implementation of Executive Order 13765. Tens of thousands<sup>3</sup> of people from across the nation wrote to the Department to share their views on health care. The comment period closed on July 12, 2017.<sup>4</sup>

We conducted a review of the public comments posted to Regulations.gov shortly after the comment period closed. This review indicates that that the vast majority of commenters oppose the repeal of the ACA and want your Administration to improve the law—not sabotage it. We are writing to you in order to highlight the key themes in the comments and urge you to carefully consider those themes, the examples we have provided, and the thousands more like them before making any material administrative changes to or pursuing legislative efforts to undermine or repeal the ACA.

Many Americans wrote in to share personal stories about how the ACA has benefited them, including:

• **Gina (Ohio):** "The ACA positively impacted my life following my Crohn's disease diagnosis and kept me from bankruptcy during an already stressful time. I would

encourage HHS to work within the framework of the ACA [...] rather than repeal important regulations, such as essential health benefits, which have made health care affordable for people with pre-existing conditions. Without these important regulations, million[s] won't be protected and will face bankruptcy and/or a serious decline in health."<sup>5</sup>

- Kass (Pennsylvania): "I am a small business owner with Ulcerative Colitis. In 2005, when I was diagnosed with this debilitating disease, I was on disability because I could not work. I was so sick that I could not drive a car to get to work. When I obtained healthcare under the ACA, my doctor got my symptoms under control and I was not only able to get off disability, I started my own business and employed others. Today, instead of being a drain on my fellow taxpayers, I am paying taxes as both an individual and a corporation and I am contributing to the local and international economy with my business. If I lose healthcare coverage—which I am likely to do under the new GOP "healthcare" proposals—I will have to close my business and go back on disability. I will again become a burden on the state. Does that make sense? No, it does not."
- Robin (Alaska): "We were healthy, happy, insured, and living well within our means until the day our daughter was born. A complication during birth landed her on full life-support for two weeks and in the NICU for 31 days. The bill for her first year was over \$800,000. The ACA kept us from going bankrupt."
- Anonymous (North Carolina): "My grandfather, who went to Stanford and worked for the Army Corps of Engineers, who has owned an engineering business that has stood at the top of [its] class for decades, had a heart attack last year, three months after we got him signed up for the ACA for the first time. He was able to weather the storm and return to work, providing jobs and boosting the economy, because the ACA supported him when he needed it, even though he was diagnosed with Type 1 (juvenile) diabetes at age 15. He and my grandmother have paid their high self-employment taxes faithfully, but have always been without health insurance because the private option was too expensive for them to handle."

In addition, many Americans wrote in to express their disapproval of current Republican efforts to repeal the ACA and their fear of losing the ACA's protections. For example:

- Trudy (New Hampshire): "We need the Affordable Care Act. It is cruel to repeal it. My son would be without any health care if you do. I will have trouble paying for all the cost increases you are proposing and I am not poor but you will make me become poor."
- Alexandra (Maryland): "It is essential that we preserve the protections created by the ACA, in particular covering individuals with pre-existing conditions and allowing young people to stay on their parents' healthcare plan. Removing these protections would be disastrous for millions of Americans, and will result in many people being unable to obtain life-saving medical treatments. Please do not get rid of these protections, nor impose burdens on Americans for not being able to afford continuous coverage." 10

- Charles (New York): "I am a kidney transplant recipient, have been a type I (auto immune form) diabetic since 1980 and my wife has asthma. My mom is 69 and, I assume in the next decade or sooner, she will need nursing services. My wife teaches public school in NY and I am still on disability. The new GOP 'healthcare' (I use that term facetiously because it is a recipe for millions to fall into bankruptcy and/or die from lack of actual healthcare...) bill will potentially cause both my wife and I to go bankrupt and/or die prematurely from lack of affordable healthcare. [...]"11
- Dana (Vermont): "The Affordable Care Act has improved the lives of millions of people by providing access to affordable and essential health care services; by providing access to Medicaid for the children, families, and elderly who need it; by protecting people with pre-existing conditions; by protecting our most vulnerable citizens. [. . .] The GOP health care bill passed in the House and now under consideration in the Senate is cruel, reckless, and dangerous, and will result in millions of people losing coverage, or worse. Don't undermine the health care of millions of Americans with the repeal of the ACA, with the deplorable GOP bill, or with Executive Order 13765."
- **Phil (Wisconsin):** "I like the Affordable Care Act, it's how I get my insurance. Not sure what will happen to me if the new bill passes, but it doesn't look good." <sup>13</sup>
- **Kelly (West Virginia):** "Saying that the money saved on this heartless "healthcare" plan to give tax breaks to the wealthy so they can create jobs is a proven false pretense based on nothing. [...] There are solvable problems with the ACA that you should be focusing on and fixing. [...] Do not let this immoral bill pass. We are better than this." <sup>14</sup>

Rather than asking you to repeal the ACA, commenters repeatedly expressed their hope that your Administration would work in a bipartisan fashion to "make [the] ACA better or leave it alone"<sup>15</sup>:

- Andrea (Utah): "The Affordable Care Act needs to be fixed, not repealed. The AHCA and Better Care Reconciliation Acts both make health care worse for tens of millions of Americans. I care far more about the hundreds of thousands of people in my home state of Utah who would lose their health care and hundreds of thousands more who would have needed services, medication and treatments cut for the benefit of a few politicians to carry out a promise of repeal. [...]On health care we need politicians willing to reach across the aisle to work together to do what's best for the American people. Right now there is no better solution than the Affordable Care Act, which is responsible for improving insured rates and care provided in every state in our nation." 16
- Nancy (California): "[S]top trying to take away health care and the ACA, put your energy into improving the ACA.[...]healthcare is a right for all citizens and the ACA, while in need of fixes, was a start in the right direction[...][S]o many people depend on Medicaid- older people, the working poor, children, do not cut their services." 17

- **Zillah (Georgia):** "I am totally opposed to the Trump care bill which will help the rich and hurt middle and low income Americans [.] [P]lease have a heart and join with Democrats to make fixes to the ACA." 18
- Connie (Indiana): "It seems to make more sense to build on what is already available. Why are we starting over when millions have benefitted from the program? Sure, it needs some changes but did anyone really think that something so new and comprehensive would work without some changes[?] Build on what is already existing rather than scrap it and start all over. Let's stop thinking about what party wants to do what and look at the overall benefits and challenges and build on that foundation." 19

We have attached sample comments from all 50 states for your review (see Appendix).

Your Administration is attempting to ram a partisan ACA repeal through the Senate, negotiating in secret and refusing to inform the public or even hold a single hearing on this matter. But when HHS offered Americans an opportunity to comment on your efforts to "repeal and replace" the ACA, they responded—making it resoundingly clear that they oppose your actions. It is imperative that you listen. We invite you to work with us to improve and strengthen health care in the United States—rather than pressing ahead with plans to eliminate health coverage for over twenty million Americans and enact deep cuts to Medicaid.
