

## Still Waters Run Deep

SACRAMENTO REGION, CA – (MPG) In search of Walden Pond you'd travel further than to Folsom CA. Dan Winkelman did not visit the Massachusetts spot immortalized by Henry Thoreau. But Walden waters flow philosophically through his own book.

Retired ranger Winkelman eulogizes a personal utopia. Below Folsom, Lake Natoma was formed in 1955 as a reservoir for the Nimbus Dam. The water and its inhabitants are inspiration to the 66-year old. His publication of "Lake Natoma – A Ranger in Search of Walden Pond" comes from many happy hours at water level. Named for Charles Darwin's ship Beagle, Winkelman's canoe

takes the nature lover on a new

voyage of discovery.

A protégé of Carmichael naturalists Effie Yeaw and Jo Smith, "Ranger Dan" Winkelman is himself part of American River lore. His book presents the perspective of explorer, teacher, puppeteer, bread baker and humorist. His account of "four butts facing me" explains why mallards must feed bill-down. Such a sighting, considers Winkelman, "is an event to

be cherished by all."

Thirty years as a State and County ranger molded commentary on subjects great and small. "A ranger provides all the services of city in one person," he considers. "You are a policeman, a doctor, and when you're in charge of a camping ground,

you're a hotel manager. You take care of people." Pets are oft included. A dangerous canine cliff rescue earned faint thanks; the owners afterward drove off with their dog. "I muttered, 'you're welcome," writes the hero. Concludes the pragmatic hero: "But hey, another cliff rescue notch on my belt..."

Winkelman's ranger years included spells in Gibson Ranch, Ancil Hoffman Park, Sonoma Coast, Sutter's Fort, the American River Parkway and Angel Island. Retiring in 2001, he penned random articles from his placid lake. "These were simple canoe adventures," he explains. "I E-mailed them to my neighbors. One urged me to continue. She didn't realize what a treasure our lake was."

The book project added odd-ball stories from a ranger's career. Eclectically self-educated and widely read, his opus includes Indian lore, pioneer and Gold Rush stories. His own forebears add fresh material to the historical record.

Some lessons are profoundly noted. Floating feathers are a lesson in evolution: those dinosaurs that learned to fly, considers the canoeist, escaped the fate of their doomed fellows: "Whatever catastrophe befell the dinosaurs created a niche for us mammals to rise in triumph... looking into the face of (an otter), I have found a distant brother. My connection with the wild is complete."

Along with this ticket, Conley said he had purchased only one other ticket for the draw, both of them Quick Picks®. Ask him how he feels about his good fortune and he gets a little emotional. "I didn't think it would happen for me, but it did," said Conley while fighting back the tears. "These are happy tears, but yea, it feels great." Conley said he wants to be careful with his money and use it to accomplish a few things he has always wanted to do. He may get a few toys, which his family presumes will include a new truck. Conley bought his ticket at the 7-Eleven located at 6840 Woodmore Oaks Drive in Orangevale (Sacramento County). It hit the numbers 29, 56, 24, 34, and 30, missing only

the Mega number of 1. The other Orangevale winning ticket was for the SuperLotto Plus® draw on Saturday. No one has claimed that ticket yet, but it's worth \$27,044. The prize would have been more, but there was another winner who matched five of six numbers in Southern California.

The Northern California winner was sold at OV Goods, which is located at 9281 Madison Avenue in Orangevale. ## BBB's Top Ten Scams of 2012

SACRAMENTO Region, CA – (MPG) Better Business Bureau serving northeast California gathered information from consumers, federal agencies and internally to cultivate a list of the top scams of 2012.

While some scams are fairly new as scammers learn to take advantage of the Internet, others have been around for years continually victimizing consumers.

"Our list highlights the scams that are the newest or most outrageous," said Gary Almond, president of BBB serving northeast California. "While consumers seem to be getting savvier, these scams only become more prevalent with the advent of new technologies."

BBB's top ten scams of 2012: Top Overpayment/Fake Check Scam: Car Ads

A prominent company is offering \$400+ per week to consumers willing to drive around with logos plastered to their cars. They send a check to the consumer and ask the consumer to wire a portion of that "check" to a graphic designer to customize the car. One week later, the check bounces, the graphic designer is nowhere to be found, and the money wired is gone.

#### **Top Emergency Scam: Grandparents Scam**

The "Grandparents Scam" has been around a while, but deserves mentioning again: grandchild/niece /friend is traveling abroad and calls/texts/ emails to say he or she has been mugged/arrested/hurt and needs money right away. Before wiring money in an emergency, check with the supposed victim or family members to make sure the relative is really traveling.

#### Top Employment Scam: Mystery Shopping

Working as a secret shopper may sound like an ideal way to supplement income, but scammers have figured that out, too. Many job offers are nothing more than a variation on the Overpayment/Fake Check Scam (above). Sometimes they claim that evaluating the wire service company is part of the job, which is why the consumer needs to send back part of the money. The Mystery Shopping Providers Association says it is not the practice of their members to pre-pay shoppers. Those looking for legitimate opportunities can find a gig through www. mysteryshop.org.

### Top Advance Fee/Prepayment Scam: Nonexistent Loans

Loan scams continued to fester in 2012. Most of the scams advertise online and promise things like no credit check or easy repayment terms. The hook: you have to make the first payment upfront, you have to buy an "insurance policy," or there is some other kind of fee that you have to pay first to "secure" the loan. In the end, the consumer ends up with nothing but an empty wallet.

Landscape and wildlife pictures illuminate many chapters. In innocent contrast to the world-weariness of a Vietnam and three-decade public service veteran are drawings from Maddie Walker. Ranger Dan recruited his seven-year-old artist after speaking at her Folsom School. "A child's truth is uncompromised," he approves. "Maddie's art portrays an innocence that left me long ago."

A life more simple is the

author's constant theme. "In the 1840s, Henry Thoreau moved to Walden Pond and built a cabin." he says. "In the 21st century, I bought a tract house above a man-made lake. "We both tried to discover our place in a natural world. In a canoe, I got in touch with the human I was meant to be." His final chapter -- a tribute to Effie Yeaw and volunteers who continue her work – advises: "We don't have a long time on this earth... take some time to know a place you can call home."

Beyond otter, beaver, and

upended ducks, inspiration comes from a motley human crew. Winkelman is an explorer with Muir; a river dreamer with Twain; a marine biologist with Steinbeck. "In writing the book, I reviewed literature that influenced my life," explains the author.

"Who'd know what runs through the mind of that guy in a truck. Yeah, me. Ranger Dan."

#### Top Phishing Scam: President Obama Will Pay Your Utility Bills

At the peak of summer with utility costs soaring, consumers received emails, letters and even door-to-door solicitations about a "new government program" to pay utility bills. Victims "registered" with a website and provided everything scammers needed for ID theft, including bank account information.

#### Top Sweepstakes/Lottery Scam: Jamaican Phone Lottery

The calls come from area code 876 but the person claims to represent BBB, FBI, or other trusted group. Great news: you won a terrific prize, but must pay a fee to collect the winnings. After wiring money to "collect" the prize, consumers never hear from the scammers again.

#### Top Identity Theft Scam: Fake Facebook Tweets

"ROFL they was taping you" or "What RU doing in this FB vid?" are typical tweets. In a panic,

you click on the link and get an error message that says you need to update your video player. It's a virus or malware that can steal confidential information from your computer or smart phone. Twitter recommends reporting spam, resetting your password and revoking connections to third-party applications.

## Top Home Improvement Scam: Sandy "Storm Chasers"

BBB spends a lot of time investigating and reporting on home improvement scams, but this year we saw an unusual amount of "storm chaser" activity following Super Storm Sandy. It's tempting to skip reference checking in an emergency, but that's never a good idea. Always check a company's licensing before hiring and search for them at necal.bbb.org.

#### **Top Sales Scam: Fake Goods**

From the Super Bowl to the World Series, counterfeiters managed to have their hands in consumers' pockets all year long. Some scammers sold cheap knock-offs in front of stadiums.

Others set up websites that never had any goods for sale to begin with. Counterfeit goods are not only a rip-off for fans, but also rip-off the teams, athletes, designers and artists who create, license and sell the real merchandise. Buy directly from teams or from legitimate retailers. If a deal sounds too good to be true, it probably is.

#### Scam of the Year: Newtown Charity Scams

Within hours of the horrific shooting at Sandy Hook Elementary School in Newtown, Connecticut, social media pages dedicated to the child victims began cropping up. Some of them were scams asking for money. The FBI has already arrested one woman for posing as the aunt of one of the children killed, and state and federal agencies are investigating other possible fraudulent and misleading solicitations. Although the number of people defrauded and the total dollars stolen is most likely low, the cynicism and sheer audacity of these scams merits our selecting it as the "Top Scam of 2012."



## New Year Planning for Small Businesses

SACRAMENTO, CA — (MPG) By now, most people have already broken at least a few of their New Year's resolutions, but the NFIB Small Business Legal Center has come up with a list of five resolutions every small-business owner should keep.

In the next few weeks, California small-business owners should:

#### Perform an Insurance Check-Up

It's a good idea to schedule an insurance physical each year. If it has been a few years since you've reviewed your coverage check in with your agent this year. Your business and industry probably has unique needs and risks. So to get the best available coverage and rates, work with an insurance broker who knows your business and has experience in your industry.

**Review Your Employee Policies** 

Although employee handbooks can be really helpful to employers, having a bad employee handbook can hurt you. Your employee handbook shouldn't describe policies and procedures that you don't follow. It is not a place to describe your dreams for how your business ought to work. It is a place to describe the reality of how your business actually operates.

This year pull out your handbook or policies, sit down, and read them. Then update, edit, and delete as recommended by your attorney. Finally, distribute the revised handbook to your employees and have them sign a form acknowledging receipt. Keep the form in your personnel files.

#### Check Your Corporate Records

Remember that a corporation is good, but only if you use



it properly. Many people pay an attorney up to \$1,000 to setup a corporation, then take the corporation's minute book and stick it on a shelf. A corporation will not shield you from personal liability if you do not follow corporate procedures. This year make an appointment with your attorney or accountant to review

your corporate binder's contents. Does it contain what you need to prove your business's corporate status?

#### Institute a Good Document Retention Policy

Have you ever wondered how long you should keep a contract, banking statements and employee

records? Or are you keeping every single bill, tax return, insurance invoice, and even the parking ticket that you received ten years ago? If you answered "yes", you are not alone. Many business owners are unsure as to how long they should retain business documents and records. A document retention policy that is followed by your employees will benefit your business by promoting efficiency, saving your company valuable computer and physical storage space. and protecting your company in the event of litigation. Given our culture's penchant for lawsuits, you want to protect yourself and having documents provides good coverage. But you needn't keep every piece of paper forever. This year commit to weeding out what you don't need and organizing what you do need. Check with your attorney or tax professional for guidelines on keeping

and tossing.

#### **Audit Your Form I-9s**

The Form I-9 is the form the federal government uses to hold employers accountable for hiring workers legally eligible to work in the United States. The form should be completed on the first day of employment by ALL employees hired since 1986. Yes, the law applies to your sister-in-law and the kid you grew up with if they are employed by your business. This year ensure that you have completed I-9s for all of your employees and that the forms are correctly filled out. Conducting an audit might take some time and effort depending on the number of employees you have, but will save you headaches and possibly penalties should a federal agent knock at your door.

#### **Assemblyman Cooley Introduces Legislation Strengthening Role of Independent Monitors in State Agencies**

RANCHO CORDOVA, CA -(MPG) Assemblyman Ken Cooley introduced AB 117 on January 14th to strengthen and formalize the role of independent monitors within state agencies. It is his second bill dealing with government accountability and transparency and continues his leadership on these issues from his work in local government with the Rancho Cordova City Council.

Current law, effective January 1, 2012, requires state agencies to appoint independent monitors to ensure efficiency and fiscal accountability. The law is silent, however, on the framework for how these monitors are to function or report their findings. AB 117 directs the Department of Finance in consultation with the State Auditor and the State Controller to create guidelines for the independent monitors to follow when fulfilling their duties.

"If we want the independent monitors to succeed in helping us

improve state agency management and fiscal accountability, efficiency, and administration we need to give the monitors the tools to do their job," said Cooley. "Recent reports of fiscal mismanagement by state agencies highlight how important independent monitoring is to ensure California's tax dollars are being spent wisely and in full public view."

The Financial Integrity and State Manager's Accountability Act of 1983 created the initial infrastructure to promote state agency fiscal monitoring. After the Enron scandal, the federal government imposed strict auditing standards on corporations, including independent internal monitors. SB 617 (Calderon, Pavley, Alquist 2011) responded by implementing auditing standards into the Financial Integrity and State Manager's Accountability Act that required mandatory independent monitoring of state agencies as an

additional check on internal auditing procedures. SB 617, however, did not provide guidelines for the independent monitors on such practical matters as training, reporting relationships, or best practices for professional development.

AB 117 instructs the Department of Finance, in consultation with the State Controller and State Auditor, to create these guidelines so that the independent monitors have a formalized framework to effectively do their jobs.







Fortunately we were able to promptly rescue the threatening jumper without injury.









## State Seeks End To Court Orders Capping the State's Prison Population

California prison health care now exceeds constitutional standards; Prison emergency declared over.

SACRAMENTO. CA -(MPG) Governor Edmund G. Brown Jr. announced January 8th that the State of California has taken legal action to end a federal court order that caps the state's prison population and another that requires "intrusive supervision" of prison mental health care.

"After decades of judicial intervention in our correctional system and the expenditure of billions of taxpayer dollars, the time has come to restore California's rightful control of its prison system," said Governor Brown.

The state also complied with the court's order to identify options to achieve additional reductions in the number of inmates held in state prison. This filing, made under protest, asserts that further reductions "threaten public safety and interfere with California's independent right to determine its own criminal justice laws."

"California's prison health care system is now a model for the nation," said CDCR Secretary Jeff Beard. "Independent expert reviews have found that crowding was the primary cause

mental health care systems meet constitutional standards. It would be both unnecessary and unsafe for the courts to order further inmate reductions."

In 1991, California prison inmates filed a class action lawsuit, Coleman v. Brown, alleging that California's prison mental health care system was unconstitutional. Subsequently, prior administrations entered into various consent decrees that set in motion vast judicial oversight of our prison system. In the intervening years, California has rebuilt its prison mental health care system into one of the best in the nation, investing billions in additional treatment capacity and hiring hundreds of mental health care professionals. The state seeks to end this judicial oversight because the mental health care provided to prisoners now exceeds constitutional requirements.

In 2007, the Coleman case along with Plata v. Brown, a case concerning medical care, was assigned to a three-judge court. That court found that over-

California's prison medical and of the failure to deliver conorder in 2011.

Since 2006, the inmate population in the state's 33 prisons has been reduced by over 43,000 and crowding is down from more than 200 percent to just below 150 percent. More than half of the population decline has happened since October 1, 2011, as a result of Public Safety Realignment.

Lowering the prison population beyond this point—as ordered by the court-would require rewriting or disregarding the California Constitution and numerous state laws that limit the early release of prisoners. The result would be shorter sentences for inmates incarcerated for serious and violent offenses. increased burdens on counties, and expanded use of contract facilities at considerable cost to the taxpavers.

Governor Brown also announced that he has signed a proclamation ending the prison overcrowding emergency that has been in place since 2006. This will allow the state to phase out the use of private out-ofstate prison beds for California inmates starting in July of 2013. At this time, there are approximately 8,900 California inmates in out-of-state prisons.

"The extreme circumstances of overcrowding in California's prisons no longer exist," said

## **Hoping for a New Energy Approach**

Obama Needs To Focus Energy Policy On Change, Not Hope

Just prior to the election, battery-maker A123 Systems filed for bankruptcy. As the recipient of \$249 million in federal money, the Massachusetts-based company represents just the latest in a long line of troubled taxpayer-enabled green ventures - some 34 companies and \$7.5 billion to date. How little different this is from Houston-based Enron's forays into wind and solar in the 1990s, which even with federal subsidies were never profitable.

Failed bets on politically correct, market-incorrect energies are part of the trillion-dollar federal deficits that shake America's living rooms. Yet President Obama seems determined to continue throwing good money after bad, setting up companies and their workers for failure. Meanwhile, resources are taken from the private sector where consumersupported jobs originate.

Such is just part of the president's grander, misdirected energy policy, one that is at odds with the Big Three Energies of oil, gas and

Consider, for example, the president's take on the cause and cure for high gasoline prices. A CNN poll earlier this year found a three-fold increase in the number of Americans viewing high motor fuel prices as the nation's most significant economic issue. The national average has abated to \$3.42 per gallon, and gasoline prices in California have recently dropped below \$4 per gallon. Still, stagnant oil production on federal lands compared to state and private lands is a missed opportunity for producers and consumers alike.

So what does the president say? That renewable energy is "the only way we'll break this cycle of high gas prices."

The truth is that the big forces pushing up gas prices can't be solved with wind, solar and ethanol. Global demand for crude oil is high, and the supply is hampered by political instability in oil-rich places such as the Middle East and North Africa. And U.S. policymakers have weakened the dollar.

Then there's the president's take on taxes. Obama constantly hammers "big oil" for supposedly not paying its fair share. And he claims these companies are benefiting from billions of dollars in taxpayer giveaways. But the fact is that the three biggest oil companies — Chevron, ExxonMobil and ConocoPhillips - all pay tax that to other major American corporations. Apple only pays 9 percent. GE, thanks in part to its windpower unit, pays just 7 Then there's the claim from the

White House that oil companies are leasing thousands of acres of land but leaving them idle.

To make its case against expanded drilling, the administration misleadingly defines "idle" to include such things as seismic testing on the land and preparing rigs to drill.

True, at this stage companies aren't physically pulling resources from the ground. But the land certainly isn't idle. Oil and natural gas developers are just taking necessary first steps before actual drilling and, hopefully, production occurs.

Compare this to genuine idleness when federal policies have unnecessarily delayed drilling permits. And don't forget the Keystone XL pipeline, which remains one White House decision away from overcoming idleness.

Obama's effort to paint greentech as the future of American

rates above 40 percent. Compare energy is predictably backfiring. While heavily subsidized wind and solar companies continue to flail, the traditional energy sector is flourishing, while developing more environmentally friendly ways of doing business.


Indeed, the U.S. Energy Information Administration projects that by 2035, oil and natural gas alone will supply about 55 percent of America's energy needs, compared to less than 11 percent from government-dependent wind, solar and ethanol.

And if federal budget reforms eliminate energy subsidies, expect this market-share differential to become much more pronounced.

With his second term just around the corner, President Obama should rethink his failing energy policy for one premised on free markets, consumer sovereignty and deficit-reduction.

One can hope for change,

In these days when it seems everything has become angry polarization, it's not uncommon to hear someone in the heat of an argument invoke the familiar words of Jesus: "Judge not, so that you are not judged." These words are probably misapplied as much as anything Jesus ever said.

Jesus' prohibition against judging has less to do with our academic arguments than it does with how we treat people. The better translation of his words is, "Do not condemn others." This changes the whole equation, as Jesus doesn't ban "judgment" in the sense of discernment, making honorable choices, or being an informed person. Rather, Jesus is precluding the use of condemnation against others.

Yet, if you turn to the media, read much of what is printed by Christian publishers, listen to what is repeated in church pulpits, or spend time perusing the Christian blogosphere, it seems the only voice we Christians have is that of a crotchety old man, angry that the neighborhood kids won't stay off our lawn.

Yes, some of what we say is healthy, principled dissent; but too much of it is an exhaustive collection of condemnation and angry finger-pointing, incensed as we are, at what everyone else is doing wrong. But by Jesus' own word, the

church is not permitted to become this type of condemnation-meting society. We are not called to operate a business of inflicting punishment on others. In fact, we aren't called to mind others' business at all.

In my vocation I often come across those who are hostile toward the Christian faith. I try to engage such individuals and learn something from them. What I have learned from people such as these, more often than not, is their exasperation over how we Christians frequently come across as a kind of moral SWAT team.

We intrude into the lives of others filling the air with the ammunition of "ought, should, and must" when we would be better served by turning our energies and attention to our own hearts and examine our own lives, not the lives of others. Dietrich Bonehoeffer said it like this, "Jesus is the only standard by which disciples should live, but he is not a standard we can apply to others. He is a standard we can only apply to ourselves.

So, when we as Christians get blisteringly angry with those who sin differently than we do, we should remember to mind our business. That business is to love, not to condemn. That business is to begin with the self, for beginning there will keep us busy for a lifetime.

To that end, there is a wonderful story from famed Rabbi Mendel Futerfas, who survived years in the Soviet Gulags of Siberia. In the Gulag, one of the many activities that was prohibited and dealt with harshly was playing cards. Still, some of the inmates managed to

smuggle in a deck of cards, and they would play for hours without the guards knowing.

Finally, however, an informant sold the card-playing prisoners out. The guards would storm in with surprise inspections looking for the cards, but could never find them. They checked every inch of the barracks including strip searches of the inmates, but the result was always the same: Nothing. Yet, as soon as the guards left, the cards would reappear and the games continued.

Rabbi Mendel couldn't understand how this happened, but eventually the card players let him in on their secret. "You see," they said, "we are professional pickpockets. As soon as the guards enter the barracks, we slip the cards into their pockets. Right before they leave, we slip them back out again. It never occurs to the guards to check their own pockets.'

"Judging" does not prevent us from having and sharing opinions. It doesn't mean we can't give a verbal witness to our faith. But it does mean we refuse – absolutely refuse – to condemn others. We leave "room in our hearts for God's grace," and that room is made possible by looking in and emptying our own pockets



In 2012, he has made 347 appearances around the world. Yet, he still finds the time to jog one hour every night. He even offered the political mouths his service to get them together to come to a compromise on the fiscal cliff which is still teetering on the edge. Don't make resolutions, he told me, go to bed and awaken with the conviction to do it. And don't wait till the New Year. Do it now. Make up your mind and get it done!

And so this is the Kreskin I got to know, and I look forward to our next time together with this man who has achieved so much, and yet cares more about sharing his talent to better us all. I am honored!






To prepare, start with cupcakes that have been baked according to package directions, in the baking cup of your choice, and fully cooled. Place a coupler and a large round tip (like a 12 or 2A) on your Wilton decorating bag; fill with the icing of your choice.



Hold the decorating tip approximately 1/4 inch above the cupcake at a 90 degree angle to the cupcake. Starting at the center, pipe a large dot of icing onto cupcake

Pull the dot of icing to the outer edge of cupcake and begin piping a spiral of icing around the cupcake top, working inward and upward.

Once at the center, stop pressure and pull tip away. It's as easy as that.

Preheat oven to 350°F. Place wave or solid black baking cup in standard muffin pan; place square baking cup in square cupcake pan.

Prepare cupcake batter per package or recipe instructions. Pour cupcake batter into prepared pan. Bake 18 to 20 minutes or until toothpick comes out clean when inserted in center of cupcake. Remove pan to cooling grid; let stand 10 minutes. Remove cupcakes from pan; cool completely.

#### **Rose Ombre Cupcakes**

Divide icing, and tint six shades of rose from dark to very light. On top of cooled cupcake, using a tip 12 and the darkest rose icing, pipe large dot in center; add ring around dot at edge of cupcake. Switch to a slightly lighter shade of rose icing and, with tip 12, add another large dot to center top of cupcake, make a second ring around the inside edge of the first ring. Continue piping next three shades of lighter rose icings with tip 12 and create smaller rings of icing on the inside edge of the previous ring. Once at the center using the lightest shade of rose icing, pipe one last ring around top with tip 12, adding a swirl.

#### **Sugar Striped Square Cupcakes**

Using white icing and tip 12, cover top of cooled cupcake with large zigzag. Top with Pink Sugar Gems.


#### **Zebra Lace Cupcakes**

Tint icing yellow. Add tip 12 swirl to top of cooled cupcake. Add Zebra Icing Decoration.
