# Storm Repairs and Costly Headaches

(MPG) The Contractors State License Board (CSLB) is urging California home owners to be vigilant when it comes to contracting for clean-up or repairs from this weekend's heavy rain and high winds. Sometimes what appears to be the cheapest solution to repair flood damage, remove a fallen tree, fix a downed fence, or patch a leaky roof may not be the best choice.

"Anyone who needs to repair post-storm damage should be looking for a legitimate, qualified tradesperson—especially in an urgent situation," said CSLB Registrar Steve Sands. "A licensed contractor who is skilled in the specific trade you're seeking is insured and bonded, and is not likely to leave you in the lurch when it comes to properly completing the job at a fair price.

"Consumers can use CSLB's online resources, available at www.cslb.ca.gov or CheckTheLicenseFirst.com, to review the license status of a contractor they plan to hire, and to get tips on the best approach to home repair projects. Any construction job valued at \$500 or more in labor and materials must be done by a state-licensed contractor. California Business and Professions (B&P) Code requires licensees to carry workers' compensation insurance coverage for their employees, and to be bonded.

For tree trimming and removal jobs where the tree is 15 feet or higher and the job is more than \$500, the contractor must be statelicensed. The B&P Code allows

a gardener who does not have a state license to work on incidental tree pruning if the tree is less than 15 feet and the job costs less than \$500.State law requires all Roofing (C-39) contractors to carry workers' compensation insurance, even if they do not have employees, to ensure that consumers are protected in the event of an accident or injury

on the homeowner's property. CSLB urges consumers to follow these tips when soliciting bids from any home improvement

- Hire only licensed contractors, and ask to see the license and photo identification.
- Don't rush into repairs, no matter how badly they're needed.
- Be careful when using online bulletin boards like craigslist.org. Unlicensed operators may try to mislead you into thinking they are licensed.
- Don't pay more than 10 percent or \$1,000, whichever is less, as a down payment.
- Don't pay in cash, and don't let the payments get ahead of the work.
- Get at least three bids, check references, and get a written
- Contact CSLB if you have a complaint against a contractor.

The Contractors State License Board licenses and regulates California's 300.000 contractors. operating under the umbrella of the California Department of Consumer Affairs.



### Reflections of 2012

During the year Sacramento County completed a number of public improvements aimed to make our roadways safer as well as friendlier for bicyclists and pedestrians. Plus several of these public works projects had the added benefit of making those areas more attractive with enhanced landscaping. Already we are seeing those efforts being complemented by private investment – hopefully a positive sign that our local economy is on a path to recovery for 2013.

#### HWY 50 and Watt Interchange

In November work started to improve the Highway 50 and Watt Avenue interchange which will make it similar to what now exists on Highway 50 at Bradshaw Road, Sunrise Boulevard and Hazel Avenue. The improvements will eliminate the current "need to weave" that makes getting on or off a challenging experience for many motorists. And not only will the project improve traffic flow along the 50 corridor but provide a much need economic boost with construction jobs

- estimated 800 workers over those flanking Palm Drive that two years.

#### Arden Way

Last April Arden Way was improved from Eastern Avenue to Fair Oaks Boulevard by updating pedestrian and bicycle facilities as well as installing street lights and a traffic signal at Mission Avenue. Plus a welcome sign to Carmichael was added at that intersection. Now residents have improved connectivity to shopping centers at both ends of Arden Way.

#### Fair Oaks Village

Progress is being made to improve Old Fair Oaks Village as part of a long-term vision developed by the Fair Oaks Village Enhancement Committee aimed to attract more local and regional visitors to the area. Work started in autumn that included new sidewalks, more parking spaces, a new mid-block crosswalk, installation of landscaping in new planter areas, and improved bicycle access. Decorative street lights are also scheduled to be installed soon. Most importantly -- the construction effort did not interfere with the annual December holiday parade.

#### Carmichael's Main Street

The first phase to improve Fair Oaks Boulevard in Carmichael and turn it into a "main street" was completed last year – and the second phase is now in

once served as the entrance to the Deterding Ranch during the rural days of Carmichael. That effort was hoped to be a catalvst, which seems to be working since private investment led to the development of the new Auto Zone and the relocation of Naroe's Bakery into its new facility nearby.

The second phase for the boulevard will focus on the segment from Landis Avenue to Engle Avenue, which will be funded by a \$4 million grant. Construction for that phase is estimated to begin in 2014.

#### Another Term & Taking the Gavel

Tradition dictates that I will assume the gavel on January 8 and take the position of chair for the Board of Supervisors having served as vice-chair during

### Disaster Averted after Fire at Parisi Insurance

CARMICHAEL, CA - (MPG) A natural disaster can be a crippling blow to a business. A fire, earthquake or flood can leave a business without access to vital information and communication with customers. One of CMIT's long standing clients, Parisi Insurance, is a perfect example of how a disaster does not have to debilitate business.

In the early morning hours of September 24th experienced a disaster. Fire that had broken out two doors down spread and destroyed their office, computers, furniture, paintings, phones and paper files. Without their infrastructure Parisi's business was facing potential standstill.

Instead of a complete business debilitation, CMIT was able to get Parisi's infrastructure hosted remotely allowing them return to business at 2pm the day of fire and have full access to their server by the next morning.

"They (CMIT) ordered and set up the new computers in the new office- as well as the phones- and were instrumental in getting us back to normal" Hart said. "Everyone was wonderful particularly Mark (Trim) and Sal (Hekmatzada) who had to deal with the most whining" quipped Hart.

As for other businesses Hart had a few words of advice "back up your digital data off site, keep as little as you can on paper, and keep your paper data in metal drawers. Also, have your phones default to employee cell phone numbers if there is a break in service." Parisi Insurance has now moved into their new location in Gold River, California and we wish them the best of luck.

### More Residential Fires Over the Holidays

From Sacramento Metropolitan Fire District

CARMICHAEL, CA (MPG) - At 6:40 on the morning of December 2, Metro Fire crews were called to a house on West 2nd Street in Rio Linda for a report of a garage fire with a possible victim. Metro units, arriving three minutes after dispatch, found a garage heavily involved in fire, with extension into the house. Crews began an aggressive fire attack while simultaneously searching for victims and ventilating the structure. No victims were found in the garage or the interior. The fire was contained just seven minutes later. Arson Investigators were on scene and the cause of the fire is undetermined at this point. No firefighters or civilians were injured in the fire.

Just after noon vesterday, Metro Fire responded to the Rancho Cordova Apartments for a report of fire in an apartment. Units arriving to 10685 Coloma Road found heavy smoke and light fire in a garden style apartment complex. The fire, which started in the kitchen of a downstairs unit, had already extended into the common wall of an adjacent apartment and both units had fire activity. Crews worked to contain the fire, focusing on searching for victims while stopping the fire spread to neighboring units.

Six engines, three trucks, one medic and two battalion chiefs were able to quickly contain the main body of fire, but it continued to burn inside the common wall and hidden spaces. Crews performed extensive overhaul to locate and extinguish all concealed fire, protecting residents from any further fire activity.

The fire appears to be accidental in nature, due to unattended cooking. Firefighting efforts saved approximately \$150,000 in personal property. No firefighters or civilians were injured in the fire.

Metro Fire crews have responded to a total of six residential fires since Thursday. In Carmichael alone, a two-alarm fire destroyed 8 apartments on Hackberry, and an exterior fire damaged a house on Sutter. In South Sacramento, a vacant house on Gardner was destroyed early Friday morning while a duplex on Sky Parkway was badly damaged in a fatal fire on Thursday.



#### **RED DAWN** (Rated PG-13)

During the height of the Cold War, at a time when President Ronald Reagan identified the Soviet Union as the "evil empire," director John Milius tapped into the 1980s zeitgeist with the original "Red Dawn."

The 1984 film became a cultclassic that showcased young actors Charlie Sheen, Lea Thompson, C. Thomas Howell, and Jennifer Grey, along with a slightly older Patrick Swayze.

The original premise of "Red Dawn" involved the Soviets invading the United States, followed by the resistance movement that arises when a group of heroic teenagers band together to repel the occupying force.

Fast forward to 2012, and the principal foe is now North Korea, launching a full-scale attack on the Pacific Northwest. You'd think that China would be the more likely invaders, but they are probably waiting to see if we'll repay our national debt first.

The face of the enemy has changed, but the tactics employed by the guerrilla insurgency are pretty much the same. Once again, it's up to a bunch of kids to be the frontling of freedom fighters.

frontline of freedom fighters.

A few minutes pass after the obligatory introduction of the primary teen characters, and "Red Dawn" kicks into high gear with a most unexpected aerial attack of North Korean paratroopers descending on Spokane, Washington.

A murderous, cruel Captain Cho (Will Yun Lee) moves his troops so quickly through town that barely a handful of teens make a getaway to the woods outside town, while most others are rounded up like concentration camp victims.

Jed (Chris Hemsworth), an Iraq War veteran, and Matt (Josh Peck), the high school quarterback, are brothers whose father, Tom Eckert

(Brett Cullen), is a ranking police officer.

The Eckert family has the natural instinct to fight back. As such, Jed, as the result of his military training, becomes the de facto leader of a budding rebel group that includes mostly Matt's high school pals.

As the quarterback of the high school football team, Matt enlists classmates and friends, including Robert (Josh Hutcherson), the tech geek, and Daryl (Connor Cruise), the mayor's son.

Other members of the core group include Danny (Edwin Hodge), the star receiver and Matt's best friend, and Toni (Adrianne Palicki), a pretty girl with a major crush on Jed. Meanwhile, Matt's cheerleader girlfriend Erica (Isabel Lucas) is incarcerated in an internment camp.

As a battle-tested Marine on leave, Jed knows what it takes to live off the land while improvising effective insurgent attacks upon the unsuspecting North Koreans who may be growing complacent after the ease with which they conquered the Pacific Northwest.

Early on, the North Korean invaders prove themselves to be murderous villains, randomly killing civilians for the slightest infractions and generally terrorizing the population into subservience.

Bonding as a team, the rebel youth take on the moniker of "Wolverines," in honor of the football squad. That Jed's younger brother is a hothead results in some complications, considering that he's fixated on liberating his girlfriend from a heavily guarded prison camp.

Nevertheless, the Wolverines gradually become more efficient in carrying out random acts of violence against the symbols of foreign occupation, going so far as to wipe out command posts, patrol unitsss and fortified areas.

"Red Dawn" becomes the fantasy revenge picture it was intended to be. The idea of North Korea successfully invading America is far-fetched, to say the

least, but the audience nonetheless delights in well-orchestrated action sequences that involve plenty of explosions and gunfights.

During the course of the insurgency, the young fighters are joined by a trio of grizzled retired Marines led by the spirited Tanner (Jeffrey Dean Morgan), just in time for a major vital assault on the occupier's main communications center.

"Red Dawn" is solid for its action, which mainly requires the insurgents to take their fight to the streets in a gripping attempt to outwit and overcome the intruders, causing major disruptions with nicely timed explosions and gunfire ambushes.

Notwithstanding the wickedness of the communist enemy, "Red Dawn" seems so implausible that if the lunatic Kim Jong-Il were still alive, even he would probably have a difficult time accepting the premise. But the little creep would be thrilled with the notion.

The bulk of "Red Dawn" is all about the action, thereby becoming the type of contemporary action thriller that is, simply put, satisfying popcorn fare.

#### DVD RELEASE UPDATE

A gangster film that plays more like a Western, "Lawless" captured the brutality of a Prohibition-era battle between moonshiners and corrupt lawmen. Now it's available on DVD and Blu-ray.

Inspired by the biographical novel "The Wettest County in the World," the film version of the adventures of the Bondurant Brothers follows a quest for a piece of the American Dream, albeit an illegal one.

The three brothers (Shia LaBeouf, Tom Hardy and Jason Clarke) fight to maintain their hold on the bootlegging business that is under attack from urban gangsters.

The youngest brother aspires to become Public Enemy No. 1, reaping the benefits that go along with the trappings of a dangerous criminal.

A mysterious woman named Maggie (Jessica Chastain) enters the picture, working in the family business and becoming the girl-friend to the oldest brother.

Living up (or is it down?) to its name, "Lawless" has plenty of brutal violence, with guns blazing aplenty. Special features include "The True Story of the Wettest County in the World."

### How to Get Tax Relief for Inherited Property

There are two issues that one has to deal with when we receive inheritance. The first is an estate tax issue and the second an income tax issue and they are not one. You may be exempt form one but subject to another.

The two usually work against each other. Maybe the mechanics of the events will illustrate the point. Rich Uncle dies and leaves you a piece of land worth three hundred thousand dollars. The first question that people usually ask, or hopefully they will ask is: Am I going to pay estate tax on this money?

Clients that I come in contact with usually ask me how much income tax am I going to pay because I inherited the property. They think that inheriting this property is a taxable event, and a taxable event in their mind means income tax. They don't differentiate between income tax and estate taxes. In 2011 property inherited up to one million dollars would be exempt from income taxes.

Notice that I said that you inherited property worth three hundred thousand dollars. How did you determine this amount? And what is the big deal about this amount anyway? You may determine this amount by looking up the county tax roll for that year or if the amount is large it could be determined by an appraisal.

This amount can cause you a tax problem if you don't pay attention. This amount will be your basis if you sell the property two years form the time you inherited it. Basis is something like your purchase price. You will be regarded as if you purchased the property for three hundred thousand dollars. So if you sell it for three hundred and fifty dollars, your gain is fifty thousand dollars.

When do you value the property? You can value the property the day you inherit it or any other date within six months from the date of death. Why the choice? Like I said the value of the property at the time of inheritance will determine your basis (think of cost).

So the higher the basis the better off you are. In the example above, if your basis at the time of death was three hundred fifty thousand instead of just three hundred your gain on the sale of the property would have been zero. So the higher the basis the better tax relief or tax help you get from the valuation.

Remember when I said above that the estate taxes and the income taxes work in the opposite direction? Now it is time to explain. As I said above to avoid income taxes upon sale property that you inherited you would want to push the value up. The higher you push, the higher the amount it cost you to

purchase the property (I am using the analogy of purchase). And the higher the cost, the less income taxes.

But can we push the price up forever? Not quite. As I said above, you had a limit of exempt estate taxes. If you push the value above the one million to avoid income tax, you will fall into the net of estate taxes. Any amount above the million will be taxed at 55%. So the best tax resolution is one that has to weigh both considerations.

If you find yourself owing back taxes as a result to your inheritance, you may be able to negotiate an IRS settlement such as offer in compromise or an installment agreement. But you must ask your CPA or IRS tax attorney to take some sort of initiative to avoid collection actions such as levy or garnishment against you because of the tax debt.


Summary: The best tax resolu-

tion for inheritance is to balance the estate and income tax consideration. You can even negotiate an offer in compromise for the new tax debt.

According to the Pew Research Center's recently released report, a full one-fifth of Americans are now unattached to religion, and the Protestant majority is no longer that; Protestant Christians now make up less than 50% of the population.

News agencies reported this news as statistical facts with maybe a raised eyebrow of curiosity while some agnostics celebrated the dawn of a new secularism. Meanwhile, fretful pulpiteers wrung their sweaty hands as they thundered to their shrinking congregations about the end of Christianity, threats against morality, and this trend that confirms that the apocalypse is upon us.

The illustrious Garrison Keillor had the cleverest response of all. If the statistics are true, he mused, then it means the death of the some of the world's finest cuisine: The end of church potluck dinners. While some mourned over the condition of souls, he crooned with tongue deeply in cheek, his concern was the future of Lutheran casseroles.

Well, it seems the statistics are correct, and those of us who spend time in the church know it, and know it is no laughing matter. We don't need an exhaustive study to confirm that the church is dwindling. A growing population is indeed unengaged with organized religion. They aren't necessarily atheistic, nor are they antagonistic toward faith.

### Where Love Begins

They are simply uninvolved. Why? Some of it is

demographic, related to the age of our transitioning generations. Some of it is the natural evolvement of a Western society, and the result of an increasingly diverse nation. But frankly, and this cannot be ignored, the church has earned this decline all by its institutional self.

The Pew Report confirms that the religiously unaffiliated think that religious organizations are "too concerned with money and power, too focused on rules, and too involved in politics." As one deeply committed to the Christian faith, I could not more heartily agree; I say, "Amen."

Combine this study with the respected statistics of the Barna Research Group (which is an evangelical think tank), and the situation becomes clearer still. According to Barna, those unaffiliated with religion use several primary words to describe Christianity, words that include: "Anti-gay, judgmental, hypocritical, and insensitive."

I know not every Christian behaves harshly toward others. The most gracious, caring, and welcoming people I have ever met are Christians, fixed firmly within the institution. But I admit that the most obnoxious, hateful, and critical individuals I have ever met are also religious people. This has to change.

"Change," you ask? "Are you saying we should change our beliefs just to salvage our fleeting market share?" No. Market share has nothing to do with it, but how we treat others has everything to do with it. How can we who follow the loving, open-hearted, redemptive Christ be anything but loving, openhearted, and redemptive people?

The longer I do this kind of work, and the longer I see these kinds of recent statistics, the more strongly I feel that the last thing most communities need is just another religious institution: An institution that pounds the pulpit and its parishioners with unyielding dogma; that points fingers, condemns, and excludes others from the love of God; that can never confess its shortcomings, admit when it has been wrong, or meet people where they are rather than demanding that people come to it.

No, communities don't need more hardened, inflexible places like these; but every community needs simple, uncomplicated, receptive places. Every community needs launch pads of empowerment and liberation. Every community needs a communion of friendship, freedom, and faith that will build bridges of grace to the world, not boundaries of separation and marginalization. Simply, every community needs a place of radical hospitality and attraction that welcomes all to know a loving God.

I call these places "church." Yes, I know, some churches are far better at being judgmental religious institutions than being living bodies of service and compassion, but my hope endures. My hope endures because where hardened institutionalism ends, love can begin, and the love of God is the most attractive force in the universe.

# FRESH RECIPES FOR A Holiday Buffet **Set Your Table with Grapes** for Heart Health Grapes may be the perfect finish to a heavy holiday meal high in fat. In a small study of healthy adult males conducted at Ohio State University and supported by the

California Table Grape Commission, grapes consumed along with a high-fat meal helped prevent the reduced blood flow typically observed with a high fat meal. Grape consumption also helped improve the function of blood vessels and increased the presence of antioxidants in the body.

#### **Smoked Salmon Appetizers with Grapes**

Makes 16 appetizers

- 1 cup finely diced red and green seedless California grapes
- tablespoon chopped fresh dill 2 teaspoons rice vinegar
- teaspoon sugar
- Pinch salt
- 4 tablespoons low fat cream cheese
- slices (roughly 3 x 5 inches) Danish-style rye bread, each cut crosswise into 4 pieces
- ounces thinly sliced smoked salmon

In small bowl, combine grapes, dill, vinegar, sugar and salt. Spread cream cheese on bread slices and top with pieces of salmon. Drizzle with the grape relish and serve.

#### **Grape Rosemary Martini**

Makes 1 cocktail

- 2 ounces vodka
- 1 small sprig rosemary, plus additional for garnish 1 ounce freshly made green California grape juice\*

Green California grapes for garnish

Combine vodka, rosemary, fresh grape juice and ice in a cocktail shaker and shake hard. Strain into a martini glass. Thread 1 grape on a rosemary sprig and place in glass. Serve.

\*To make fresh grape juice, puree 1 cup seedless green California grapes in a food processor or blender and strain through a fine sieve. It will make about 1/3 cup.

#### **Pickled Grapes**

Makes 3 pints

- 1 pound green, red or black seedless California grapes, cut into medium size clusters on stem, rinsed
- 1 cup unseasoned rice
- vinegar
- 1 cup sugar
- 1/2 teaspoon kosher salt 1 teaspoon whole black peppercorns
- 1/2 teaspoon whole cloves Large pinch red pepper flakes

Accompaniments

Wedge of Manchego or sharp cheddar cheese Multigrain crackers or toasted baguette slices

For pickled grape clusters: Place grapes in several large clusters into large bowl. Combine the vinegar, sugar, salt, peppercorns, cloves and pepper flakes in a small saucepan and bring to a boil. Stir just until the sugar has dissolved and pour over the grapes. Cover and refrigerate at least 1 hour. Place into serving dish of choice, and serve with the cheese and crackers or bread.

For more intense flavor: Remove grapes from stems. With a sharp paring knife, cut an X in the stem end of each grape. Divide between 3 pint-size canning jars. Make pickling sauce according to directions, then pour over the grapes in each jar. Cover and refrigerate at least one hour.

### For the First Time in My Life God had 100% of My Attention

A true Story: Written by Mike Williams, while homeless at the Salvation Army Shelter.

After taking care of my inlaws with Alzheimer's for six years in my home, losing my home and land to foreclosure, my kids finding my wife with another man, and then losing millions in a money scam, how was I to recover late in life? No matter what I did I couldn't stop

In less than two years my world just crumbled to nothing. I'm still in shock and keep asking God, "Why? I'm a good man, what did I do to anger You

I'm a proud father of three beautiful kids and grandfather to a five year old girl and loved my wife and life to the end. I'm a giver and freely gave to needy families, our church, friends and family. I prayed everyday thanking God for my blessings. I served my country and have never been arrested for anything

As a seasoned educated business man, and a world famous medical / dental technology inventor, I would have never imagined that this kind of loss and destruction could ever happen to me and my family. Looking back on everything now I know that I had no control over the events that put me in the streets. It could happen to

My name is Mike Williams, the second oldest of four kids. I was born in San Diego in 1952 and we moved to Pollock Pines in 1959 after my father was killed in a construction accident. We all lived in a small 32ft. pink trailer and were raised very poor and didn't know it. I loved hunting and fishing and sports of all kinds. I graduated the 8th grade at Pine Wood School and high school in 1971 at El Dorado High in Placerville. It was the best time to be a teenager. All my friends and I loved to go on road trips to the lake or drive-in in my 1955 Chevy listening to Wolf man Jack on the radio.

I was very famous at one time. I'm the guy who invented all the tiny video cameras for dentistry and for viewing inside the heart and body. At one time I was worth millions! As a famous inventor and business man I to use my products. During my travels I saw allot of poverty and started helping the poor and feeding the homeless whenever I could. It was nothing for me to

people and families suffering in the streets.

But the tides have turned. Never in a million years did I think that someday I would be the homeless guy asking for help just like they did. It still seems like a bad dream I can't get out of. When I went homeless I was tired, broke, depressed, and heartbroken from losing my wife, my beautiful ranch and life's work in the blink of an eve.

I learned how to live in my car and survive on food stamps and doing odd jobs for cash that no one else wanted. I learned how to be homeless and asked a lot of questions from other homeless people I met along the way. Living in the streets and camping by the river in a survival mode, I suffered many hardships and got involved in some strange situations because of my innocence as a new homeless person.

To stay occupied when I wasn't looking for work I kept notes on my laptop so someday I could tell everyone my story. I learned that homelessness is an awful life and never understood how dangerous and lonely it could be until it happened to me. I cried allot and gave up many times and even thought about ending it all but I couldn't do that to my kids.

After a while I gave up my car because I was 5 months behind on my payments and didn't need any further troubles. This is when reality really set in! I'm alone with just a few things, scared dirty and weatherworn. I was constantly being moved by the park rangers and police day and night. I never could relax and was always on guard and never imagined how hard this kind of life could be. I was beaten-up and stomped upon at night in the streets many times but somehow made it through day by day.

My last beating wasn't so kind. Late at night in the State Capital Park I was resting under the rose garden fountain where I liked to sleep and smell the roses. On this night I was woken up at about 1 am by two guys kicking me as they tried to take my computer and back pack. I fought as best I could but they stomped me and kicked me in the stomach so many times I passed out. I remember waking up in gut wrenching pain only to find that traveled and lectured all over I had lost everything, even my the world teaching doctors how laptop with all of my notes and pictures of over a year's of work and stories.

I laid there and just broke down for at least an hour. I didn't care anymore and just wanted to give \$1000's of dollars away to die. I kept thinking about my

kids and asking God, "Why are you doing this to me?" In a great deal of pain, and with no help or place to go, I decided to get up and started walking in the dark to check into Sutter Hospital emergency room.

After I got there I went to the window and told the nurse that I was beat up and robbed in the streets and had no medical insurance and was in a lot of pain. She asked me a few questions and gave me some forms to fill and told me to have a seat. After returning the forms I sat down and waited, and waited, and waited to see the doctor.

The nurse was getting upset with me because I kept asking for help, was in severe pain and needed to be seen. I think they we're waiting for me to give-up and just leave! After nineteen hours of waiting I soon realized that I was someone they didn't want to see. But refusing to leave the nurse and doctor finally checked me out and ordered some tests. They discovered that I was really hurt and needed a hernia surgery as soon as possible and after further blood work and tests also discovered that I had walking pneumonia. They had no choice but to admit me. After a full day of waiting and tests I was finally admitted for three days and then released back onto the streets.

I was still very sick and in a the park in midtown. I remember not sleeping for over a week, suffering and I couldn't take it

anymore. I decided to go to the ER at the Mather VA hospital for more help. I was a veteran I had never used any of my VA benefits. During my exam at the ER the Doctor told me that I that I was very sick and needed surgery right away and to go over to the out-patient clinic and ask to see a surgeon, which I did.

As I waited in line holding myself from the pain, the man at the desk finally checked me in and then told me to come back in ninety days. Ninety days? I couldn't believe it! I think I went nuts and started to cry. I had no place to go and not knowing what to do next I decided to sit down to rest and make a new plan. I remember sitting in the corner crying in pain and asking God to forgive me for all of my sins and forgive me for all of my shortcomings. FOR THE FIRST TIME IN MY LIFE GOD HAD 100% OF MY ATTENTION.

As I was sitting and waiting to calm down, an old veteran sitting next to me asked me if I was there to get into a shelter? I said no and asked him why? He told me that he was homeless for over three years and finally got off the streets with help from a VA case worker named Kristine Flowers and she was going to be in all afternoon, but I needed an

I thanked him and told him that I will wait all day to see her praying to God to help me as I waited to see Mrs. Flowers. I

noticed that she had many other people waiting to see her, so I just waited and waited until the end of the day.

I was the last one waiting, so as she was leaving and walking by me I stopped and told her my story and right in the middle of everything she grabbed my hand, sat down and told me not to worry any longer because I she had one more bed at the Salvation Army Shelter available. I started to cry and so did she! Don't tell me that God isn't real... Angels do exist you never know when God uses one to answer your prayers.

I never did get the name of the Veteran who told me about Mrs. Flowers but whoever you are I want to thank you for saving my life. I know now that God asked Mrs. Flowers to step in as part of His miracle to showing me His power. I'm not alone anymore. God is my Father and my best friend who really loves me.

Now let's see why I was saved?

I'm out of the streets now for one hundred days living at the Salvation Army Center of Hope. I finally got my hernia surgery at Mercy Medical center four weeks ago and was starting to feel better only to find out that I had a swollen prostate and needed another surgery.

I wish to thank Dr. Jong Chen for doing my prostate surgery lot of pain and had no place to if need be because I had to get and all of the staff at his office go and just walked and rested in off the streets and get my surger- and Sutter Medical Center for ies or I was going to die. I kept fixing me and loving me when I needed it the most. The laser surgery on my prostate was painless

and successful, I've never felt

More to the story: A few weeks ago Dr. Chen called me at the shelter and asked me out to breakfast. I was surprised and had no idea what was on his mind, and of course I said yes. On the call he told me to bring some of my past work and patents because he wanted to talk to me about something. I told him I would bring everything I had and also wanted him to see my new invention and business plan about a system to house and shelter the homeless.

During the meeting I showed Dr. Chen my most famous patents and we talked about all of the famous doctors I used to work with that he also knew. I think he was surprised and impressed as to my knowledge about engineering everything from lasers to medical scopes and couldn't understand why I was homeless.

As I told him my disaster story I noticed a special look of concern of wanting to help me in his eyes, so with nothing to lose I thought I would show him my plan and ideas. As I started to fill him in, as he was reading my plan I noticed a calm peace filled the room like God was sitting at the table with both of us. I said nothing, and let Dr. Chen read and think! Then he looked up and asked me if he could be involved and partner with me?

I was shocked and lost my breath as I took a slow drink of my coffee. After about a minute of silence I looked at him shook his hand and said YES!


Little did I know that all those days ago when I was being beat up and robbed and left for dead, that it took those events requiring surgery in order for me to meet Dr. Jong Chen. Within a week Dr. Jong Chen and I became partners in a new company called Steps Housing Systems Inc.

On the 10th of October he took me out of the shelter and got me a new place to live down town. By the grace God, and His angels, I'm now the CEO and founder of a new company to build my new homeless sheltering housing survival POD.

Thank you for reading my story. My hope is that I can keep all of you updated as to our mission to shelter and care for the homeless grows. May God bless everyone during this holiday season!




