



# **River Cats Playoff Tickets** on Sale Now

SACRAMENTO REGION Sacramento River Cats 2012 playoff tickets are on sale now, with four-game playoff packs available starting at just \$24. Individual tickets start at \$8 for advance purchases, and are available online.

The River Cats, who currently hold a five-and-a-half game lead over second-place Las Vegas, are seeking their PCL-record sixth-straight division championship and 11th in 13 seasons. If they hold on to win the Pacific Coast League South Division title, the Cats would open the first round of the playoffs at Raley Field on Wednesday, Sept. 5. Game two would be Thursday, Sept. 6, with games three, four and five to be played on the road at the home of the PCL North Division champions.

The two potential home dates for the River Cats in the second round of the playoffs are Tuesday and Wednesday, Sept. 11-12. Fans can purchase fourgame "strips" of tickets to all four potential home playoff games or individual game tickets to select games.

# Accessible Housing Out of Reach for People with Disabilities

SACRAMENTO REGION — People living with disabilities face a significant problem - the lack of affordable, accessible housing. Approximately 54 million Americans have at least one disability, constituting the largest minority group in the nation. And people with disabilities often spend a disproportionate share of their income to secure housing that is both safe and suitably accessible.

Federal guidelines define housing as "affordable" if total costs, including rent/mortgage, utilities, insurance and taxes, don't exceed 30 percent of a renter's or homeowner's household income. Individuals currently eligible for

Supplemental Security Income (SSI) in California receive \$854.40 per month, while couples receive \$1,444.20. Under the 30 percent housing affordability guidelines, an individual living solely on SSI should pay no more than \$256.32 per month for housing and a couple no more than \$433.26. With this in mind, affordable housing is nearly impossible for people with disabilities to find and thousands and thousands of names are on waiting lists throughout the state. "The reality is that most all

of us will experience a disability within our lifetime, which may prompt the need for affordable, accessible housing," said Bob Hand, Executive Director of Resources for Independence, Central Valley. "However, for people with permanent disabilities,

the need is "now" and affordable housing resources simply aren't available." Affordability is just one problem. Accessibility also is a challenge. Several California communities are trying to address the lack of accessibility by, among other things, adopting the state's Universal Design Model Ordinance. The intent of the ordinance is to increase opportunities for persons with temporary, developing or permanent disabilities to "age in place."

"Trying to decipher the maze of information and resources can be overwhelming," said Hand, "and that's where independent living centers (ILCs) come into play. ILCs provide a number of services to people living with disabilities, including educating them about housing options as well as assisting them in negotiating rents and working with landlords. But more needs to be done."

According to experts in the industry, education is the key to making a difference. Individuals need to be made aware of programs and agencies that are working with lenders, housing authorities and service providers in creating innovative housing options, such as "smart-home" technology, within their locale. Experts also believe it's imperative for people with disabilities to talk to elected leaders about their real-life experiences and the need for policies that improve affordability and accessibility.

"We are committed to supporting people living with disabilities in getting their voices heard," said Elsa Quezada, Chair of the California State Independent Living Council. "By providing people with timely and pertinent information, training and education, we can arm them with the tools they need to live independently and not take "no" for an answer."

The California State Independent Living Council is an independent state agency which, in cooperation with the California State Department of Rehabilitation, prepares and monitors the State Plan for Independent Living. SILC solicits continual public feedback on the effectiveness of independent living services and coordinates with similar agencies and councils at the state and federal levels to increase communication and help assure that services to people with disabilities are delivered



# Rancho Cordova Wins 2nd Public Works Award

RANCHO CORDOVA - The White Rock Community Pathway Project in Rancho Cordova has been named the winner of the Project of the Year Award in "The Less than \$100,000 Small Agency Division" by the Sacramento Chapter of the American Public Works Association

The winning pathway connects White Rock and Cordova Towne neighborhoods to Folsom Boulevard, giving residents easy access to public transit and retail shops. "The previous pathway posed safety concerns for both residents and City law enforcement," said Ben Chan, Assistant Engineer for Rancho Cordova.

"The project straightened the pathway alignment so there is now a clear line of sight and a better view of the entire pathway."

In addition, the path was resurfaced and wrought iron fencing,

landscaping, and a French drain were installed. "The wrought iron fence is very effective in preventing graffiti markings," said Chan.

The pathway project was funded with Community Development

Block Grant program funds that are provided by the U.S. Department of Housing and Urban Development. This is the second 2012 APWA award that the City of Rancho Cordova has received.

Last week, the City received notice that its International Bridge project was named the Sacramento Chapter's APWA Transportation Project of the Year. It will now be the Chapter's entry in the national APWA competition.

"We are honored and pleased that two of our projects have been recognized by our peers," said Cyrus Abhar, Rancho Cordova's Public Works Director. City Council Members and City staff will accept the awards next week at an Awards Luncheon. Twenty-four California counties are members of the Sacramento Chapter APWA.







Several years ago, on the courthouse steps of the town in which I lived, there was a rally. A homosexual couple in our community was seeking to become foster parents. You can imagine the kickback that erupted in a small Southern town.

But it wasn't just the members of our community who were most vocal in protest. Gathered on the courthouse steps of our fair city were representatives of a religious group from Washington D.C. and points beyond, to speak out in holy fury.

I strolled up the street to check it out, and what I found there was horrifying. Laced with scripture quotations and shaking the abysmally familiar "God Hates Fags" signs, speaker after speaker raged with some of the most vicious and hateful words I have ever heard. I could not believe how angry and poisonous it was.

One of the police officers watching over the proceedings walked up and asked me, "What do think about this, preacher?" I knew this officer. He was a good man but did not consider himself a Christian. So, I turned his question around and asked him what he thought about it. He answered, "This is why you all ought to keep your church and Bible to yourself."

# Hating the Haters

Dorothy Sayers was fond of saving that Jesus endured three great humiliations: The Incarnation, the cross, and the church. Jesus has subjected himself to a spastic, debilitated, malfunctioning body; a body called the church. And rather than communicating clearly the love and grace of God, we obscure and twist the message so that it cannot be heard correctly.

That is what I felt most strongly as I stood near the court house steps on that afternoon. These people, exercising their freedom of speech for which I am so very thankful and for which I would go to the wall, were attaching hateful words and spiteful talk to the name of Christ. Somehow, in the convulsive twisting of the body of Jesus, the message was twisted. I felt ashamed.

The following Sunday I fumed from my own church pulpit about how we are called to love our neighbor as ourselves – even the people we just positively know that God condemns. Love your neighbor with a love that goes beyond feeding their dog or keeping an eye on their home while they are out of town. No, to love your neighbor as you love yourself, I rightfully said that Sunday, is to love whoever you come across, whoever is in need, no matter who they are.

If they live across the street or on another continent; if they are black or white; if they are straight or gay; if they are Latino or Anglo; if they are of my political persuasion or not; if they are Christian or Muslim; if they are my buddy on the bar stool beside

me or someone I would never shake hands with, they are my neighbor. As a follower of Christ my responsibility is to love them and not condemn.

Oh, it was a virtuous, unfettered, holy tirade; and I felt so very good after it was delivered. But over the course of the next few days all my good feelings ebbed away. These feelings were replaced by genuine conviction of heart.

I realized that what had made me feel so "good," and what eventually disturbed me about myself was this: I hated the people who were hateful. I did not love them – as my neighbors – instead, I loved condemning them. My actions were nothing more than a variation of the words and behavior I found so repugnant.

Street preachers railed against and hated homosexuals, abortionists, teenagers with tattoos and piercings, and the like. In my righteous indignation, I fumed against and condemned them. We were all wrong.

Opinions, conviction, beliefs: We all have them and we all have the freedom to express them. But the moment our beliefs are used as motivation and means to hate others, we have left the path of Christ who taught us that the greatest commandment is to





# Murder is More Permanent Than Life Without Parole

#### SB 9 Bill Would Allow Prison Release For Juvenile Murderers

derided the content of Senate Bill 9 (Yee), which passed from the Senate Floor August 20, 2012 despite bipartisan opposition. If signed by Governor Brown, the bill will allow individuals who have been convicted of special circumstance murder committed as a juvenile, and who have been sentenced to life with without parole (LWOP), to petition the court for a resentencing of "25 years to life," potentially resulting in the release of convicted murders.

"Life without the possibility of parole for minors was implemented by the voters in 1990 by Proposition 115," said LaMalfa. "Californians have been clear and decisive in their intent to implement justice of murderers. This measure not only subverts the electorate, but it undermines public safety."

LaMalfa emphasized that current law does provide several

SACRAMENTO - Senator protections for any juvenile that the devolution of penalties. At the requirement that an offender must be older than 16 at the time of the crime. Additionally, the prosecuting attorney would have to proactively choose to pursue the sentencing given the special circumstances. "Not only does a juvenile have to meet a variety of requirements to be eligible for LWOP, but the jury must unanimously agree that the defendant was guilty of a particularly heinous crime and the judge must concur that the severity of the crime warrants the absence of an opportunity for parole," explained LaMalfa. "Life without parole is a fitting

punishment for some special circumstance crimes. In fact, just a few years ago, some of these offenders would have qualified for capital punishment. Life without parole was supposed to be the more humane option in lieu of the death penalty, and now we are seeing

Doug LaMalfa (R – Richvale) is eligible for LWOP, including this rate, I am concerned about where public safety—or should I say the lack of public safety will be within a few short years."

The Senator concluded: "We spent a lot of time talking about compassion for the person convicted and sentenced to life without parole, and how the permanency of their sentence will cause that person to lead a life of hopelessness. Think about it: the victim does not get to enjoy a life of hope. And the victim's family does not have any reason to hope for the victim. We're not talking about misbehavior; we're talking about murder, and correct me if I am wrong, but murder is more permanent than life without parole."

A recent case of interest

CASE: Marquise Smith (08/20/12)

**PROSECUTOR: Deputy District Attorney Andrew Smith** 

District Attorney Jan Scully announced today that Marquise Smith was convicted by jury of second degree murder with the use of a handgun for the shooting death of Danielle Benefield.

Ms. Benefield was a passenger in a car that had gone to the Fastrip gas station after leaving a downtown club on September 4, 2010. Upon arriving at the Fastrip, her friend exited the car and entered into the crowd. Ms. Benefield got into the driver's seat and moved the car to the slow lane on Florin Road where she and her other friend waited for their friend to return.

During this time, Smith was being chased in his car as he drove back to the Fastrip. He made a U-turn off of Florin Road back into the Fastrip parking lot. He exited his car and went into the crowd. When he saw the victim's car now parked on Florin Road with the car running, he mistakenly believed it belonged to those that had chased him. Smith yelled out "Do you have a problem?" then fired four shots into the car. Ms. Benefield was killed by a bullet that traveled through the passenger car door and driver seat, hitting her in the back and heart.

Smith told detectives that he was across the street at the Shell station wearing different clothes and driving a different car than witnesses described as belonging to the shooter. While testifying, he admitted being at the Fastrip when the shots were fired and lying about his clothes and car.

Although there were more than 100 people at the Fastrip, no witnesses could identify the shooter. The jury was able to use inconsistent statements from Smith's friends and Smith's own statements and testimony to reach the conclusion that he was the shooter that night.

Smith faces a possible maximum sentence of 40 years to life in prison. Sentencing is set for September 14, 2012 at 9:30 a.m. in Department 30 before the Honorable Judge DeAlba.

Suppose that Aaron was seriously injured in a car accident due to the negligence of Gehrig. Aaron hires an attorney and the case goes to trial. In the first stage, a jury determines the degree of Gehrig's liability whether it was 100% or some lesser number. Once liability was decided, the damages that Gehrig (or his insurance company) would have to pay Aaron would be determined in a second stage. In legal terms, Aaron's trial is "bifurcated" - split into two parts, so that liability is determined separately from the calculation of damages.

"Damages" is money paid to an injured person as compensation for loss or injury. The purpose of damages, at least in theory, is to place the victim in the same position he or she would have been in had the injury not occurred. While no amount of money can restore, say, a healthy person who was rendered paraplegic in a car accident, an award of money can "compensate" and help the victim deal with harsh realities. Compensatory damages usually are calculated in three categories: medical and related expenses, lost earnings and earnings capacity, and pain and suffering (to compensate the victim for physical and psychic pain, humiliation, and anguish caused by the injury).

As you might imagine, calculating the amount of damages can be considerably more complex than determining whether the defendant was at fault for causing the injuries in the first place. Damage awards are the proverbial blend of art and science. Professor Joseph Glannon, of Suffolk University Law School in Boston, has created hypothetical cases that teach the intricacies of damage awards.

For example, Professor Glannon presents the imaginary case of Mendel, a 25-year-old construction worker who is injured in a traffic accident and suffers a concussion. He has to decide whether the jury will

minimal medical expenses, but testifies that he developed tinnitus, or ringing in the ears, due to the accident. Although tinnitus is a recognized medical condition, it is nearly impossible to corroborate by independent medical tests. The diagnosis is totally dependent on the testimony of the person suffering with the condition.

Mendel testifies that he is constantly plagued by tinnitus, and that it has made him jumpy and nervous. He says he often feels that he is going insane due to the ringing in his ears. He continues to work in construction, but the condition interferes with his ability to read or concentrate and interrupts his sleep, so he is always tired.

Assume that the other driver is found liable and that medical costs and lost earnings are less than \$1,000. The defendant's insurance company offers \$35,000 to settle Mendel's case. If you represented Mendel, would you advise him to accept the offer?

Remember that if you refuse the settlement offer, you will have to go before a jury to seek an award of damages. The jury could award something less than \$35,000, or something a great deal more. There is simply no way to know in advance.

Professor Glannon asked his law school students what they would award Mendel if they served on the jury. The answers ranged from \$20,000 to over half a million dollars. Some students reached their awards by calculating a sum for each minute, hour or day that Mendel had to live with tinnitus. One student gave Mendel two cents per minute; another awarded \$10,000 per year; a third gave Mendel a dollar per hour. Given Mendel's life expectancy, the time-based awards by these student-jurors were in the \$300,000 to \$500,000 range.

As Mendel's lawyer, you have

believe your client. Since the symptoms of tinnitus cannot be proven by objective measures - such as blood tests, X-rays or brain scans – Mendel's testimony will be the crucial factor. If the jurors conclude that he is sincere, they will probably award more than \$35,000. If they think he is making up the injury, they may award him very little, despite the fact that the other driver has already been found negligent.

Veteran personal injury lawyers have a keen sense of what an injury is "worth." It may sound cold-hearted, but a good Plaintiff's attorney must make an educated guess about the economic valuation of a client's injuries. The attorney's estimate will be based on similar recent verdicts, the credibility and circumstances of the Plaintiff, and the juror pool from which the jury will be drawn. That said, even experienced attorneys are surprised from time to time by what a jury awards (or denies) an injured person.

Remember, if the jury's damage award seems excessive, the defense still has the option of appealing the award and seeking a reduction. That's what happened in the notorious "hot coffee" case, where a jury awarded a McDonald's customer \$640,000 for being burned by coffee. McDonald's appealed the award, and ultimately the parties settled out of court for a sum that was kept confidential, but was reported to be less than \$600,000.

# What can NASA's Curiosity Rover Tell Us **About the Future of Health?**

My cousin Tracy is our family's token rocket scientist. (Doesn't everyone have at least one in his or her family?). She's so smart that you can tell it's an effort for her to explain, in terms the rest of us can understand, exactly what it is she does at NASA's Jet Propulsion Laboratory (JPL). When she does, my standard response - "Wow!" - can either mean, "Wow, I can't believe you know so much" or "Wow, I have

no idea what you just said." Suffice it to say, Tracy is a happy camper these days. For the past two years she's been working on the Curiosity Rover project and finally saw her efforts come to full fruition last Monday when this Mini Cooper-sized mobile laboratory touched down on the surface of Mars. (For a mindblowing account of what the last 7-minutes of Curiosity's 8 1/2month, 352 million-mile journey looked like, check out this video from JPL)

Compare this achievement

to a project my dad worked on some sixty years ago: A space capsule that took monkeys into outer space – the precursor to the Mercury, Gemini, and Apollo programs that eventually put men on the moon. Had you asked anyone back then if they thought there'd ever come a time when we'd be landing hi-tech dune buggies on Mars, their answer might have been anything from "You gotta be nuts" to "I don't see why not."

Knowing Dad, it probably would have been the latter.

I always admired Dad's ability to think outside of the box, beyond present perceptions and more towards future possibilities. But what does it take to make the leap from, in this case, monkeys to Mars? Is it better technology? Or better thinking?

Obviously new technology doesn't just magically appear on the scene. The thinking always precedes the thing. This applies, of course, to every human endeavor and not just space exploration.

Take for instance health care.

Had someone told you 50 or even 10 years ago that the simple act of being honest might have an impact on your health, would you have believed them? Probably not, and yet that's exactly what University of Notre Dame's Dr. Anita Kelly asserts in a paper presented just last week to the American Psychological Association. Dr. Kelly found that those who participated in her study "could purposefully and dramatically reduce their everyday lies, and that in turn was associated with significantly improved health."

The idea that the quality of one's thought can have an impact on the quality of their health extends well beyond honesty to include other health-inducing attitudes such as gratitude, generosity, compassion, and love.

The interesting thing is, unlike our ability to land a sophisticated piece of machinery on Mars, the connection between consciousness and health has been around for a very long time, although perhaps not as widely understood or practiced as it is today. After all, wasn't it Moses who first implored the Children of Israel to be honest; that is, to "not tell lies about others" (Exodus 20:6)? Who knew that what he was saying to those thousands of people wandering around in the desert some 3000 years ago was as much prescription as it was proscription?

Although no one can say for sure what the future holds - either for space exploration or health care – there does appear to be one constant: Better thinking always begets better things - better science, better technology, and better ways of caring for our health. With this in mind, the future looks very bright indeed.

# Little known Veterans Administration Benefit is Lifesaver for Local Family Struggling with Long-term Care Costs

In early 2011, Marianne Discovering The Aid Thomas of Fair Oaks found herself in a difficult situation trying to manage her father's care. A strong and independent war vet who took great pride in living alone, dad's health was rapidly declining, making it hard for him to keep up around the house.

Recognizing her father was struggling to perform tasks of daily living such as self-care, medication management and food preparation, Thomas asked her dad about bringing in an agency for in-home care or moving to assisted living.

Thomas says dad refused out of fear he'd have to sell his home and start blowing through the savings that he worked so hard to leave behind for his kids and grand-

Torn between getting her dad the help he needed and letting her father age with dignity, Thomas began cutting back her work schedule to provide much of the handson assistance herself.

"Dad didn't realize the financial hit I was taking, but it was important to me that he felt comfortable and dignified in his last years," she explains. "In my own time, I began to look for options to support our family as we worked through dad's disability," she said.

& Attendance Benefit

It was during this search that Thomas came across a flyer to attend a workshop hosted by local elder law attorney, Heather Chubb on VA benefits. The workshop focused on Aid & Attendance, a benefit for wartime veterans (or their surviving spouses) to cover the costs of longterm care.

"I had no idea such a benefit even existed," recalled Thomas. "I always considered the VA and VA hospitals as a last resort for when we could no longer meet dad's needs here at home," she says.

#### What is Aid & Attendance?

This special VA pension awards up to \$24,238.00 per vear in tax-free income for veterans and their spouses struggling to perform tasks of daily living such as bathing, toileting, dressing, meal preparation, shopping, feeding and managing medication.

No service-connected disability is necessary to qualify, but attorney Chubb notes that there are income and asset restrictions to collect the full benefit. She warns that families should "not disqualify themselves though," because the VA takes into account medical expenses and additional planning that is approved by the VA.

#### Financial Relief for Dad

After attending Chubb's workshop on VA benefits, Marianne Thomas felt relieved to finally have the information to get her father the help he needed without having to spend his entire life savings. She immediately started planning and within 6 months her father began receiving his benefit checks.

"The best part about these benefits is that the VA allows you to pay a family member if you don't want to hire outside help. Dad asked me to continue handling his care, so this benefit allows me to leave work and do that," says Thomas.


