### Area Waterways Expecting Big Crowds

SACRAMENTO REGION – The California Department of Boating and Waterway's urges boaters to be properly prepared for safe boating this Memorial Day weekend. California's waterways will be crowded with motorized and non-motorized vessels. People will boat in groups creating numerous distractions, which can have deadly consequences.

"Boating during Memorial Day weekend means being a more responsible boat operator," said DBW's acting Director Lucia Becerra. "Operators may have people on board their vessels who do not normally boat. Familiarizing passengers with the location of safety equipment and how to be safe aboard will decrease the likelihood of being involved in a boating accident."

Here are some suggestions



Boat Safely this Memorial Day Weekend. Follow some simple rules and inform your guests before leaving the dock.

from the DBW for boat operators to decrease the chances of being involved in a boating accident: 1) Always wear a life jacket. 2) Avoid alcohol. Everyone who drinks alcohol on board is at risk. Passengers can easily fall overboard, swim near the propeller, or cause vessels to capsize. 3) Designate a person aboard the

vessel to help you act as a lookout. 4) Carry the required safety equipment such as fire extinguishers, sound signals, navigation lights, and life jackets for every person on board.

Boat operators should inform everyone on board where the required safety equipment is located. Operators should also turn off the engine when the boat is not moving to avoid propeller injuries.

### Pothole Sweeps Week Starts up

SACRAMENTO COUNTY The Sacramento County Department of Transportation (SACDOT) has started up 2012 "Pothole Sweeps Week", which is an intensified effort to identify and repair potholes. This project is part of continuous efforts to improve preventative maintenance activities for unincorporated area roadways. Pothole sweeps are performed twice each year: In late Spring to repair potholes caused by inclement weather, and in Fall to ready road surfaces for the storm season..

This County-wide effort will begin in the Arden Arcade community, which is the center of our service area, and continue through the remainder of the unincorporated areas.

Work crews began inspecting streets and fixing potholes on May 21st. Residents are encouraged to contact SACDOT concerning potholes on neighborhood streets. Pothole locations can be called into Customer Service at 916-875-5171, or emailed to www.sacdot. com: Report a Problem.

There are over 5,200 lane miles of paved roadways in the County unincorporated area and it's inevitable that somewhere in this large area of streets there will be potholes. SACDOT's policy is to: "Repair all potholes as soon as possible." The Pothole Sweeps Week program enhances ongoing pavement maintenance activities, which include SACDOT crews who are sent into the field Monday through Friday each week to specifically repair potholes.

### Rancho Cordova Has Role in Chinese Documentary

filmed a documentary about the
City of Rancho Cordova. The
documentary series will be aired
throughout China to show better
management and government in
action. Shown on China's main
television station, the series will
be seen by more than a billion
people.
"We hope government offi-

cials and our citizens can learn different ways of social management after seeing our program," said Xumin Hu, who coordinated the project. Hu continued that America's "unique system of governance, distinctive legal system, and the wide-held respect for the law throughout the country are products of the unique/distinctive history of the United States."

During their three-day stay in Rancho Cordovo, the crew filmed various City buildings, including the Police Station and Cordova High School, and the big May Is Bike Month bicycle ride and American River parkway activities. The five-member TV crew followed staff members throughout their workday and then filmed the Rancho Cordova City Council meeting.

The Chinese crew chose Rancho Cordova because "City Manager Ted Gaebler has shown us a great number of vivid case studies in the book he co-authored, 'Reinventing Government'. We know Ted has done successful government reforms in various cities," said Hu.

"Reinventing Government", written in 1992, is often described as the best book ever written on government reform strategies and is proof that government does not have to be a gigantic and inefficient bureaucracy. The crew said the book is very popular in China.

While in Sacramento region, the Chinese crew also filmed footage at the California Department of Water Resources. Other American places they will visit and film include the White House; the U.S. Capital building; the Supreme Court; several businesses; including Merck Company and Johnson and Johnson; and other communities and agencies.

#### Primary Election

California's Presidential June Primary will be held on Election Day, Tuesday, June 5. Polls open 7 a.m. until 8 p.m.

All area voters can go online to confirm that they are registered by visiting the Sacramento County Elections Office's web site at elections.saccounty.net. The web site also allows you to find your polling place or you can call 875-6451 for more information.

Registered voters also may apply for a vote-by-mail ballot with May 29 being the deadline. More information including an application is available on the Elections Office's web site.

#### Alcohol Ban keeps Parkway Family Friendly

This Memorial Day weekend there will be a complete ban on alcohol consumption and pos-

session both on land and in the

Parkway between Hazel and Watt avenues. An exception exists for Ancil Hoffman Golf Course.

In past years holiday weekends were major problems along the river because of fights, public nudity, profanity and littering fueled by excessive alcohol consumption. The Board of Supervisors restored decorum by implementing the ban starting on Labor Day weekend 2006 which is also applicable for the holiday weekends of Independence Day as well as Memorial Day.

Since the restriction has taken effect, families I have talked to have expressed appreciation for making these holiday weekends once again a time for everyone to enjoy the American River.

#### Reserve Park Ranger Program

Sacramento County Regional Parks is creating its first volunteer Ranger Reserve program to support the current Ranger Patrol system. The Reserve rangers would be sworn officers capable of performing all ranger duties, working with a Ranger or independently.

Participants will either be entry level candidates looking to start a career in law enforcement or journey level officers who are still active with other law enforcement agencies or who have retired. The Reserve Rangers undergo the same training and background investigation as regular Rangers, must be graduates of a full police academy, and will complete the full field training requirements. They will be required to perform a minimum of 15 hours of service per month to maintain their status as a Reserve Ranger. Since Park Rangers are accredited Peace Officers, they will also be required to fulfill the Peace

> The Reserve Ranger program is part of a coordinated effort to maintain patrol services in the Park system, build partnerships with other law enforcement agencies such as the cities of Sacramento and Rancho Cordova, and deploy Ranger Assistants to most effectively support the Rangers.





### Sacramento Choral Society's Year-end Concert Celebrates their Debut at Fremont Presbyterian Church

Following their amazing English Grandeur celebration on April 14th at the Sacramento Community Center Theater, the SCSO and Conductor Donald Kendrick are now thrilled to be making their debut in Fremont Presbyterian Church's recently renovated sanctuary on Saturday, June 2 at 8 PM.

The concert entitled European Traditions is part of the Sacramento Choral Society's Stained Glass series that started originally in 2009 at the Cathedral of the Blessed Sacrament in Sacramento. "What a thrill it is for us to discover this amazing space and take full advantage of Fremont's acoustics and the recently installed powerful new Reuter pipe organ," says Kendrick. "Fremont has done a royal job on its renovation and the pipe organ is one of the largest in Northern California. This concert is a fitting way to end our 16th season of offering classical music concerts for families in our

The group's performance will highlight a variety of musical styles through the ages with works sung in Latin, German and English.

composers that will surely demonstrate the power and the versatility of Fremont's gleaming new pipe organ. 



#### **Sacramento County DA Reports**

Recent cases of interest

CASE: Sylvester Griffin (05/18/12)

PROSECUTOR: Deputy District Attorney Hilary Bagley Franzoia

District Attorney Jan Scully announced today that Sylvester Griffin was sentenced by the Honorable Greta Curtis Fall to life in prison without the possibility of parole. Last month, Griffin was convicted by jury of murder, rape, and first degree burglary in the 2009 killing of 64-year-old Alice Lynn Murphy.

Alice Murphy lived alone in a senior apartment complex in Folsom. Griffin was a driver for a medical transport company and had a client that lived in the same complex. In December 2009, Murphy was found dead in her apartment by a friend. She had been raped and smothered to death.

DNA evidence was collected at the crime scene. A match was found in the FBI's DNA database, and the Folsom Police Department was notified of Griffin's identity. The Sacramento County District Attorney's Crime Lab confirmed the match that linked Griffin to the crime scene.

CASE: Willie Weaver (05/16/12)

PROSECUTOR: Deputy District Attorney Aaron Miller, Vehicle Theft Unit

District Attorney Jan Scully announced today that Willie Weaver was convicted by jury of carjacking and possession of a firearm by a convicted felon.

On April 14, 2011, Weaver exited the light rail train at the Florin Road station and walked to a nearby Walgreens. Shortly after he arrived at Walgreens, the victim pulled her car into a parking space in front of the store. Weaver approached her on foot and demanded her car keys. A short struggle ensued before Weaver forced the victim's keys from her hand, pushed her to the ground, and drove off with her car.

A few hours later, officers located her car parked in the area of North C and Ahern Street. Inside the car was a bag that Weaver was wearing over his shoulder during the carjacking. The bag contained a sawed-off shotgun and clothing matching the description of clothing worn by the carjacker. The District Attorney's Crime Lab conducted DNA testing on a beanie and a jacket found inside the bag. A match in the national DNA database of criminal offenders (CODIS) identified Weaver as the suspect. He was also identified by two witnesses using still photos captured from light rail surveillance footage.

Sentencing is set for June 15, 2012 at 3:00 p.m. in Department 33 in front of the Honorable Lloyd G.

#### CASE: Jimmy Phi Nguyen & Alan Sayareh (05/10/12) PROSECUTOR: Deputy District Attorney Doug Whaley

Sacramento County District Attorney Jan Scully announced today that charges have been filed against 1 Ozone Smog technicians Jimmy Phi Nguyen and Alan Sayareh. Both defendants are charged with felony conspiracy to provide false information to DMV, and four counts of providing false information to DMV. Nguyen has an additional eight charges of reporting false information on DMV documents.

Investigators from the Department of Consumer Affairs' Bureau of Automotive Repair found that vehicles were illegally passed on smog check inspections at the 1 Ozone Smog station on Power Inn Road where Nguyen was employed. Surveillance showed the defendants utilizing their own vehicles to perform smog certifications on different vehicles. A search warrant was served at the 1 Ozone Smog Shop today, and among the items seized were the smog testing equipment known as an Emission Inspection Machine, and vehicles used in the commission of the offenses.

The records from smog tests are sent directly via the smog testing computer to DMV, which DMV relies on to issue vehicle registrations. The defendant's scheme allowed vehicles that could not pass emissions testing to be registered illegally. Bail for each defendant was set by the court at \$50,000. Arraignment is scheduled for May 14, 2012 at 8:30 a.m. in Department 62.

### **Property Assessed Clean Energy (PACE) Program**

The City Council of the City of Rancho Cordova in a unanimous decision approved the California Property Assessed Clean Energy (California PACE) Program at a regular city council meeting on April 16, 2012. The California PACE Program will provide special assessment financing for energy efficiency and water conservation projects installed on commercial properties.

The City has authorized the California Economic Development Authority (CEDA) to establish the assessment district on the City's behalf, and provide the complete administration of the program through CEDA's program administrator, Figtree Energy Resource Company (FIGtree), and its resource efficiency consulting ws/commercial-services.php).

FIGtree provides PACE administration for local cities and counties throughout California. The establishment of the Commercial PACE Program allows the City to offer the California PACE financing to property owners within the City limits.

The access to PACE financing provides much needed financing capital to commercial property owners while providing an opportunity to reduce energy operating costs and conserve water. The property owners repay the special assessments annually through a voluntary special assessment on their property tax bill. This property based financing provides long-term, fixed rate financing generally



Our graduates are being shortchanged. The workplace they are entering is the most challenging it has been in decades. By comparison, the workplace those who are responsible for education policy, funding, administration and delivery entered, was a piece of cake. These people have no affinity whatever with the challenges today's graduates are facing.

Tom Friedman, the bestselling author and New York Times

columnist met recently with Prem Kalra, the director of the new Indian Institute of Technology in Rajasthan. He told Friedman that he tells recruiters for major companies to stay away from his campus. He wants his Indian students to think about inventing their first jobs, not applying for them.

That's exactly what we should be doing. Instead, our colleges and universities keep turning out graduates who expect that someone is going to offer them a job and when that doesn't happen, many end up unemployed or in low paying jobs in the service sector. The fundamental challenge is that for generations we have been turning out employees. Now, increasingly, we have to turn out entrepreneurs or graduates who have an enterprising approach to finding work.

The area of career/employment counseling needs a complete overhaul with an objective of meeting the needs of today's graduates. A Canadian graduate who sought help summed up her experience by saying that "I decided I really didn't want to speak to the nice lady who had been doing that job for the last twenty years."

Our graduates need access to people who are experienced in today's workplace and who can show them how to market themselves effectively to employers and how to create their own jobs as freelancers, consultants, or small business owners. Showing graduates how to succeed in today's workplace should be an integral part of their education, not an option as it currently is. And we need more resources in this area.

Graduates can't wait for the education system to enter the twenty-first century; they need to take charge of their own success. And, with a little bit of help, they're absolutely capable of doing that.



I have heard some Mennonites use the term "non-violent evangelism." It is a way of sharing faith that does not harm those with whom they share. It is built on mutual respect, love for others, and a commitment to the other person's freedom. People are treated as seekers, not potential converts, without pressure, arm-twisting or coercion; and no manipulation of words or emotions.

Seekers are not vilified, targeted, pursued, or argued with. They are simply invited into radical hospitality where questions and exploration are not only tolerated, but encouraged and expected. These non-violent evangelists share their faith with a "come and see" attitude, opening their arms and hearts to others, leaving the rest to God.

The church could learn a lot from these quiet souls. Many of us, overtly and subtly, have taken a very militant approach in sharing our faith with others. We corner people. We demand immediate decisions. We use emotionally charged environments to wrangle decisions. We are sometimes disrespectful. We say, "Follow Christ and we will let you in." But maybe we need to learn to say, "Come on in, and learn what it means to follow Christ."

### You Are Welcome

Here is an example: My friend Sabrina, and her husband Blake, live in a Christian community on a working farm. By "Christian community" I mean a group of people who are attempting to live out the way of Jesus while sharing life, space, and the same values. It's not a commune -Sabrina, Blake and the other two dozen folks living there are definite individuals - it is a community: A group of people helping the world and welcoming others.

Welcome, in fact, is what brought Sabrina to the farm. She wasn't a Christian when she arrived. Actually, she was rather hostile toward faith. But she loved the earth, she was trying to stay sober, and she and Blake wanted to give self-sustaining, organic farming a try while they were still young enough to pull

Through a series of inexplicable events, but mostly because of the dramatic welcome others at the farm gave them, this couple found themselves moving out of the city and into the cornfields. Sabrina was going to farm with gusto, but she had no intention of getting involved with what she called, "the Jesus stuff." And her co-farmers respected that.

But one day, after being surrounded by all this grace and love, and having begun to pray again and study the way of Jesus, she woke up in half panic, in half celebration, and all surprise: "Oh, my God, I think I'm a Christian!" It was a beautiful conversion; one made possible by giving plenty of margin, not plenty of manipulation.

Maybe it is because I

hang around with too many Mennonites now, because I long ago defied my own coercive religious upbringing, or because of precious people like Sabrina, but I have come to the core conclusion that we need to give people some space. Should we share and live our faith? Absolutely! But I believe every person is capable

In the words of that old Baptist from Oklahoma, Herschel Hobbs: "The Church cannot fasten its iron grip upon anyone's soul...This is the worst of all tyrannies. And it is made worse by its claim to be in the name of God who created men and women to be free."

of relating directly to God with-

out coercion or interference by

Thus, every person should be given the right of free choice in his or her relationship with God (or without God). Every individual should be given the dignity as image-bearing creations of God to arrive at their own spiritual conclusions, choosing to be Catholic or Coptic, a Methodist or a Muslim, a Buddhist or a Baptist, a Jew or a Jainist, an Anglican or an atheist, without heavy-handedness of any kind.

No, not everyone will "convert" to our way of thinking or adopt our ideas about faith. But faith isn't about force; it is about being set free. God entrusted people with that freedom. Let's do the same.

He didn't know what he was doing when he committed all those crimes. He begged them. He said, "Please just give him to me. Let me have him. I'll train him. I'll help him make something of his life."

Strangely enough, the United Nations granted this man's unbelievable request. He took the

murderer of his own son into his own home and raised him and loved him and cared for him. To make a long story short, that young communist gave his heart to the Lord. Today, that former communist murderer is a pastor of a church in another nation. Love never fails.

I challenge you again to let your life overflow with God's love and God's mercy. Life is too short to get caught up in petty differences or bound up in bitterness and grudges. Give people the benefit of the doubt. Give them a little room to be the person God's called them to be. Nobody's perfect. Overlook their faults and be quick to see the best in everybody. Be quick to show God's mercy because we know we're going to need it one day. My prayer today is that all of us from this day forth will make up our minds and determine in our hearts that we are going to live a life of mercy and unconditional love.

A Film Review by Tim Riley

#### THE DICTATOR (Rated R)

The appeal of the offbeat personality of supreme prankster Sacha Baron Cohen may be an acquired taste. He was an absolute idiot in "Borat" and then again in "Bruno."

Now he's the moronic tyrant of the fictional North African country of Wadiya in "The Dictator." Cohen was likely inspired by similar roles played to the hilt by Charlie Chaplin and Groucho

Though Cohen has the unique ability to sink deeply into character as the despotic Admiral General Haffaz Aladeen, he's no match, in the end, for Groucho's autocrat Rufus T. Firefly.

To the uninitiated, it should be observed that a Sacha Baron Cohen comedy, whether entirely scripted or mostly ad-libbed, wallows in the crude, vulgar and scatological. "The Dictator" is no exception to this tested formula.

In his home country, Aladeen rules supreme from an ornate palace that makes Saddam Hussein's former mansion look like a nondescript tract home in a drab San Fernando Valley neighborhood.

Aladeen's reign of terror grips Wadiya in a perpetual state of fear. The slightest indiscretion will result in the immediate execution of an otherwise prudent, obedient citizen.

The dictator amuses himself by entertaining visiting Hollywood royalty, leading to one-night stands that are memorialized with Polaroid snapshots. Megan Fox is only the latest palace conquest.

WILL COMIC "DICTATOR" SINK "BATTLESHIP" OR VICE VERSA?

The basic story is deceptively simple and almost coherent. On a diplomatic mission to the U.N., Aladeen is betrayed by his uncle (Ben Kingsley), an heir to the Wadiyan throne.

Shorn of his flowing beard and regal clothes, Aladeen is soon adrift on the streets of New York, winding up as the counterman at a vegan grocery store run by the ditzy organic zealot Zoey (Anna Faris).

The clueless Zoey thinks that Aladeen's politically incorrect quips are misguided and possibly harmless, but Cohen's brutal comedy is most effective when his insults exploit a wide range of prejudices.

That "The Dictator" is dedicated to the loving memory of North Korean tyrant and certified nutcase Kim Jong Il is an indication of where Cohen seeks to take his satire.

#### **BATTLESHIP** (Rated PG-13)

Based on a Hasbro board game, "Battleship" offers few surprises, none of which is more astonishing than the fact this spectacle of explosive action is directed by Peter Berg instead of Michael Bay.

What we get is "Transformers" on steroids, which should be satisfying enough for the undiscriminating aficionados of the action adventure film fueled by the overconsumption of popcorn.

The nominal hero of this action flick is Taylor Kitsch, suddenly infamous for the unfortunate clunker that was the extravagant "John Carter."

This time around we are first introduced to Kitsch's Alex Hopper as a hotheaded slacker who desperately seeks to impress a hot blond in a Hawaiian dive bar by securing a chicken burrito from a closed convenience store.

Alex's brother Stone (Alexander Skarsgard), a Navy captain, has grown weary of his sibling's antics and demands his enlistment into the Navy.

I don't remember how time flies by, but suddenly Alex is a Navy lieutenant whose quick temper often gets the better of his judgment.

But now he's engaged to the blonde beauty (Brooklyn Decker), who just happens to be the daughter of the blunt, testy Admiral Crane (Liam Neeson).

Meanwhile, a crew of computer nerds is hunkered down at a communications center in the hills above Honolulu where they send out signals into outer space.

A reply to their messages arrives suddenly in the form of large metal objects that crash into the ocean, waiting ominously for Lieutenant Alex and his crew to show up to investigate.

The aliens are apparently not looking for Reese's Pieces. They're hostile and ready to decimate the Earth. Perhaps the long trip to our planet made them extremely irritable.

Thus begins a prolonged battle that consists of plenty of explosions. Oh, I forgot to mention that the Japanese navy has joined ours for exercises in the Hawaiian seas.

The best thing about the international flavor is that Tadanobu Asano's visiting Captain Nagata is a better actor than most of the American crew, bringing some much-needed gravitas to a grave situation.

For his part, Liam Neeson is great at barking some orders and putting down an oblivious Secretary of Defense. Sadly, though, he's mostly underutilized. "Battleship" is loud, noisy and

frantic. Most of all it is an assault on common sense and reality. Thus, it almost makes "Pearl Harbor" look good, the operative word here being "almost."

Unfortunately, the film is full of glaring errors and missteps, of which the most egregious is when a battleship is taken out of mothballs from the Pearl Harbor museum and just happens to be loaded with live weapons ready for action.



### ACHIEVE YOUR WILD GOALS

Do you have some wild goals you dream about, and never told anyone? You probably think you can never achieve them, so why try? How would you like the map to get there in four steps? Sean Covey, along with co-authors Chris McChesney and Jim Huling, have put together "The 4 Disciplines of Execution" to change your behavior and achieve your wildly important goals. I had Chris on my POPPOFF Radio Show and he led me through these disciplines. So put aside your old ideas and get ready for some new ones. Here is the capsulated version right from their book.

1) Focus on the Wildly Important. Basically, the more you try to do, the less you actually accomplish. This is a stark, inescapable principle that we all live with. Somewhere along the way, most leaders forget this. Why? Because smart, ambitious leaders don't want to do less, they want to do more, even when they know better. Isn't it really difficult for you to say no to a good idea, much less a great one? And yet, there will always be more good ideas than you and your

teams have the capacity to execute. So, Discipline 1 requires you to start by selecting one, or at the most, two extremely important goals, instead of trying to significantly improve everything all at once. Failure to achieve it will make every other accomplishment seem secondary, or possibly even inconsequential.

2) Act on the Lead Measures. This is the discipline of leverage. It's based on the simple principle that all actions are not created equal. Whatever strategy you're pursuing, your progress and success will be based on two kinds of measures: lag and lead. Lag measures are the tracking measurements of the wildly important goal, and they are usually the ones you spend most of your time praying over. Revenue, profit, and market share are all lag measures, meaning when you receive them, the performance that drove them is already in the past. Lead measures are quite different in that they are the measures of the most highimpact things you must do to reach the goal. Once you have identified your lead measures, they become the key leverage points for achieving your goal.

3) Keep a compelling Scoreboard. People play differently when they're keeping score. This is the discipline of engagement. In principle, the highest level of performance always comes from people who are emotionally engaged and the highest level of engagement comes from knowing the score...that is, if people know whether they are winning or losing. And you must know the scoreboard. If the scoreboard isn't clear, the game you want people to play will be abandoned in the whirlwind of other activities.

4) Create A Cadence of Accountability. This is where execution really happens. The first 3 disciplines set up the game, but number four is based on the principle of accountability: that unless we consistently hold each other accountable, the goal naturally disintegrates in the whirlwind. The secret to Discipline 4, in addition to repeated cadence, is that members create their own commitments. Because they make their own commitments, their ownership of them increases.

This is a very condensed version of what "The 4 Disciplines of Execution" is all about. The good thing is when I asked Chris if this works for team participation or for single achievement, he told me absolutely for both. 



how important it is to come up with his own conclusions and that life itself will teach him whether he is right or wrong or somewhere in between. He also hears that what might


disagree, I always let him know



A Case in Point

### The Case of the **Unlucky Driver**

There's a tug-of-war in society between technology, which changes rapidly and constantly, and the law, which changes gradually and infrequently. Technologies such as cell phones or "tweeting" alter the social patterns of everyday life. The law struggles to catch up and stay relevant.

That's brings us to the story of Carl Nelson, the unlucky driver.

Mr. Nelson was driving his car in the city of Richmond, California on the morning of December 28, 2009. He stopped at a red light and decided, like many of us, to make use of the waiting time. Mr. Nelson opened his "flip-style" cell phone and began dialing to check email.

At this precise moment, a police officer pulled up on a motorcycle directly next to the driver-side door. The officer saw Mr. Nelson holding a cell phone to his ear and dialing. Mr. Nelson looked over, saw the police officer, removed the cell phone from his ear and closed it. We don't know Mr. Nelson's thoughts at this point, but they probably consisted of a two-word expression beginning with "Oh."

When the light turned green and Mr. Nelson drove through the intersection, the officer pulled him over and ticketed him for using a cell phone while driving. In traffic court, the ticket was upheld and a fine of \$103 was levied.

Most people would have given up and paid the \$103. Mr. Nelson, however, was sufficiently disturbed that he retained a law firm and appealed. The California Appellate Court, First District, agreed to hear the case.

Mr. Nelson's lawyer made an interesting argument. He acknowledged Vehicle Code, Section 2313(a), which says, "A person shall not drive a motor vehicle while using a wireless telephone unless that telephone is specifically designed to allow hands-free listening and talking..."

That's the key, argued the lawyer. Mr. Nelson wasn't driving a motor vehicle. He was stopped at a red light and posed no risk to anyone. To quote the legal lingo: "The term 'drive' requires evidence of volitional movement of the motor vehicle as an element of the offense."

To use a cell phone while stationary was no more hazardous than various other things people do while waiting for a light to change - putting on makeup, eating a messy sandwich, reading a map, or changing radio stations, according to the argument.

The lawyer cited a 1991 decision, Mercer v. Department of Motor Vehicles. Police found a man asleep over the wheel of a car that was legally parked at the curb. The car had its lights on and engine running. The defendant was fined for driving under the influence – but on appeal the fine was overturned. Yes, Mercer was drunk; however, when police observed him, he wasn't driving. He was legally parked and asleep.

That gets us back to the Nelson case. When the Court announced its decision, it turned out that Mr. Nelson's luck hadn't improved. He lost again.

"Driving" a car, said the decision, meant the same as "operating" a car. The court cited various cited California laws that used the words "drive" and "operate" interchangeably.

The drunk driver in Mercer was in a different situation. Mercer wasn't going anywhere, nor was he about to. However, drivers at a red light are still "operating" a car, and could pose a hazard if distracted – by their feet letting up on the brakes, for example, or by failing to promptly move as required by the traffic laws.

If Mr. Nelson wanted to use a cell phone at a red light, the Court concluded, he should install a hands-free wireless system and be in compliance with the law.

My guess is that California will have more litigation like this. What if I am stuck in dense traffic and call home to alert my family? What if I am in line at the McDonald's drive-thru and use the time to check email or call the office? Technology and law are destined to continue skirmishing in the courtroom.




