# Job Trends Spell Layoffs Sacramento Works Unveils a New Identity

Hiring trends in the Sacramento Region continue to be influenced by Wall Street fluctuations and the depressed national economy.

Sacramento Region - While Sacramento's top employers are hiring, they continue to show extreme caution as events outside the area raise concerns about the economy. Like the up and down bouncing of the children's toy, extreme fluctuations on Wall Street and in the greater world economy are impacting hiring trends revealed by Pacific Staffing for October, November and December. Polled directly by phone sixty-two percent (62%) of Sacramento's top companies say they will hire in the Fourth Quarter, but forty-two percent (42%) of planned hiring was motivated only by the need for replacements. These levels mirror a straight line, or

flat trend from third quarter numbers continuing to reflect caution in hiring for expansion by employers.

On the flip side, some industries are improving and thirty percent (30%) of hiring was also cited for growth needs, which is a slight improvement from the third quarter when twenty-five percent (25%) of hiring was motivated by planned expansion. Service industry companies were discovered to be most active in hiring during the Fourth Quarter.

Ten percent (10%) of companies say they planned to layoff workers in the next three months. Half those reductions, or 5% are motivated by seasonal change. The remaining reductions caused by acquisitions and slowing business demand according to employers surveyed between 8/29 -9/23/2011.

Employers continue to say benefits costs and management are their biggest struggle. A new challenge was noted, as some companies report finding qualified applicants is becoming an issue. Specific skills in high demand are technical including software design and digital networking, with biology lab science, allied health skills, sales and customer service workers in demand.

When asked if their company had a page on the social network, Facebook, fifty-four percent (54%)

of Sacramento's top companies said, 'Yes'. Twenty-four percent (24%) admitted to looking at job applicants social network posts in hiring, while twenty-nine percent (29%) say they are spending part of their budget on social networks, through marketing or human resource departments.

Of the top 100 Sacramento Regional Companies 38% are Service, 37% are Manufacturers, 16% are Construction and 9% are Retail.

### **Gas Still More Than Last Year**

Sacramento Region - "Motorists are certainly delighted that average gasoline prices are at their lowest since early March, but compared to prices a year ago, motorists are still feeling a pinch at the pump," said Patrick DeHaan, GasBuddy.com Senior Petroleum Analyst. "It's great to see gasoline prices falling, but at the same time, prices a year ago were nearly 75 cents less per gallon. The good news is that over the upcoming weeks, there will continue to be factors that could put more downward

pressure on oil and gasoline prices. I continue to expect that average gasoline prices will bounce between \$3.25-\$3.50 for much of the rest of

2011," DeHaan adds. Average retail gasoline prices in Sacramento have fallen 4.9 cents per gallon in the past week, averaging \$3.75/g yesterday. This compares with the national average that has fallen 5.9 cents per gallon in the last week to \$3.46/g, according to gasoline price website SactoGasPrices.com.

## **SMUD Breaks Ground for East Campus Operations Center**

Construction project brings 300 new jobs to area and earns top green building award

The Sacramento Municipal Utility District (SMUD) officially started construction on the nation's first field operations center to earn the U.S. Green Building Council's top honors - the Leadership in Energy and Environmental Design (LEED) Platinum certification. The project will also be the second "net zero" undertaking in North America.

By incorporating the latest energy efficiency features as well as some tried and true technologies, the energy consumption of the 51-acre campus will be greatly minimized. The net zero designation will come from incorporating technologies such as a 5-acre geothermal heat pump system and a 1.1 megawatt tracking photovoltaic system allowing the campus to generate as much power on the site as it consumes. The project also brings 300 much needed

This multi-year construction project will include offices, equipment repair shops, maintenance and warehouse buildings, storage space and parking for fleet vehicles and employees. Upon completion of the project in late 2013 approximately 750 employees will move to the facility.

Environmental benefits from the design features included in the construction project translate into an annual savings of over 3.7 million kilowatt-hours in electricity or enough electricity to power 413 homes. The project design also delivers a reduction of 3.2 million

# County Faces Issues with Growth Strategy

Sacramento Region – Sacramento County has been updating its growth-management plan for the unincorporated area as part of the General Plan. This Plan, which directs future development, is required by law and should be complete by the end of 2011.

There were many issues involved with arriving at a new growth strategy, and careful attention was paid to balancing the requests of community members, environmentalists and developers. The growth strategy underwent several changes as the building boom ceased and the County had to address state laws that required lower carbon emissions (AB 32) and encouraged mass transit (SB 375). Multiple public meetings were held to fully understand all the interests and arrive at the new strategy that would best meet everyone's needs.

At this time, the new Plan does not call for expanding the urban growth area, which is the area designated for urban development to occur. However, once the General Plan is adopted, landowners may submit

applications to expand the area, but only if the proposed new growth meets certain criteria.

Under the proposed Plan, the re-

quirements that projects would have to meet include: • The property has to be next to exist-

ing urban areas.

 Development must be near transit and employment or provide new transit and employment as part of the

# Aerojet Claims it is Committed to the Future Success of Rancho Cordova

Rancho Cordova - They came. They spoke. And they are hopping mad.

Citizens of Rancho Cordova spoke out Monday evening, September 19, 2011, at the city council meeting about GenCorp's (Aerojet) request to change the zip code to a Folsom zip code in an unincorporated area of their city.

The area at the center of the controversy is south of Folsom Blvd., west of Prairie City Road and east of Hazel Ave., slated as the Easton development, a large retail and residential community to be developed in the future.

All of this land was allotted to Rancho Cordova in 1980 by Sacramento County, according to Rancho Cordova Mayor Robert McGarvey, speaking the afternoon before the meeting, and although the 1,400 acres of land in question is not entitled yet, it does have a Rancho Cordova zip code.

"My first impression is that this

Also at issue is the fact that tax monies in this area will go to Sacramento County, and all police and fire, library, and park services will also belong to Rancho Cordova. Sheriff Department Captain Doug Diamond told the council that this will be "confusing" for residents living in the Easton area as they would be inclined to call Folsom for life saving services.

Meantime, Wallace Morgan, another speaker, said that he felt betrayed and that the people of this All America City are due an apology.

Julie Pierce said that she backs the city council's position of this "theft". And Sheryl Longsworth spoke of GenCorp's greed and how "GenCorp only wants what is good for GenCorp."

At the meeting, people discussed similarities to Gold River's decline to be incorporated and to the Granite Bay had a more desirable area and therefore, received their own zip code.

**Customer Relations Coordinator** for Sacramento Post Offices Ralph Petty said that at this time, there is a review in place and that they are receiving information from both Folsom and Rancho Cordova cities and residents. He indicated that they are 15 to 30 days into the process, and that a decision may not be ready for six months.

Meantime, Tim Murphy, Gencorp's spokesman, said that he believed the citizens of Rancho Cordova are misinformed. He explained that the boundary of Rancho Cordova city limits stops at Hazel and does not extend eastward. While this land does have a Rancho Cordova zip code, he explained that this does not mean the land belongs to Rancho Cordova, and GenCorp is letting the post office decide which facility is better equipped to handle the mail as part of the long term

not used to define city boundaries," he said.

This emotional battle waged by the city is not necessary," he said. "For Rancho Cordova (officials) to say that they have claim to this land is inconsiderate. We consider ourselves a part of Rancho Cordova, Folsom and Sacramento County We are very much committed to the future successes of Rancho Cordova."

He went on to add that GenCorp views themselves as partners with Rancho Cordova. "This is unin-corporated land," Murphy said. He explained that GenCorp added 4,000 acres of land within Rancho Cordova for future projects such as Rio Del Oro and Westborough, two future developments.

"We would like for the city council to step back and look at what Aerojet has done with the city and recognize that we want to partner with them." Murphy said.





Fair Oaks - A new Centurion lives right here in Fair Oaks and she is the proud matriarch of four generations.

Jocelyn "Billie" Cross turned 100 on Sept. 11 and had a birthday bash where she resides at Embracing Arms Care Home. The celebration continues to this day.

"I get cards and calls every day," she said.

Born in St. Louis, MO., Billie and her husband, Charles "Warren" Cross, moved to the Sacramento area in 1942. Her 62 year marriage resulted in two daughters, Marion Silva of Fair Oaks and Carolyn Schilling of Sacramento. Her husband worked as a civil engineer for the federal government while Cross was a homemaker. Warren died in 1994. Silva said that Billie was a

good wife and mother while working at their 5 acre walnut orchard, which was her dad's hobby. The girls had horses on the property.

Over their years together, Billie and Warren did quite a bit of traveling to places such as Europe, China, Mexico and Cambodia in the early 1960s before Viet Nam. Silva, now 72, married in 1962 and has two sons, now 44 and 46-yearsold. Silva's sons have a combined 3 boys and 2 girls, ages 2 and a half to 10-years-old. Schilling raised a lot of animals, as animals have always been a large part of this family.

Billie was an avid bridge card player in her day. Silva said that at her peak, she was in five bridge clubs. She started playing cards in the 1940s. She doesn't play any more because most of her friends are deceased and younger people play by different rules, Billie said.

Meantime, Billie said she does not feel any different being 100years-old. "Millions of people don't get to be this old," she said. "Sometimes I realize it's quite old, but I don't feel any different," she



CASE: James Carlton (9/30/11)

PROSECUTOR: Deputy District Attorney Shelly McGill

District Attorney Jan Scully announced that James Carlton was convicted by jury on multiple counts of child molestation, sexual assault, harassment, as well as a multiple victim allegation, and one prison prior.

Carlton victimized his longtime girlfriend's 10 year-old niece on several occasions. The abuse came to light after he assaulted the niece and a 12 year-old neighbor in the same evening. Another niece of the girlfriend then reported she too had been victimized by Carlton years ago at age 9 until she was 13 years old.

Carlton faces a sentence of approximately 120 years to life in prison. Sentencing is set for October 28, 2011 at 9:00 a.m. in Department 28 in front of the Honorable Judge Oros.

District Attorney Jan Scully announced that 50-year-old Linda Marie Wells of Sacramento was sentenced by the Honorable Gary Ransom to 2 years in prison after pleading no contest to grand theft charges

Wells was employed as an office manager by Norwood and Associates, a lobbying firm. From 2004 through August 2010, Wells increased her salary by more than \$95,000. Wells used the company credit card and made close to \$40,000 in personal charges and transferred close to \$75,000 from Norwood and Associates bank accounts into her own account and to one of her friend's account. The total amount taken by Wells was

John Norwood, the owner, hired an auditor to check his firms' finances. The auditor made a comment to Norwood about how well he paid his office manager. This led to the discovery of Well's embezzlement.

CASE: Gary Vue & Chong Vue (9/29/11)

PROSECUTOR: Deputy District Attorney Eric Kindall

District Attorney Jan Scully announced today that on September 23, Gary Vue was convicted by jury for the first degree murder of California Department of Corrections and Rehabilitation Officer Steve Lo. The jury also found true the special circumstance allegations that the murder was committed by lying in wait, and that Gary Vue personally and intentionally discharged a firearm in the commission of the offense.

Today, Chong Vue was also convicted by jury for the first degree murder of Lo. The jury also found true the special circumstance allegation that the murder was committed by lying in wait.

Both defendants are facing a sentence of life in prison without the possibility of parole. Sentencing for both defendants is set for October 14, 2011 at 9:00 a.m. in Department 21 before the Honorable Steve White.

CASE: Luis Hurtado (9/26/11)

PROSECUTOR: Deputy District Attorney Jeff Harry

District Attorney Jan Scully announced that Luis Hurtado was convicted by jury on all counts of first degree attempted murder and inflicting corporal injury on his spouse resulting in a traumatic condition, and aggravated mayhem. The jury also found true all allegations of inflicting great bodily injury involving domestic violence, and use of a deadly weapon.

Hurtado and his victim wife had been separated for four years. In December 2010, Hurtado was visiting his six year-old daughter at his wife's apartment. While at the apartment, he began to accuse the victim of having a sexual relationship with another man. The victim told Hurtado to leave her apartment, but he refused. She then called 911 and reported that her husband was drunk and would not leave her residence. While she was speaking with the 911 dispatcher, Hurtado crept up behind her with a knife. He pulled her hair back, exposing her neck, and repeatedly slashed her neck and face. The victim sustained a deep laceration from just below her right lip all the way back to her right ear, requiring 60 stitches.

Hurtado faces a sentence of life in prison. He will be eligible for parole in 13 years. Sentencing is set for October 28, 2011 at 10:00 a.m. in Department 25 in front of the Honorable Kevin McCormick.

CASE: Robert Precobb (9/23/11)

**PROSECUTOR: Deputy District Attorney Keith Hill** 

District Attorney Jan Scully announced today that 56 year-old Robert Precobb was sentenced by the Honorable Greta Curtis Fall to 125 years to life after being found guilty last month on all counts of child molestation with a prior felony conviction, and providing marijuana to minors.

Precobb has multiple prior convictions of child molest dating back to 1978. Following a 1988 conviction, Precobb was sentenced to serve 15 years to life. He was granted an early release from prison on February 26, 2010. In just one week, he lured a 14 year-old boy to his motel room by plying him with drugs and alcohol, where he then had the victim remove his shirt and asked him a series of sexually suggestive questions.

Through the course of the investigation, sheriff's detectives discovered a number of additional victims that Precobb had provided with drugs and alcohol in an attempt to bring them back to his motel room.

## Mesa Verde High School Threats

- Mesa Citrus Heights Verde High School is presently experiencing threats to students' safety as the school and neighboring Carriage Elementary School were put on lock down on Friday, Sept. 30 while both schools were evacuated Monday, October 3, 2011 due to a bomb scare.

Friday's threat was that someone had a gun on campus. School officials notified all parents of

the incident by phone and the lockdown lasted for approximately two hours while Citrus Heights Police Officers thoroughly searched the school. According to Public Information Officer for the Citrus Heights Police Dept. Jon Kempf, they determined the call on Friday was a hoax and they arrested two students. They are not releasing any information about the students at this time.

Monday's bomb threat required

the assistance of the Sacramento County Sheriff's Dept. Canine Unit. Kempf said that the dogs sniffed the buildings and did not locate any explosives.

"We made an arrest for a hoax on Friday," he said. "We are not saying that the incidents are related but we are investigating them separately.'

The San Juan Unified School District office was contacted, but was not available for comment.

## **SMUD Reaps Savings Through Refinancing**



Generally speaking, people don't like to change. People feel like things ought to stay just the way they are. We work so hard to get things nice and neat and perfect. Don't we? And then here comes change! One of my challenges is to be able to celebrate change with people who don't seem so happy about changing.

In the world of materiality, the only consistency is change. Nothing in the material universe is permanent. I would venture to say that most of people's problems stem from their resistance to change.

However, most people don't resist what we label as, "good change". People resist what they call "bad change". A bad change is usually something that is outside of our comfort zone or sphere of influence. It's something that we feel uneasy with and that we avoid. For most people, death is at the top of the list of so called, "bad change".

When there is "bad change", there is some fear and pain involved and usually in that order. To continue with the example of death, the sudden interruption of the way things are causes some people an immediate shock to their system and a sense of panic. In fact, most people avoid the subject at all, feeling that speaking of it will bring it about.

What should perhaps be the most logical thing to accept about life is our own mortality. Just as autumn follows the summer, so does death

follow life. Thus, what we must conclude from this is that change is good. Pain is an indicator that we are alive and that there is yet opportunity for growth.

#### "Pain as a Pathway"

If life is a dynamic exchange of give and receive, live and die, up and down, joy and pain, to struggle with the notion is to struggle with the entire universe, because our refusal to accept the way things are is more than a personal challenge. It becomes a futile attempt at changing what requires no change.

What does, however, need adjusting is our perception of how things are, especially for those things that we interpret as negative or bad.

Many people learn the best when they have experienced pain. Yet, the price for the lesson is either physical or emotional discomfort. Most of us remember the age-old admonishment, "don't touch the hot stove". For some, it is not until they touch it themselves that they learn not to do so.

In short, in life we will experience pain and discomfort. Embrace them and let it make you solid as oak. When you and I want to build muscle in our bodies, it requires that we exert more physical exercise and strain on our bodies than usual. However, what we discover is that in order to build up the muscle, we have to tear it down so that it may be completely transformed. And boy, aren't we in pain when this happens? However, this pain ultimately leads to an energetic, muscular, and fit body.

Remind yourself of this when it seems that the pain that you are experiencing is permanent. Pain is a temporal pathway into greater life

To embrace your experience of change or pain is to recognize that this experience has come to teach you, test you and eventually bless you.

#### "Complaining and Crying"

Some people feel that to complain is an effective means for bringing about positive change in their lives and in the world. To complain is to express pain, uneasiness and resentment. Complaining withdraws power from a person because he is using his power to convince someone else of his victimhood and for his need to receive justice that only he can secure for himself, by not being a victim

Complaining and whining deteriorates your power. It also deteriorates the power of others with whom you interact and it works against your very body-your physical body as well as the body of your affairs.

There's a difference between "complaining about something" and "standing up for something". When you are standing up for a cause, you are presenting an organized plan for its resolve. You are providing alternatives for what you presently oppose and you are taking "right now" action to secure your vision.

For example, recently I took a trip to Venezuela to support my friend during a very critical election as they sought to bring about a more democratic country. There is great discontent in Venezuela and the people are desperate for a new day. However, people were not making idle complaints and whining about the sad state of affairs. Instead, about a million and a half of us were in the streets marching, making our dissatisfaction known, but presenting an alternative form of government than the current administration.

More powerful than a complaint - we made a statement. We took a stand. This is an example of how to express your dissatisfaction proactively and make the best use of your power at the same time.

Have you ever felt like everthing was going against you?

You lose your job, the car breaks down, your toilet doesn't flush, you get sick, all at the same time! One of my favorite stories in the Old Testament is found in 2 Chronicles chapter 20. The background of this story is that there were three enemies of the nation of Israel. They decided to all get together and

gang up on the little nation of Israel. If you've ever felt like things were ganging up on you, this is a good chapter for you to read. From this chapter we learn some principles about what to do when the odds are against you.

Turn to God in prayer. The very first thing you need to do when you face a major problem is get still and tune into God. "God, what's Your perspective on this problem? How do You see it? What's Your point of view? How do You look at the situation?" You begin to pray about the

problem; you seek Him.

Focus on God, not the problem. The problem with many people is that they focus on their circumstances rather than the Lord. That gets them down. You ask somebody, "How are you doing?" They say, "I'm good, under the circumstances." What are you doing under tress. You get on top and you rest easy. You get under them and you suffocate. Do you need a miracle? Focus on your Deliverer not your difficulty. I'm not saying you deny the problem. No. You defy the problem. Nothing's too difficult for the

Relax in faith. "You will not have to fight in this battle. Take up your positions. Stand firm and see the deliverance the Lord will give you." vs. 17. Has God ever lost a battle? No! God never loses. He's got 100% success rate. He bats 1000. He never loses. I've learned from personal experience that it is never God's will for me to fret over a difficult situation. Why? Because God wants to teach me that there's no problem too difficult for Him.

Thank God in advance for the victory. As they went into battle

they put the choir out in front of the army. When you start praising God in your situation, in the midst of the problem, thanking God that He's going to take care of it, you're going to see some incredible things take place. Anybody can thank God after the victory. Faith is praising God in advance, that the odds will be overcome, that the solution will arrive, the miracle will take place.

The Bible says that as the Israelites praised God in advance, somehow these three armies got confused and started fighting each other and knocked each other off. There was victory.

Do you need a miracle? Some of you really do. Everything seems to be ganging up on you. The odds are against you and you're in need of a miracle. What do you do? Seek the Lord, stay focused on Him, not your circumstances, relax in faith, knowing that He loves you, knowing that the battle is not yours but His. Finally, you praise Him. You thank Him in advance for victory, because the battle is the Lord's! And you will see the victory.

**MONEYBALL** (Rated PG-13)

You don't have to love baseball to enjoy the captivating story, the great dialogue and the well-developed characters in "Moneyball," though it likely helps.

Baseball purists may object to certain liberties taken with factual accounts of the Oakland Athletics 2002 season. But that's of no con-

The film is based on Michael Lewis'nonfictionbook"Moneyball: The Art of Winning an Unfair Game," which extolled cash-poor Oakland's ability to compete with rich, big-market teams.

In certain respects, "Moneyball" is a Cinderella story set on a nicely trimmed field of dreams, except that baseball fans know that Oakland hasn't won a World Series since the showdown with the Giants during the 1989 earthquake.

The story of hope is fueled by Oakland's General Manager Billy Beane (Brad Pitt), a free thinker not constrained by the conventional wisdom of baseball.

After the witnessing the failure of his team to beat the Yankees in a 2001 playoff series, Beane takes it upon himself to develop new strategies.

Prior to the start of the 2002 season, on a trip to visit his counterpart at the Cleveland Indians to discuss trade options, Beane meets nerdy young assistant Peter Brand (Jonah Hill).

Beane is impressed by Brand's mastery of numbers and a method of statistical analysis known as sabermetrics to determine which players are undervalued.

With Oakland's inability to keep star players like Jason Giambi, Johnny Damon and Jason Isringhausen, Beane realizes he must approach the game from a

different angle.

Some of the film's most amusing dialogue occurs when Beane introduces Brand to a roomful of grizzled, aging scouts who only value gut feelings and information about the players' personal lives to judge their baseball potential.

The Yale-educated Brand, with a degree in economics, is dismissed out-of-hand by the old-timers when he suggests that on-base and slugging percentages are determinative of a player's ultimate performance.

The early stages of the baseball season are not very promising, starting with an effort to convert ailing catcher Scott Hatteberg (Chris Pratt) into a first baseman.

Even if you can't root for the Athletics, the true baseball fan will ache when the team struggles to get its footing, falling behind in its

However, you can root for Billy Beane and his young protégé as they cope with the doubters in their own organization, including the grizzled manager Art Howe (a superbly crusty Philip Seymour Hoffman) who despises the mathdriven method of playing ball.

For a movie about baseball, most of the action takes place off the field. Primarily, it's about the brilliant dialogue and attempts for Beane to find redemption.

"Moneyball" is, at its core, focused on Beane's checkered history with the game and his desire to fulfill a dream that eluded him during his playing career.

Flashbacks to Beane's youth, when he was scouted by the New York Mets, tell a story of a young man's wish to excel at the game even though he was wrongly overvalued as a potential player.

That Beane did not rise to the level of expectations that were held for his career as a player is a motivation for his yearning to manage his way into a contender.

Never fear that talk about statistics and players' skills dulls the

story into a dreadful morass that could only entertain the devotees of statistician Bill James.

Dealing with the intransigence of his team manager Art Howe, Beane is nonetheless confident in his approach. Part of the fun is watching him maneuver around the game's dinosaurs.

Any sports movie requires the feel-good moments that define the genre. That comes with the incredible game-winning streak late in the 2002 season, when the Athletics set the AL record for winning 20 straight.

Winning is not the only thing, though. The story also triumphs when Beane finds washed-up or undervalued players who surprise the baseball world by their forgotten talent.

Another terrific aspect to "Moneyball" is the pleasing relationship that Beane, a divorced father, has with his young daughter Casey (Kerris Dorsey).

In baseball parlance, "Moneyball" hits a grand slam, the highest score you can obtain in one at-bat. Not just a great baseball movie, this is a winner for story, character and dialogue - all things that should matter.





**Expert Answers to Common DMV Questions**

Do you have questions about general driving related requirements like registration and insurance?

Are you unclear about laws and restrictions related to driving?

The California Department of Motor Vehicles has answers.

Q: I live in Nevada and frequently travel by car to California on business. Do the new text messaging and cell phone laws apply to me as well?

A: These laws apply to anyone driving in California, even if the driver is just visiting. In order to prevent cell phone related collisions both laws prohibit drivers from using electronic wireless communication devices to write, send or read text-based messages; motorists are required to use a hands-free device when talking on their cell phone while driving. The base fine for the first offense is \$20 and \$50 for subsequent convictions. However, with the addition of penalty assessments, the total amount can be more than triple the base fine.

Q: I am applying to become a commercial truck driver. What

documents do I need to bring with me to the DMV?

A: Good question. The following link contains all the required documents, forms and prerequisites toward obtaining a commercial driver license: http://dmv.ca.gov/ commercial/commercial.htm.

However, remember to save an extra trip to the DMV and make sure to bring your valid Social Security Card, because this is one of the most commonly forgotten items on application day. Save Time. Go Online!

Q: My daughter is 16 and just received her driver license last week. She wants to drive her best friend, who is also 16, to school. Is it ok if she receives a letter of approval from her friend's parents?

A: No. Even with the permission of a parent, your daughter may not drive with anyone under the age of 20 unless a licensed driver over 25 is in the vehicle. She also may not drive between the hours of 11 p.m. and 5 a.m. without a licensed

driver over 25. These restrictions are in place for the first 12 months your daughter is licensed.

The DMV website has a section dedicated to new drivers and their parents with more details on new driver restrictions. To view the page, visit www.DMV. ca.gov, and under the Home tab, click Teens. I encourage you to visit the page to learn about the provisions your daughter will have to follow over the next year. Save Time. Go Online!

The DMV is a department under the Business, Transportation and Housing Agency, which is under the direction of Acting Undersecretary Traci Stevens. The DMV licenses drivers, maintains driving records, registers and tracks official ownership of vehicles and vessels, investigates auto and identity-related fraud, and licenses car dealers, driving schools, and traffic violator schools. ### Who Are Those Guys?

Who are those guys who showed up to play in the second half Sunday in Philadelphia?

The self-anointed "Dream Team," the Philadelphia Eagles, were caught from behind, 24-23, by the San Francisco 49ers posse despite a 23-3 head start. The brains, coach Andy Reid, and the gunslinger, quarterback Michael Vick, must have asked each other the old Butch Cassidy and the Sundance Kid question, "Who are those guys?"

That sure didn't look like the same old quarterback Alex Smith the majority of 49ers fans have been wanting to run out of town for the last few years.

Dressed in red and white with gold helmets - not white skimmers and cowboy hats — the second-half Niners kept gaining ground on the Eagles. Led by relentless tracker Lord Baltimore (alias Alex Smith) and hard core lawman Joe LeFors (alias coach Jim Harbaugh) the 49ers maintained hot pursuit. With support from the other members of the Niners' Smiths Gang — DE Justin Smith and rookie LB Aldon Smith — the visitors caught and passed the Eagles with three minutes remaining in the game.

The Niners (3-1) rode their old horse RB Frank Gore down the stretch, despite his gimpy ankle. Gore (15 carries for 127 yards) ran 12 yards for the winning touchdown and had key runs to help kill the game clock. He had lots of help from rookie Kendall Hunter, who had 100 total yards, running and receiving.

But the big surprise was Alex

Smith's performance, the best most 49ers fans can remember. Smith went 9-for-9 for 179 yards in the third quarter to get the comeback rolling. It was the biggest SF comeback in fifteen years and the largest second-half lead lost by Philadelphia in 26 years.

In the first half it looked like more of the same old 49ers we've watched in recent seasons, ending with a 20-3 Eagles' margin. Receivers were dropping passes, Smith was misfiring and fumbling the ball away, a field goal was missed. The defense couldn't stop the opponent, allowing Vick to amass 276 yards and two touchdowns in the half. It appeared the predicted blowout was inevitable.

SF pulled within 23-16 behind two Smith TD passes in his hot third quarter, to Joshua Morgan and Vernon Davis. The Eagles, however, had a chance to make it a two-score lead again and all but put the game away with a 33yard field goal, but rookie kicker Alex Henery missed his second of the game and left the opening for the 49ers' rally.

After the missed try the television coverage broke for commercial while playing Tom Petty's "Runnin' Down a Dream." When the game resumed, that's just what the 49ers did...

Meanwhile, back at the ranch in the Bay Area, the Oakland Raiders hosted New England before a packed house. The Raiders had taken a giant step forward the previous week with their impressive upset victory over the New York Jets.

But this week the Silver and

Black (2-2) took two steps back, losing 31-19. The most penalized team in the NFL had nine more for 85 yards, two setting up Patriots' touchdowns. The Raiders were just too hyped up for the big game against brilliant QB Tom Brady, unstoppable receiver Wes Welker and the machine-like New England offense.

Former Patriots DT Richard Seymour set a bad tone early for the Raiders, committing three penalties of his own. Quarterback Jason Campbell regressed, throwing two awful interceptions to ruin his 344 yard passing effort. The Pride and Poise boys seemed to play with their rekindled pride, but the poise was missing. The commitment to excellence was

Speaking of Giant steps your 2010 World Series champion San Francisco Giants took several steps backward down the stretch run of the baseball season, missing the playoffs altogether. A plethora of injuries to key players and sub-par seasons by a number of others was too much to overcome.

Now the Giants' brass must contemplate what steps to take for next year. Apparently intending to keep most of the dominating pitching staff intact for 2012, it's the battered and broken everyday lineup that must be reshaped for another run at another title.

When the Giants take the diamond on Opening Day we may all be asking the question, but with different inflection, "Who are THOSE guys?!!"

A Case in Point

## The Case of the **Fatal Mixer** By David Graulich, Esq.

On the evening of March 4, 1982, the Stockton Chamber of Commerce sponsored a mixer for local businesses. The event was hosted by a nonprofit agency whose offices were in Cherokee Industrial Park, on Cherokee Road and Highway 99.

The industrial park was in a rural area on the outskirts of Stockton. About 400 people attended the mixer. The nonprofit had only about 25 parking spots near its premises, so most guests parked elsewhere in the complex. .

One of the persons attending the mixer that night was Jenny Beth Steinmetz, 35, an agent with Cal-Western Life Insurance. She left the event, by herself, about thirty minutes before it concluded at 8 p.m. She walked to her car, which she had left about a block away within the industrial park. When she returned to her car, she was attacked by an unknown assailant who stabbed her to death. Ms. Steinmetz's body was found later that night when other guests left the mixer.

A lawsuit, filed on behalf of Ms. Steinmetz's two minor sons, claimed liability on the part of three parties: Stockton Chamber of Commerce, the nonprofit agency, and the company that owned the industrial park. The suit alleged that the Defendants breached their duty to Ms. Steinmetz by failing to provide a safe place for her to park her car while she attended the mixer. The complaint further charged that lack of security and inadequate lighting contributed to the horrific crime.

At the essence of this heartrending case is the concept of duty. In civil litigation, there can be no negligence unless the Plaintiff establishes that

the Defendant breached a legallyrecognized duty of care. Duty seems like an obvious notion, but it can be surprisingly difficult to establish in a negligence action. Courts tend to be worried that, if the boundaries of duty become extended too widely, the floodgates will open and potential liability will be almost everywhere. Judges, meanwhile, vary widely in their individual assessments of whether a duty of care existed in a given circumstance.

In the Steinmetz case, the trial court dismissed the complaint against the landowner of Cherokee Industrial Park. The court reasoned that there had been no prior violent criminal activity in the industrial park, that the attack was unforeseeable, and that the landowner owed no duty to the decedent. Now the question before the Court of Appeals, Third District was whether the Stockton Chamber of Commerce (sponsor) or the nonprofit agency (host) had liability.

The Plaintiffs argued that it was apparent that the nonprofit's premises had inadequate parking for the hundreds of people invited to the mixer. It was foreseeable to a reasonable person that the invitees would be forced to park in the outlying areas, where the danger was greater. The Defendants countered by saying that, once the attendee left the mixer itself, their liability ended.

Here's what the appeals court ruled: No liability on the part of either the Chamber of Commerce or the nonprofit.

The court compared the situation to that of a movie theater showing a film, or a department store holding a sale. Neither is able to offer sufficient parking for the number

of people expected to show up. Yet there is no obligation for the movie theater or the department store to provide additional lighting on the city streets, or to hire private security guards to patrol the streets for safety. Their liability is limited to their places of business.

Another comparison made by the court was that of a homeowner who hosts a business event at his house. There's not enough parking at the house for all of the guests, and some people park in the adjoining neighborhood. There's no obligation on the part of the homeowner to provide additional lighting or hire security guards to escort guests to their cars.

"In the final analysis," said the court, "the decedent was killed by an unknown assailant in a parking lot located off property owned, possessed or controlled" by the Chamber of Commerce or the nonprofit.

Was the killer of Jenny Beth Steinmetz ever captured? In researching this column, I came across an October 9, 1982 article from the Lodi News-Sentinel, reporting that the San Joaquin County Sheriff's Department had taken a suspect into custody. The suspect also attended the Chamber of Commerce mixer that night, and had once been employed by a company with headquarters in the industrial park. However, I couldn't find any additional newspaper articles on the case. The trail ended there.



#### Is Online Trading Okay?

Dear Dave,

How do you feel about online trading for building a stock portfolio? Assuming that someone has done their homework on which stocks to buy, is there anything else to know about do-it-yourself trading?

Dear Kevin.

There's one very important thing to know - don't do it! This kind of thing is one rung below day trading on the ladder of stupidity.

Here's the problem. When most people talk about "doing their homework" on single stocks they're just barely skimming the surface. And most of the time this involves just talking to their broke friends. There's no way you and your golfing buddy are going to dig up and decipher the kind of solid, reliable information

you'll need to be successful at this kind of thing.

I'd much rather go with a mutual fund that's spent millions of dollars analyzing companies and doing real research. What you're talking about is a million times riskier than using good growth stock mutual funds selected by professionals – with 90 to 100 different stocks.

Investments Using Home Equity?

Dear Dave,

Right now our debt is keeping us from investing. Do you recommend making investments with a home equity line of credit?

- Paul

Dear Paul,

Let me answer this very, very carefully. No!

You don't borrow on your home, Paul. You never want to put something as precious and important as your home in jeopardy just for the sake of investing.

Follow the Baby Steps. First, get \$1,000 in the bank to start your emergency fund. Second, pay off all debts from smallest to largest – except for your house - using the debt snowball. This will lead you to Baby Step Three, which is fully funding your emergency fund with three to six months of expenses. Once you've done all this you're ready for Baby Step Four, which is investing in Roth IRAs and other pre-tax retirement.


