"The Courage to be You" Works to End HumanTrafficking



Congressman Dan Lungren, Jenny Williamson. Location is Placer County proposed site for Courage House Northern California, a home to house and heal girls who have been involved in the illicit sex trafficking industry of our area.

Sacramento - There is a long, winding lane that leads up to the house, the barn and the future for young girls rescued from the sex traffic slavery of Northern California.

Sex traffic slavery of Northern California?

That's right. Sex traffic slavery right here in River City. Though most people think that is some exotic international problem in faraway Asian countries or down below the border, fact is, dozens of U.S.-born girls ranging in age from 11 to 17 are being recruited and exploited daily.

Elk Grove. El Dorado Hills. Sacramento. Carmichael. Rancho Cordova. No place is immune.

The typical girl more than likely was sexually abused at home. Repulsed and confused, they run away. Pimps find them at shopping malls and through internet classified ads. They promise food, shelter, a little money and a life on their own. The job, though, involves giving away their bodies to sex customers dozens of times a day. Day after day.

It's estimated that more than 400,000 children are being sexually exploited each year in the U.S.

The FBI and undercover Sacramento and Sacramento County police are among the agencies that catch up with them. They bust the pimps and put the girls in juvenile detention or send them home. Eventually, they get a chance to bolt and they do. The cycle starts anew and the hard miles of the illicit sex trade beget drug problems and all that begins to pile up on their bodies and spirits.

If only there was a place, a special place to put these girls where counselors and therapists could work with them and bring them back to where they last lost sight of their dreams. There is. Almost.

Jenny Williamson and her "Courage To Be You" nonprofit are working on it.

This Rocklin woman, a blonde whirl of enthusiasm and energy who also is a mom and a wife, took time out from her comfortable suburban world to have a personal epiphany a few years back. A life coach by profession, she had arrived at one of those personal stocktaking moments that tug between the light and darkness of the soul around a person's 40th birthday.

This launched her on a journey of self discovery whereupon she met God in a new church and learned that HE had a plan for her life that SHE had been ignoring: The Courage to Be You.

That plan didn't come all at once, but was eventually revealed: start a faith-based mission to serve the victims of human trafficking, the walking wounded juveniles caught up in sexual exploitation. Provide a home for these girls where they can heal in Northern California.

MEETING THE GOAL

Spin ahead now to a sunny day last month when Williamson has invited Congressman Dan Lungren (R-CA) and some staff members to tour the proposed site for Courage House Northern California.

This pastoral ranch setting in rural Placer County has been used to train and board horses. The views of the foothills, the wide open spaces and fresh air seem the perfect antidote for a young woman to mend from the horror of the sex traffic world.

While Lungren listens to Williamson's plans to buy and eventually turn the house and outbuildings into facilities to house 20 to 30 girls, farm dogs frolic with horses in a pasture.

FBI Special Agent Minerva Shelton and an unidentified undercover Sacramento police officer describe how the girls are recruited, put to work and enslaved.
"These pimps know exactly

what they're looking for," says the undercover cop.
"They're like the pied piper."

Though area law enforcement has been adept at arresting the adult perpetrators and sending them off to jail, there's no place beyond juvenile detention facilities to house the young female victims and to get them straightened out.

"There are 50 girls from Northern California who have been sent away to a facility in Arizona," explains Williamson. "But there's only a couple such places in the country. There's another in Los Angeles. We need this one."

The goal is in sight. Just this year Williamson and supporters—mostly a group of evangelical churches in the Sacramento region — have raised more than half of the \$1 million needed to buy the acreage, house and barn presently on the site.

"They've accepted the offer of our purchase. But we need to raise the rest of the money," says Williamson. Looking at what has happened to date since her epiphany, there seems little doubt in her mind that more donors are out there. But they have to hear and they, like Williamson, have to commit to the cause.

Williamson is so sure it will happen, she's getting everything ready for a potential summer opening of Courage House Northern California. Platoons of volunteers are investing their own time and money (\$250) to go through background checks and six-week-long certification training sessions with CASA (a nationally accredited program for Court Appointed Special Advocates).

The DUI enforcement grant is to assist in efforts to reduce the number of persons injured and killed in impaired-driving traffic collisions. This will be done through the use of DUI and driver's license checkpoints.

"When more people buckle-up and drive sober and safely, we save lives. It's just that simple," said Christopher J. Murphy, Director of the Office of Traffic Safety. "This grant will help make Citrus Heights just that much safer of a place to live and work."

Funding for the grant comes from the University of California at Berkeley Traffic Safety Center through the California Office of Traffic Safety.

Pet Gift and Supply Store to Open in New County Animal Care Facility

Non-Profit creating store to raise funds to help animals find permanent homes

Sacramento - The Sacramento County Animal Care Facility has opened a new retail store for pet owners, the Critter Outfitter. Pet supplies and gifts are available from \$1 dollar and up. The store is run by the animal facility's non-profit 501(c) (3) affiliate known as TEAM - Teaching Everyone Animals Matter. Store Hours are 11 to 6 Wednesday through Friday and 11 to 5 on Saturday & Sunday.

"This is a dream come true," said Pat Wilcox, founder and director of TEAM. "Funds brought in from this store will be used for special medical needs of shelter animals such as flea treatments, offsite adoption events and monthly spay/neuter clinics."

The TEAM group also funds popular shelter adoption programs run through PetsMart stores; Friends of Unwanted Rabbits (FUR), LAPCATS adult cats at the Elk Grove Laguna store and dog adoptions in the Rancho Cordova store. They also support the wonderful shelter volunteers who care for all the animals.

Pat Wilcox founded the nonprofit in 1997 when she was the director of the animal facility from 1992 to 2002. Though now retired, she has been running TEAM for twelve years and remains very involved in animal issues.

"With the opening of the new store, I hope to help further my dream that for Sacramento that no animals are euthanized due to lack of housing space," Wilcox added.

In 1997, Robert De Niro and Dustin Hoffman starred in a film titled "Wag the Dog." The film portrayed a sex scandal involving the President shortly before the election. De Niro, a Washington spin doctor, was brought in to distract the electorate and save the election. He hired Hoffman, a Hollywood movie producer, to help fake a war to distract attention from the scandal.

president's The advisors expressed initial skepticism, arguing that the plan was too absurd and the public would not fall for it. De Niro and Hoffman assured them the public would, saying "they always do." Sure enough, the president was reelected.

Today, we see the reality of "Wag the Dog" being played out in Washington on a daily basis. The spin doctor's assurance the public will "fall for it" seems to be holding. Global warming, health care, cap and trade, bank bailouts, a \$14-trillion debt, and "we can spend our way out of the recession" are all promoted as necessary. The public is repeatedly told that if these issues are not immediately addressed and action taken, catastrophe is sure to follow.

On December 13, 2009, Larry Summers, the President's top economic advisor, informed the nation, "Everybody agrees that the recession is over." Although time will tell, this assertion

does not match the conclusion private economists.

pronouncements are certainly reminiscent of the scenario of the movie. Yet, another tail-wagging-the-dog scenario is being played by our federal and local governments, possibly an even more troublesome one.

Jessica Klement, government affairs director for the Federal Managers Association, told USA Today that federal employees make 26 percent less than private sector workers for comparable jobs. The average federal worker's pay is now \$71,206. However, the facts find the average private sector salary to be \$40,331 – or 76.6 percent less than federal employees' salaries.

This recession has pushed million into almost 7.5 unemployment. That number continues to increase every month, and there is no end in sight to layoffs. The 2 million-plus federal workforce, however, is expanding and is receiving significant pay increases. Federal employees are not experiencing a recession; they are experiencing unprecedented growth and financial gains.

The tail is most certainly wagging the dog. Public servants are no longer servants by any understanding of the term. The average federal "public servant" earns more than those who pay that salary. While average taxpayers suffer, federal workers prosper. Those at the top of the federal food chain do even better.

At the beginning of this recession, only one Department of Transportation employee was receiving a salary of \$170,000 or more; 18 months later, 1,690 are. The number of federal employees receiving salaries of \$100,000 or more jumped from 14 percent to

19 percent of the federal workforce during the same period, not including overtime or bonuses.

Those in the private sector, being taxed to fund federal wages and benefits, are receiving little or no salary increases. Between 17 percent and 22 percent of the private workforce is unemployed, has stopped looking for work, or is involuntarily working less than 40 hours per week. The tail is most certainly wagging the dog.

The same is true at the state level. States large and small are paying state workers significantly more than their comparable private sector counterparts. For example, North Dakota's private sector work force has a mean annual salary and benefit package totaling \$41,053 per year. State employees have an annual package totaling \$51,948 -- 26.5 percent more than their private sector neighbors whose taxes fund this package. It is likely we would find the same at the city and county levels.

When the dog finally realizes what is happening, it is likely to begin chasing the tail. When the tail is caught -- and it will be -- the consequences will be painful for everyone.

Californians are tired of hearing about government's problems. Because they are struggling with their own crises - including high unemployment, foreclosures and taxes - the last thing they want is more bad news from government. But want it or not, the bad news keeps coming.

After approving the largest tax increase in the history of all 50 states last February, the Sacramento politicians told us that the ship was righted and we were on course. When the state budget was back in the red just five months later, we were told that the necessary corrections were made through spending cuts and we had avoided disaster. Now we learn that the state is upside-down by another \$20 billion, and this will necessitate further program cuts, new taxes or both. But compared to what is coming down

the pike, this is the good news. Just like the bulk of the iceberg that was struck by the Titanic - a ship with whose passengers many Californians now identify was under the surface, so too, we are finding that some of government's most severe maladies have been hidden from view.

are sounding the alarm that it is debt that may sink the ship of state. A quarter century ago, state treasurers like Tom Hayes were recommending a debt ratio of no more than 4%. More recently Phil Angelides, the former treasurer who recommended bonds as a panacea for most that ails our state, said we could safely handle a debtratio of 6%

The debt ratio is calculated by determining how much the state is obligated to pay out on existing debt as a percentage of the general fund. Since each new state bond that is approved - like those for stem cell research and bullet trains - and sold increases the annual obligation for debt retirement. Put too many bonds on the market too quickly, or suffer a decrease in revenue due to a sour economy and California has been subjected to both – and the debt ratio goes up.

Now Taylor and Lockyer warn that the ratio could go to 7 or even as high as 10%.

And although California already has the lowest credit rating of all 50 states, the oblivious Legislature has placed an \$11 billion water bond on the June ballot without considering the impact on just how this will impact California's long term fiscal health. Because of our already huge debt, and the lack of confidence the financial community has in the Sacramento governing class, California debt instruments are no longer the sound investment they once were.

All this means that, although California can still sell bonds, like a consumer with bad credit, that debt will be very expensive. But after selling \$36 billion of debt this year, and struggling to find

further takers, Treasurer Lockyer may begin seeking to sell bonds to overseas investors. "We are running out of tricks," Lockyer told an Assembly hearing. "Shortly we are going to have to go international to sell California bonds. I don't know how expensive that is going to be." California currently pays higher rates than Brazil, Indonesia and Mexico, the treasurer says.

What does this mean to the average citizen as a practical matter? Since constitutionally the state is required to meet its bond obligations before one dime can be spent from the general fund on other programs, a high debt ratio means less money for schools, law enforcement, transportation, healthcare or any of the other programs that most Californians value. It means that Californians will not only have to accept less from government but that there will be even greater pressure to raise taxes to pay for the services that remain.

Californians already pay some of the highest taxes in the nation and our state competes with New Jersey for the heaviest tax burden per capita. Higher taxes would drive even more jobs out of state and increase the number of people depending on dwindling state services. It's not a pretty picture and, if during the holiday season, Californians would prefer not to dwell on the iceberg lurking under the surface, who can blame them?



Finding the Right Person

As you may already be aware, Sacramento's County Executive retired on December 31, 2009 after just over ten years of service with the County. Going through the process to hire a County Executive is a challenge in good economic times; finding the right person now is critical for this Board of Supervisors, and may well be the most important decision we will make in the next several years.

It's no secret that Sacramento Countyisfacingseriouschallenges right now. Following the real estate bubble burst, property tax revenue is declining rapidly. Anxious consumers are spending less, and sales tax revenue has also taken a significant hit.

On top of the challenges we face as a consequence of the global economic downturn, Sacramento County is also experiencing significant impacts from State worker furloughs, as hundreds of millions of dollars in salaries have been removed

from our local economy – but we still must absorb State funding reductions to mandated programs as if we were any other county.

Ballooning payments for Pension Obligations bonds are also on the horizon due to a decision to refinance the bonds that was made before I joined the Board of Supervisors which minimized the costs in early years but results in much higher payments in later years - now.

Leadership is needed, not only from the County's elected officials, but from the managers we appoint to run day-to-day operations.

The Board has appointed an interim County Executive, Steve Szalay, to manage the County while we search for the right person to fill the permanent position. Mr. Szalay has been gettingup to speed on the County's challenges very quickly. I have already discussed with him my concerns about the about the lack of transparency in the County budget. I have raised these concerns regularly over the last few years, but only recently did these concerns get attention, after I appointed an ad hoc committee of citizens to help me in dealing with our current budget crisis.

As we begin the search for candidates, I want to share with you my expectations of the next County Executive. We face serious challenges right now that need real, structural, and permanent solutions. The County

budget needs to be much more transparent than it is now – costs cannot be hidden from the public or the Board of Supervisors through budget gimmicks. The public and County employees, along with the Board, must be able to trust the information they are given. This person must be able to think creatively about the best way to provide the services the public expects from their local government.

A search firm has been hired to conduct a national search for candidates. I expect that we will begin vetting candidates in early 2010, and that a new County Executive will be in place by the end of June or sooner.

I welcome your input as we go through this process. Please feel free to share your opinions to me via email at macglashanr@ saccounty.net. You can also attend my monthly Community Cabinet meeting. Orangevale, we meet the first Friday of each month at Annie's Breakfasts and Steaks on Greenback Lane. In Fair Oaks, we meet the third Wednesday of each month at Dianda's Bakery in the Old Fair Oaks Village. Each meeting features a guest speaker on a topic relevant to County taxpayers. In February, we will be hearing from Michele Steeb, Executive Director of the St. John's Shelter for Women and Children and a member of the region's Homeless Policy Board. I hope to see you there.

FRIES, THIGHS, AND LIES

Has your New Year's resolution to take off those extra pounds tanked yet? Never fear, the real truth about dieting is here! According to nutritional coach **Deborah Arneson**, there are nine top mistakes dieters make, and it's time to banish the fat frauds that have made America so obese. Deborah does nutritional counseling at her Healing Quest Center, is producer of Chicago's Health Quest consumer health show, and now has penned her new book Fries, Thighs, and Lies: The Girlfriend's Guide to Getting the Skinny on Fat. There's a good reason diets don't work, says Deborah. Most people do them wrong.

She has helped hundreds of clients achieve their goal weight for the first time, and these are her top nine diet bloopers.

1) Poor Sleep Habits. Bedding down after 10 and sleeping too little prohibits nightly adrenal regeneration and adds toxic load in the liver...leading to weight gain and slow metabolism.

2) Not enough calories. Eating less than your body's minimum daily requirement causes your body to store fat. This feast or famine response kicks in the moment daily calorie intake drops below 1,200.

3) Under hydration. Drinking too little water slows down your metabolism and fat burning. To calculate your daily water allowance: Weight in pounds multiplied by .075. This gives you the approximate number of 8-ounce glasses you need. Three cups of water can come from foods.

4) Exercising less than 26 minutes. To lose fat, the exercise that counts kicks in after 26 minutes at your target heart rate. Less than that only maintains your current weight.

5) Eating too little protein. Too little protein in your daily diet slows down fat processing in the body. To calculate your body's daily protein requirements: Weight in pounds divided by two equals the number of grams of protein per day.

6) Not enough fiber. 2-4 pieces of fresh fruit and 2-4 cups steamed or raw vegetables daily can help the body burn fat, stabilize insulin, and drop pounds.

7) Watching the wrong numbers. Ditch the scale. The important numbers you need to know for fat loss are: body-fat percentage, body-mass index, waist-to-hip ratio, and daily calorie allowance. Learn how to find these numbers and use them correctly.



8) Ignoring the clock. An easy way to lose weight is to eat smaller meals, eat soon after rising, and then every 2-4 hours after that. Don't eat after 7 PM.

9) Not Budgeting. Once you calculate your daily calorie allowance, budget for 500 calories less than that if you want to lose 1-2 pounds a week. Most dieters are clueless about how many calories they consume a day.

Deborah wants to demystify what she calls the myth-information from the food pyramid to the wrongheaded low carb, high protein craze, or the amount of water to drink. Debt Collection Supervisors Settle FTC Charges

Concluding a case that drew the largest civil penalty ever imposed on a debt collection business, the Federal Trade Commission settled with the two remaining individual defendants who allegedly misled, threatened, and harassed consumers; disclosed their debts to third parties; and deposited postdated checks early, in violation of federal law. The settlement order requires each of these senior managers to pay a civil penalty and bars them from future violations.

"The FTC wants to remind debt collectors of their responsibilities and obligations under the law. Abusive collection actions are illegal, and if debt collectors use abusive tactics they could face legal action," said David Vladeck, Director of the FTC's Bureau of Consumer Protection. "At the same time, we want consumers to understand their rights if their debts go into collection. Money matters, and the more people know about managing their debt and dealing with debt collectors, the better off they will be."

According to the FTC's complaint, filed by the Department of Justice on the FTC's behalf, the defendants participated in, or controlled, the actions of debt collectors whose unlawful practices included false deceptive threats of garnishment,

arrest, and legal action; improper calls to consumers; frequent, harassing, threatening, abusive calls; and unfair and unauthorized withdrawals from consumers' bank accounts. The complaint also alleged that the defendants failed to adequately investigate consumer complaints or discipline collectors, and collectors who were terminated for violating the Fair Debt Collection Practices Act (FDCPA) often were rehired within a few months.

In 2008, Academy Collection Service, Inc. and its owner, Keith Dickstein, paid \$2.25 million to settle FTC charges that Academy collectors violated the FTC Act and the FDCPA while collecting debts, and that Dickstein failed to stop the violations. The settlement order announced today, negotiated by DOJ and the FTC, imposed civil penalties of \$375,000 and \$300,000, respectively, on Albert S. Bastian and Keith L. Hurt III, who oversaw Academy's Las Vegas collection center. The judgments were suspended upon payment of \$7,500 each, based on their ability to pay. The full judgments will become due immediately if the defendants are found to have misrepresented condition. their financial

The order bars Bastian and Hurt from making false, deceptive,

or misleading representations in debt collection efforts, such as that nonpayment will result in garnishment of wages, seizure of property, or lawsuits, or that they or their agents are attorneys. They also are prohibited from withdrawing money consumers' bank accounts without their express informed consent, and from depositing or threatening to deposit postdated checks before the date on the check. In addition, the pair are barred from improperly communicating with third parties about a debt; communicating with a consumer at any unusual time or place, including the workplace; and harassing, oppressing, or abusing any person in connection with debt collection.

The Commission vote to authorize DOJ to file the consent decree was 4-0. The consent decree was entered in the U.S. District Court for the District of Nevada.

Obama Administration Diverts Small Business Funds to General Dynamics

(BUSINESS WIRE) -- The following is a statement by the American Small Business League:

The Obama Administration has awarded a \$28.5 million small business contract to Fortune firm General Dynamics. America's fourth largest General contractor, Dynamics did more than \$29.3 in sales during fiscal year (FY) 2008 and maintains more than 92,000 employees.

According to the most recent data from the Federal Procurement Data System - Next Generation (FPDS-NG), General Dynamics is just one of hundreds of corporate giants that are currently receiving federal small business contracts from the Obama Administration.

Since 2003, twenty-five federal investigations have uncovered the diversion of billions of dollars a month in federal small business contracts to corporate giants. In Report 5-15, the Small Business Administration Office of Inspector General (SBA OIG) referred to the issue as, "One of the most important challenges facing the

FDIC

Small Business Administration and the entire Federal government today." As recently as October 16, the SBA OIG listed the issue as the SBA's top management challenge for the fifth consecutive year.

The American Small Business League (ASBL) has estimated that every year more than \$100 billion in federal small business contracts are diverted away from legitimate small businesses and into the hands of some of the largest corporations in the world. The most recent data released by the Obama Administration firms counted that as small businesses included: Xerox, Bechtel, Lockheed Martin, Northrop Boeing, Raytheon, Grumman, British Aerospace (BAE), Ssangyong Corporation in Seoul, South headquartered Finmeccanica and SpA, which is located in Italy with 73,000 employees.

During the 2008 presidential election cycle, President Barack Obama promised to address these abuses when he stated, "Small businesses are the backbone of our nation's economy and we must protect this great resource. It is time to end the diversion of federal small business contracts to corporate giants." Yet to date, President Obama has failed to adopt any policy or legislation to honor that promise.

The ASBL maintains that stopping the diversion of federal small business contracts to large corporations alone would serve as a greater economic stimulus than anything proposed to date.

In May of 2009, Congressman (D-4-GA) Hank Johnson introduced H.R. 2568, the and Transparency in Contracting Act. If passed the bill would halt the flow of federal small business contracts to large businesses and redirect more than \$100 billion a year in federal infrastructure spending to legitimate small businesses. Although the bill has bipartisan support with 19 co-sponsors, to date President Obama has refused to endorse the legislation. Source: American Small Business

After the Rebound: It's Time to Review and Rebalance - Your Portfolio

Given the remarkable turnaround in the stock market reviewing rebalancing and portfolio assets should be done.

What Is Rebalancing?

It is important to understand that your investment mix (known as your asset allocation) is always subject to change. That's because investment performance could cause the value of some assets to rise (or fall) more than others. When an asset allocation changes in this way, investment professionals often say it has "drifted" or become unbalanced. In that event, you may need to rebalance your asset allocation so that it again has the risk and return potential you desire.

One way to rebalance involves

selling investments in the asset class that currently exceeds your allocation target. Another is to buy investments in the underperforming asset class or to use new money to increase the underweighted asset. Or you may opt for a combination of those strategies.

Many investors rebalancing because it means selling winners in favor of losers. Rebalancing can also generate transaction fees, as well as taxes on gains created by selling Nonetheless, most securities. financial professionals believe the advantages of rebalancing outweigh the disadvantages. How often should you rebalance?

The usual answer is any time your goals change; otherwise, at least once a year. However, to keep close tabs on your investment plan and make sure it doesn't drift far from

your objectives, you may prefer to set a percentage limit of variance, say 5%, on either side of your intended target, that would trigger a review and possible rebalancing.

Is There a Supreme Being Who Manages History? A Lawyer Offers Evidence

Barnardstates, "God's Everlasting Covenant reminds us that God did not set the universe in motion and then go off and leave it to run itself." He is confident that people who have questions about the nature, attributes, and activities of God will find some answers in his discussion.

In Genesis 13, God takes Abraham up on a hill and says, "Look as far as you can see. Anything you can see, you can have. This will be the Promised Land. If you can see it, you can have

it." He saw with spiritual eyes. In Numbers 13, we have an example of an entire nation failing to realize their potential because they could not see with eyes of faith. Because of the way they SAW themselves and the way they SAW their obstacles, they underestimated what God could do through them. "And there we saw the giants...and we were in our own sight as grasshoppers." Numbers 13:33 (KJV)

So let me ask you, as you look into your future what do you see? What do you see God accomplishing through you? What do you see yourself doing for God? God wants you to see as He sees, because He wants to use you in the world today in a significant way. You know you are created for far more than you've experienced to date. Many people never achieve their full potential because they can't see themselves as God sees them. They miss God's plan for their life because of self-imposed limitations.

My challenge to you this week is to get a new view of you. Ask God to open your spiritual eyes so you can see yourself as He sees you. God says, "You can be more than you are right now, you can be something you never thought you could be before."





Debt Management Mistakes to Avoid

Most people carry some debt, whether it's a credit card balance or the money they owe on a car loan or home mortgage. Debt is not become a problem if you allow it to get out of control. The California Society of CPAs (www.calcpa. org) offers these tips on mistakes to avoid in managing your balance.

DON'T FORGET TO PAY WITH CASH

If you have enough cash to pay for a purchase, don't be tempted to put it on your credit card instead. That's an easy way to spend more than you intended -- and in many cases more than

you can really afford. Before you reach for that plastic, think about whether you've got the dollars you need for the purchase. necessarily a bad thing, but it can
If you do, set the credit card aside for the bigger-ticket items that are on this month's budget. **DON'T IGNORE YOUR**

CREDIT REPORT

Credit agencies maintain information on your credit history and give you a credit score based on whether you make your payments on time, run up heavy balances and other factors. Lenders use your credit score to decide whether you qualify for a new loan and what interest rate you ought to pay for

it. If the information in your credit report is incorrect, you could end up being denied a loan or paying unnecessarily high interest rates.

You are eligible to receive a free credit report from each credit agency once a year, so take advantage of this option and review the information carefully. If there are errors, inform the agency and ask how they can be corrected. Be aware, as well, that any suspicious entries in your report could be an indication that an identify thief is using your identity to run up debt without paying it off. That's another good reason to keep an eye on your credit report.

DON'T MISS A PAYMENT DEADLINE

Skipping a payment or mailing your check a little late may not seem like a big deal, but it can cause a big headache. Not only will you likely be stuck with a late fee, but your creditor may also raise the interest rate it charges you. When other creditors see the late or missed payment, they may deny you credit or raise the rates they charge you. This small step can become a costly mistake.

DON'T STICK TO THE MINIMUM PAYMENT

If you're squeezed for cash, it is better to pay a little rather than nothing at all, but try whenever possible to pay off as many of your recent purchases as possible.

If you pay as you go, you avoid interest charges on your purchases altogether. Even if you can't cover your full balance, paying only the minimum that's due lengthens the amount of time you'll have that outstanding balance -- and that you will be paying interest on it.

DON'T LEAVE YOUR **CREDITORS IN THE DARK**

Creditors understand that good customers sometimes fall on hard times, especially in the current troubled economy. And they're often willing to work with you to prevent your account from falling into default, but you have to let them know that you're facing problems. If you lose your job or face some unexpected financial hardship, contact all of your creditors

immediately. Ask them if it's possible to pay a lower interest rate or minimum payment for the time being, or if you can skip payments altogether for a few months until you're back on your feet.

CONSULT YOUR CPA

Whatever financial issues you're wrestling with, remember that your local CPA can help. Turn to him or her with all your questions about any financial issues facing your family.





Dave Says

No Credit Score, No Mortgage? Dear Dave,

I've never had a credit card or a bank loan, so I really don't have any established credit. What should I do when it comes to a cell phone contract or establishing utility service? Also, what will happen if I try to get a mortgage loan at some point? - Matthew

Dear Matthew,

There's usually no exception on cellphone contracts or utility service. Chances are you'll have to put up the deposit, and you'll probably get it back in six months or maybe a year from now. I still run into this kind of thing from time to time. It's almost like you don't exist if you don't have debt and a credit rating.

The mortgage lending rules are changing almost daily at this point. Under the current rules,

there are two ways to be in a great position to get a home loan. One is to have credit running out of your ears and a huge FICO score. This is pretty stupid when you think about it, but it will get you a home loan almost instantly. The second is to have no credit whatsoever. So, it's really the people in the middle who are feeling the pinch.

When you have no credit, the lender has to do the underwriting themselves. It's something banks used to do, back when they actually had some sense when it came to making loans. They take a look to see if you have a stable job and a decent income. They'll probably want some kind of proof that you pay your bills on time, and this could be as simple as showing them a few electric bills and other receipts to show that you honor your financial commitments.

Do I Tithe On An Inheritance?

Dear Dave,

- Dave

My wife is about to receive a sizeable inheritance from her father. Do you think we should tithe on the principal sum that she receives?

Dear Wade,

To the best of my knowledge, there's no indication in Scripture that vou should tithe on an inheritance. It never hurts to give, but I think when it comes to an inheritance, you're talking about something that would be more of an offering than a tithe. I don't think you've got a biblical mandate to tithe on an inheritance.

References to tithing in the Bible seem to me to be connected to money that you earn. In Deuteronomy 28, it says to tithe on your net increase. Now yes, you're increased by an inheritance, but many of these people were herders and lived in an agrarian society. If you had a herd of 100 sheep one year, and two died but seven were born, then you'd have a net increase of five, and you might calculate your tithe on that basis.

It would be the same principle if you owned a small business. Your net profits would be your income, and you would determine your tithe based on that amount. - Dave



The following letter is from Michelle Steeb, Executive Director for St. John's Shelter for Women and Children. It includes an update on the progress of the new winter shelter and what YOU can do to help. Together, we can make a difference! VCS

Dear Friend of St. John's,

Yesterday, the Board of Supervisors unanimously approved the final piece of the Winter Shelter plan, the housing of families in the empty bungalows at Mather Field!

St. John's will be running this program, and we are not wasting any time. With the help of HomeAid and Home Depot, we have recruited volunteers and are busy cleaning the bungalows!

Now, we're looking for donated itemstohelp furnish the bungalows. Sleep Train is donating a majority of the mattresses required. (Thank you Sleep Train!) If you are able

to help with any of the items on the list below, we would be most grateful! And, please consider forwarding this list to friends and colleagues who might want to help

I believe you are aware that St. John's is turning away over 300 women and children each day. As the winter approached, and as we learned that there would be no funding for winter shelter for these families (which has historically happened at Cal Expo), St. John's led the committee effort to develop winter shelter options. We were able to raise \$400,000, primarily from the City, the County and the Faith Community. As a result, 196 winter shelter beds are available for families and individuals to date, which is slightly higher than the number of beds were historically available at Cal Expo! By January, we are on target to have 340 winter shelter beds-- an amazing testimony to "Sacramento Stepping Forward".
